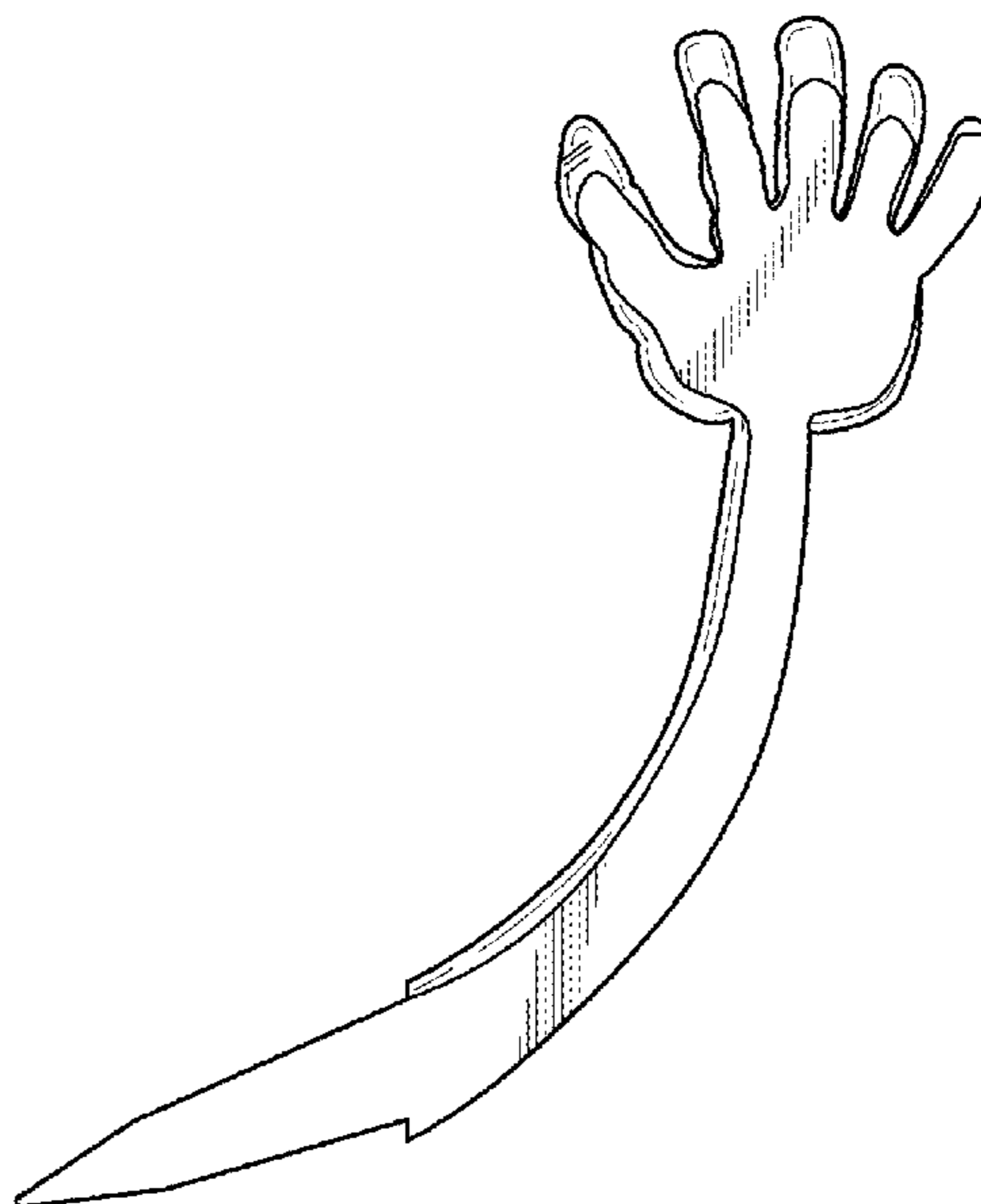
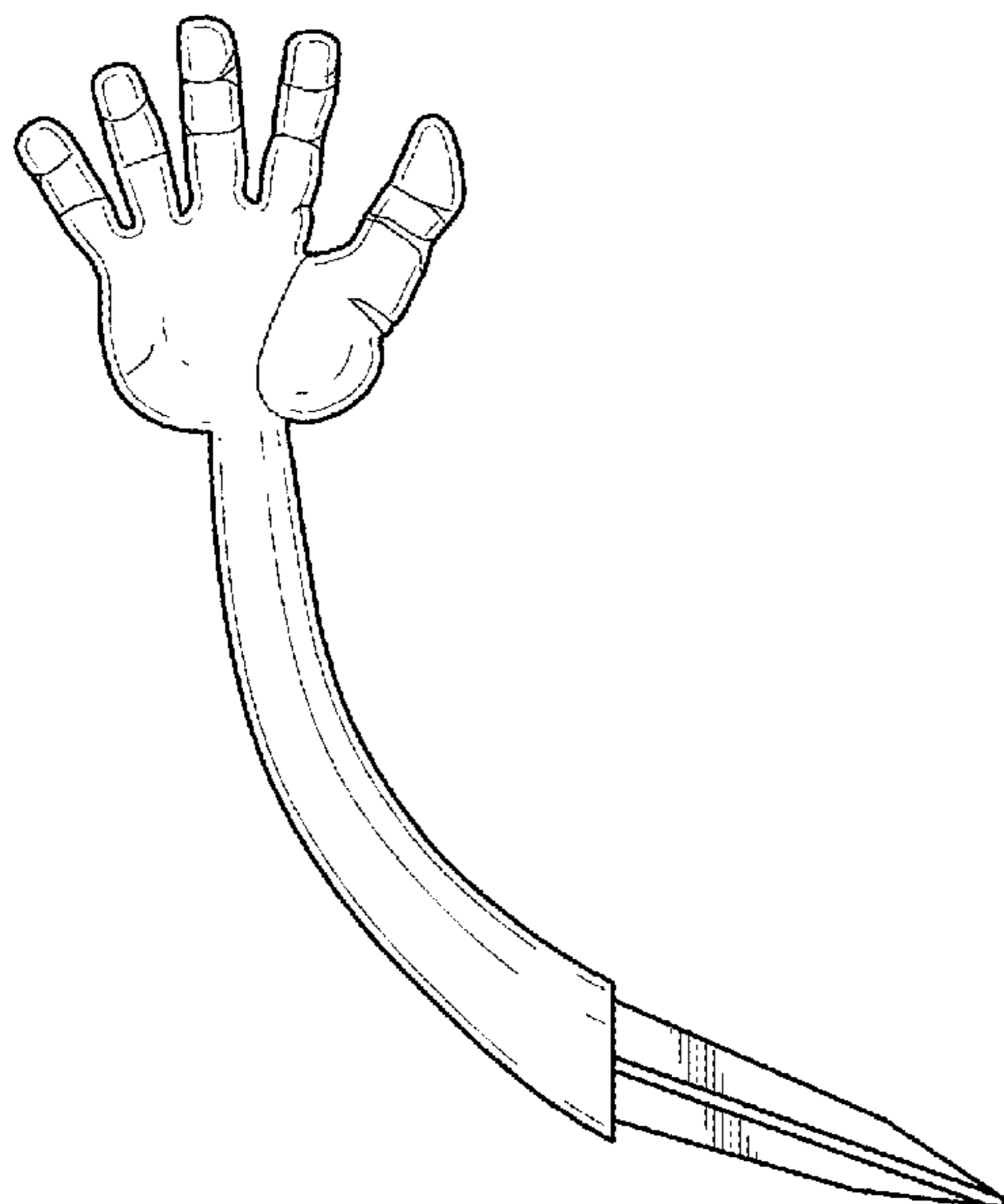
The ornamental design for pumpkin arm, as shown and described.

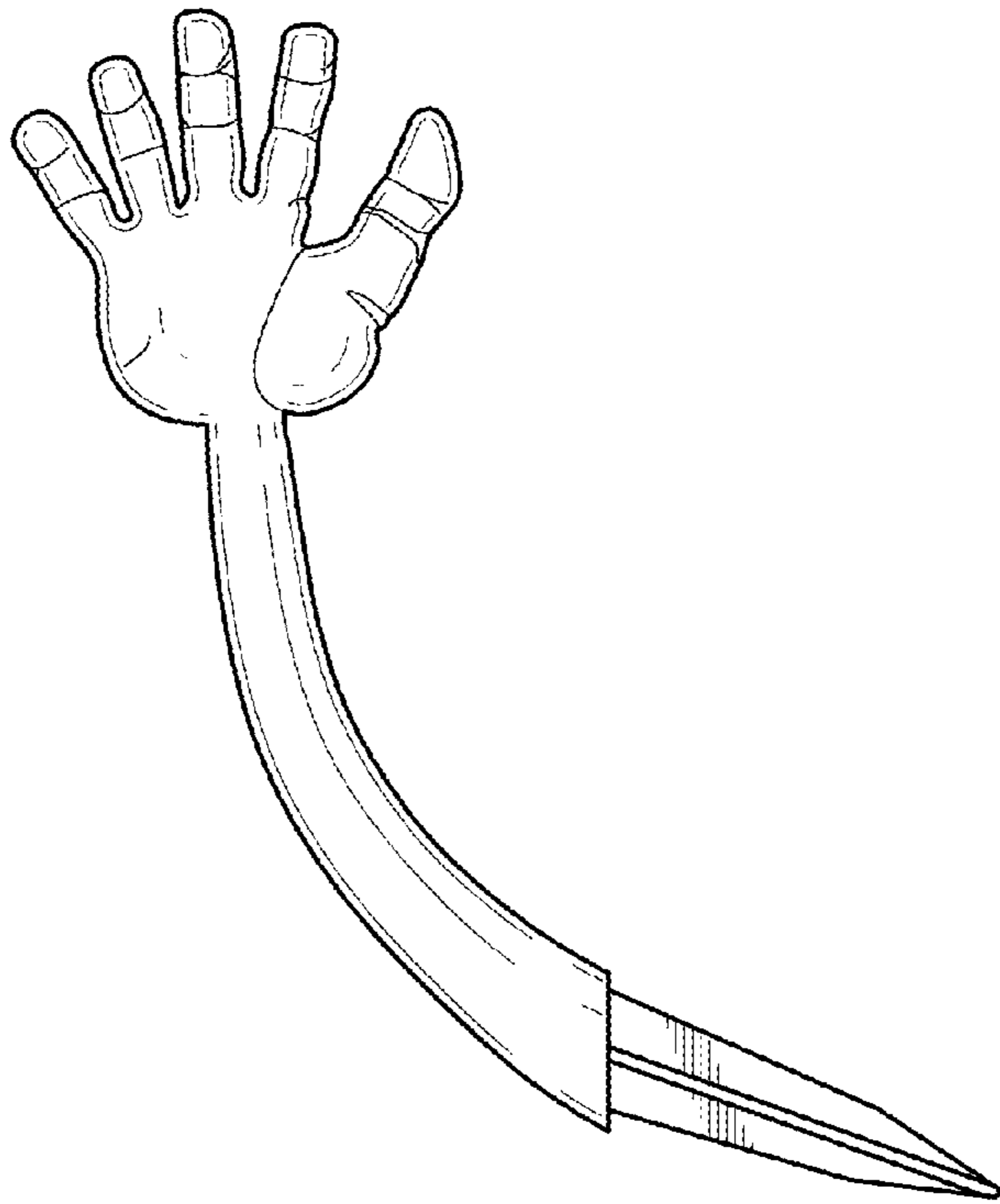
**DESCRIPTION**

 FIG. 12 is a top view thereof.

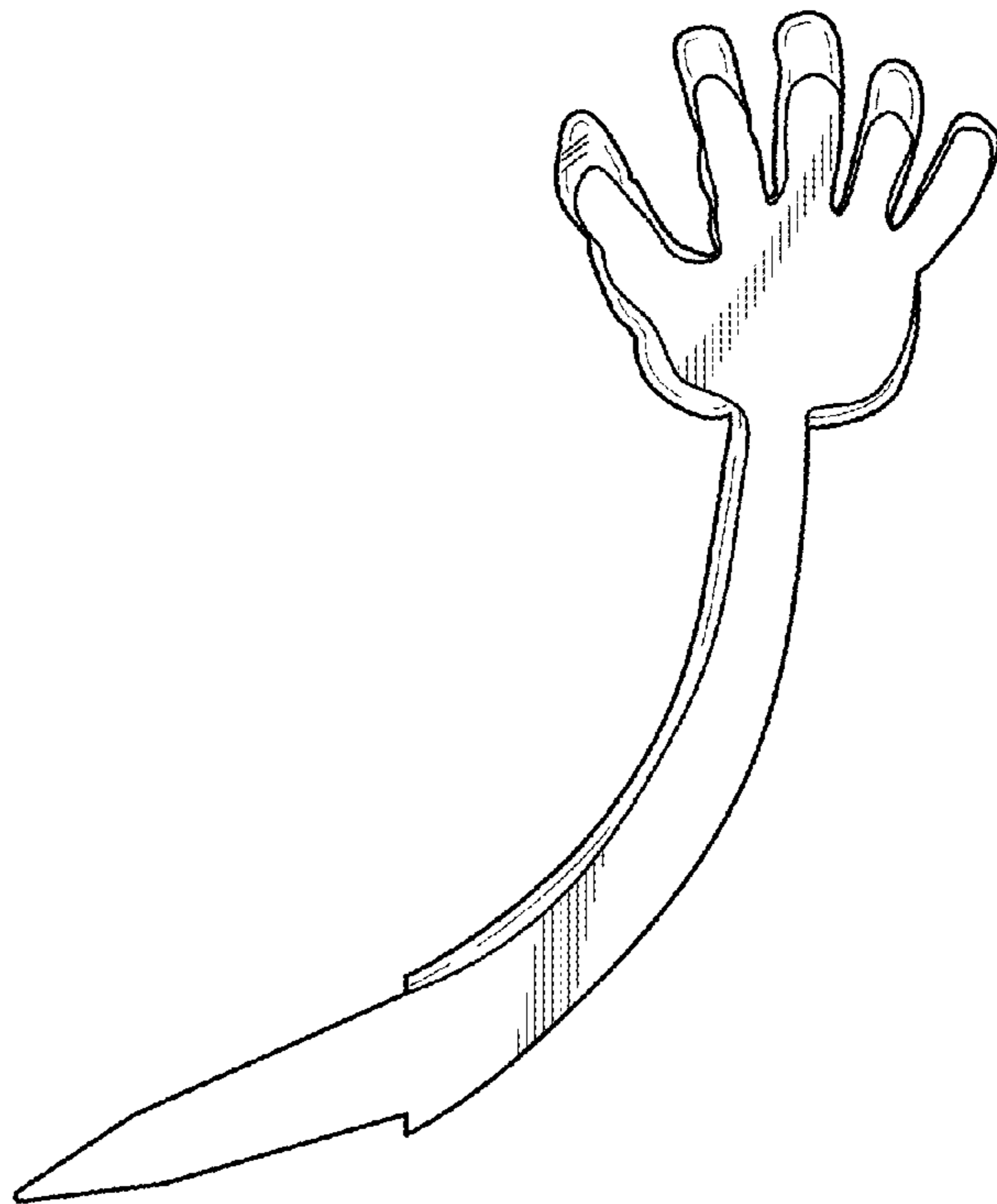

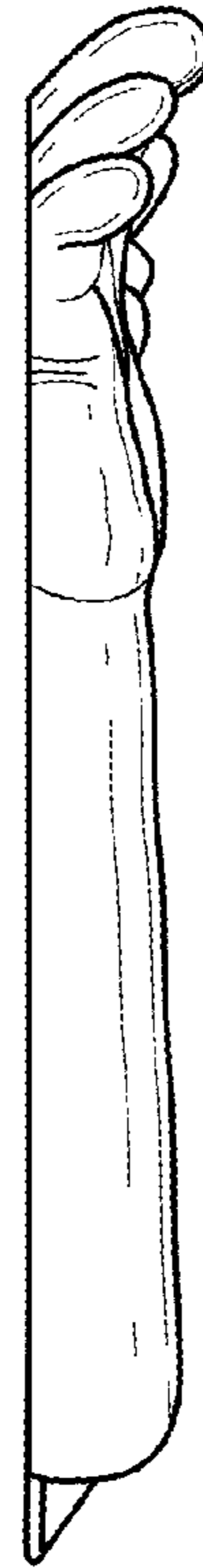

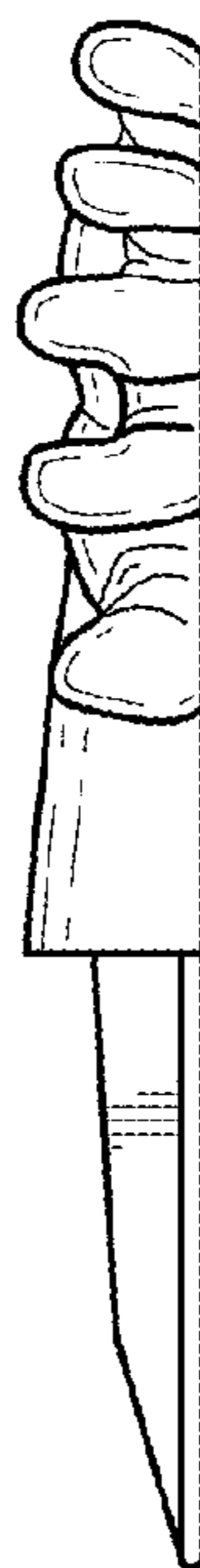

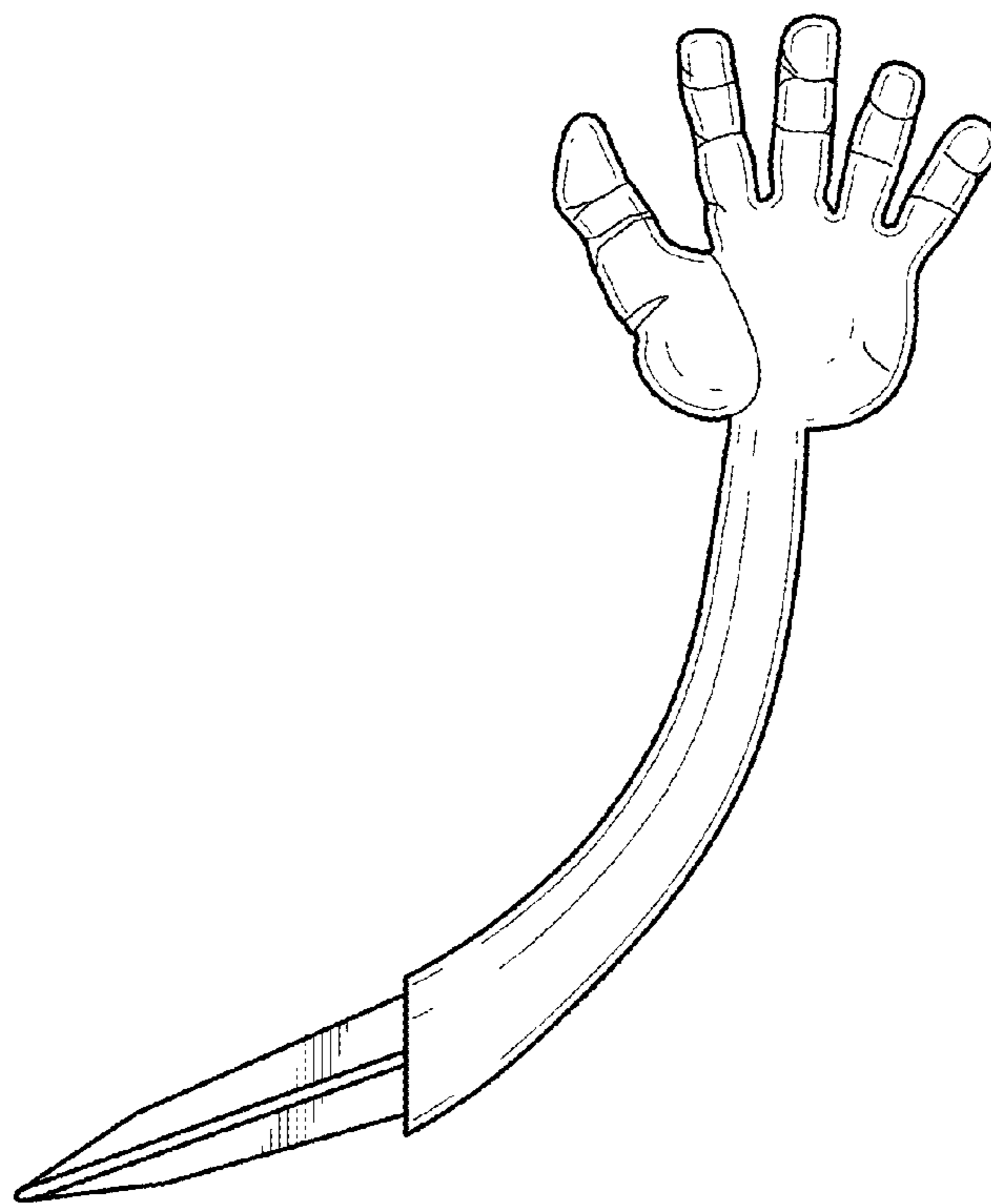

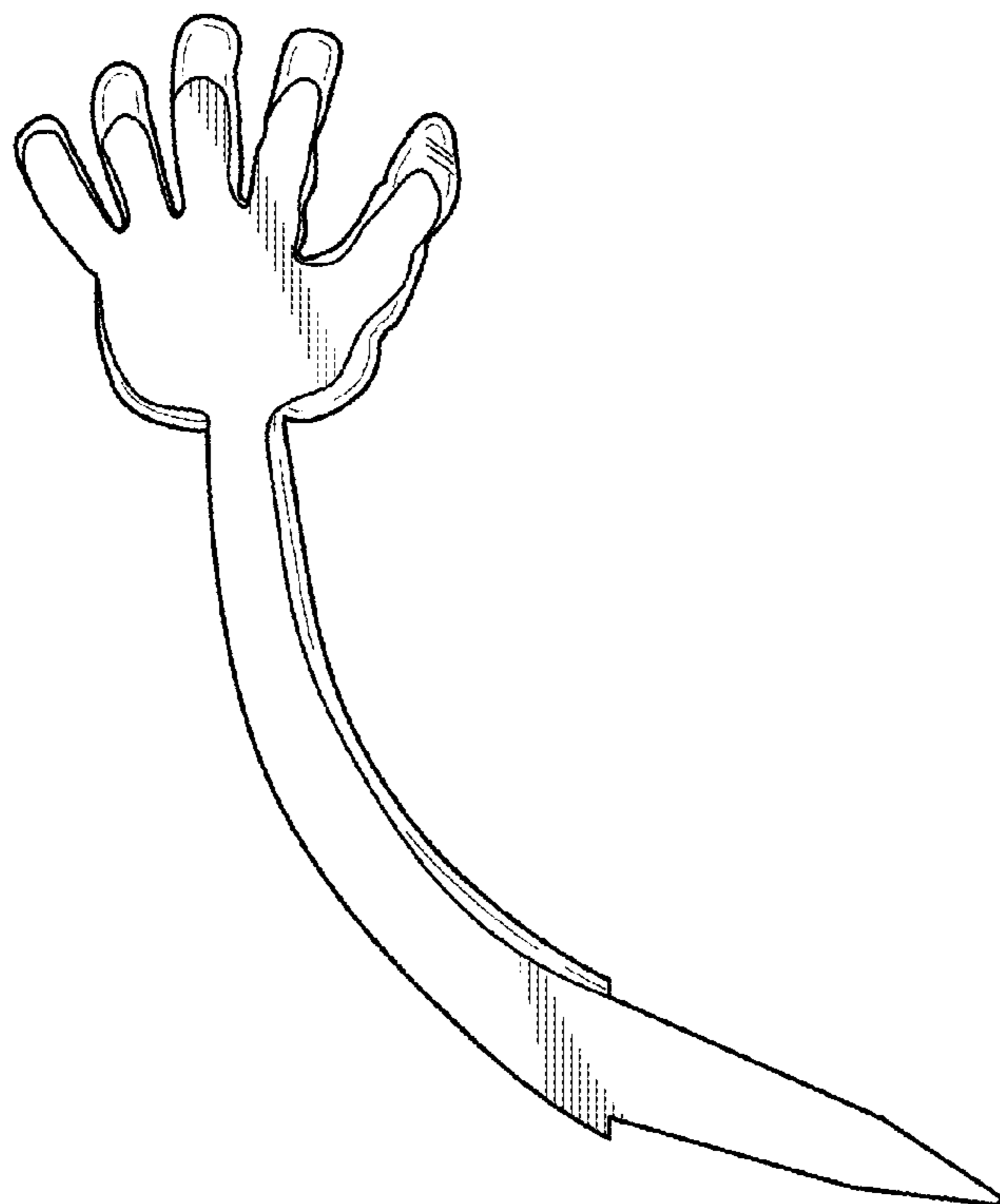

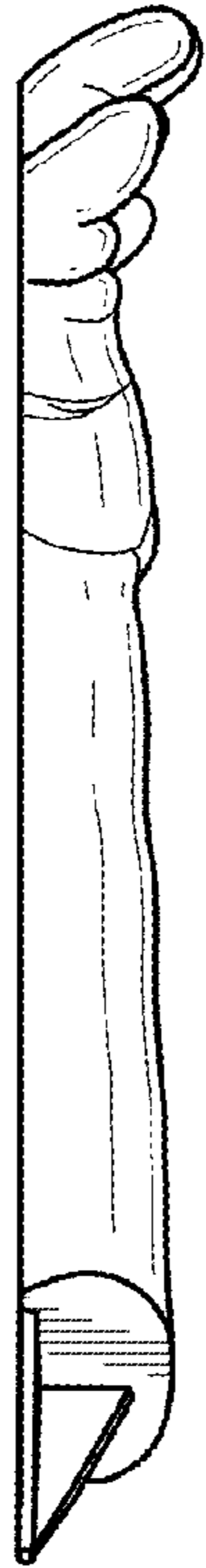

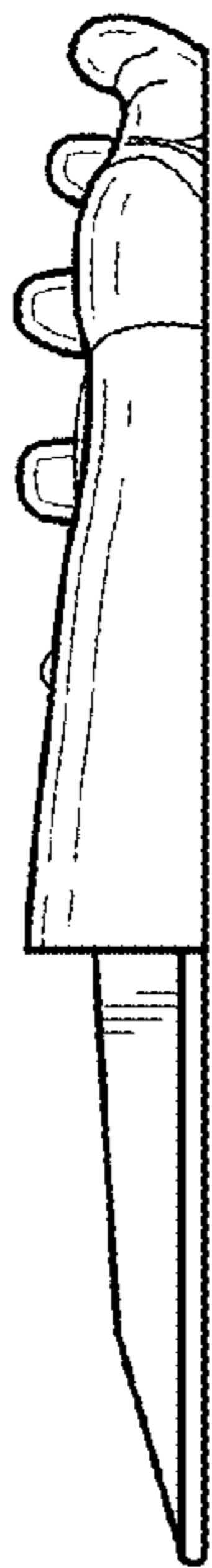
