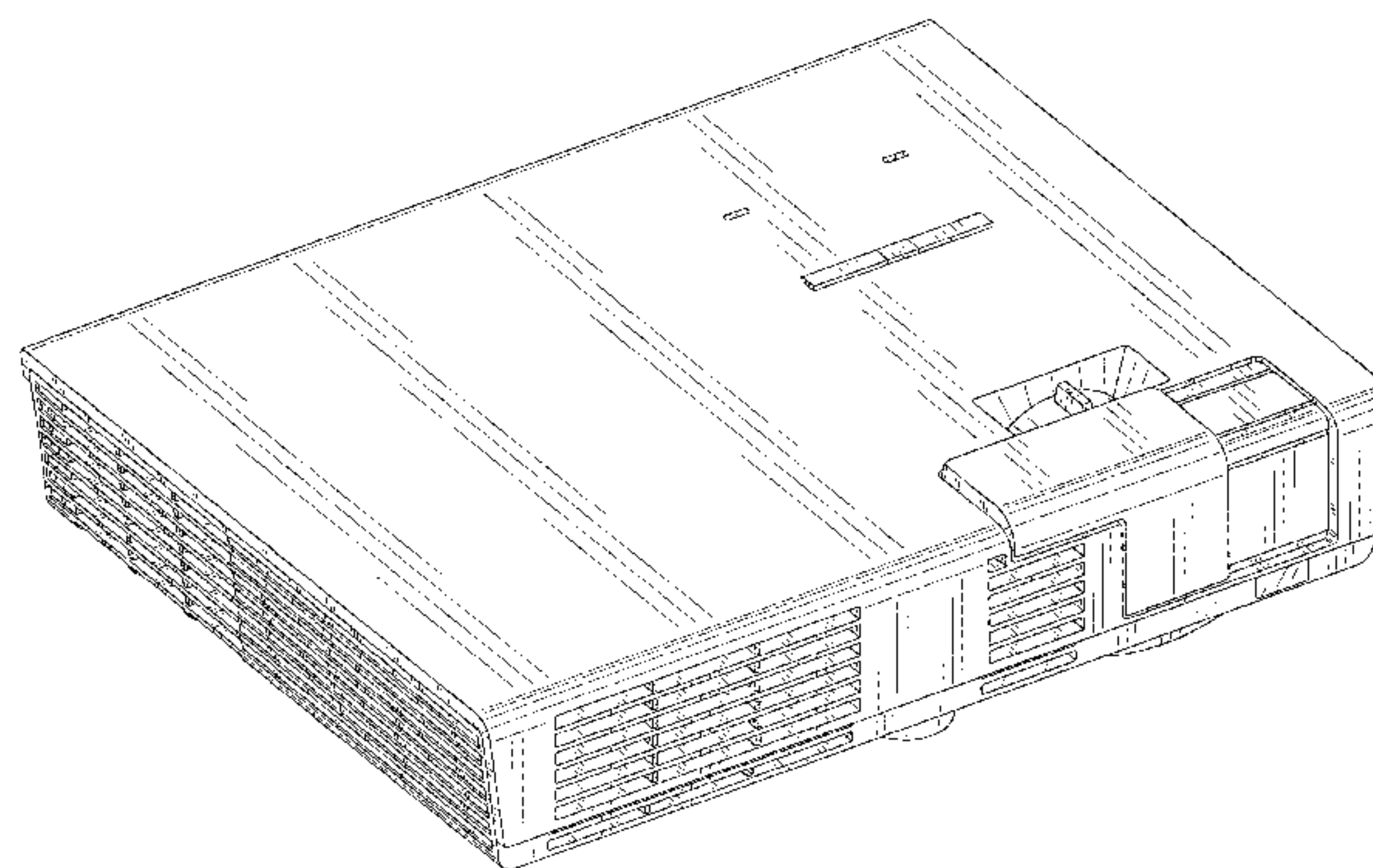
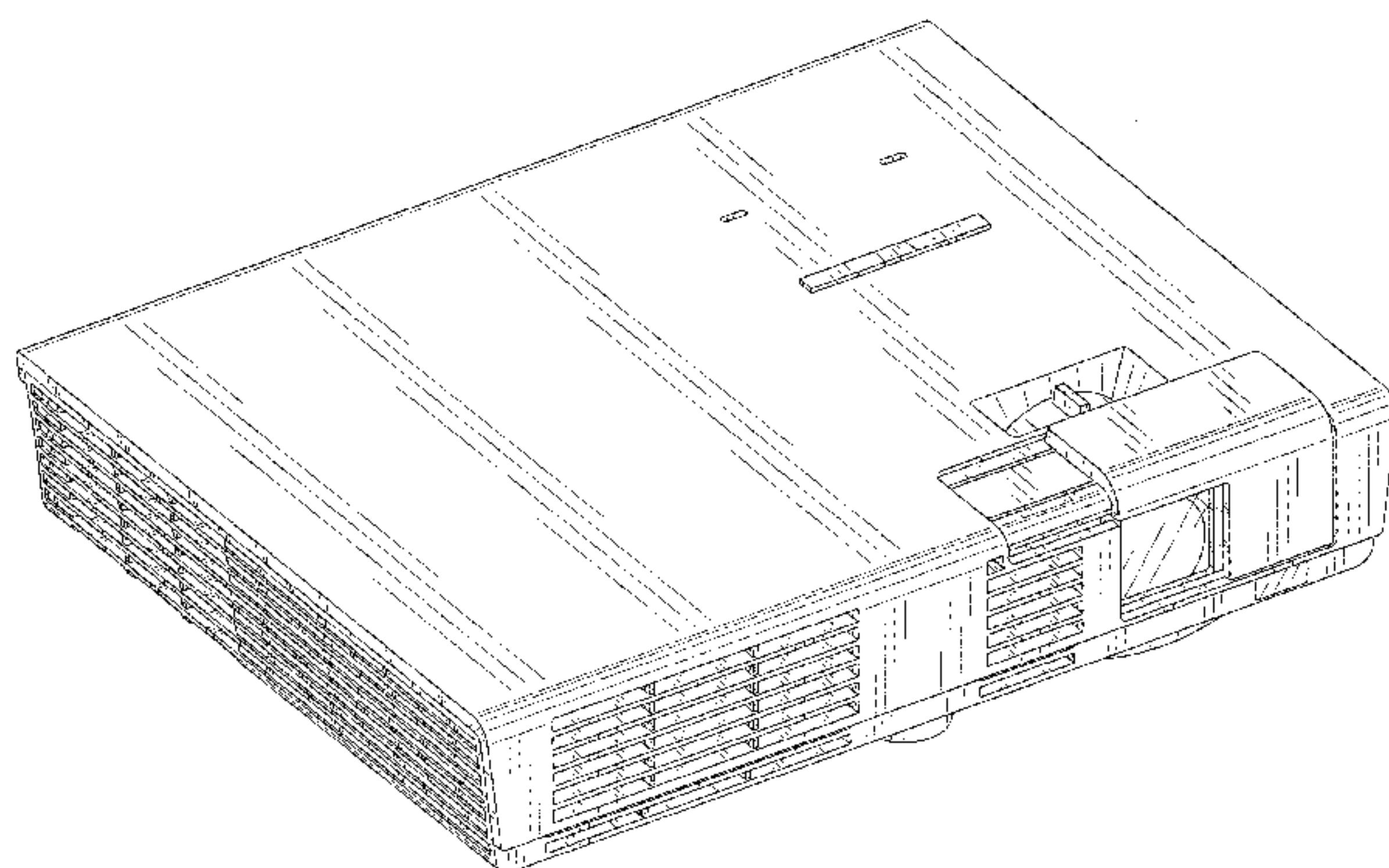
(57) **CLAIM**

The ornamental design for a projector, as shown and described.

DESCRIPTION

FIG. 1 is a front, left side, top perspective view of a projector showing our new design;
FIG. 2 is a slightly enlarged front elevational view thereof;
FIG. 3 is a slightly enlarged rear elevational view thereof;
FIG. 4 is a slightly enlarged left side elevational view thereof;
FIG. 5 is a slightly enlarged right side elevational view thereof;
FIG. 6 is a slightly enlarged top plan view thereof;
FIG. 7 is a slightly enlarged bottom plan view thereof; and,
FIG. 8 is a front, left side, top perspective view thereof showing a state in which a lens cover is closed.
Portions of the projector shown in broken lines form no part of the claimed design.

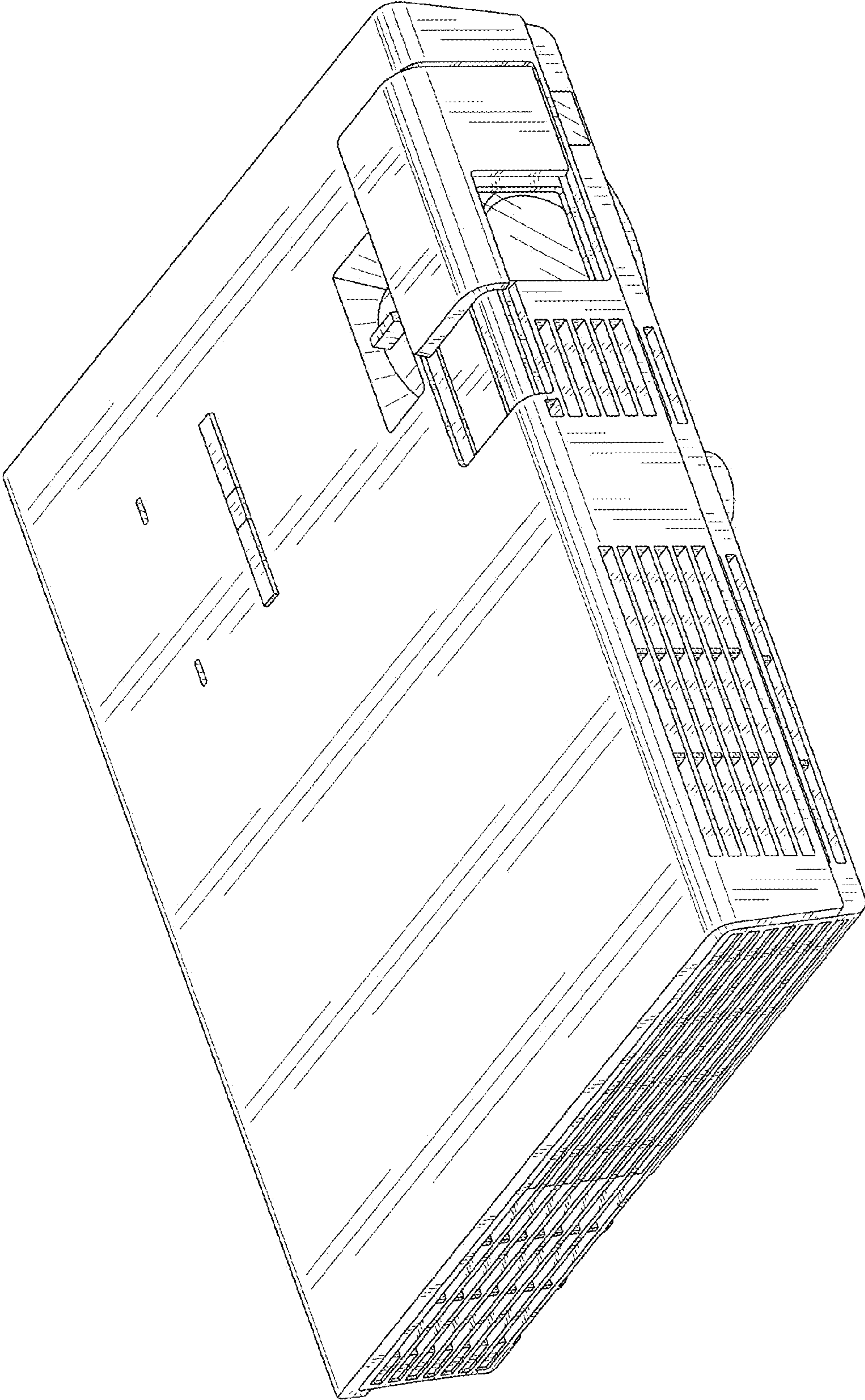

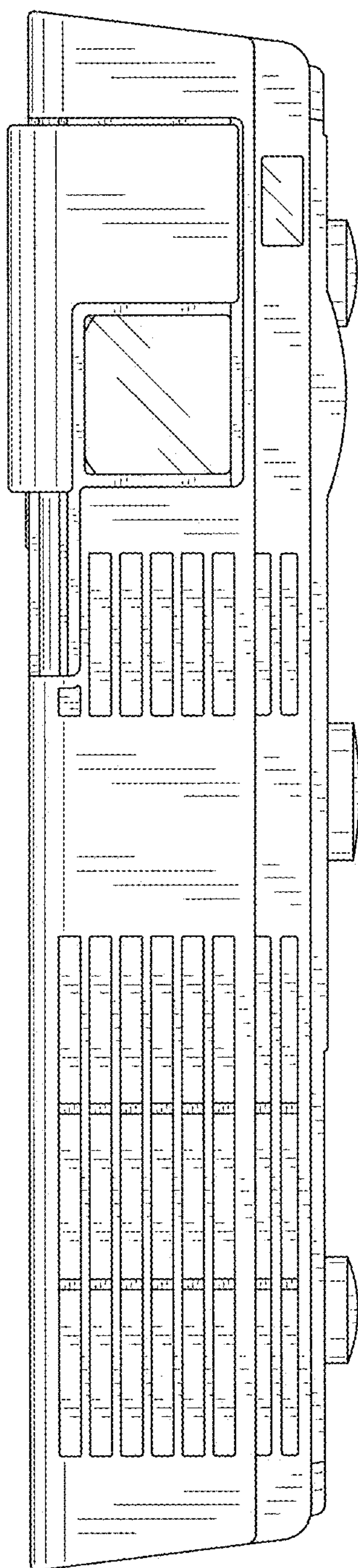

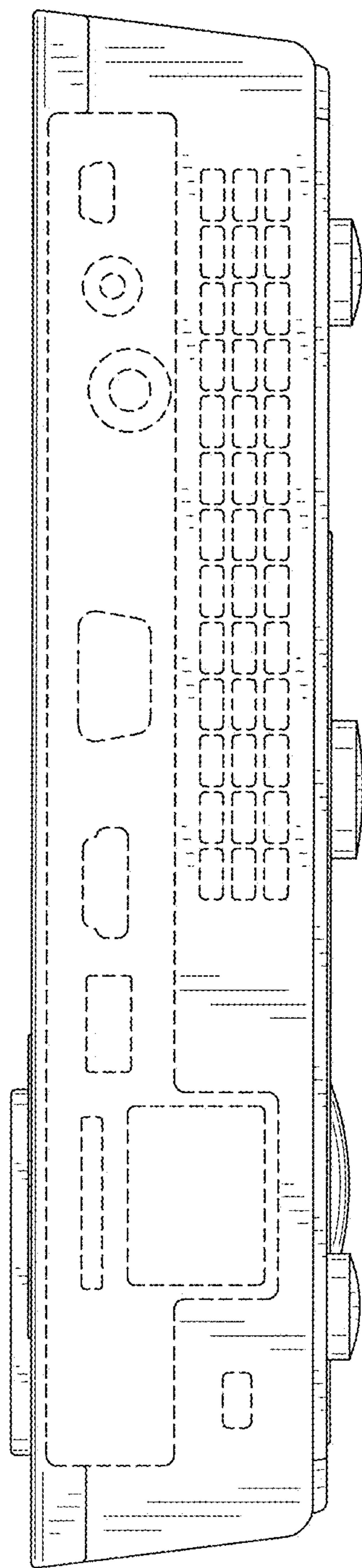

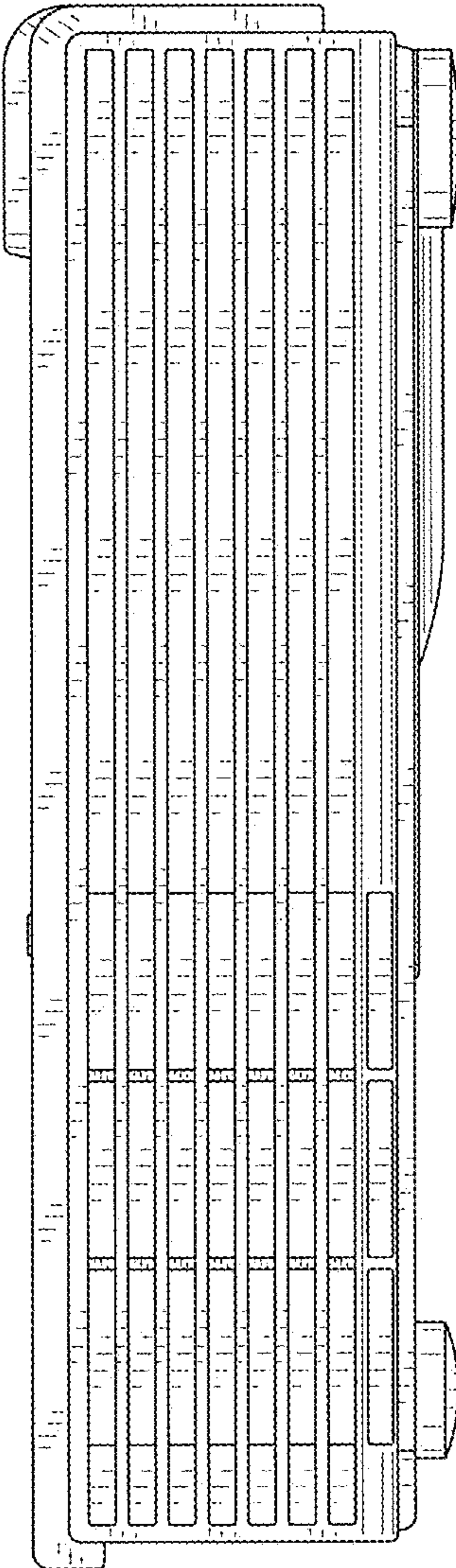

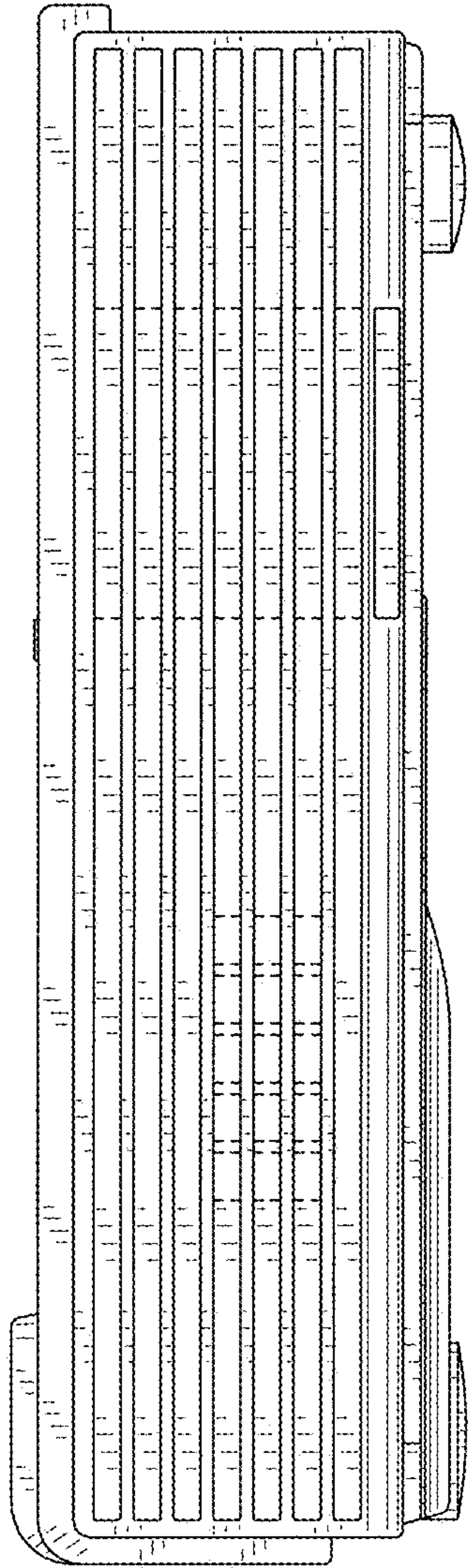

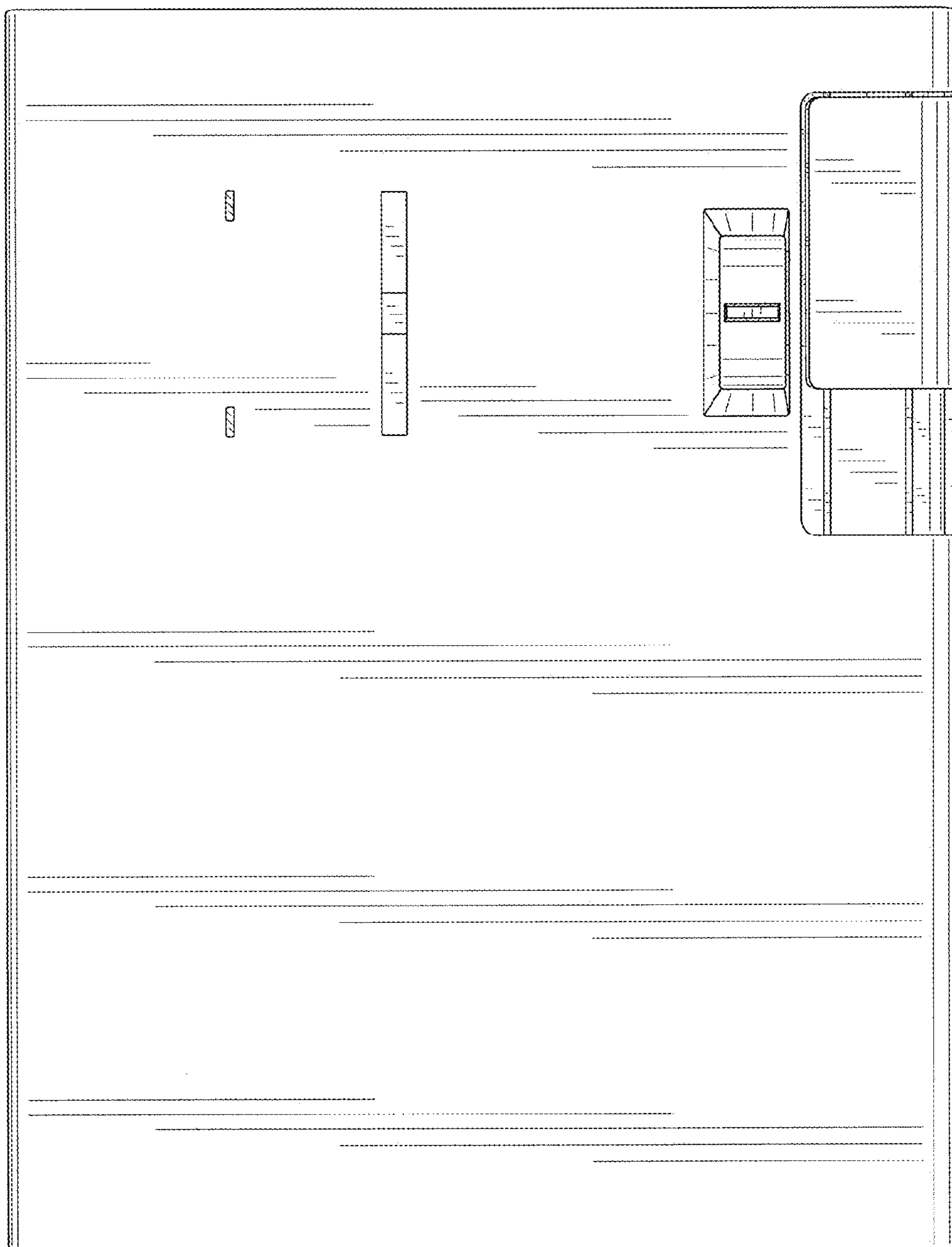

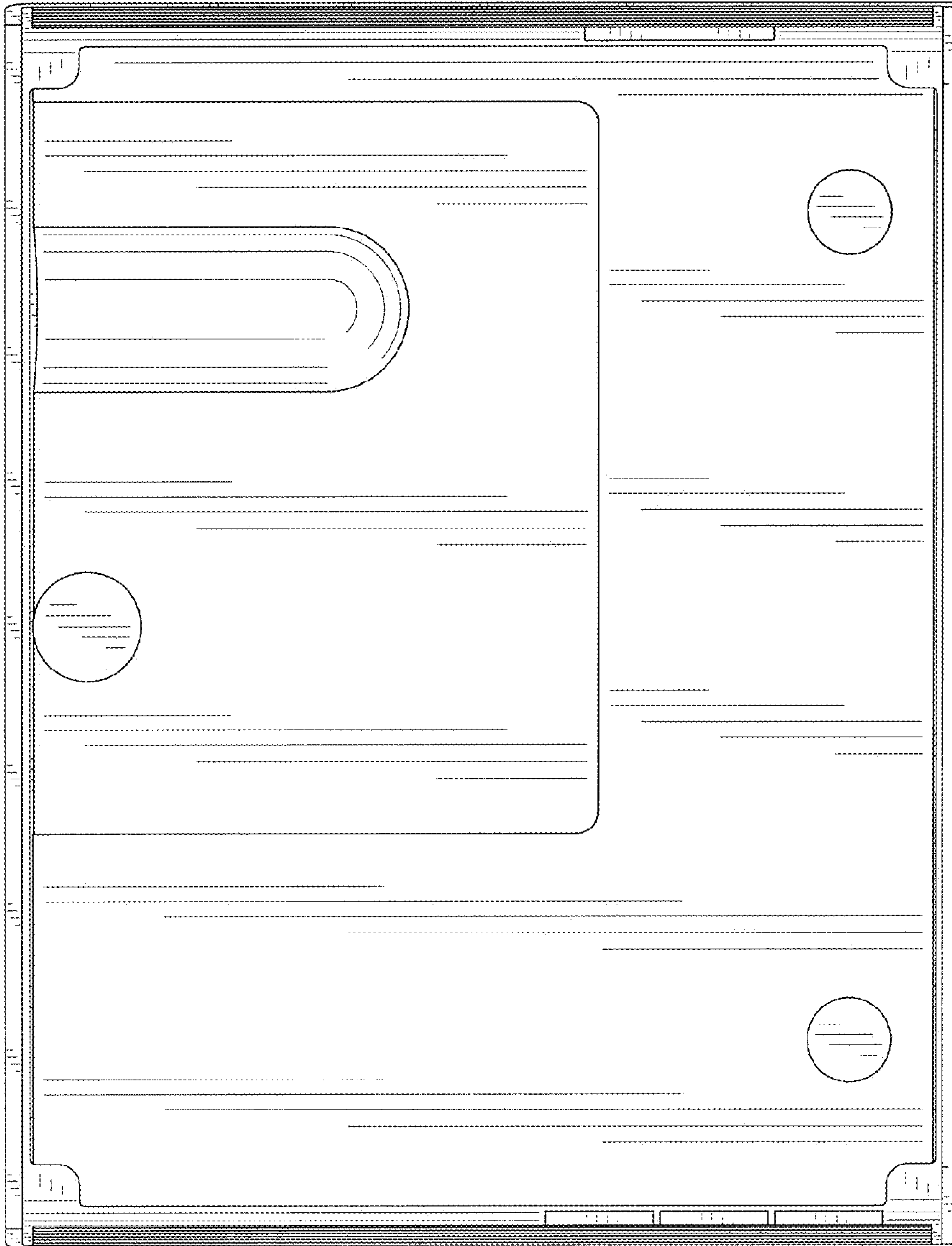

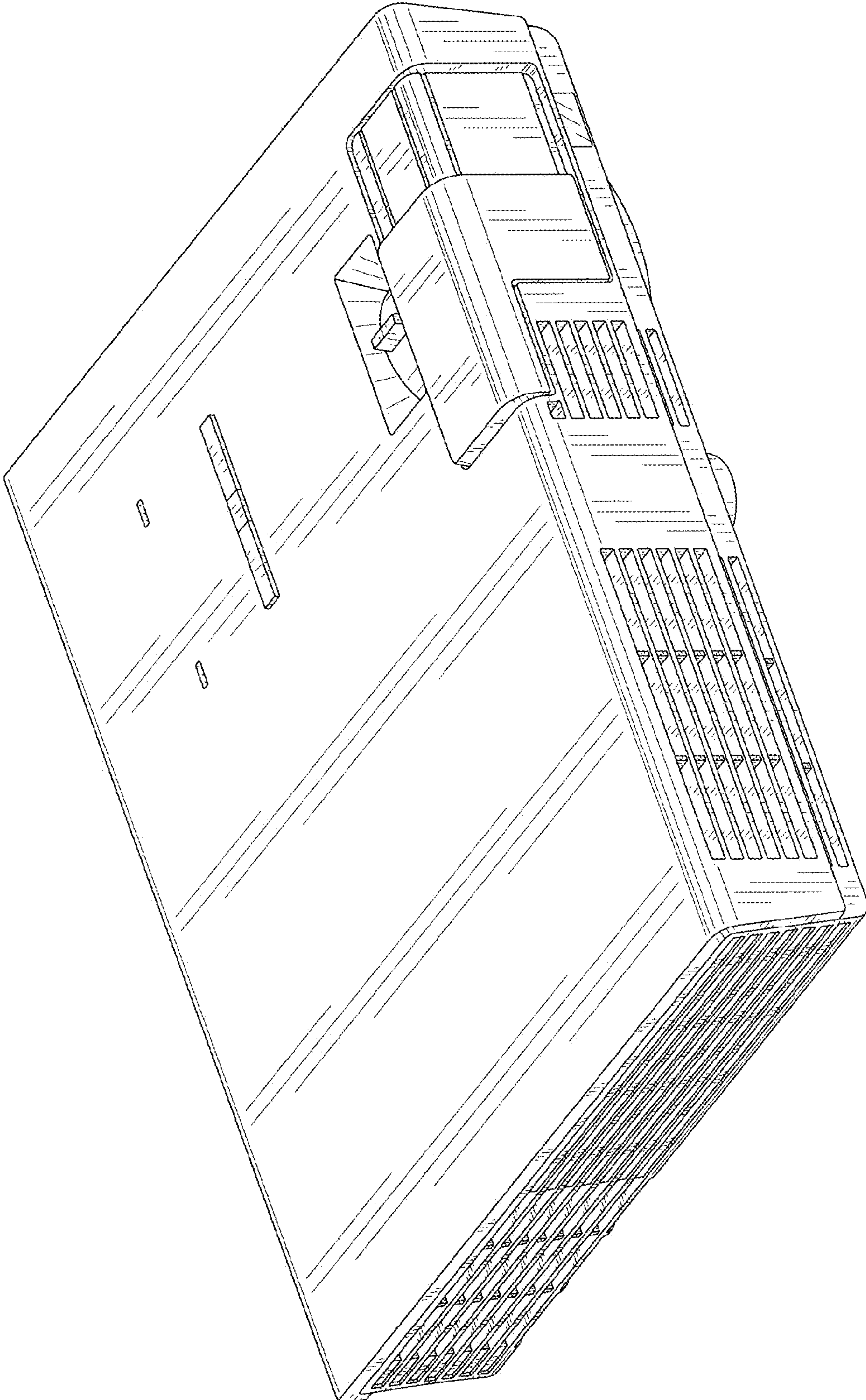
