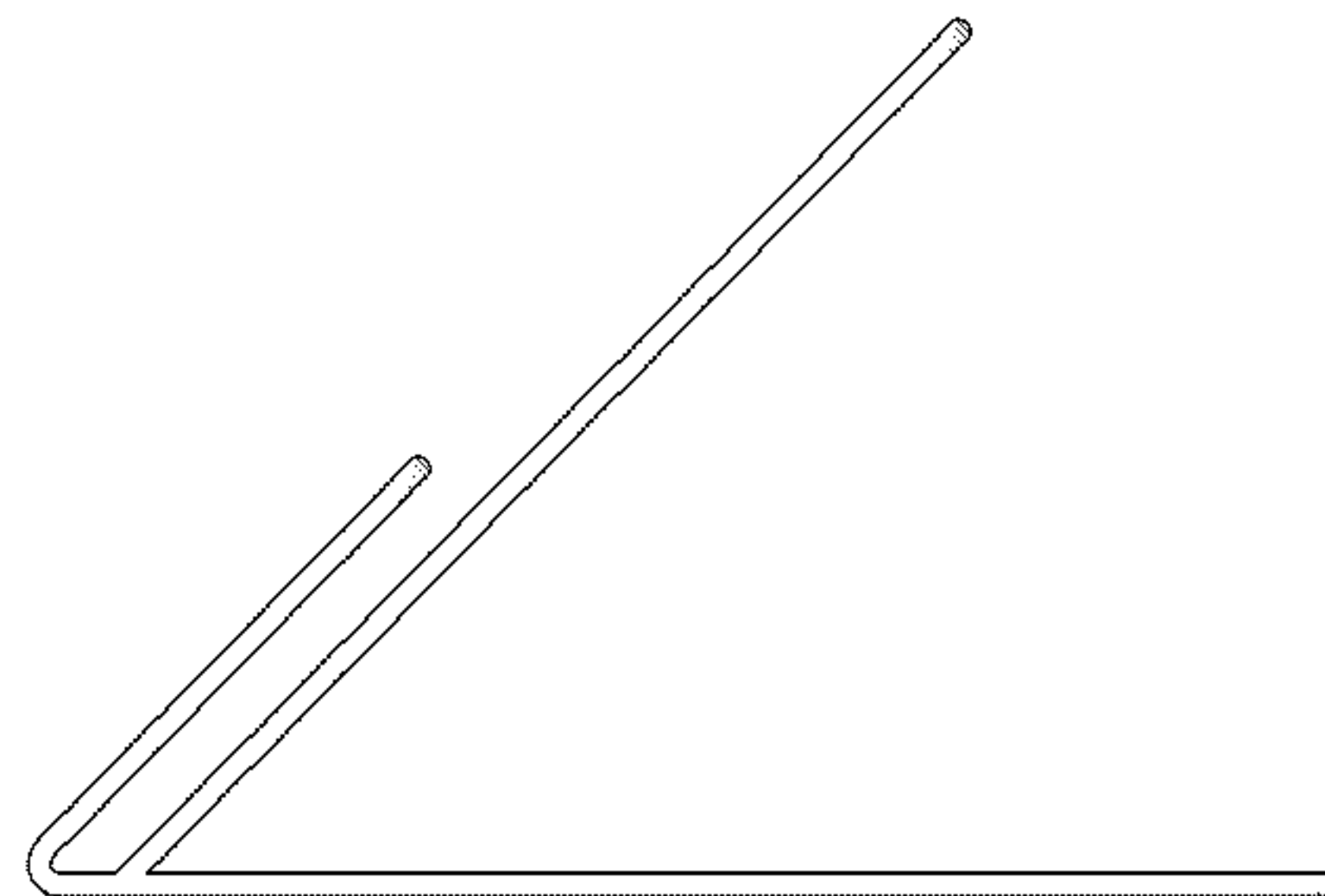
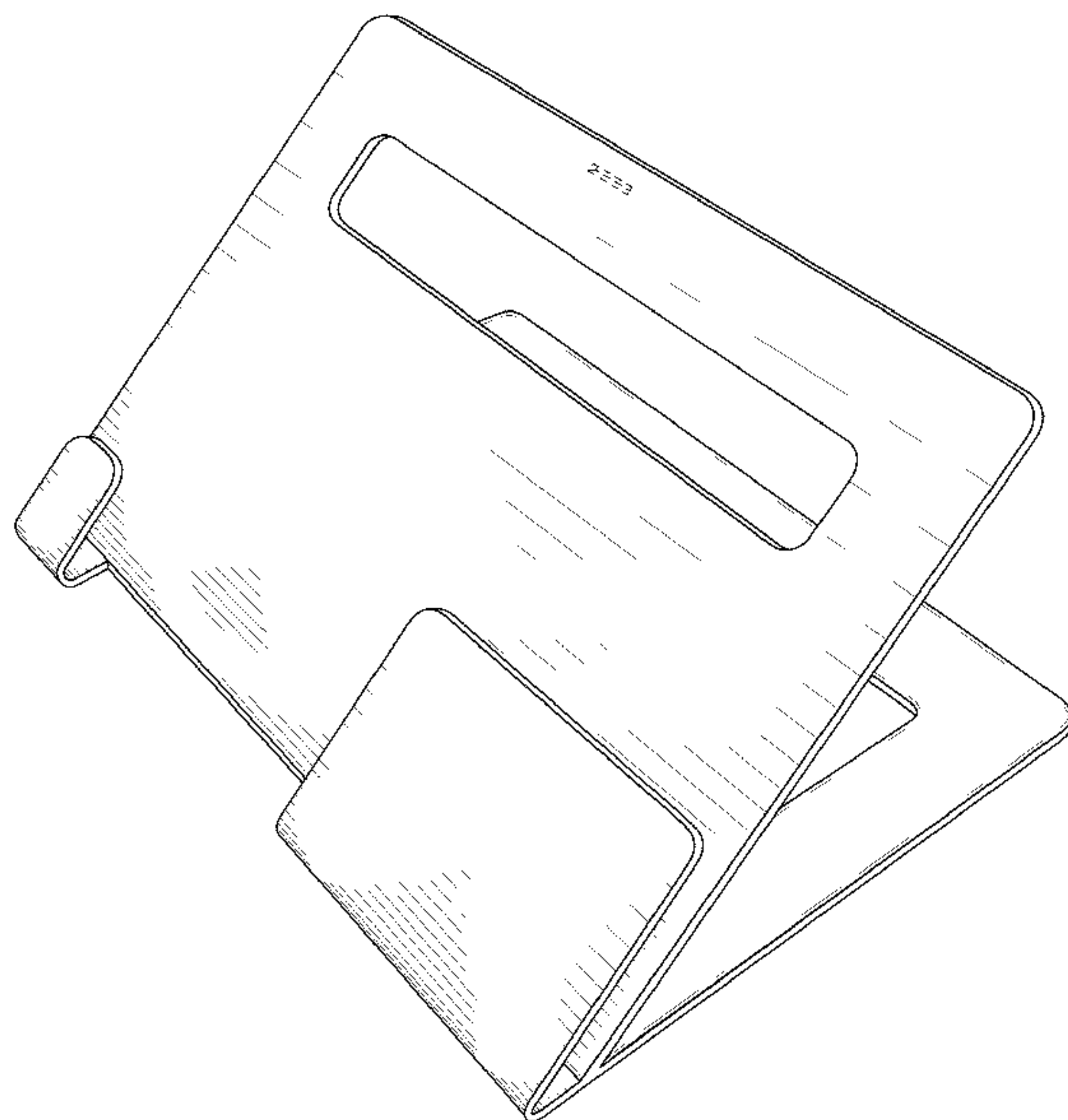

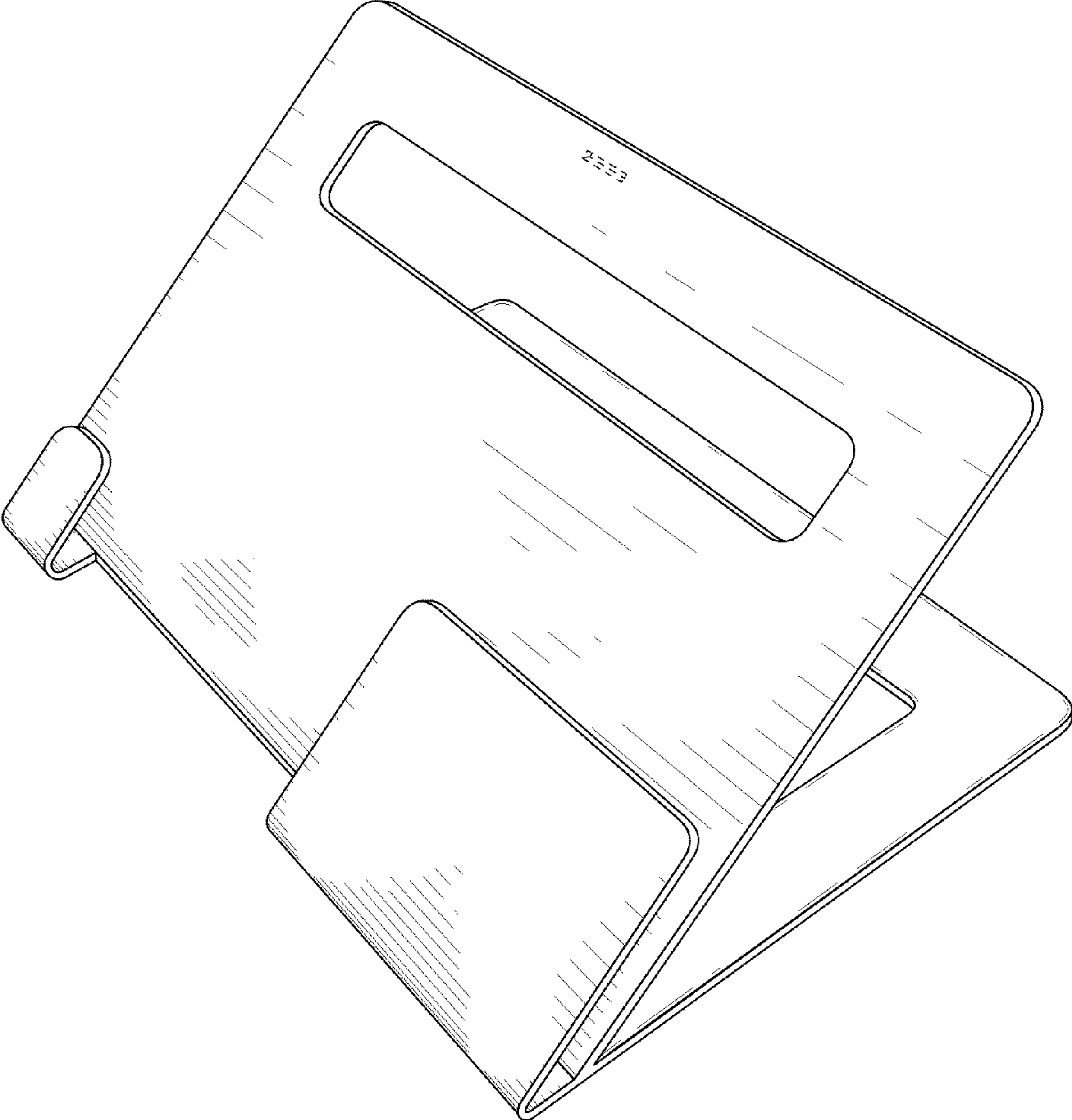
The ornamental design for a book stand, as shown and described.

**DESCRIPTION**

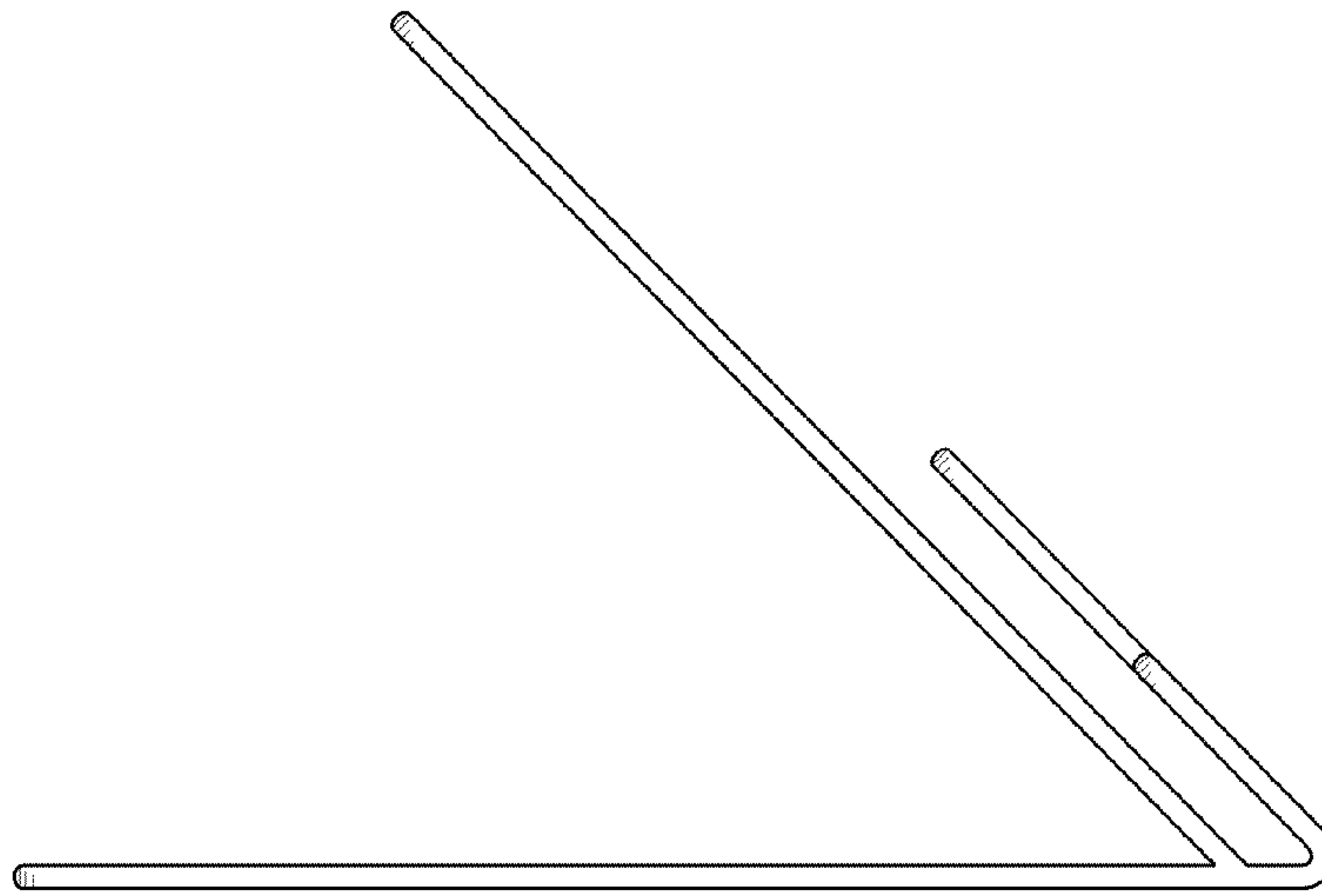
FIG. 1 is a front perspective view of a book stand showing my new design;

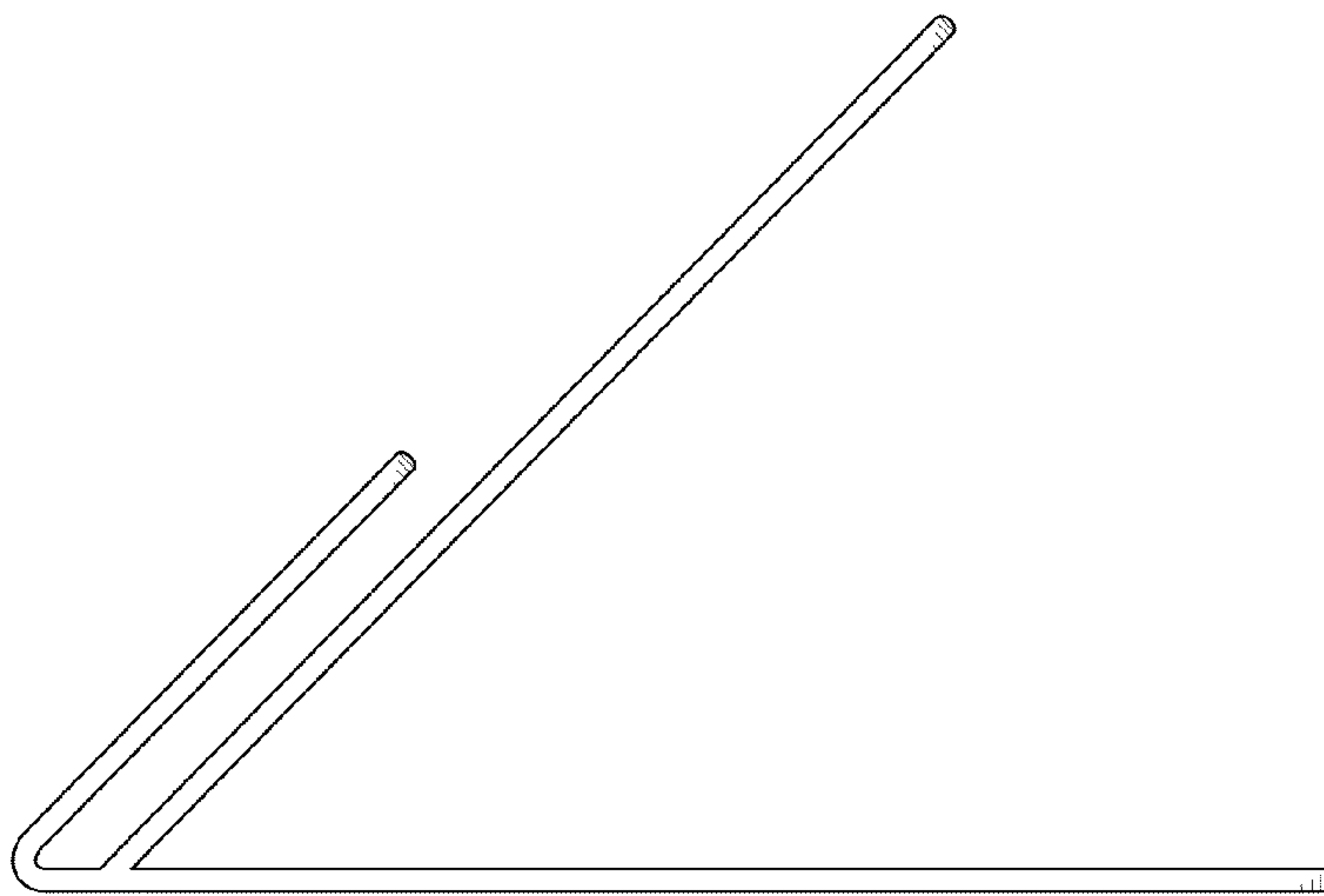




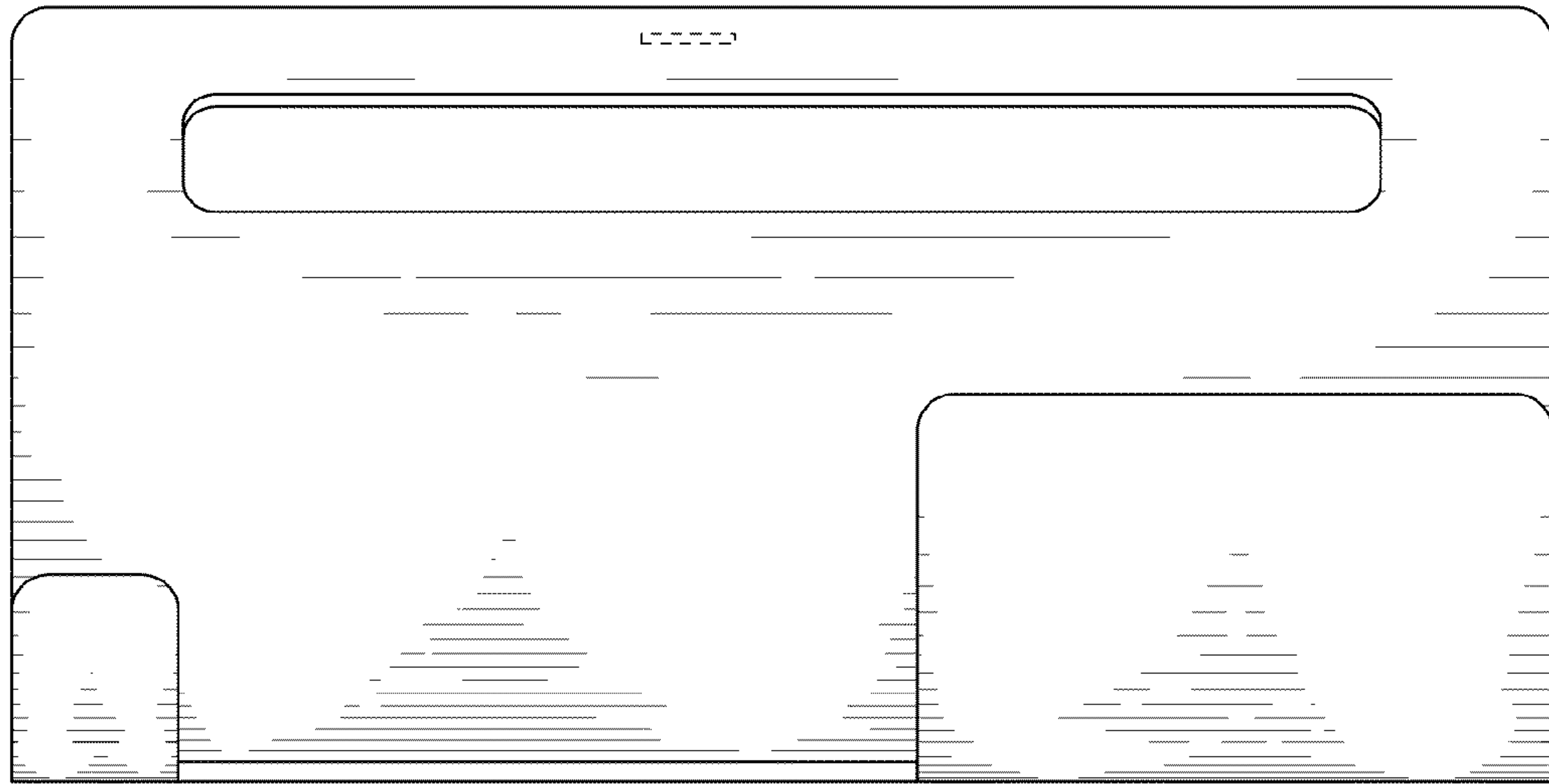

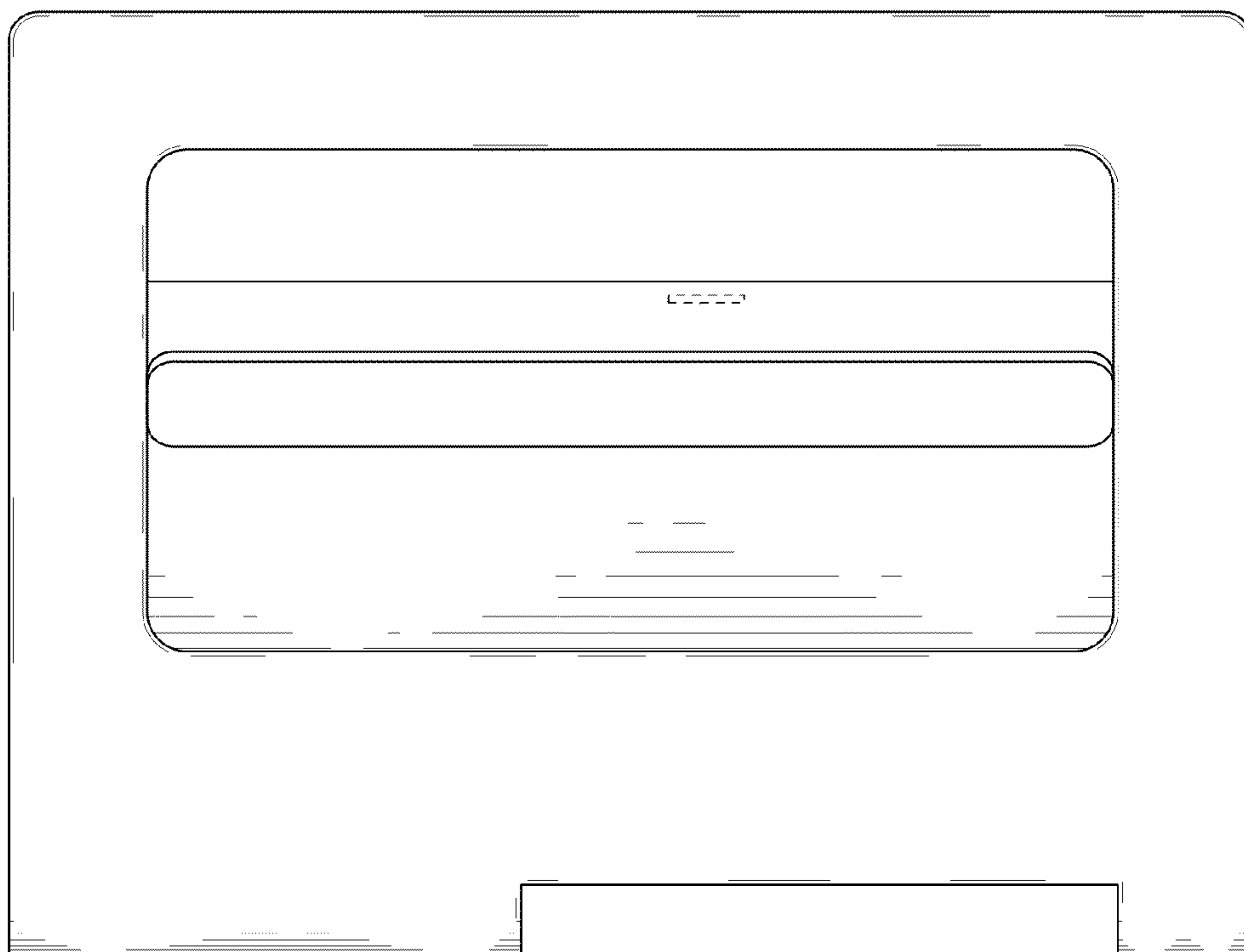

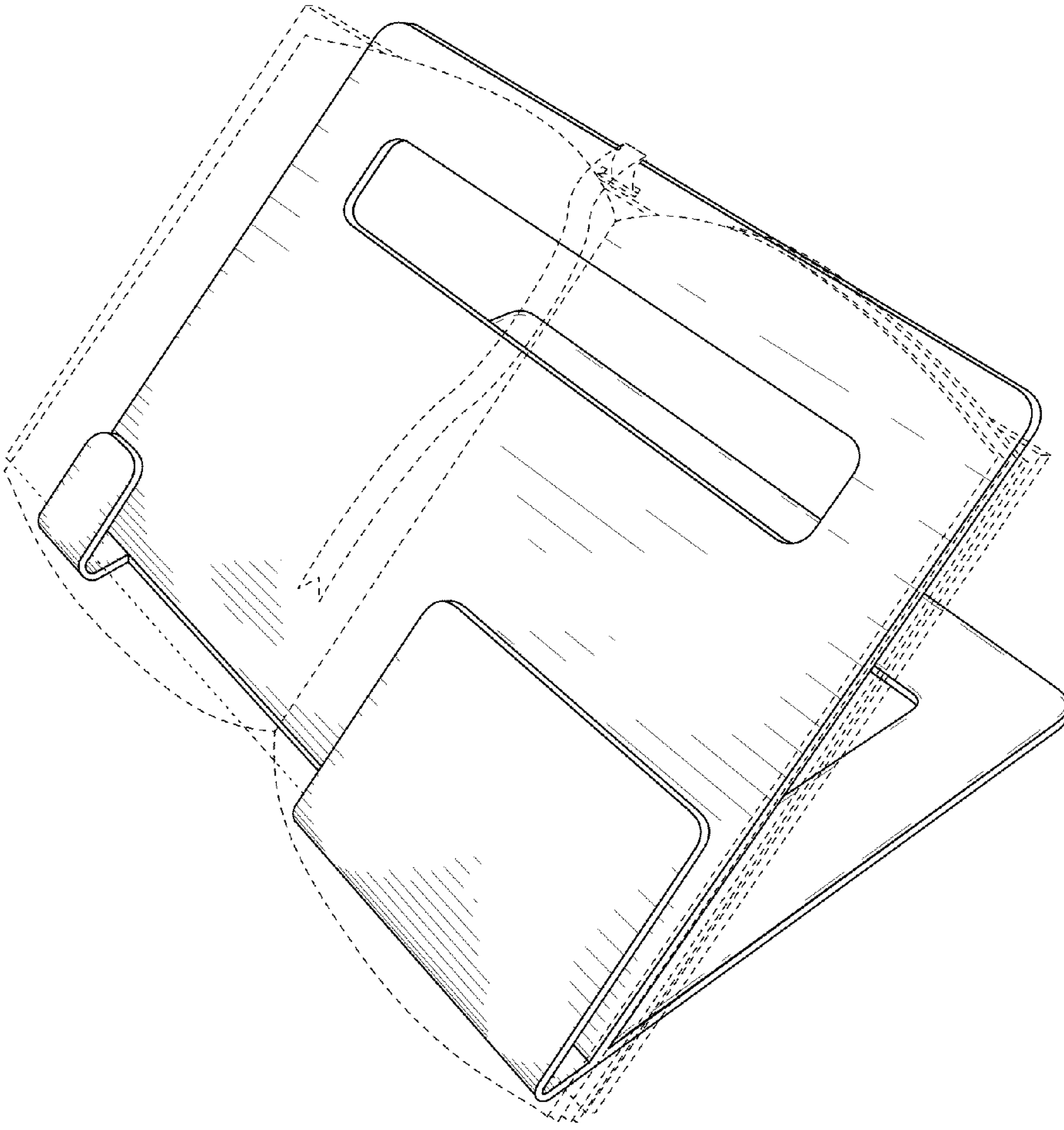
