The ornamental design for a frog lure, as shown and described.

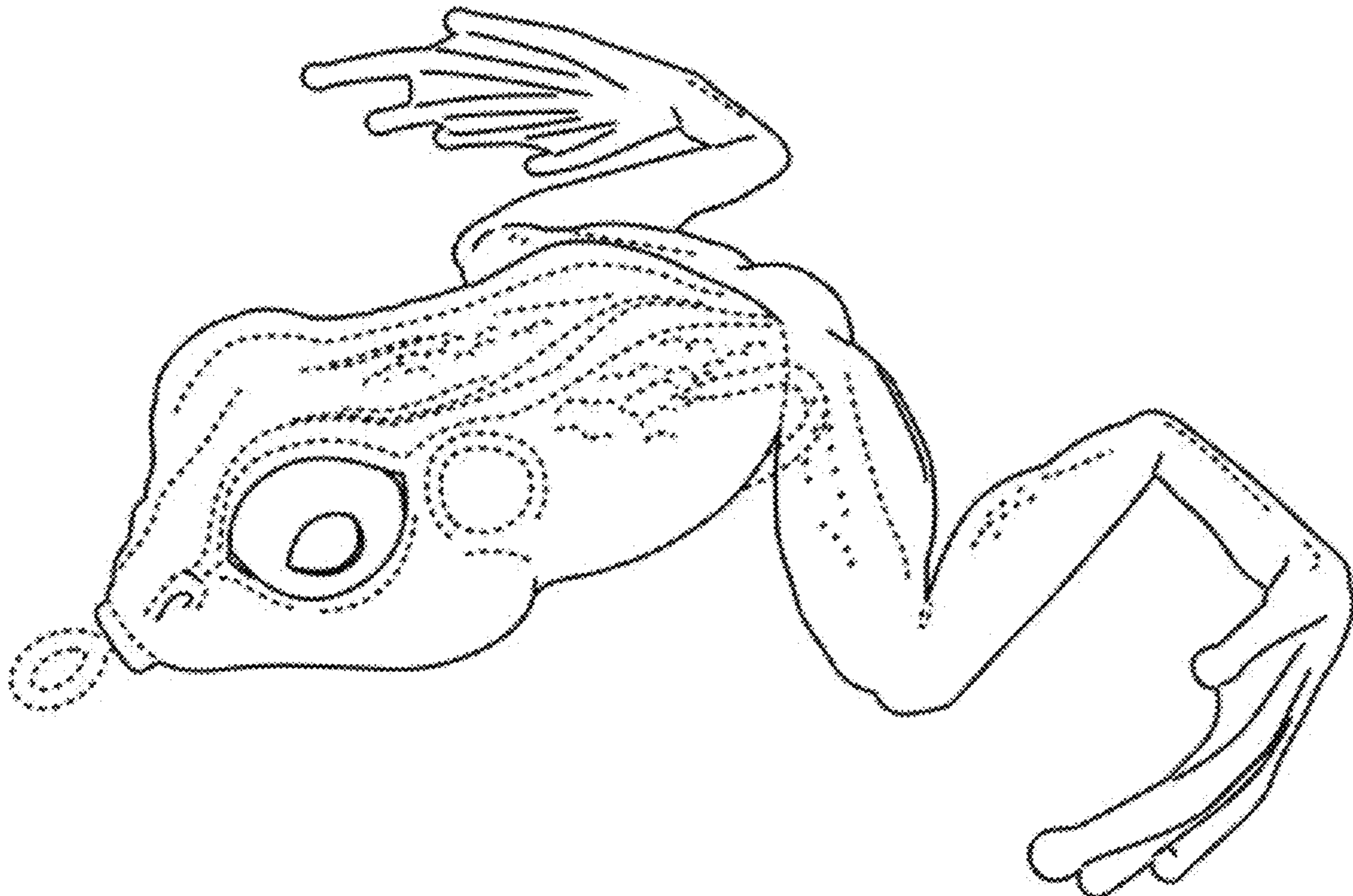
DESCRIPTION

FIG. 1 is a top view of the frog lure of the invention;
FIG. 2 is a right side view of the frog lure of the invention;
FIG. 3 is a left side perspective view of the frog lure of the invention;

FIG. 4 is a rear view of the frog lure of the invention;
FIG. 5 is a bottom view of the frog lure of the invention; and,

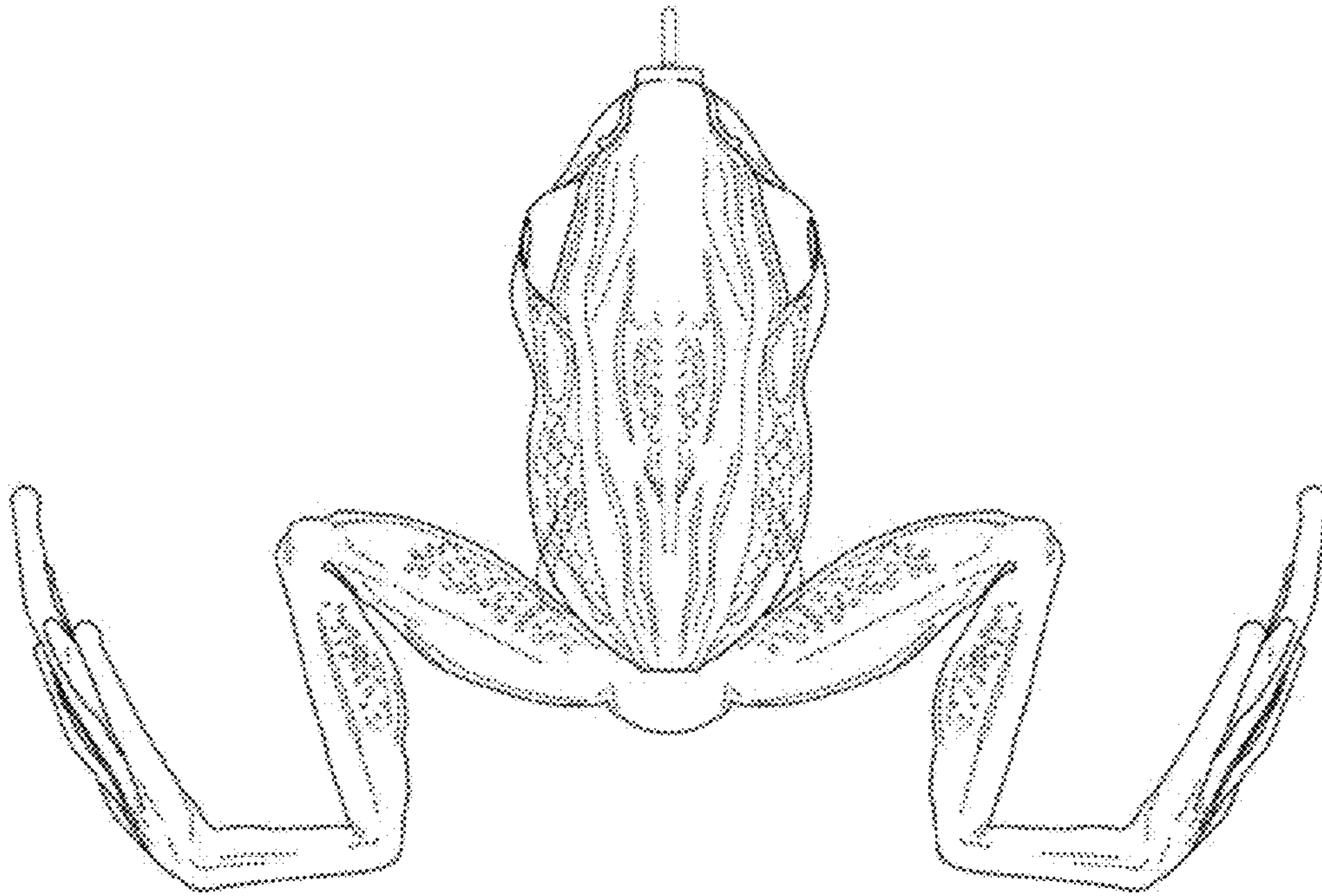

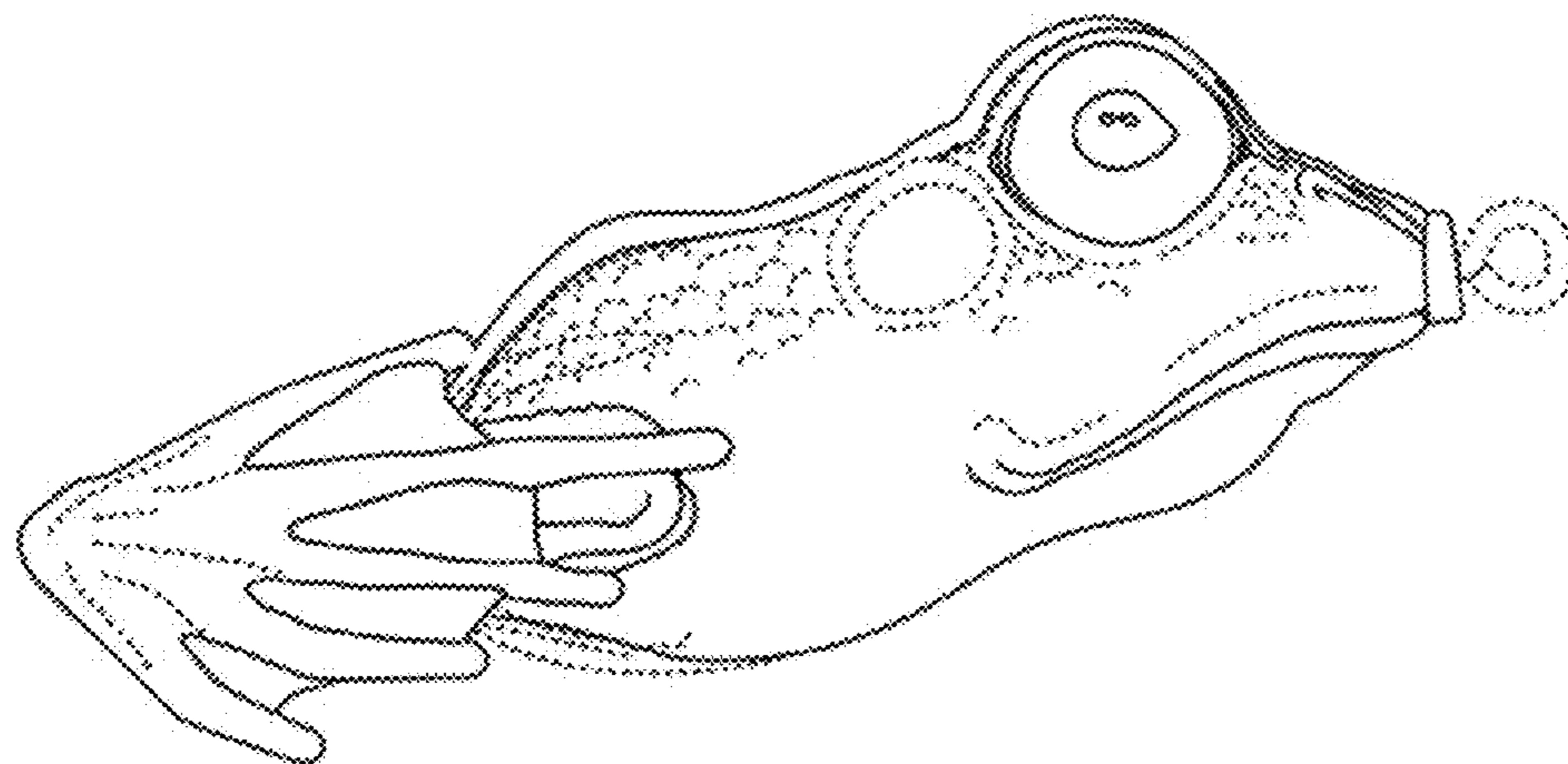

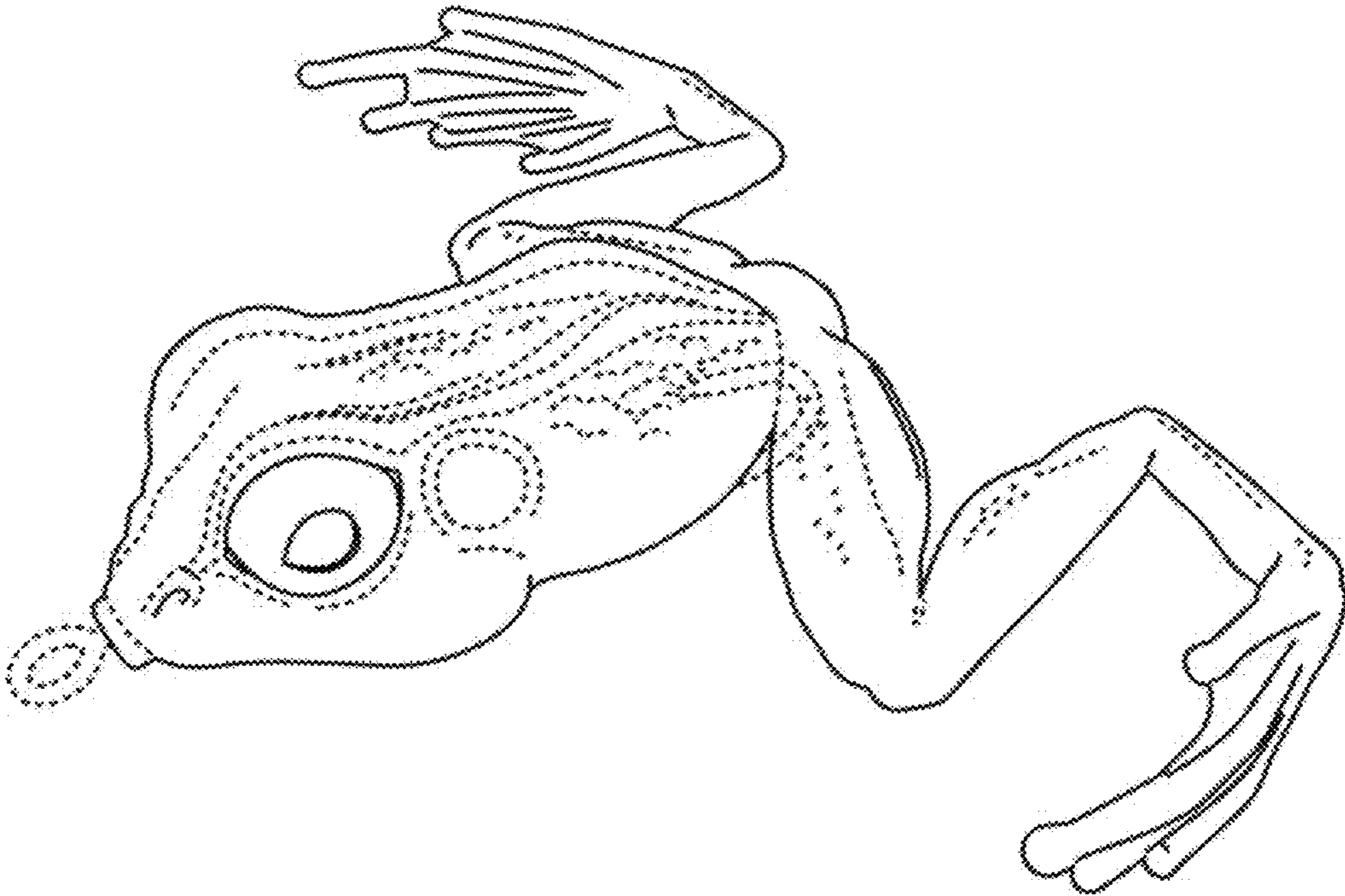

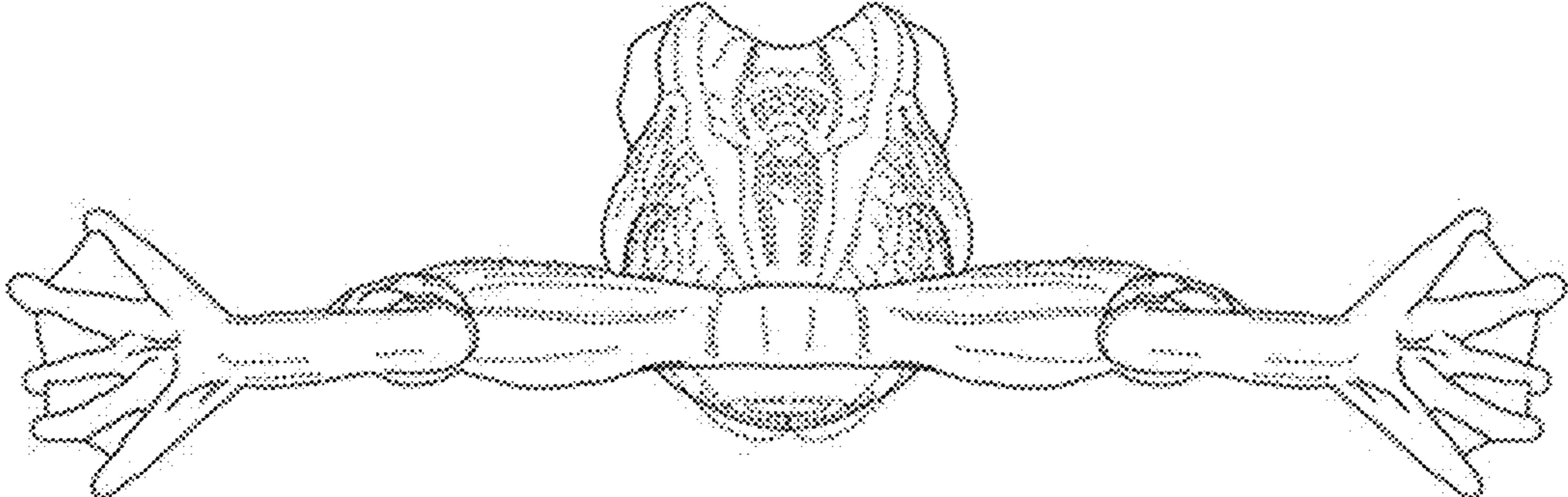

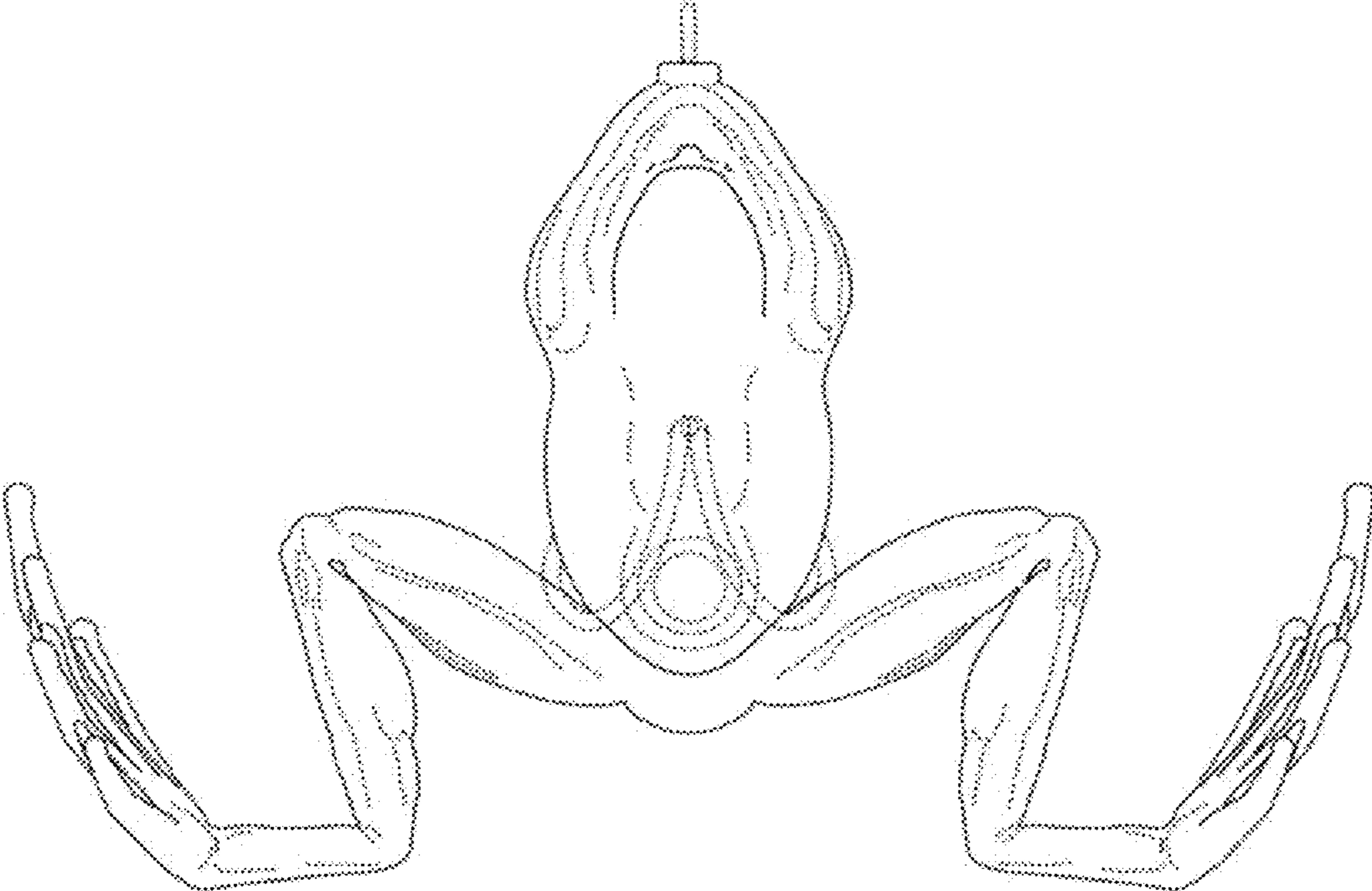

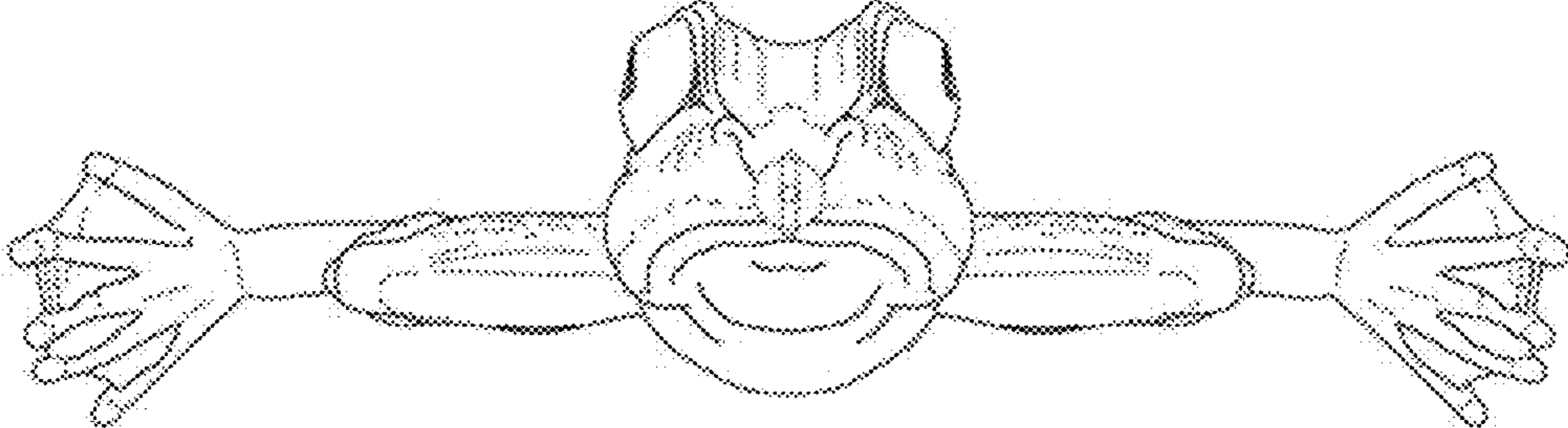
