(57) **CLAIM**

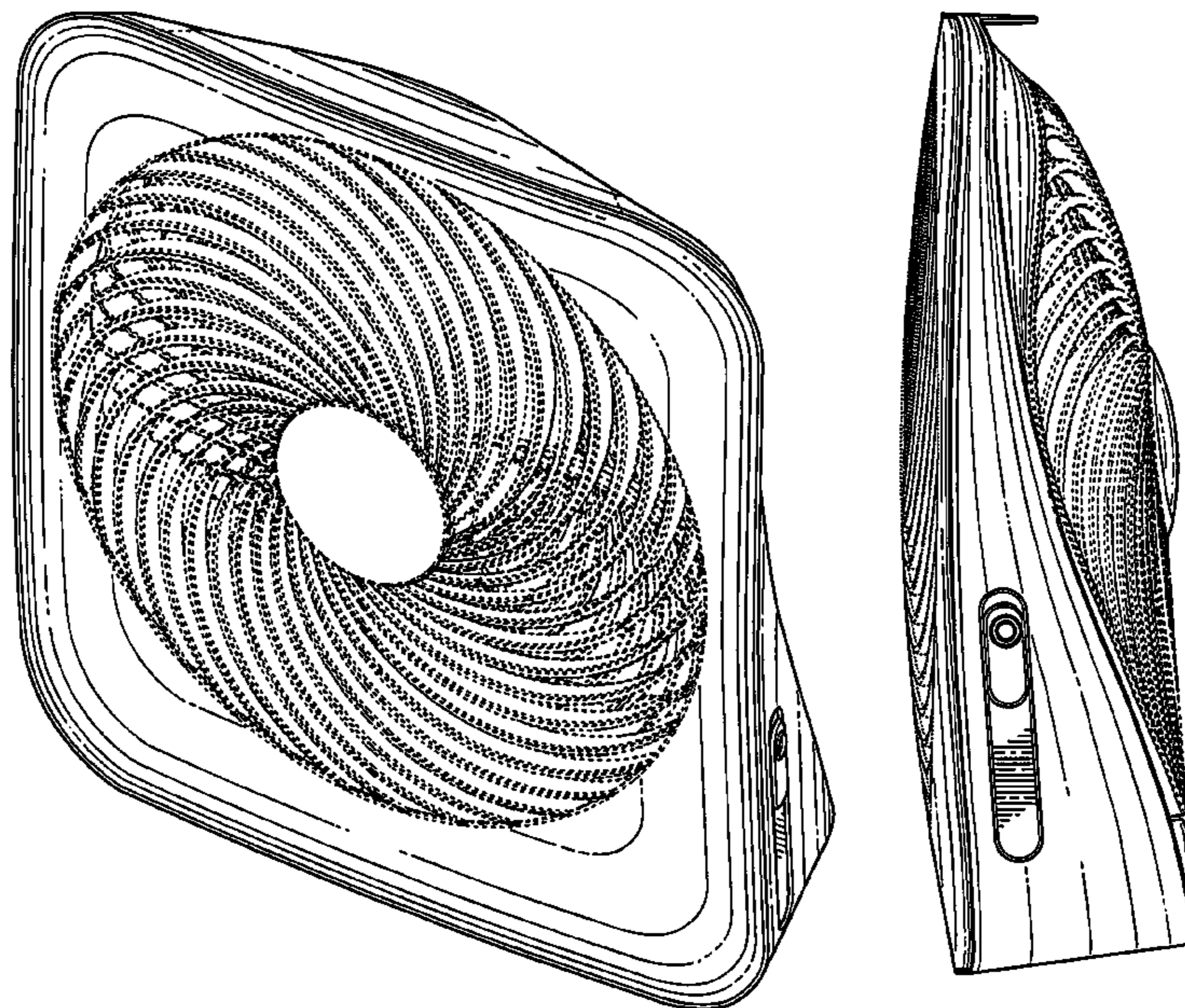
I claim the ornamental design for a smooth front fan enclosure, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the smooth front fan enclosure;
 FIG. 2 is a rear perspective view of the smooth front fan enclosure;
 FIG. 3 is a front elevational view of the smooth front fan enclosure;
 FIG. 4 is a rear elevational view of the smooth front fan enclosure;
 FIG. 5 is a side elevational view of the smooth front fan enclosure;
 FIG. 6 is a side elevational view of the opposed side of the smooth front fan enclosure;
 FIG. 7 is a top elevational view of the smooth front fan enclosure; and,
 FIG. 8 is a bottom elevational view of the smooth front fan enclosure.

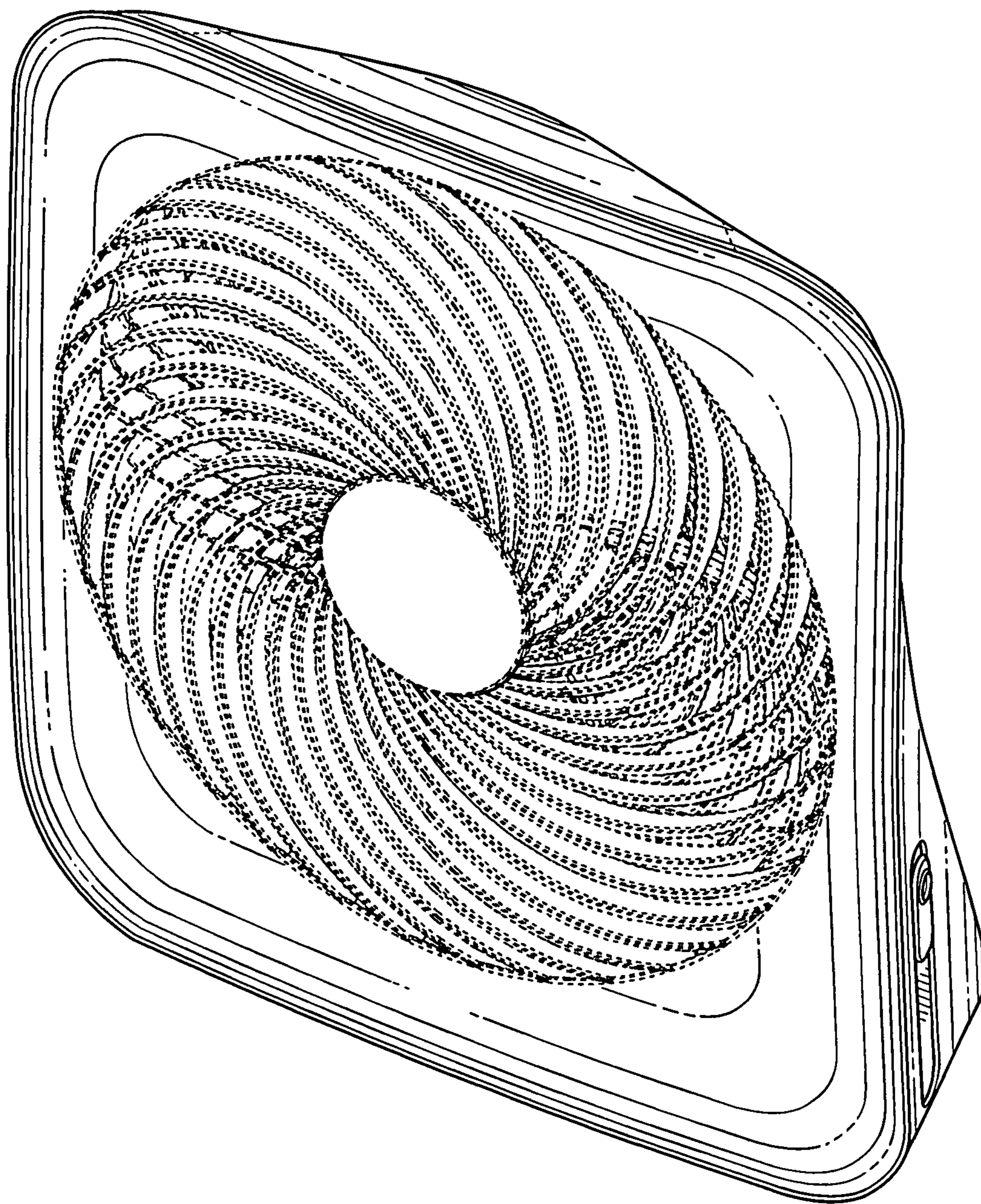

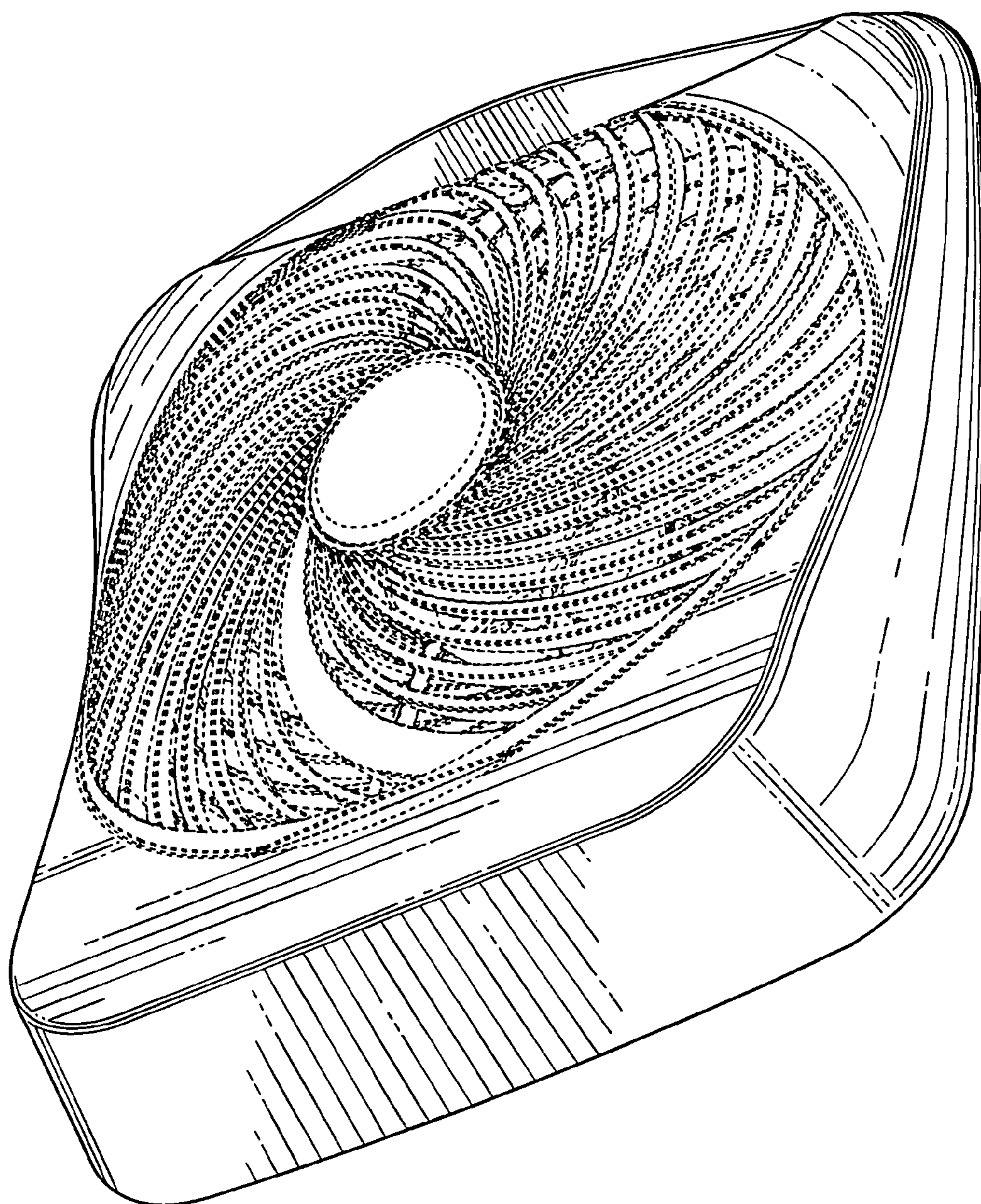

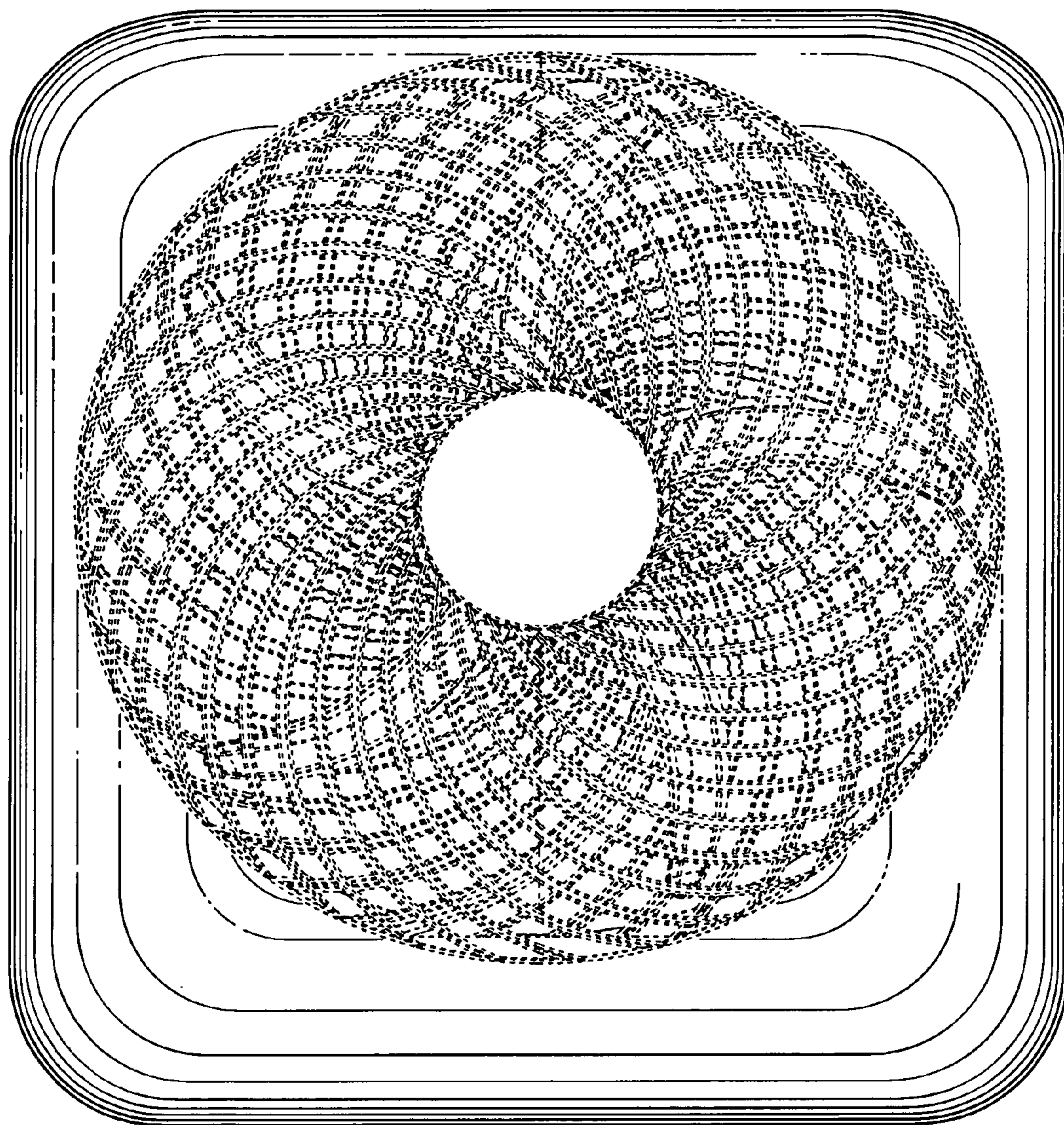

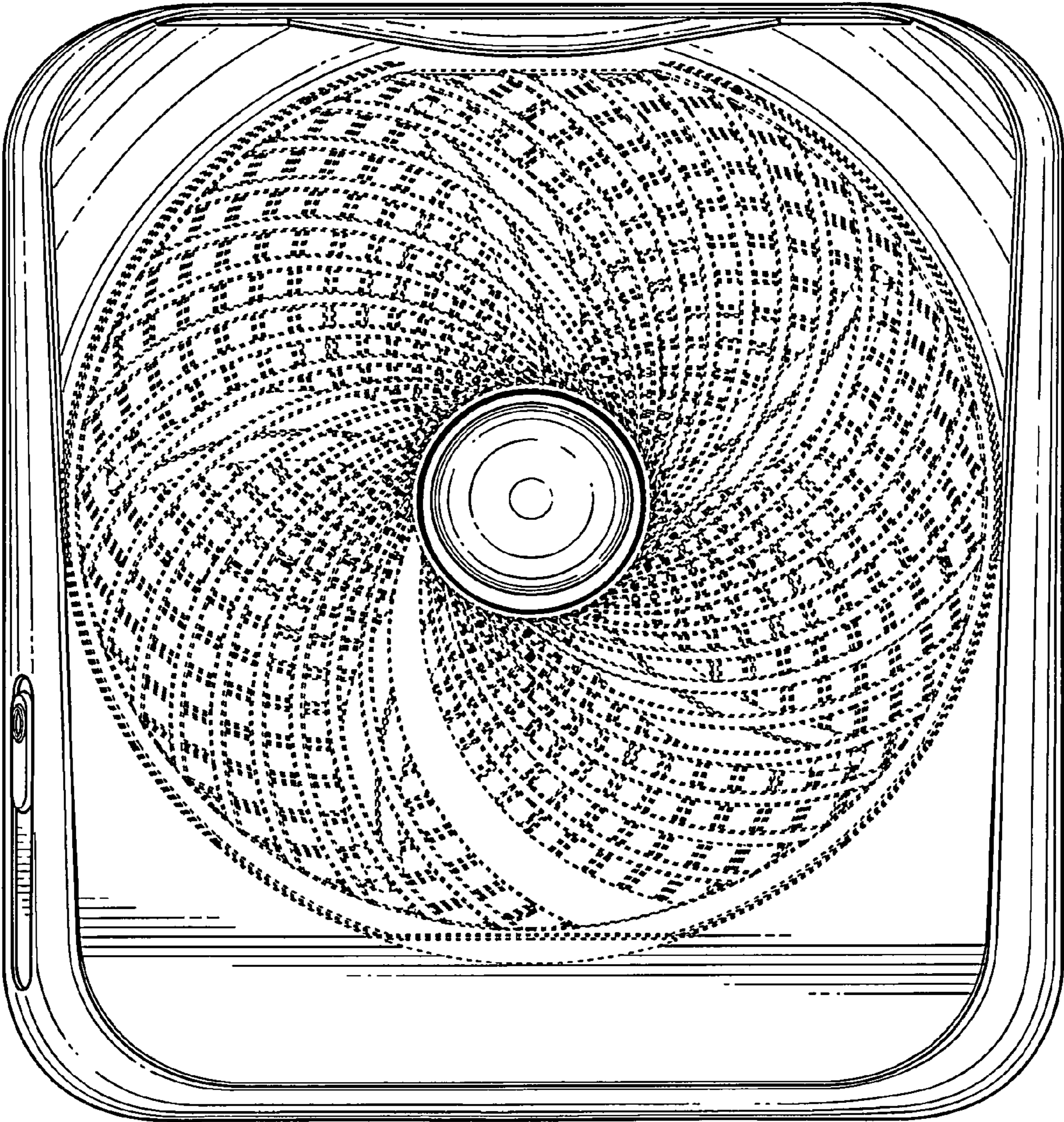

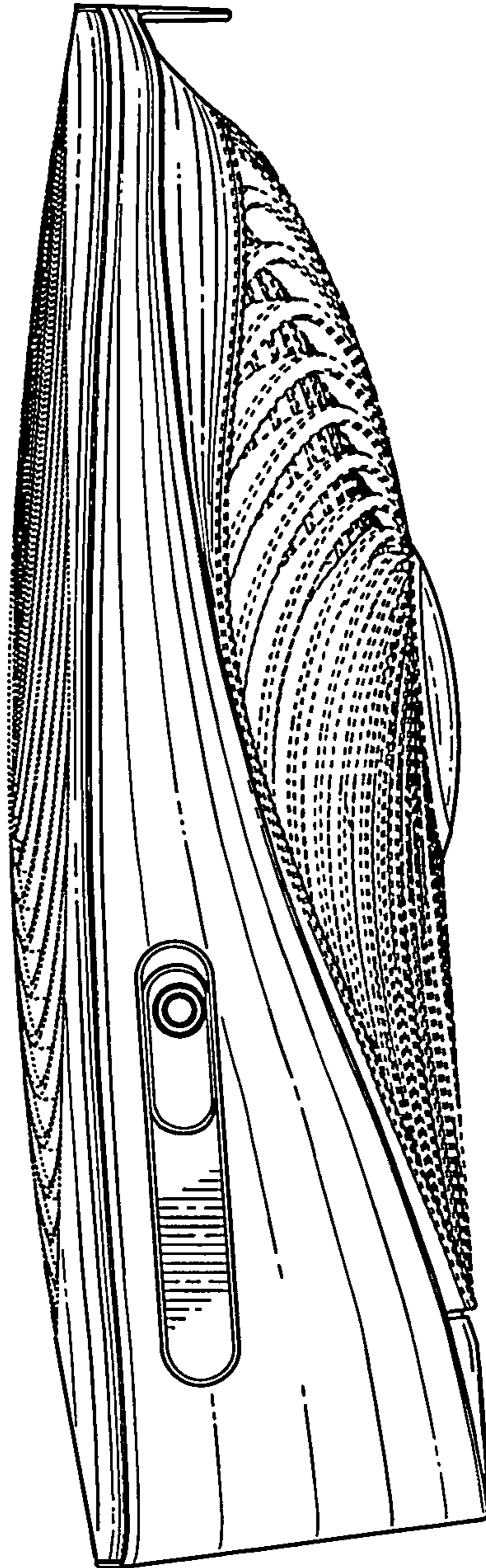

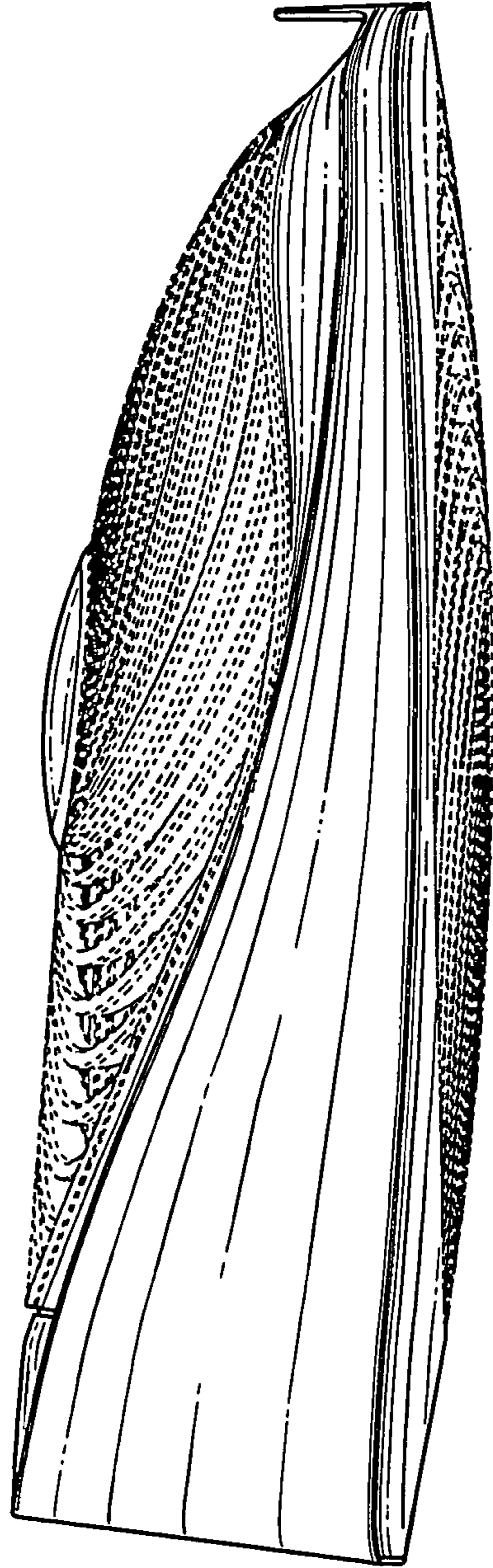

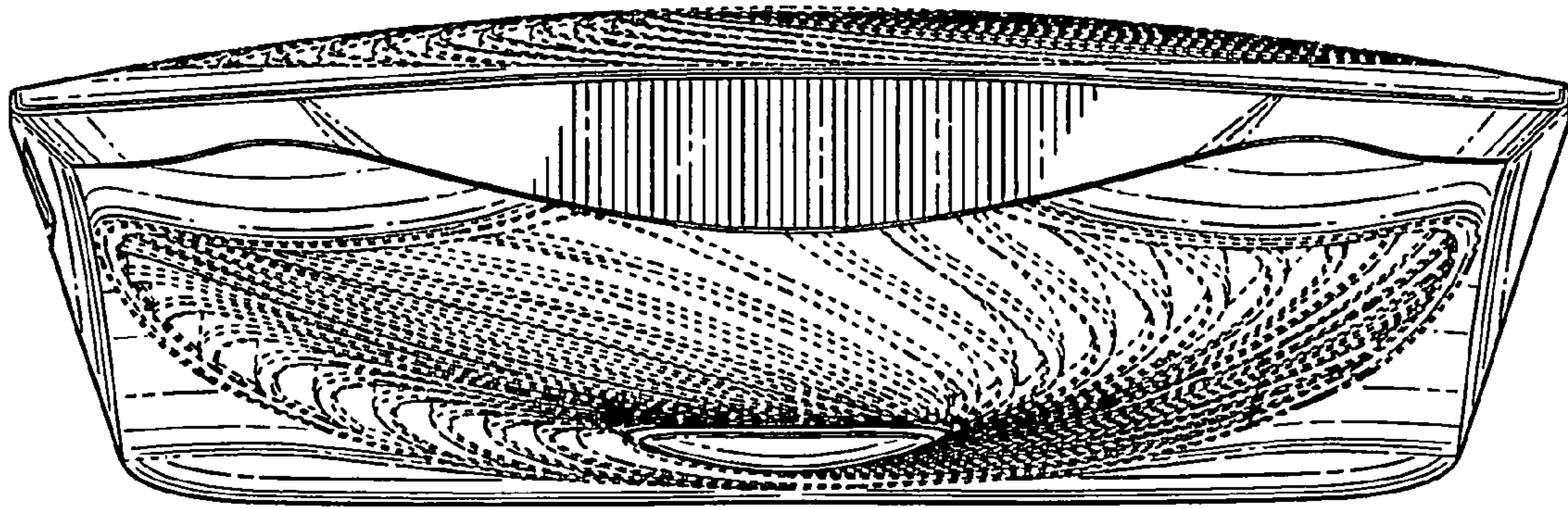

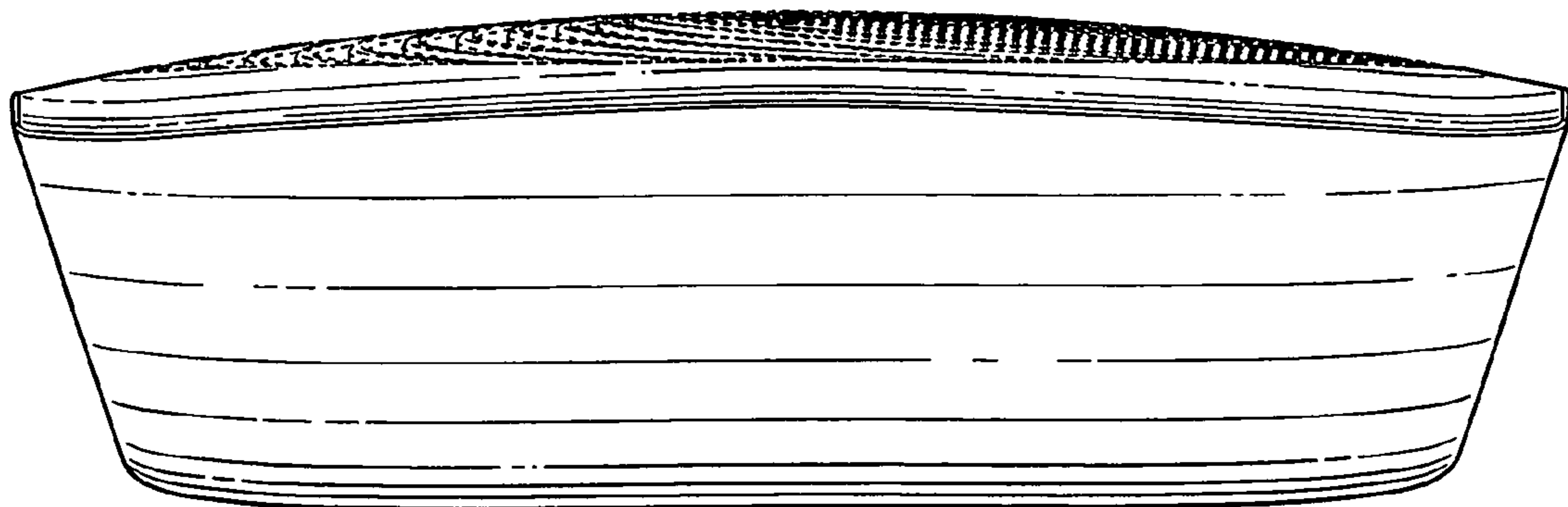
