**DESCRIPTION**

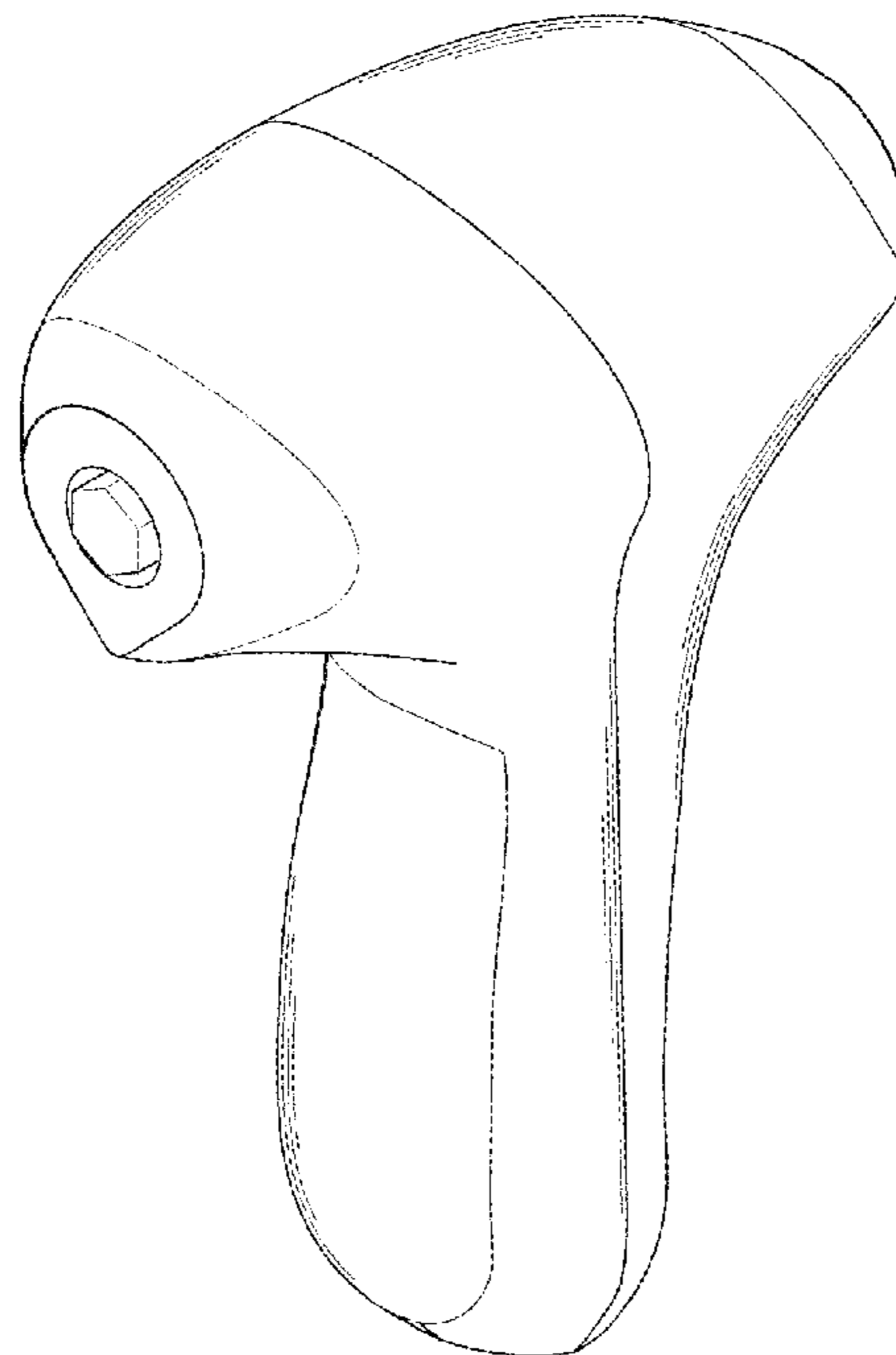
FIG. 1 is a perspective view of a pedicure machine showing my new design;

 The broken lines shown in the drawings illustrate portions of the article and form no part of the claimed design.

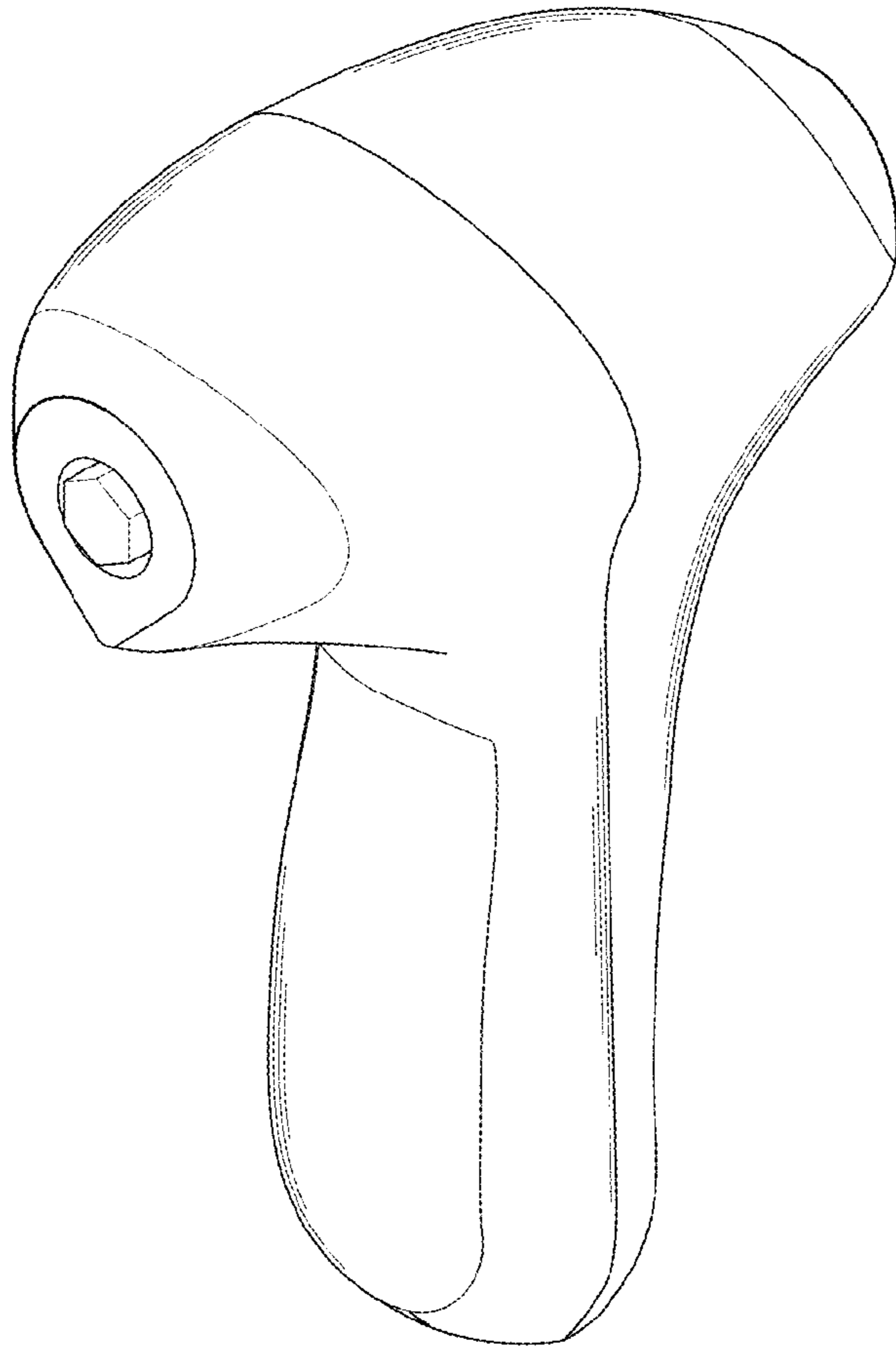

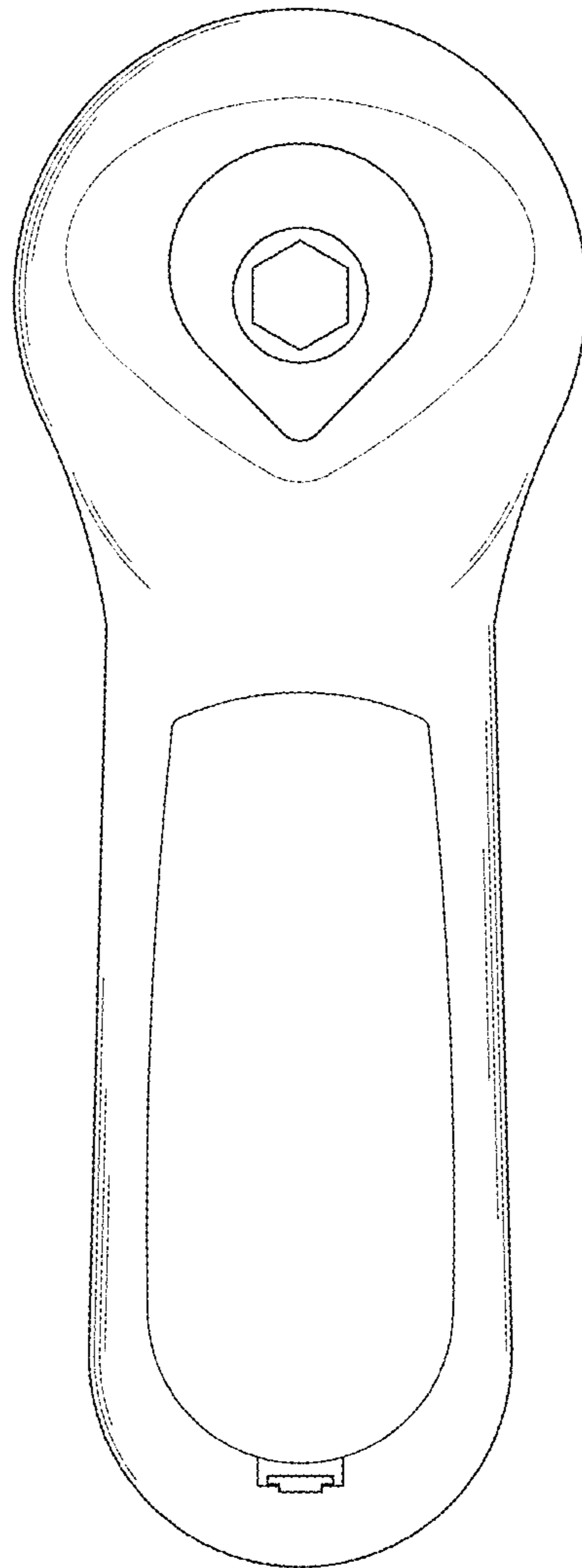

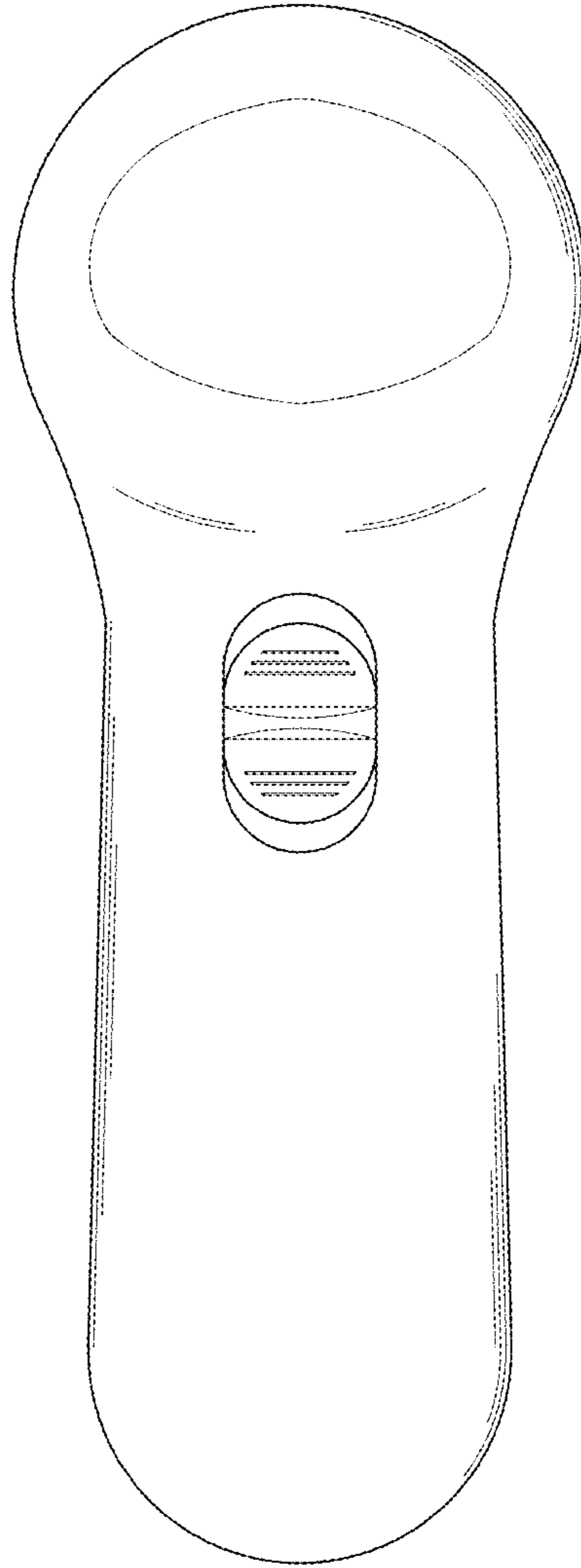




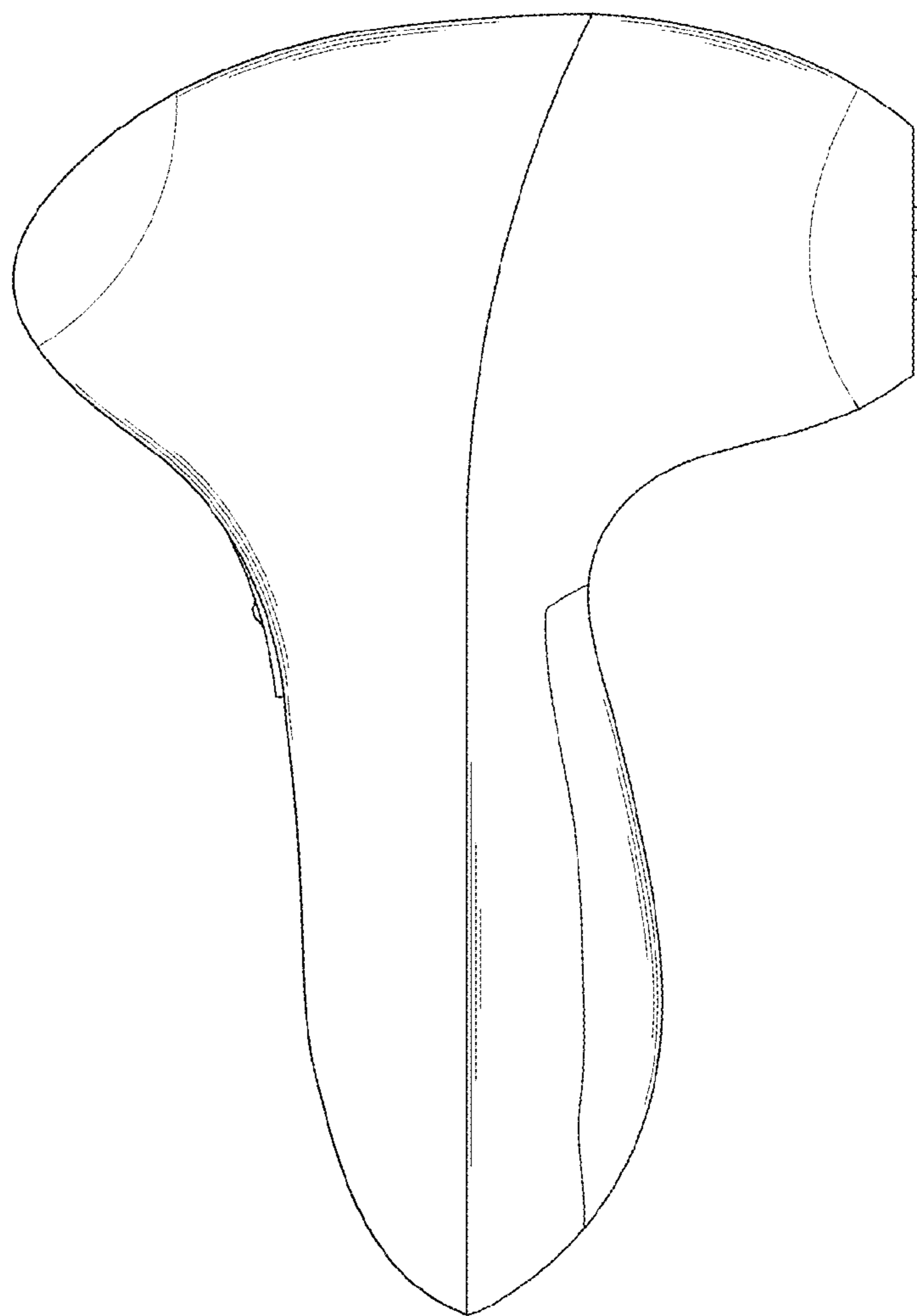

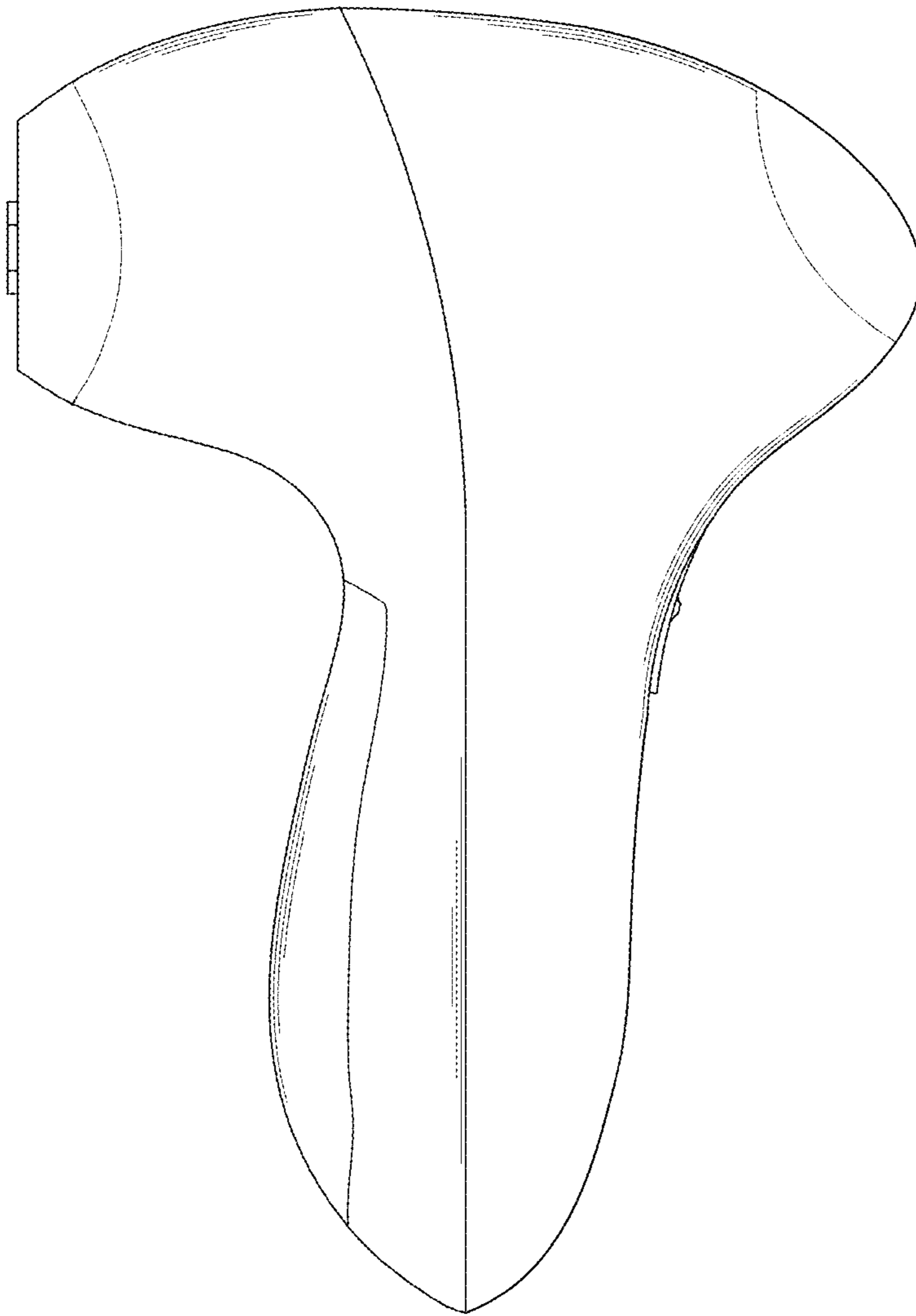

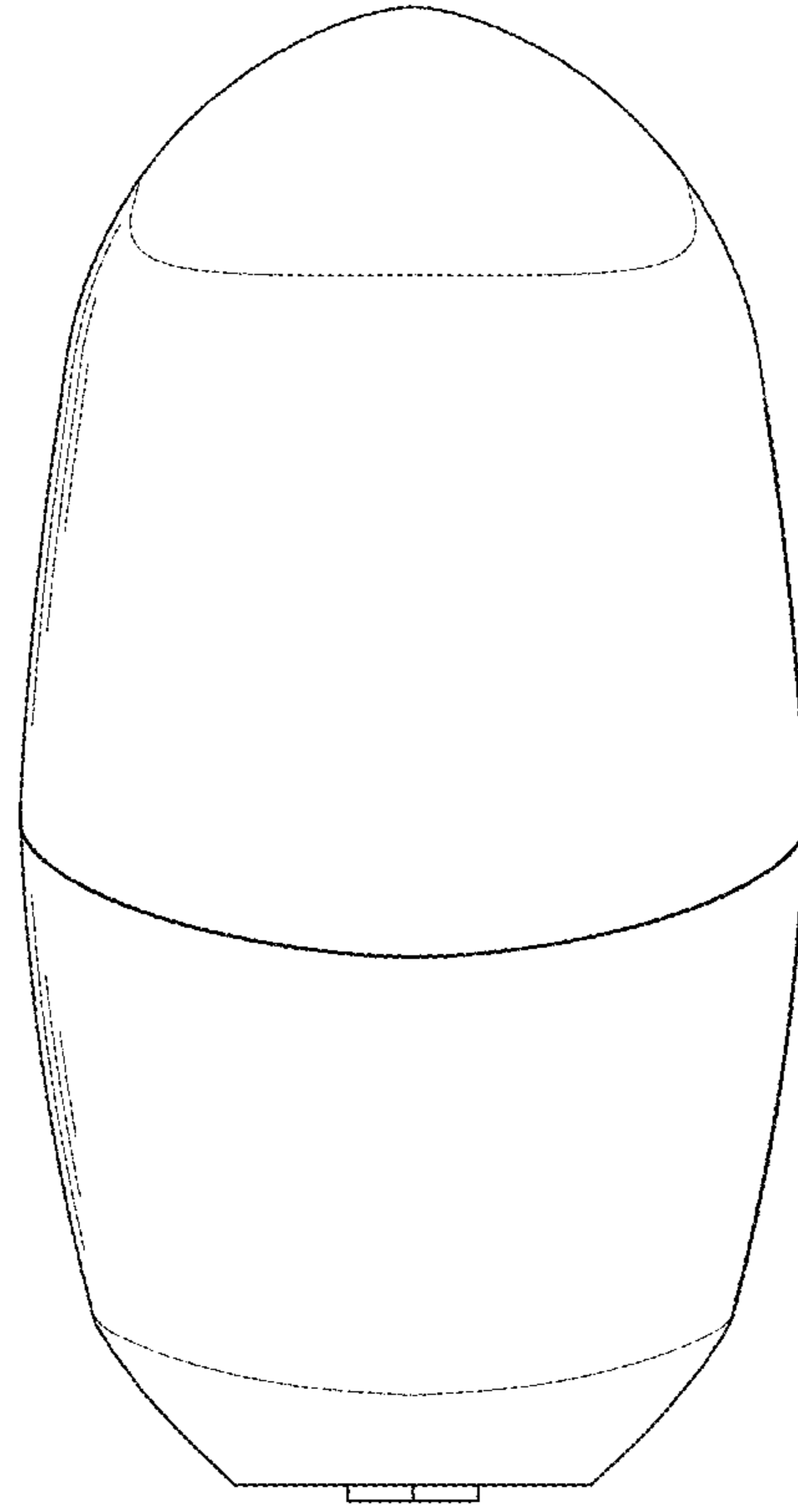

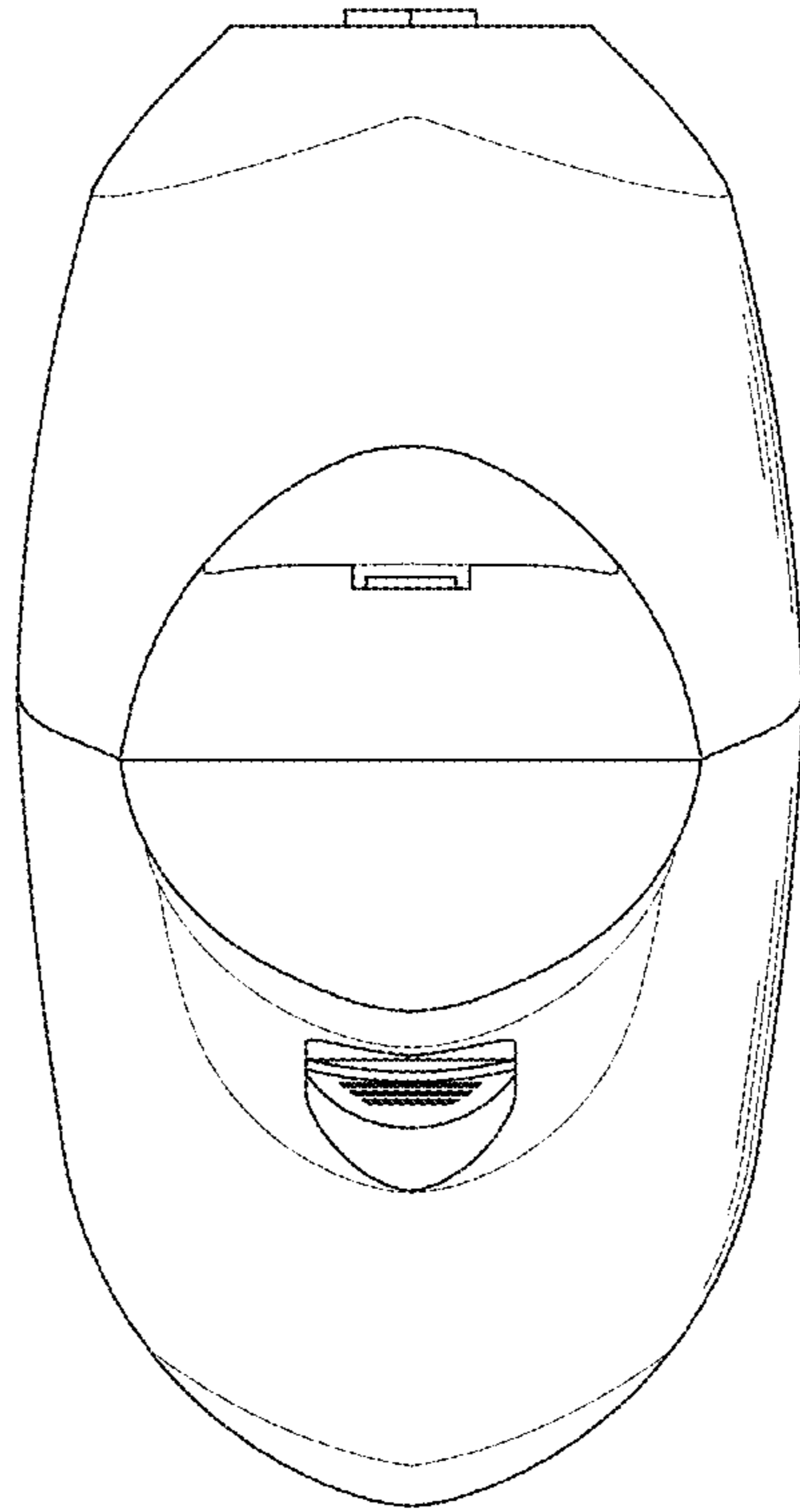

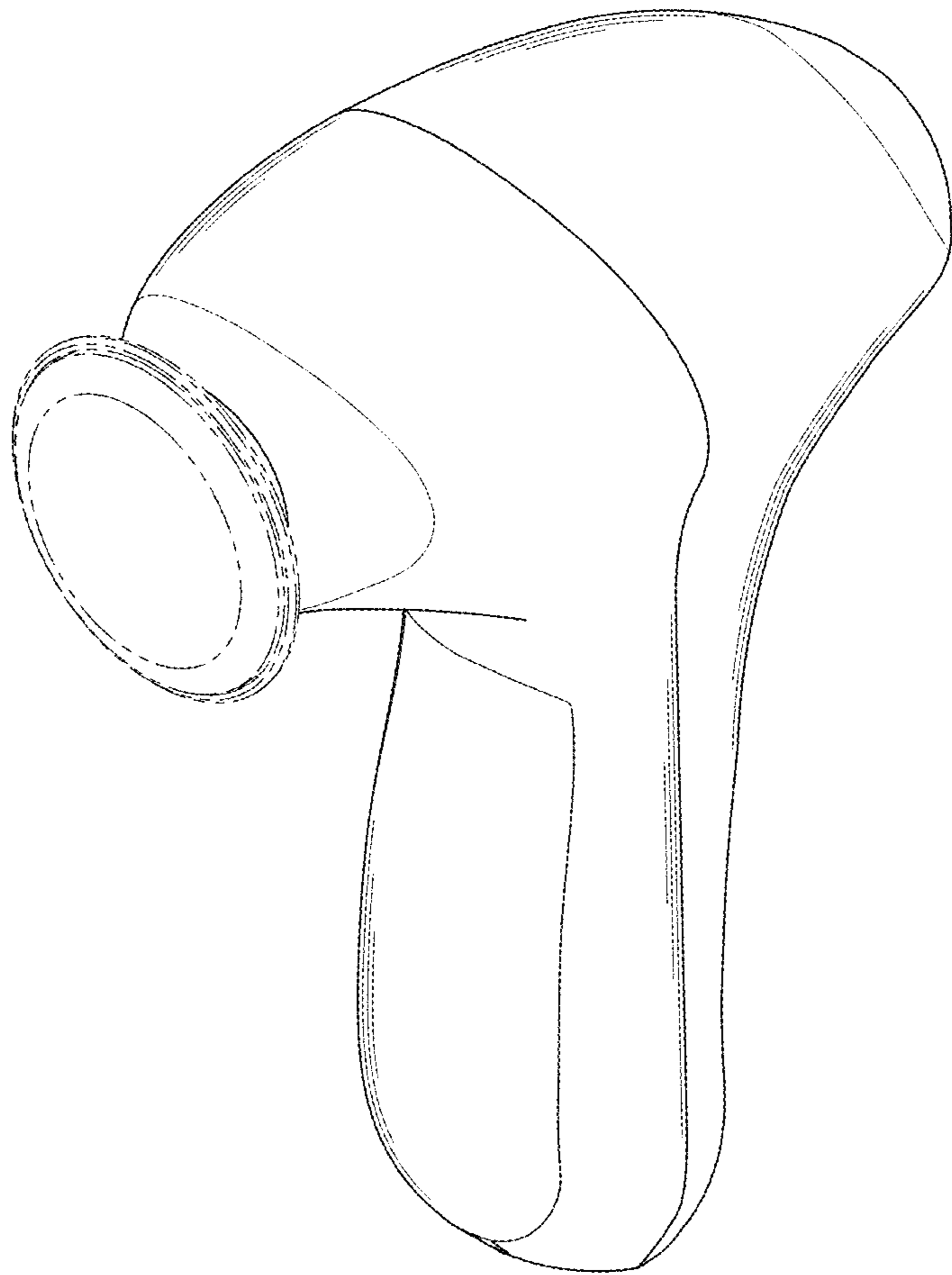

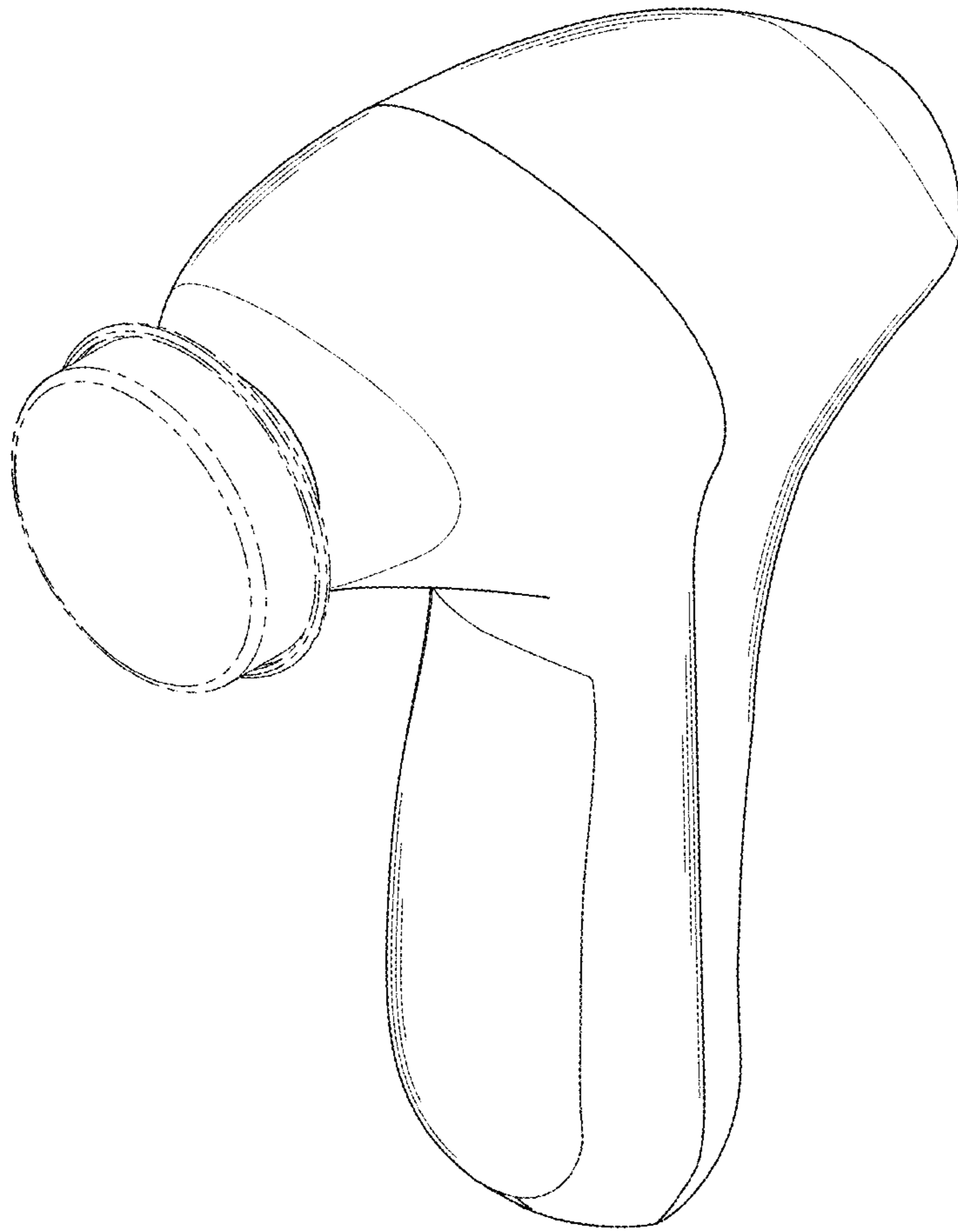

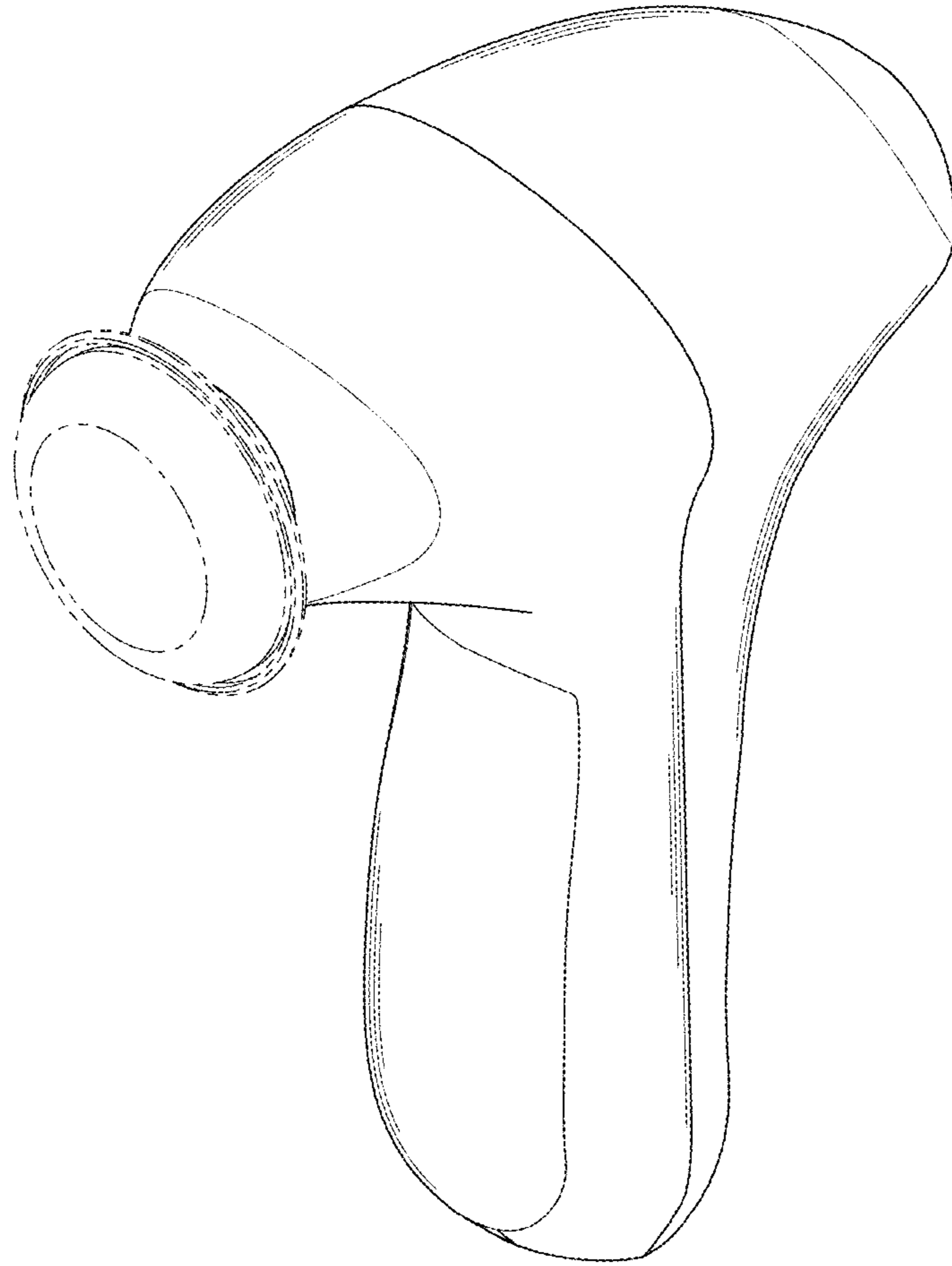




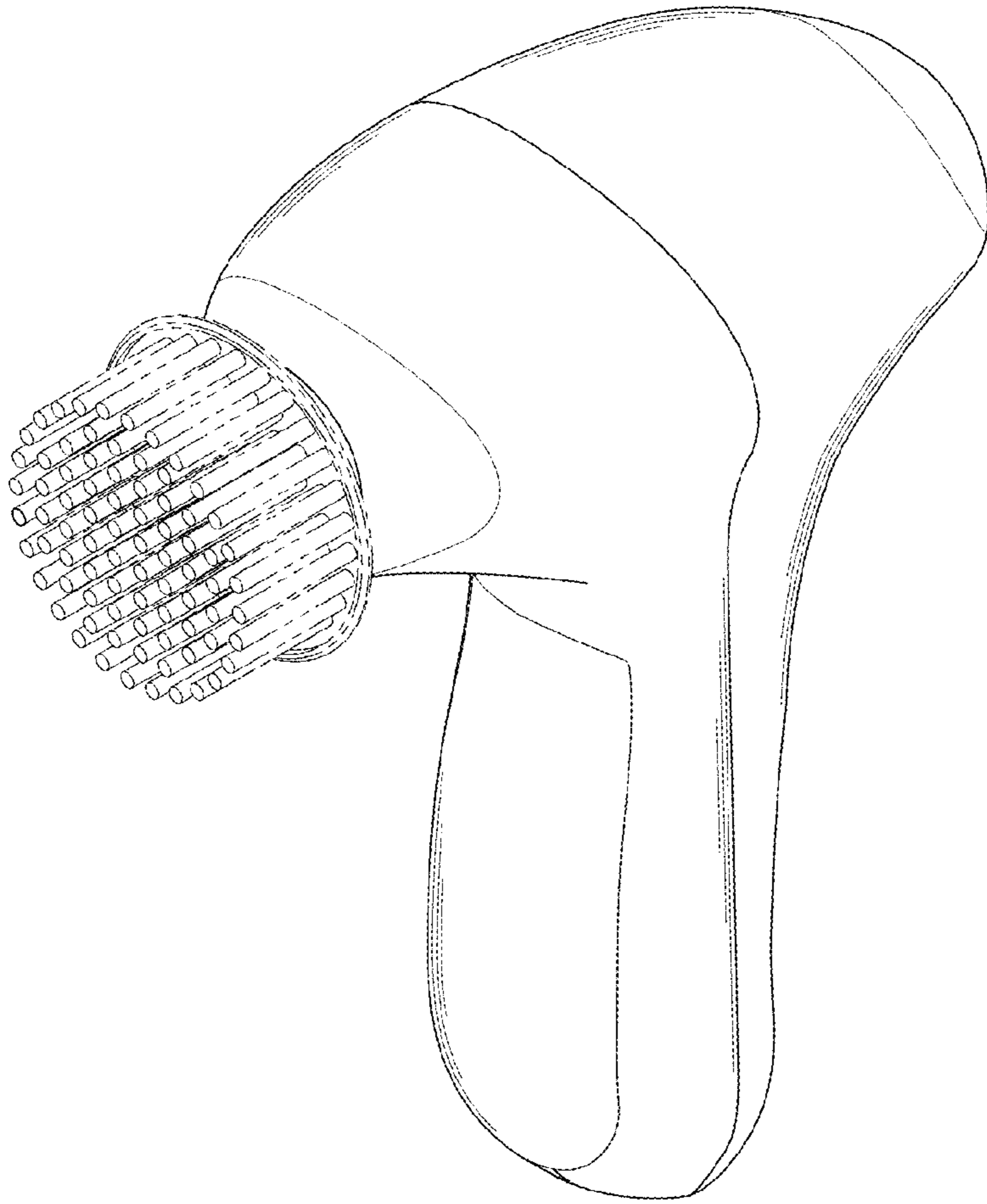
