(57) **CLAIM**

The ornamental design for an upper outerwear with back pouch, as shown and described.

DESCRIPTION

FIG. 1 is a front-right perspective view of an upper outerwear with back pouch according to a first embodiment of the present invention;

FIG. 2 is a front view of the upper outerwear with back pouch according to the first embodiment of the present invention;

FIG. 3 is a rear view of the upper outerwear with back pouch according to the first embodiment of the present invention;

FIG. 4 is a left side view of the upper outerwear with back pouch according to the first embodiment of the present invention;

FIG. 5 is a right side view of the upper outerwear with back pouch according to the first embodiment of the present invention;

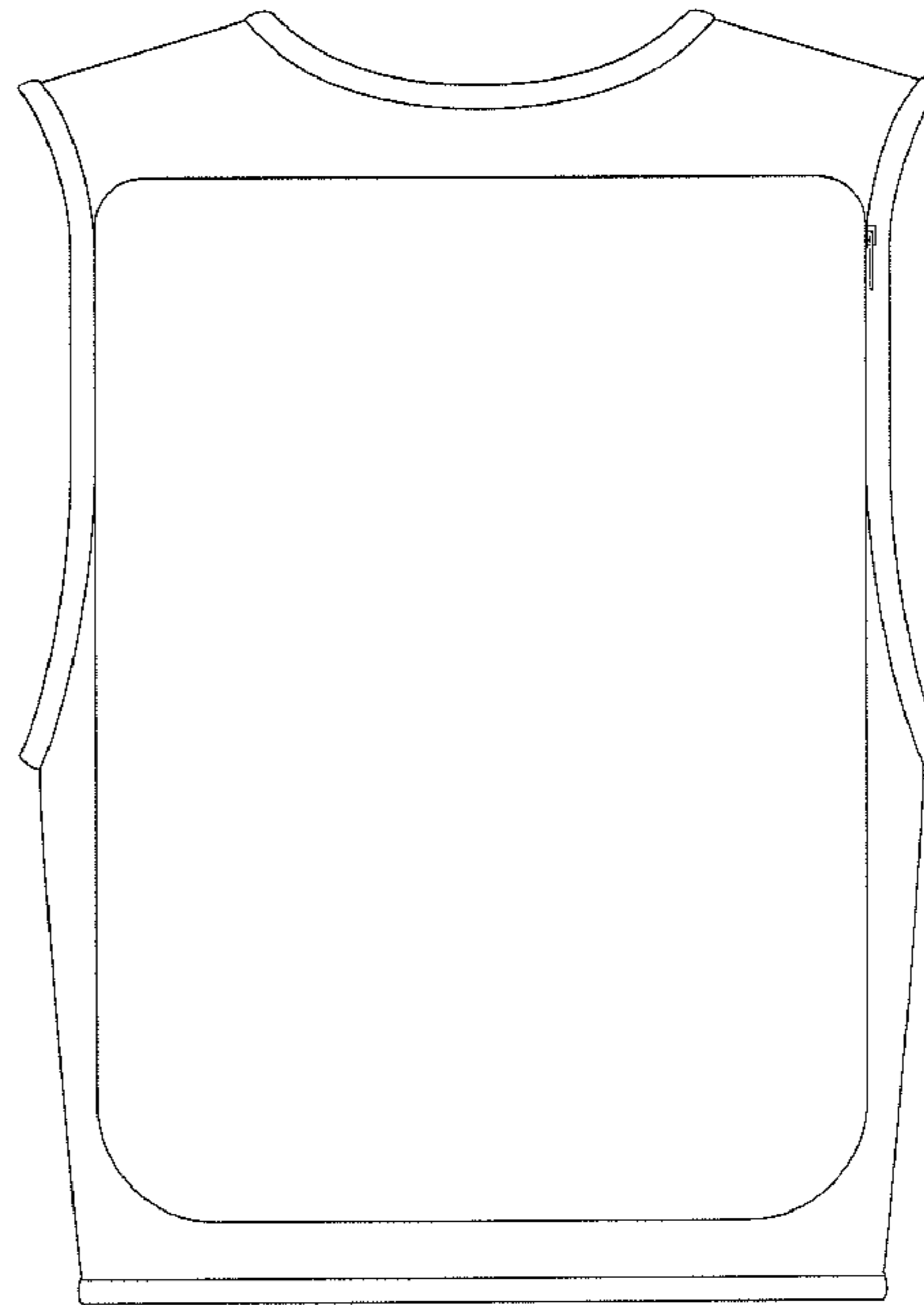
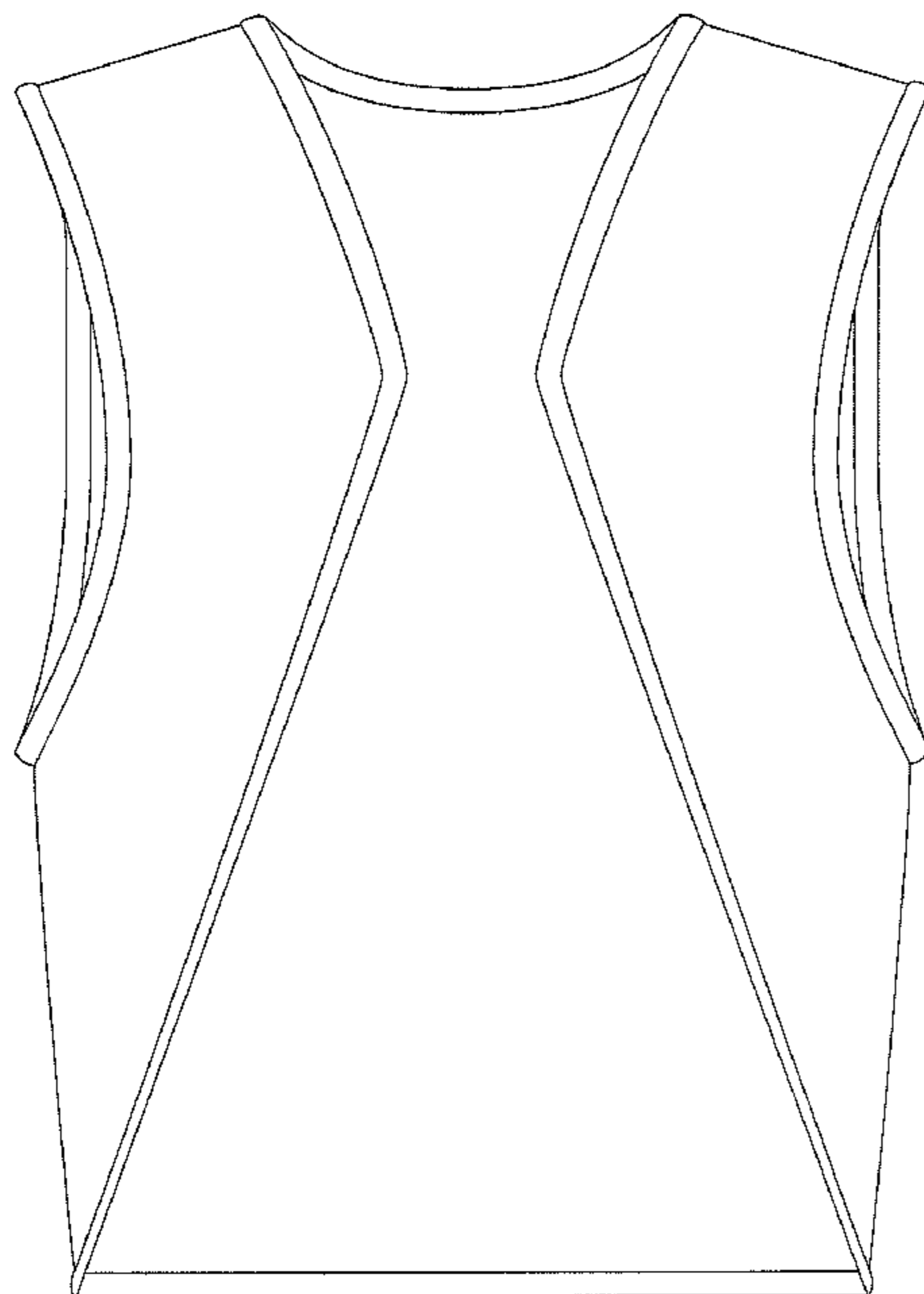

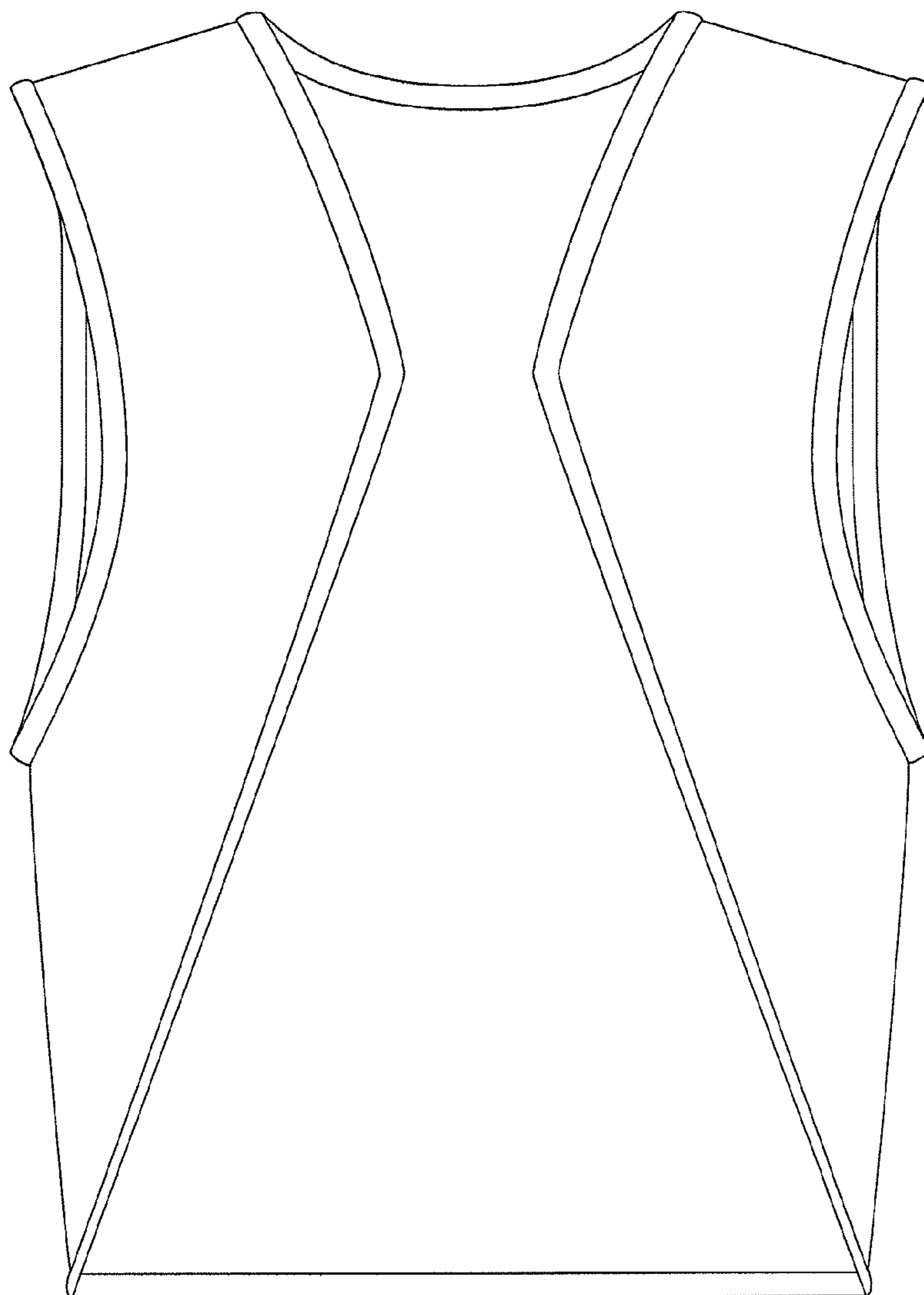

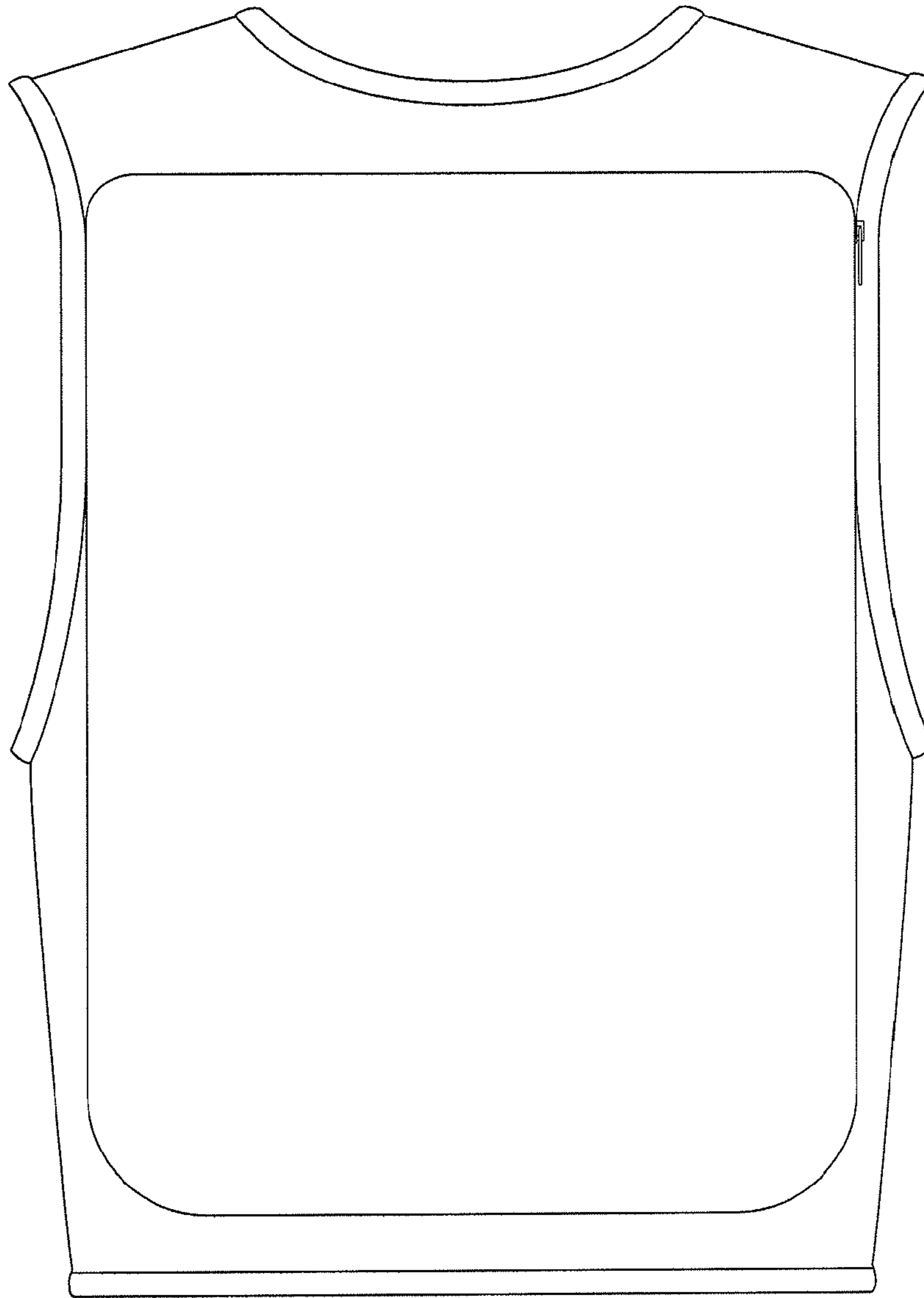

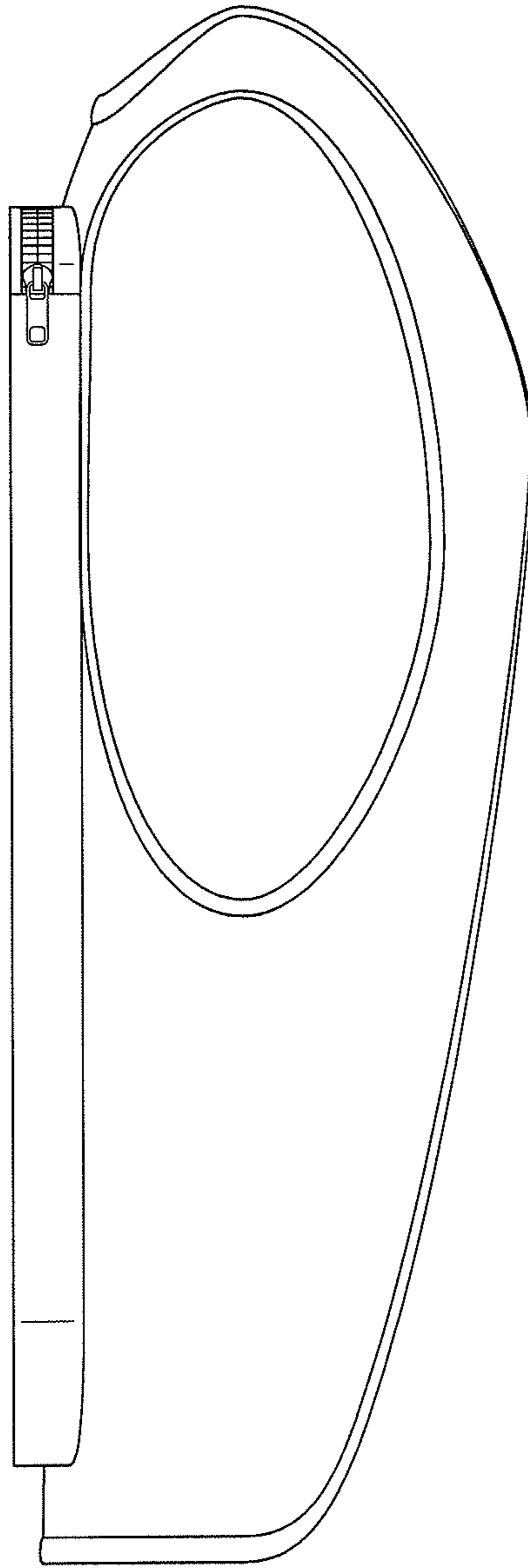

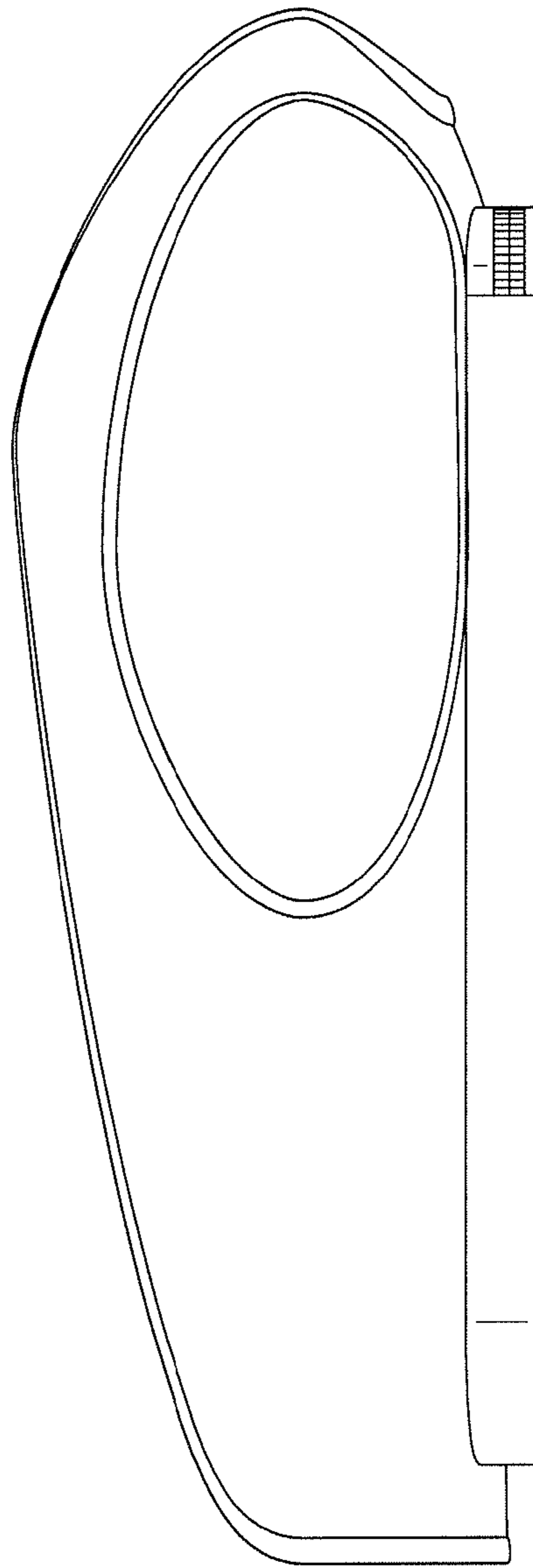

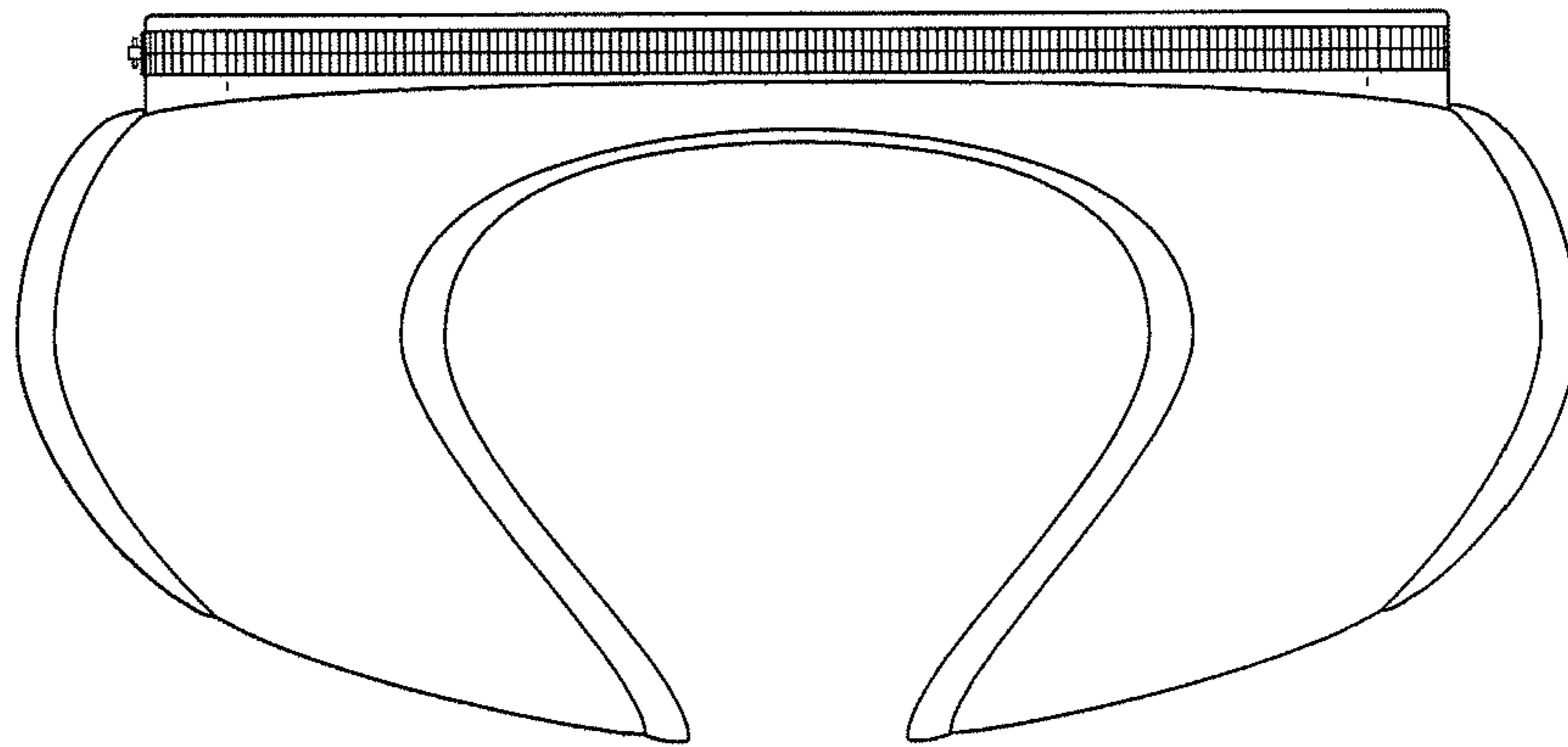

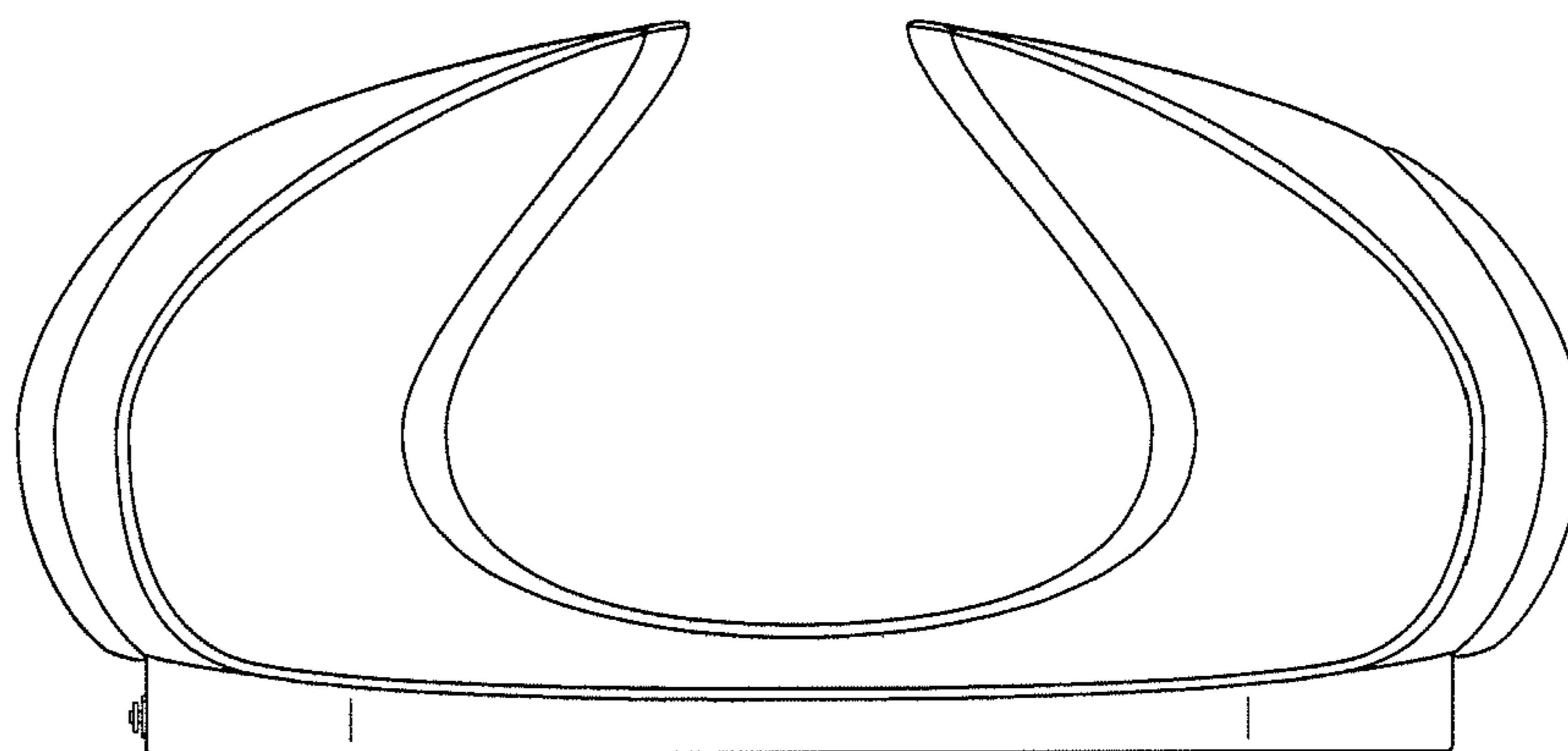
