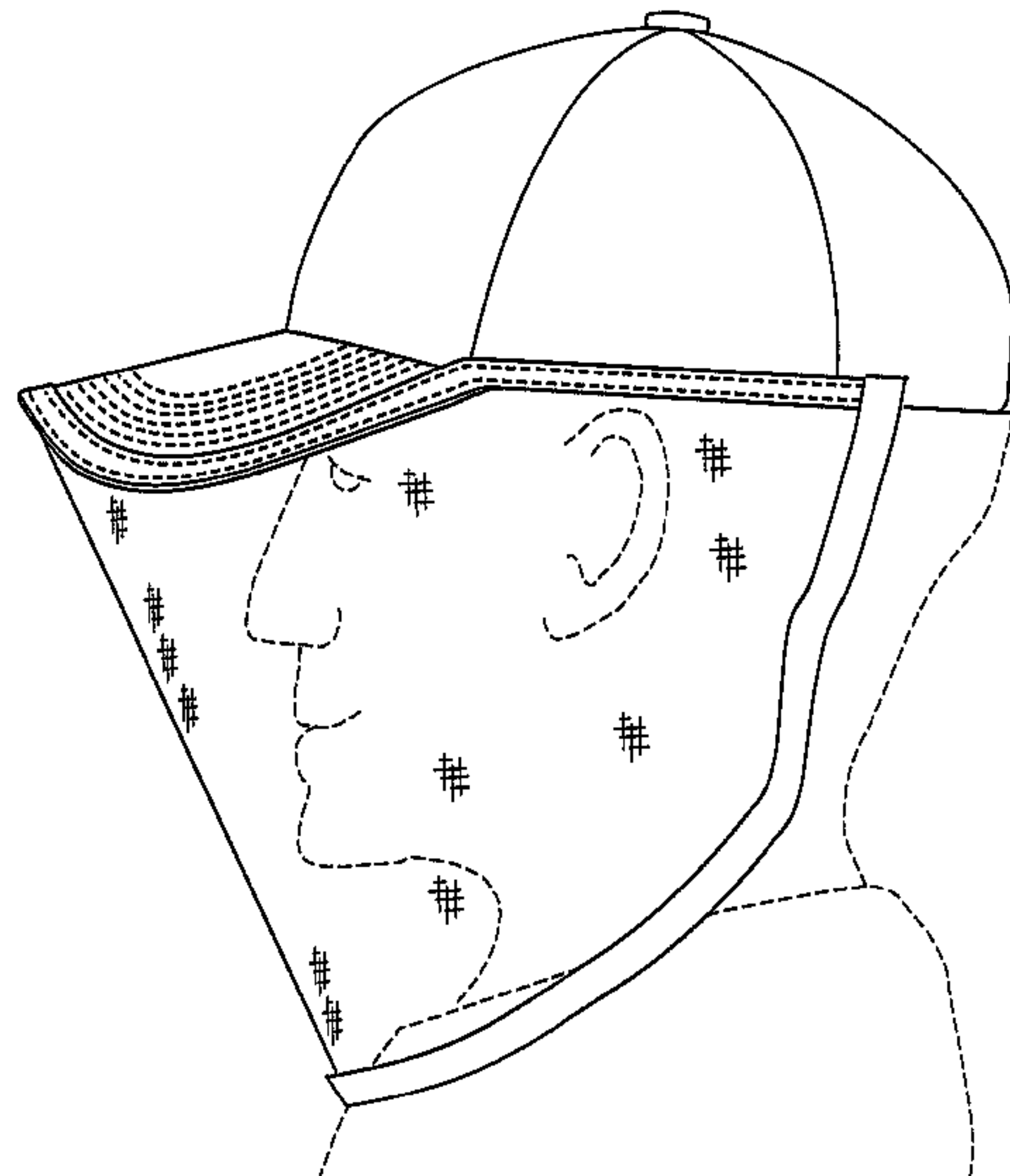
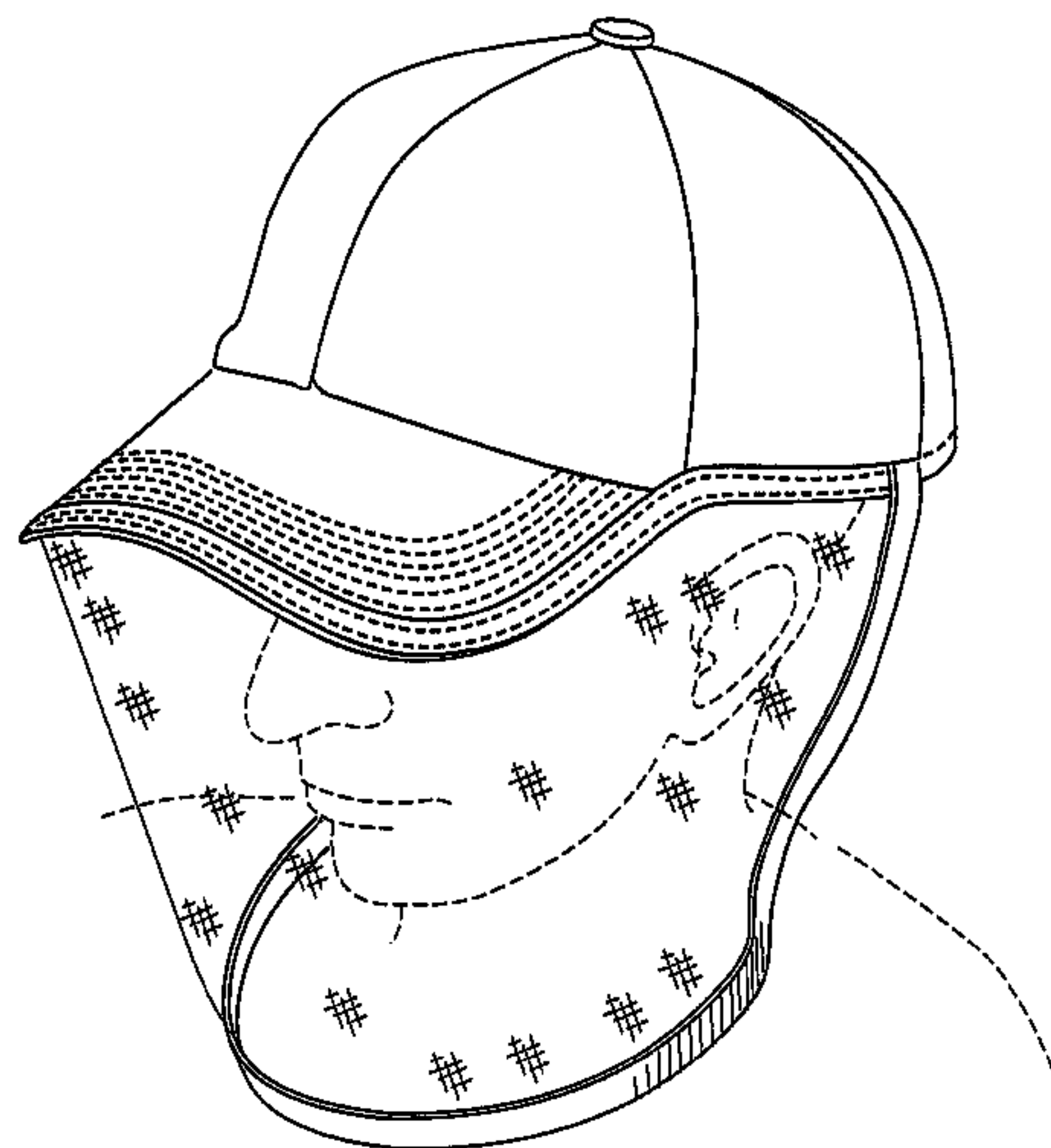
(57) **CLAIM**

The original ornamental design for a cap with protective detasseling screen, substantially as shown and described.

DESCRIPTION

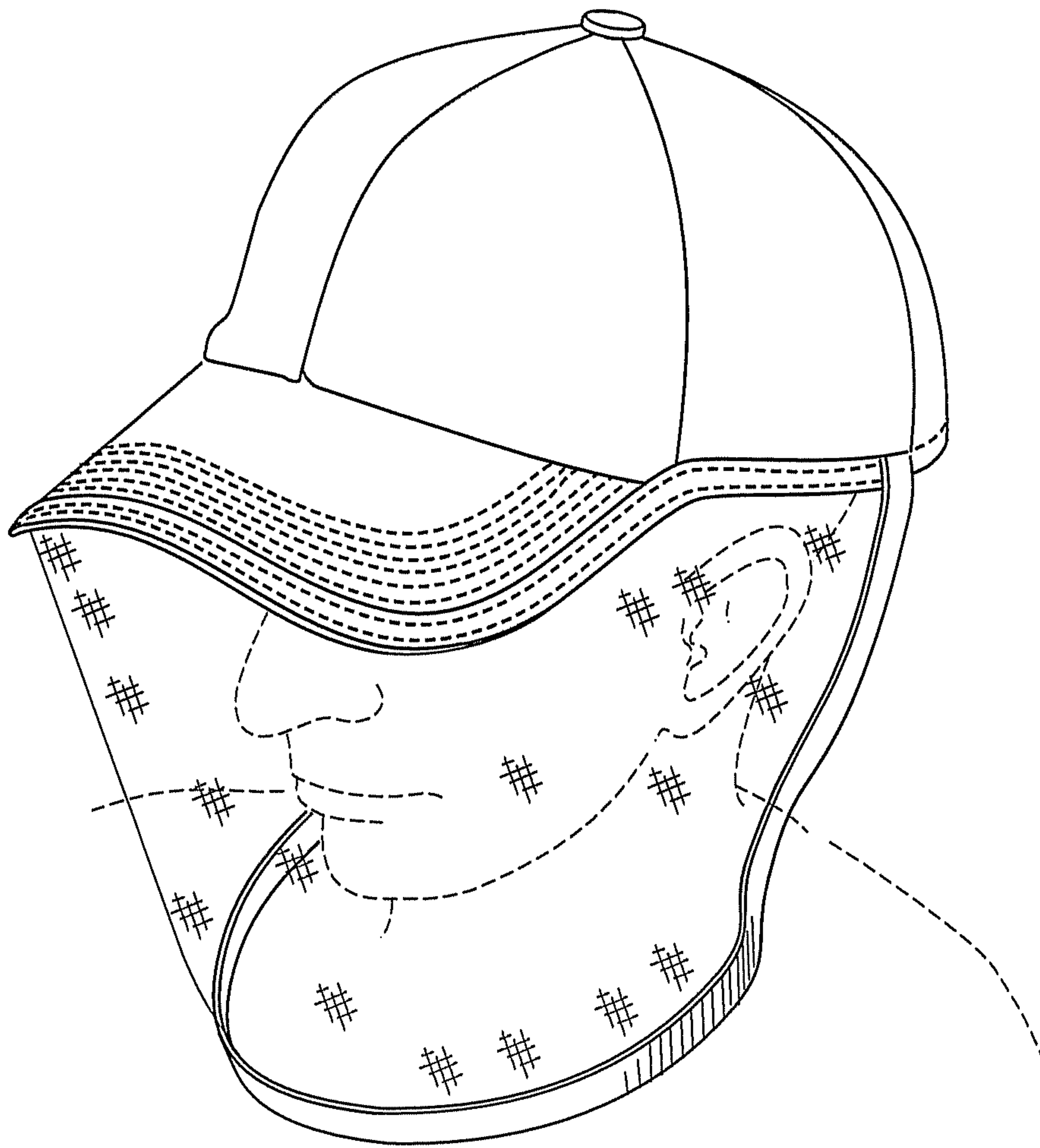

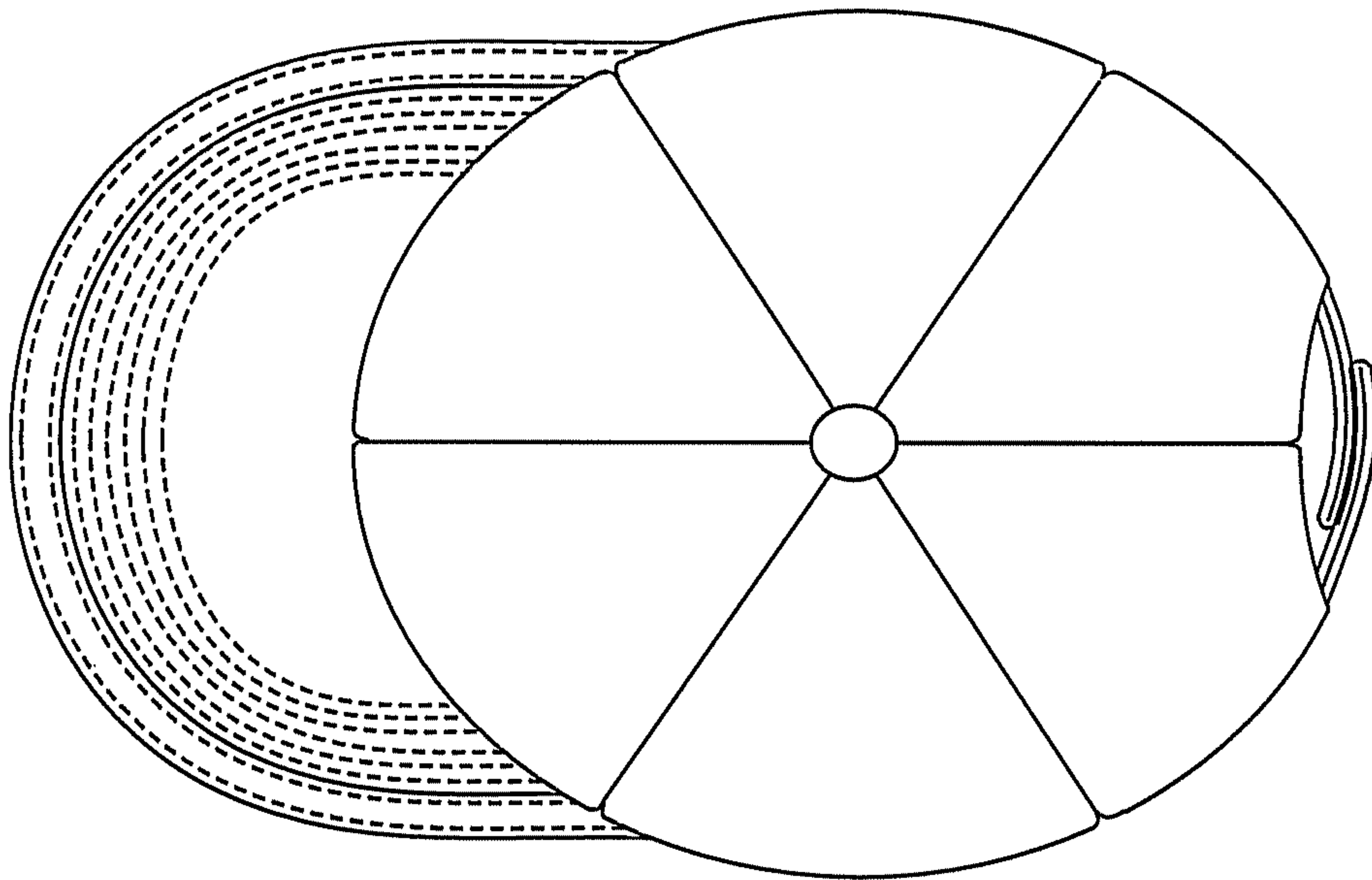

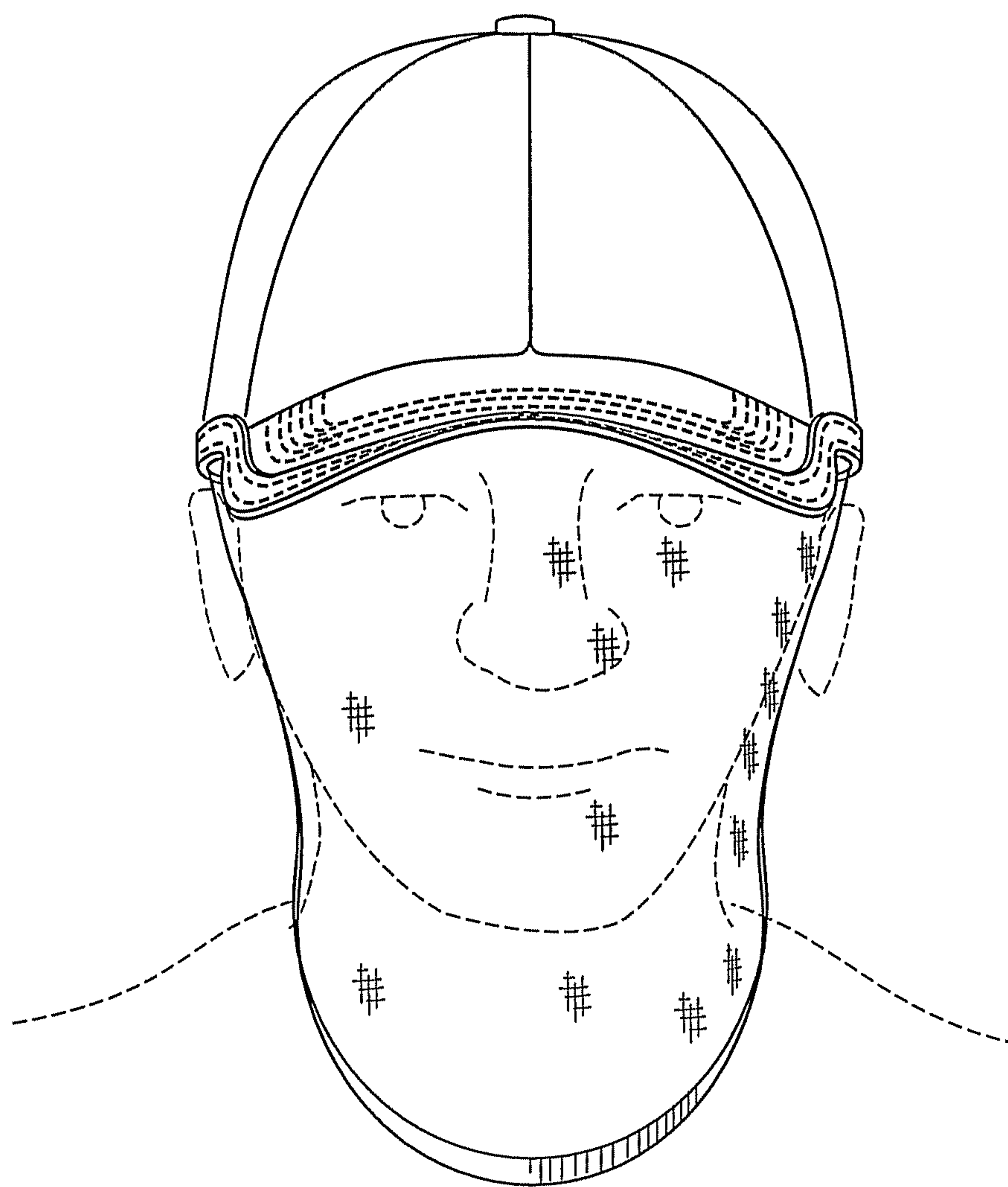
