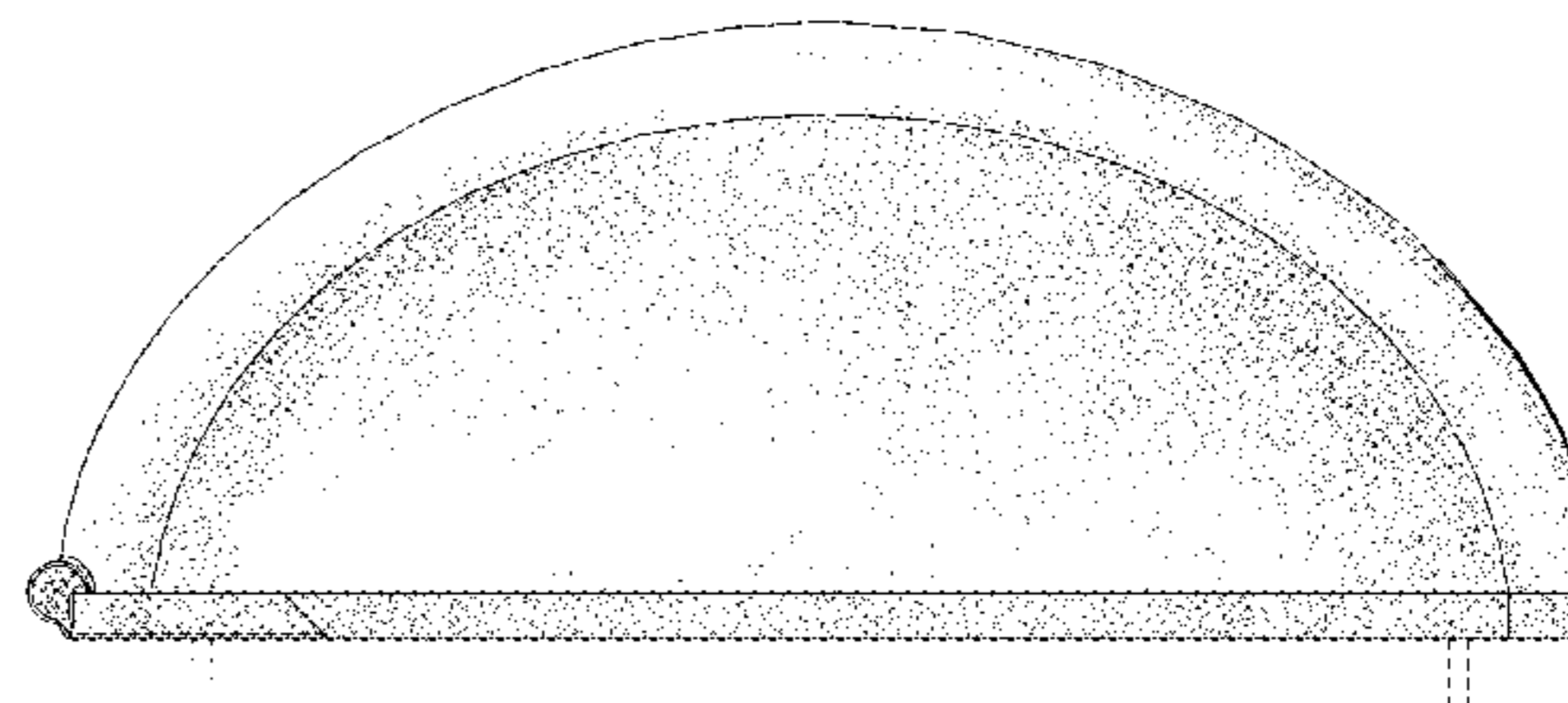
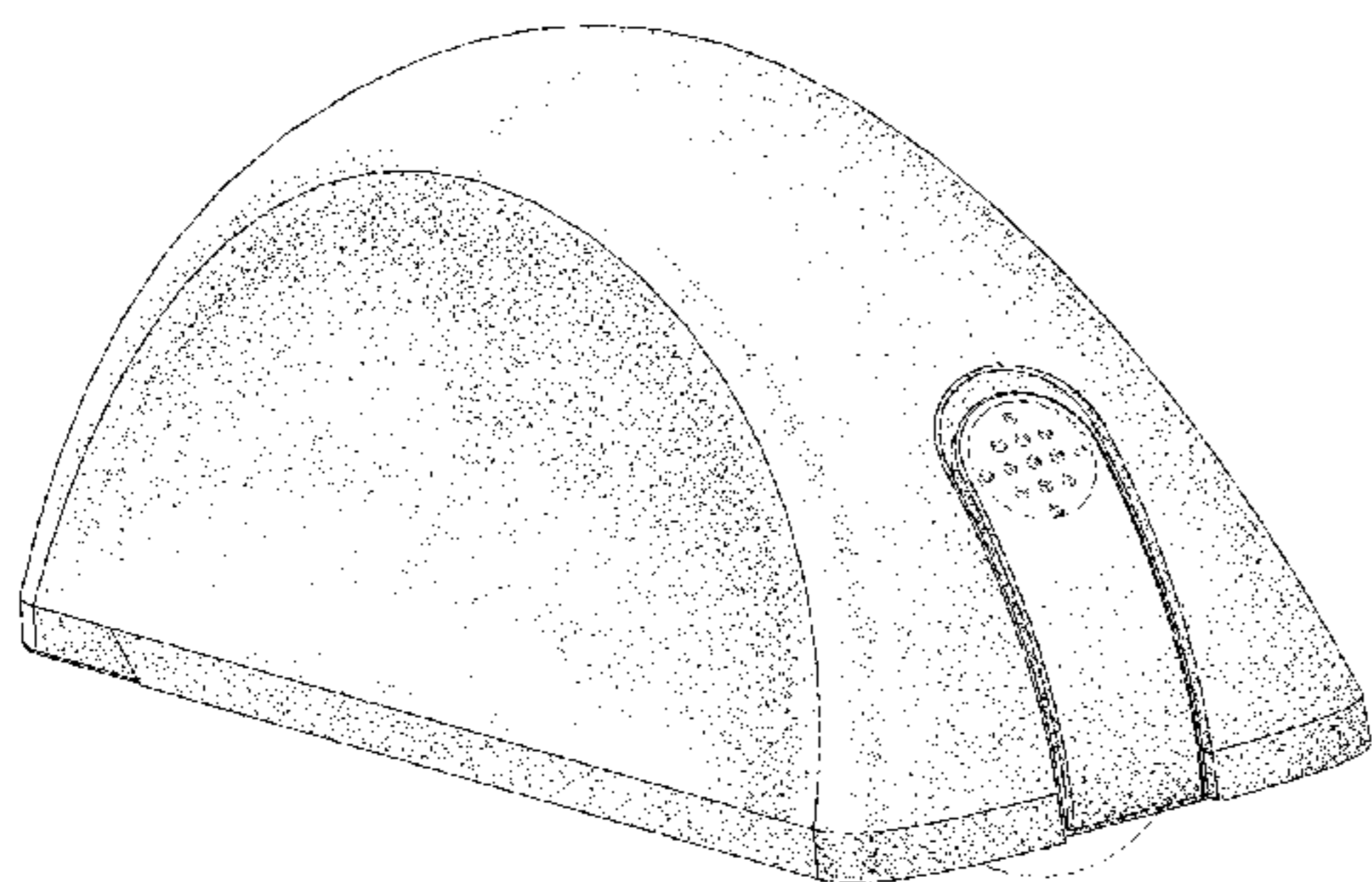

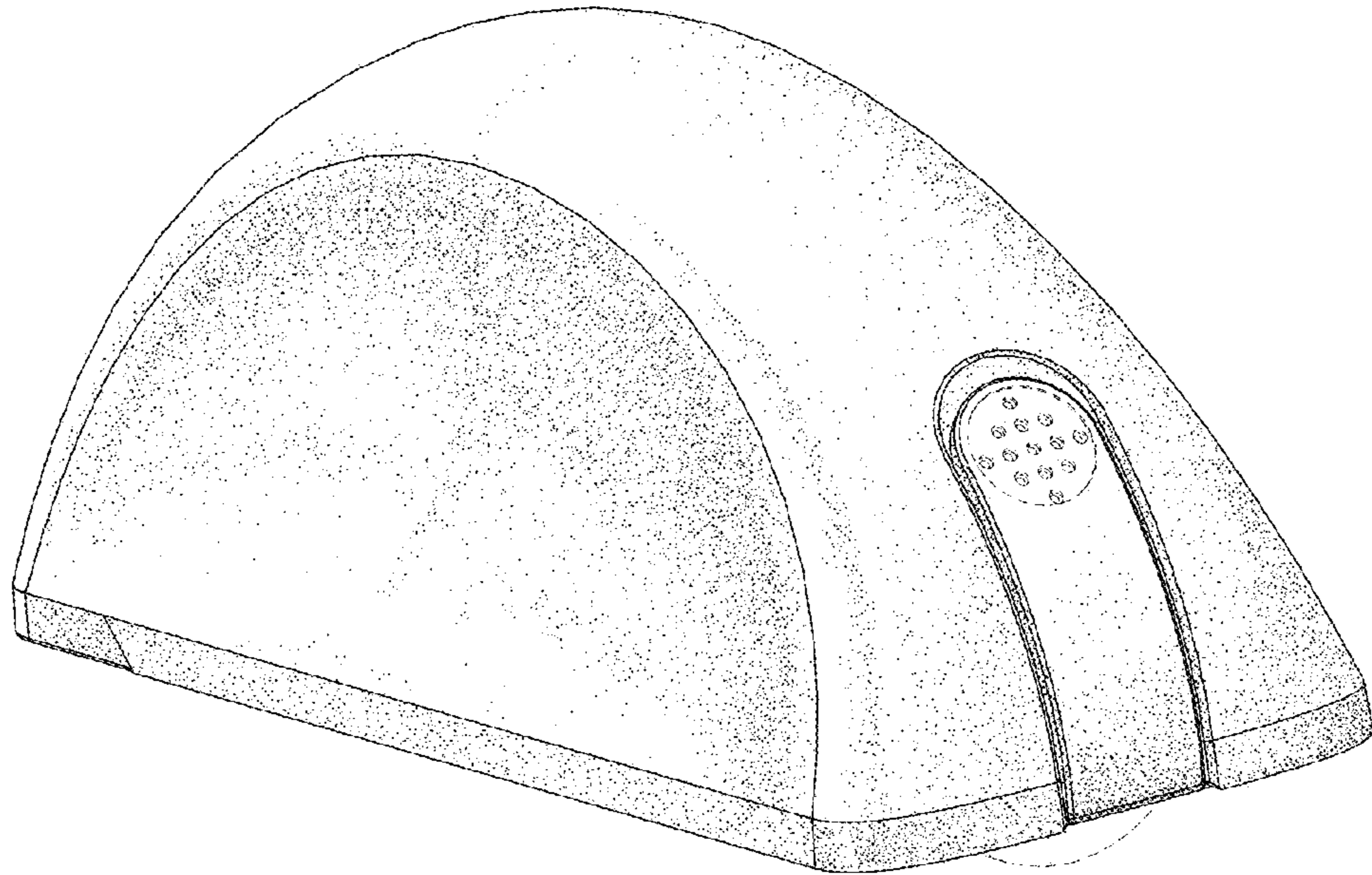
The ornamental design for a handheld lint sweeper, as shown and described.

**DESCRIPTION**

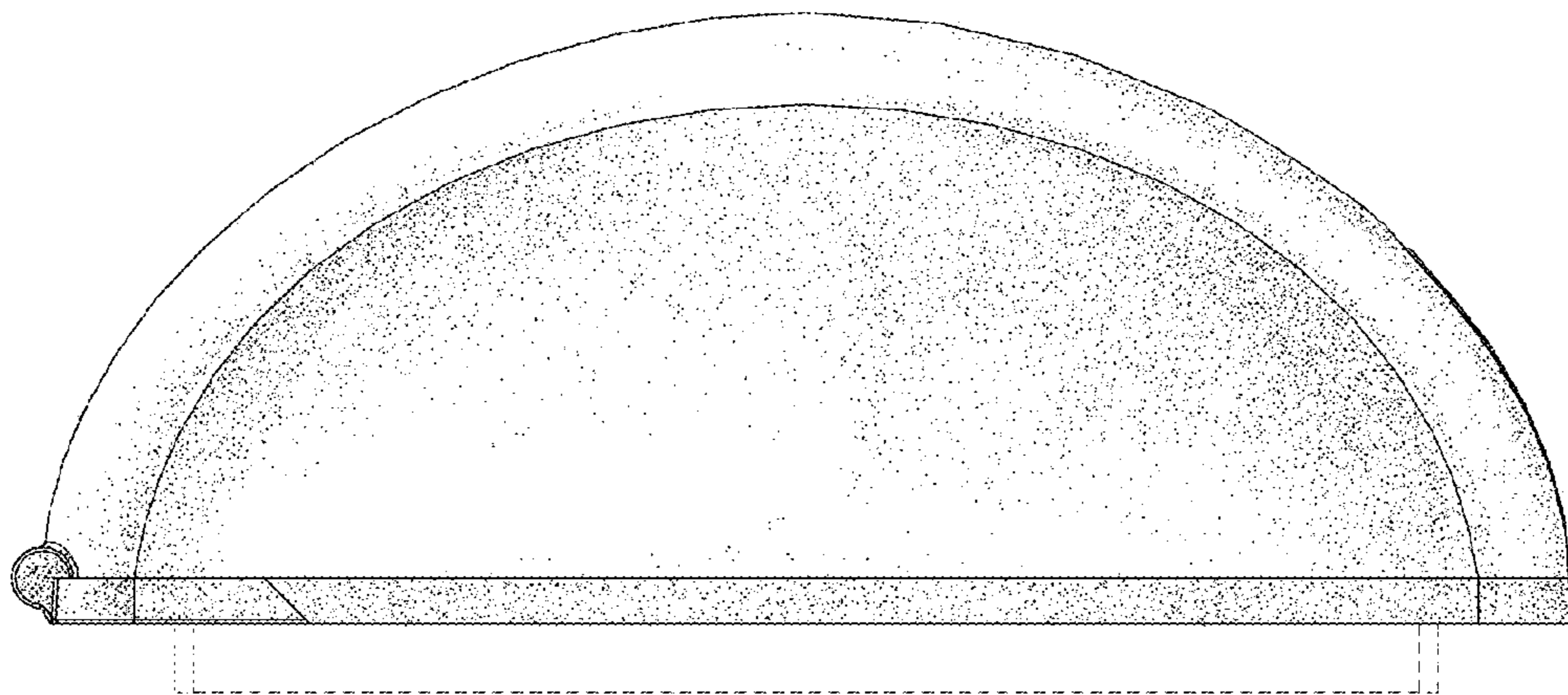
FIG. 1 is a perspective view of a handheld lint sweeper which embodies our design;  
FIG. 2 is a front view thereof, the rear view thereof being a mirror image of the front view thereof;

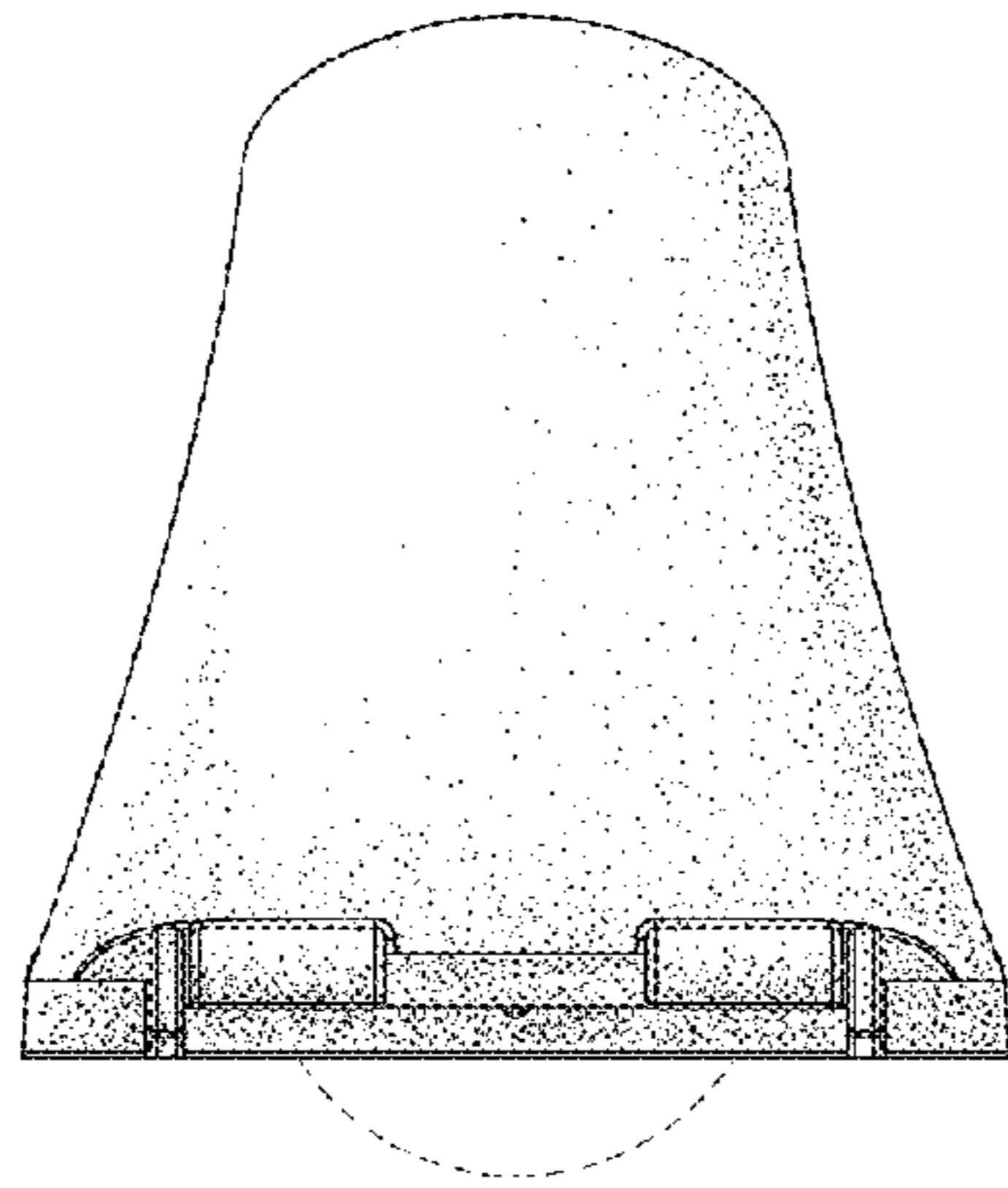

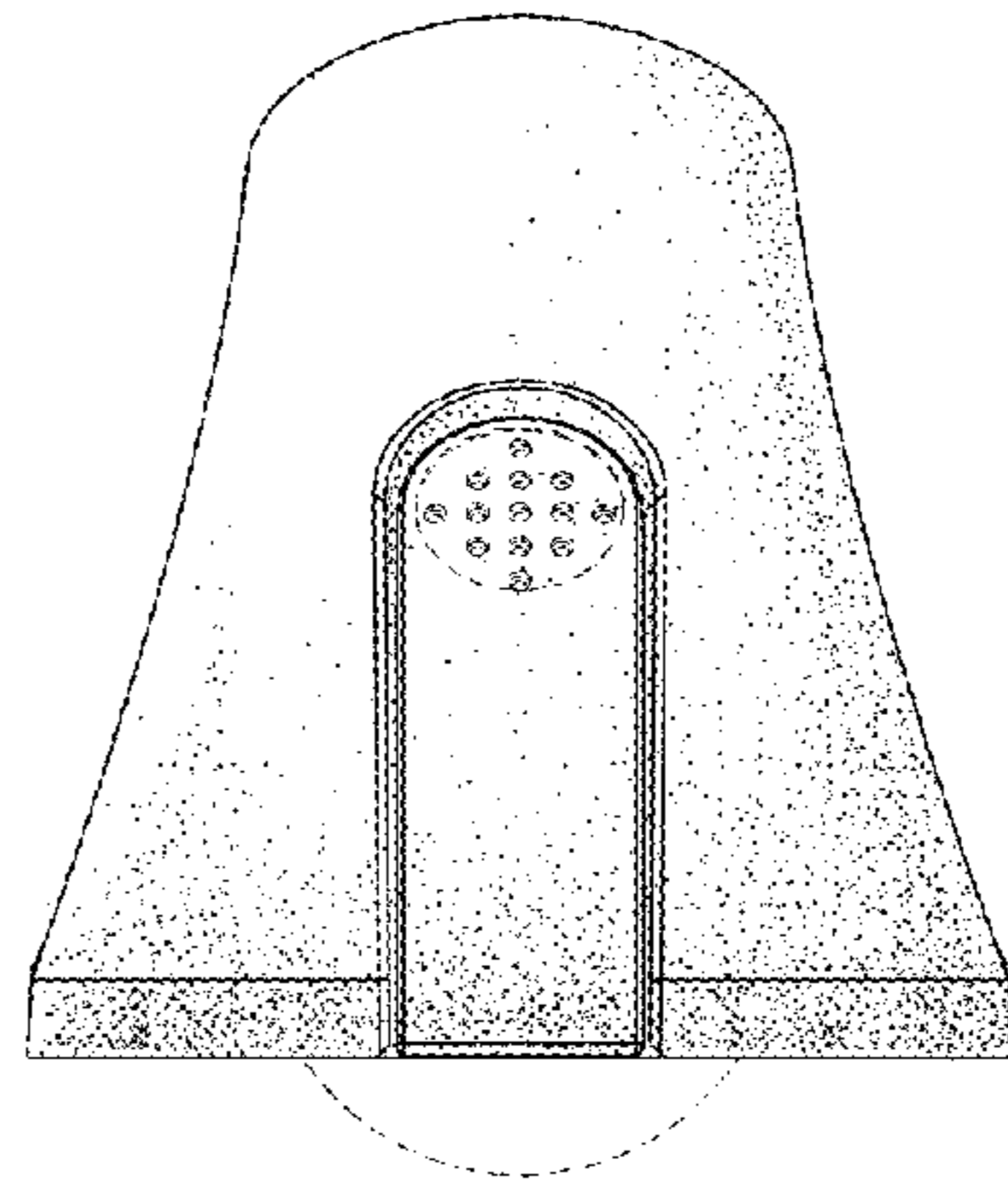

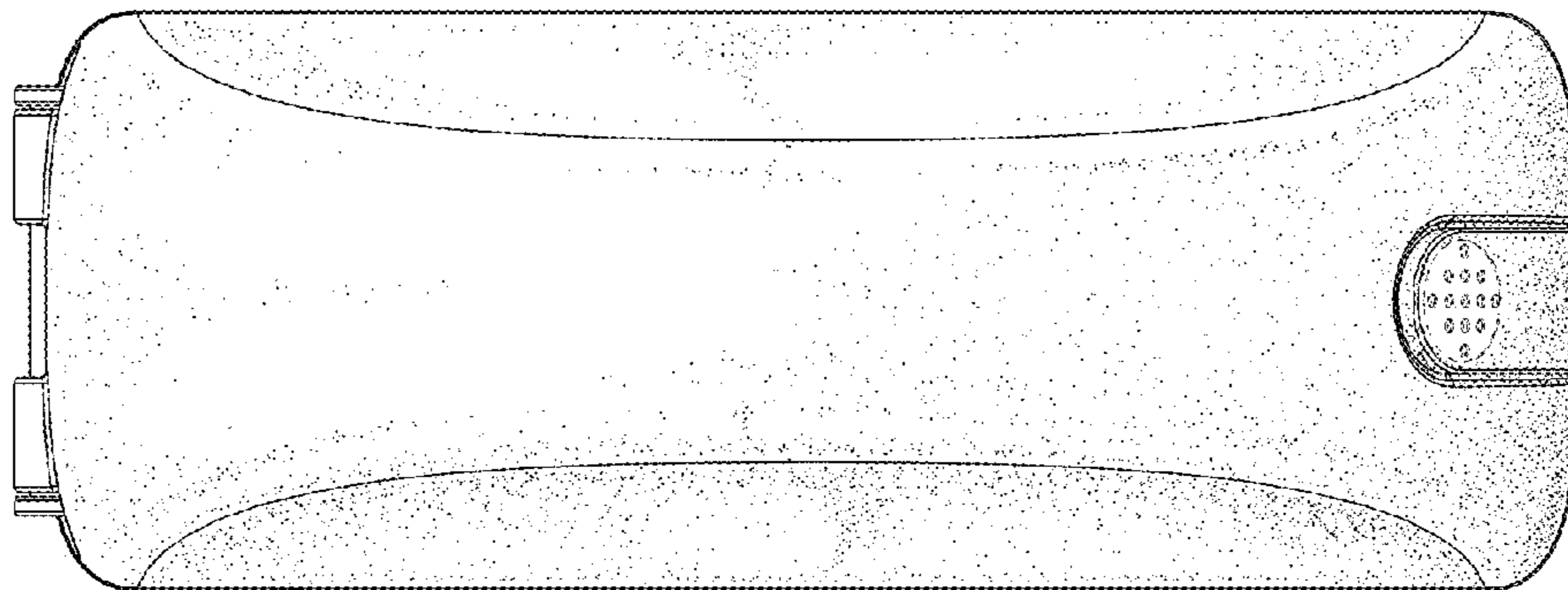

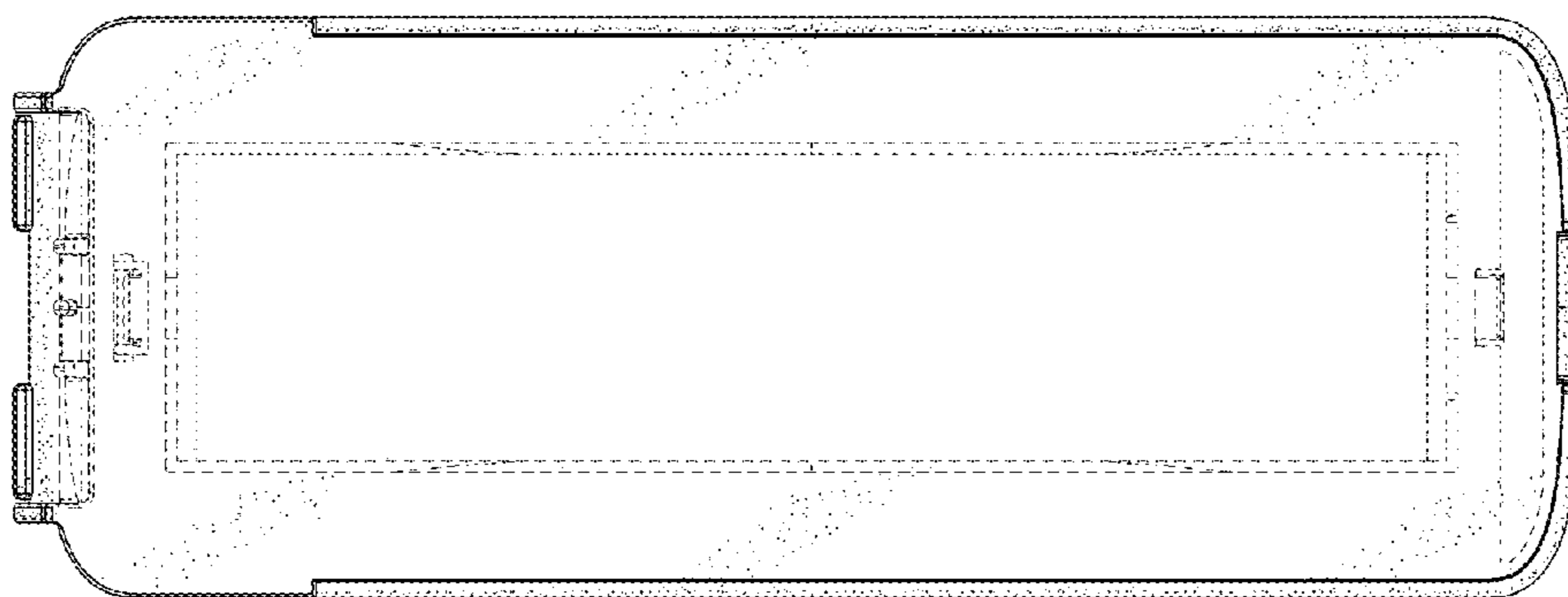
