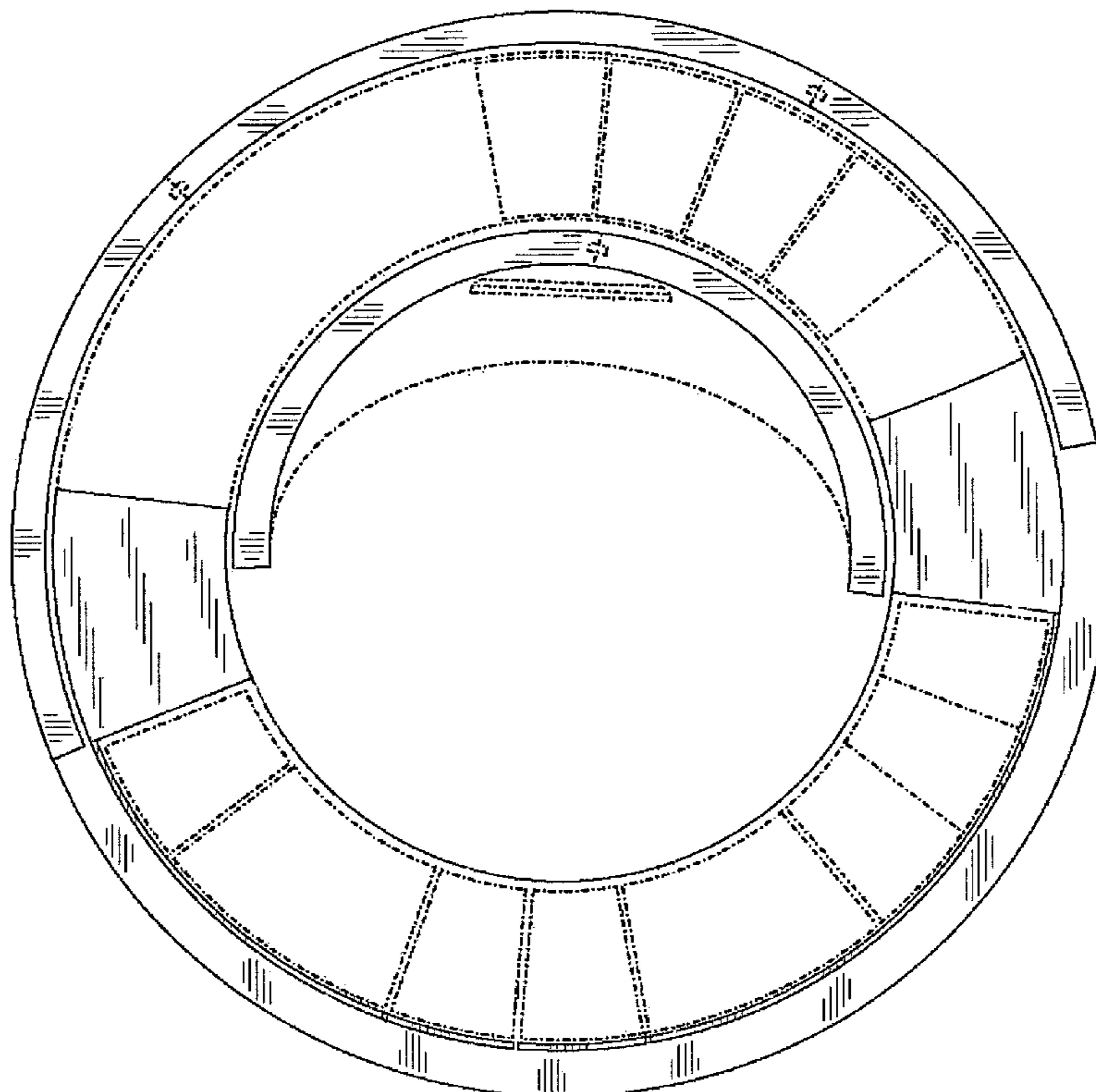
CLAIM

The ornamental design for a kiosk, as shown and described.

DESCRIPTION

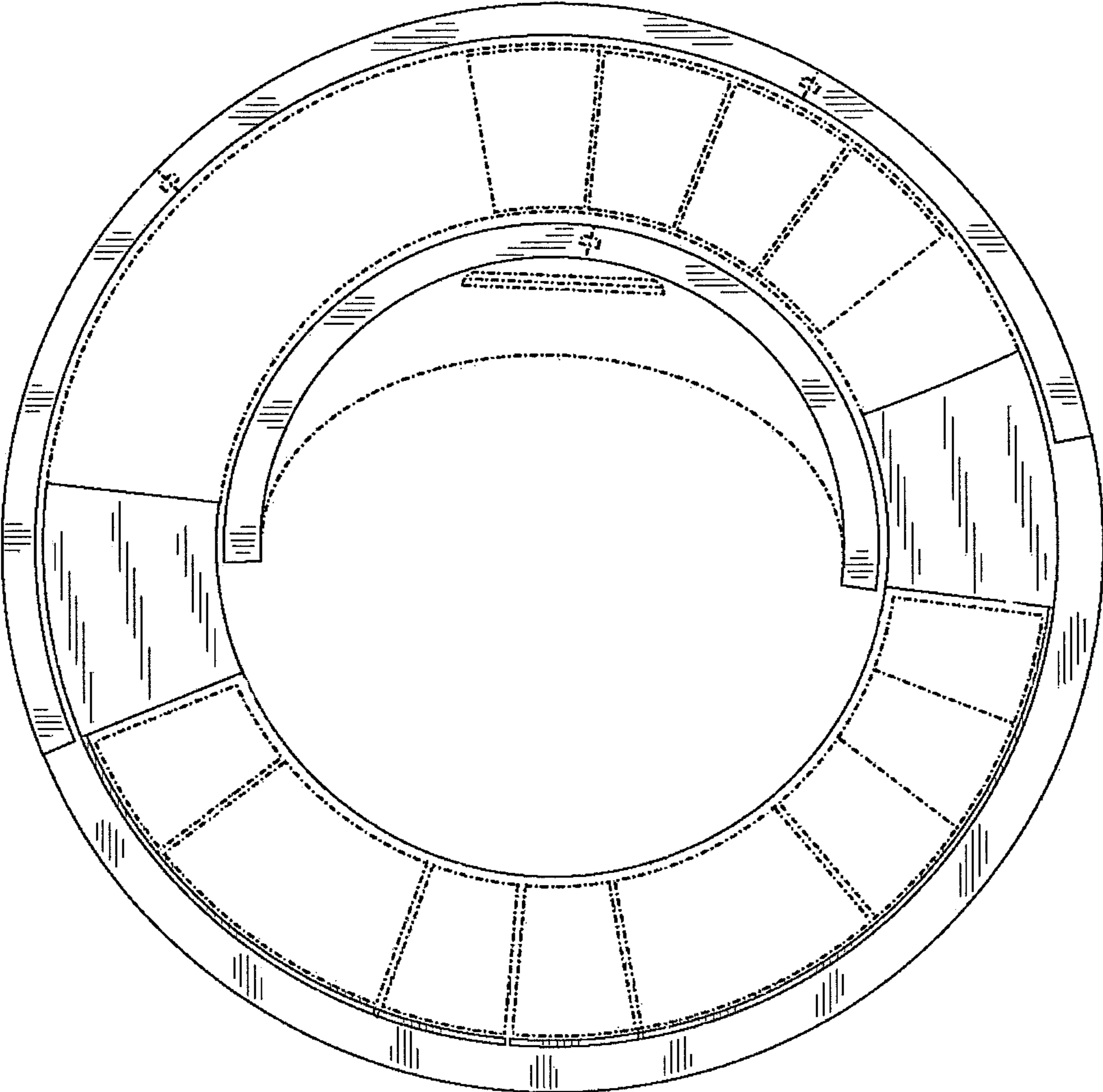

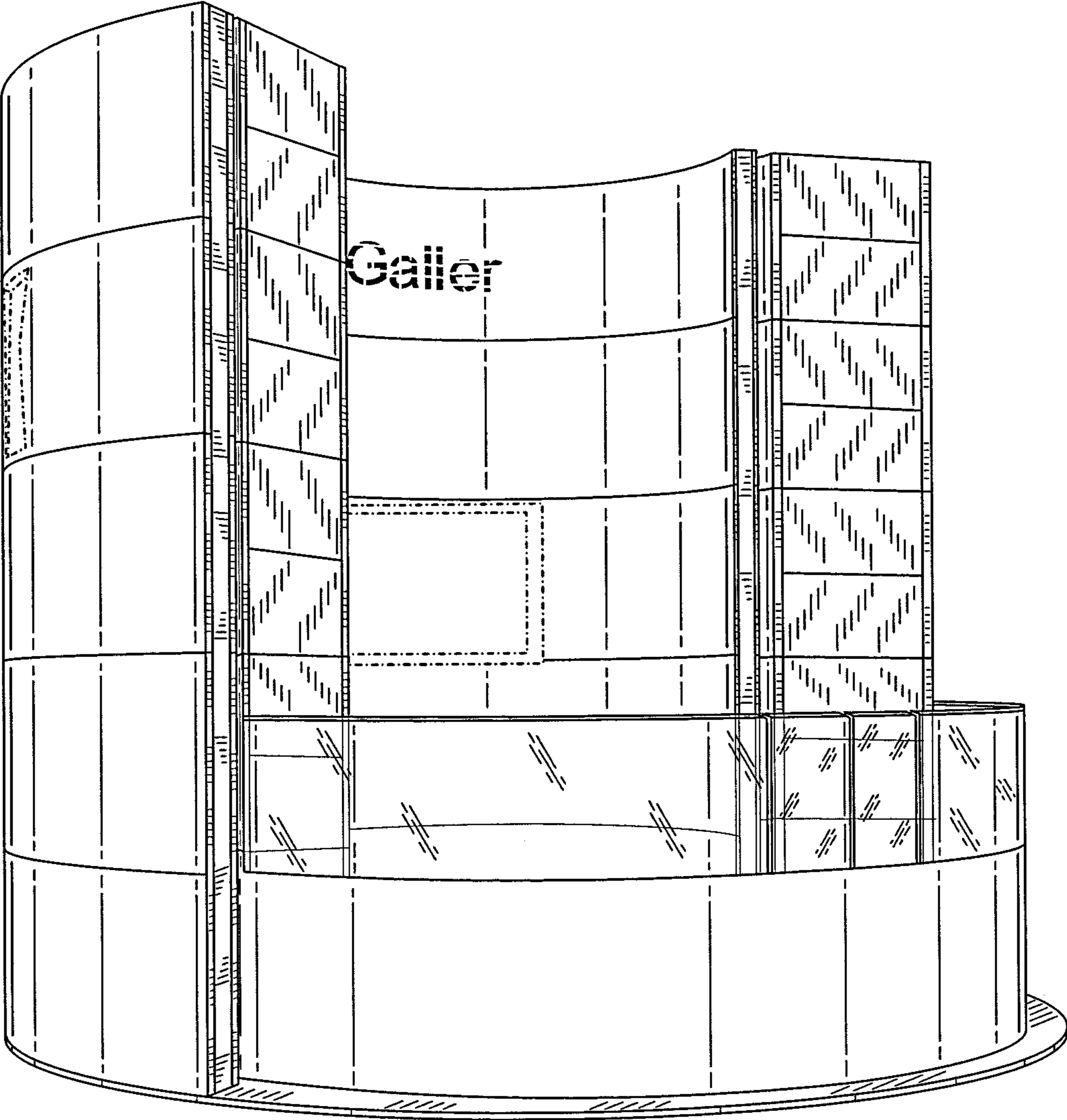

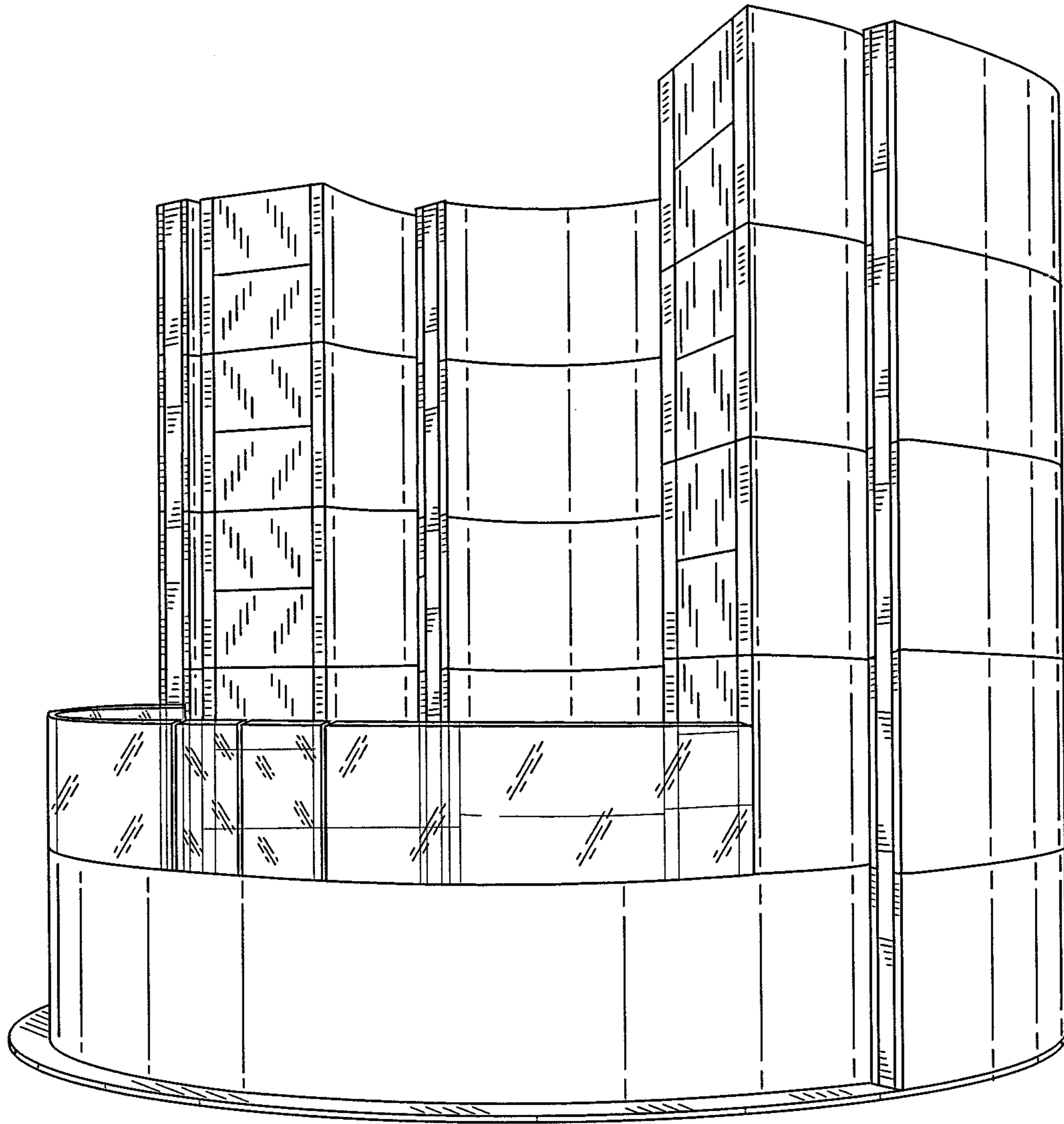

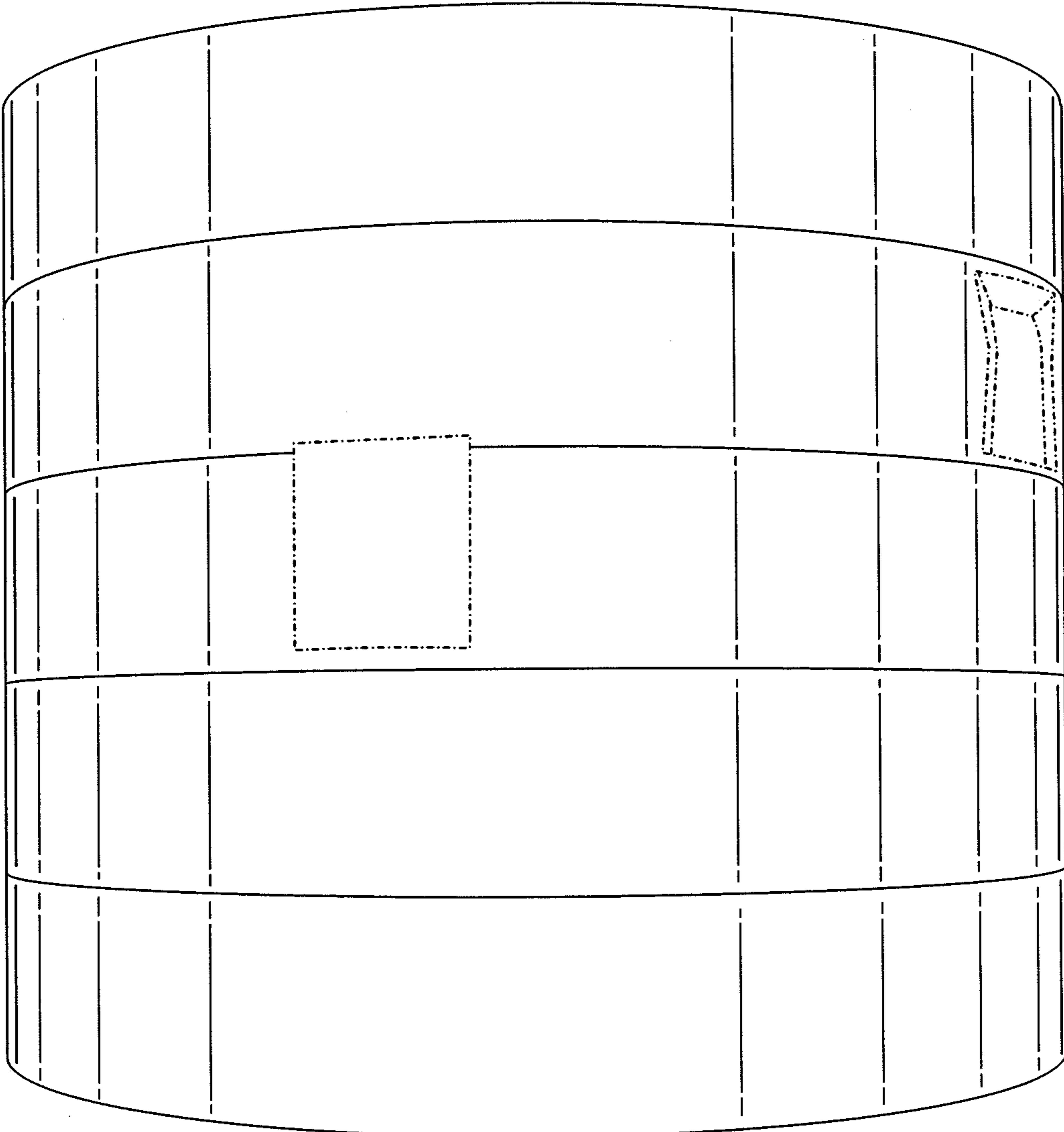
