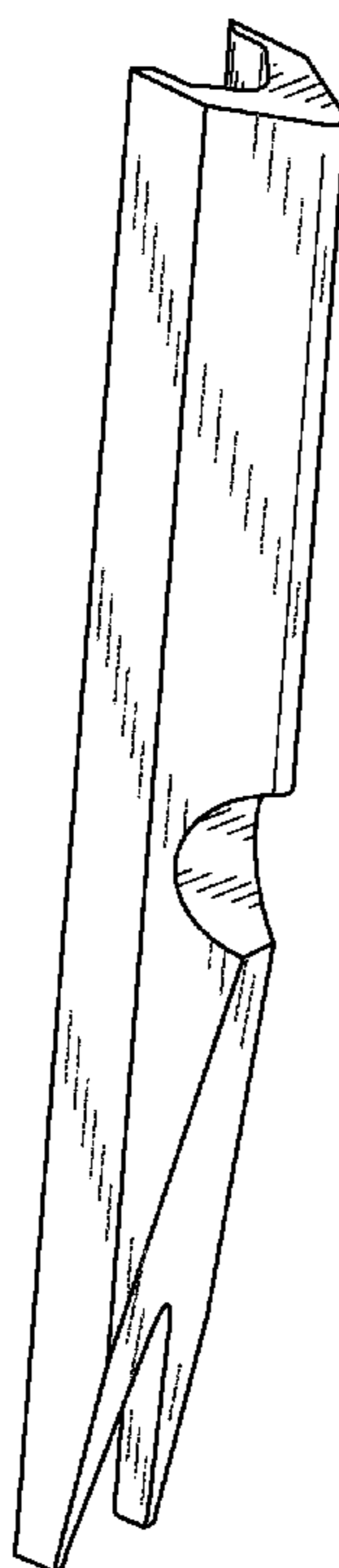

(57) **CLAIM**
The ornamental design for a blade for fiber-resin composite bolt cutter, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, right side perspective view of a blade for fiber-resin composite bolt cutter showing my new design. FIG. 2 is a bottom, back, left side perspective view thereof. FIG. 3 is a top plan view thereof. FIG. 4 is a bottom plan view thereof. FIG. 5 is a right side elevational view thereof, the left side being a mirror image thereof. FIG. 6 is a front side elevational view thereof; and, FIG. 7 is a back side elevational view thereof.

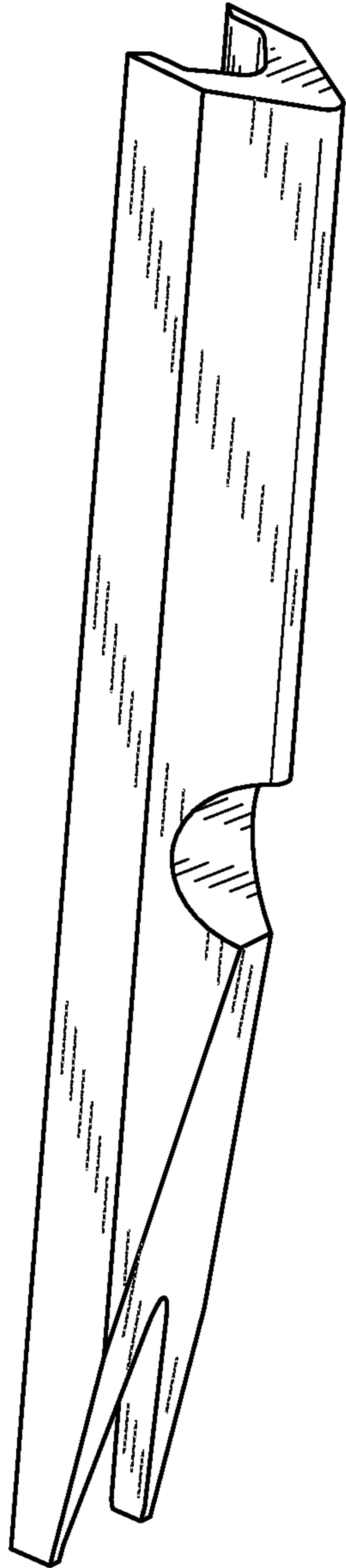

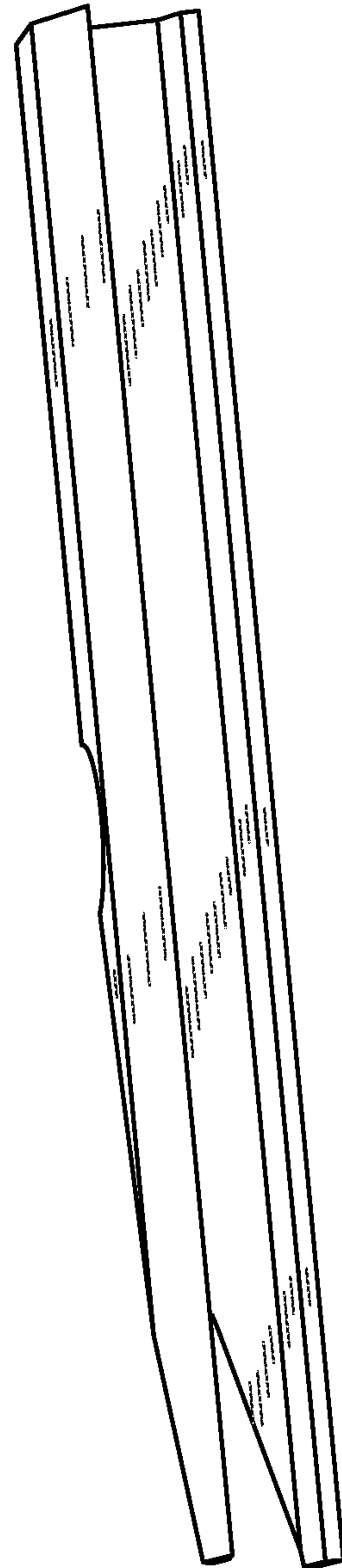

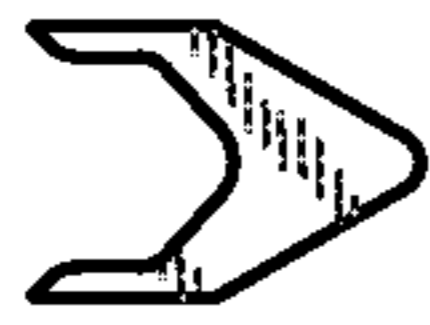

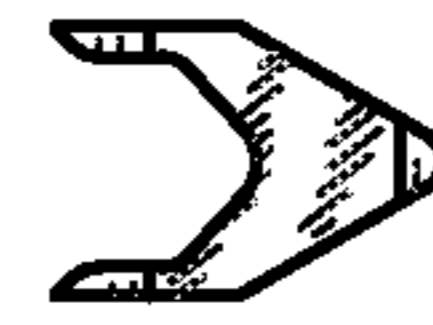

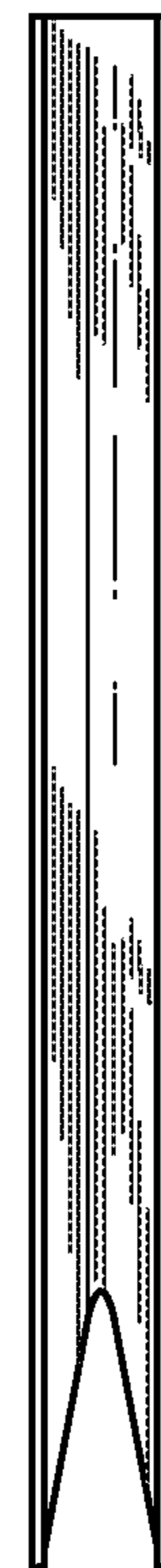
