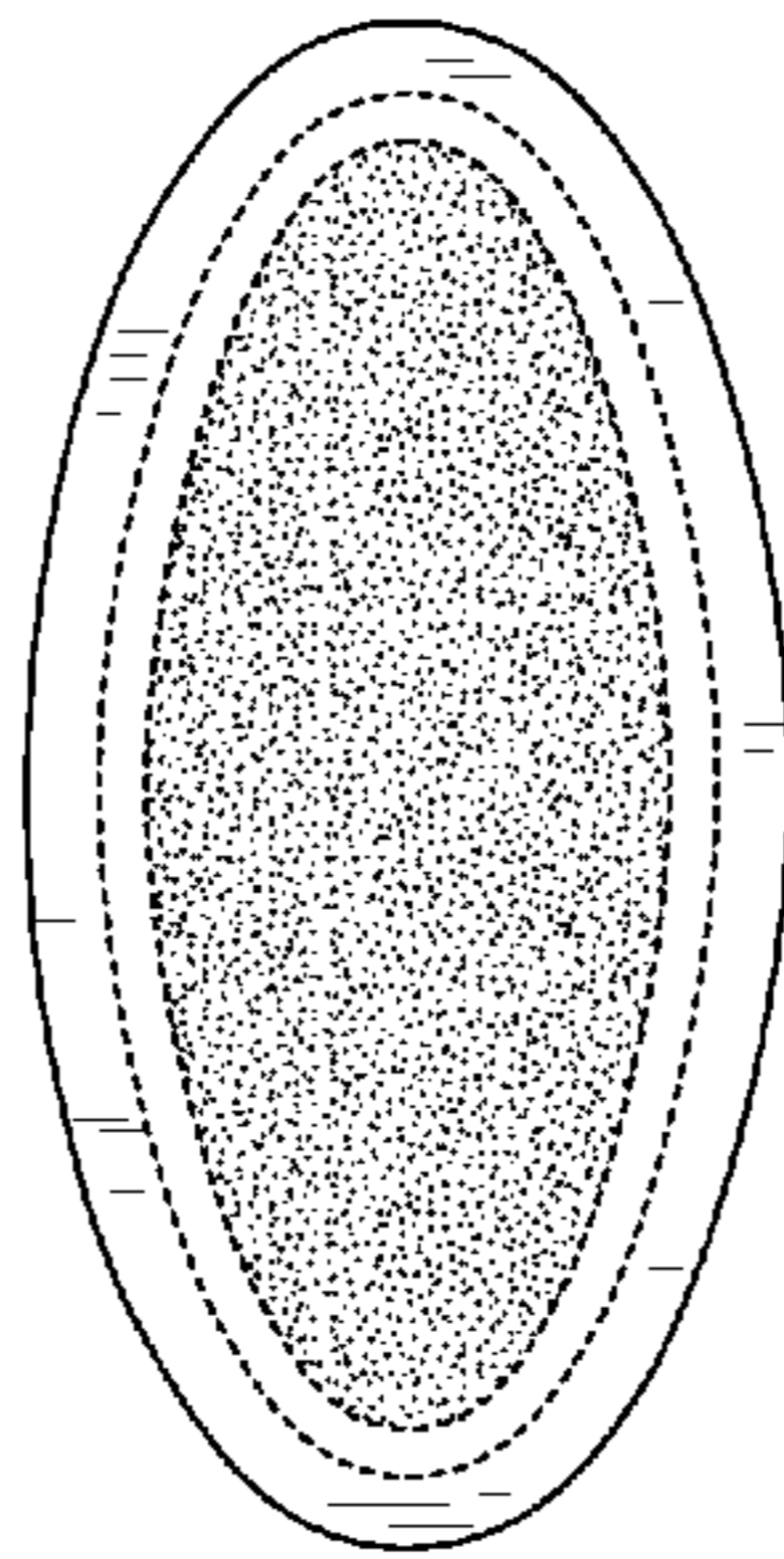
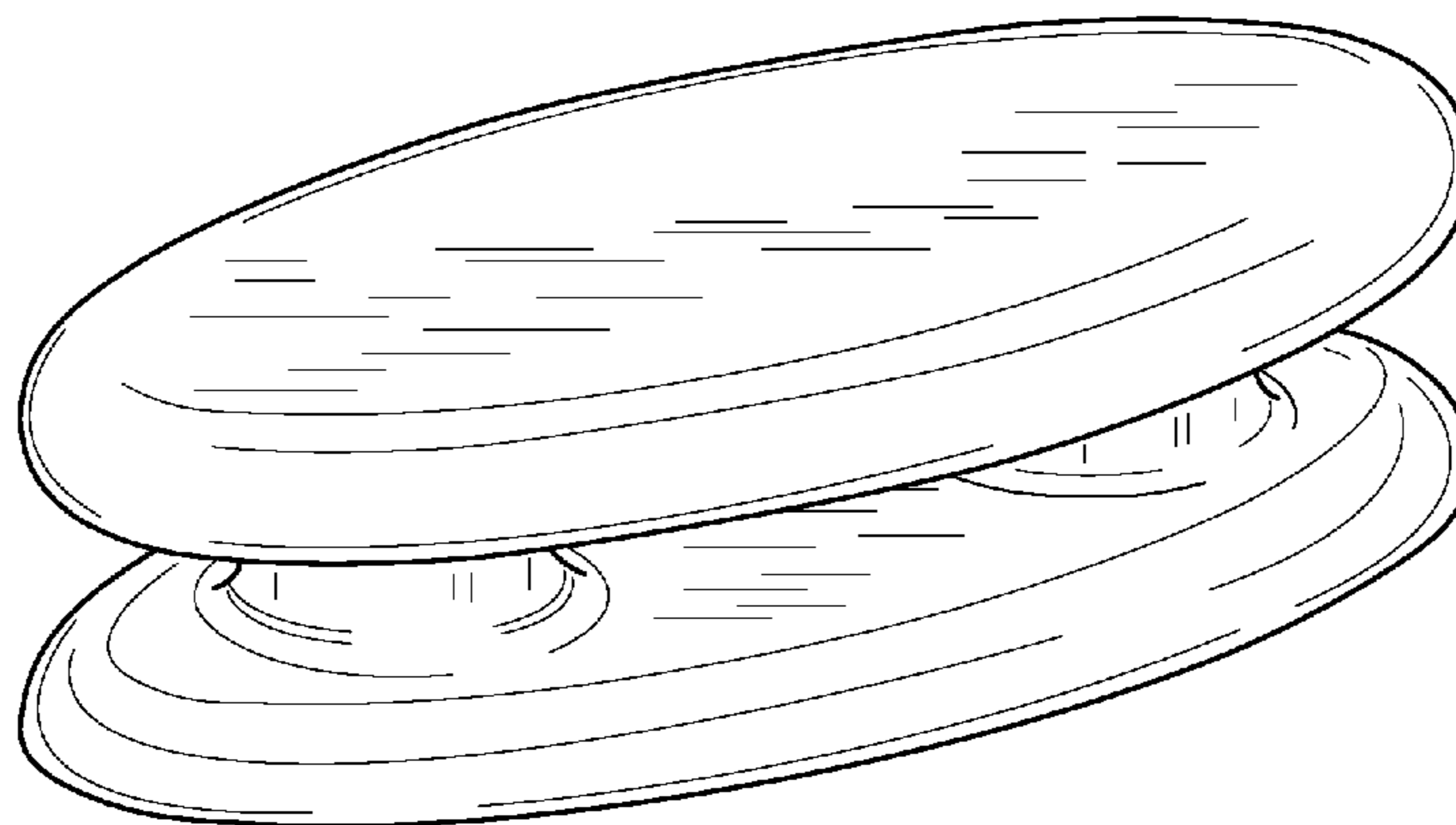
(57) **CLAIM**

The ornamental design for a cord retainer, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the cord retainer;
 FIG. 2 is a front elevational view of the cord retainer.
 FIG. 3 is a rear elevation thereof with the broken lines forming a portion of the structure that forms no part of the claim;
 FIG. 4 is a right side view thereof.
 FIG. 5 is a left side elevational view thereof.
 FIG. 6 is a top plan view thereof.
 FIG. 7 is a bottom plan view thereof; and,
 FIG. 8 is a perspective view thereof, shown on the back of a smartphone with a pair of earbuds attached to a cord wrapped around it in broken lines representing an environment of use forming no part of the claim.

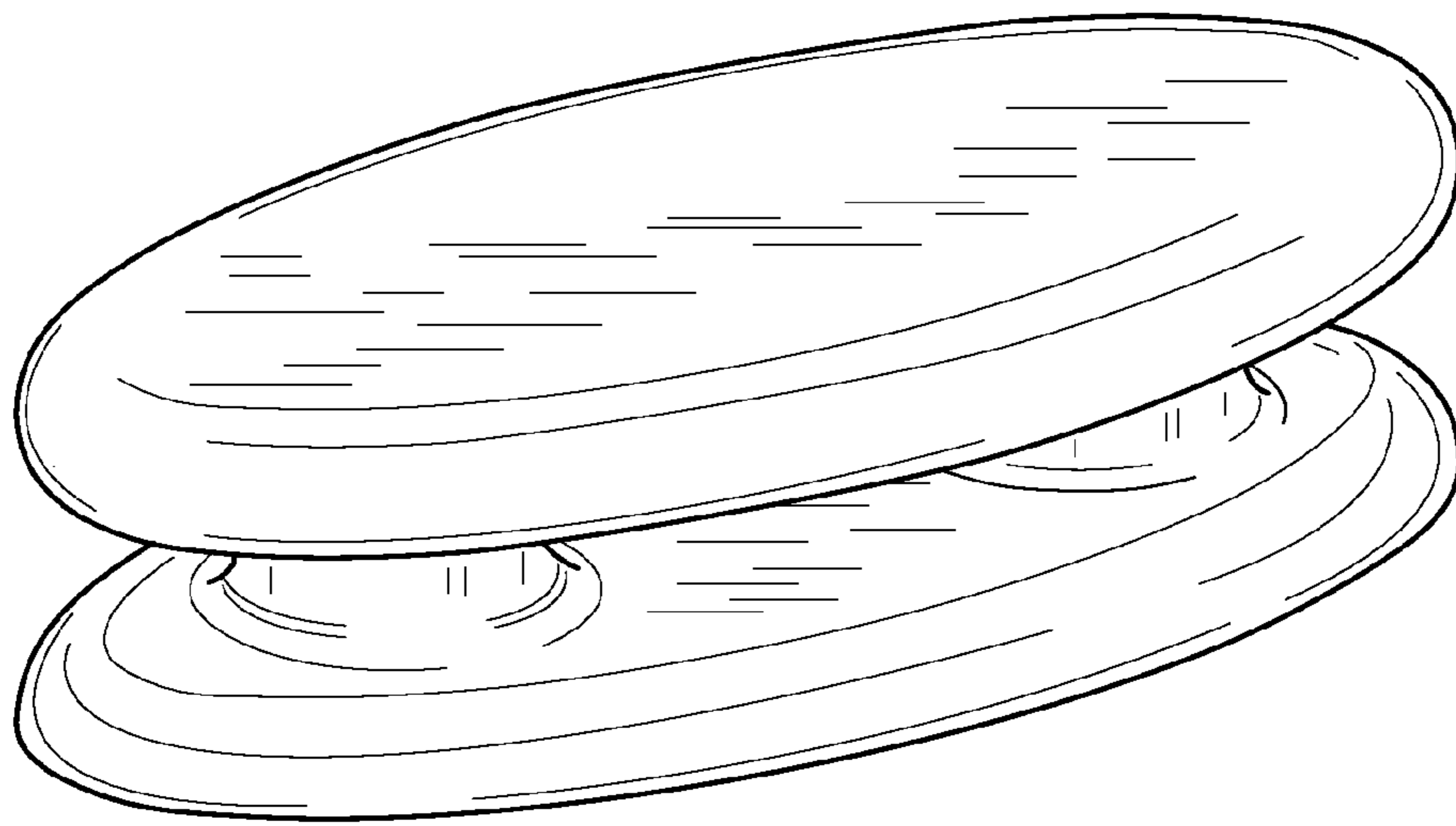

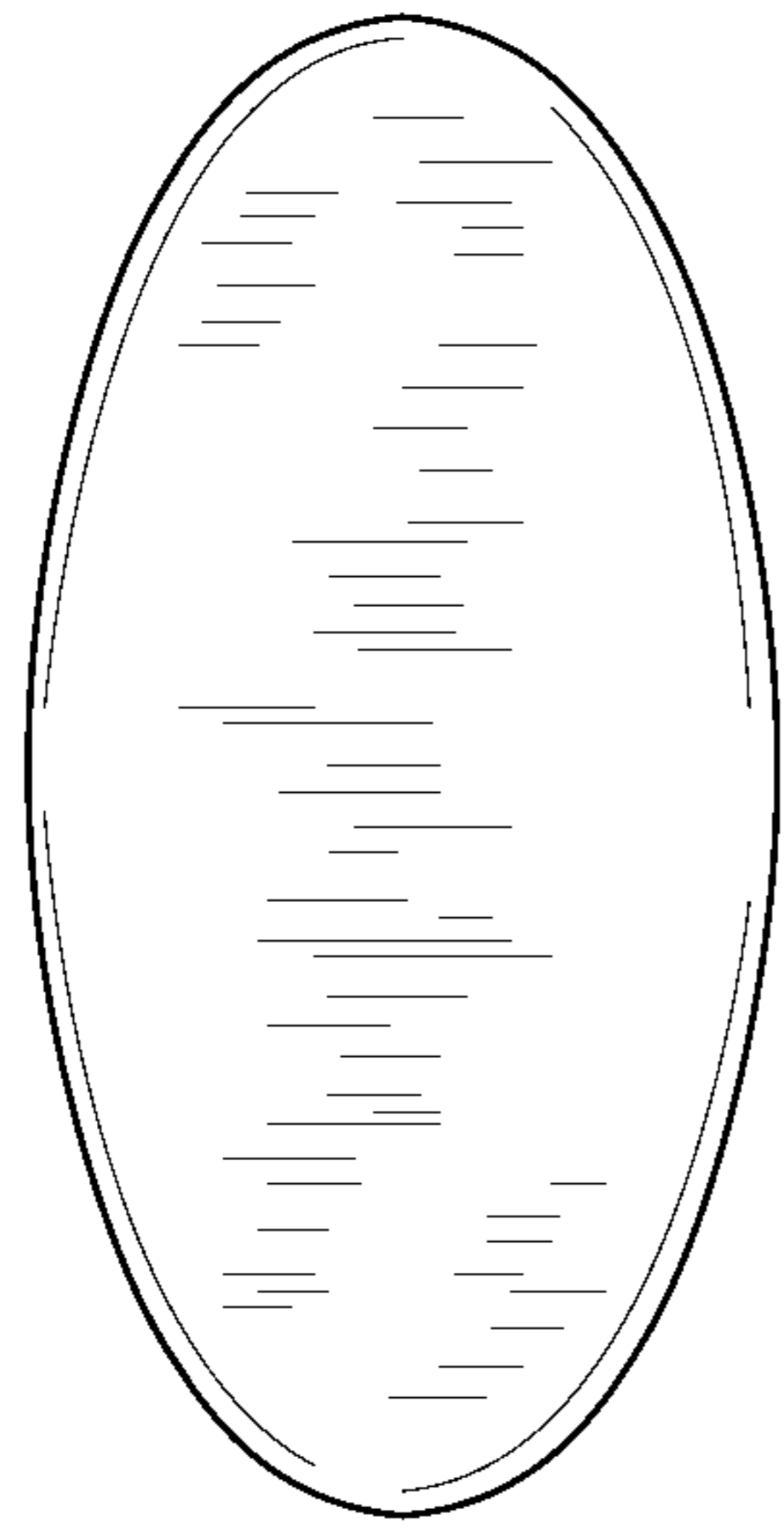

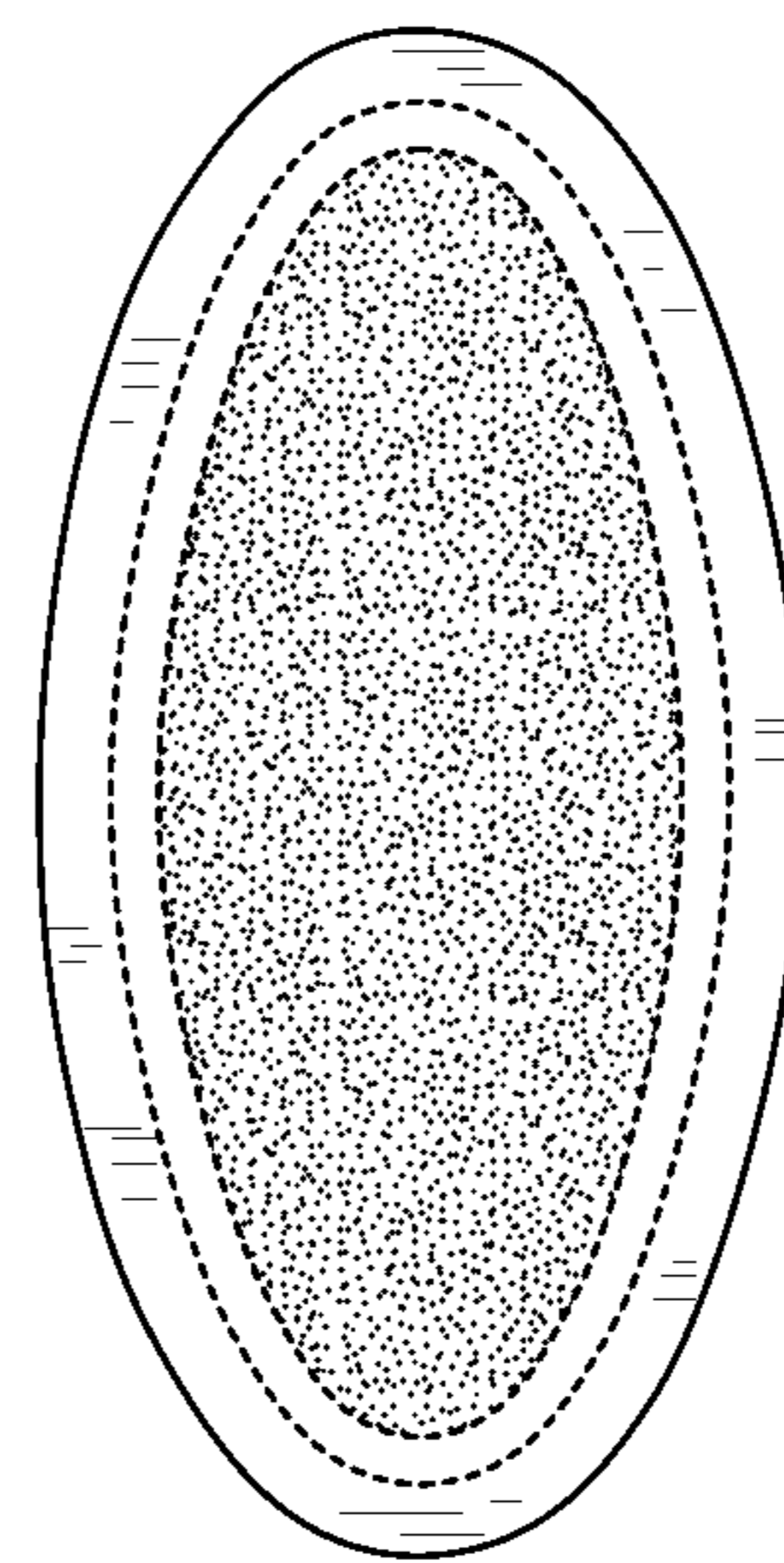

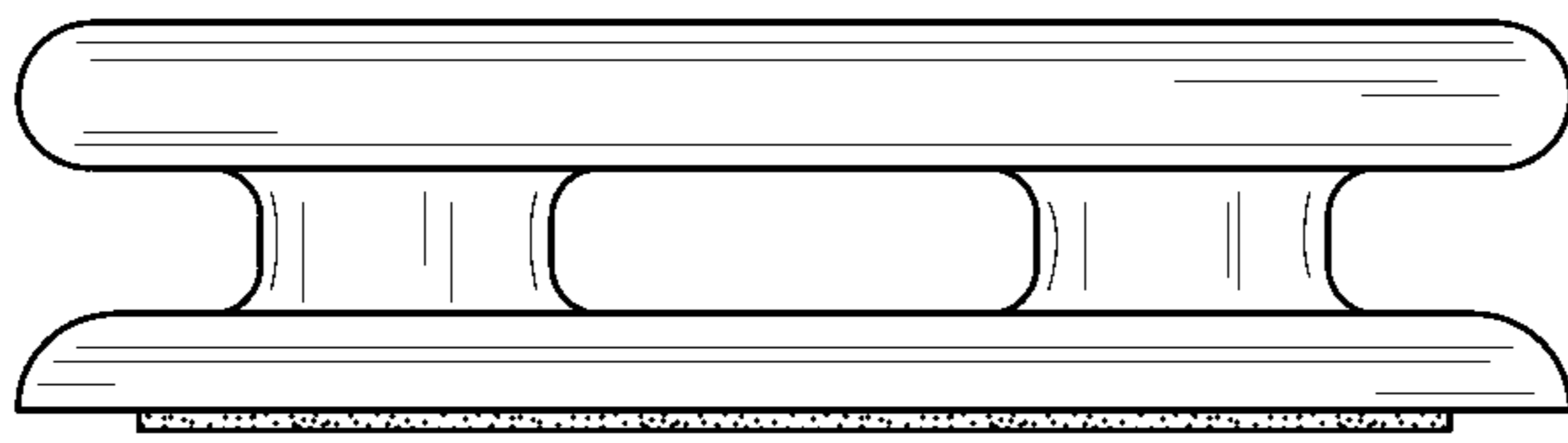

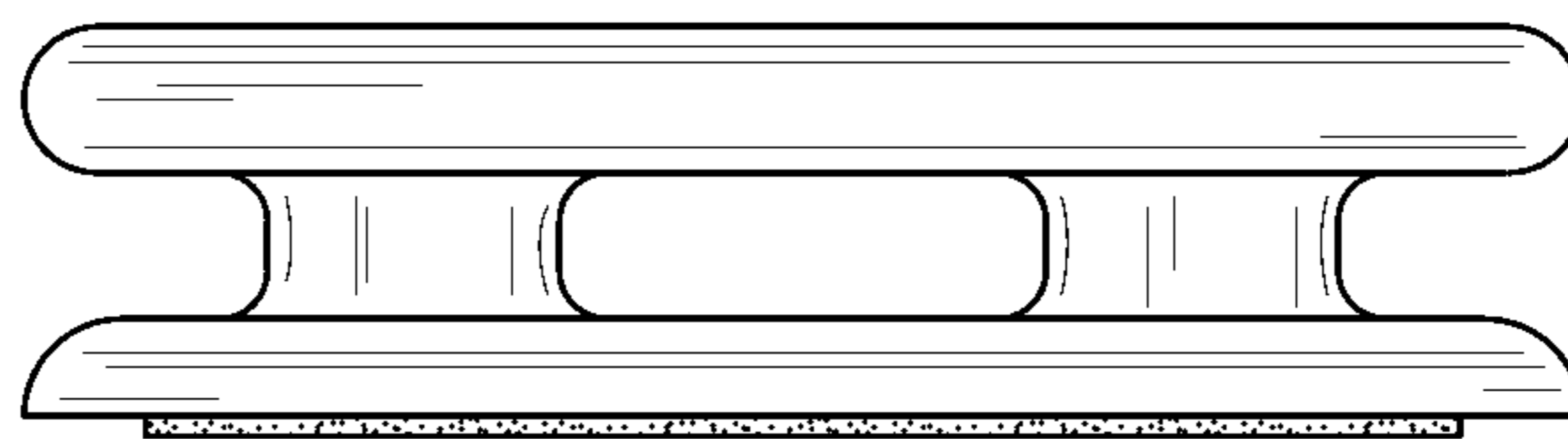

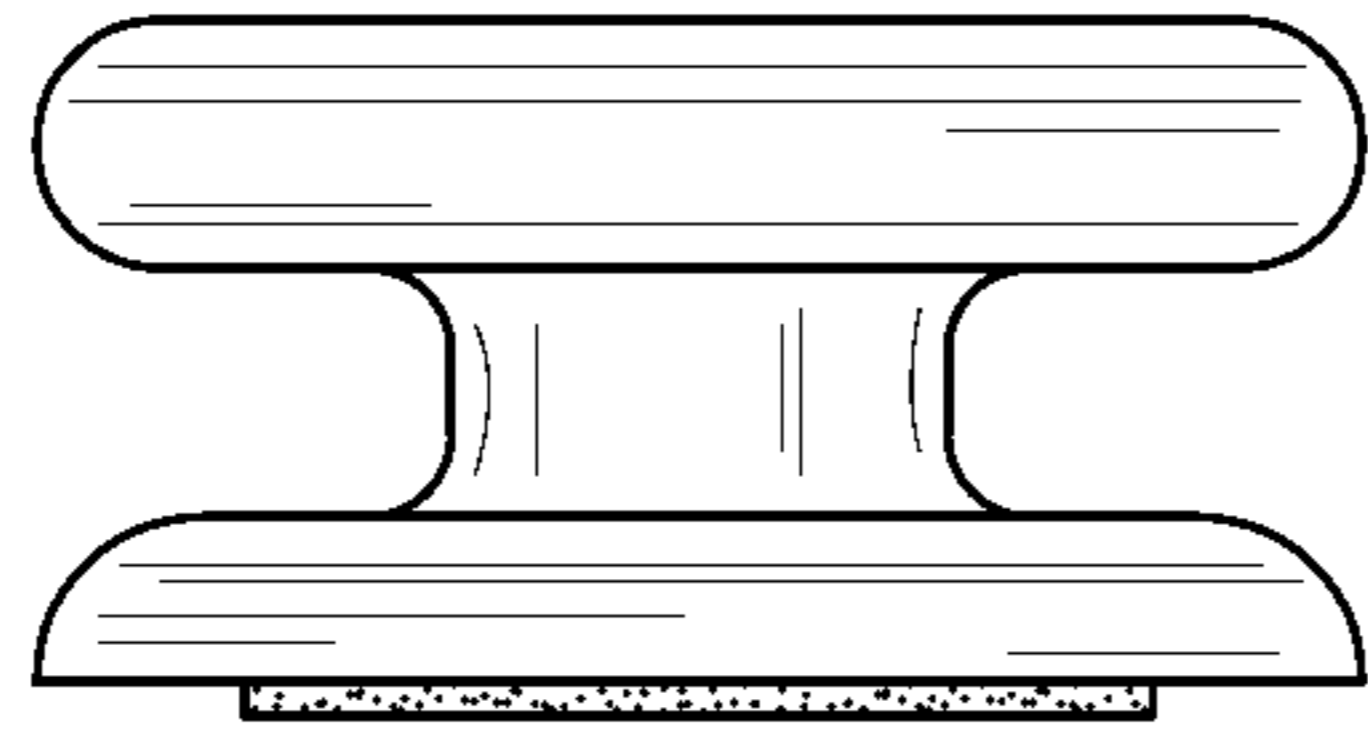

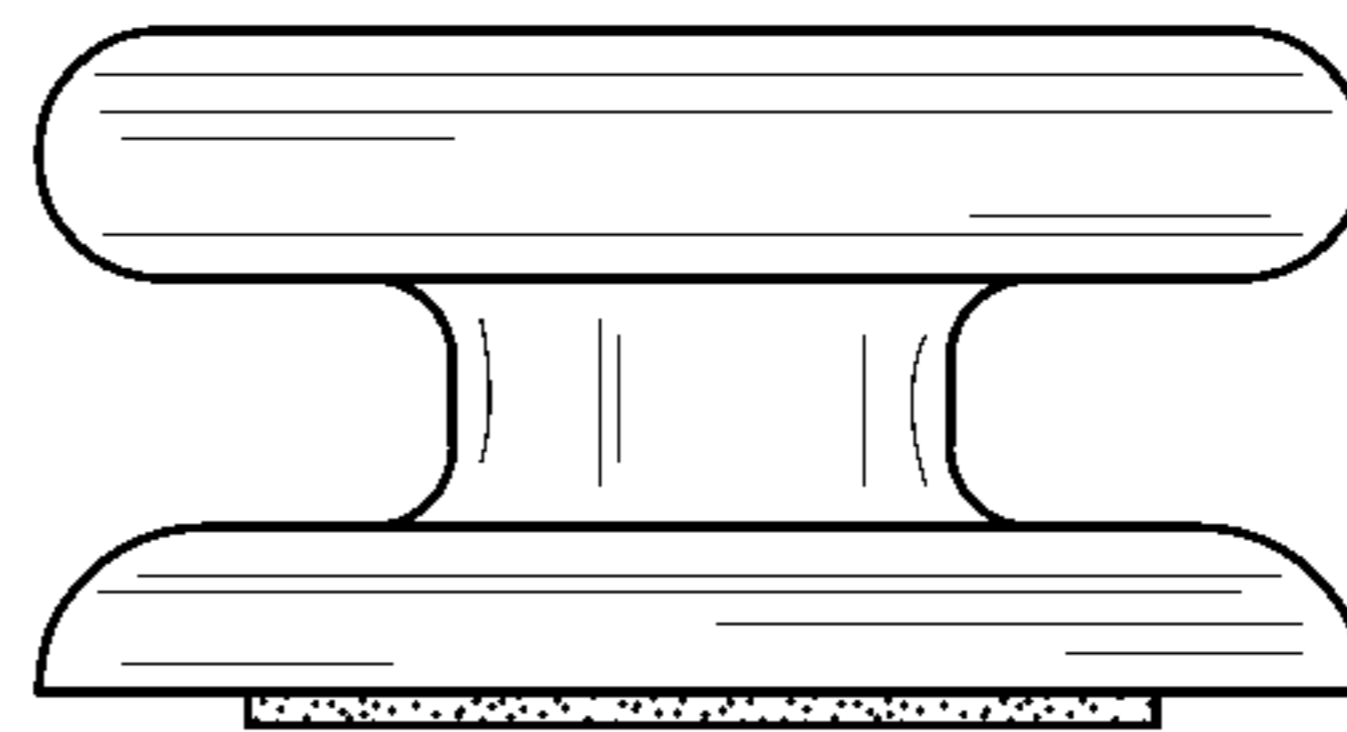

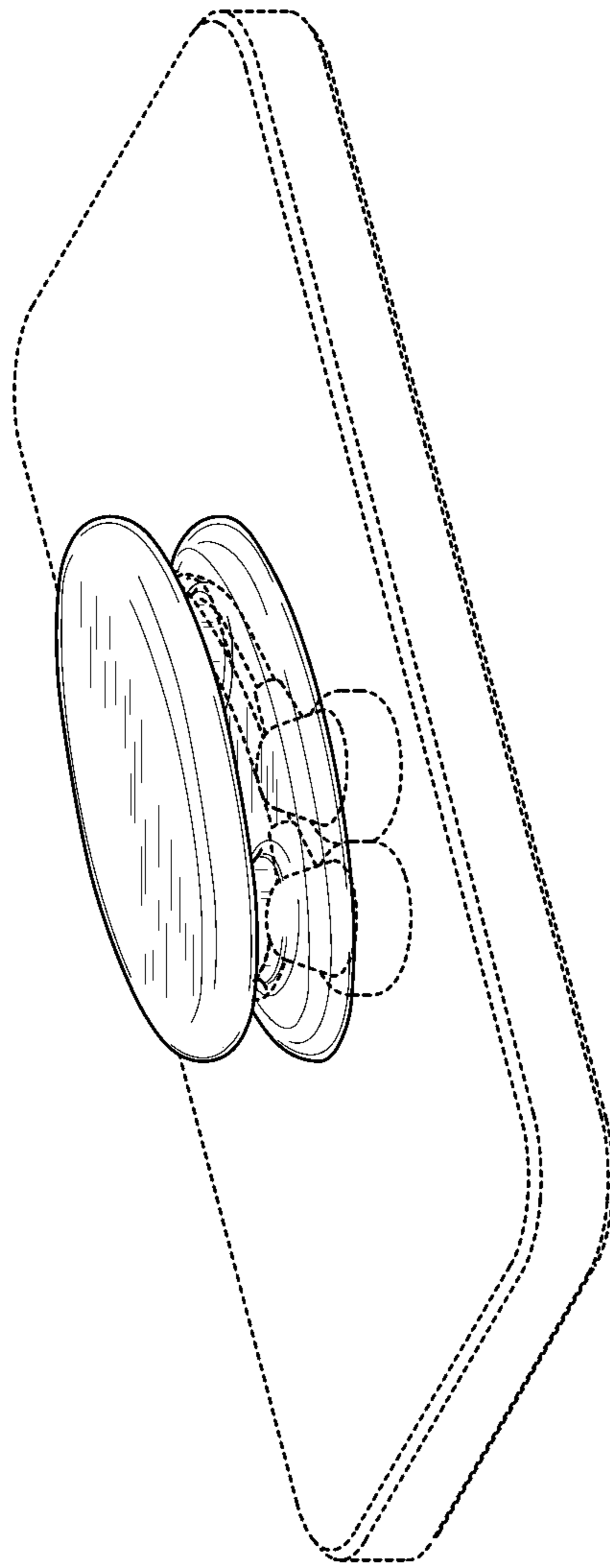
