(57) **CLAIM**

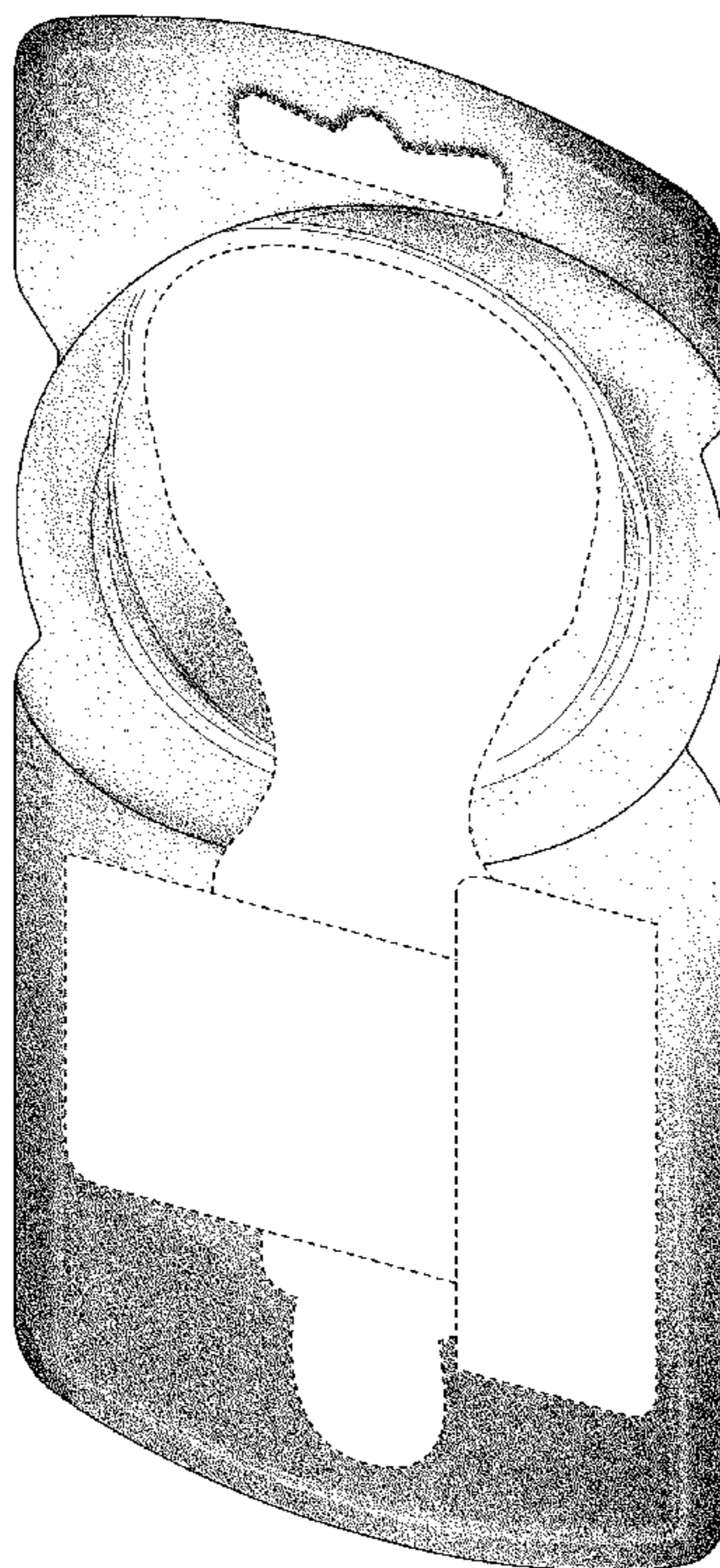
The ornamental design for a package card for a shaving product, as shown and described.

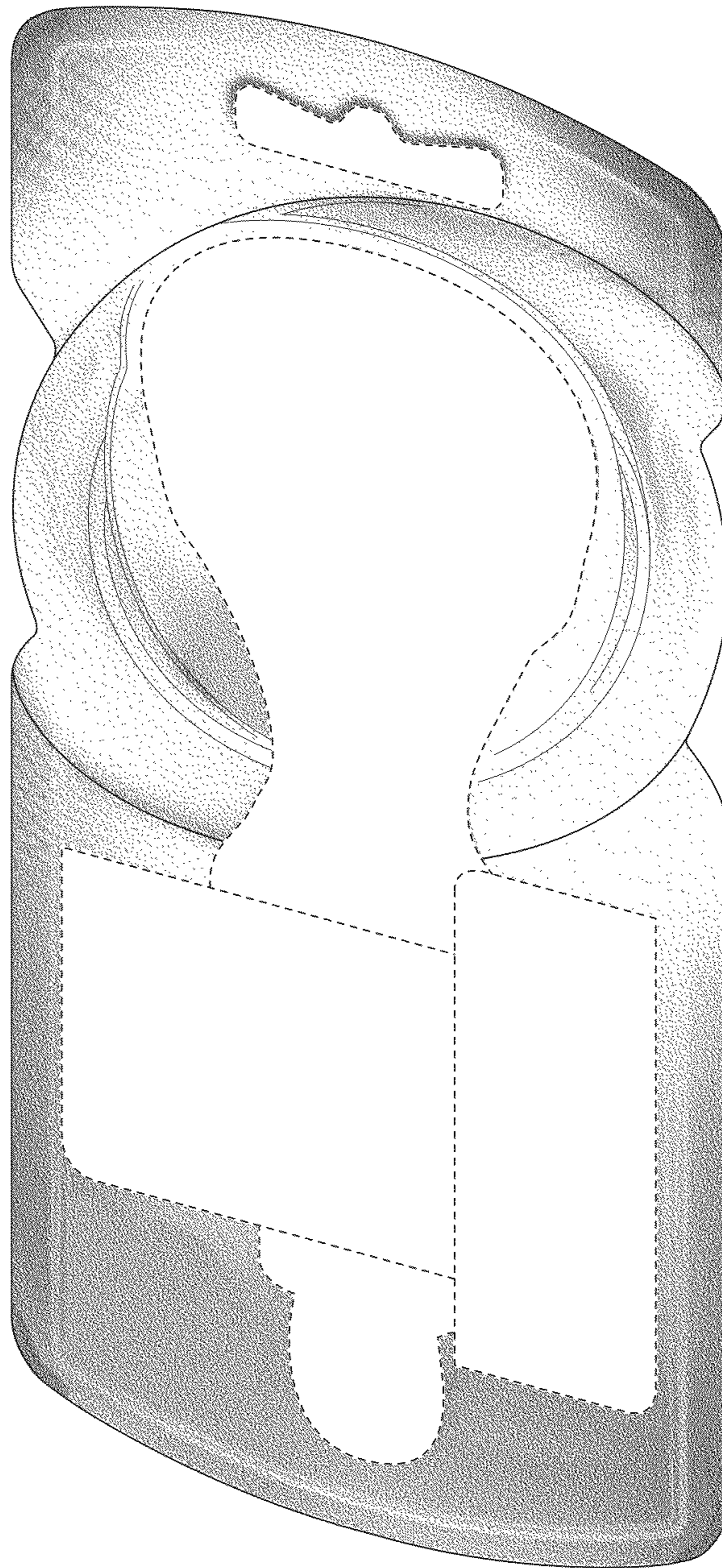

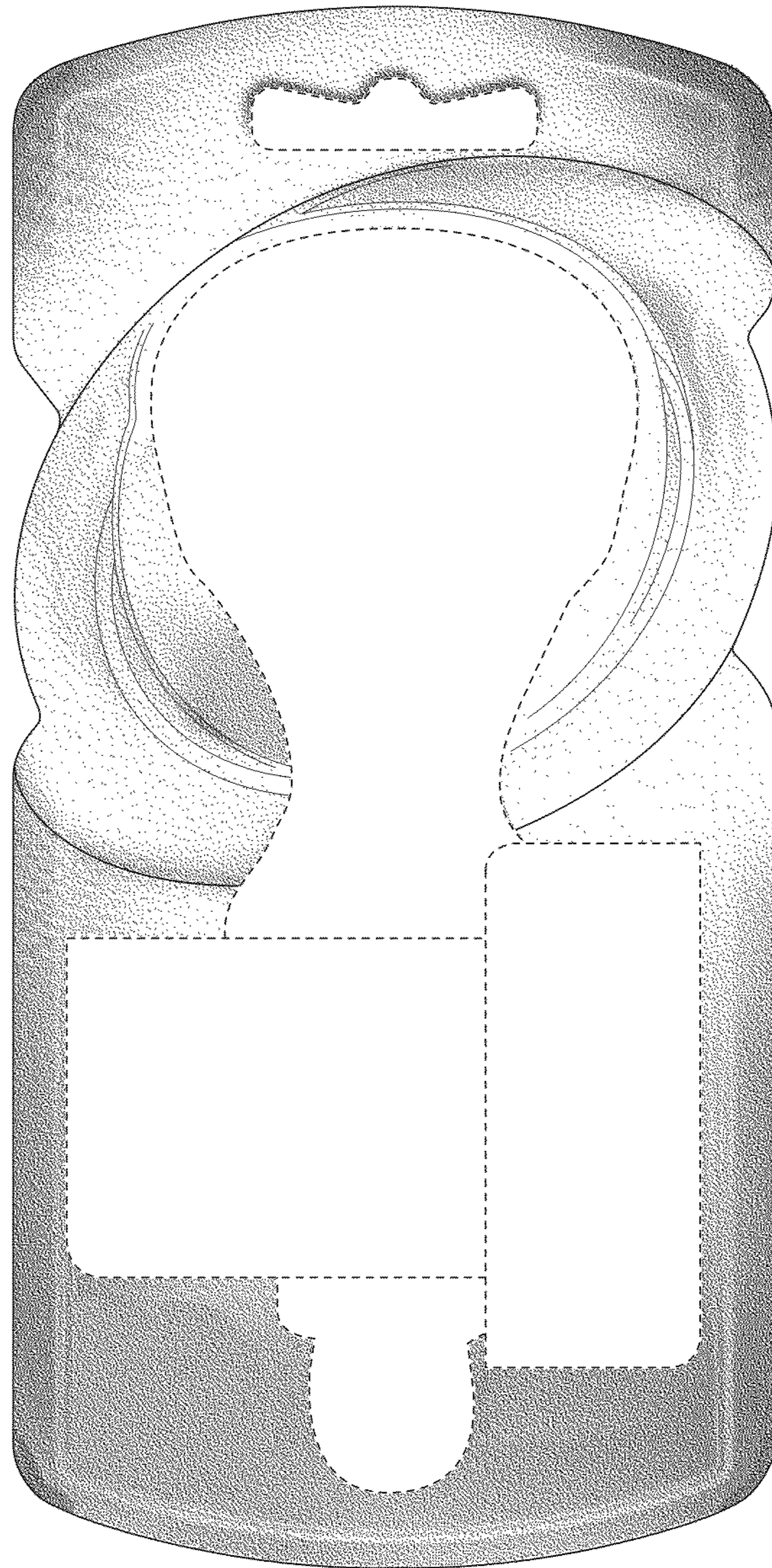

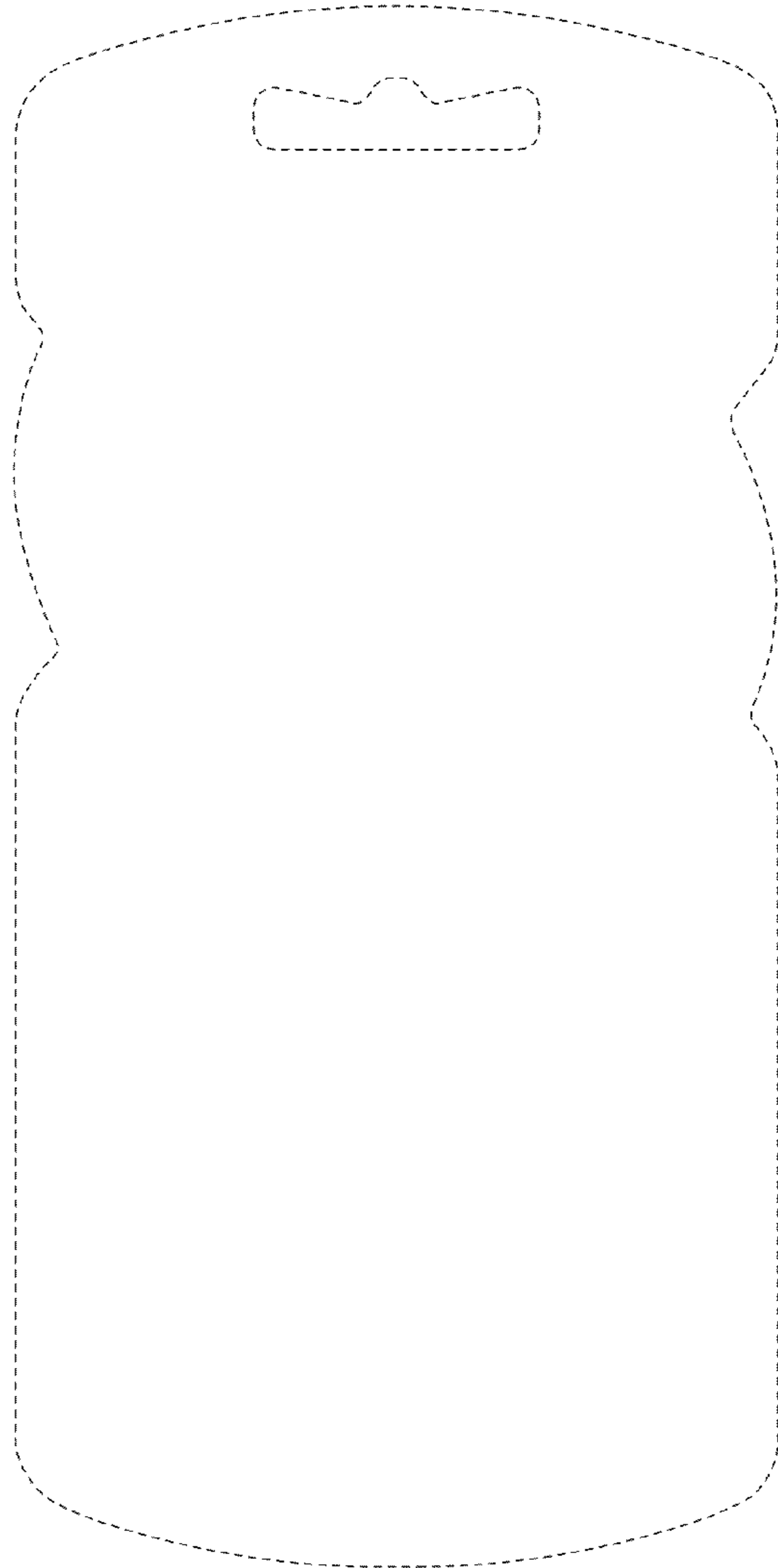

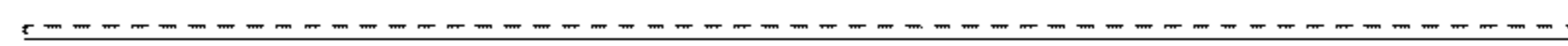
