DESCRIPTION

FIG. 1 is a top perspective view of a gemstone jewelry setting showing my new design;

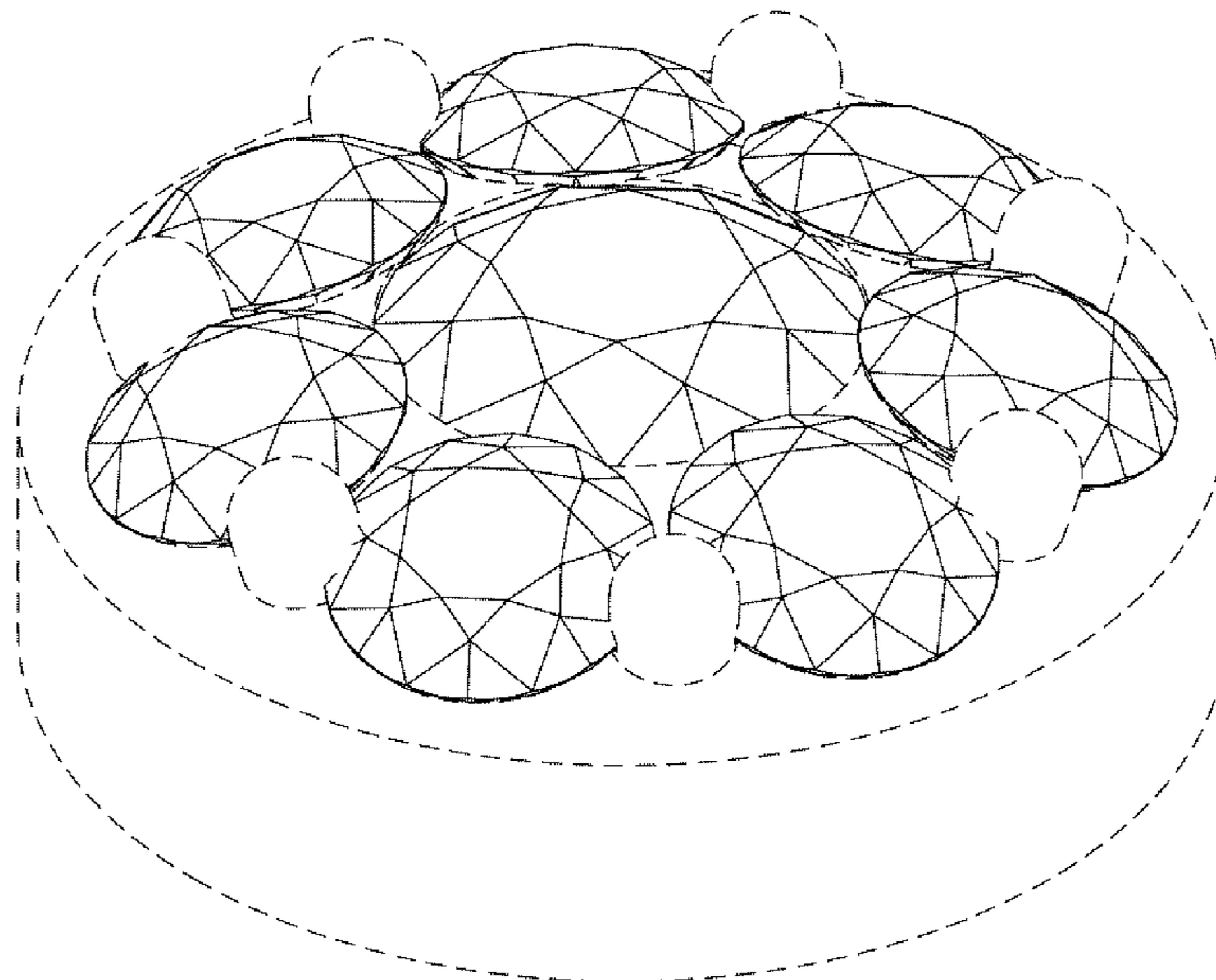

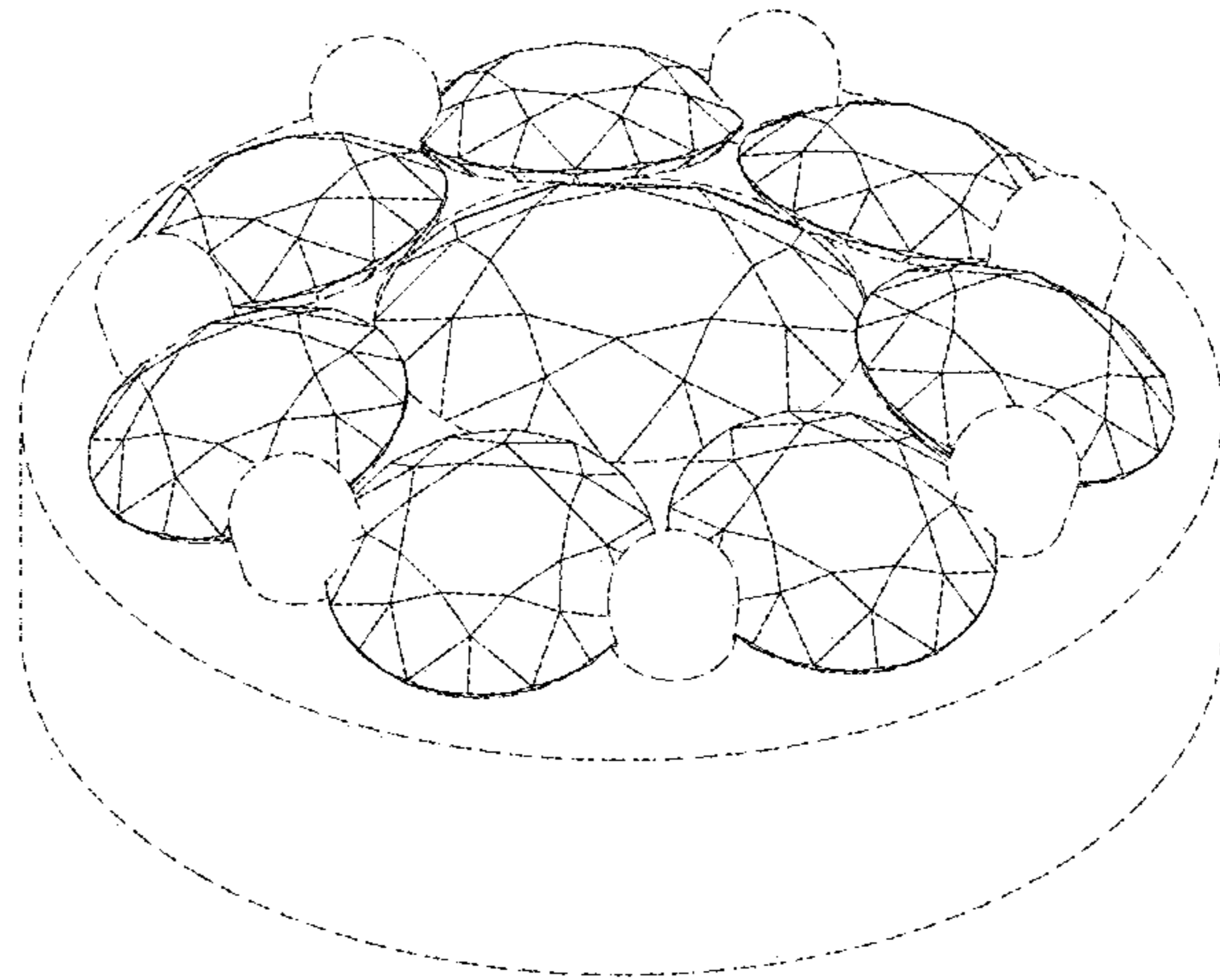

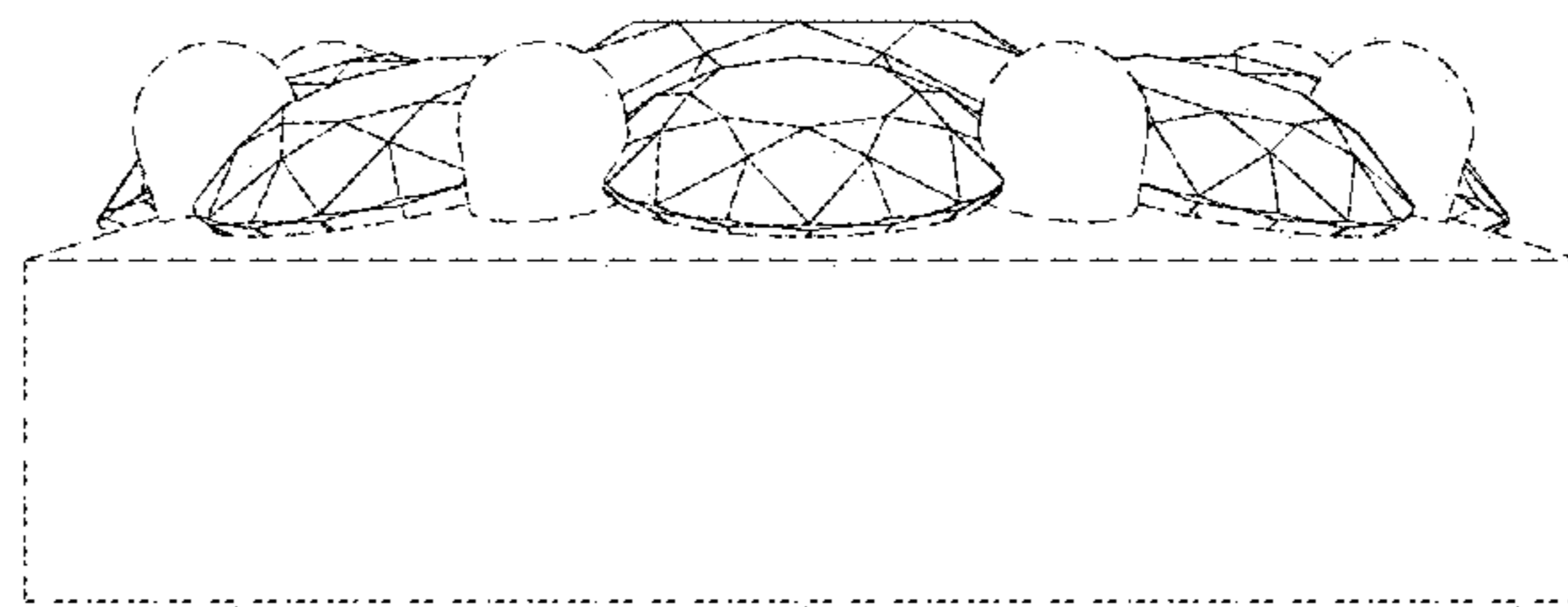

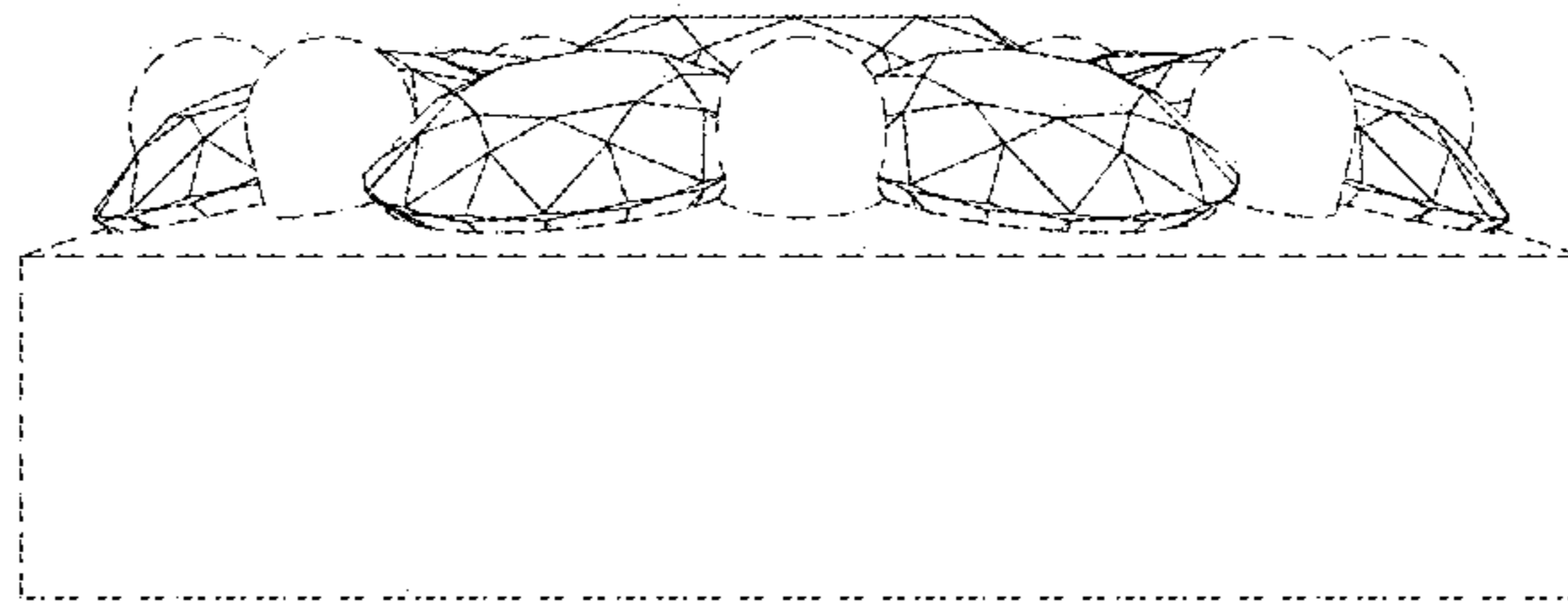

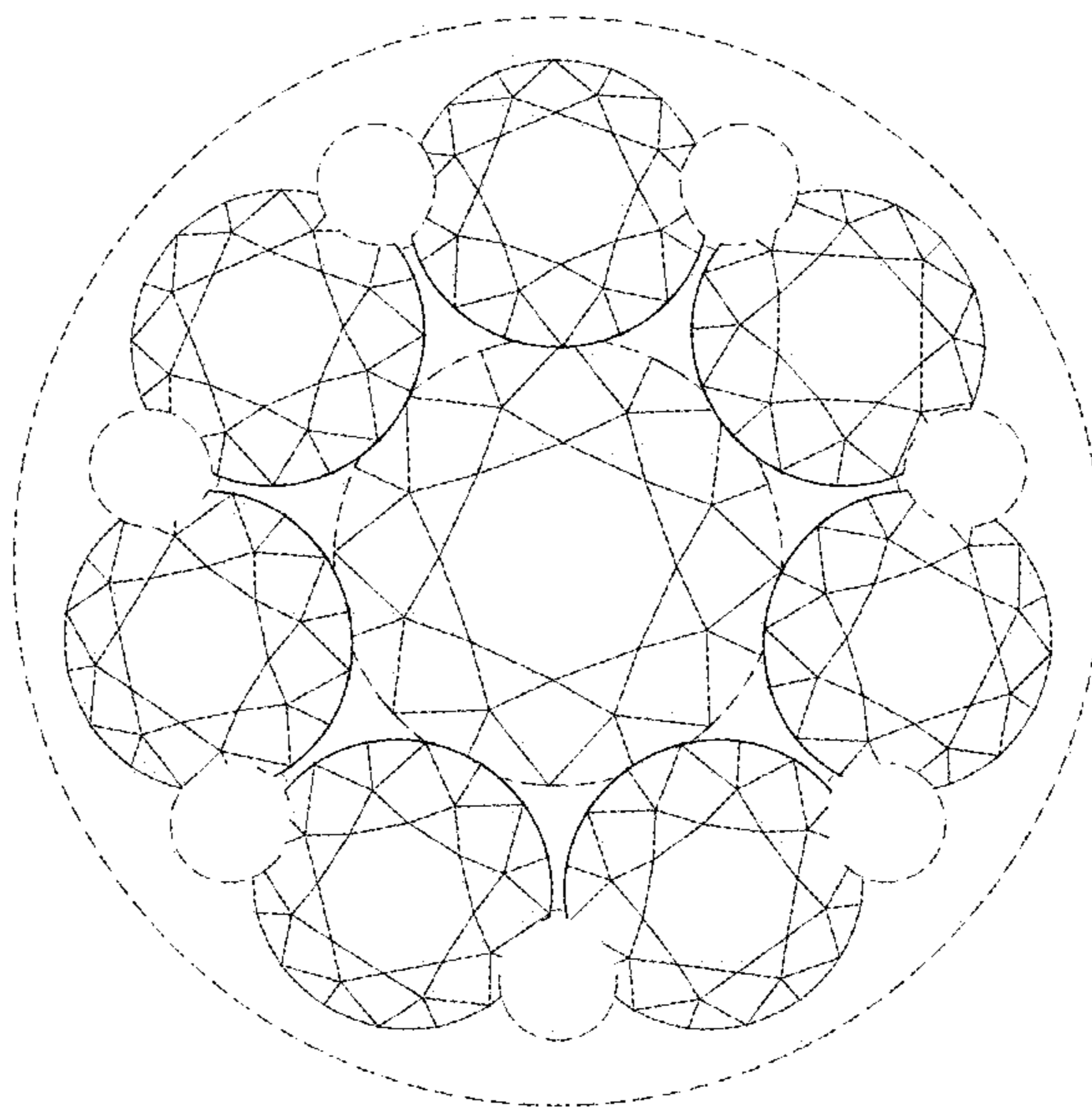

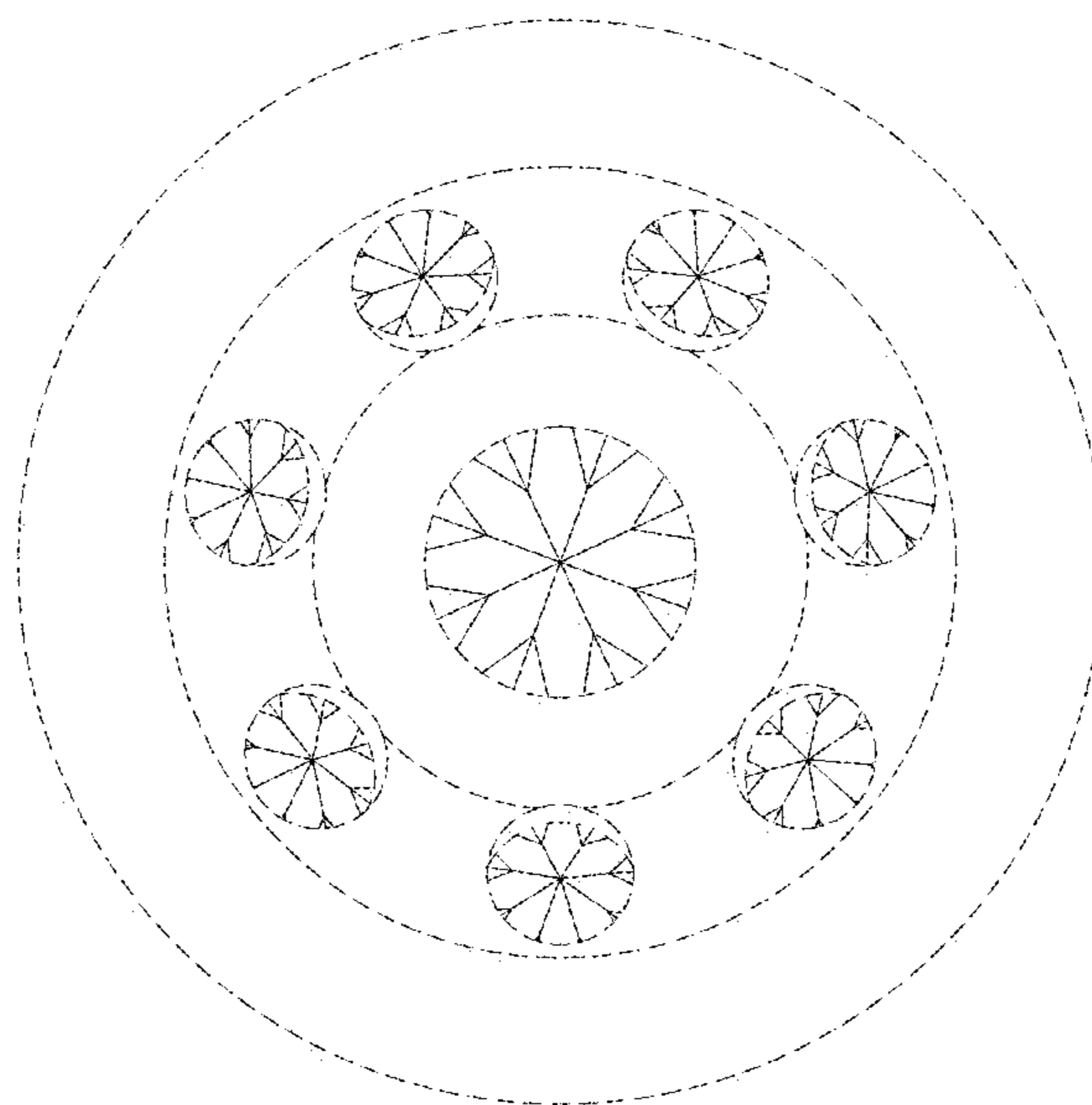

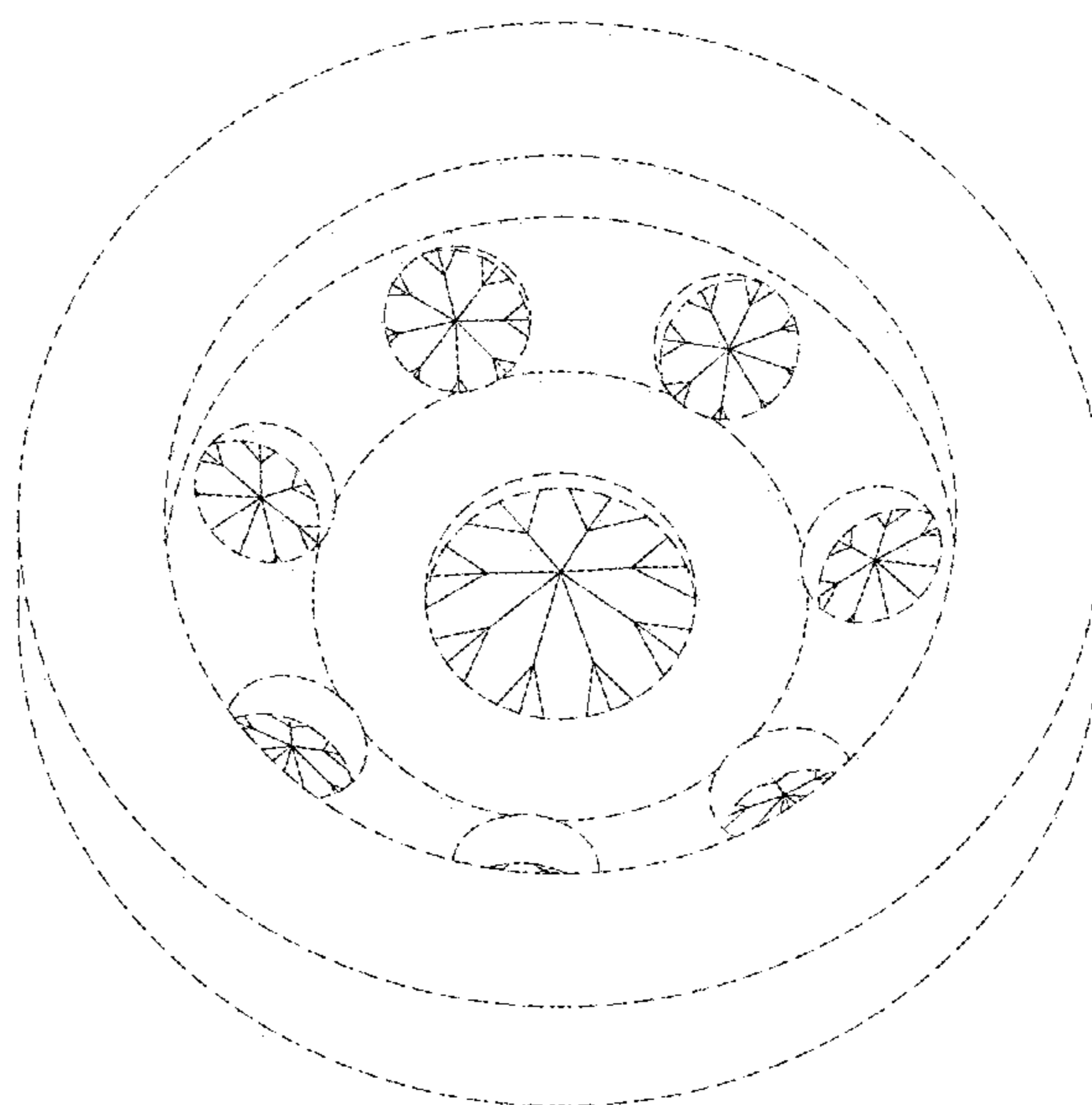

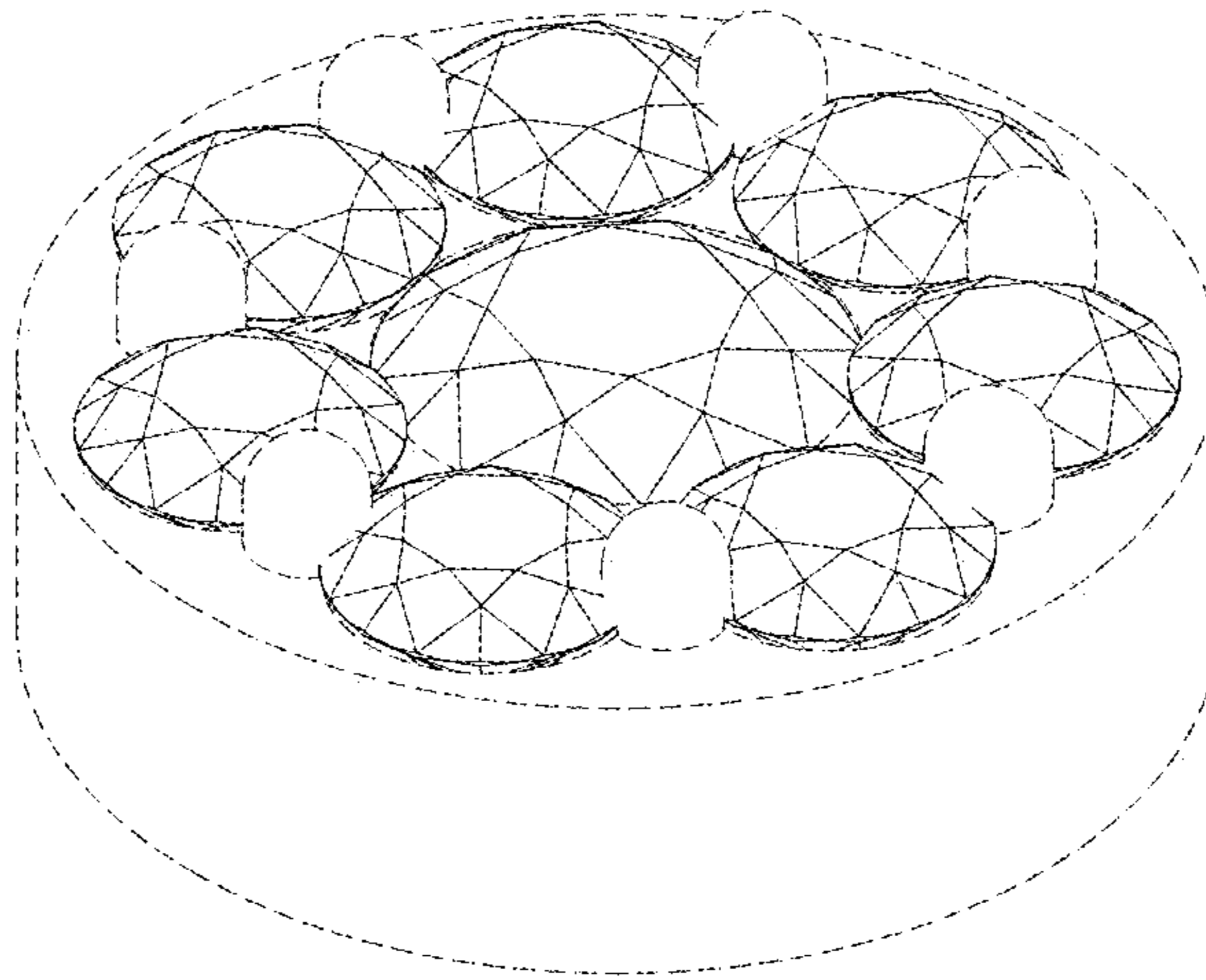

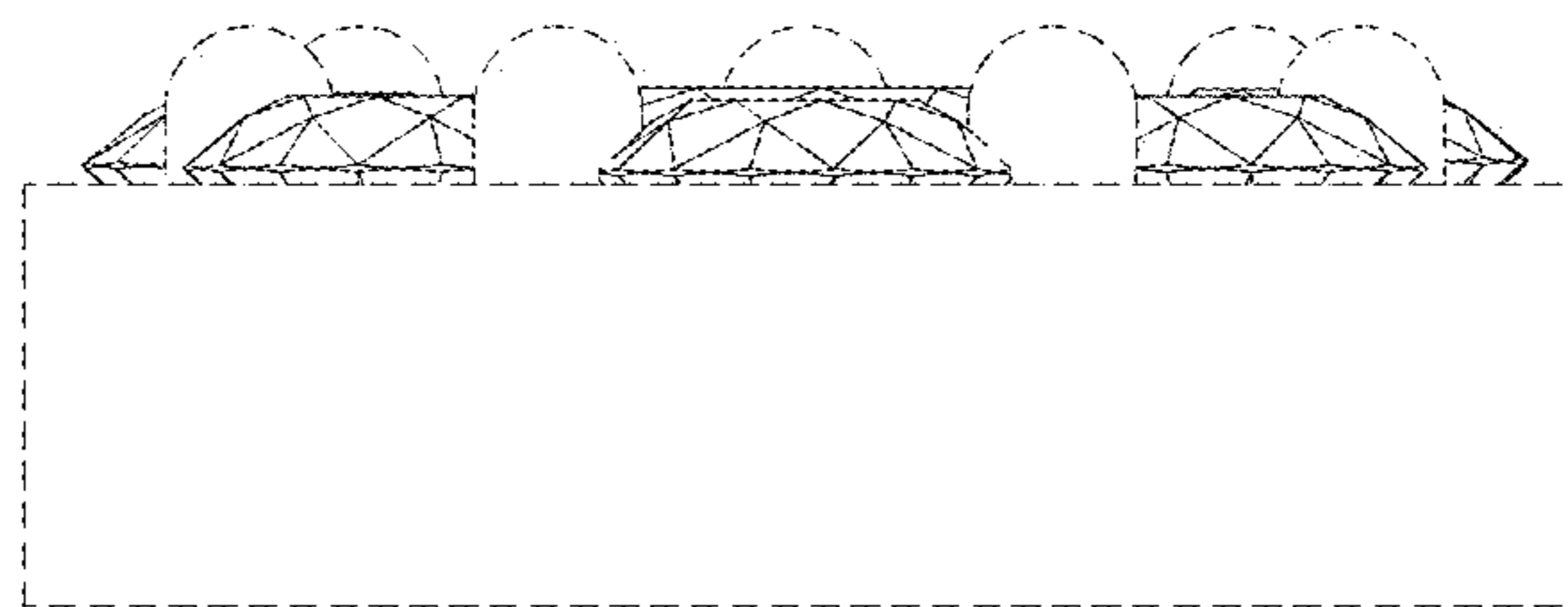

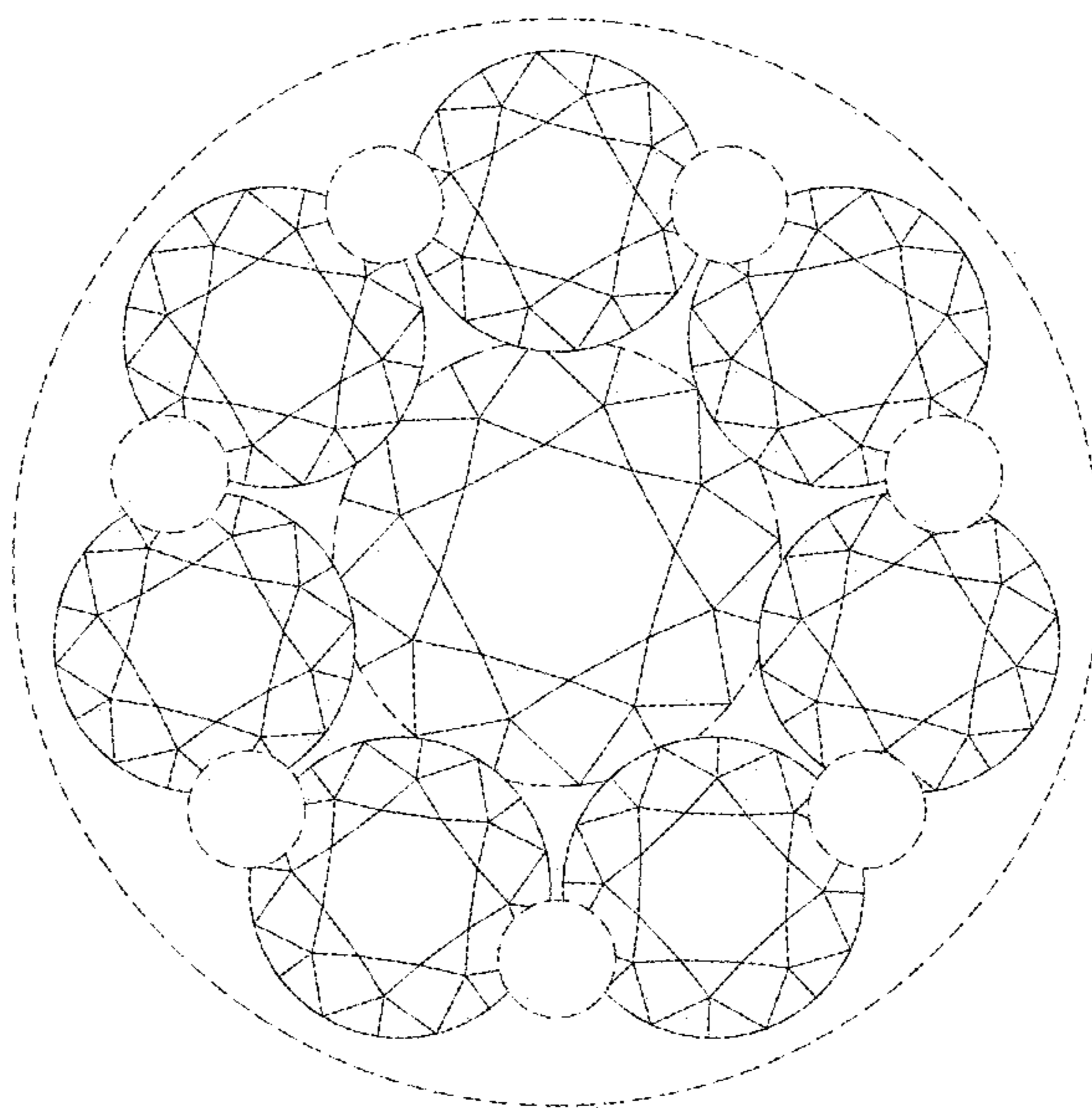

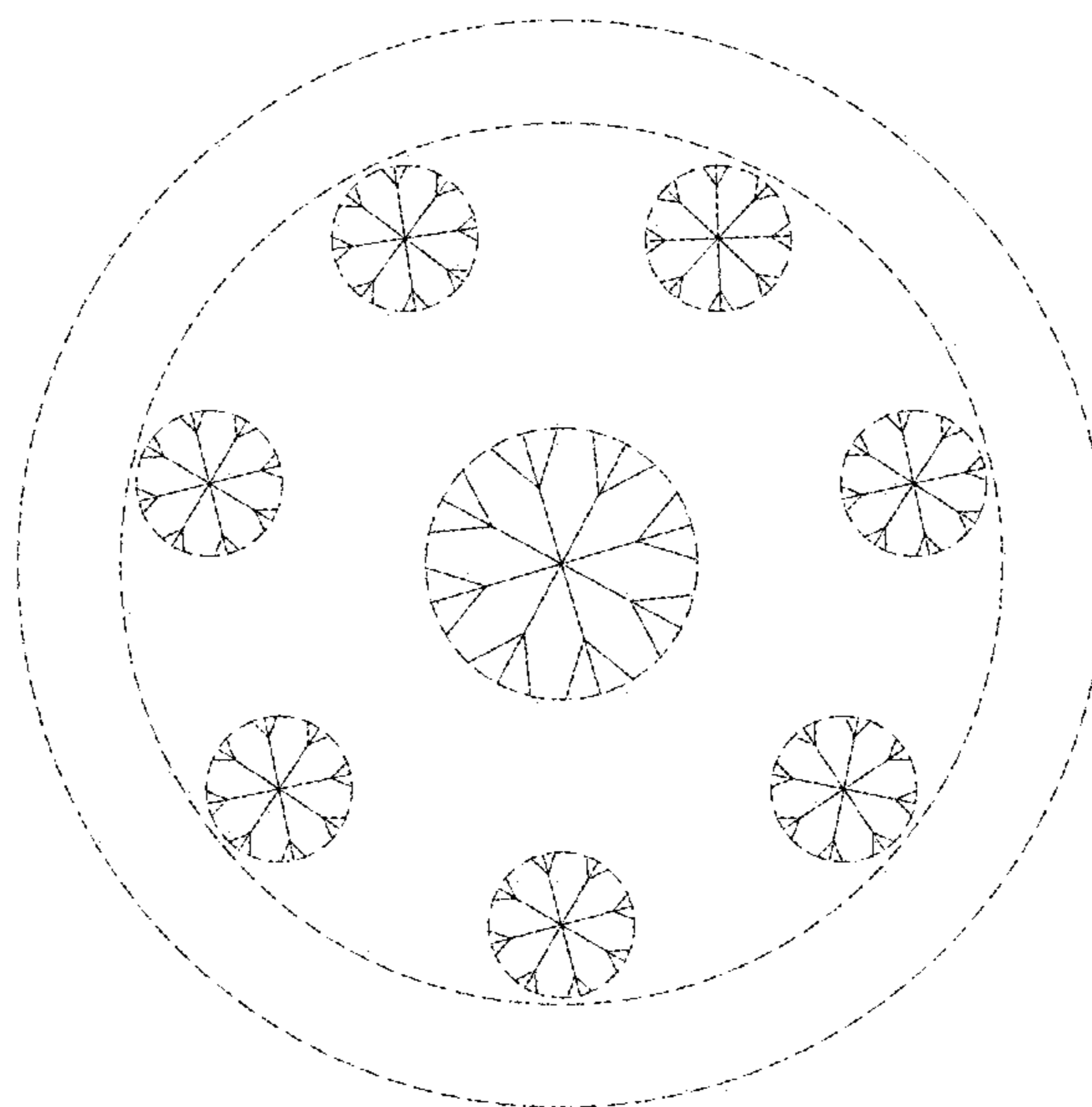
