(57) **CLAIM**

I claim the ornamental design for in-cab accessory mounting kit for vehicles, as shown and described.

DESCRIPTION

This application filed concurrently with pending U.S. patent application Ser. No. 13/134,112.

FIG. 1 is a perspective view of an in-cab accessory mounting kit for vehicles showing my new design;

FIG. 6 is a top plan view thereof;

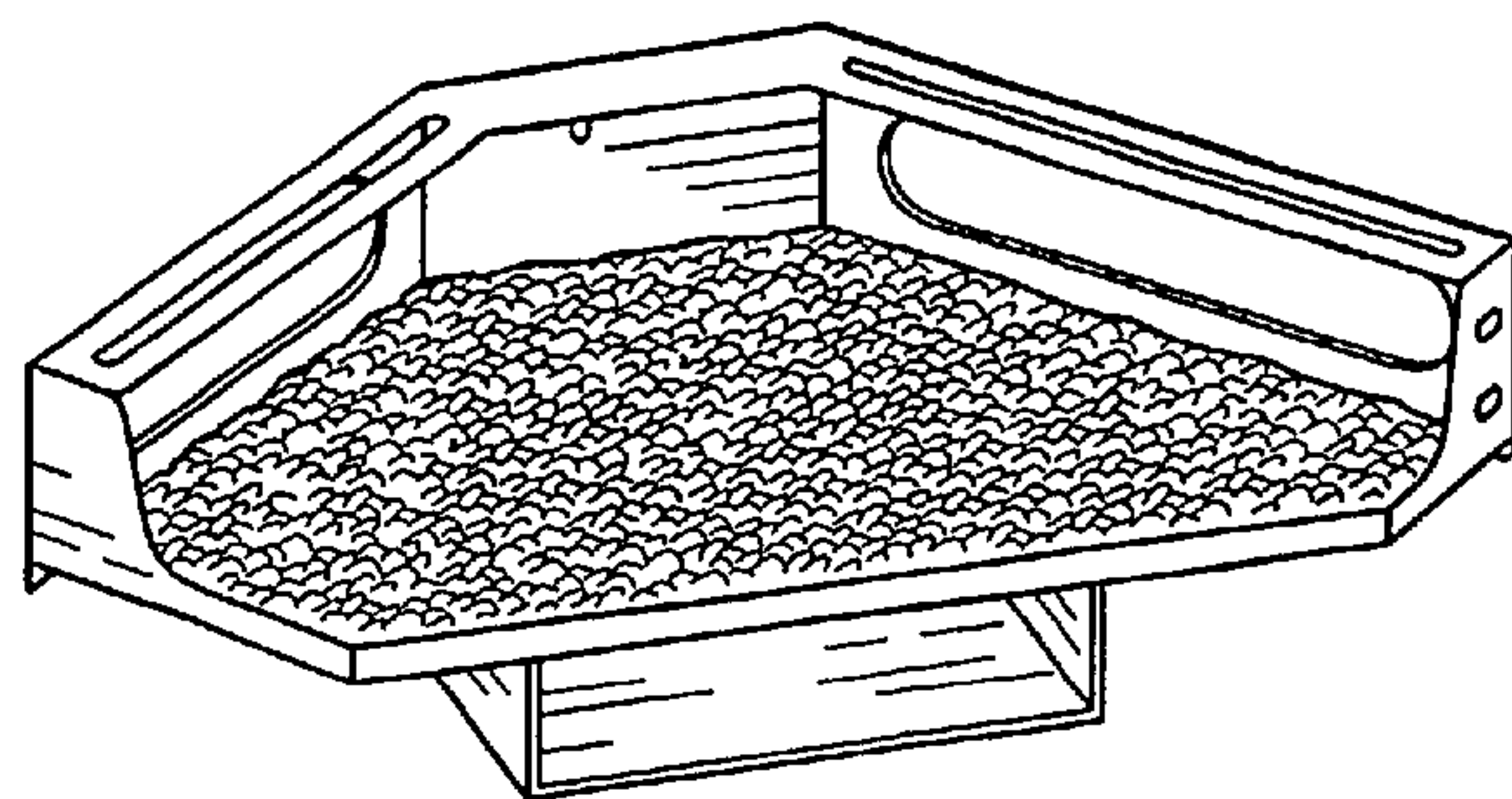
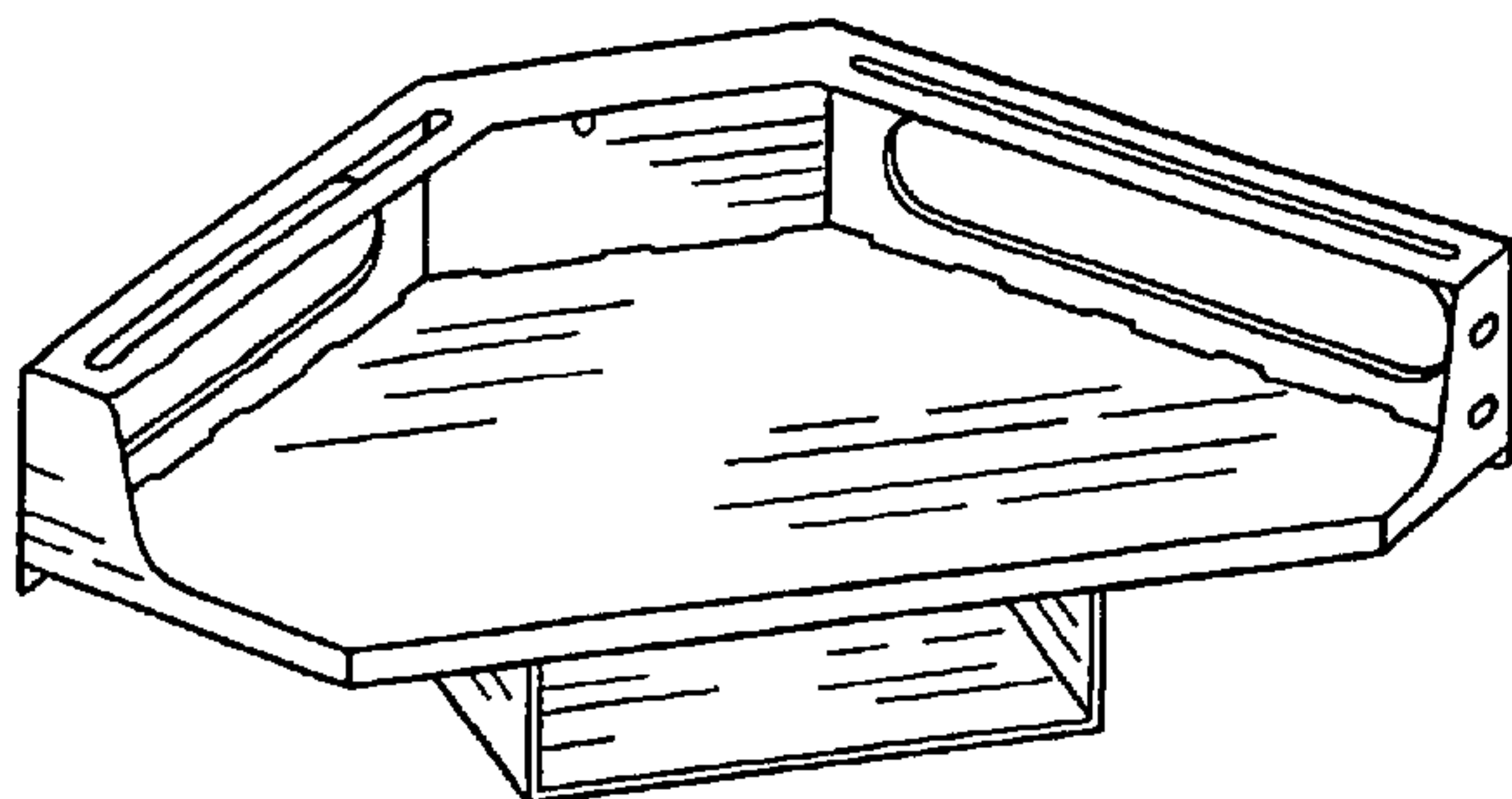
FIG. 7 is a bottom plan view thereof;

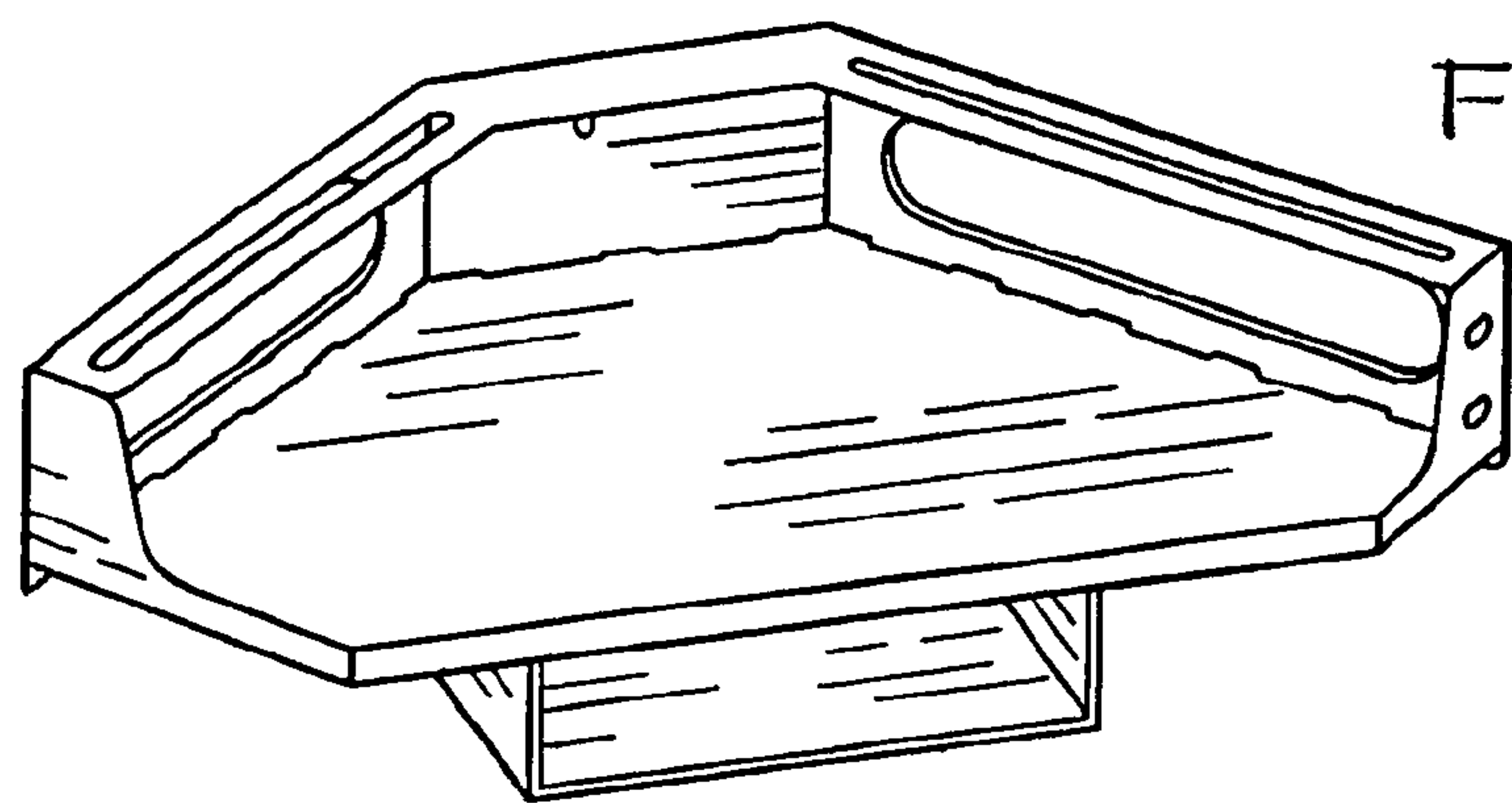

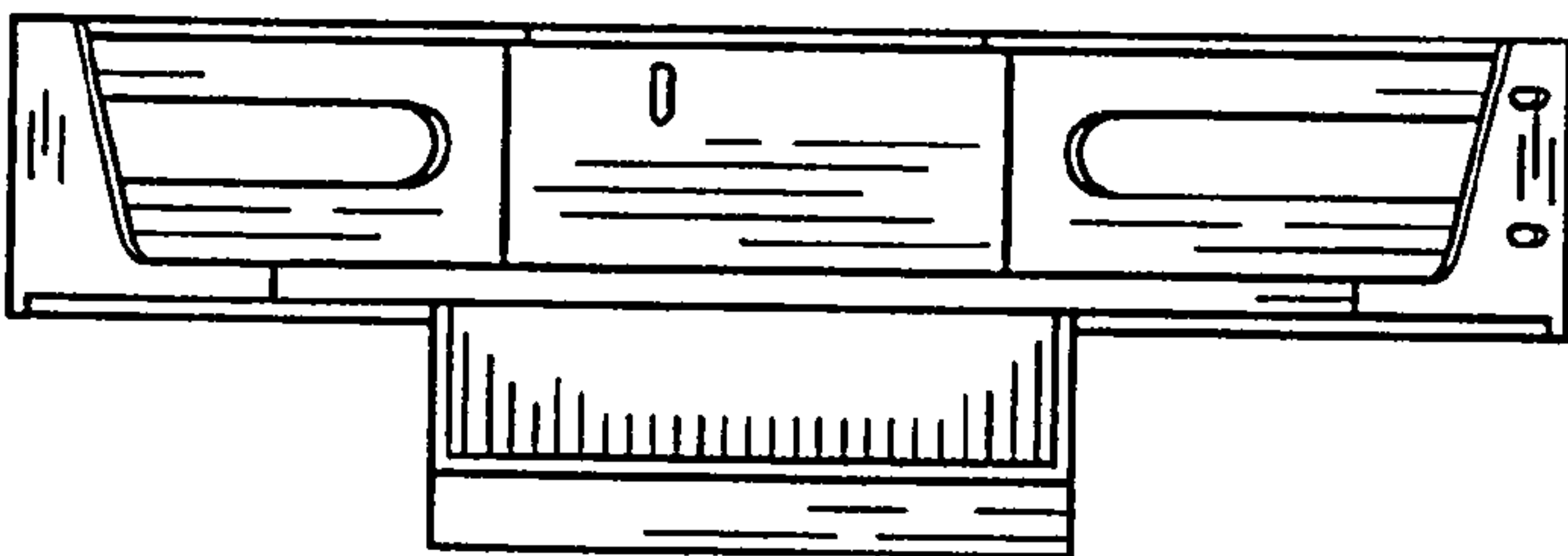

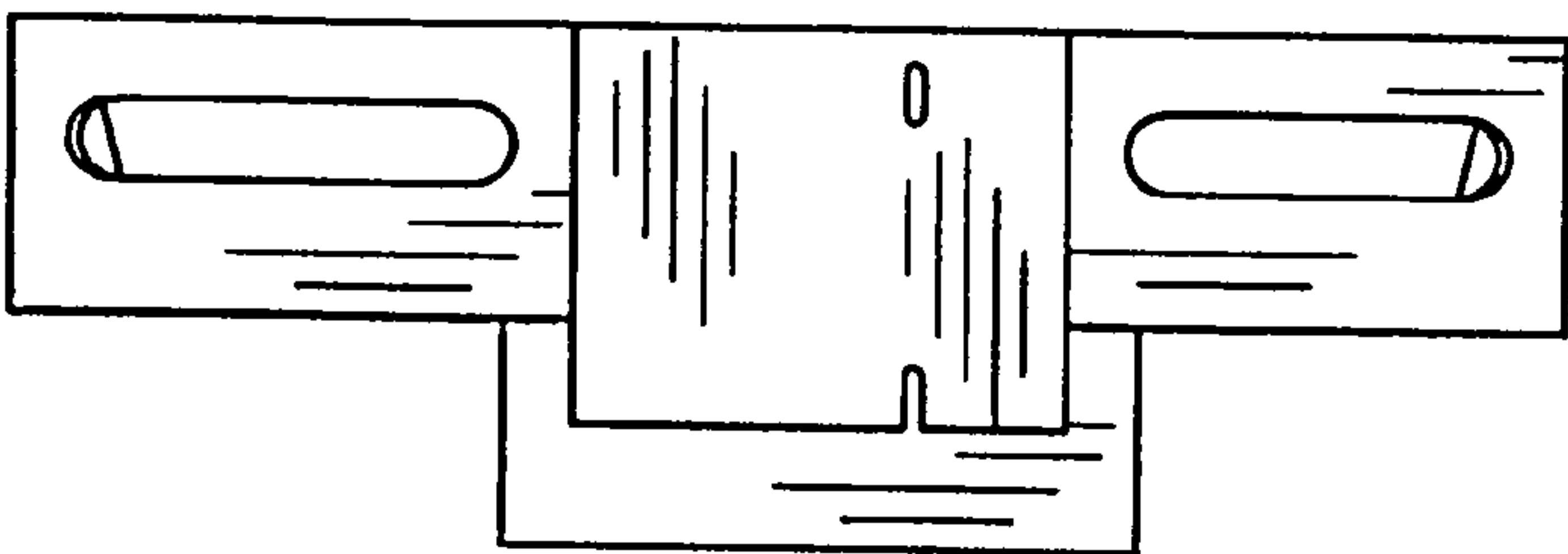

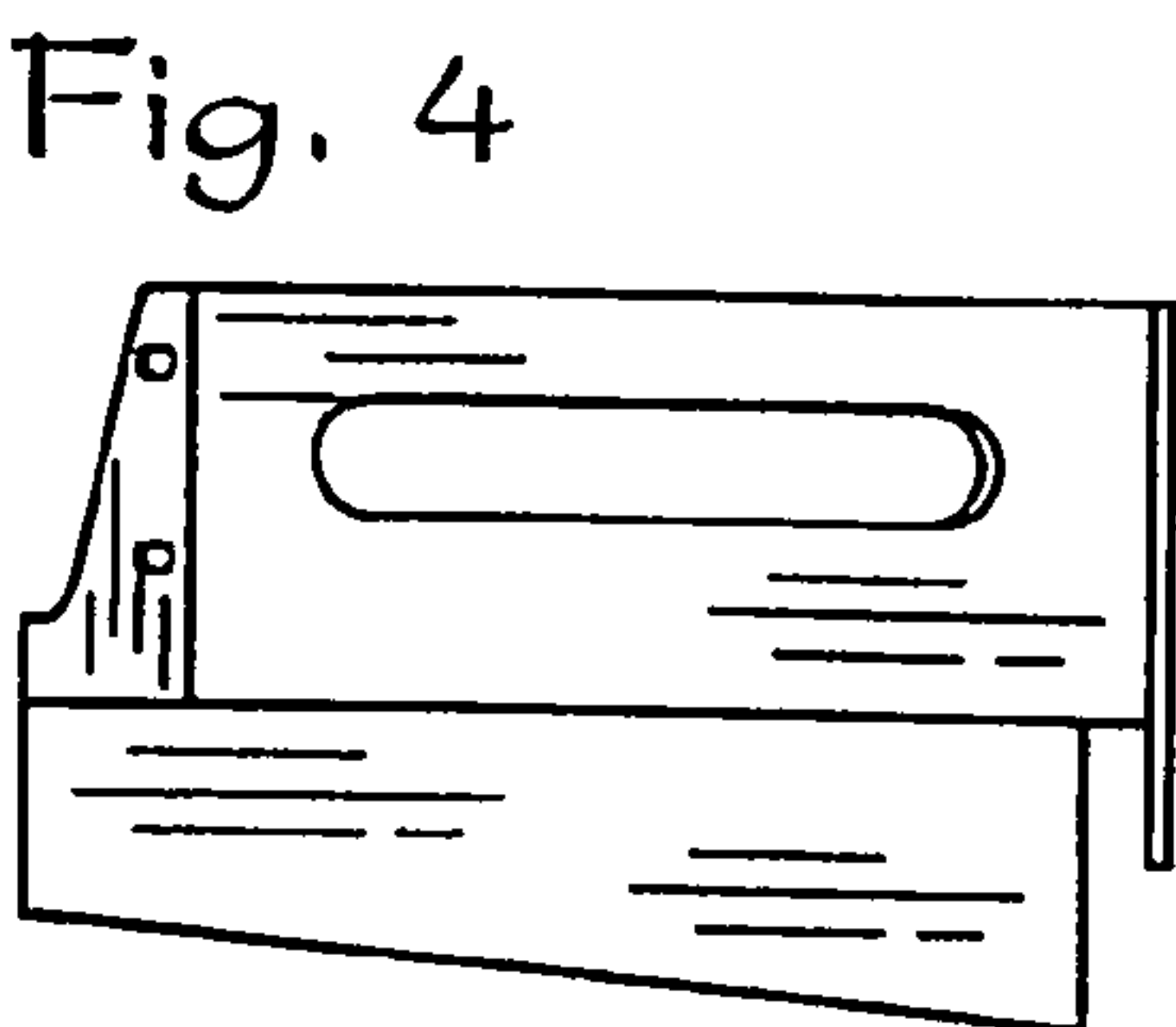

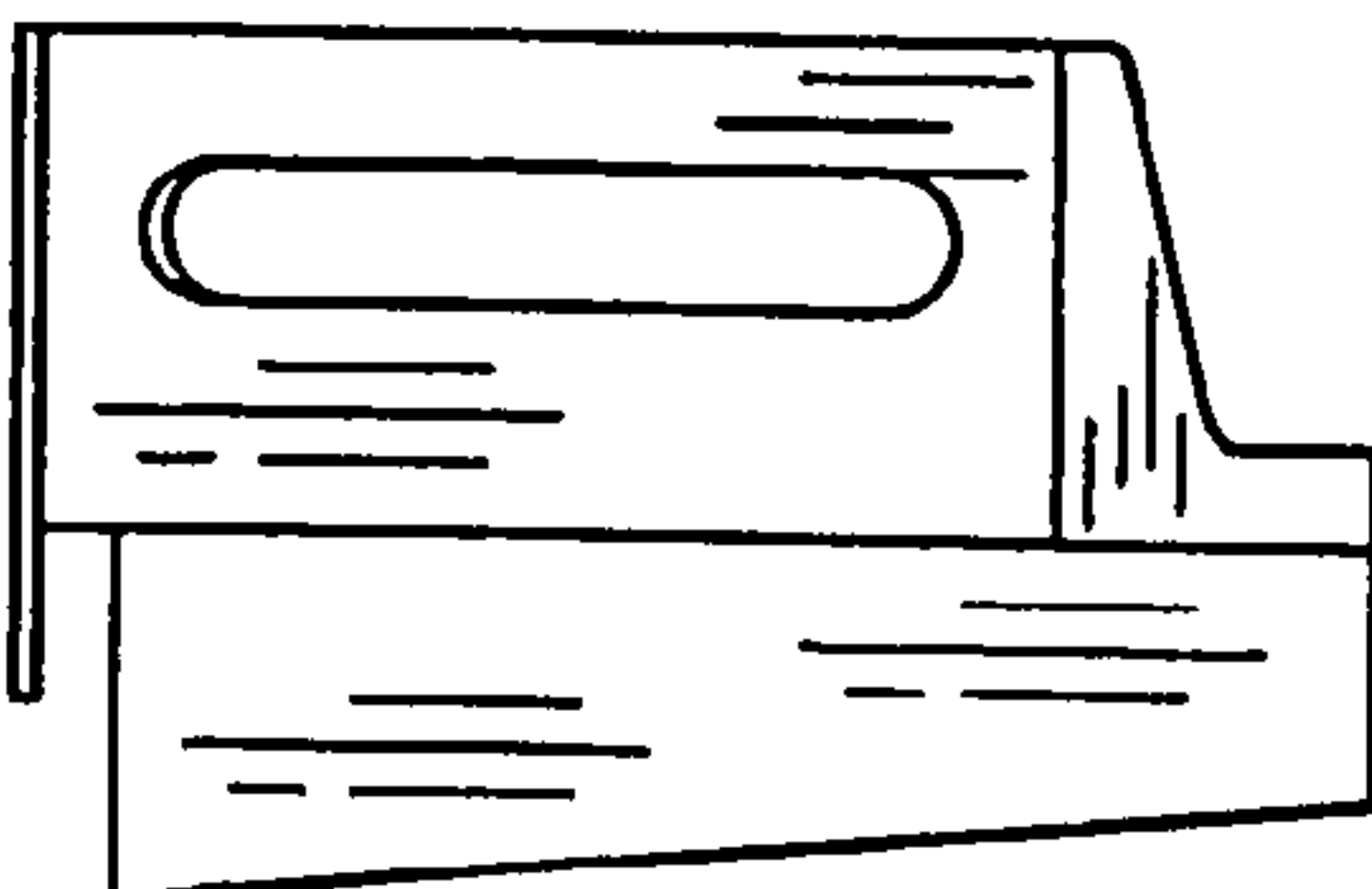

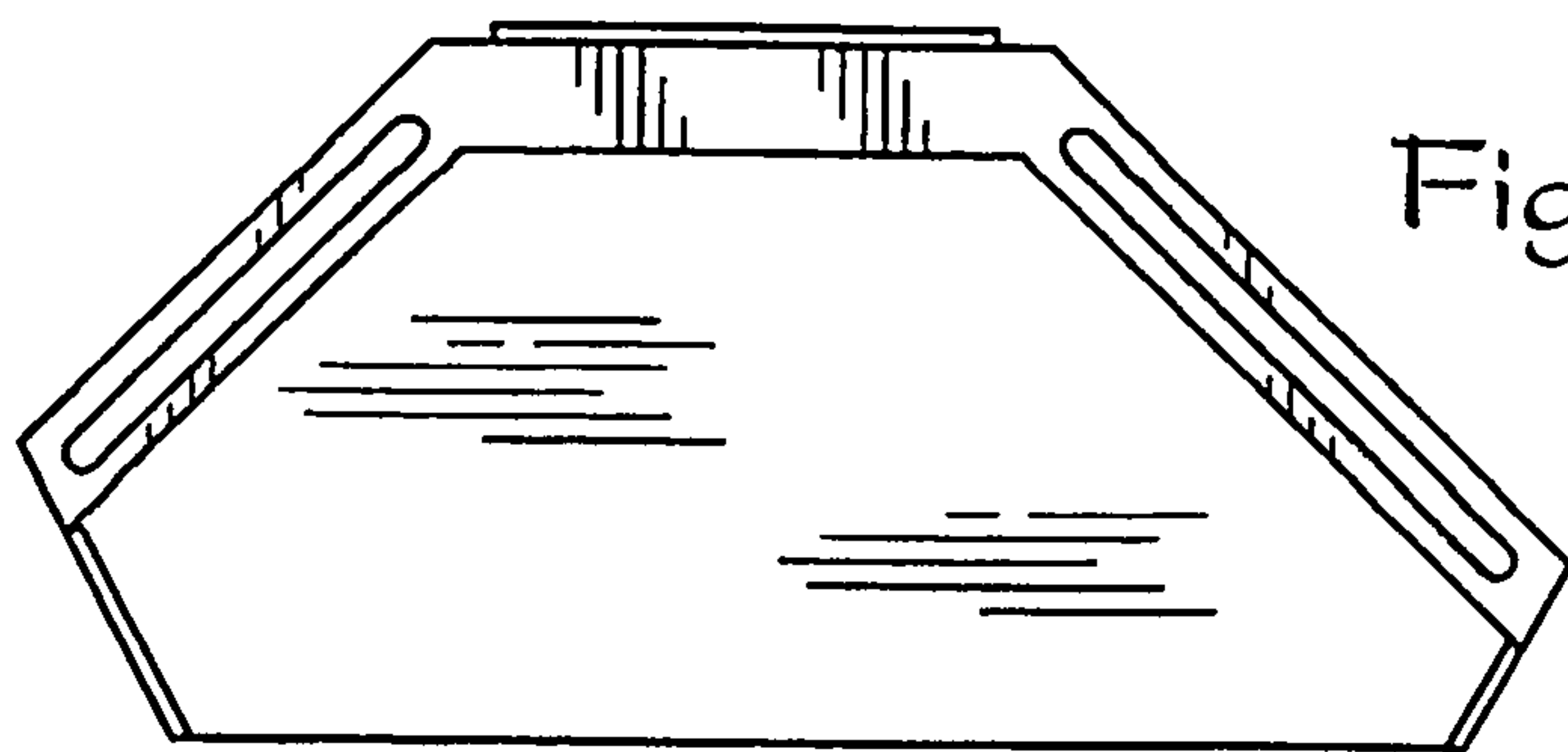

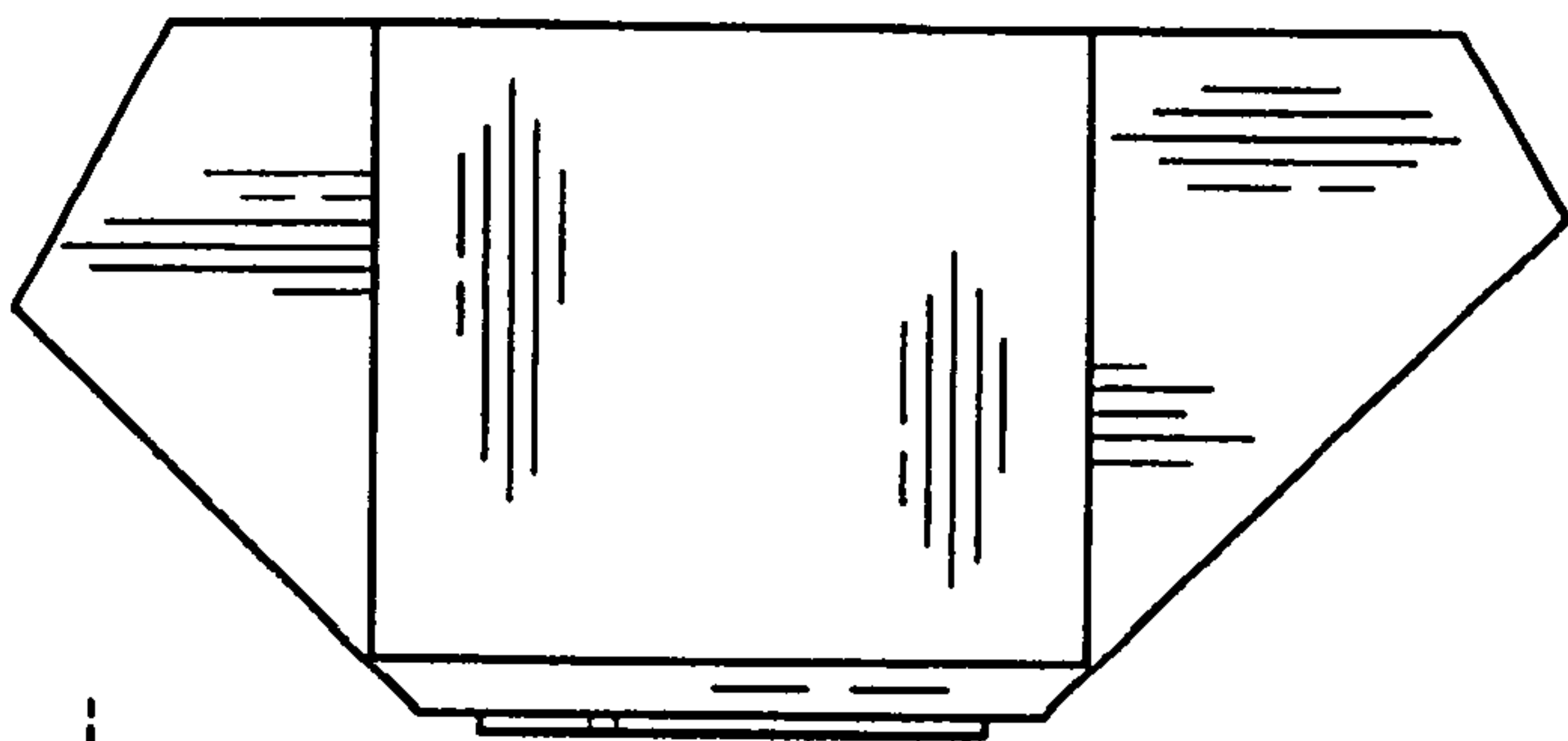

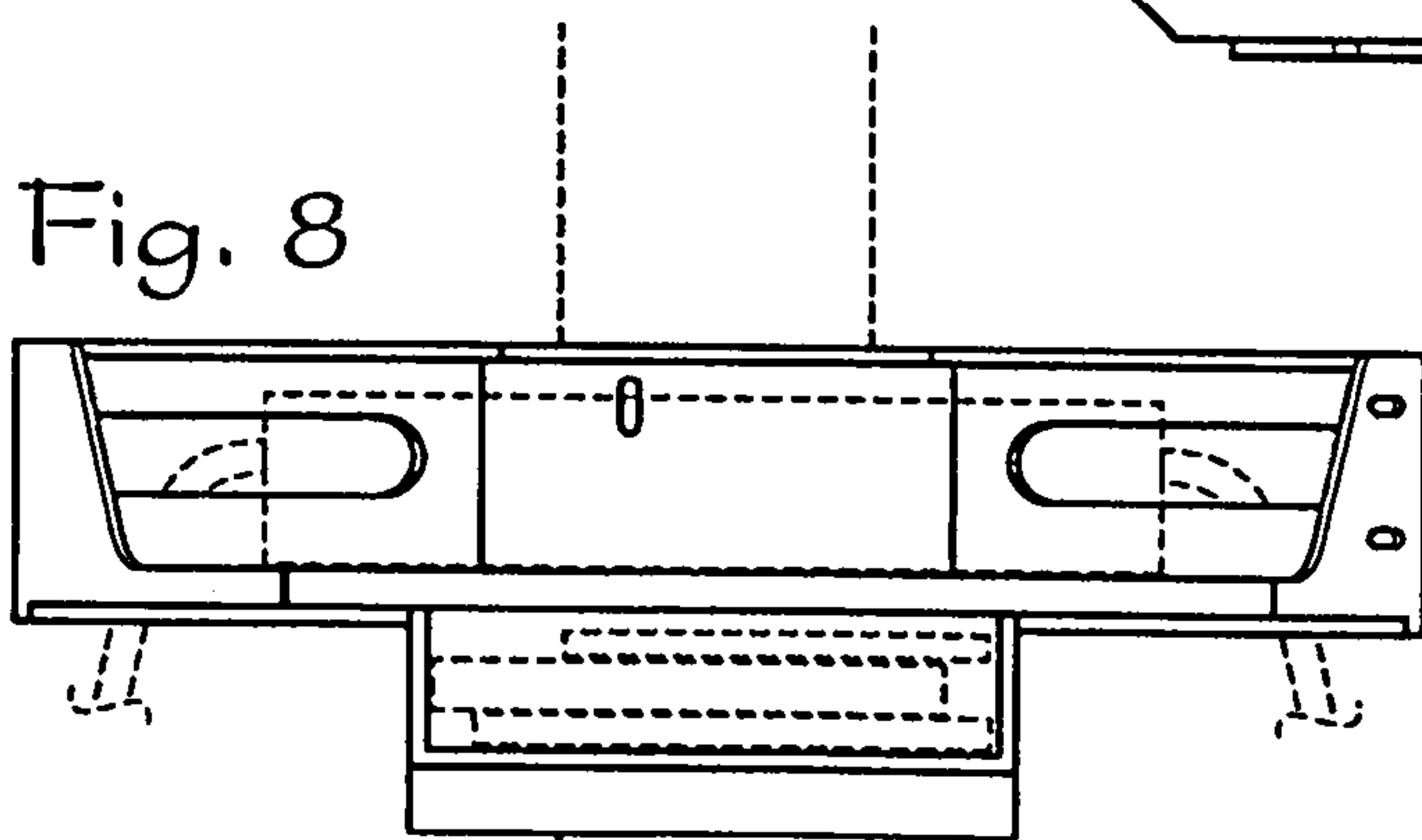

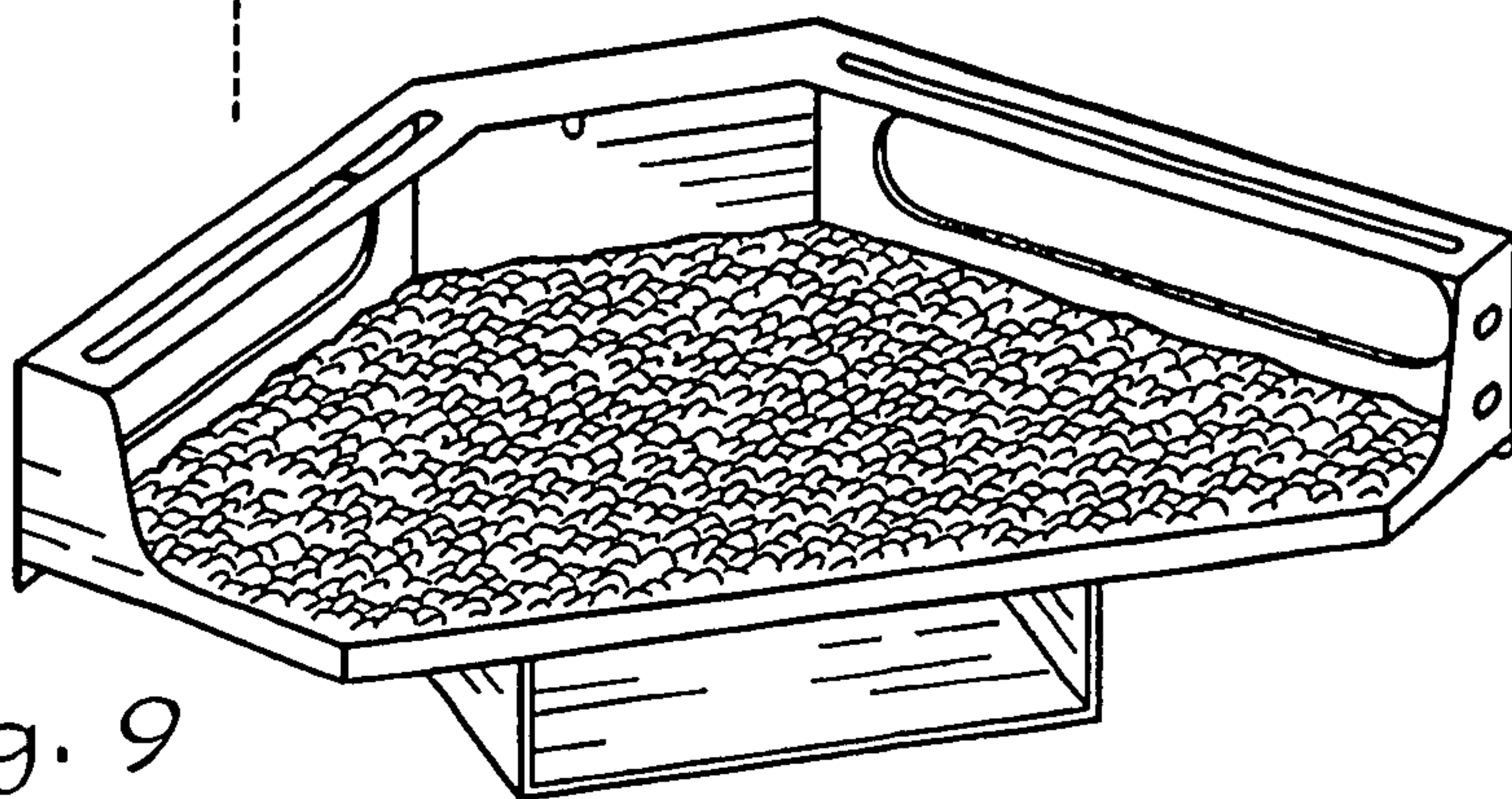
