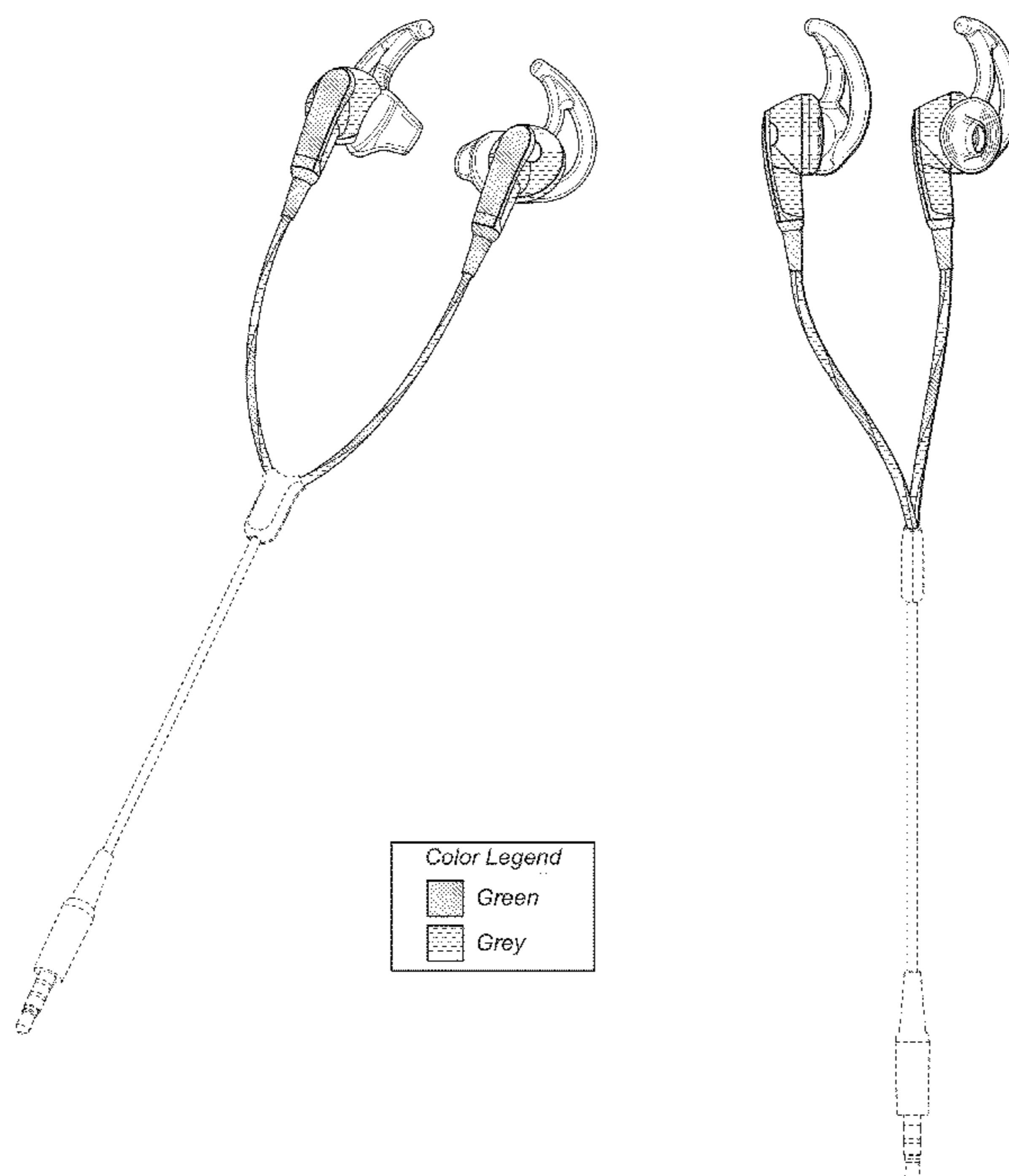
(57) **CLAIM**

The ornamental design for a set of headphones with green and grey details, substantially as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a set of headphones with green and grey details as seen from the front, bottom, and left side; the drawing includes a color legend;
FIG. 2 is a front view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a top end view thereof; and,

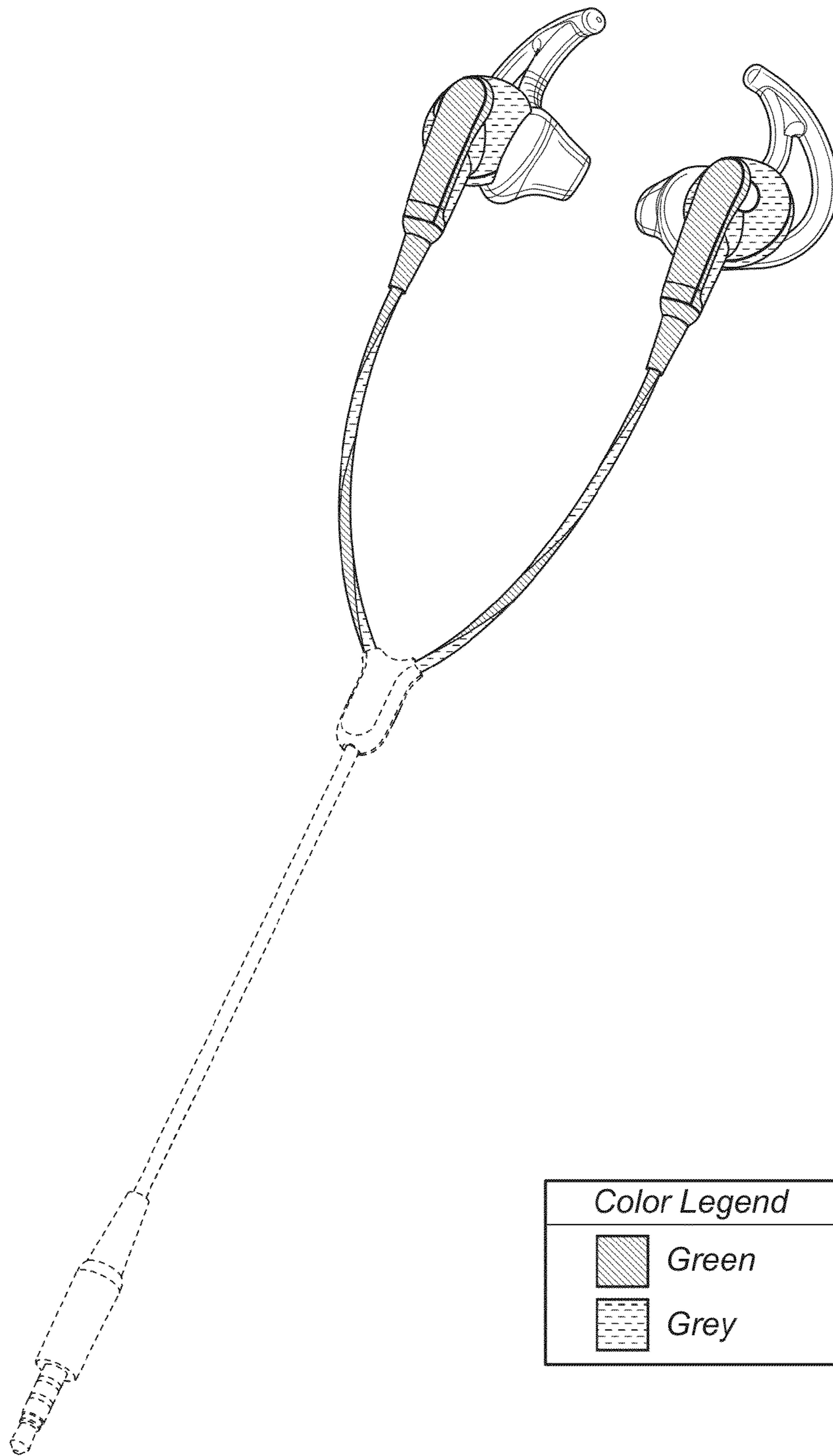

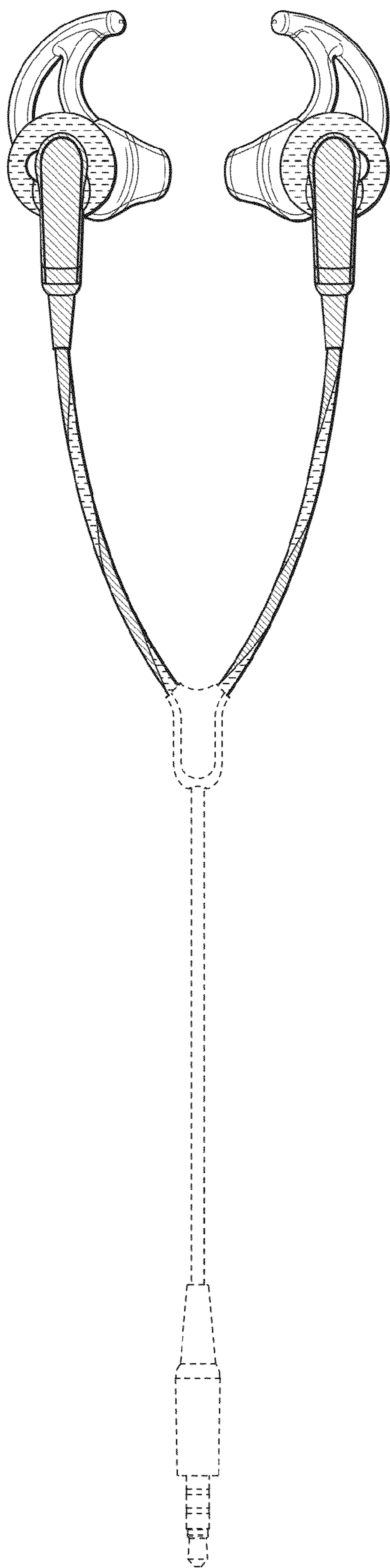

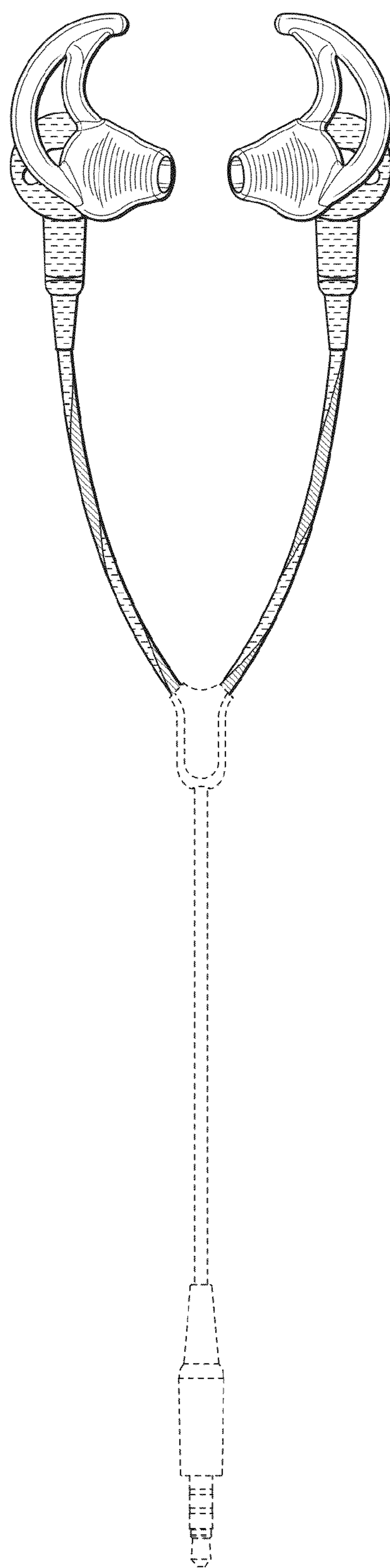

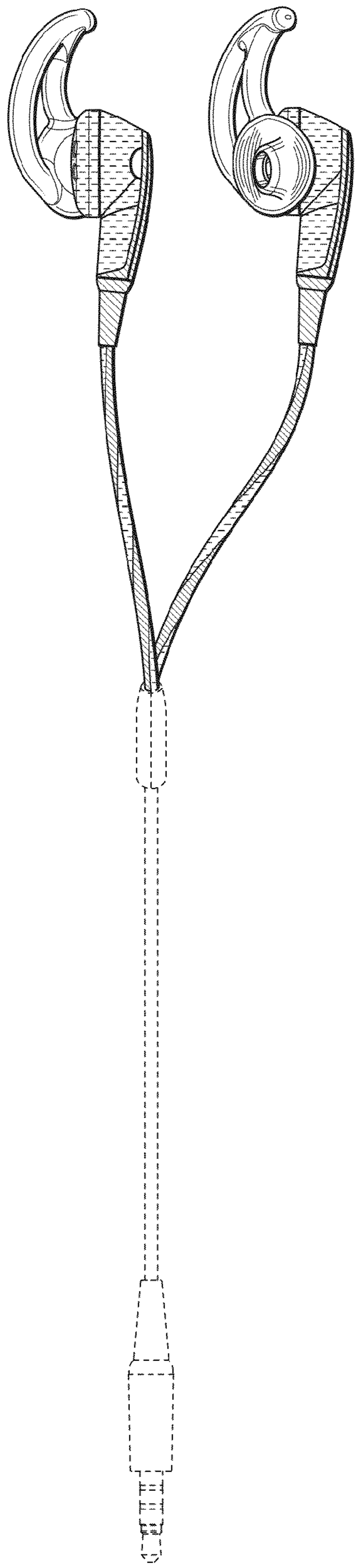

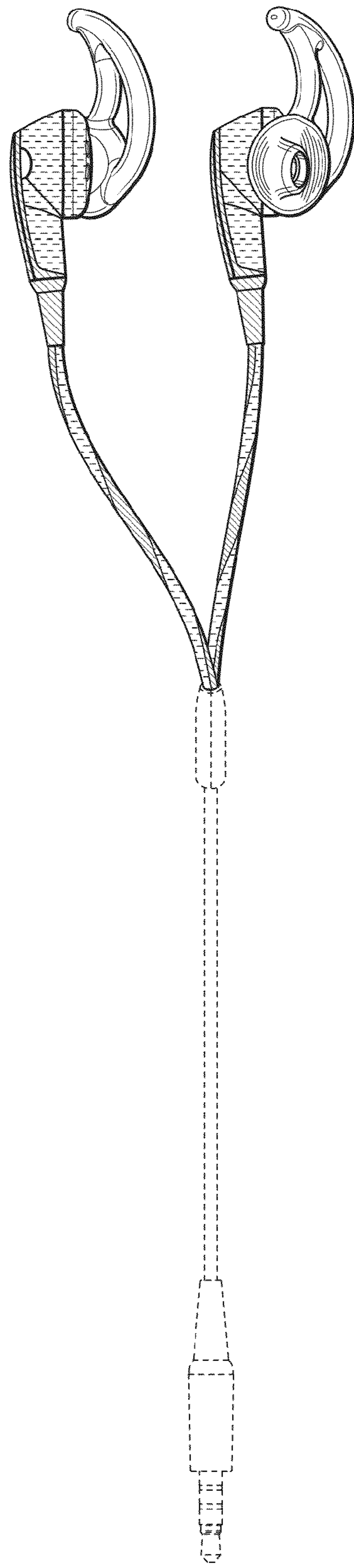

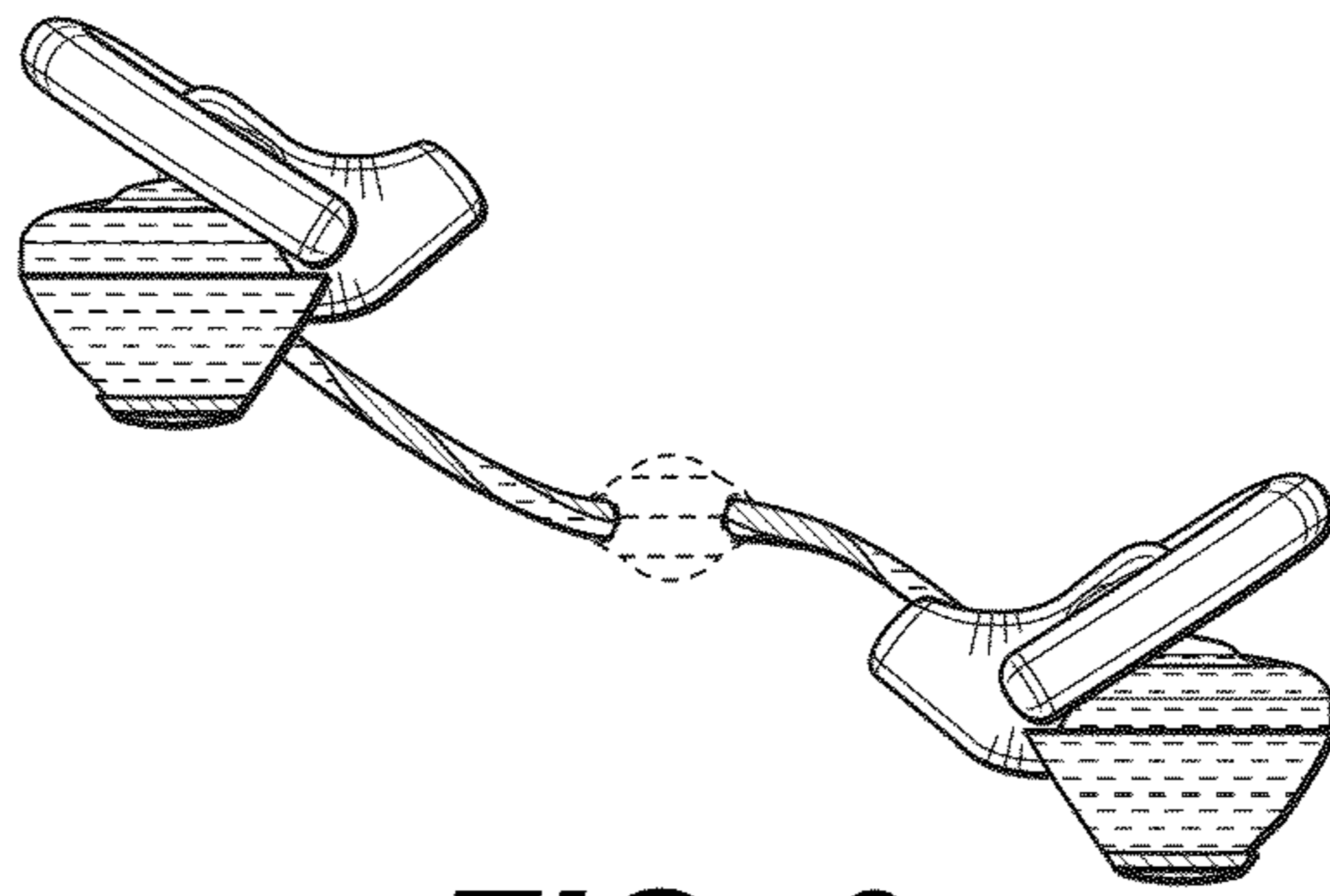

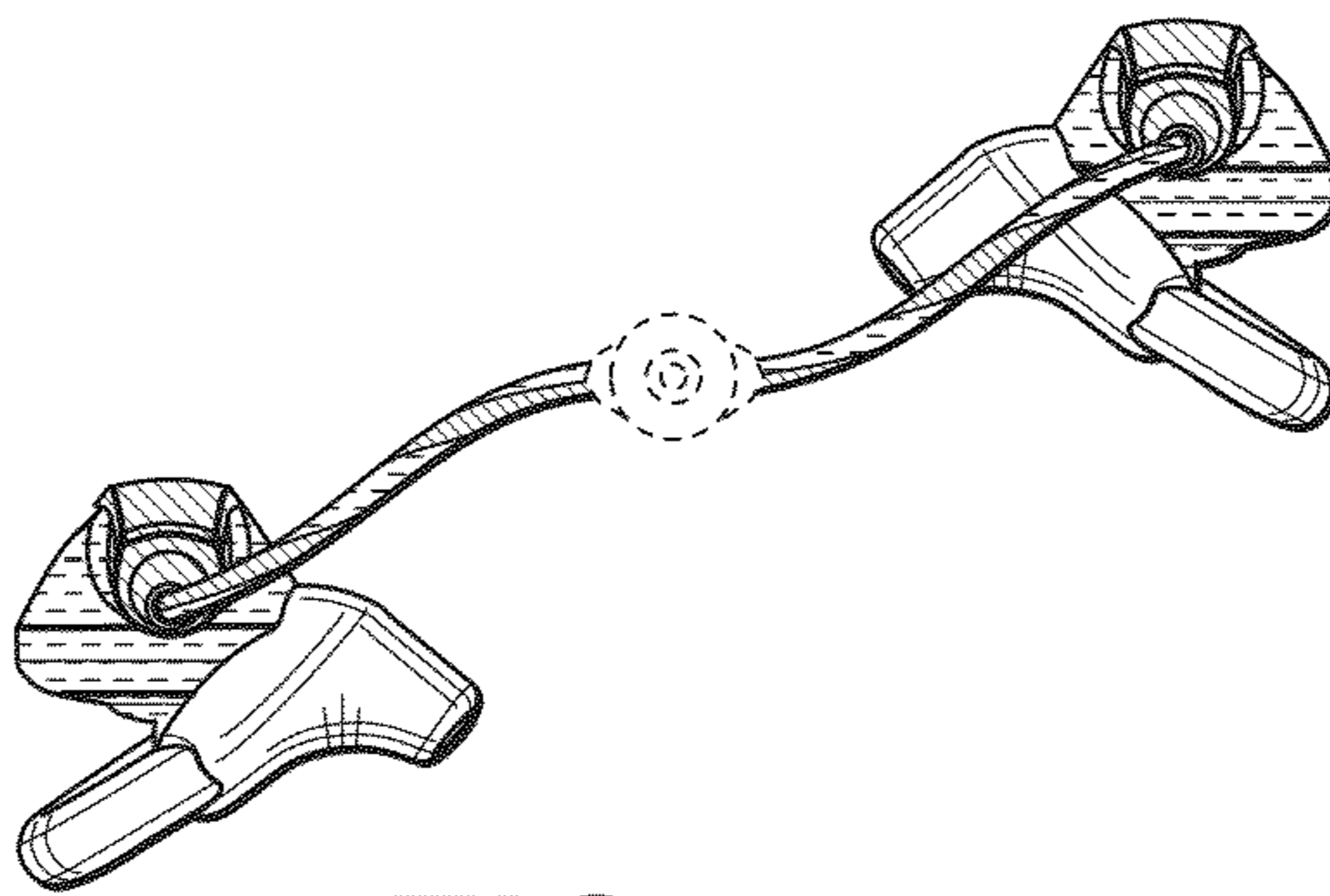
