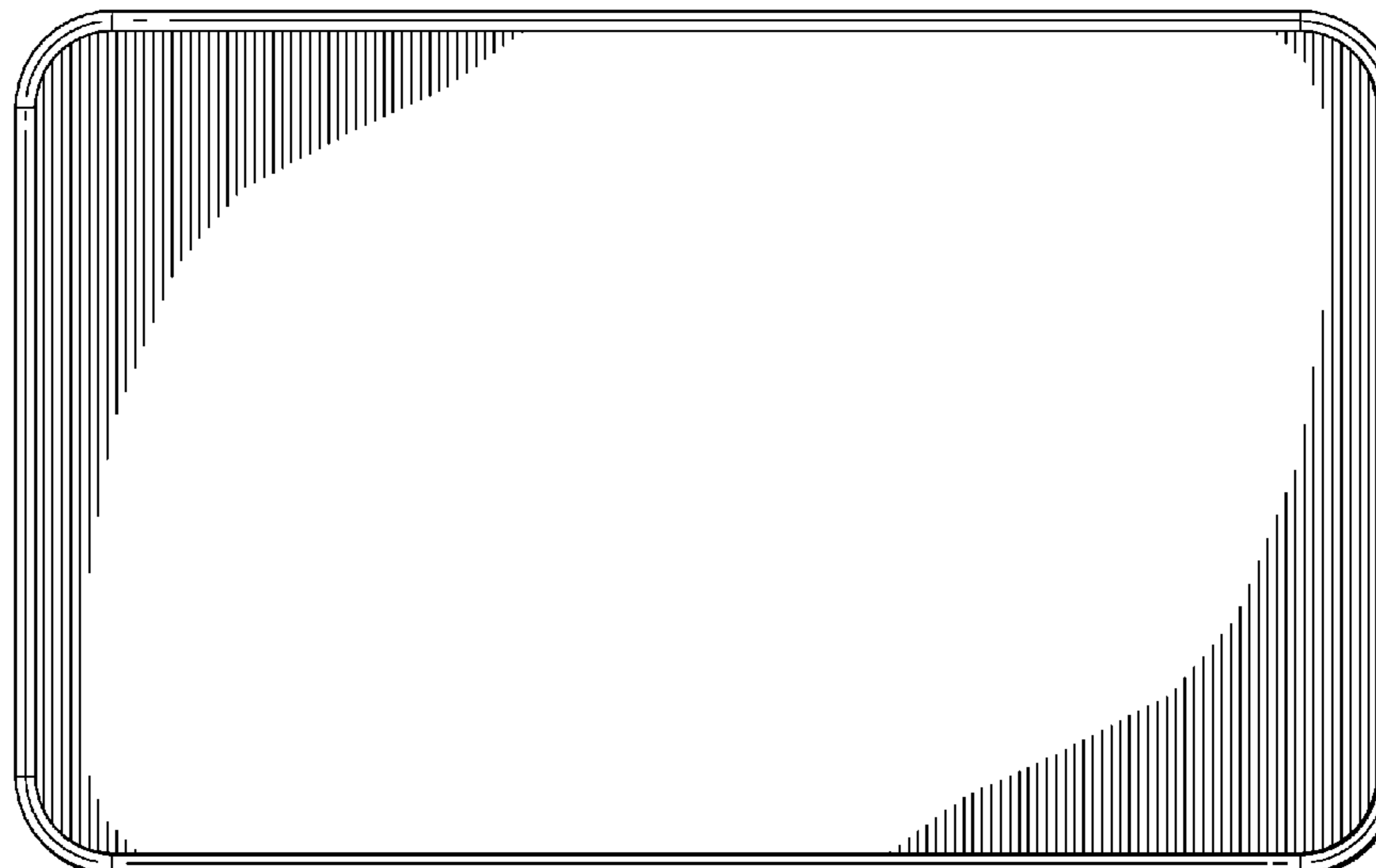
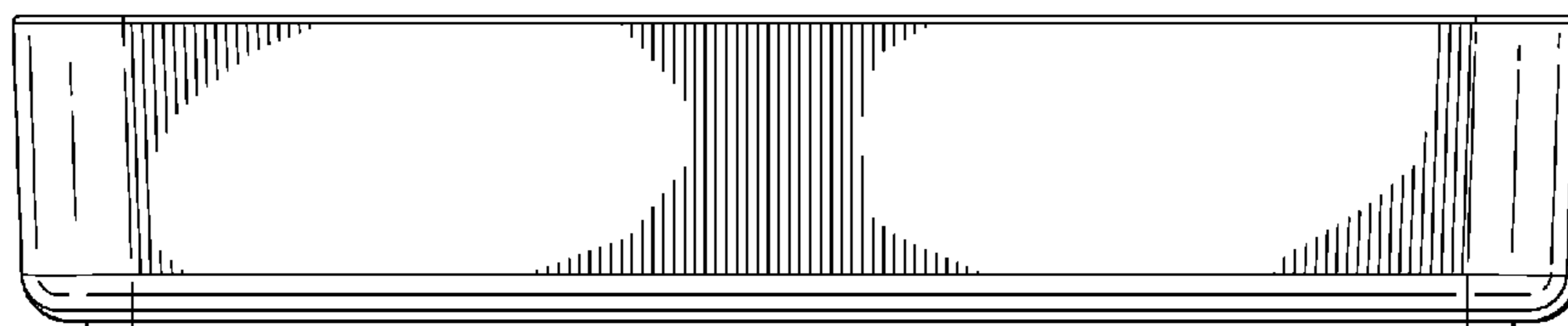
We claim the ornamental design for a portable audio hotspot device, as shown and described.

**DESCRIPTION**

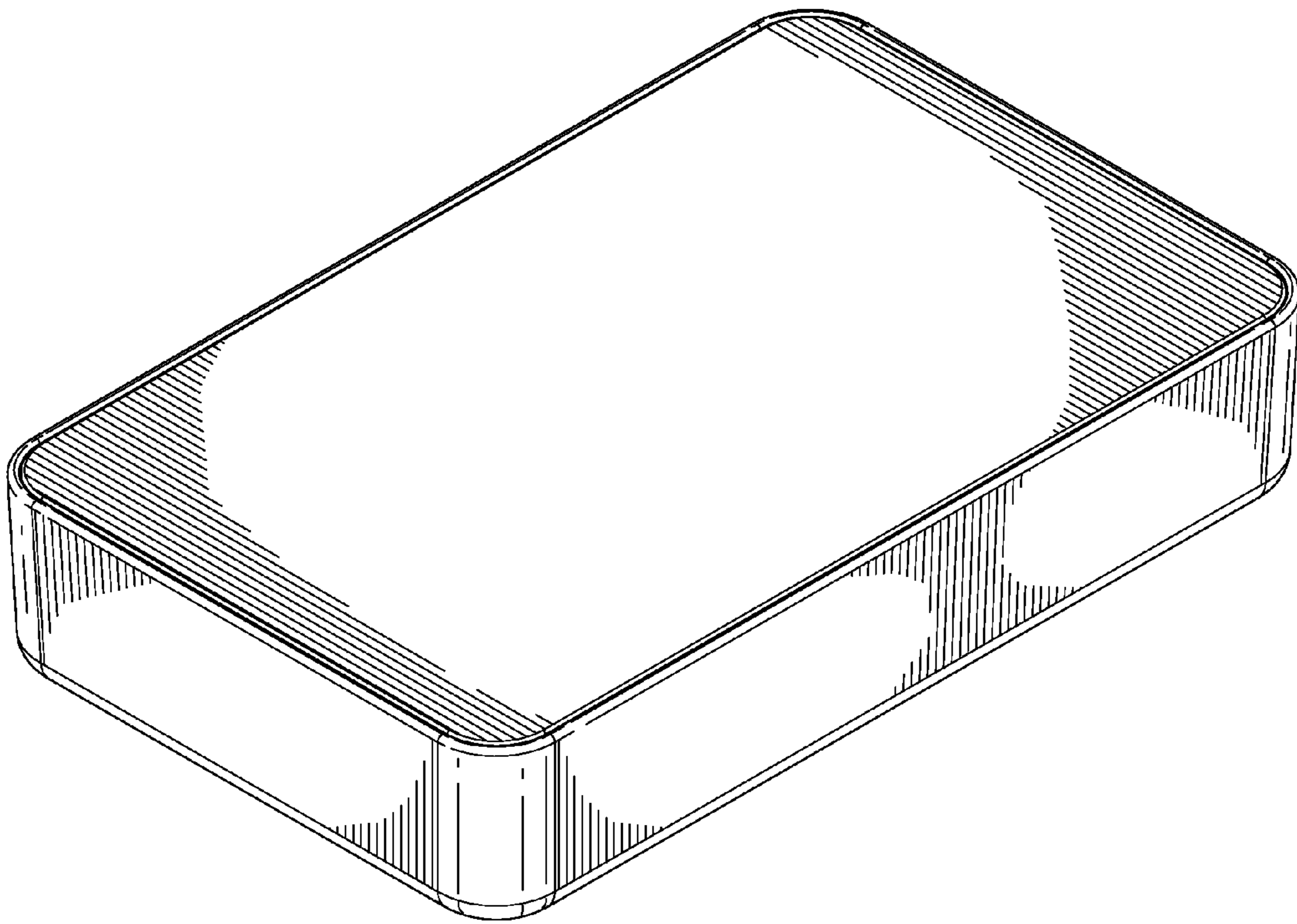

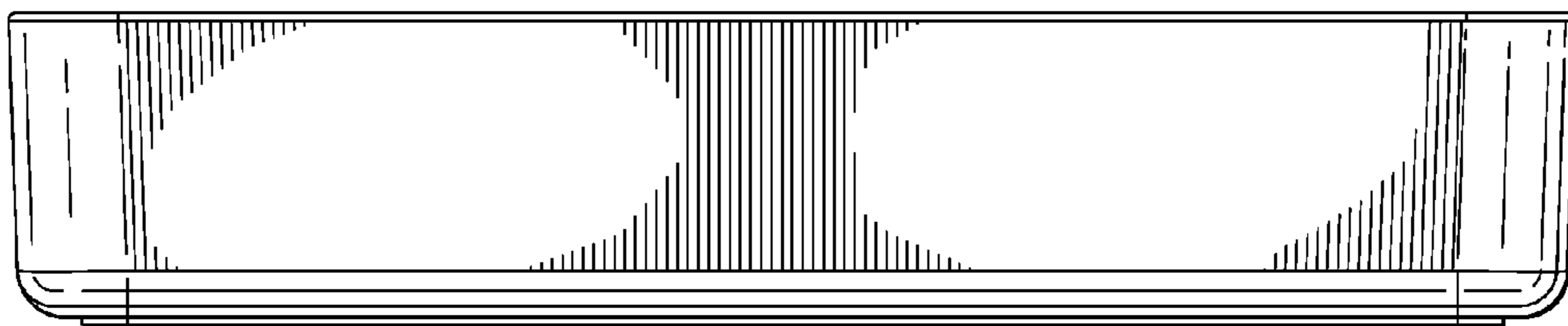

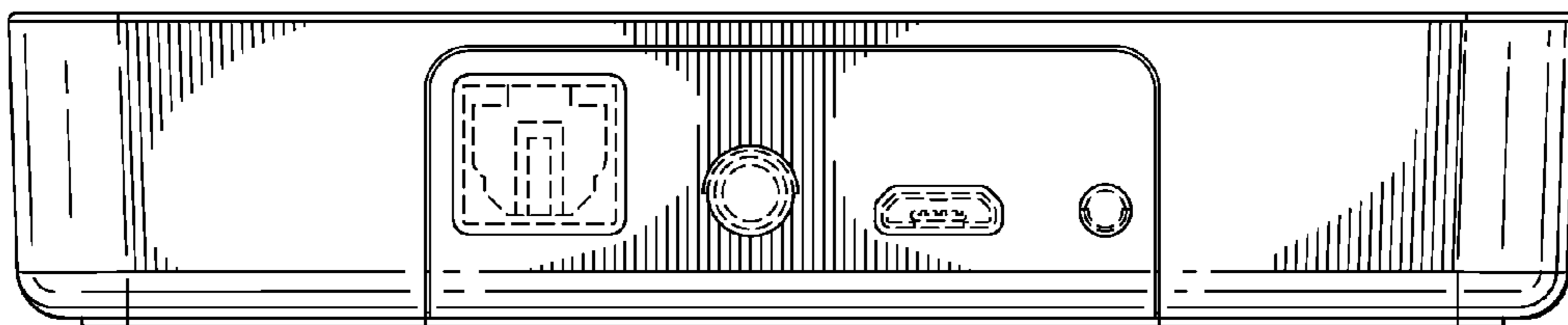

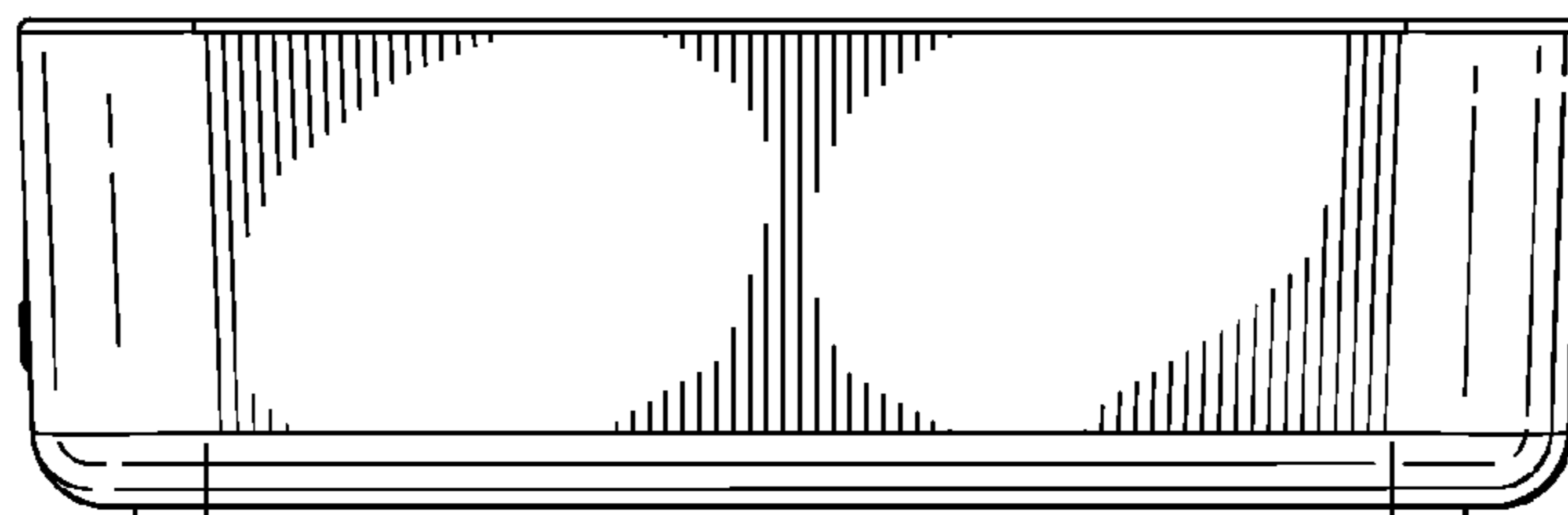

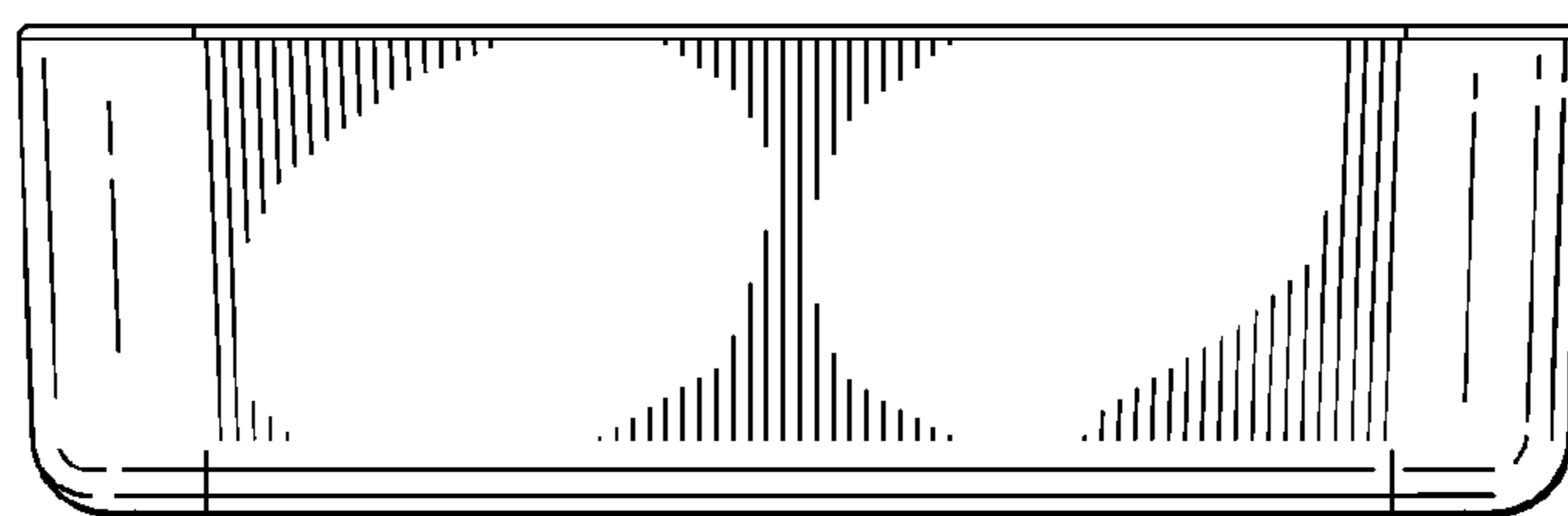

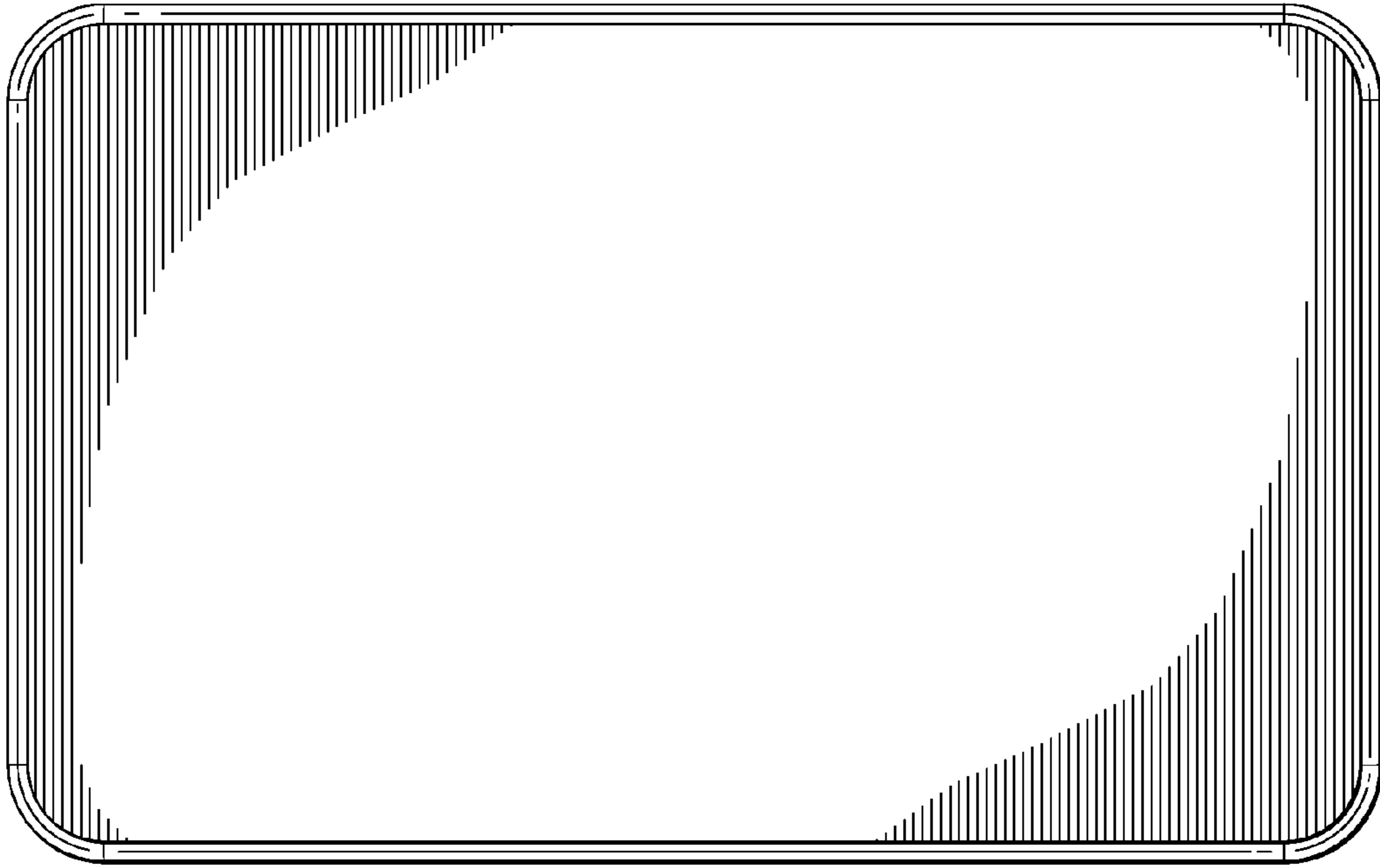

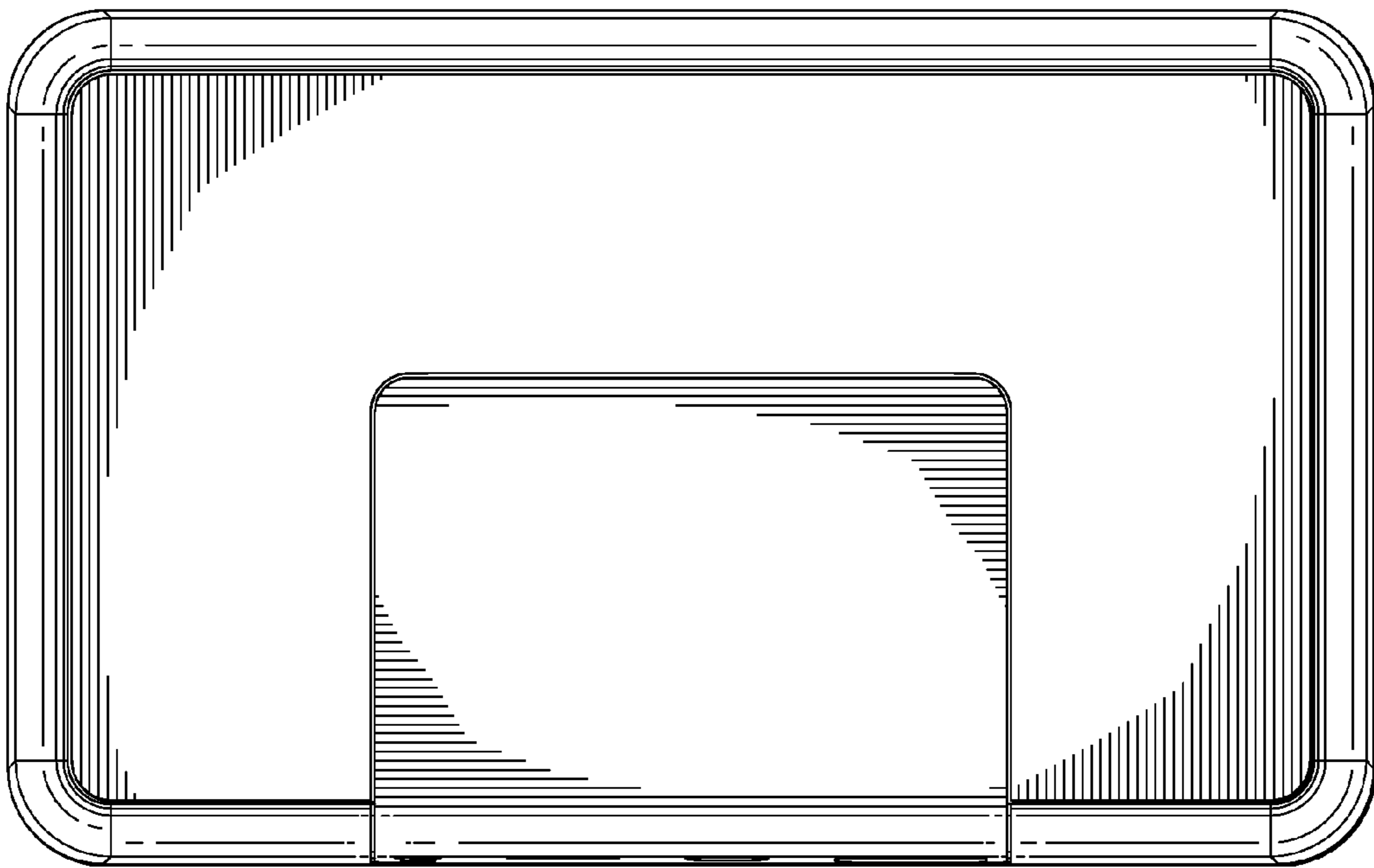
