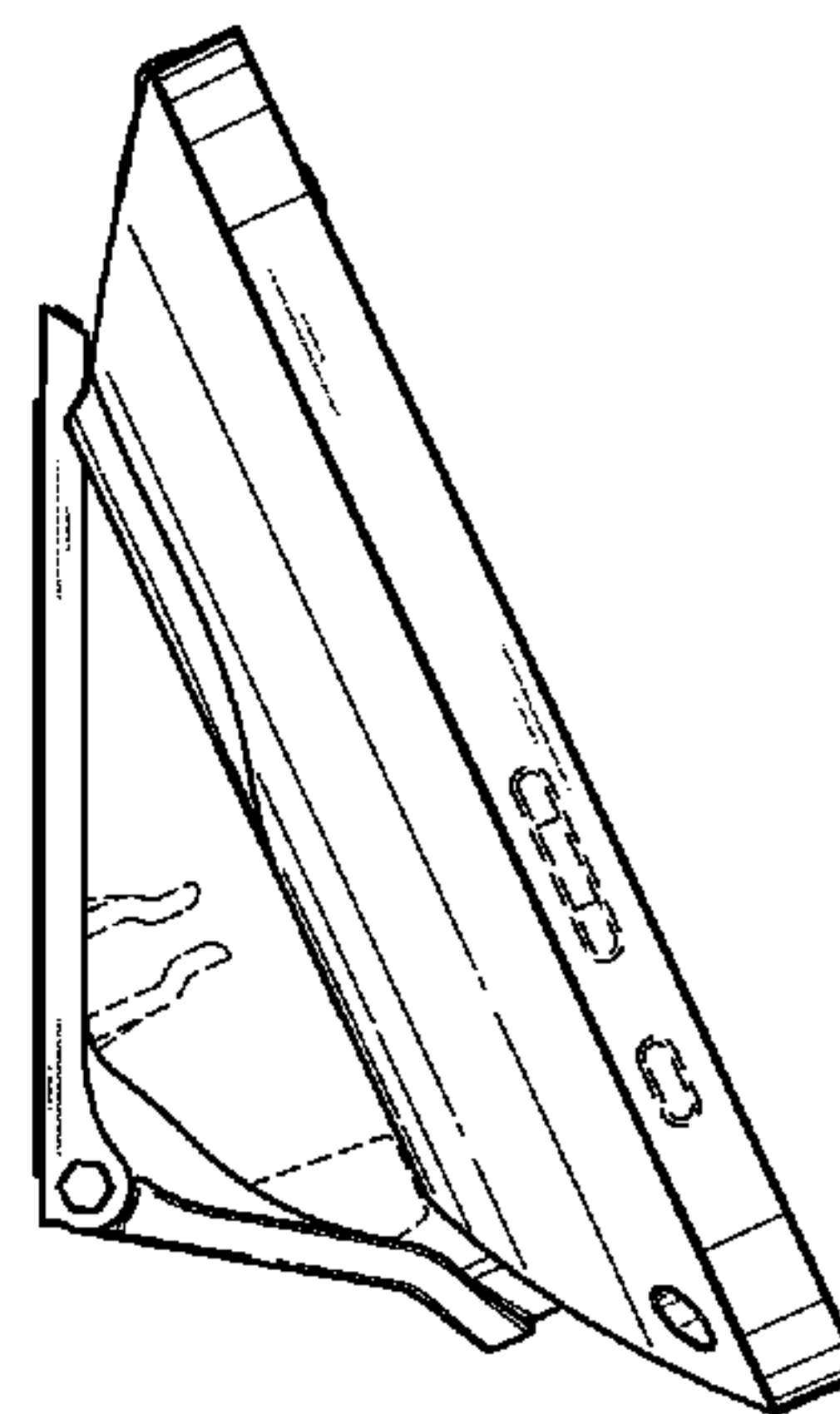
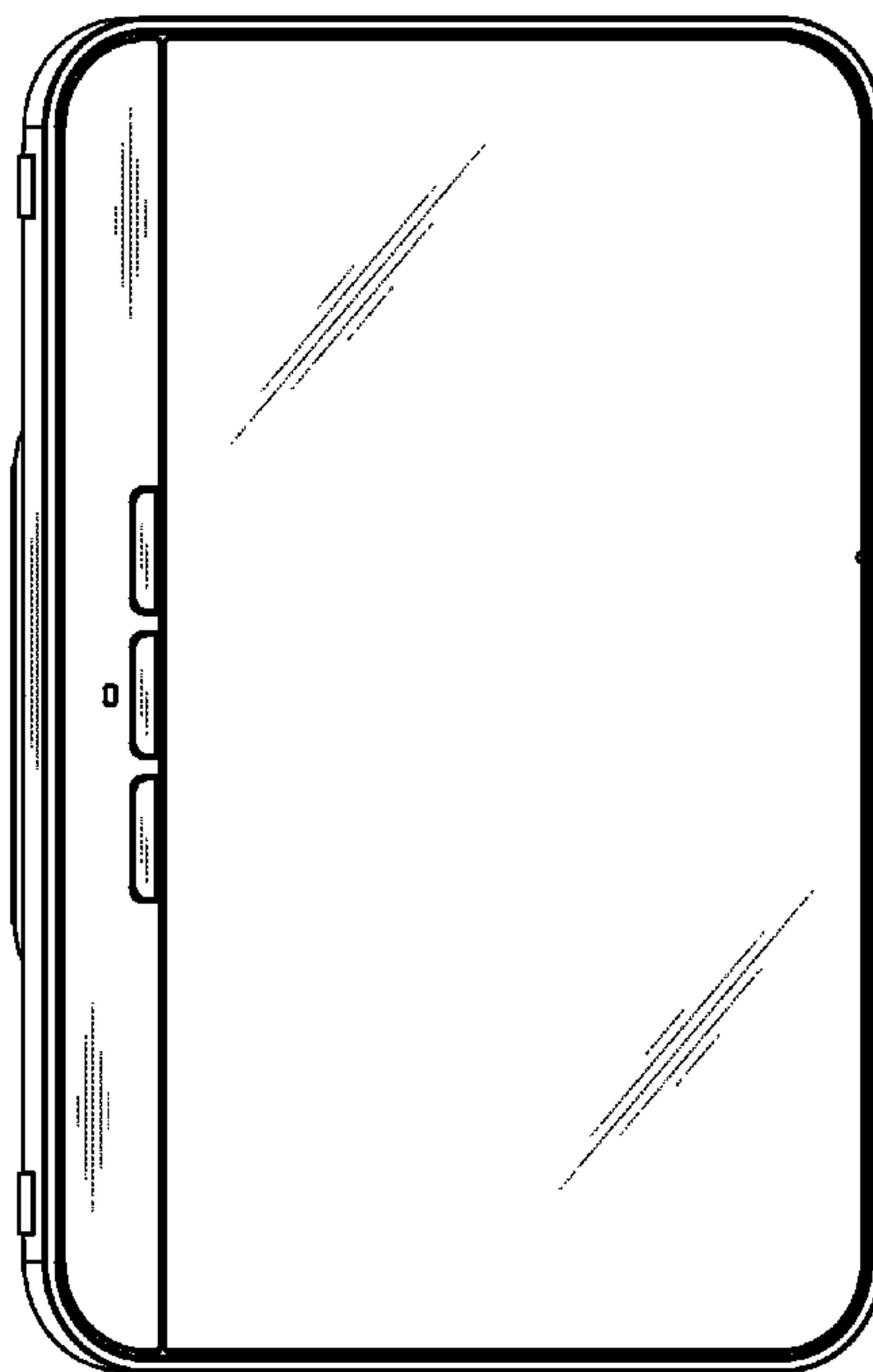
(57) **CLAIM**

The ornamental design for a tablet, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the tablet with a stand, according to my new design;
FIG. 2 is front perspective view thereof;
FIG. 3 is a back view thereof;
FIG. 4 is a rear perspective view thereof;
FIG. 5 is a right side view thereof; and,
FIG. 6 is a right side view thereof with the stand extended.
The broken lines shown in the drawings represent portions of the tablet that form no part of the claimed design.

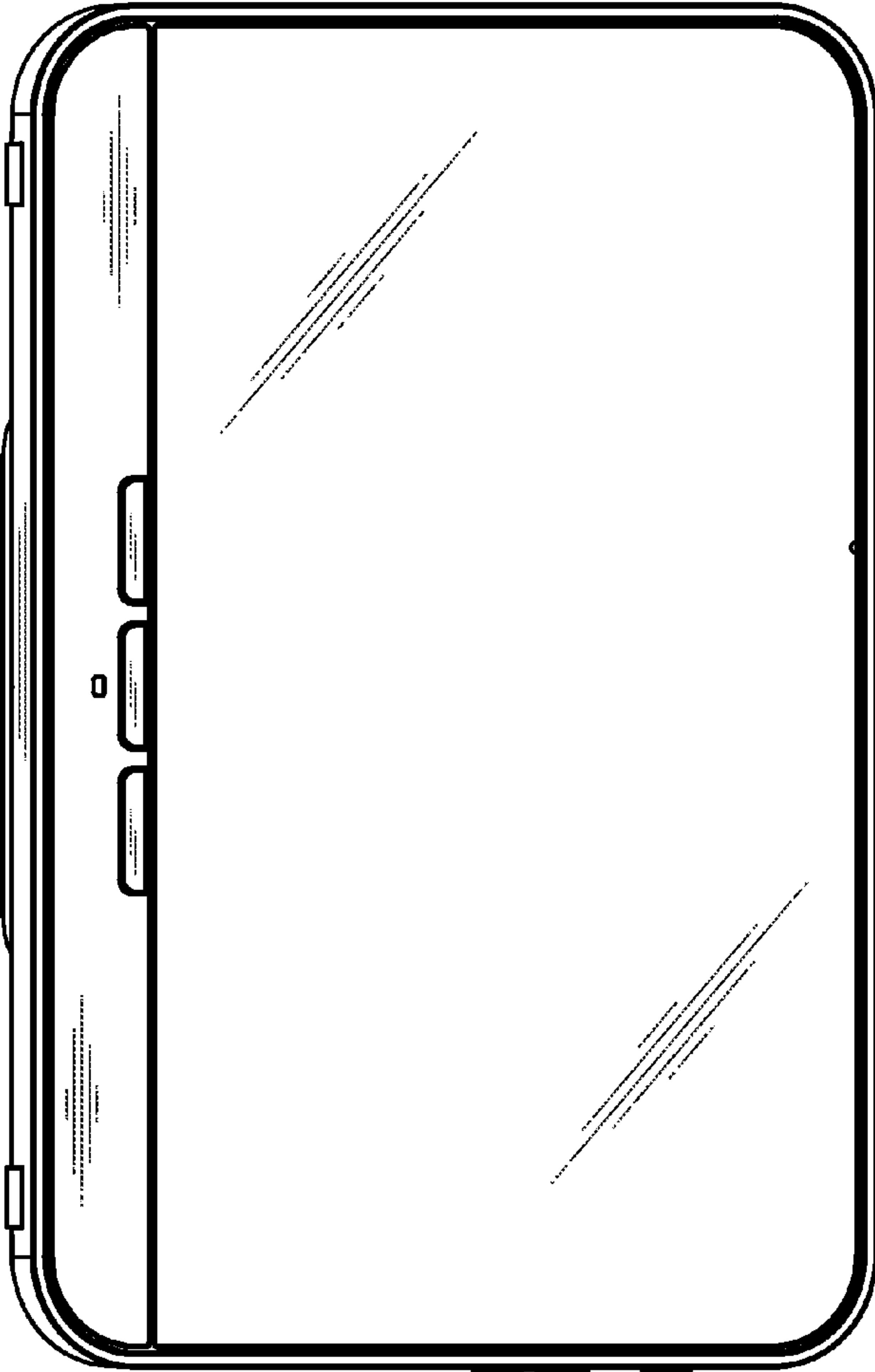

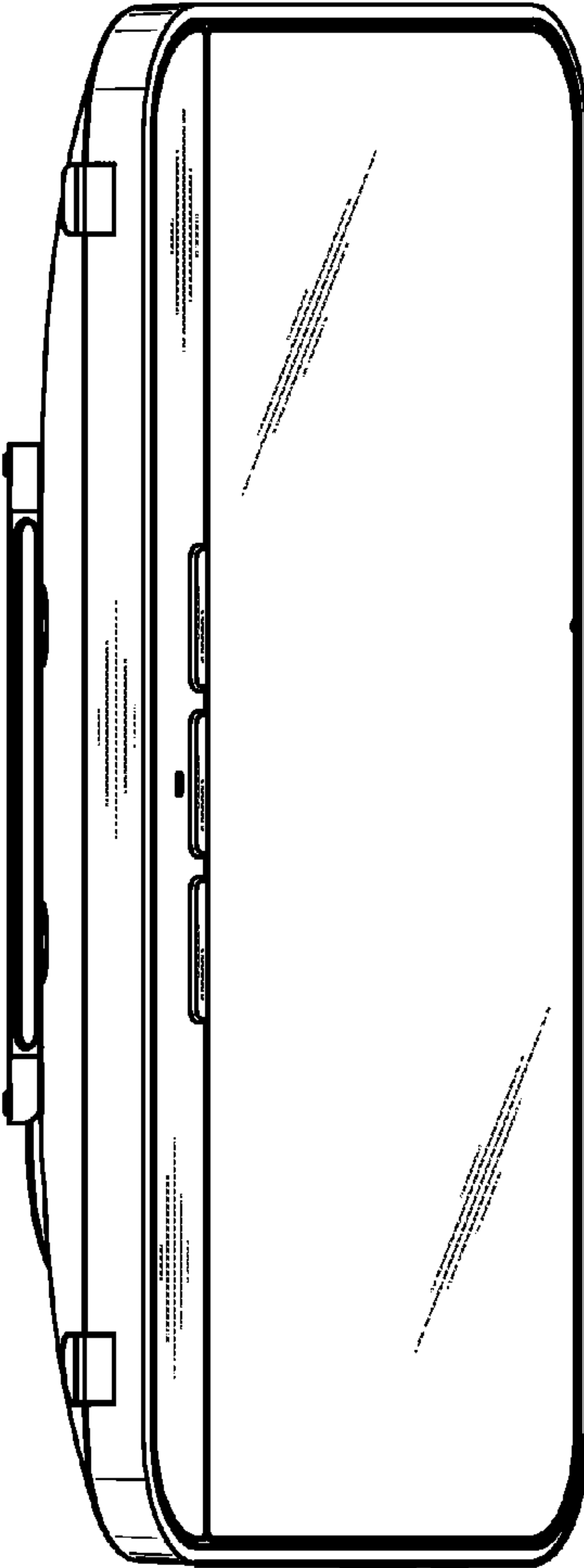

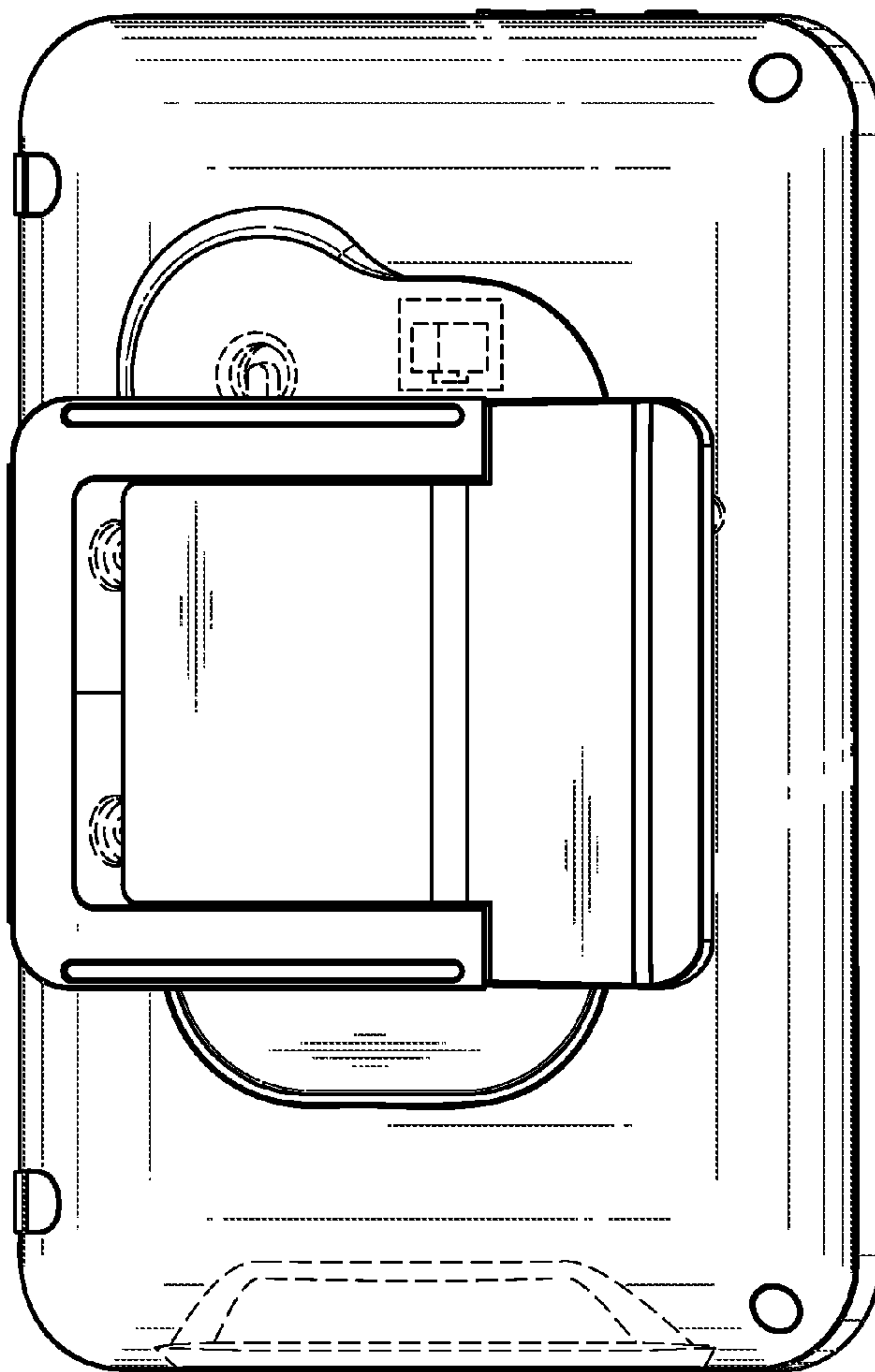

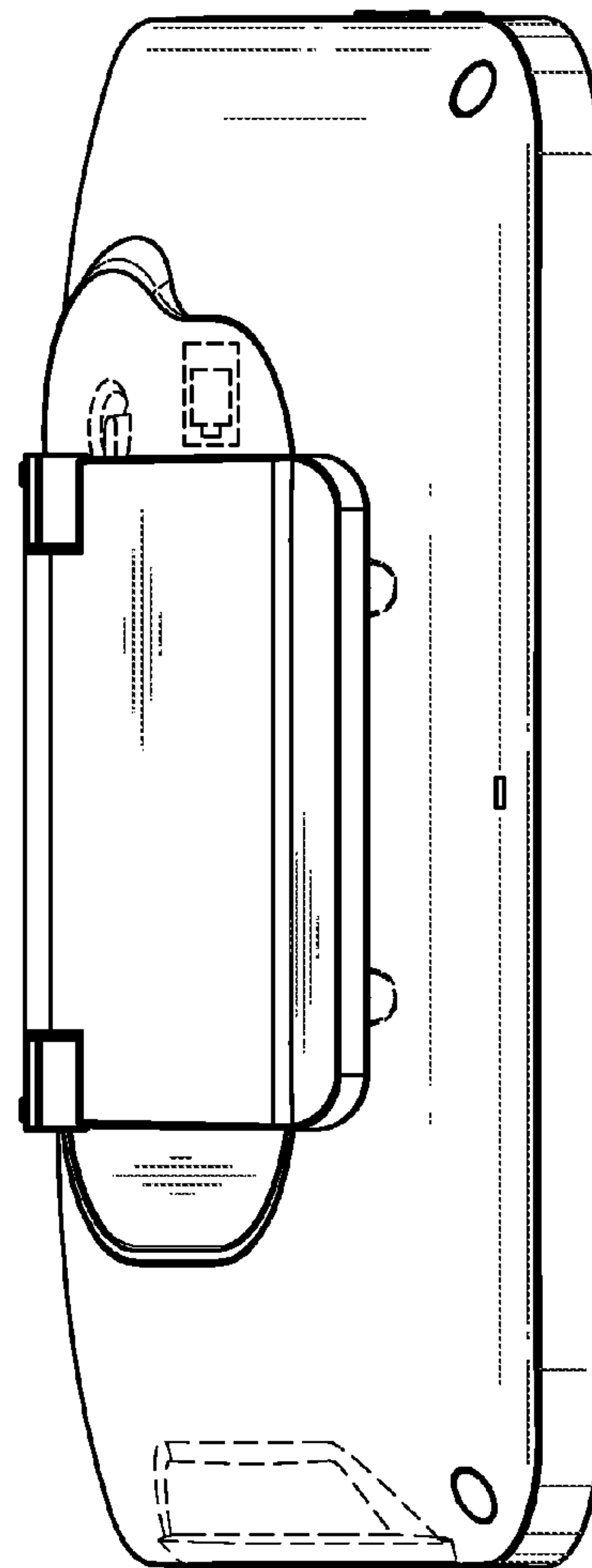

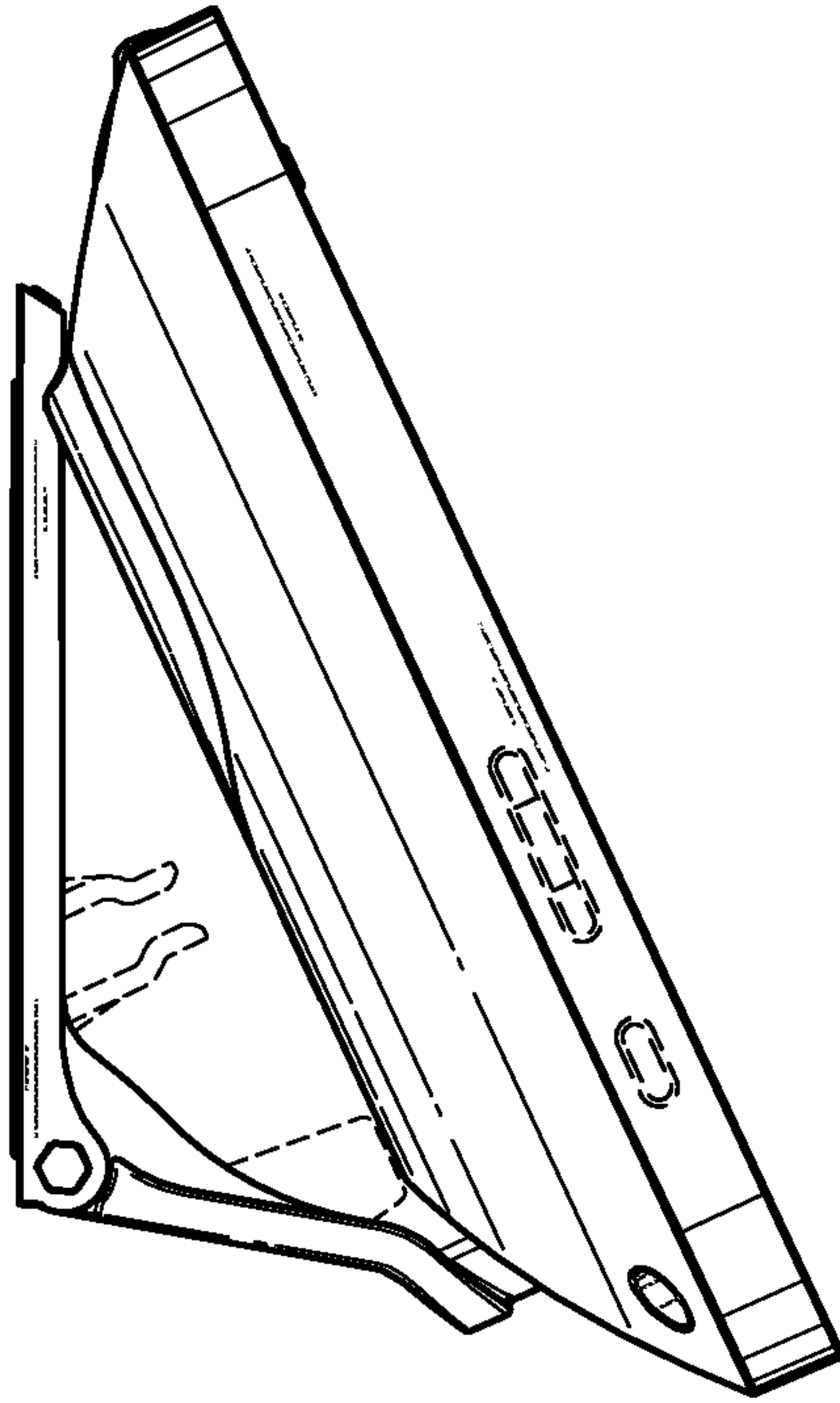

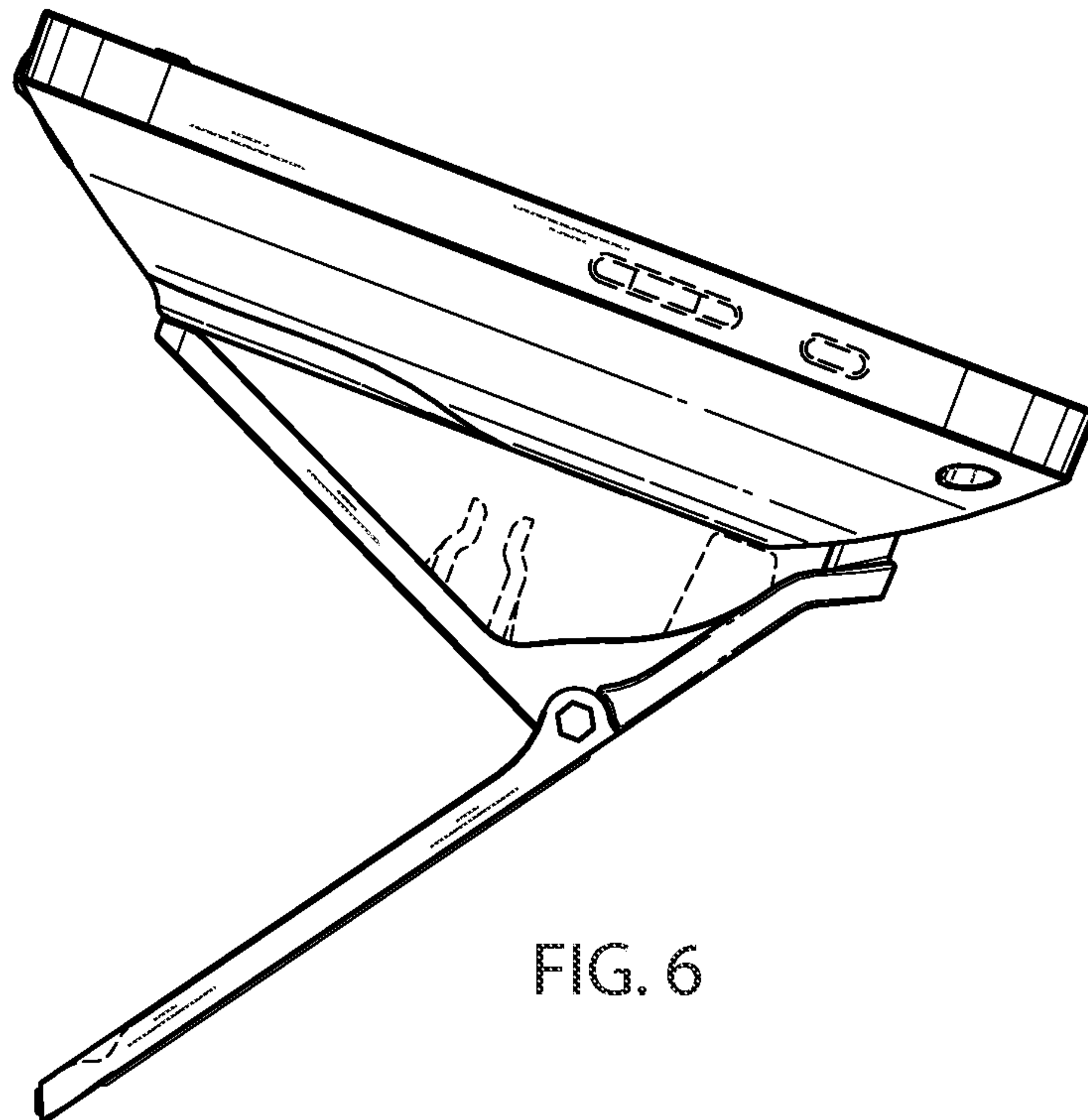
