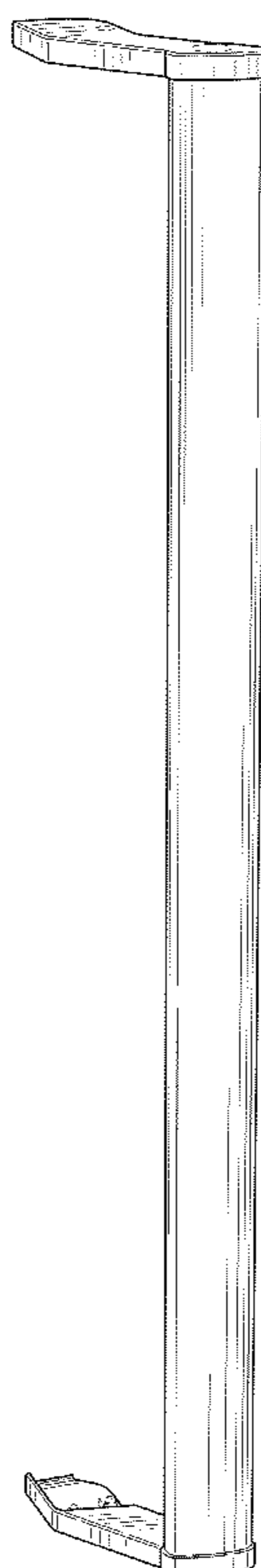
(57) **CLAIM**

The ornamental design for a handle for a refrigerator, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a handle for a refrigerator showing our new design;

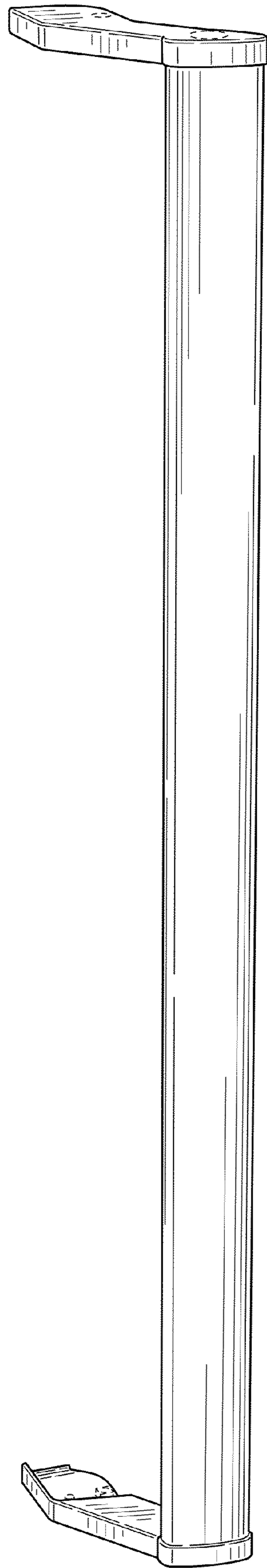

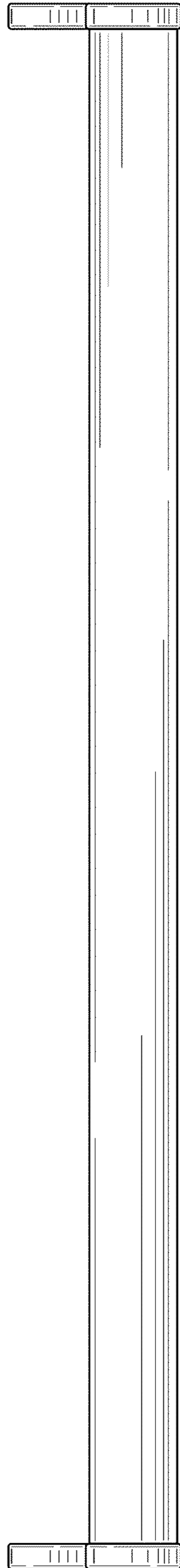

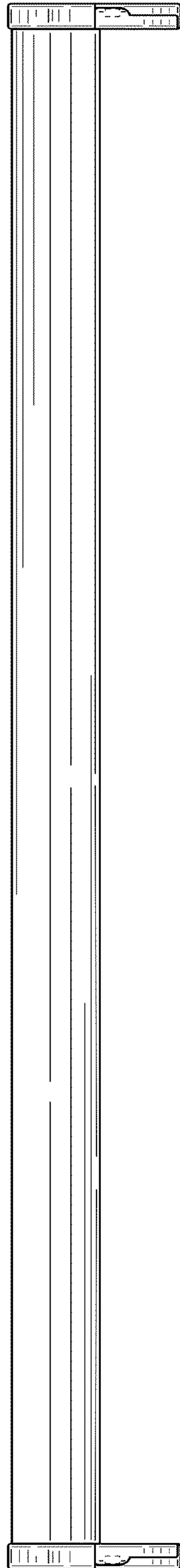
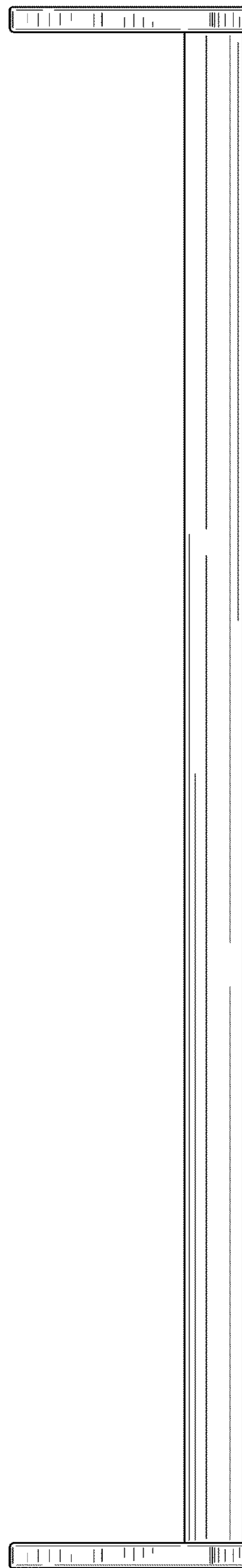
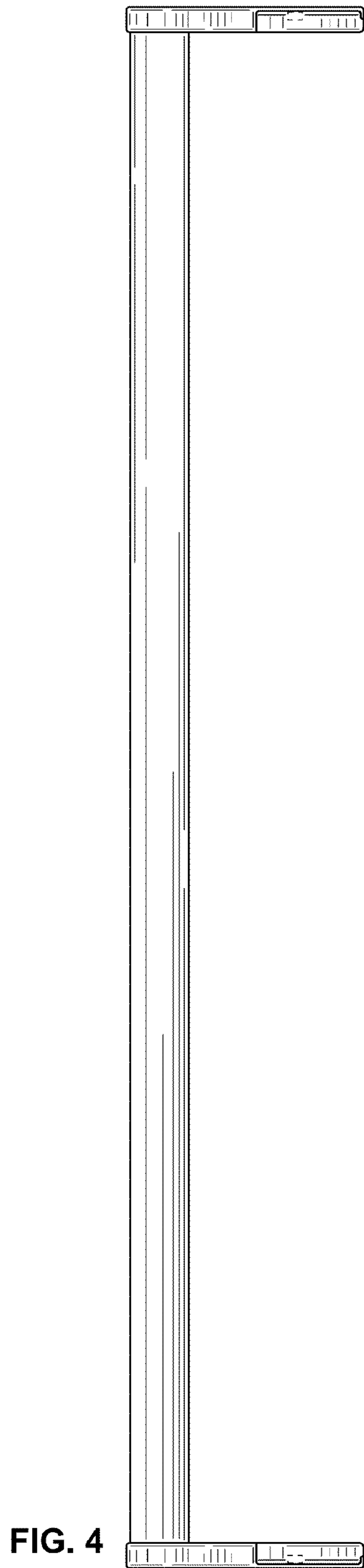

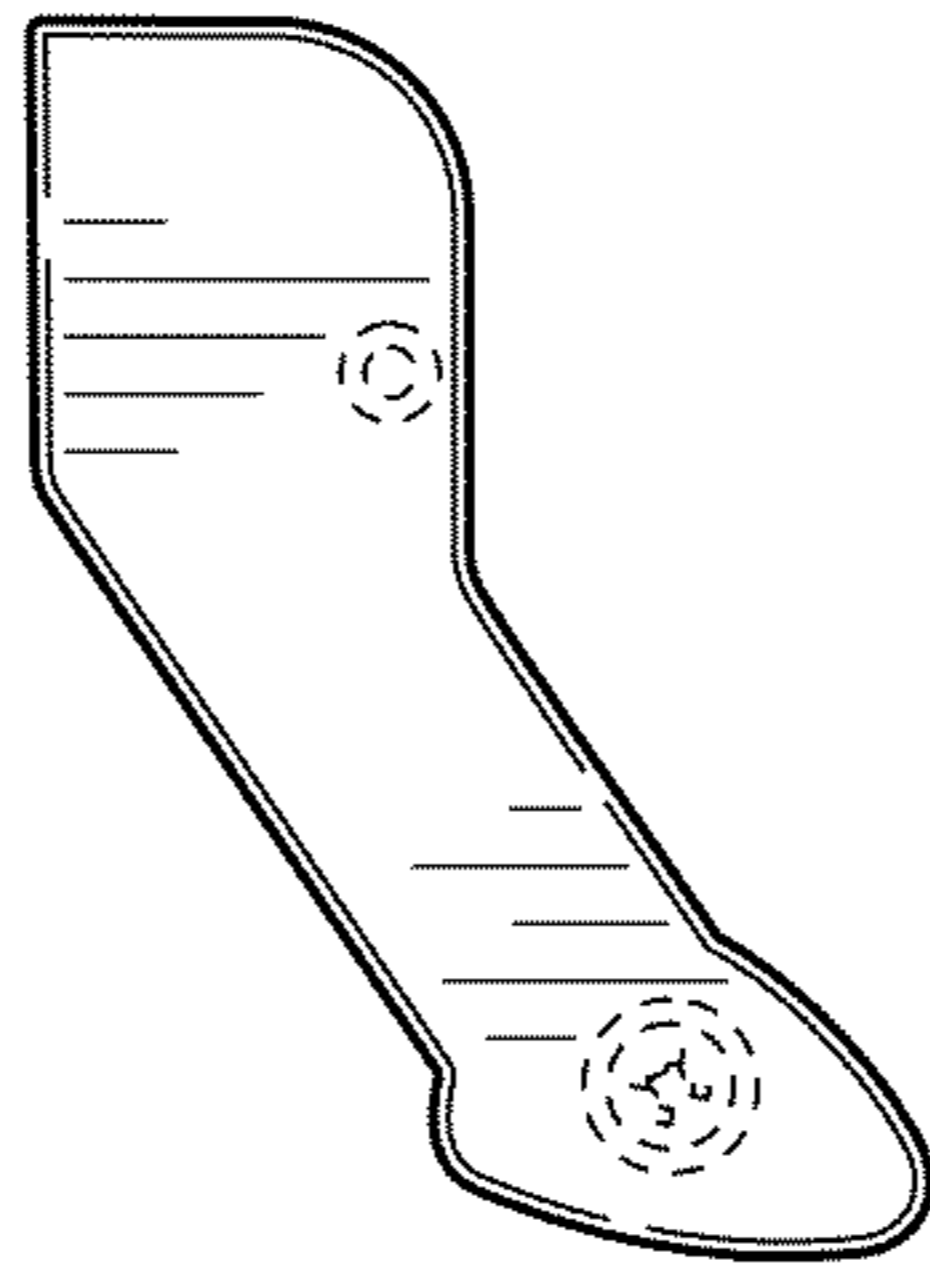

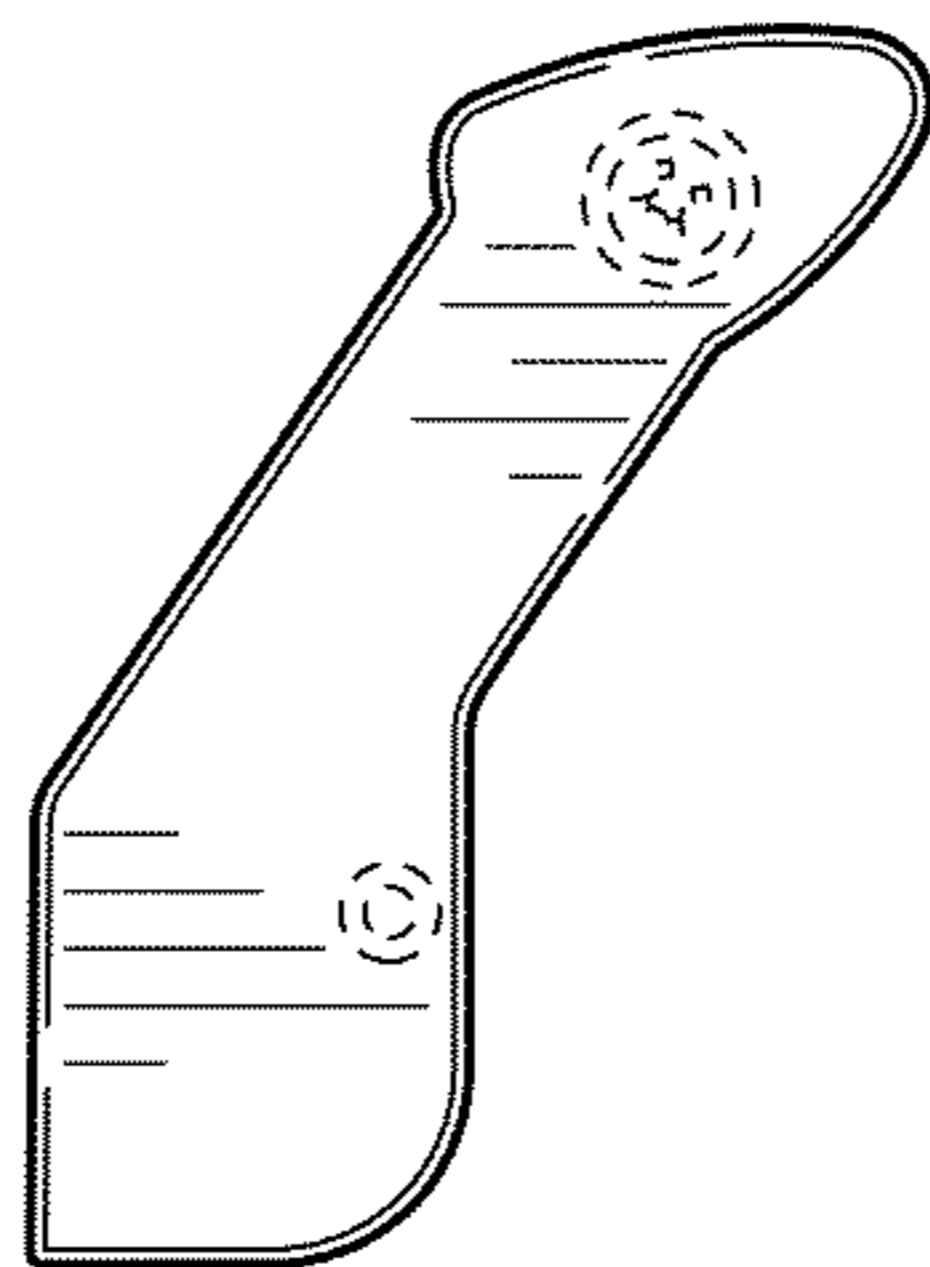
