(57) **CLAIM**

The ornamental design for a fishing rod with surface ornamentation, as shown and described.

DESCRIPTION

FIG. 1 is a side view of a fishing rod with surface ornamentation showing our new design in color;
 FIG. 2 is a top plan view of a portion thereof;
 FIG. 3 is a bottom plan view of a portion thereof;
 FIG. 4 is a left side view of a portion thereof;
 FIG. 5 is a right side view of a portion thereof;
 FIG. 6 is a detail of the fishing rod with surface ornamentation illustrated in FIG. 1;
 FIG. 7 is a side view of an alternative embodiment of a fishing rod with surface ornamentation showing our new design in black and white;
 FIG. 8 is a top plan view of a portion thereof;
 FIG. 9 is a bottom plan view of a portion thereof;
 FIG. 10 is a left side view of a portion thereof;
 FIG. 11 is a right side view of a portion thereof; and,
 FIG. 12 is a detail of the fishing rod with surface ornamentation illustrated in FIG. 7.

Although the fishing rod is generally tapered as is conventional, such taper is not apparent in FIGS. 2-12, as the taper along the length of the rod is gradual, and the portions depicted in FIGS. 2-12 are relatively short.

The broken lines in the drawings are for illustrative purposes only and do not form a part of the claimed design.

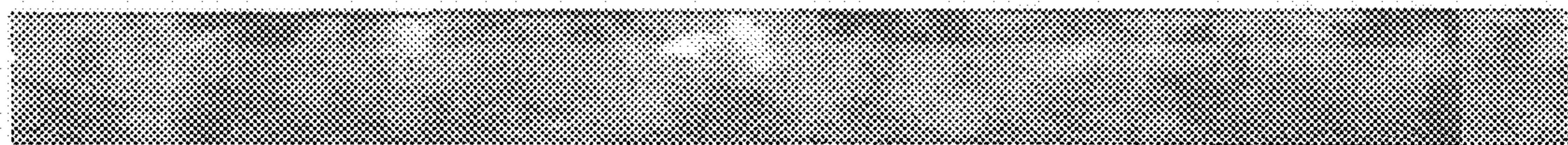

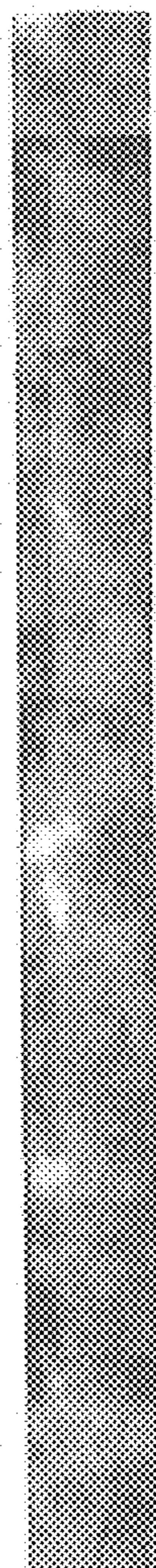

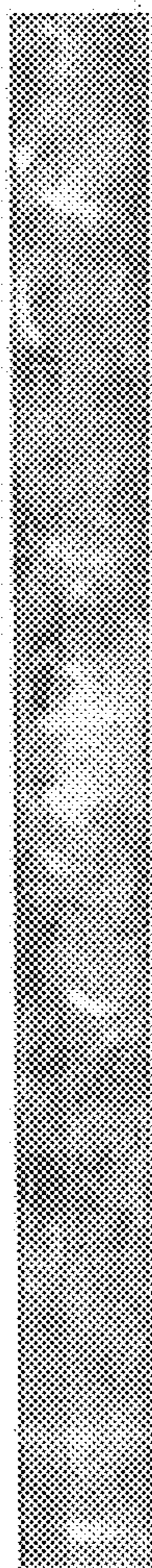

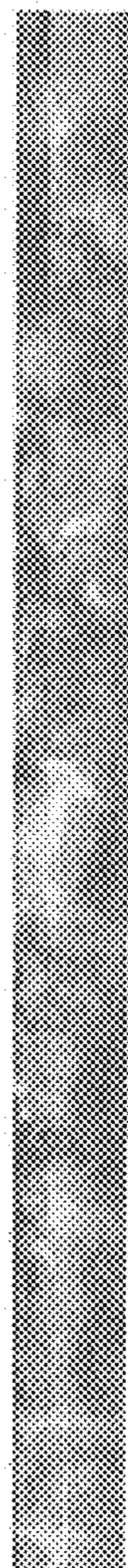

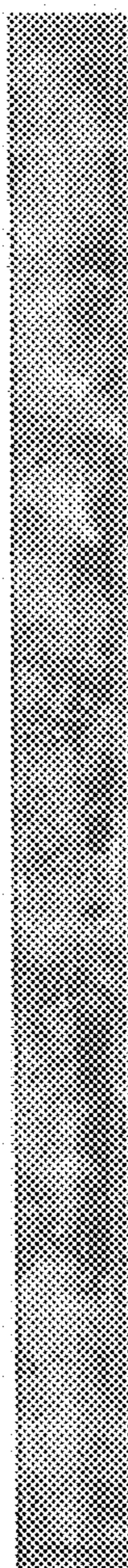

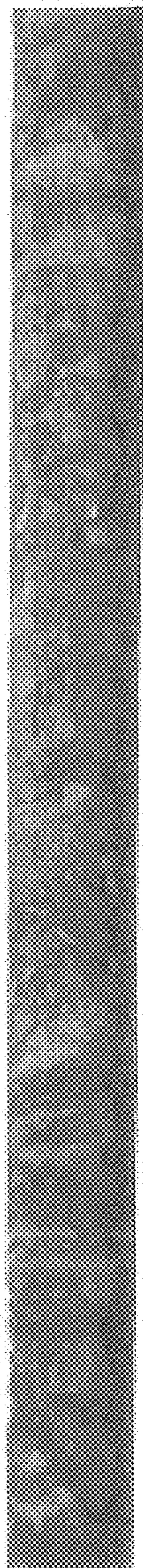

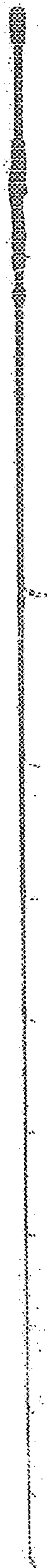

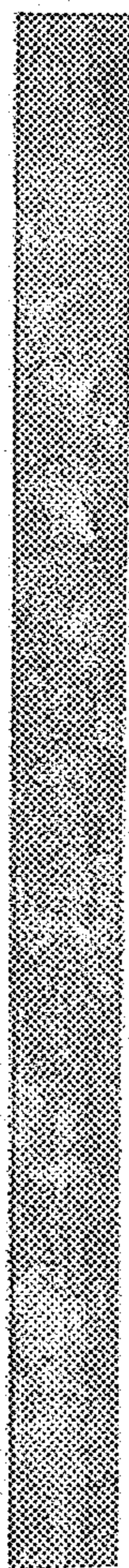

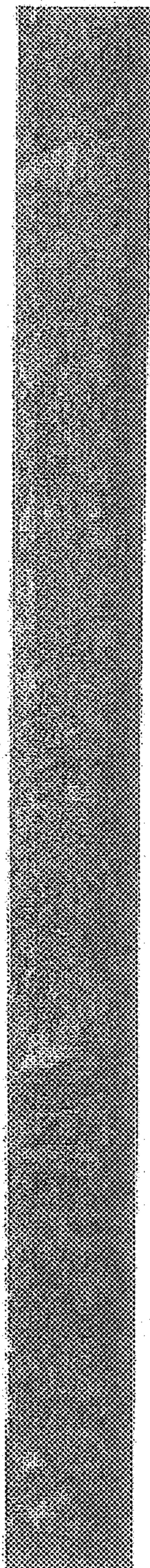
