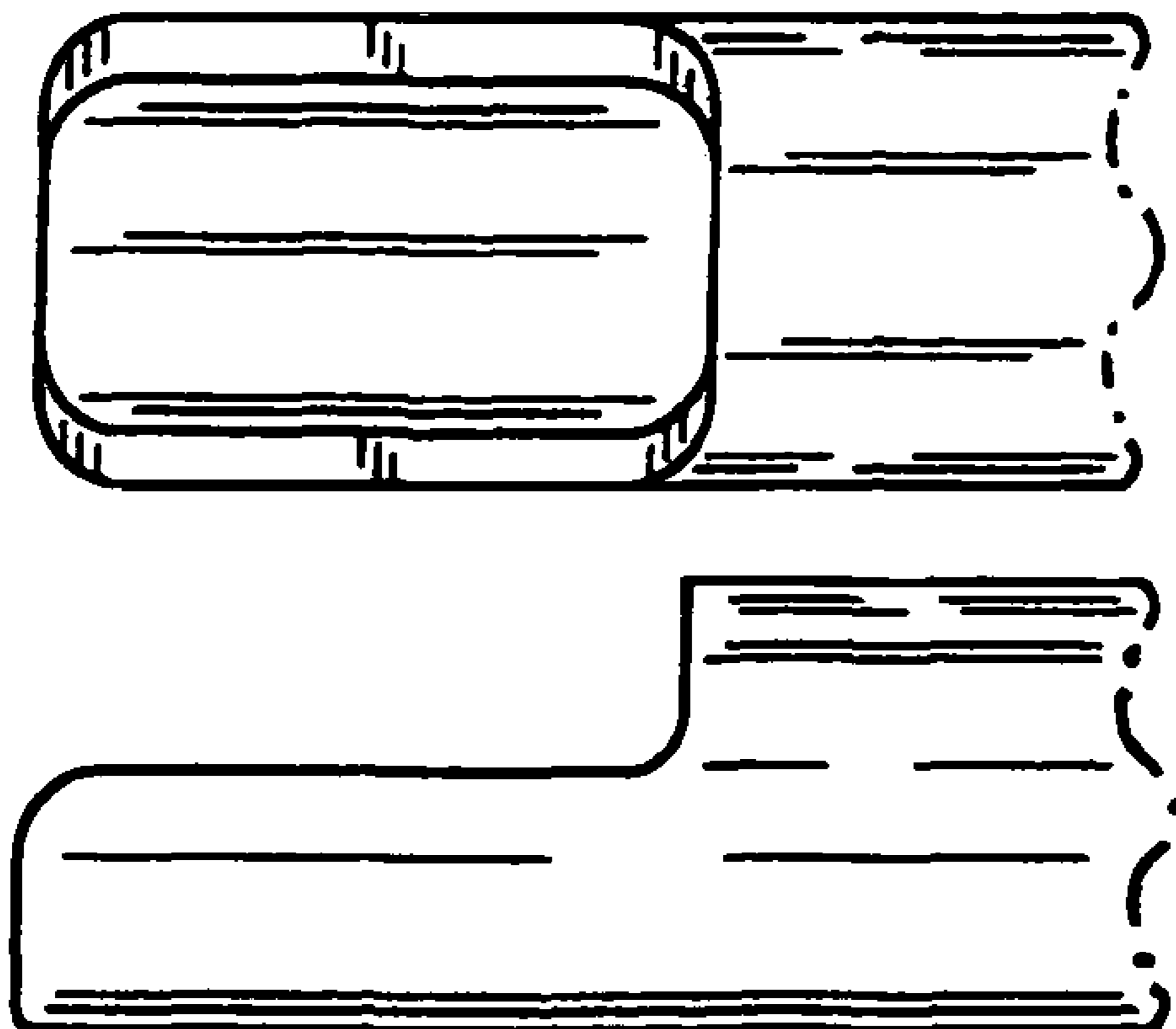
(57) **CLAIM**
The ornamental design for the surgical instrument sleeve, as shown and described.

DESCRIPTION

FIG. 1 is a top, front, and left side perspective view of a surgical instrument sleeve, showing my new design;
FIG. 2 is a top plan view thereof;
FIG. 3 is a bottom plan view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof; and,
FIG. 6 is a left side elevational view thereof, the right side elevation being a mirror image thereof.
The broken line break is shown to indicate the unclaimed boundary of the claimed design.

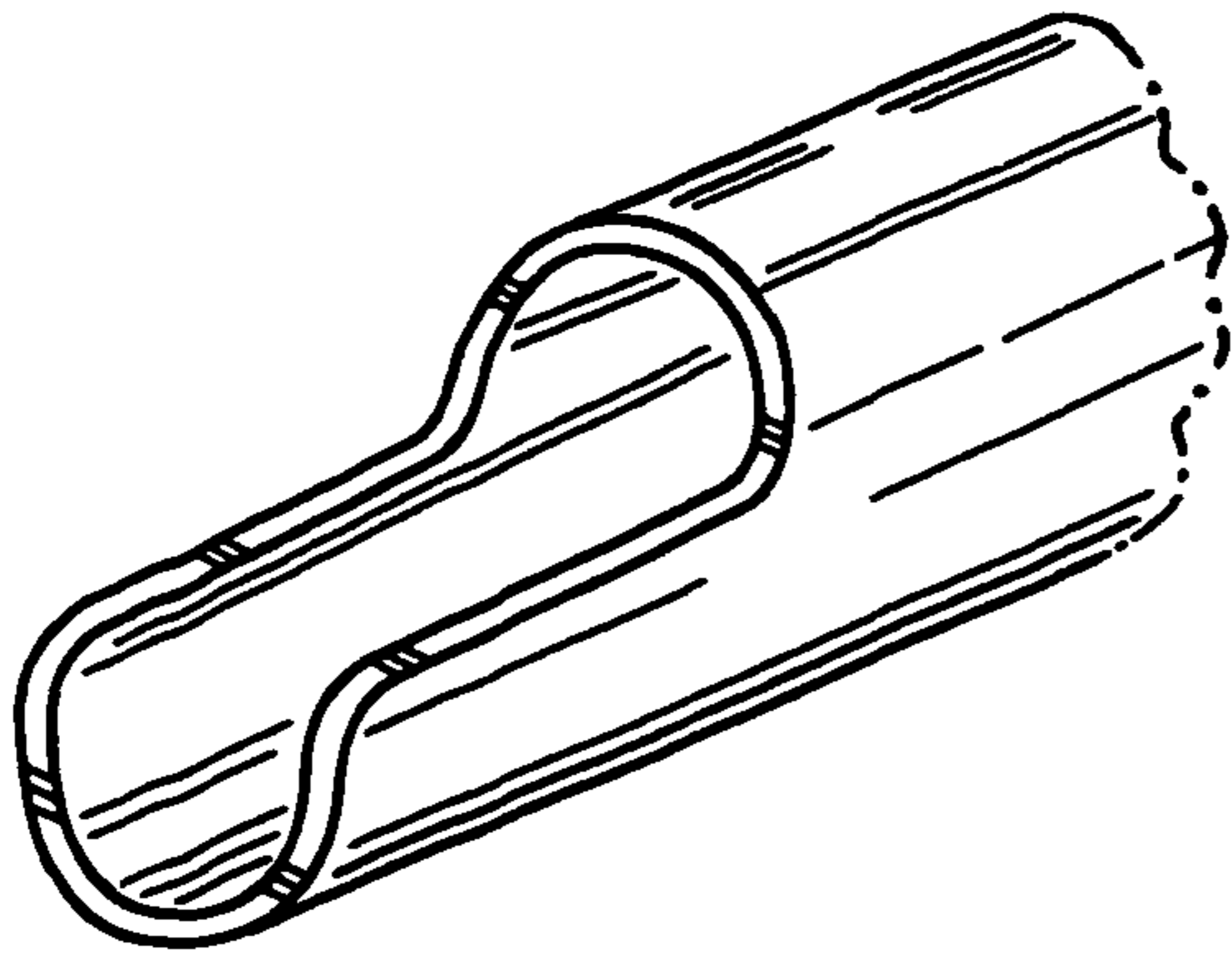

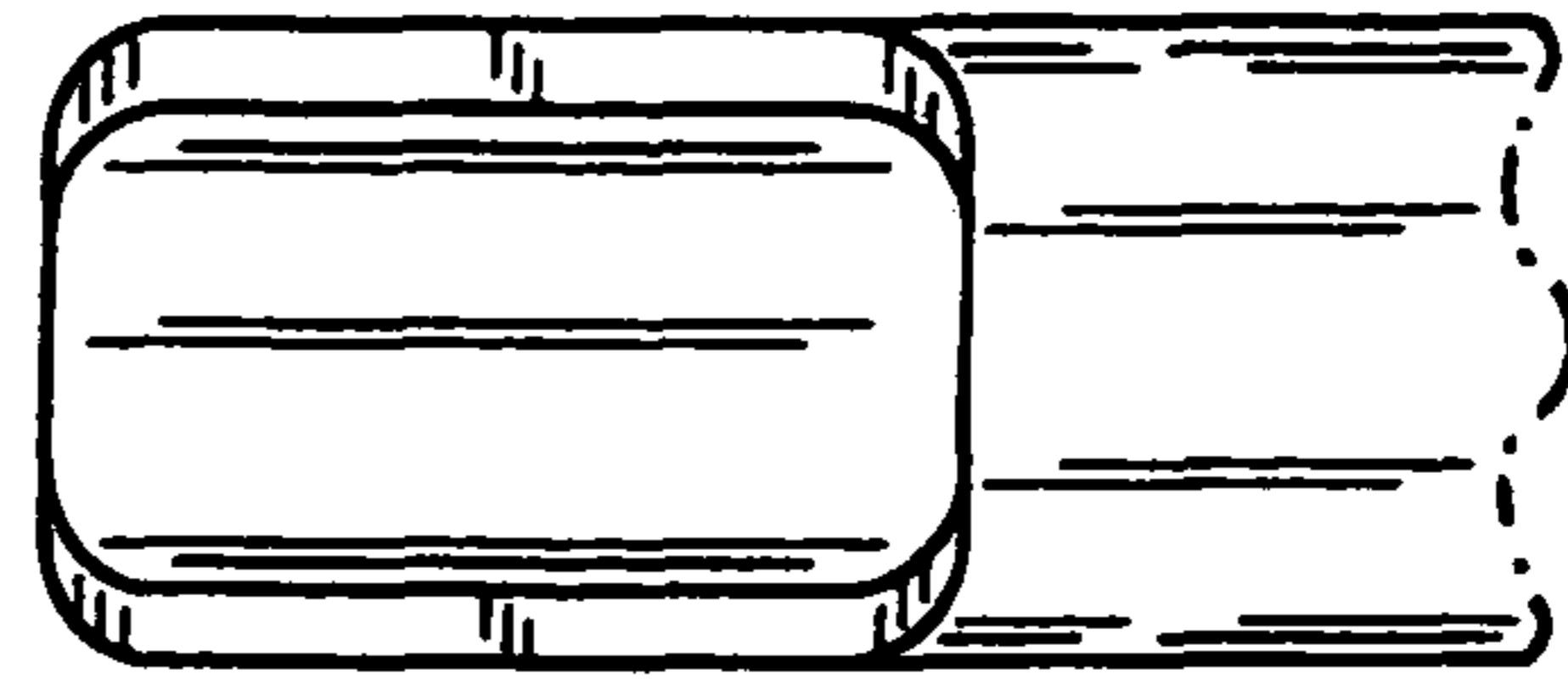

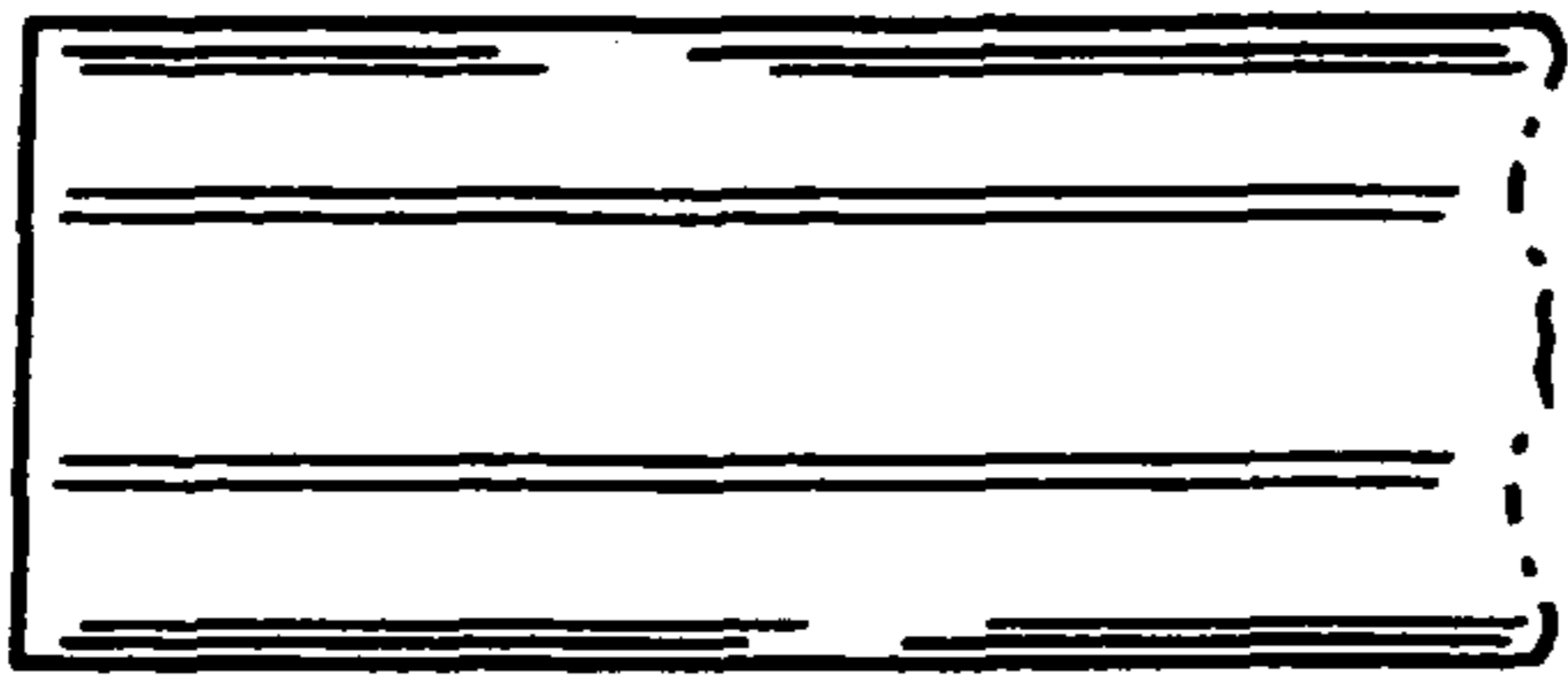

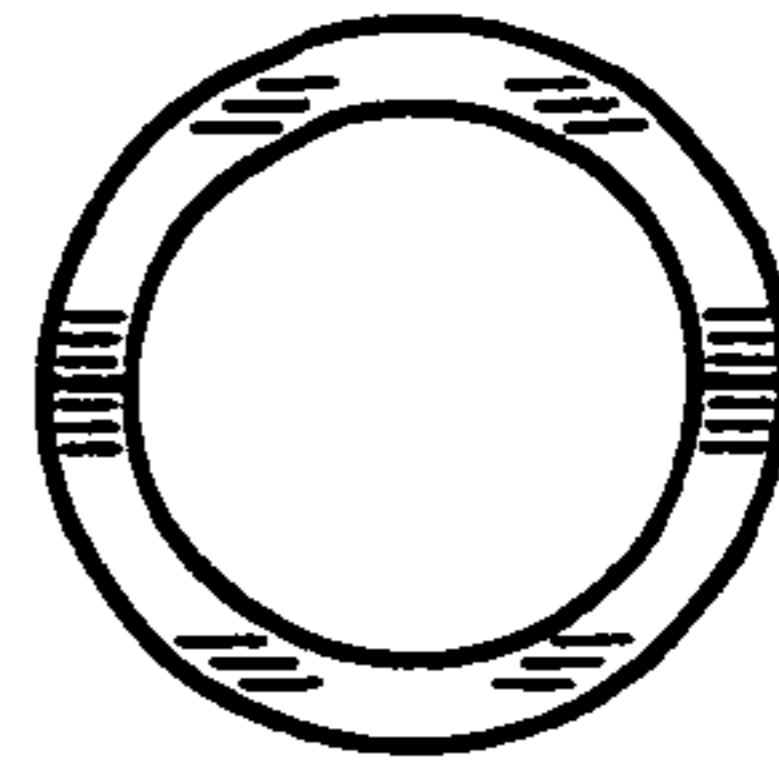

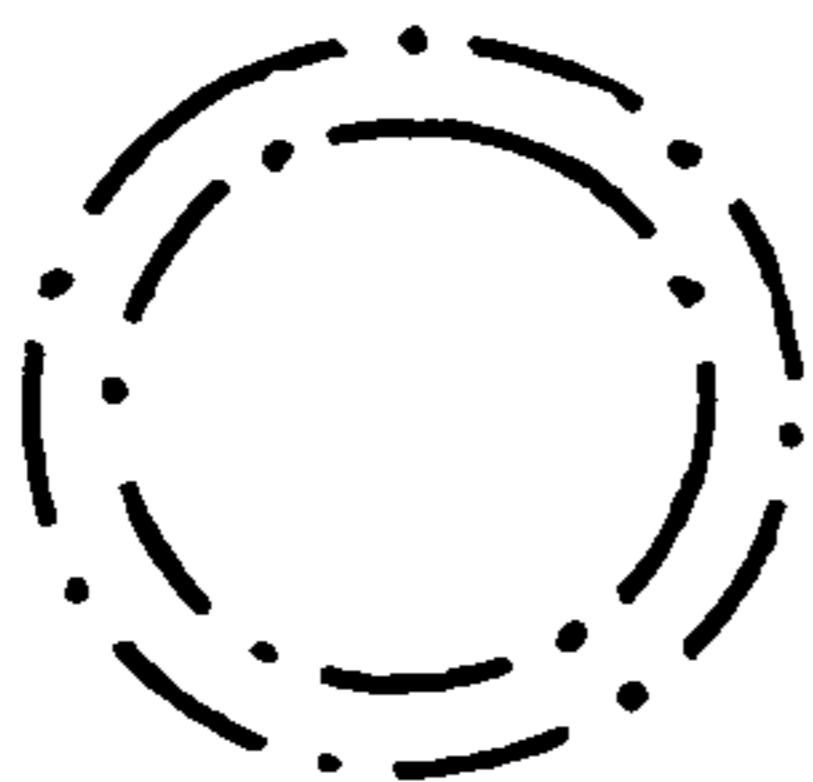

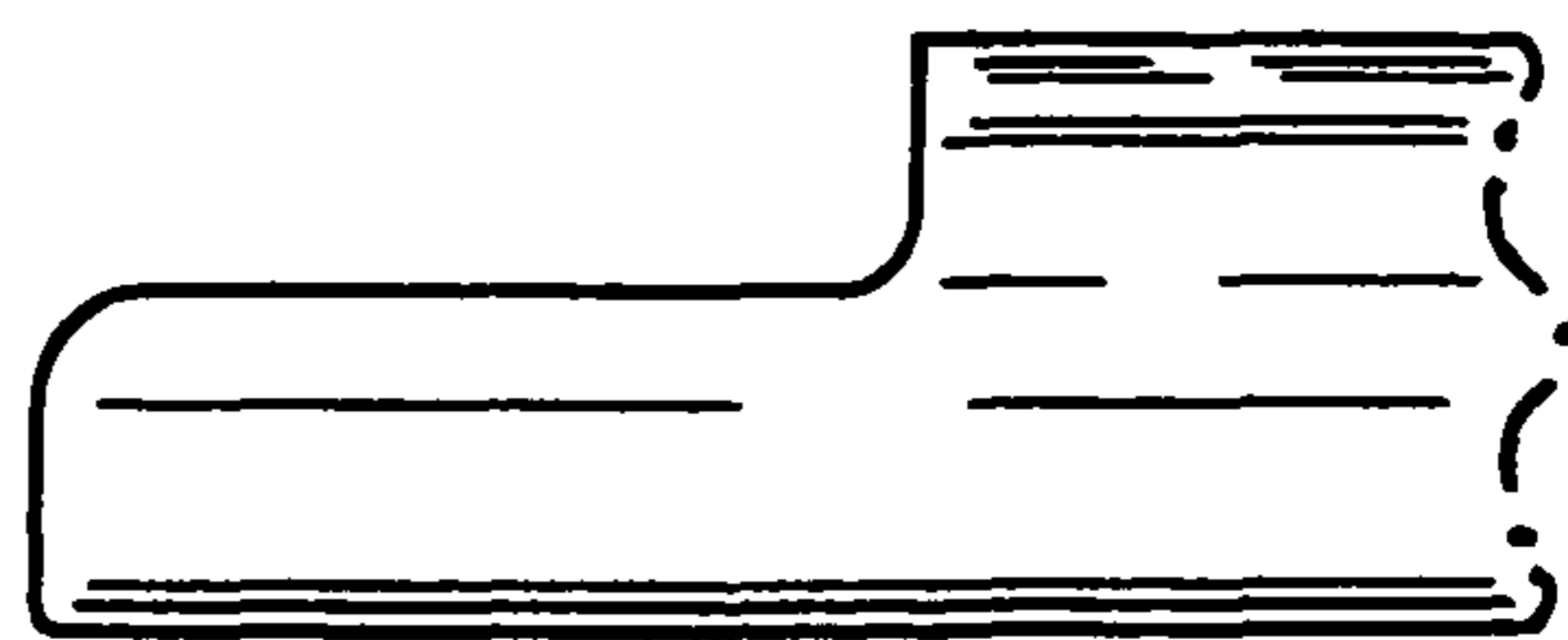
