FIG. 2 is a front view of the pacifier.

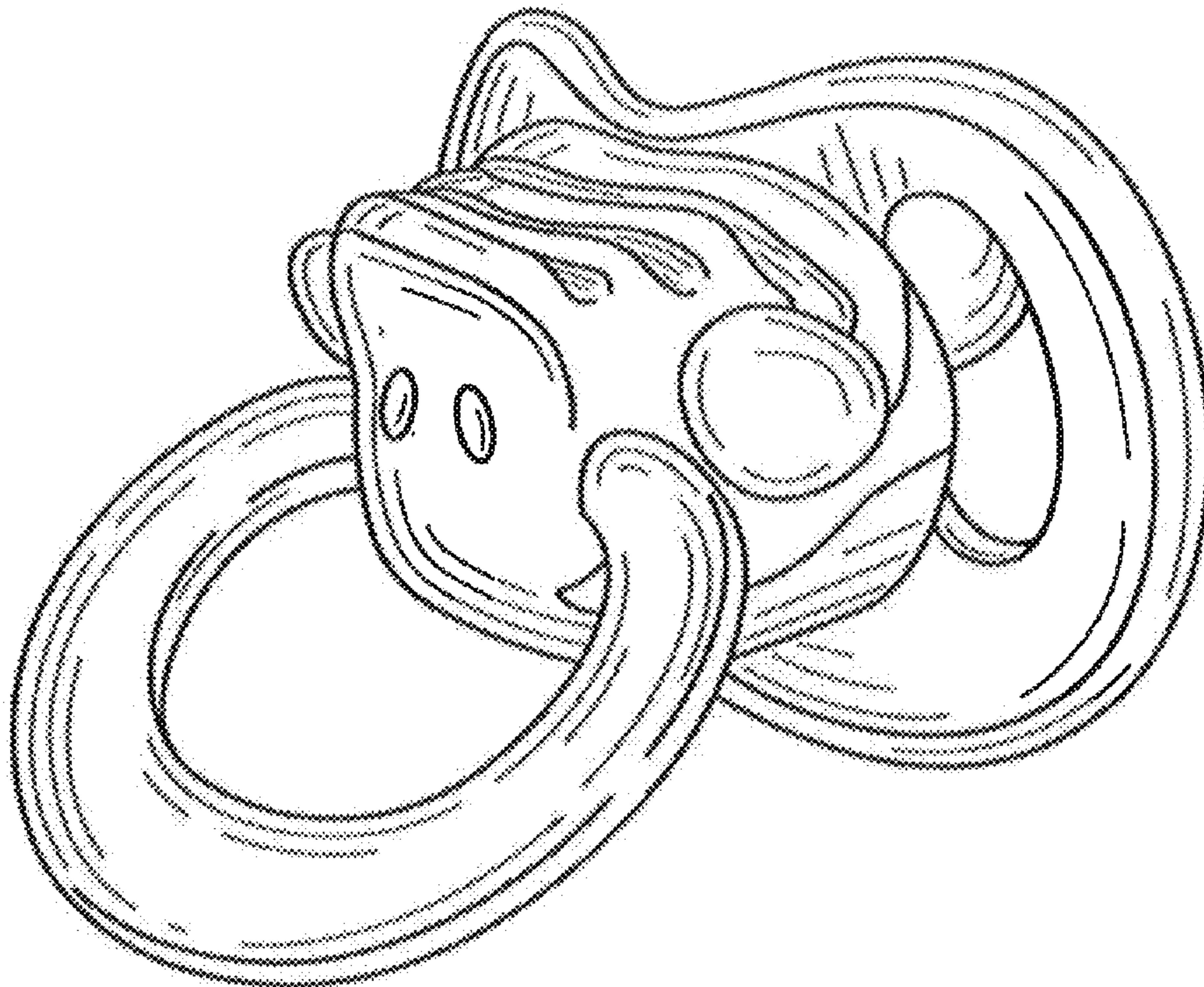
FIG. 3 is a rear view of the pacifier.

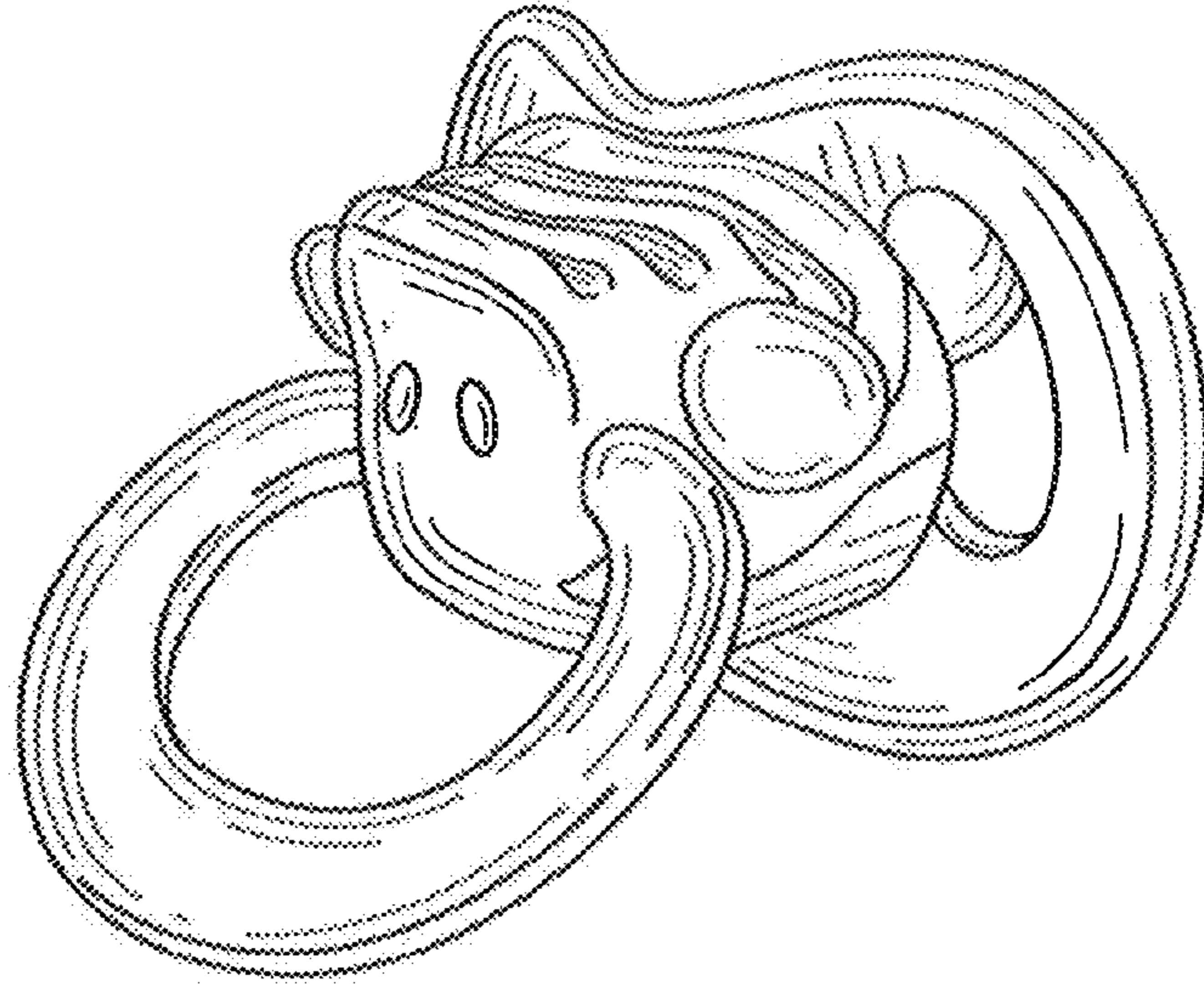

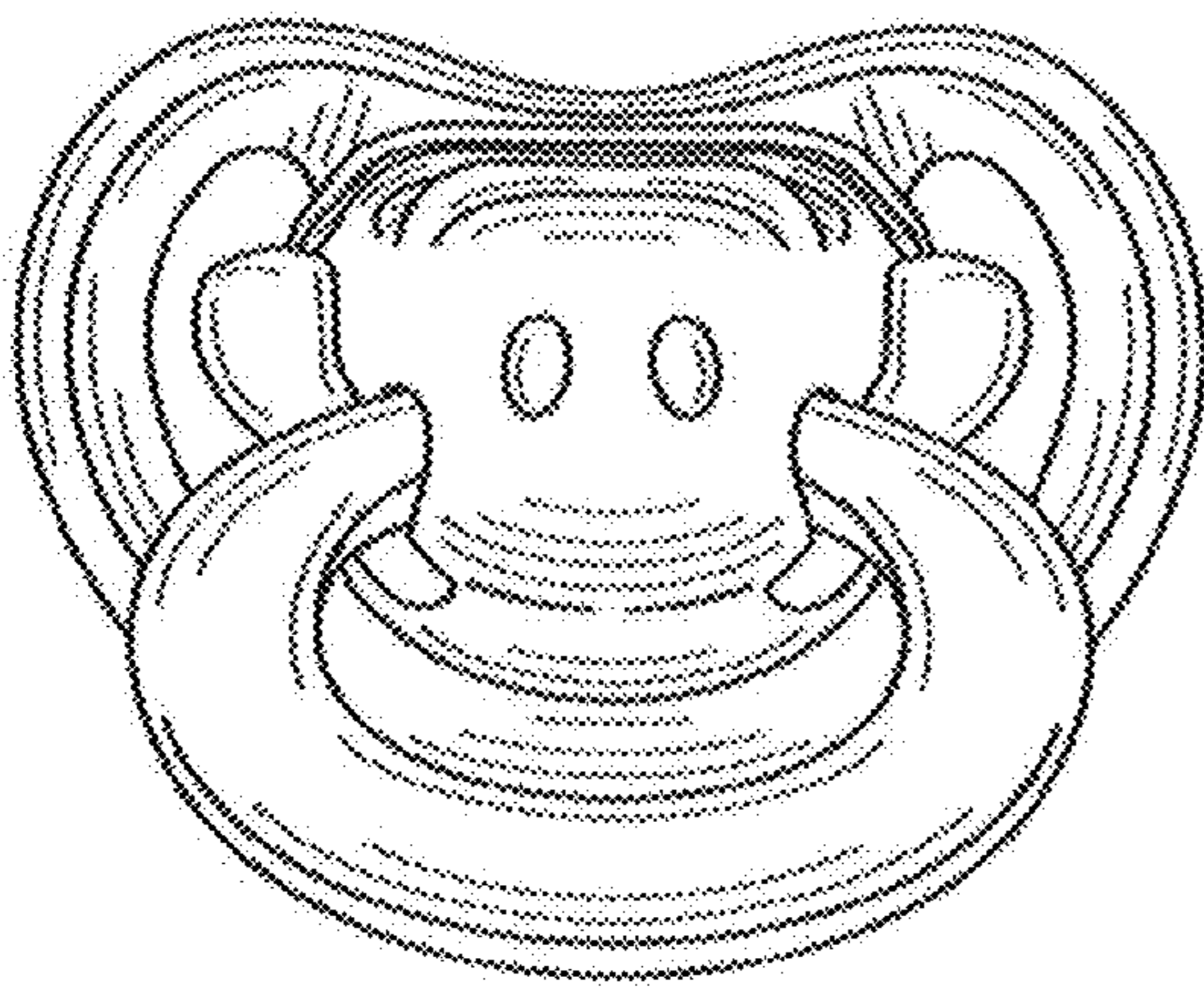

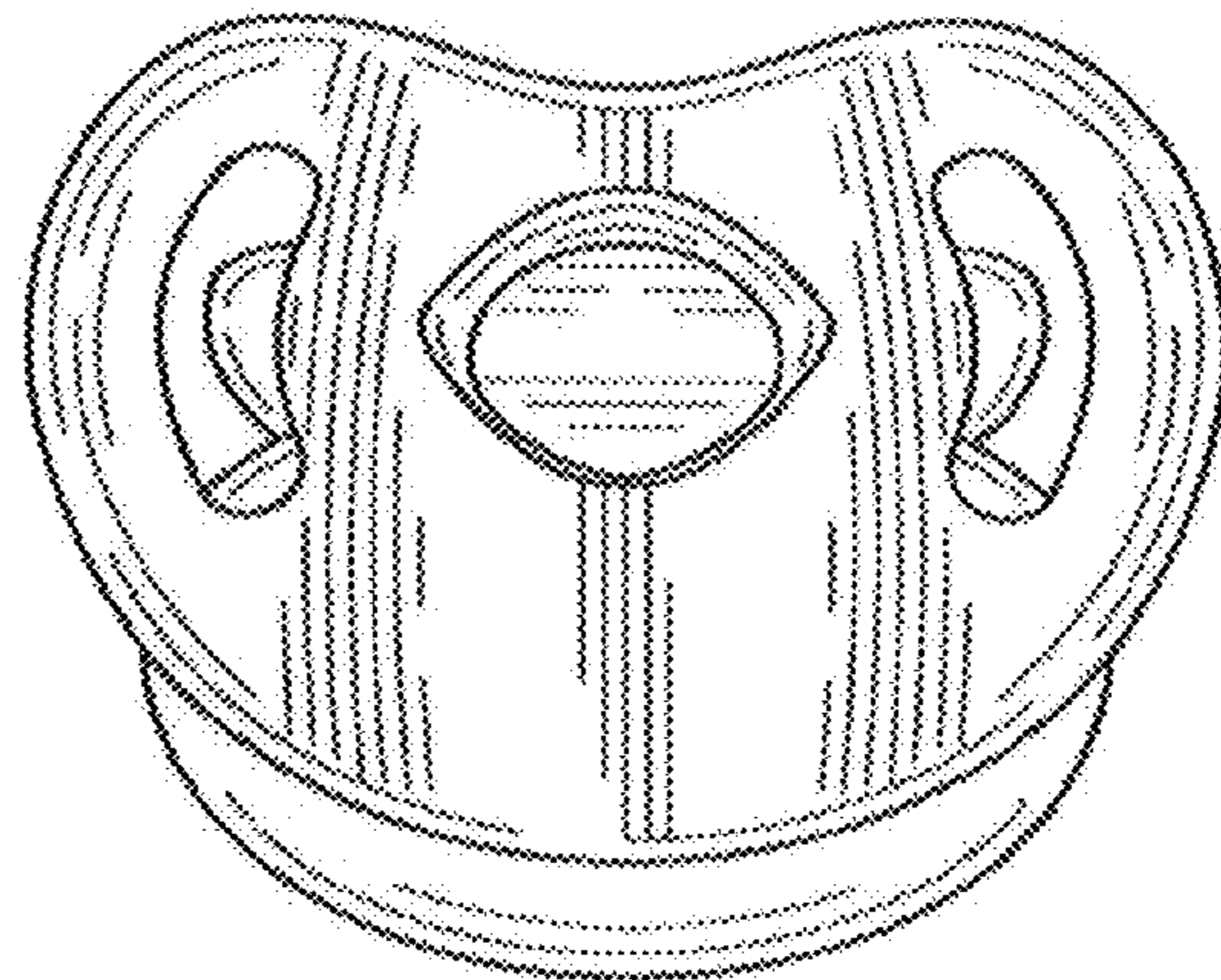

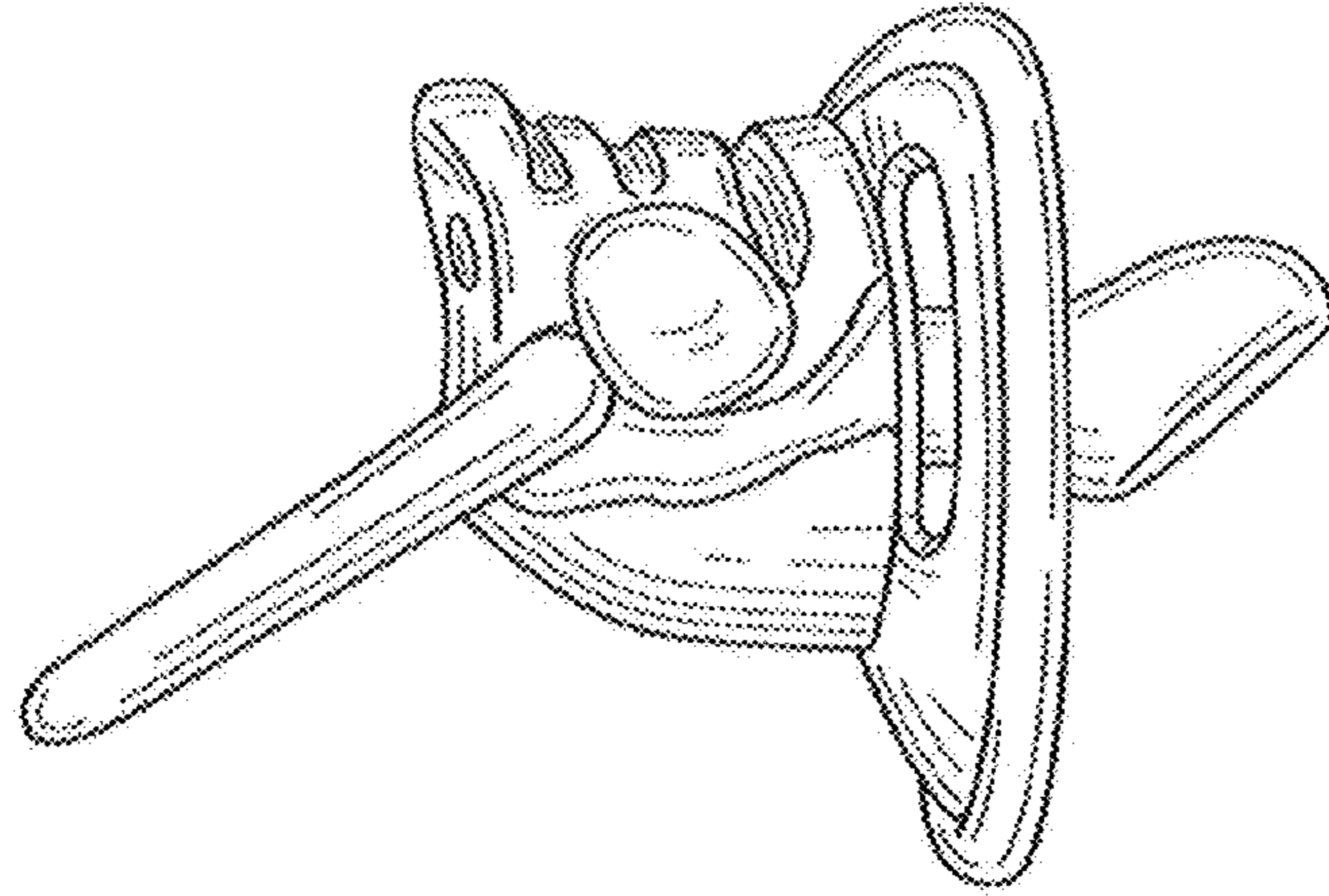

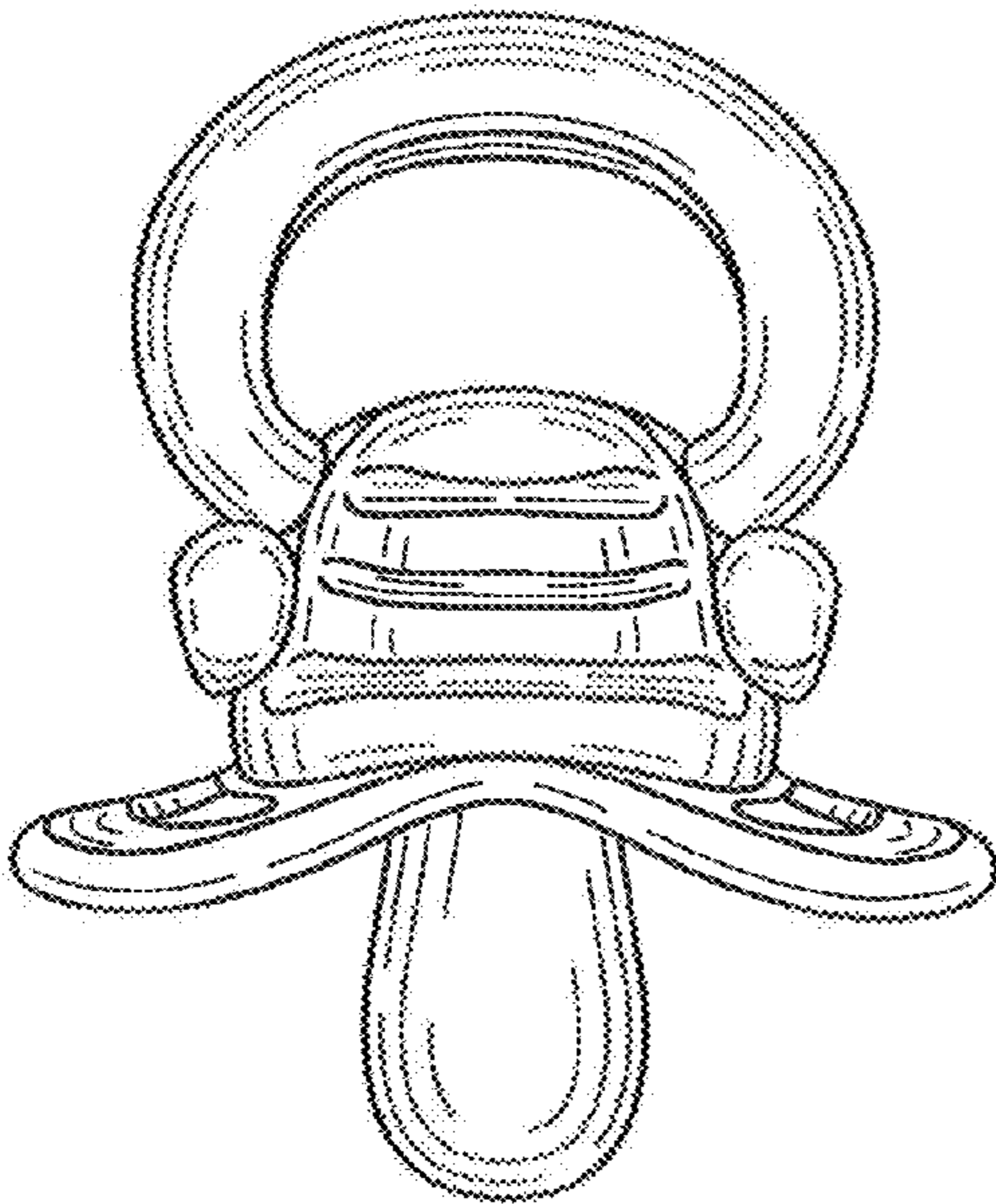

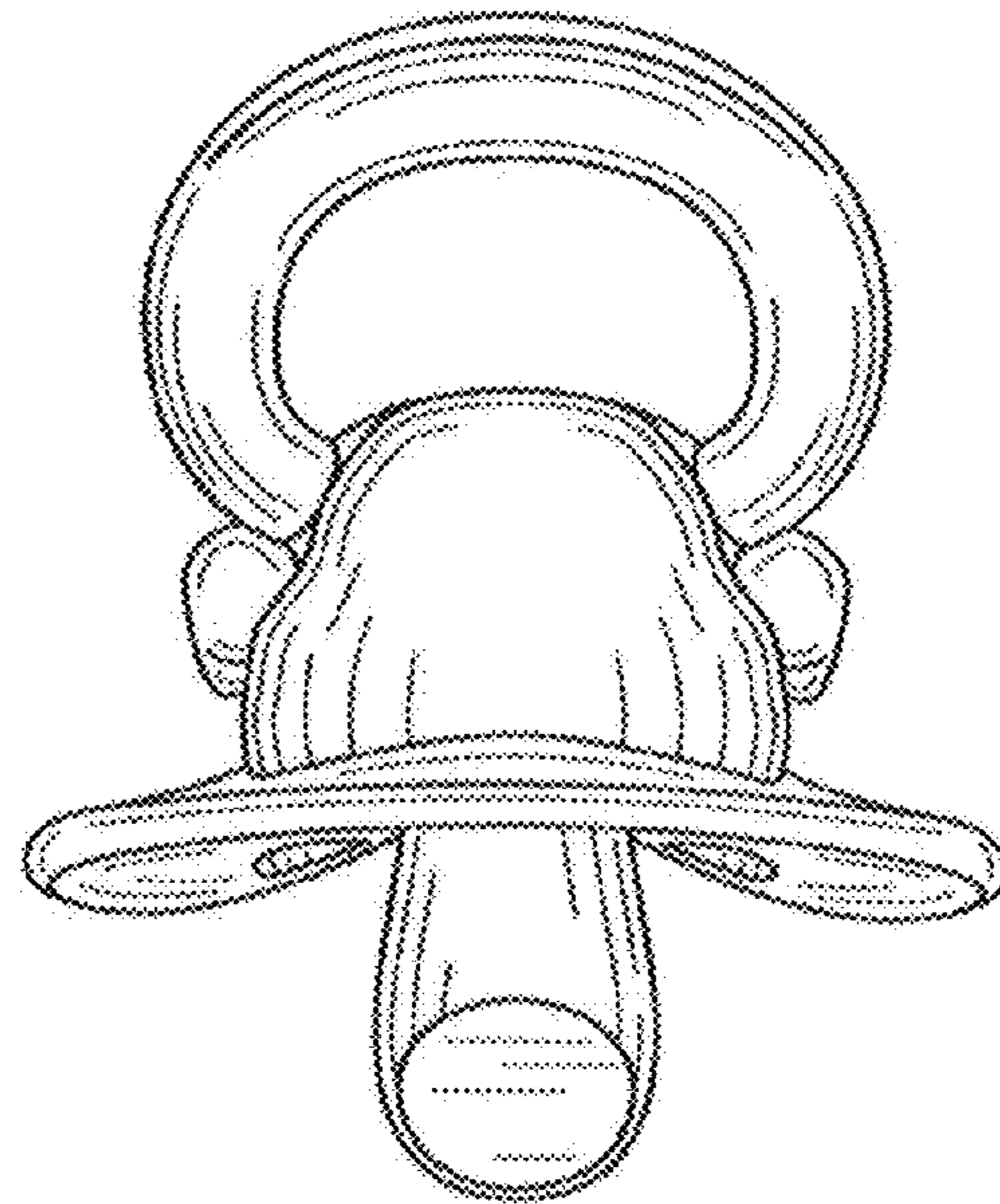
