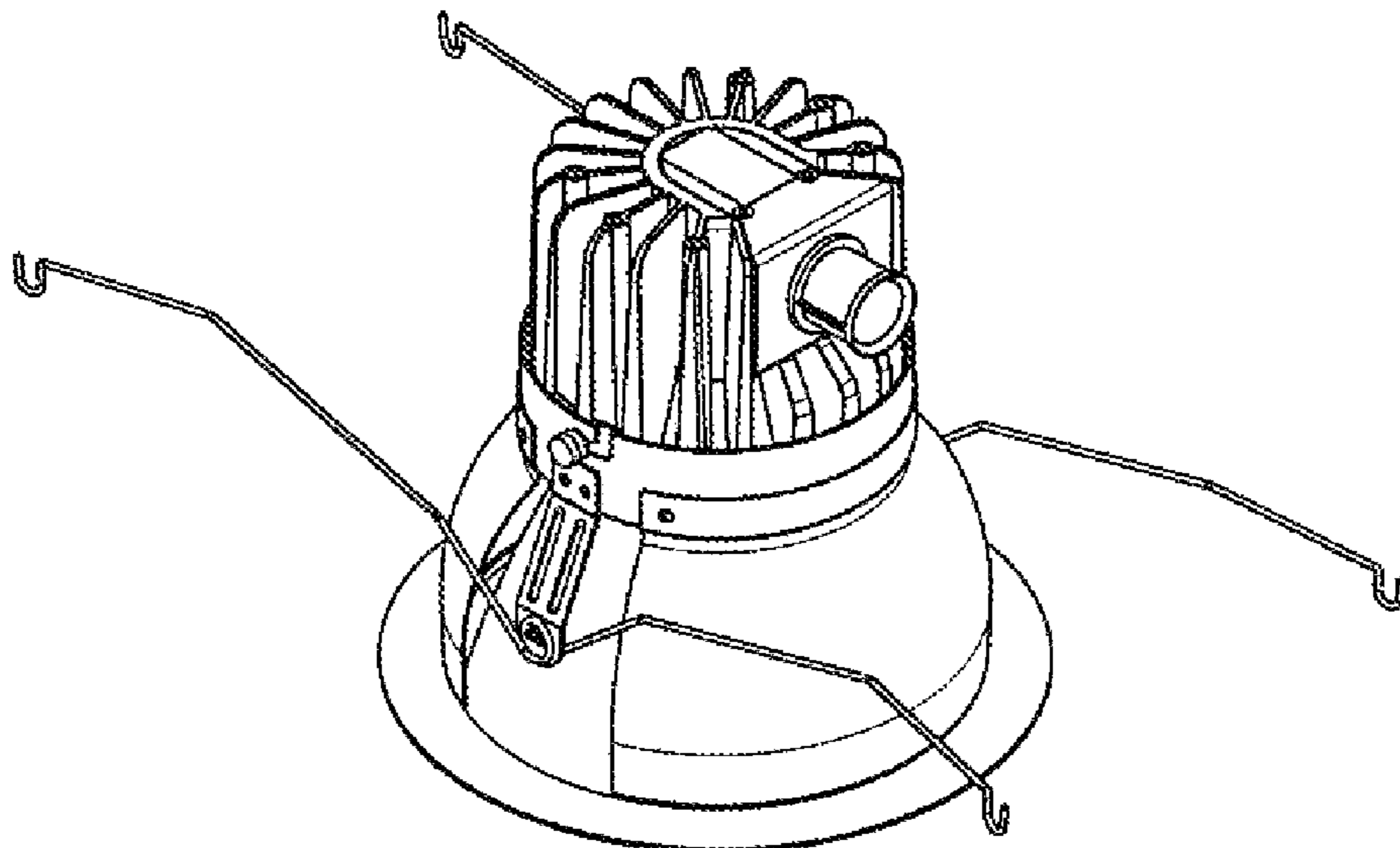
(57) **CLAIM**

The ornamental design for a commercial LED fixture with main reflector having a pair of oppositely disposed wall washes, as shown and described.

DESCRIPTION

FIG. 1 is a side perspective view of a first embodiment of the commercial LED fixture with main reflector having a pair of oppositely disposed wall washes;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a left side elevational view thereof;

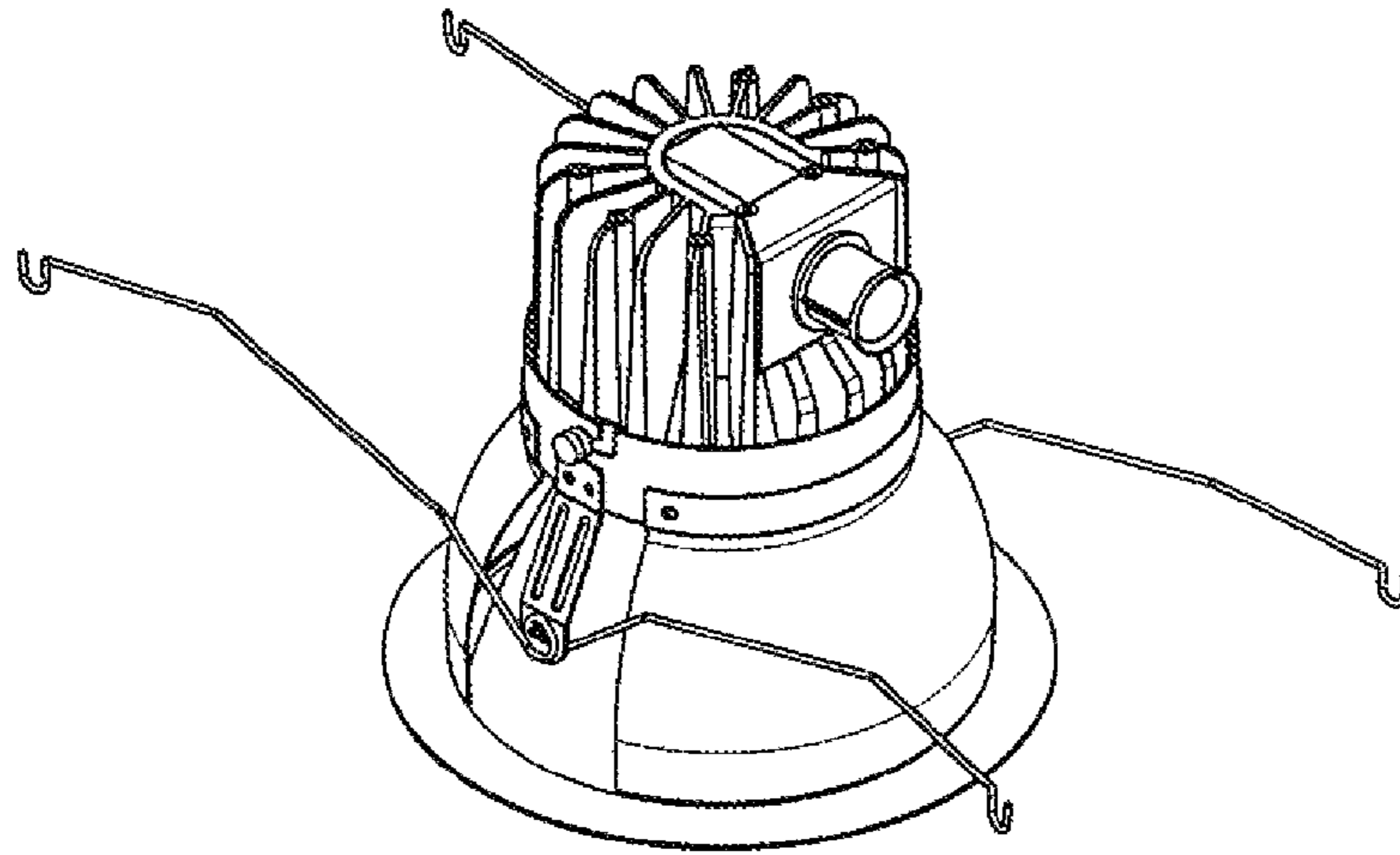

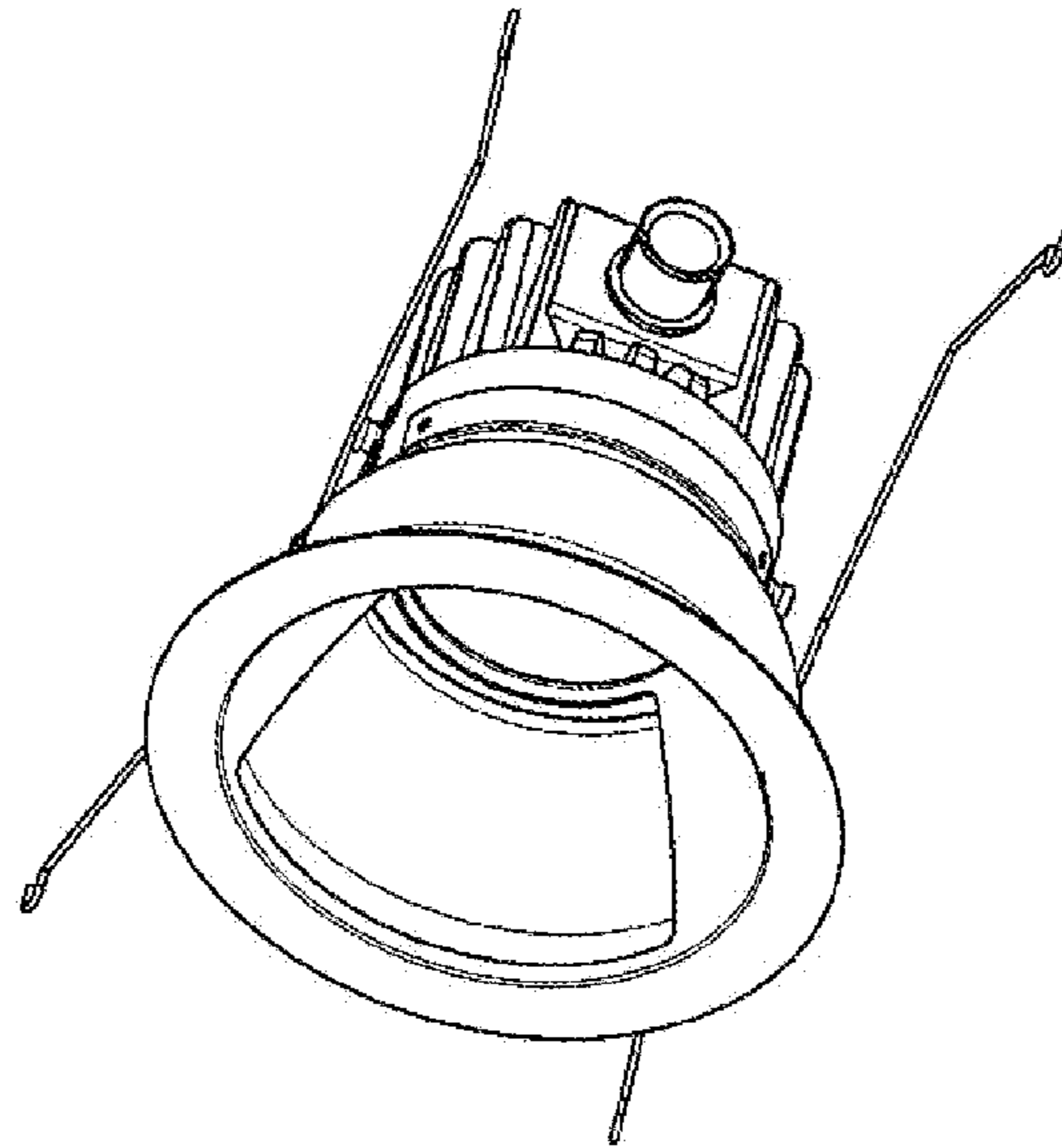

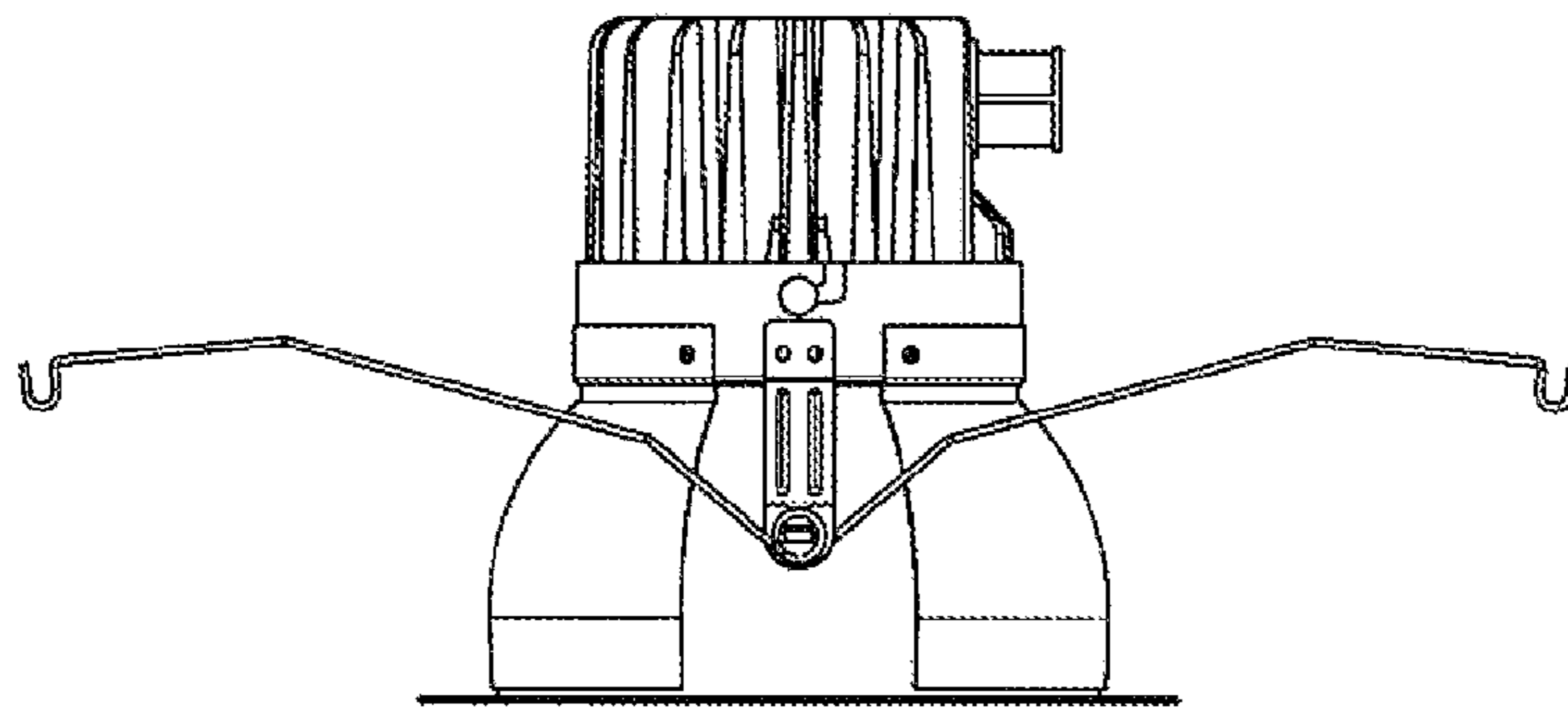

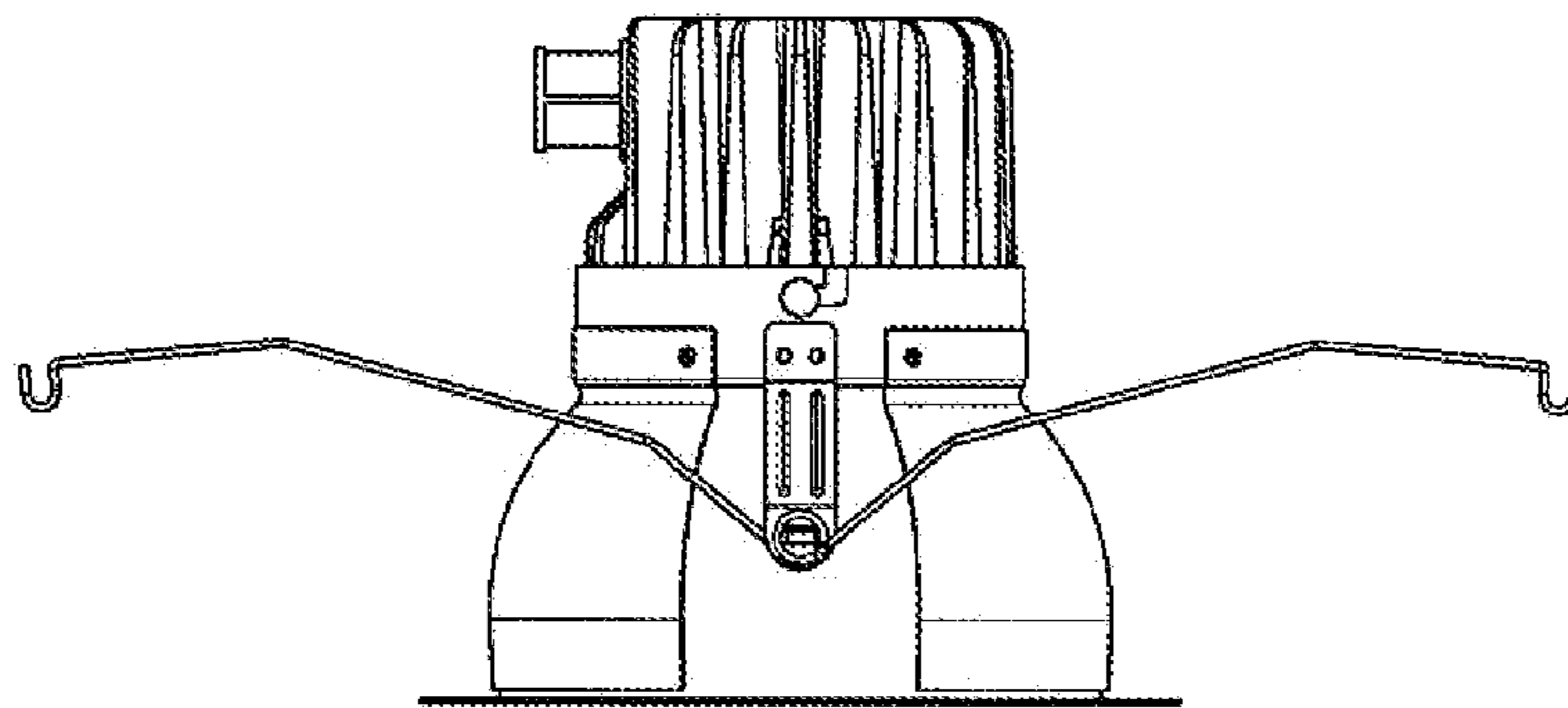

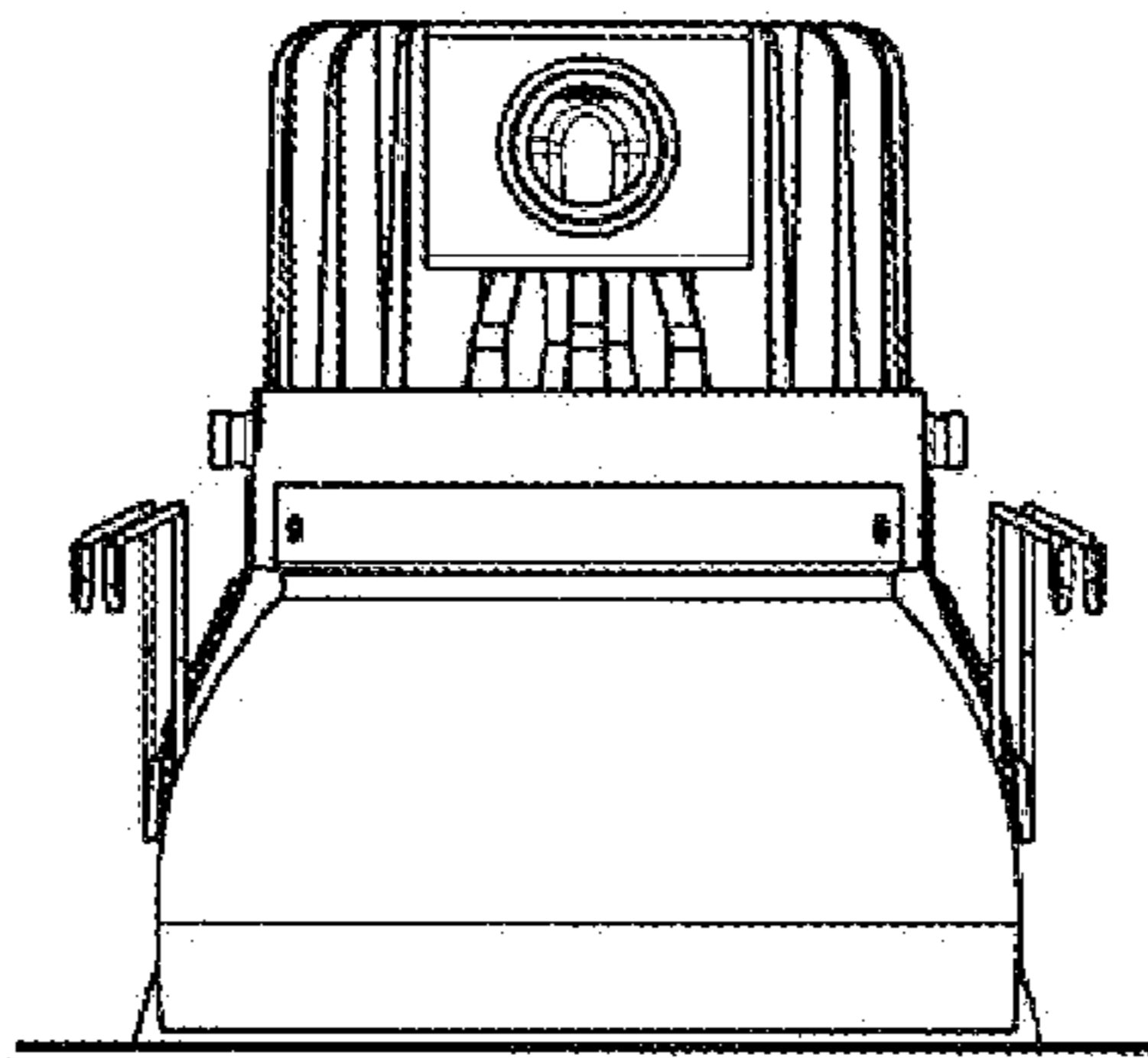

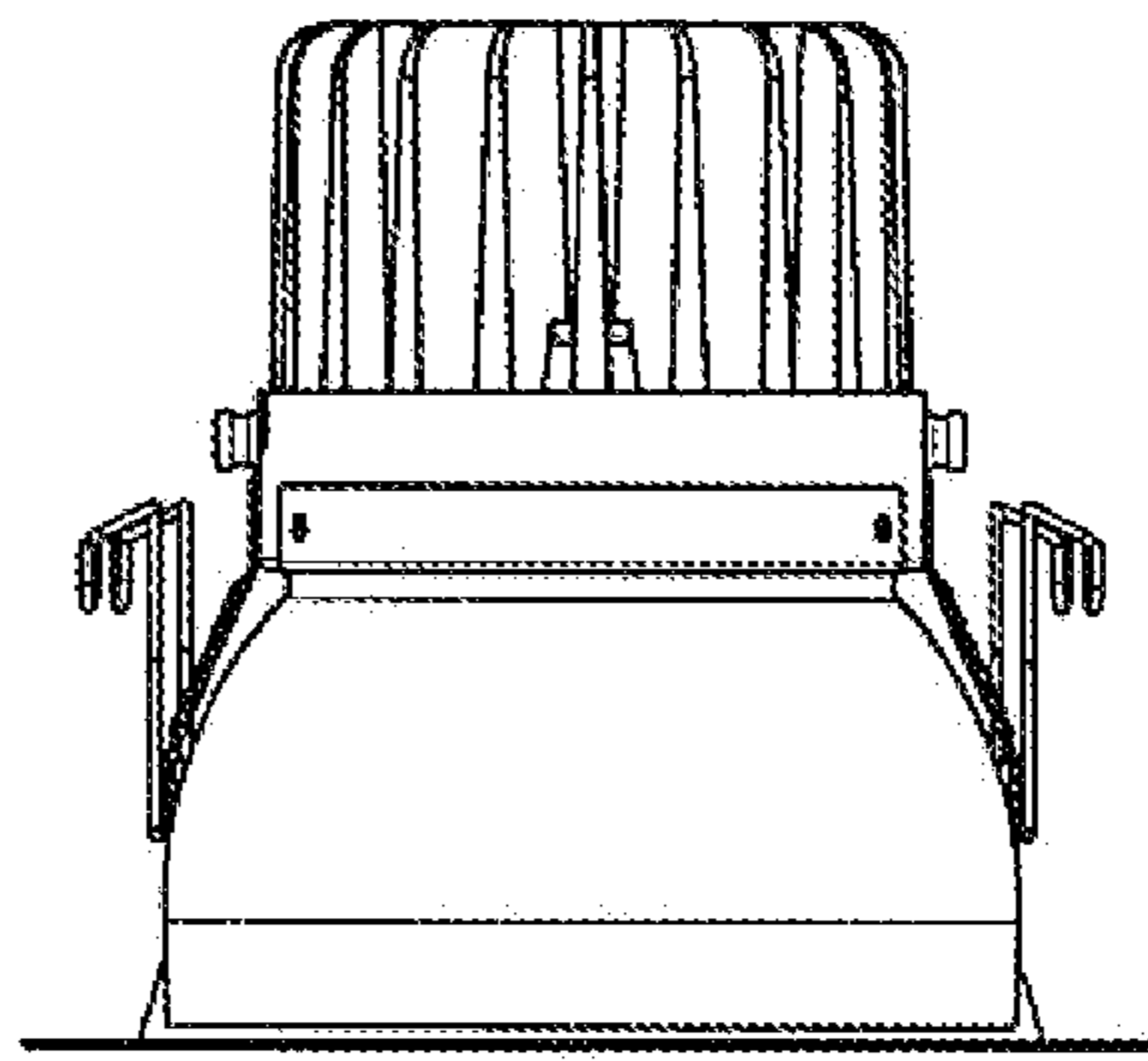

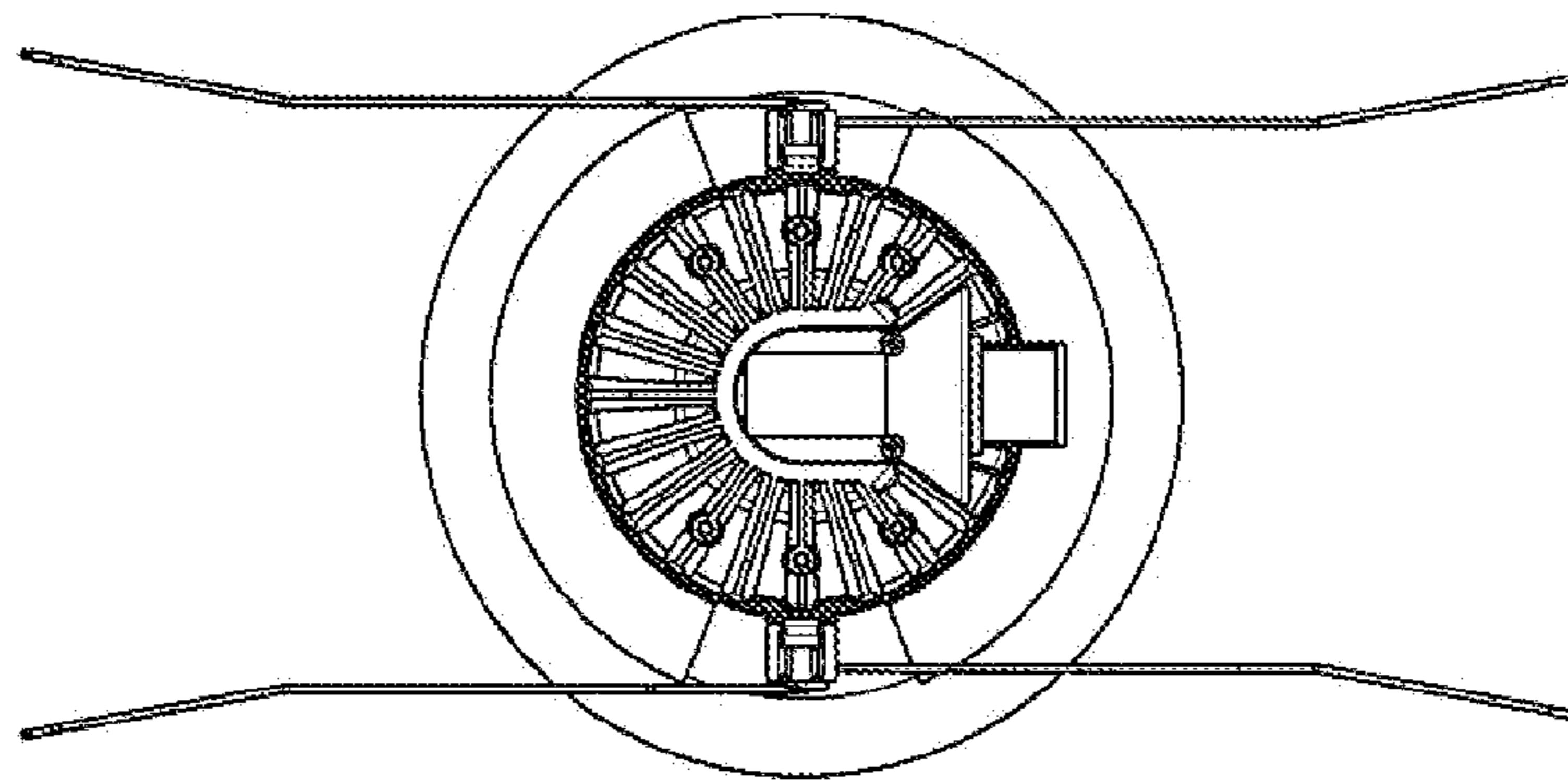

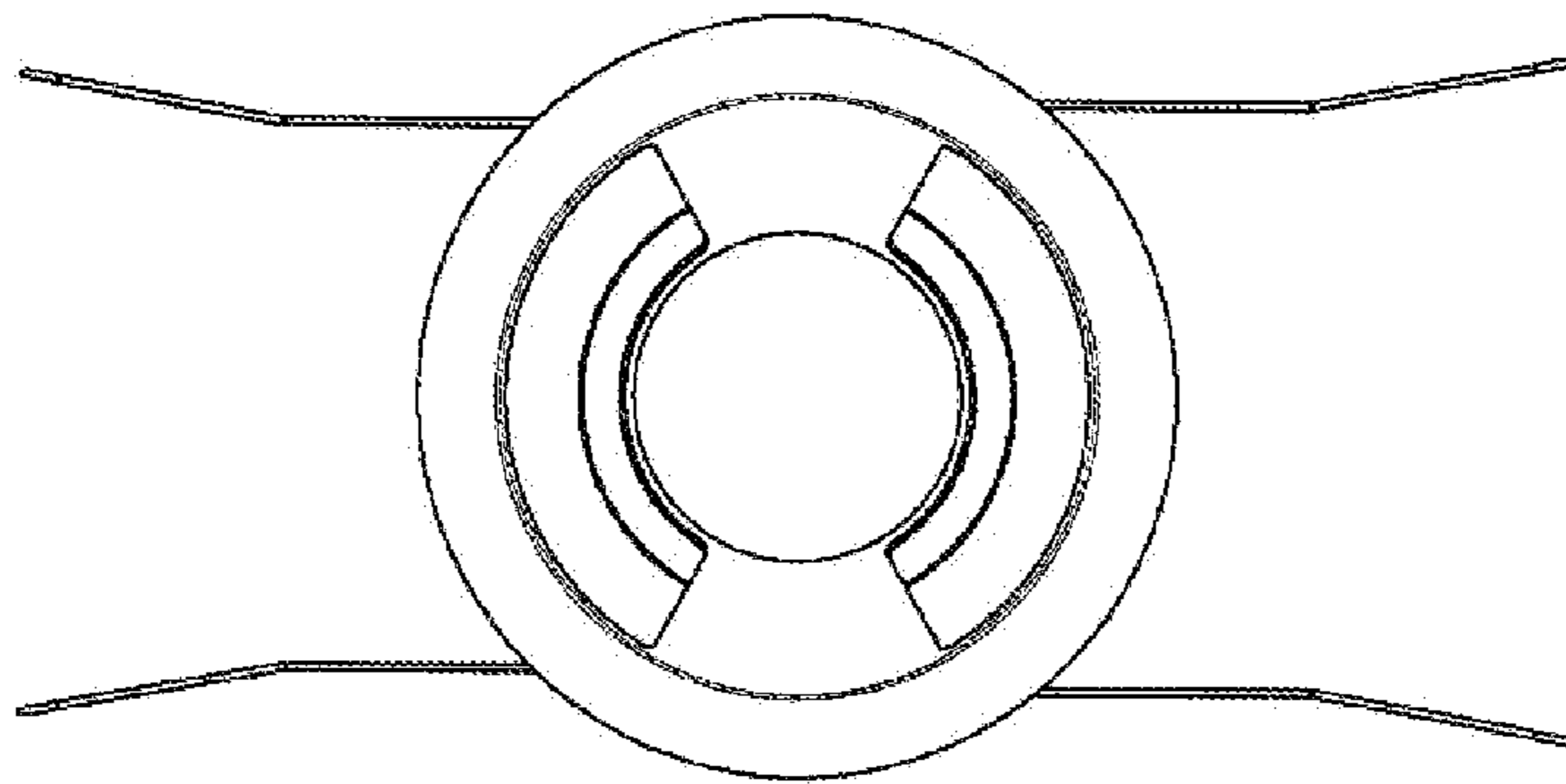

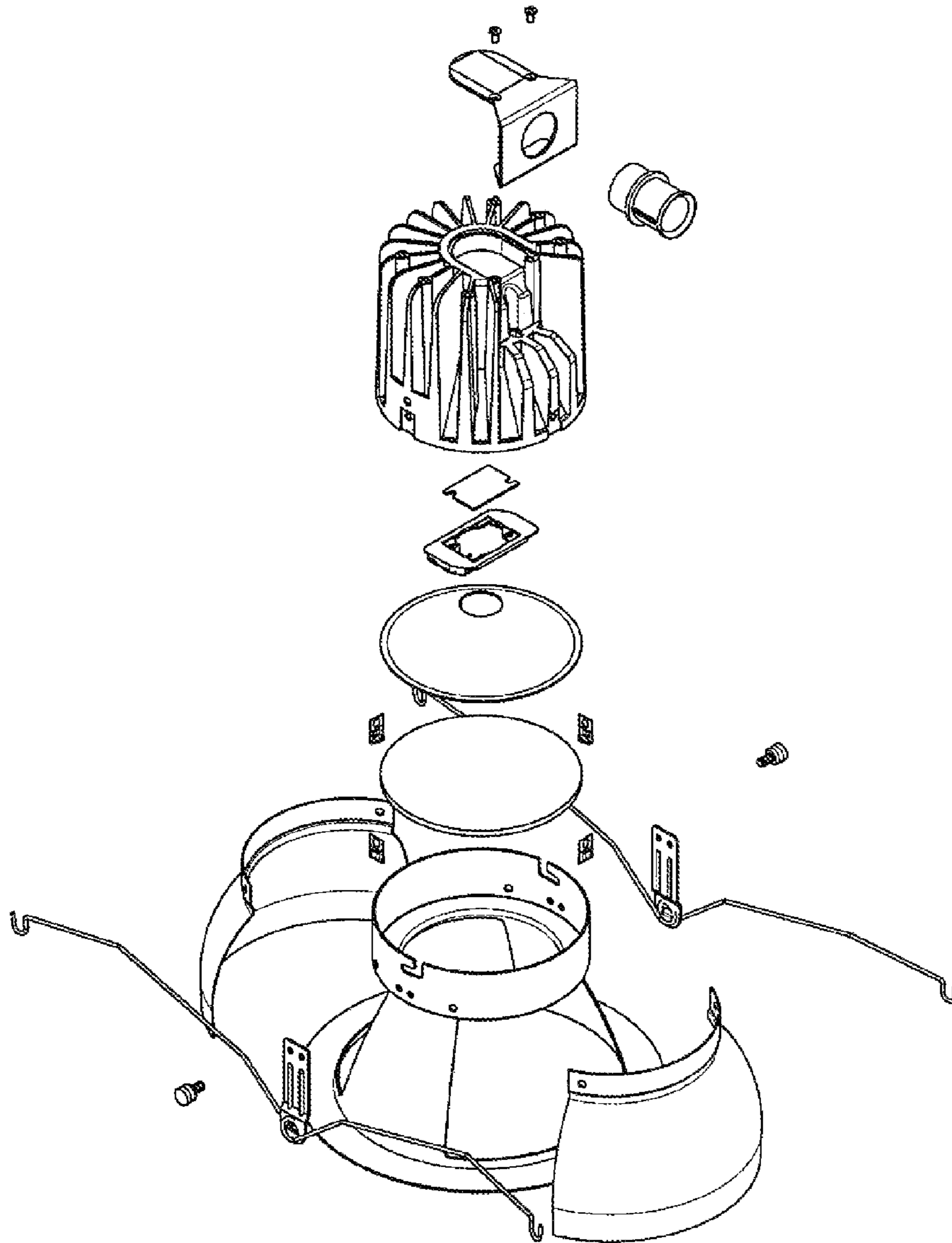

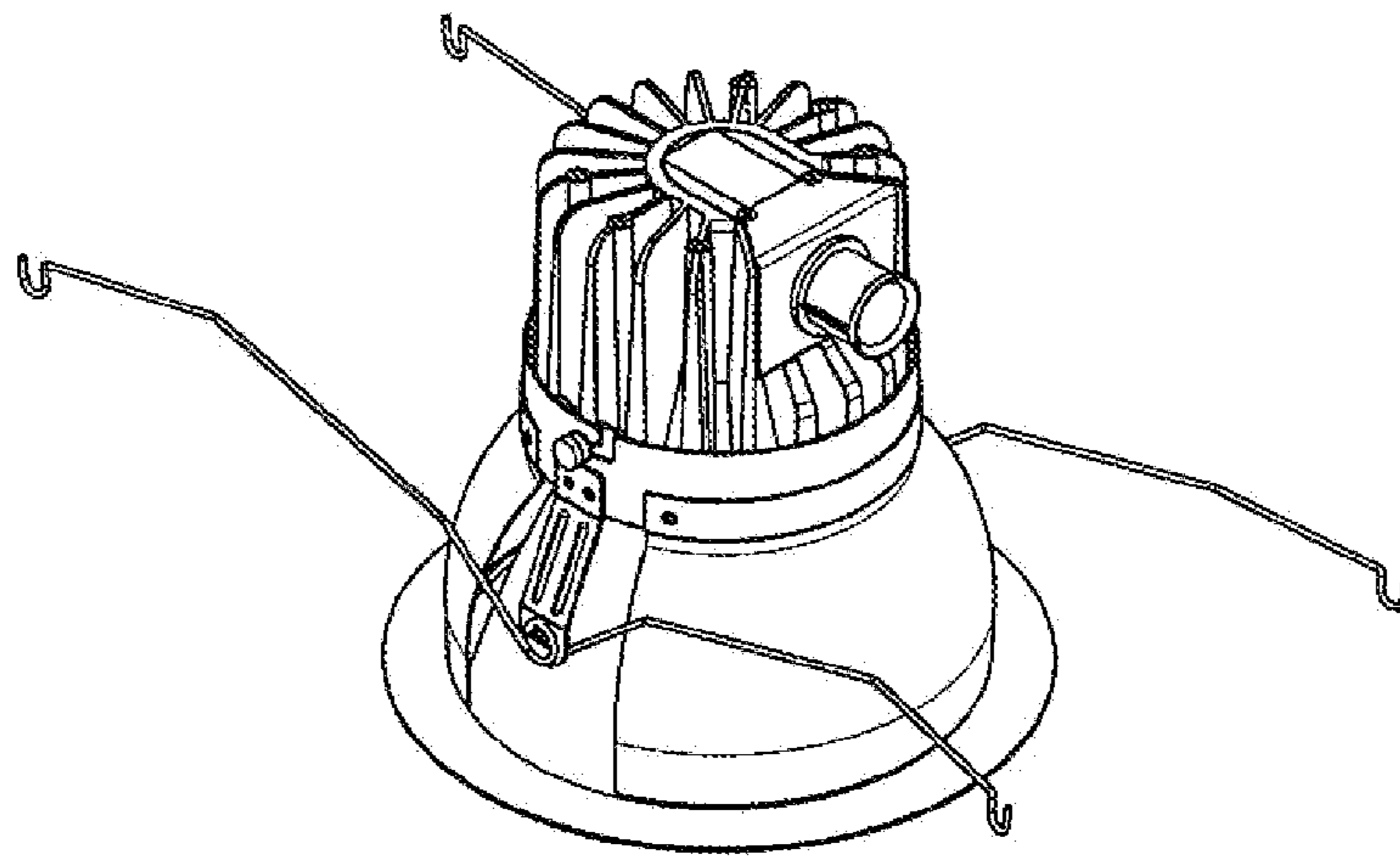

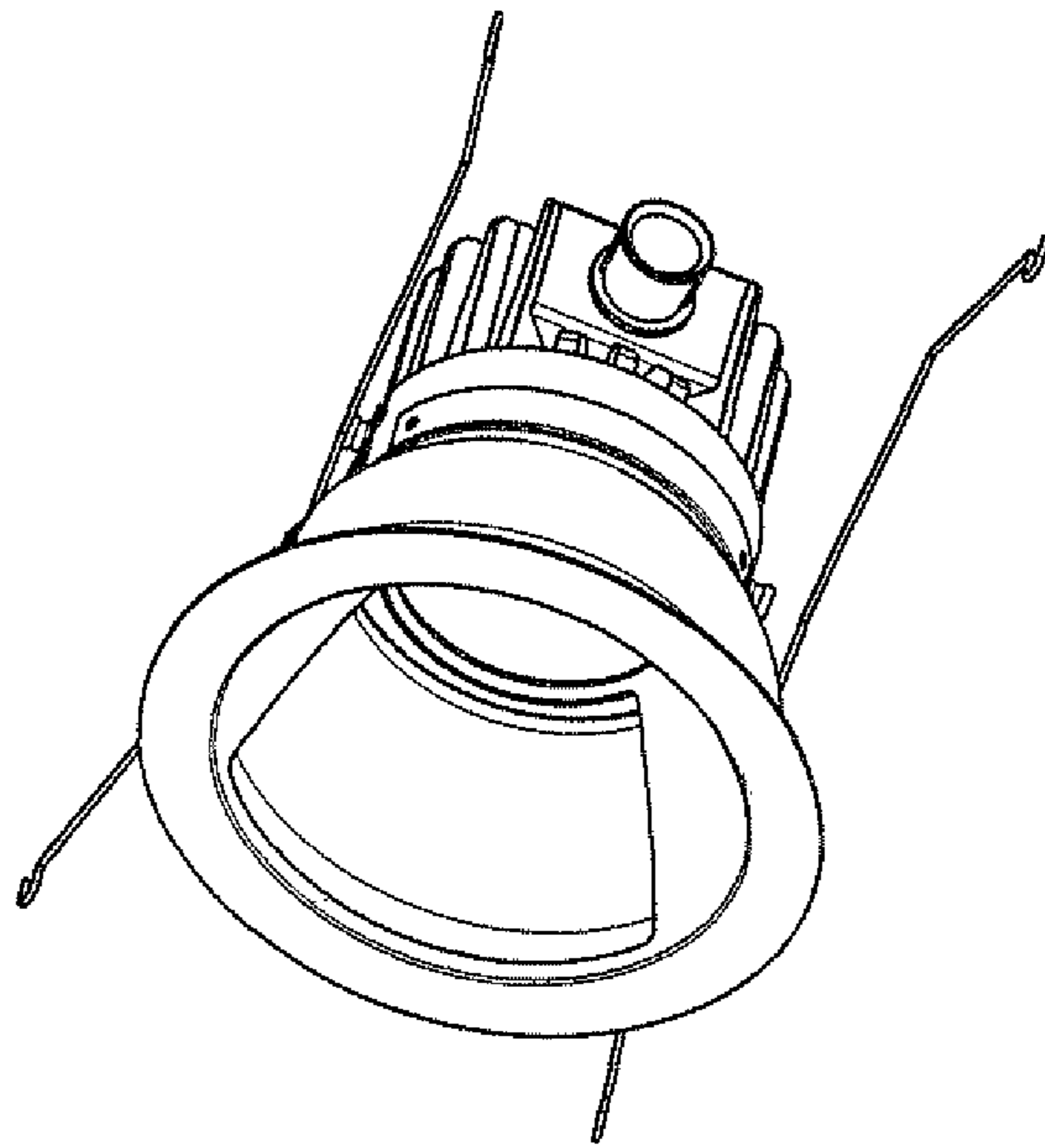

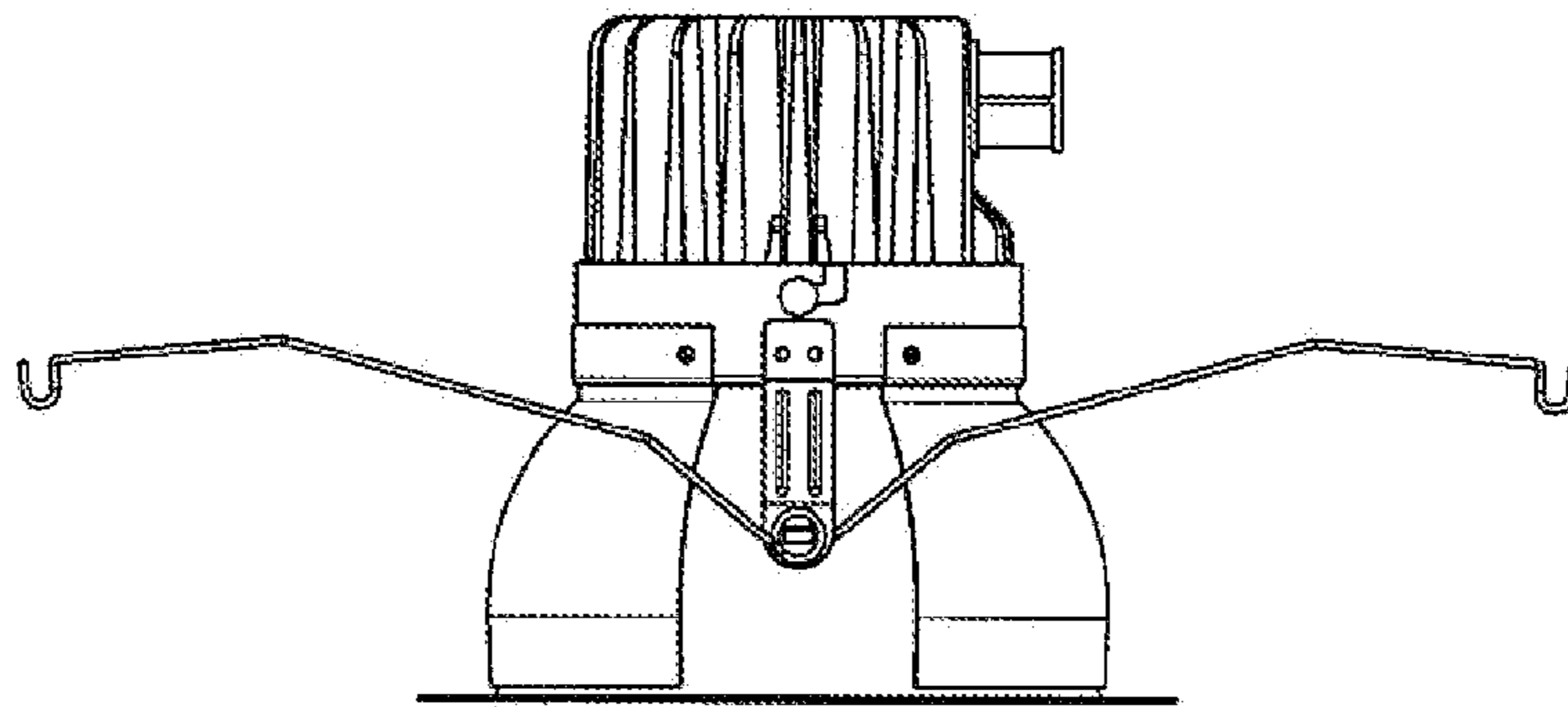

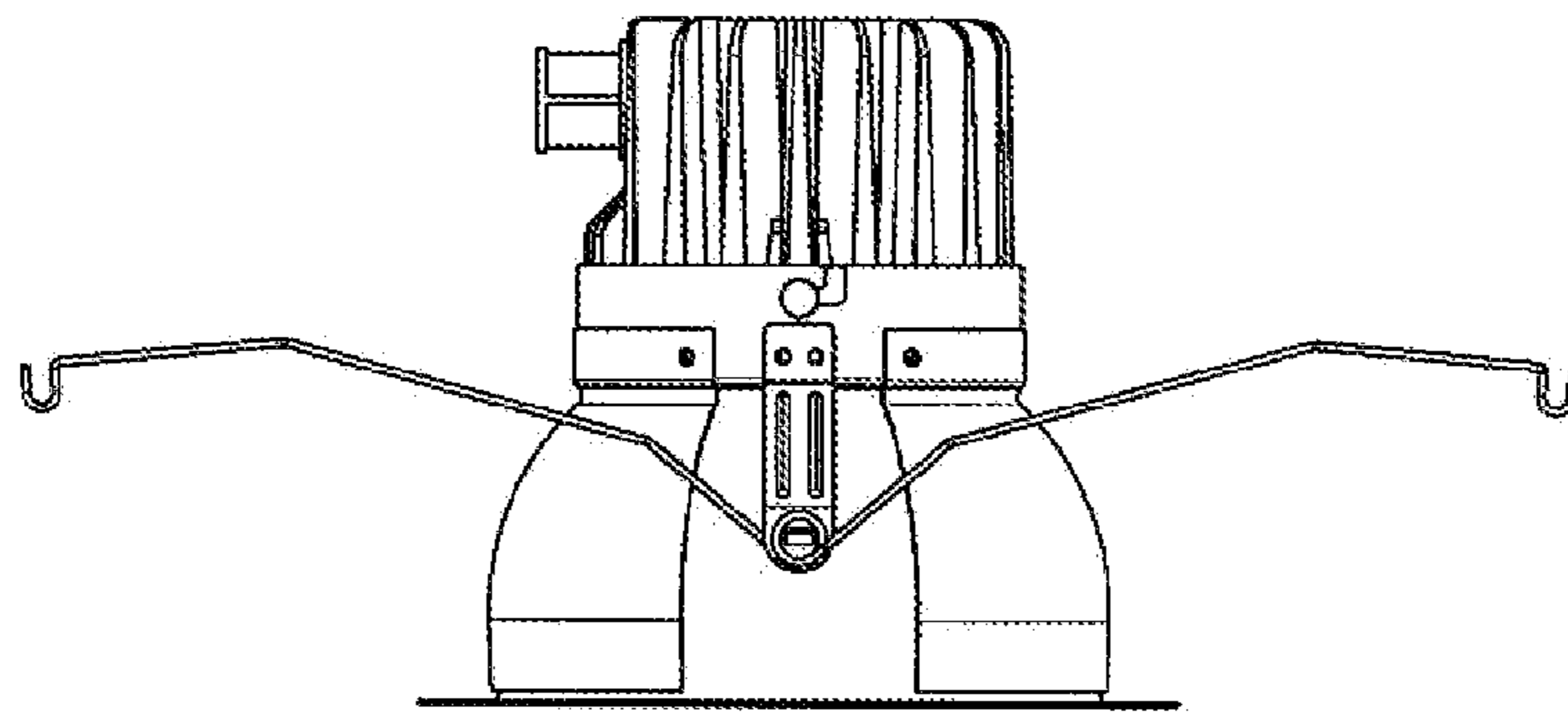

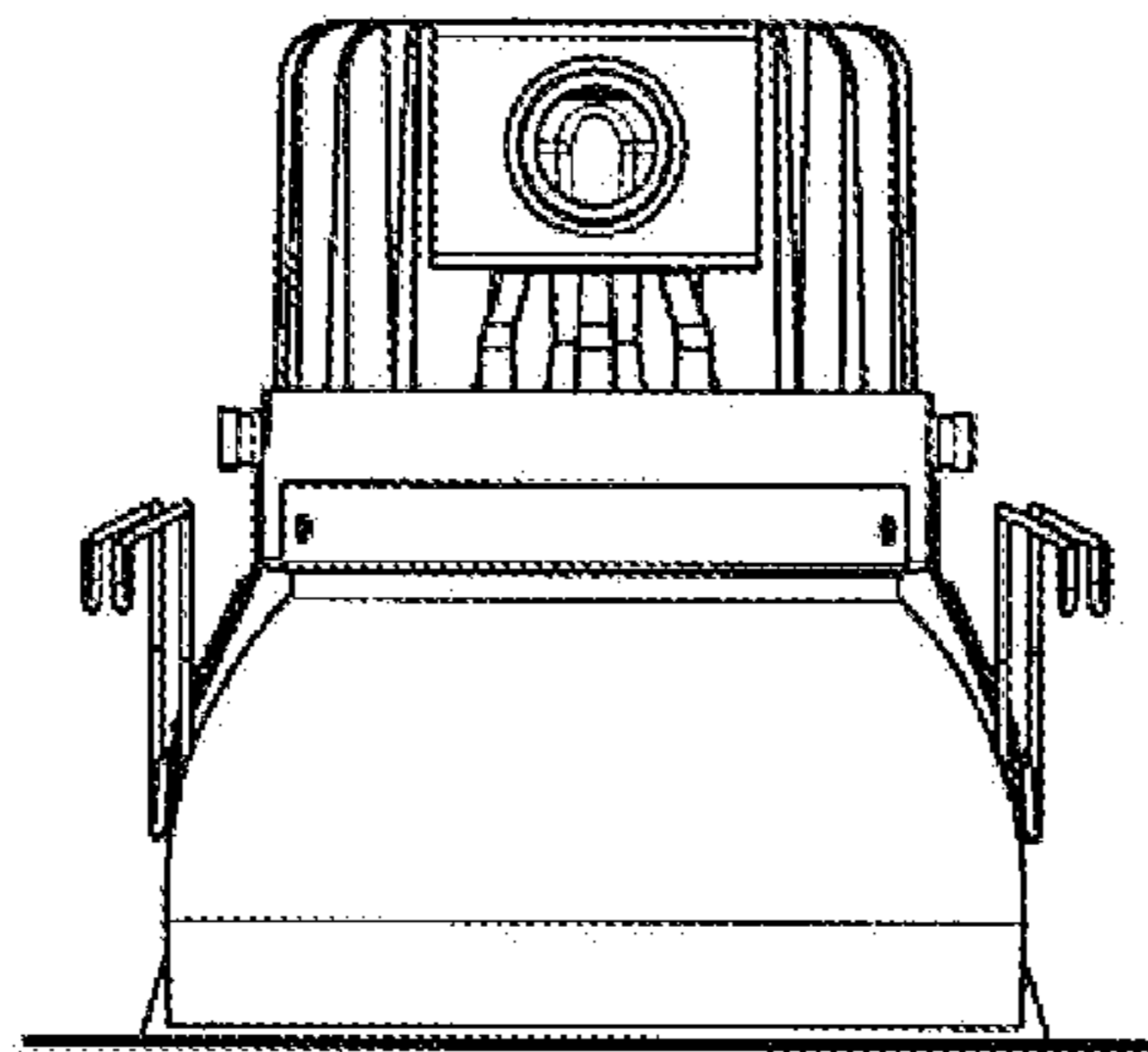

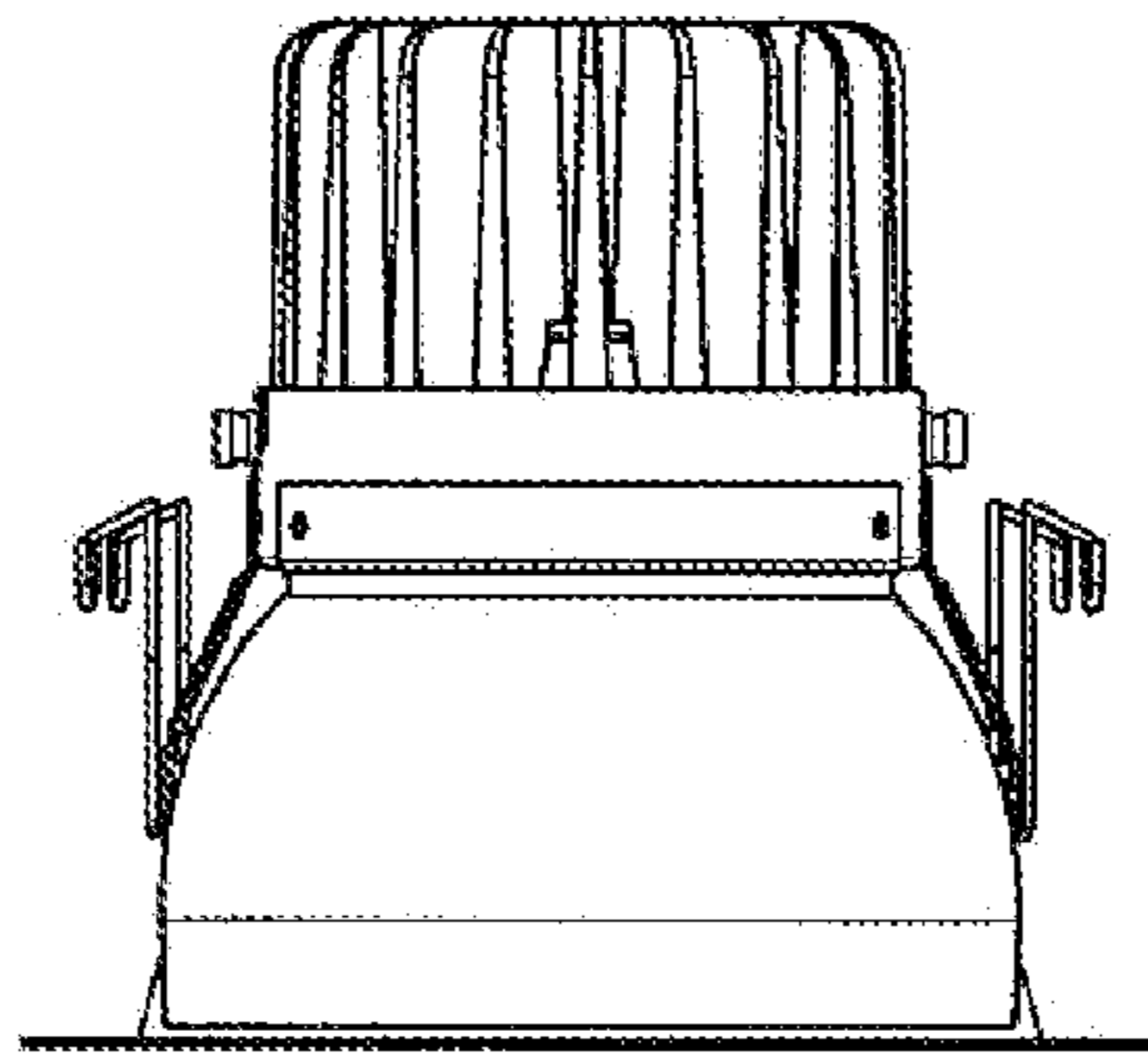

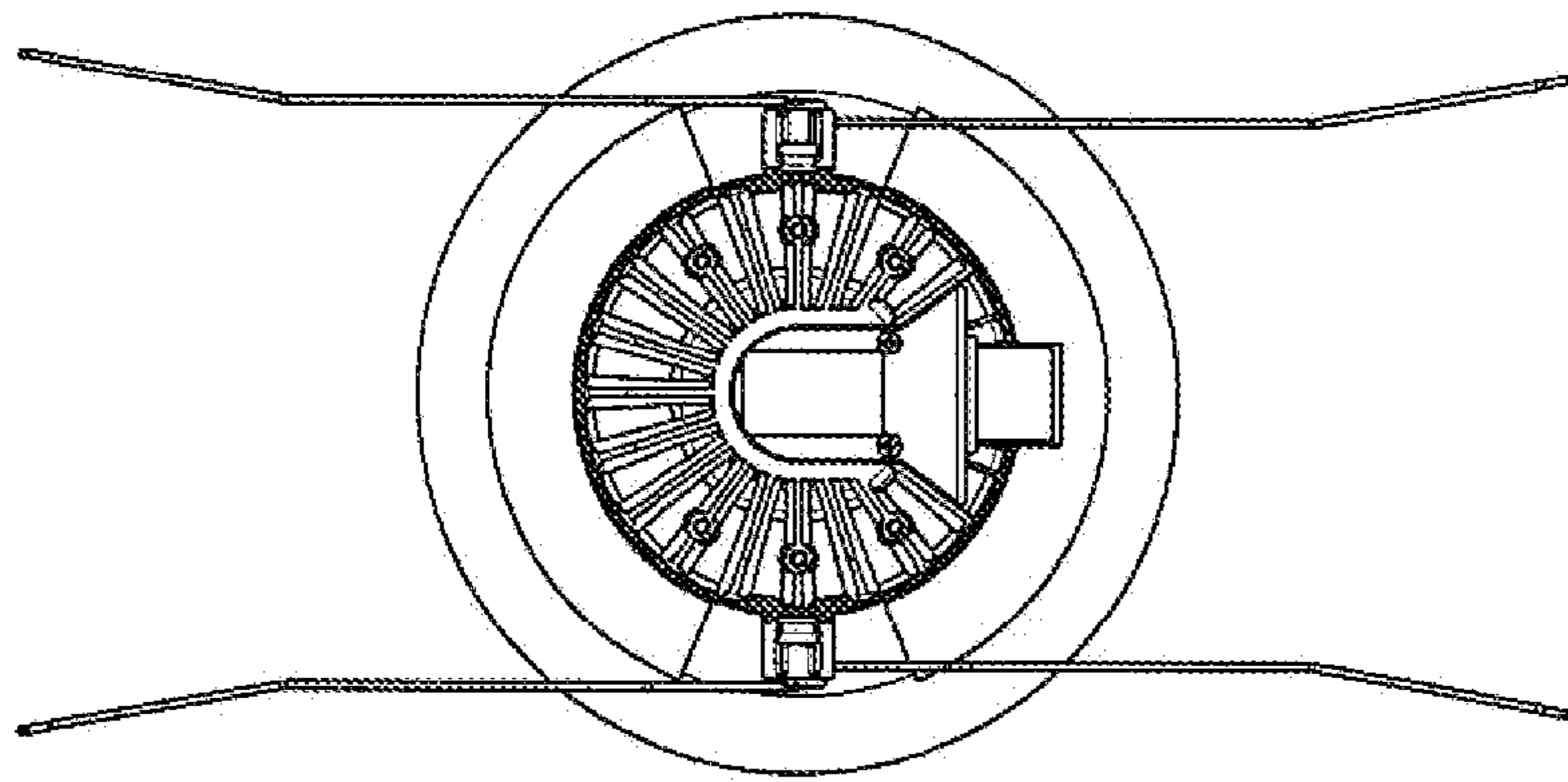

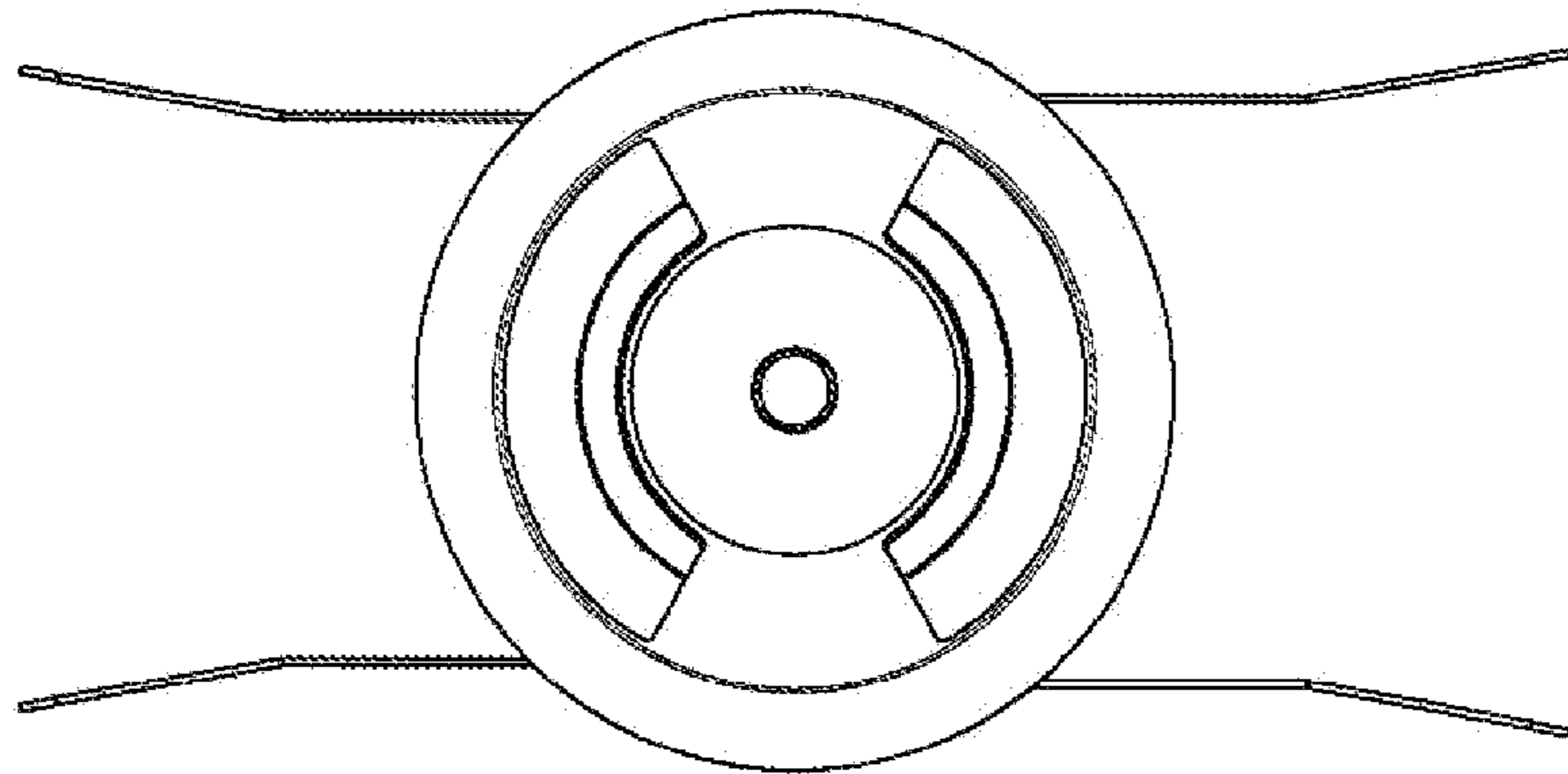

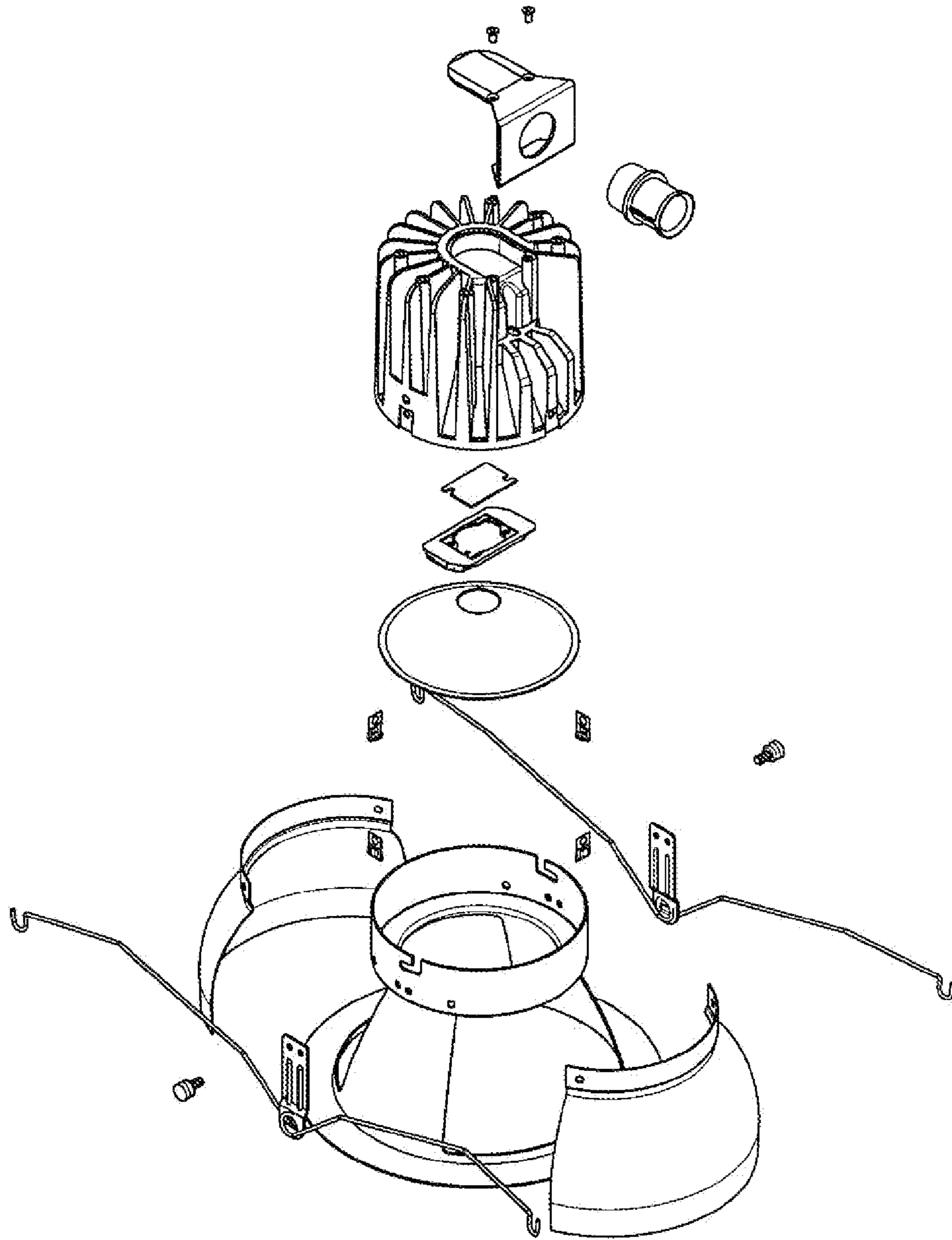
