(57) **CLAIM**

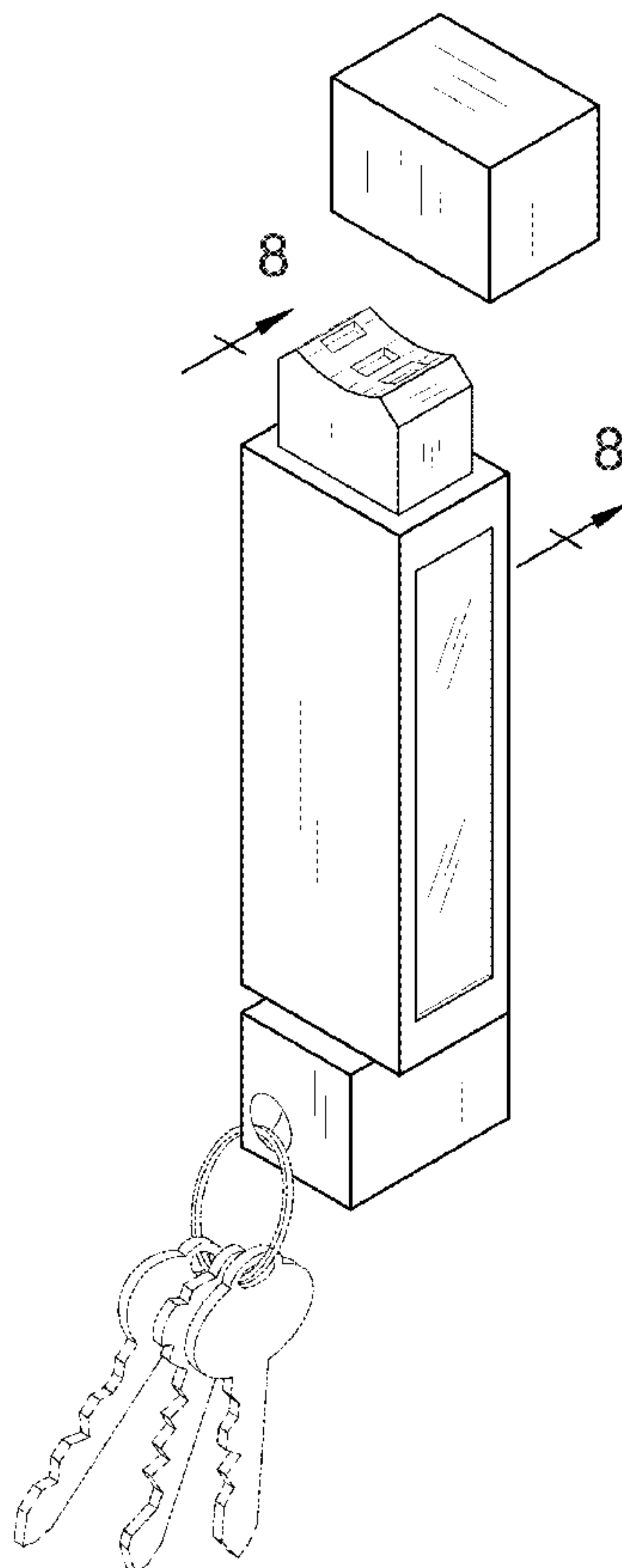
The ornamental design for a lip gloss dispenser, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a lip gloss dispenser showing my new design showing a lid separated for clarity; FIG. 2 is a rear elevation view thereof; FIG. 3 is a right elevation view thereof; FIG. 4 is a left elevation view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a bottom plan view thereof; FIG. 7 is an isometric view thereof; and, FIG. 8 is a cross-sectional view thereof taken along line 8-8 of FIG. 7.

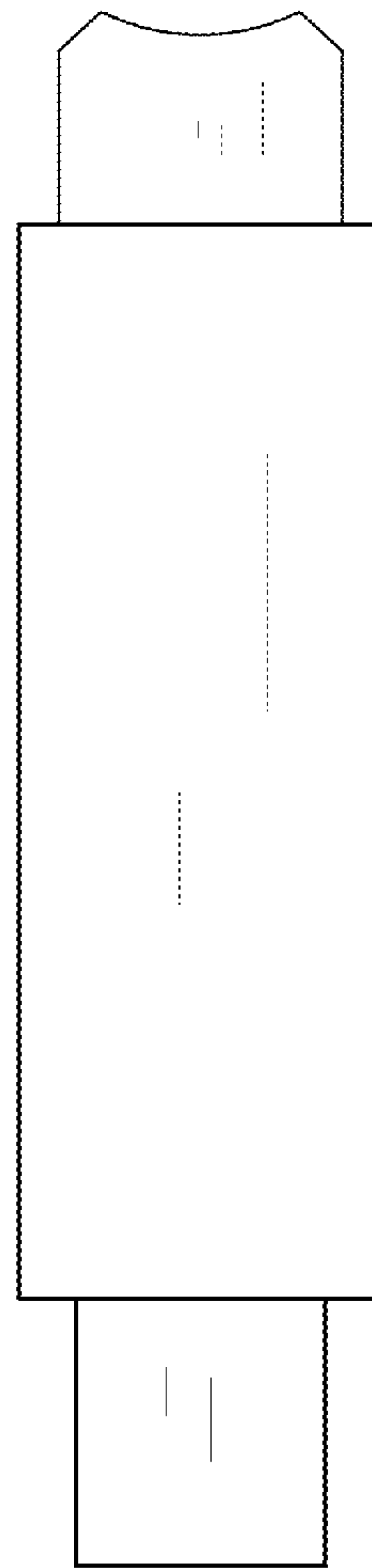
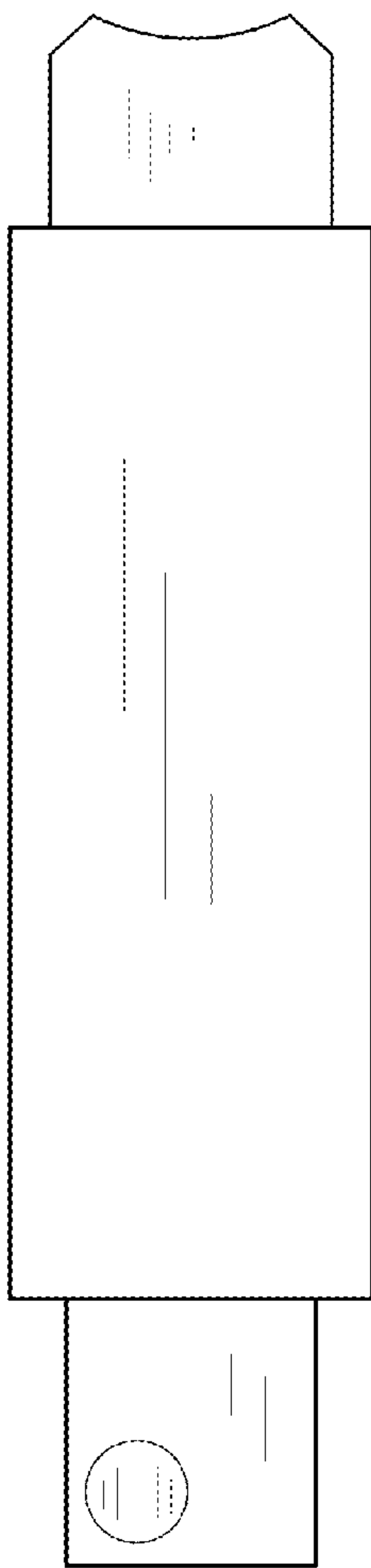
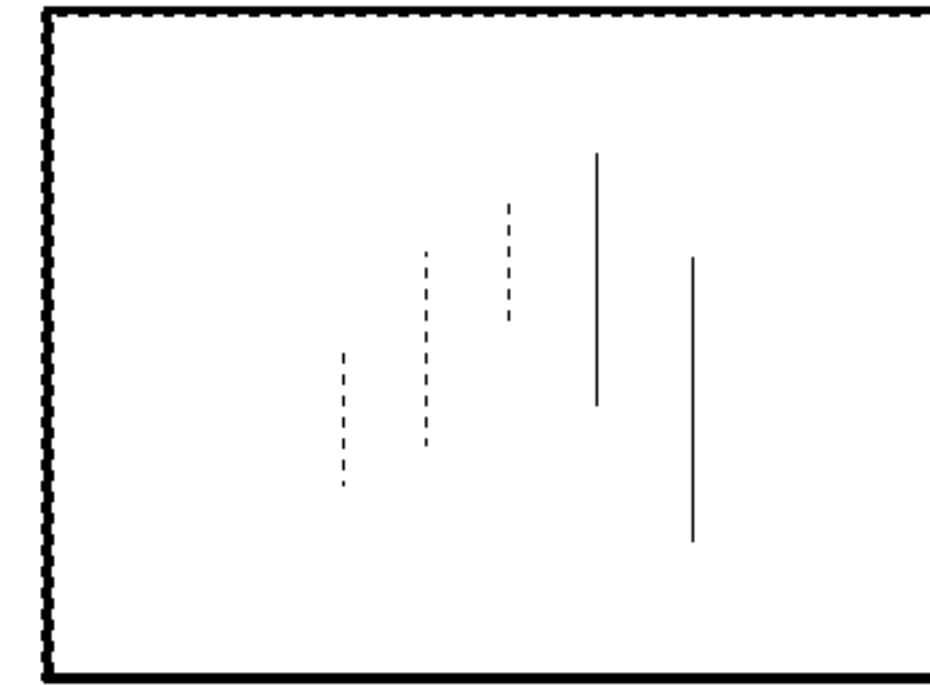
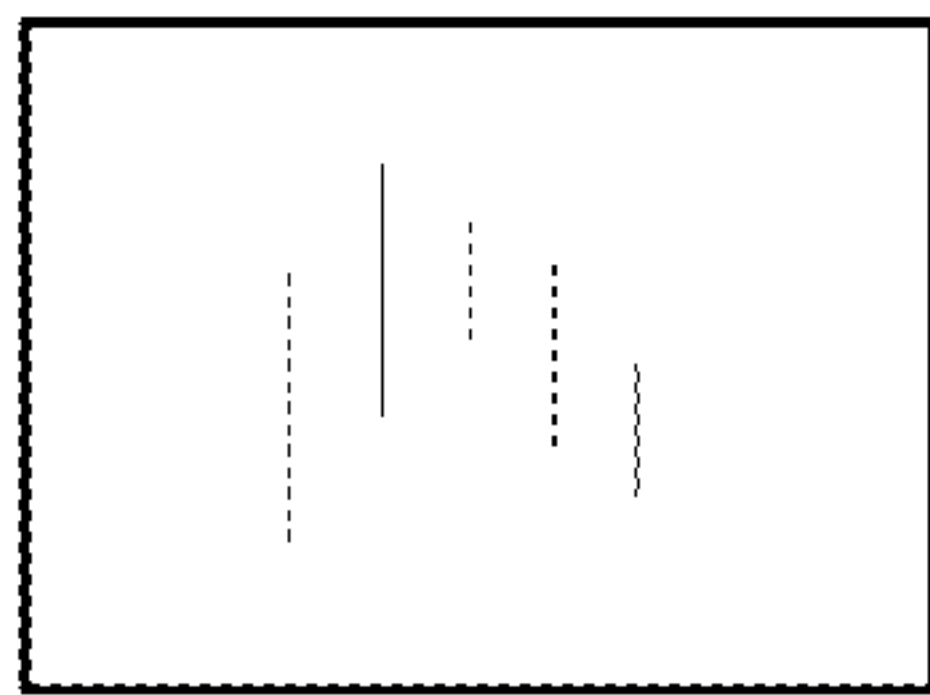

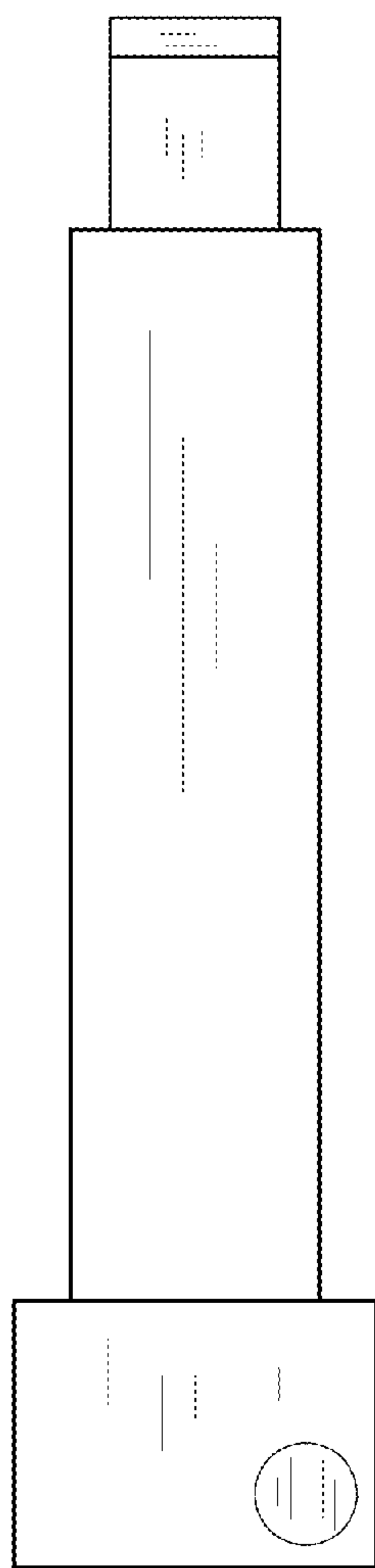
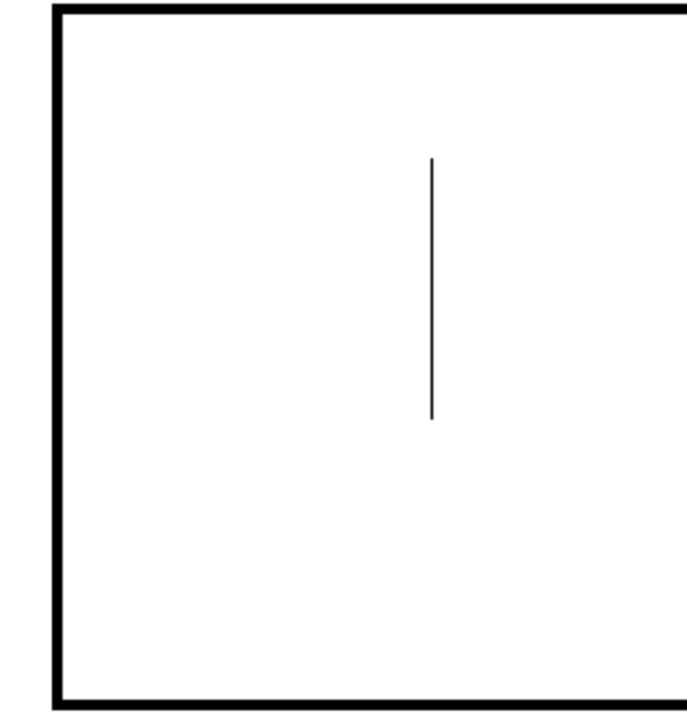
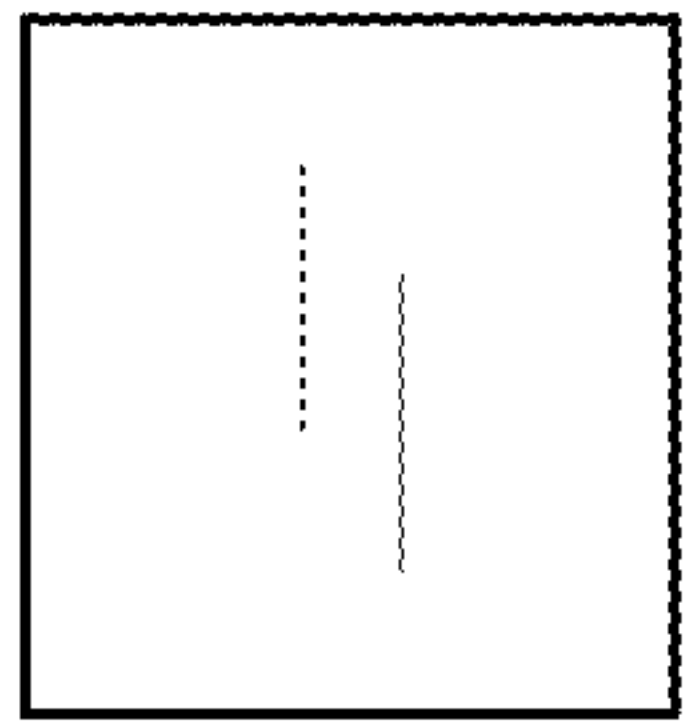

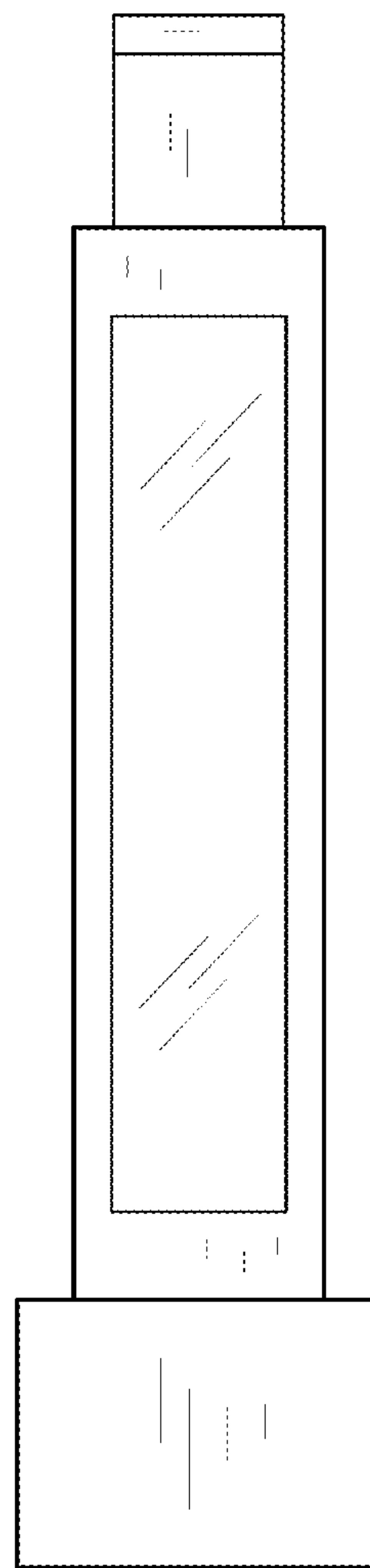

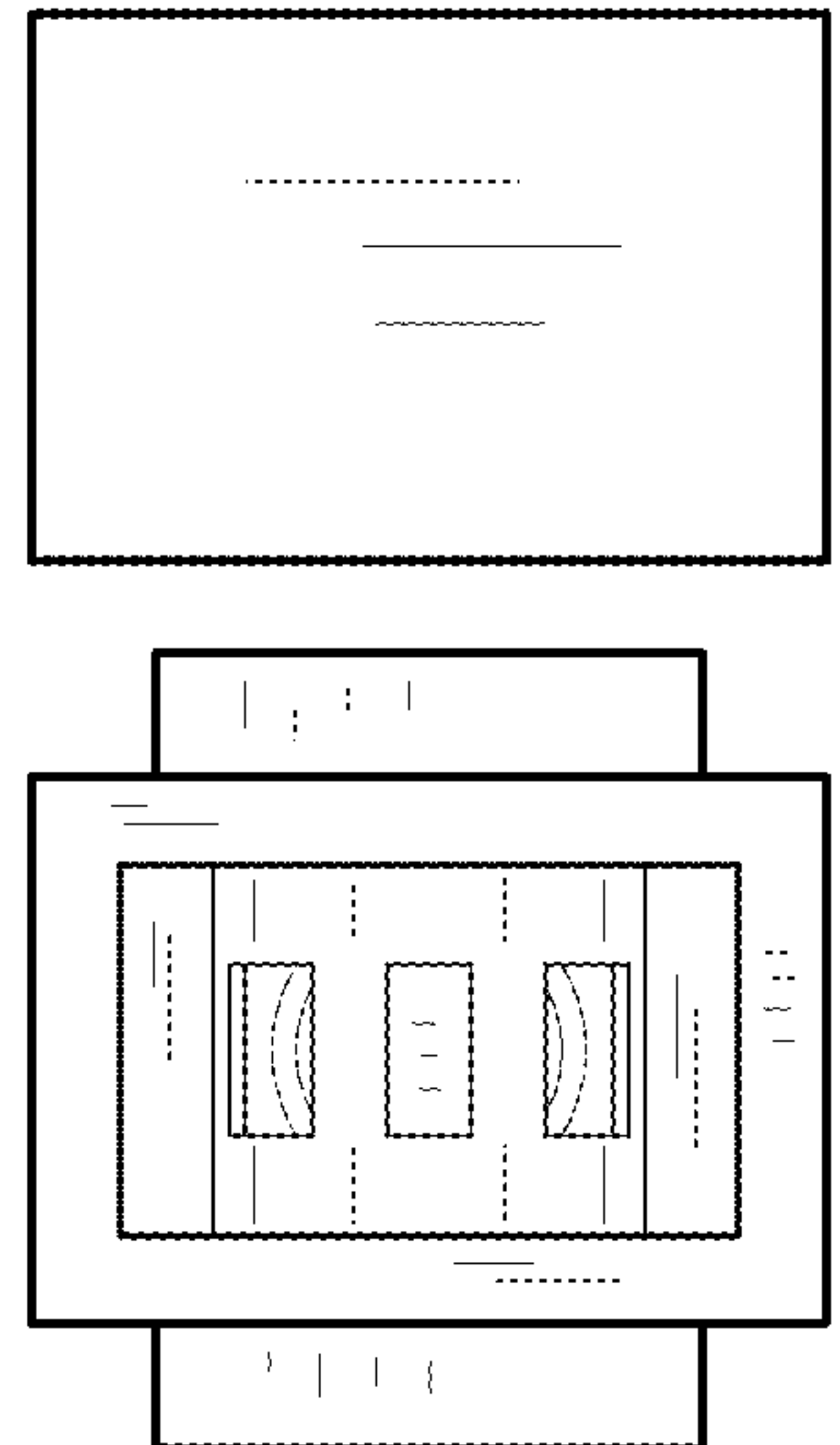
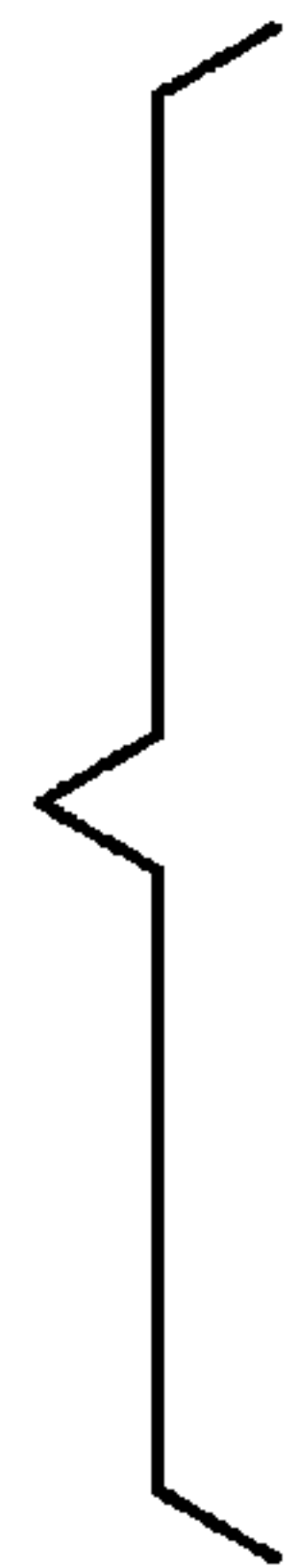
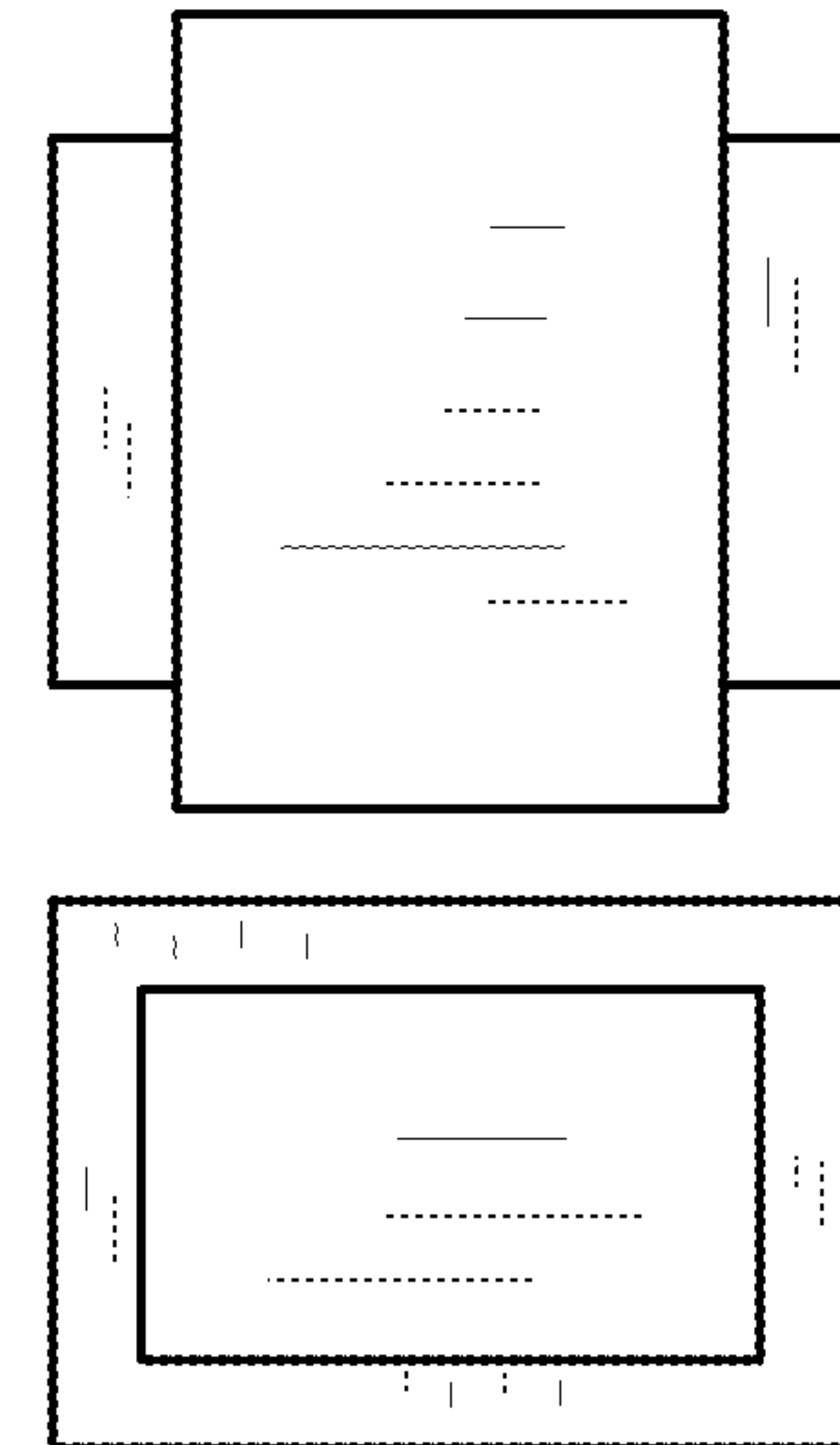
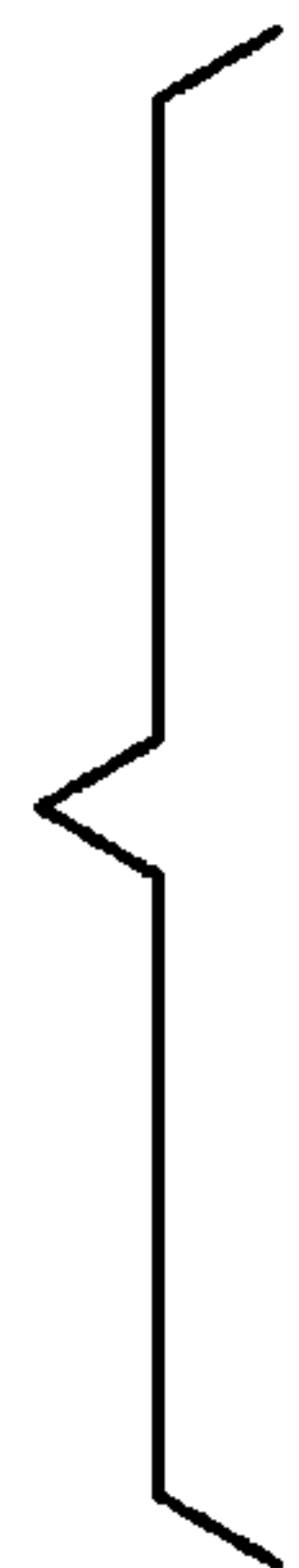
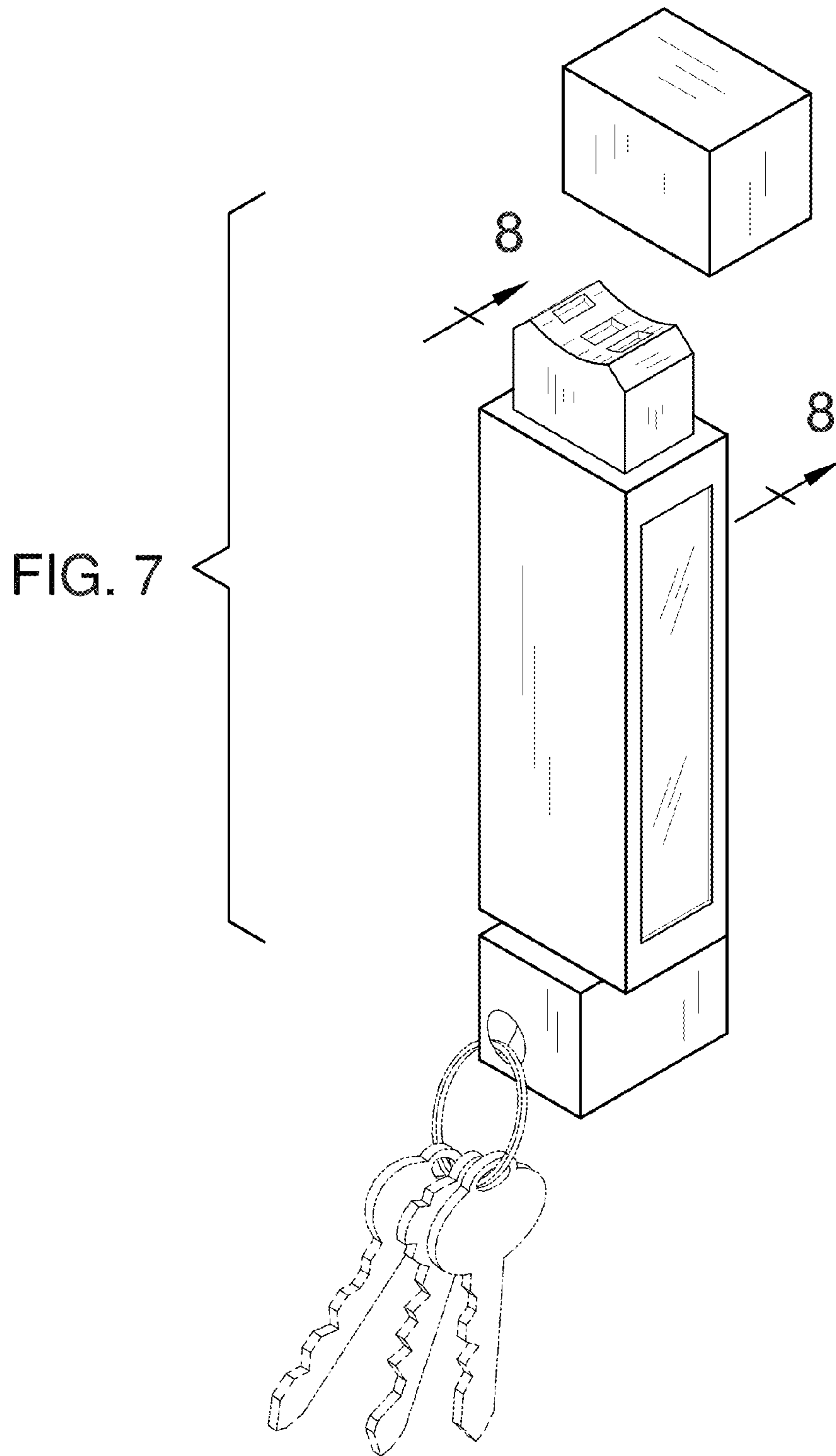

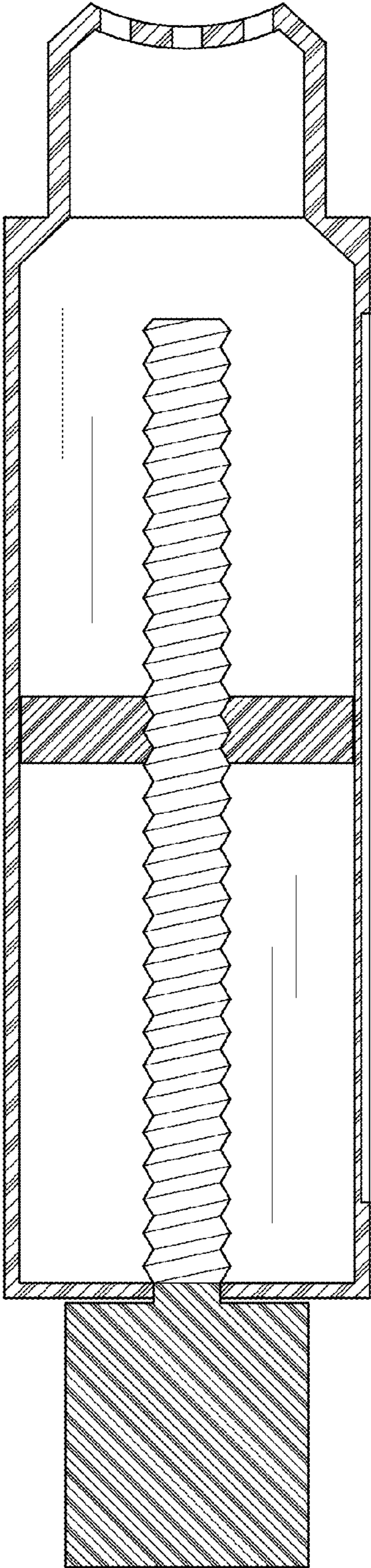
