**DESCRIPTION**

FIG. 1 is a perspective view of a flip visor showing my new design;

FIG. 5 is a bottom plan view of FIG. 1;

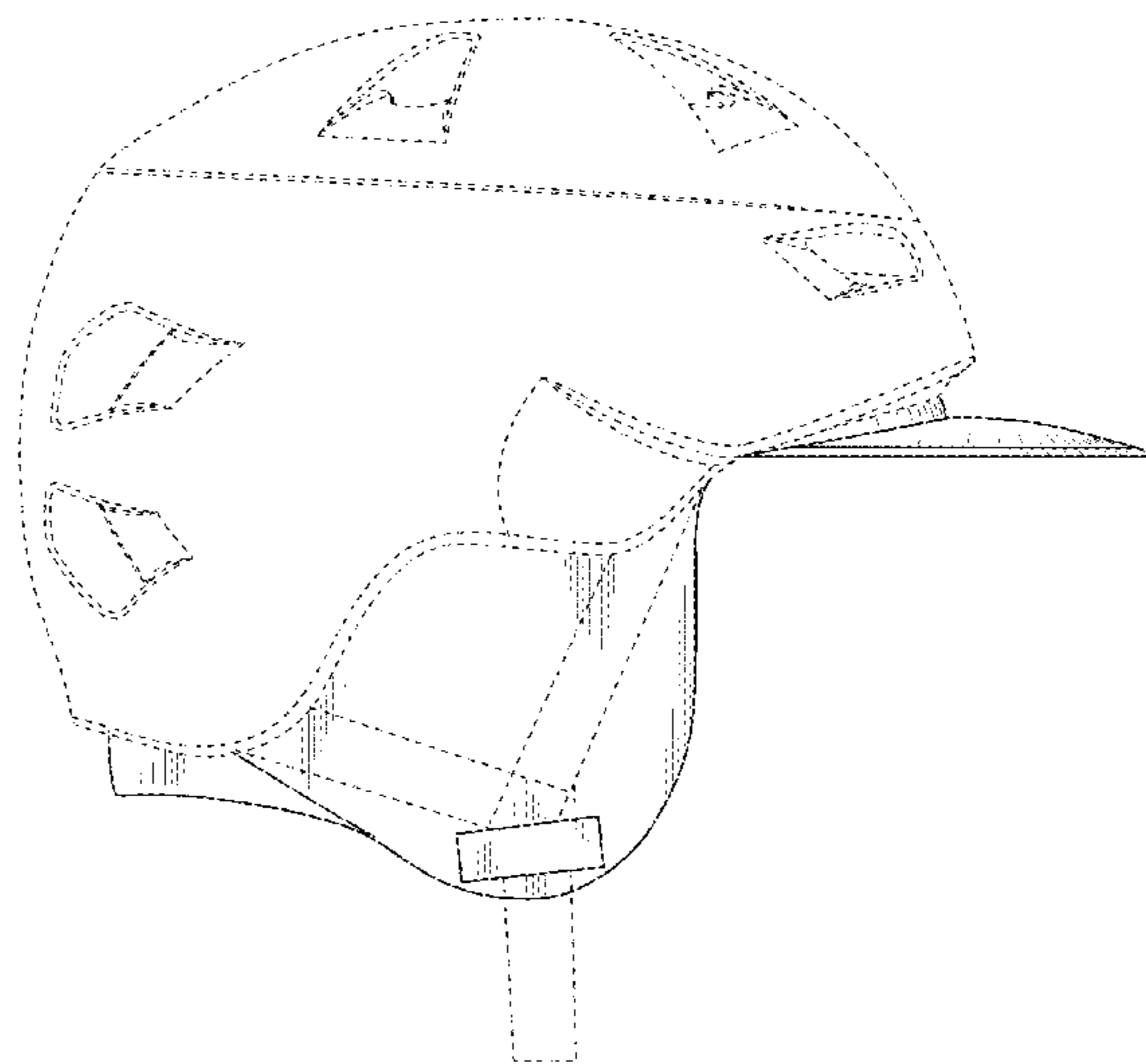
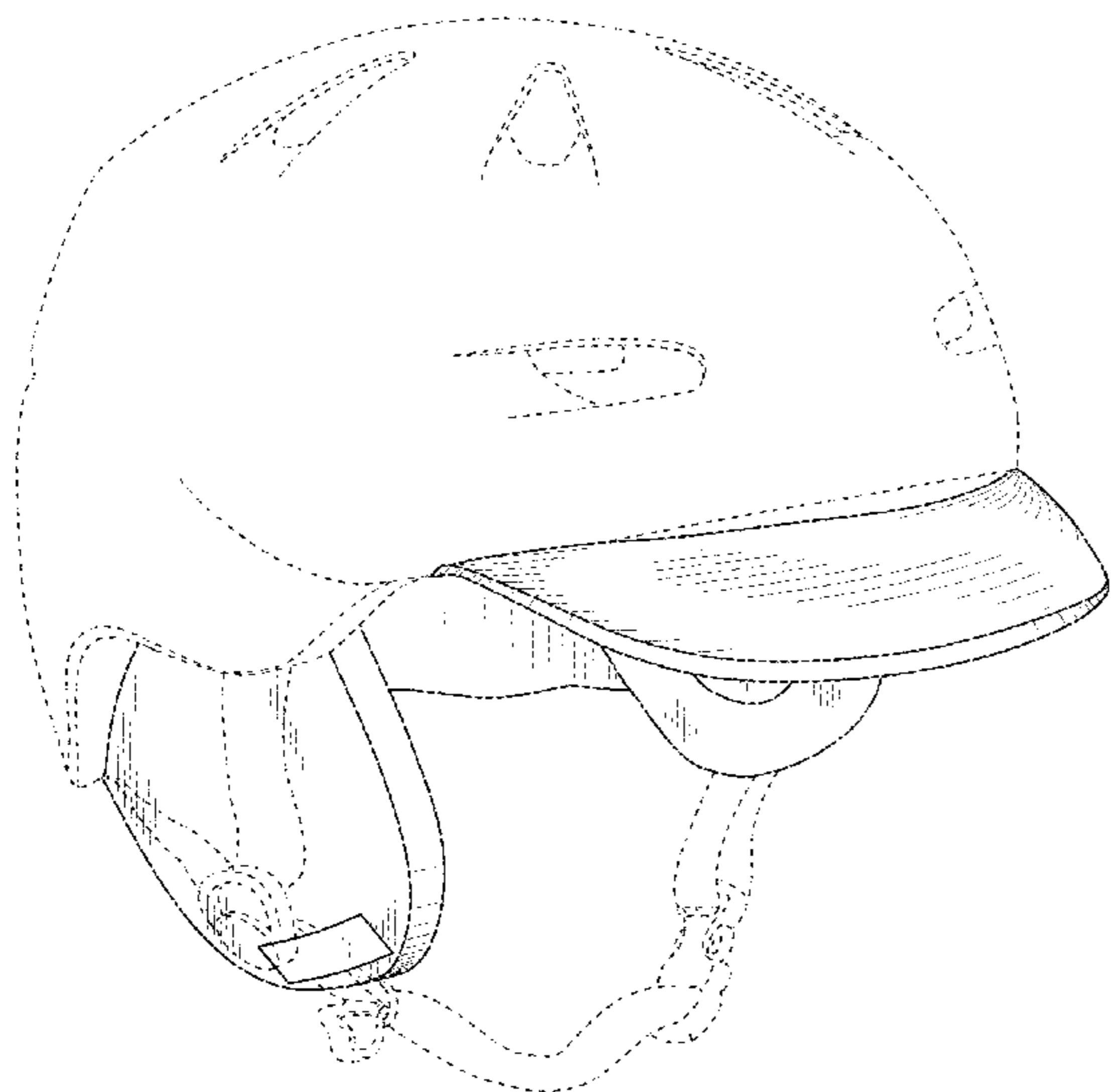
FIG. 6 is a bottom plan view of FIG. 2;

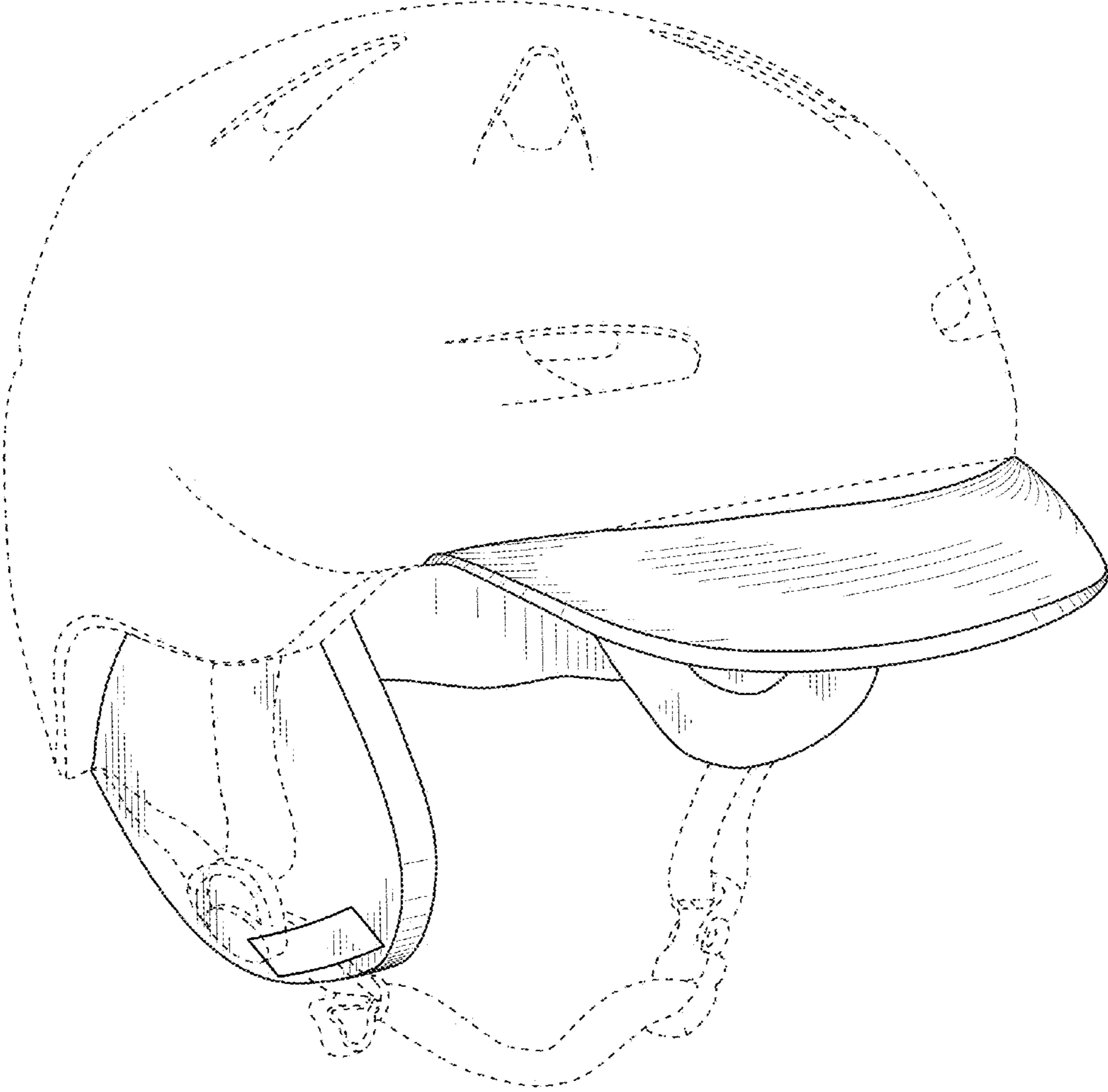

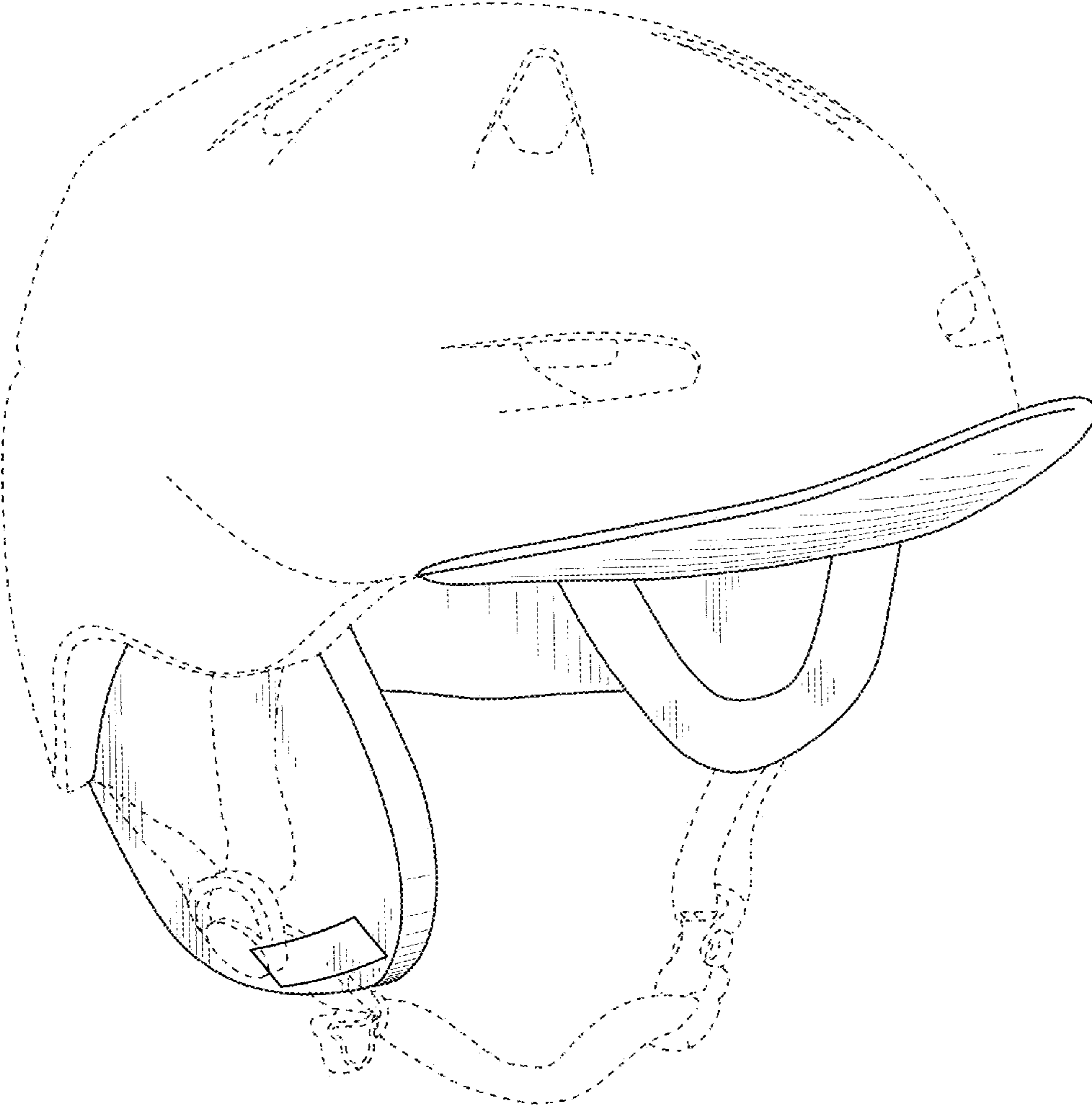

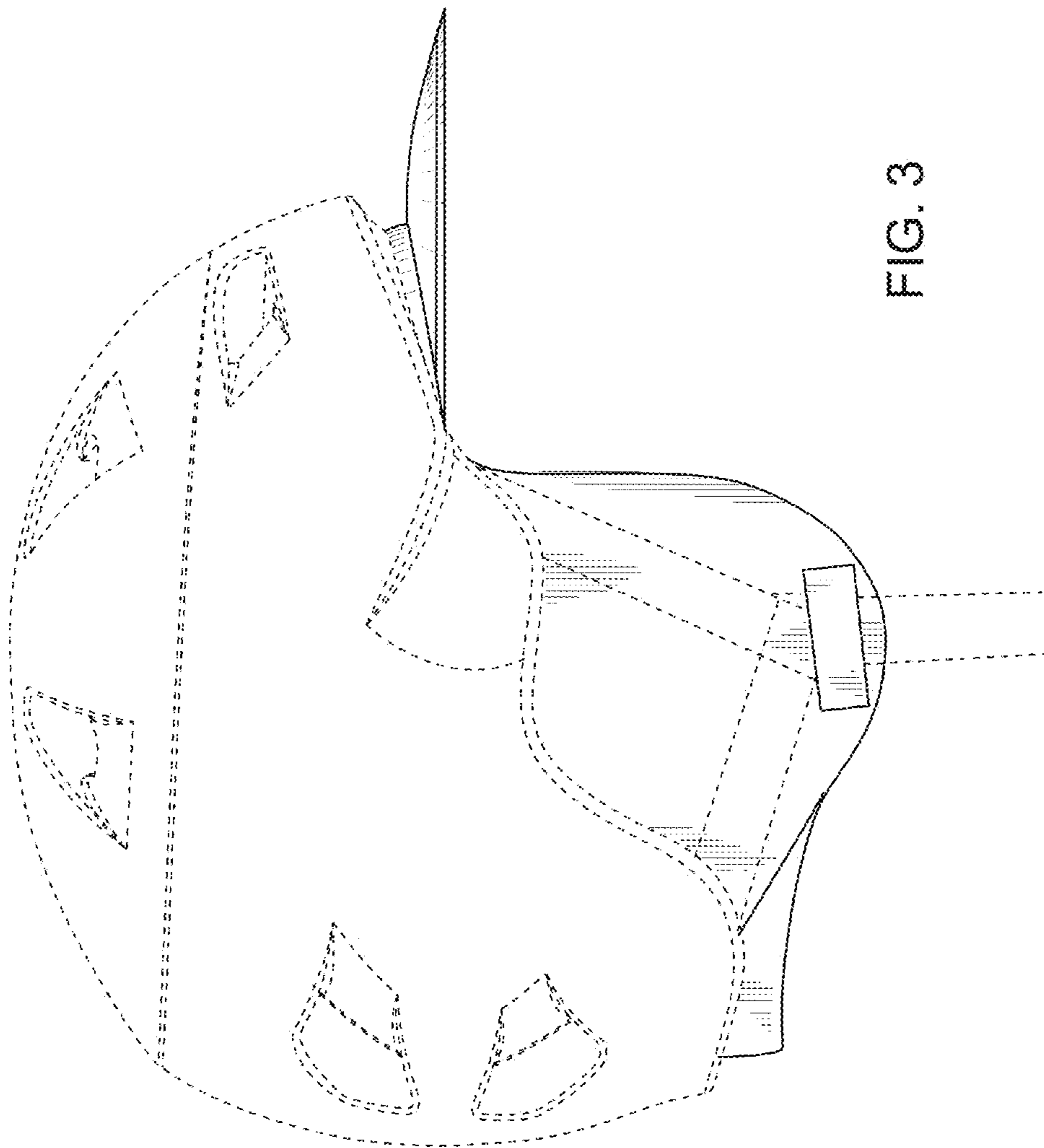

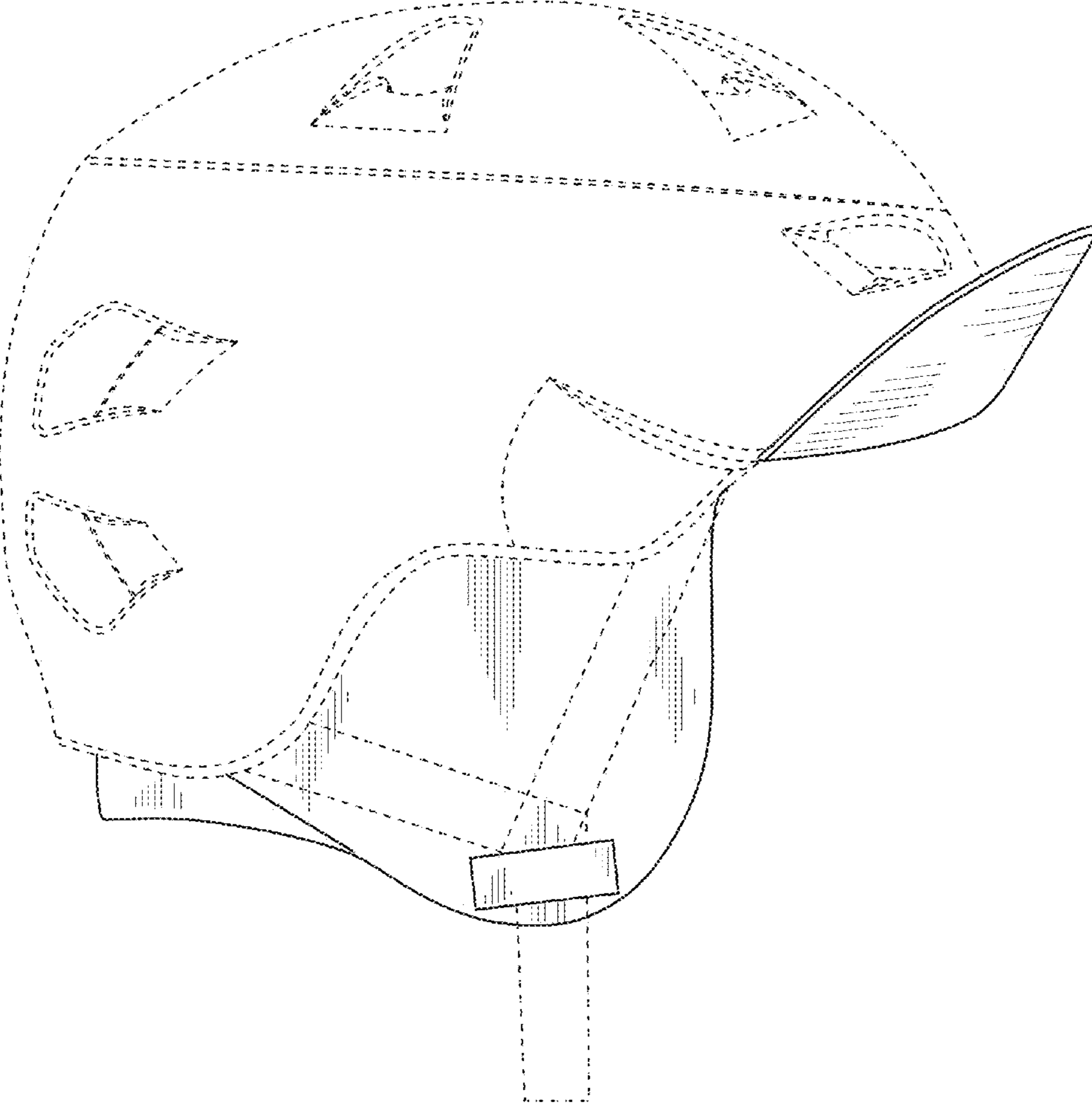

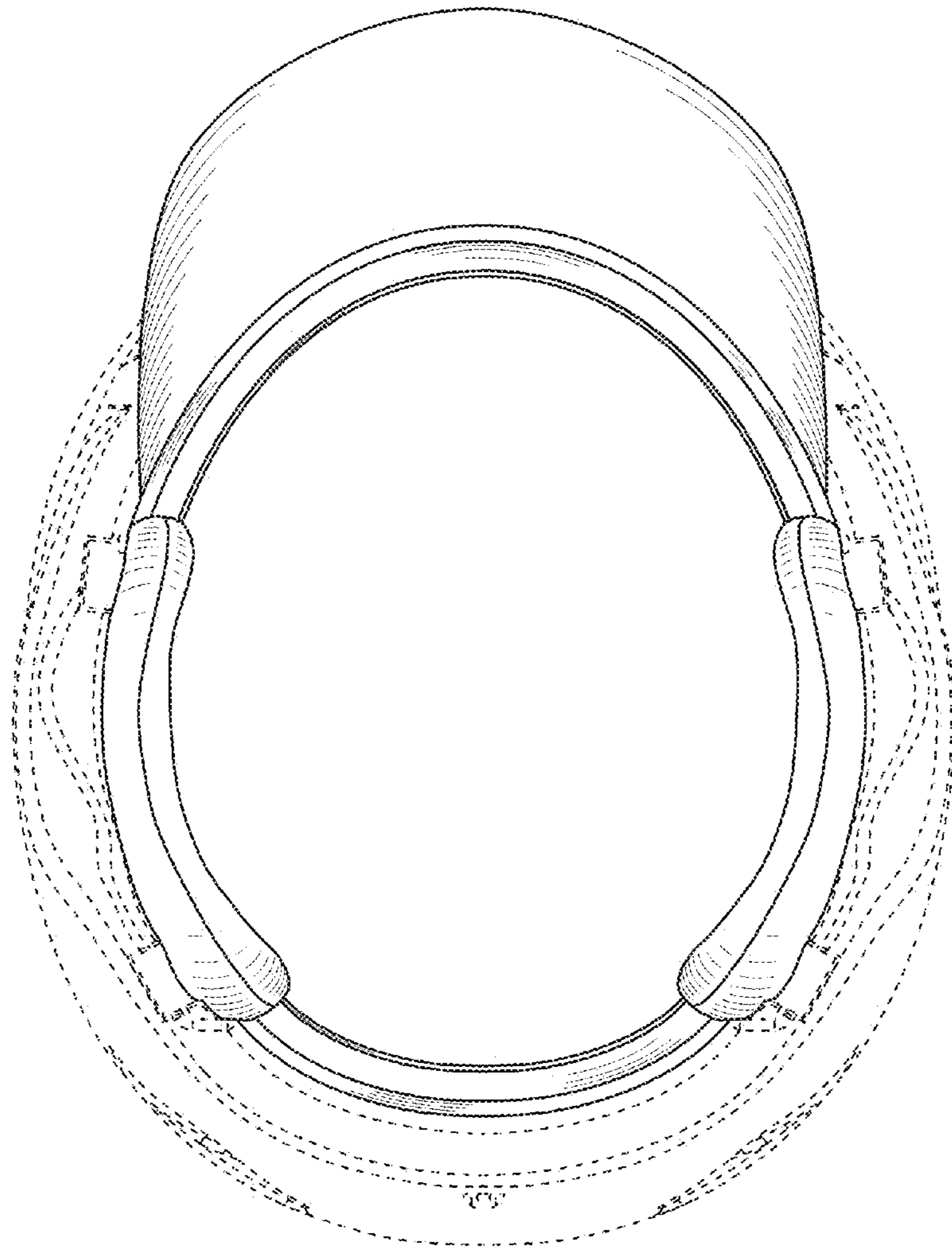

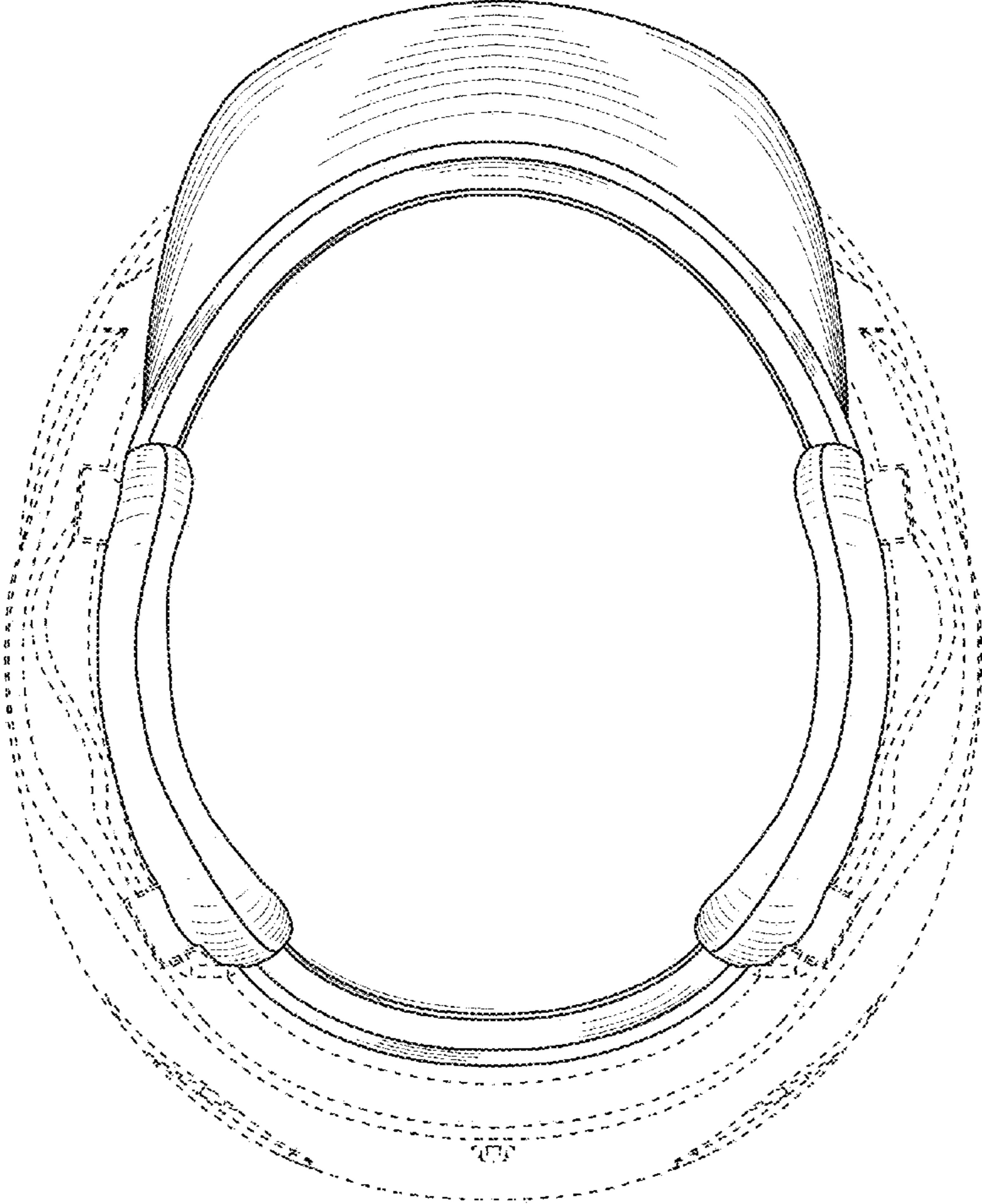

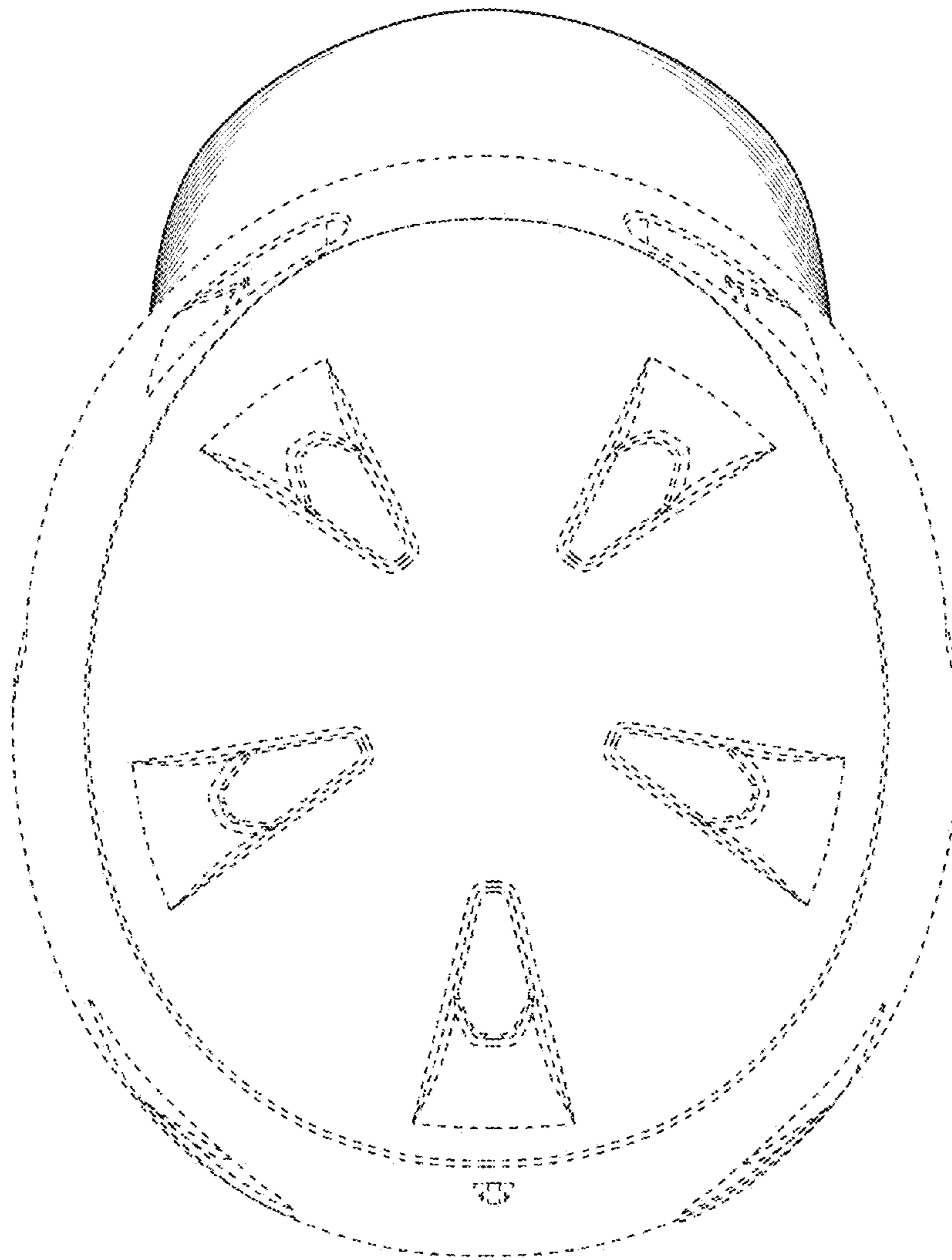

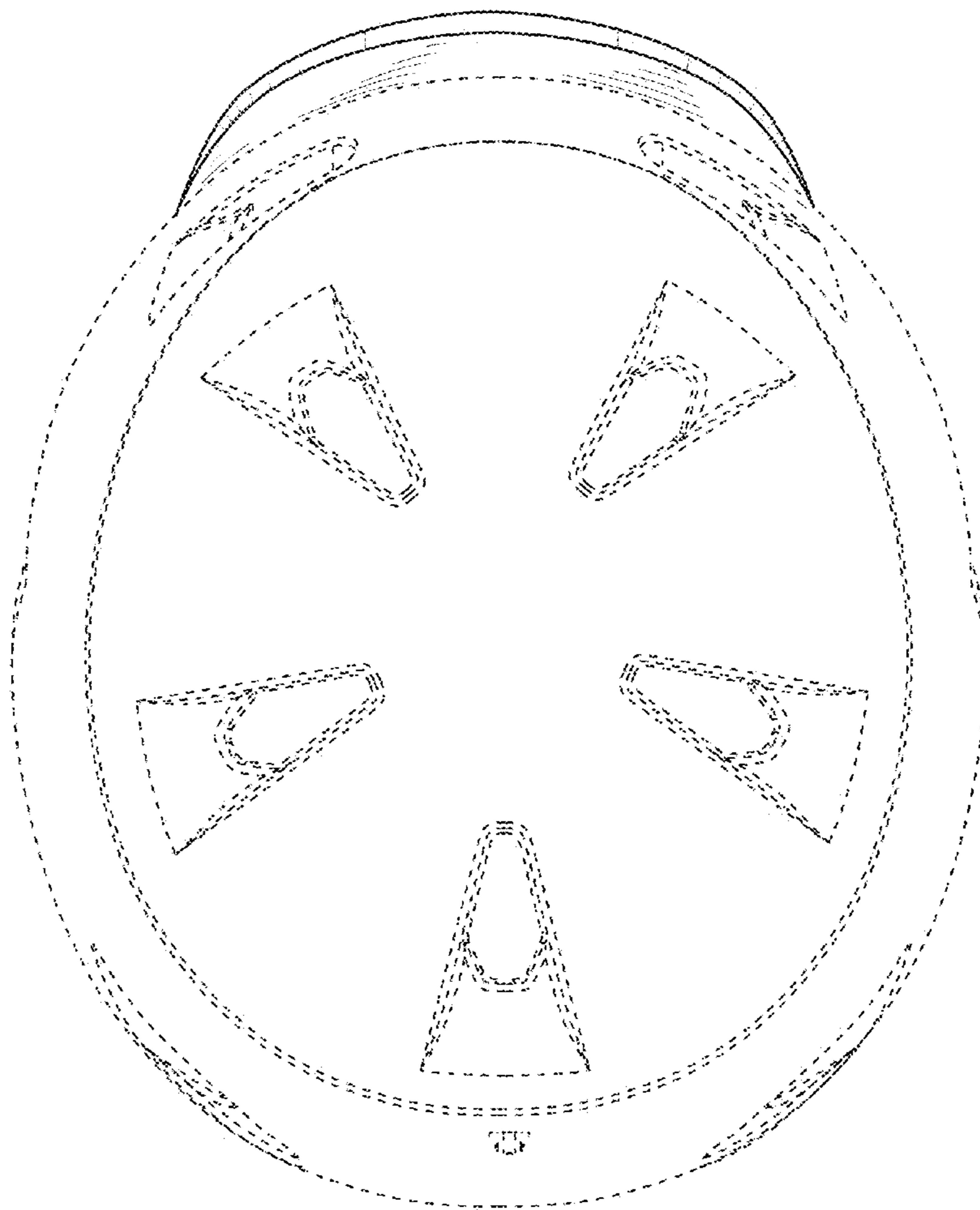
