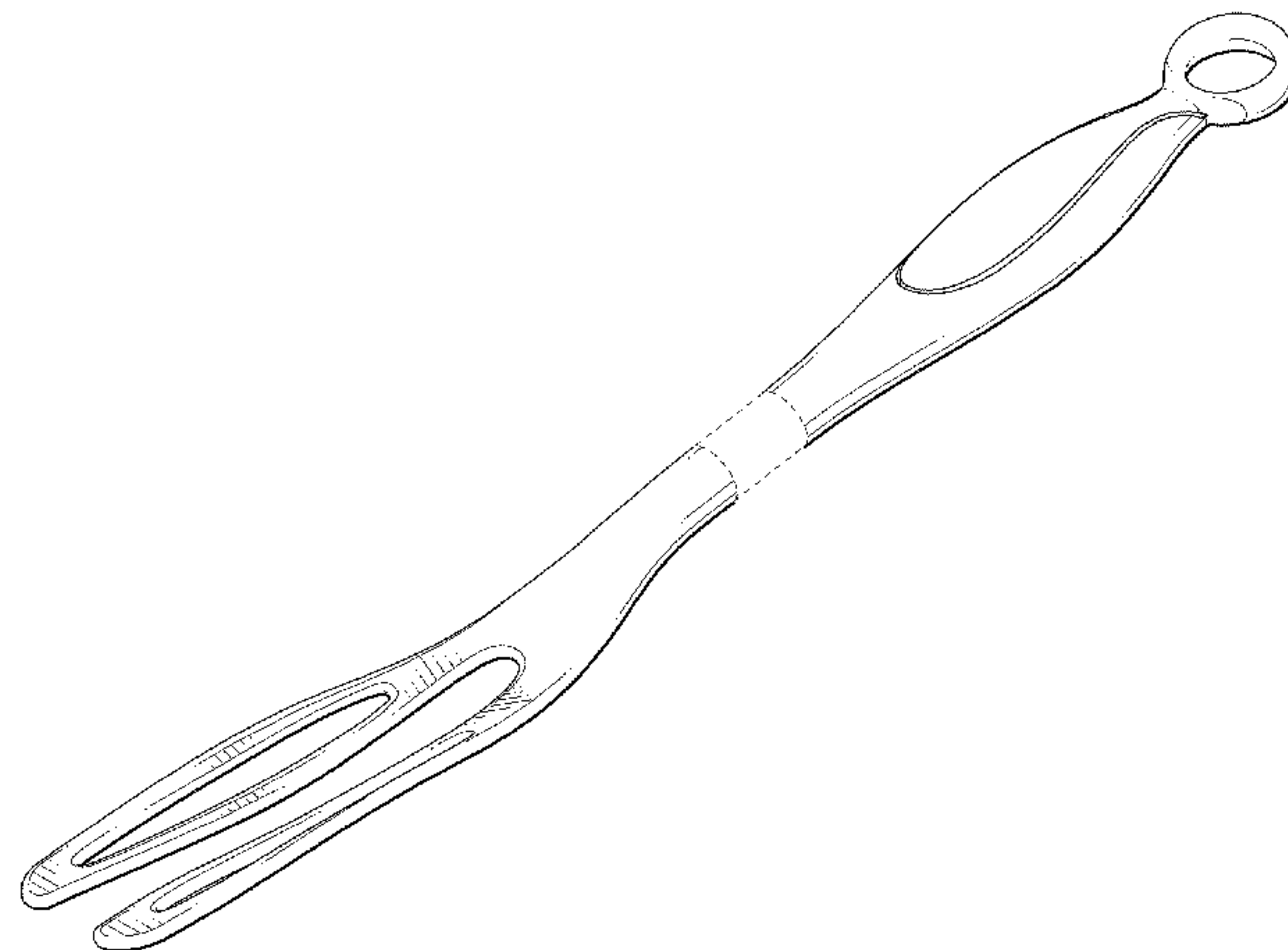
(57) **CLAIM**

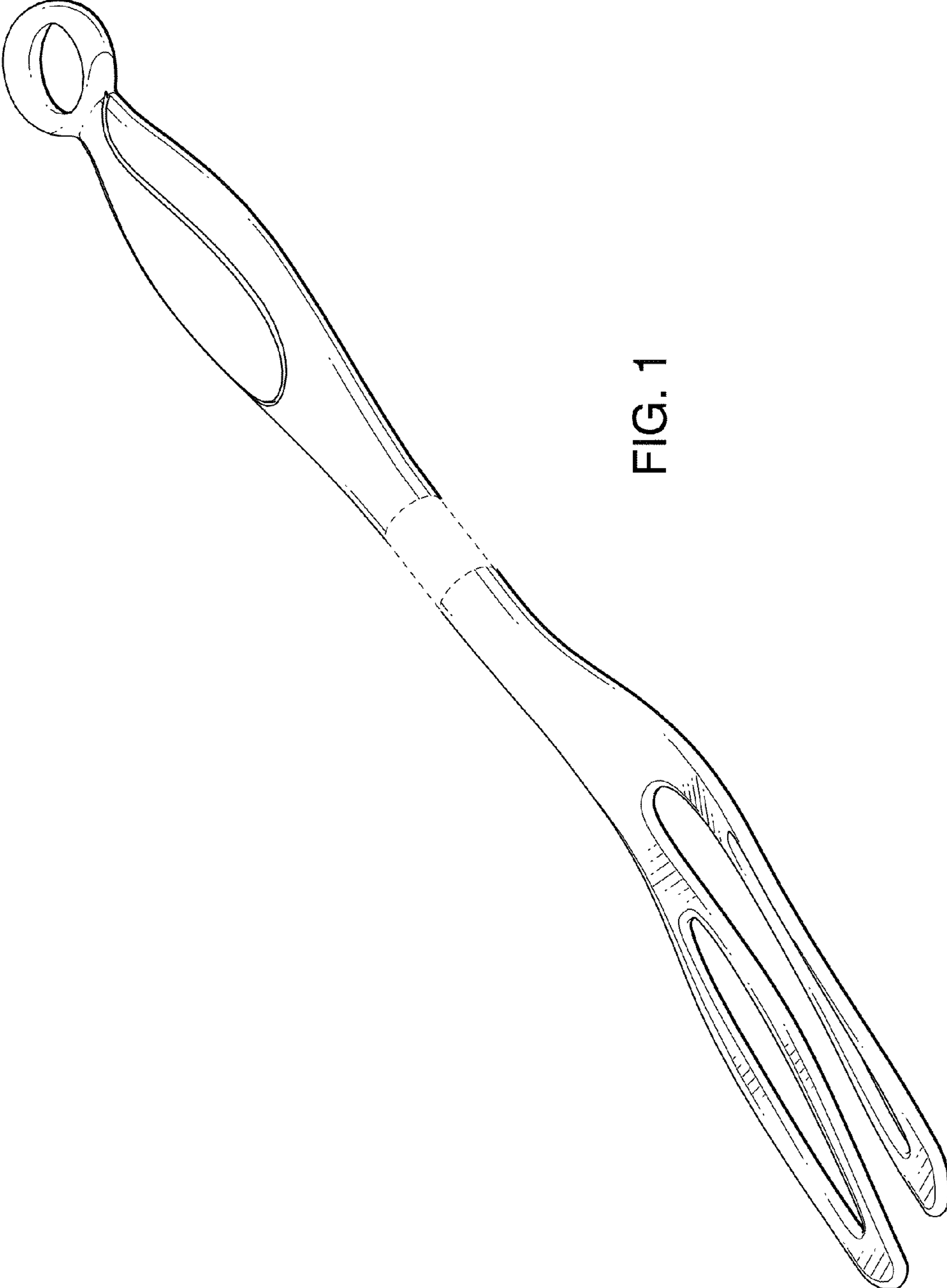
The ornamental design for a handle for holding a cleaning device, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of one embodiment of a handle, according to the present invention; FIG. 2 is a side elevational view thereof, the opposite side being a minor image thereof; FIG. 3 is a top view thereof; FIG. 4 is a front view thereof; FIG. 5 is a rear view thereof; and FIG. 6 is a bottom view thereof; FIG. 7 is a perspective view of a second embodiment of a handle according to the present invention; FIG. 8 is a side elevational view thereof; FIG. 9 is an opposite side elevational view thereof; FIG. 10 is a top view thereof; FIG. 11 is a bottom view thereof; FIG. 12 is a front view thereof; and, FIG. 13 is a rear view thereof. The portion of the handle for holding a cleaning device shown in broken lines forms no part of the claimed design.

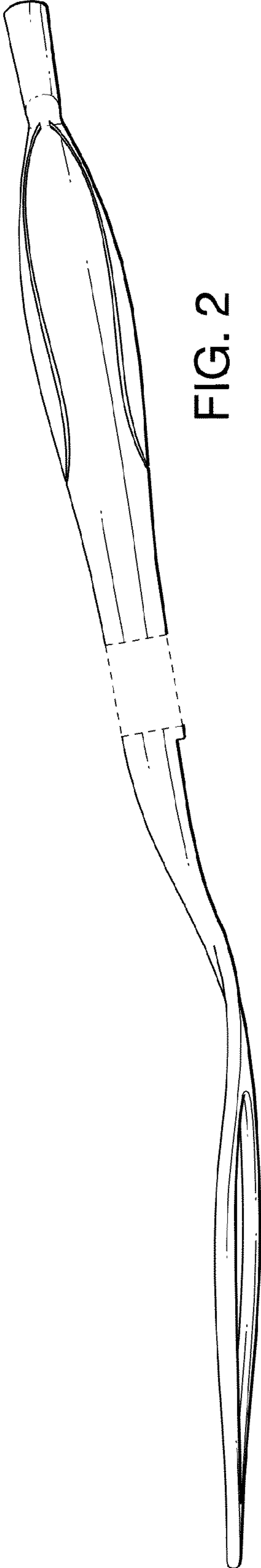

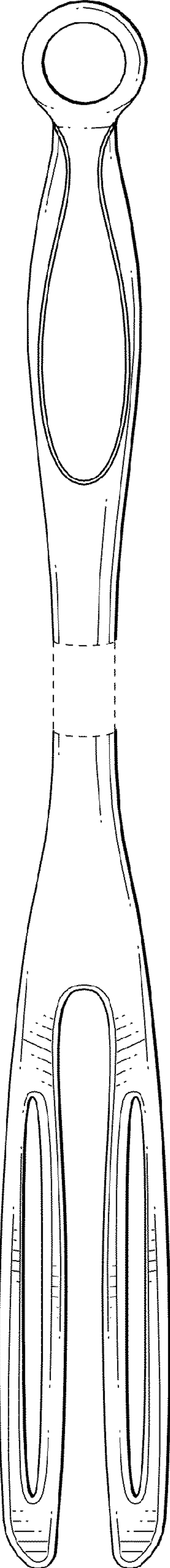

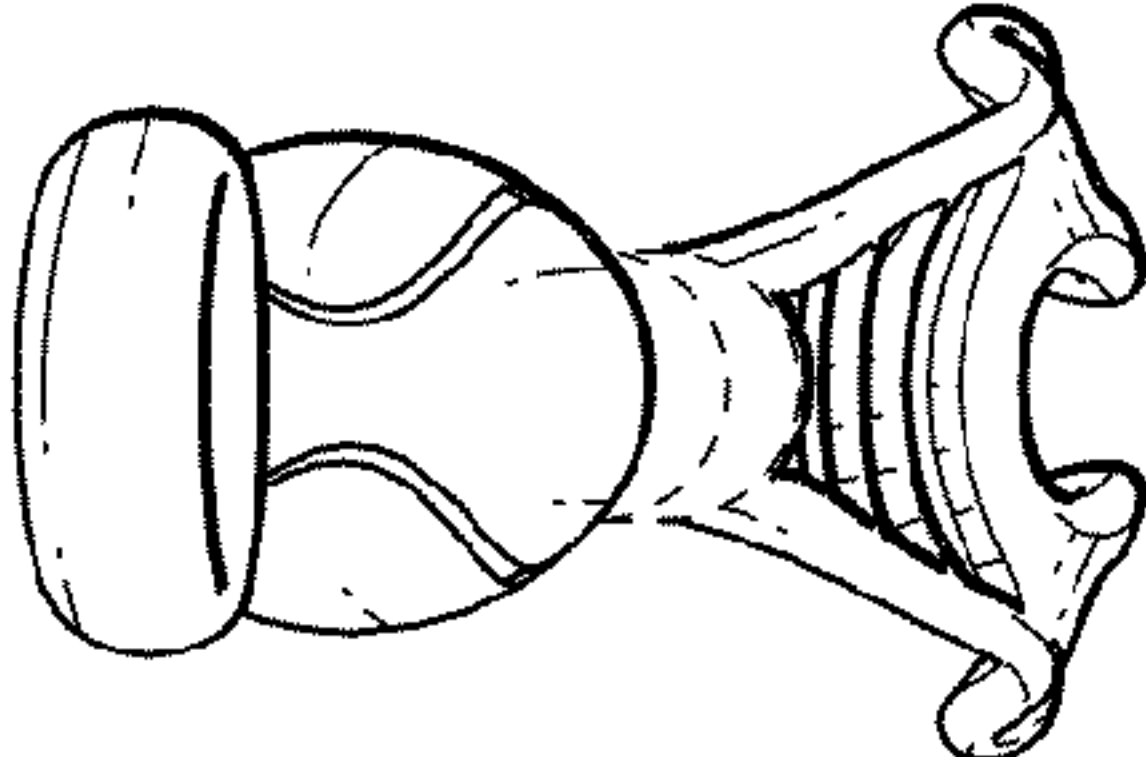

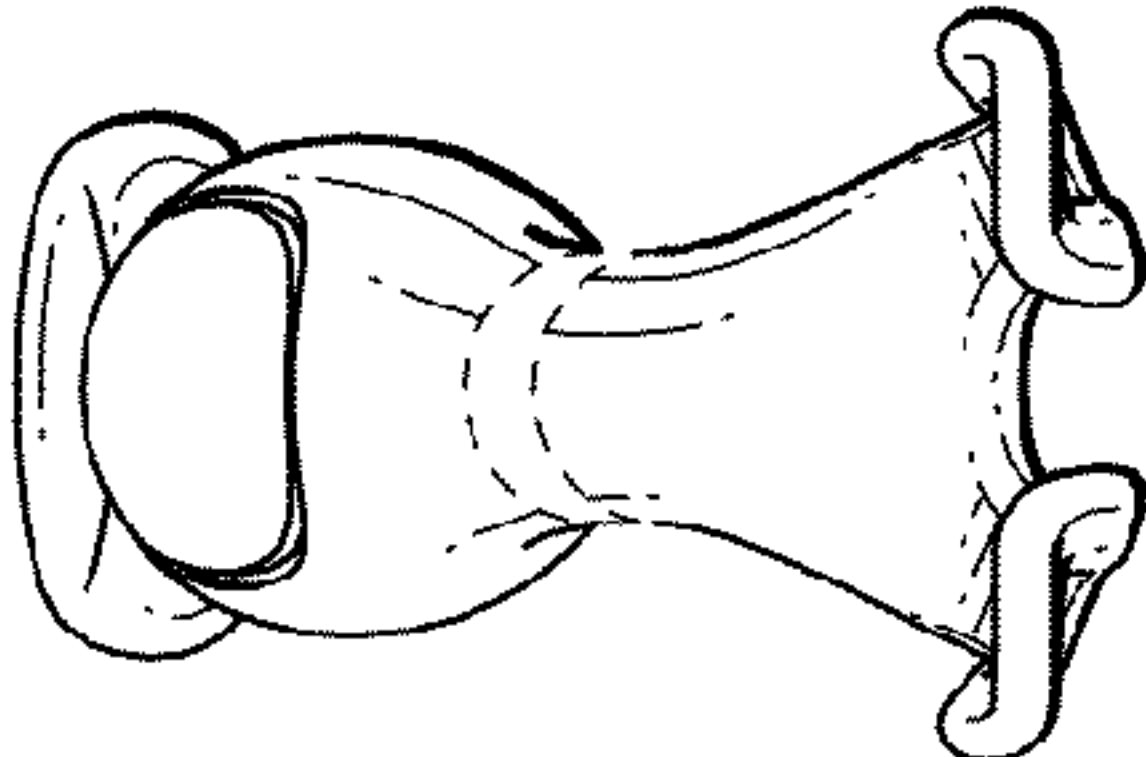

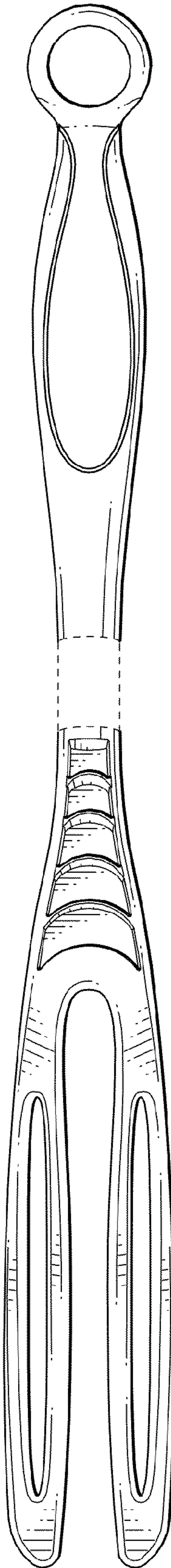

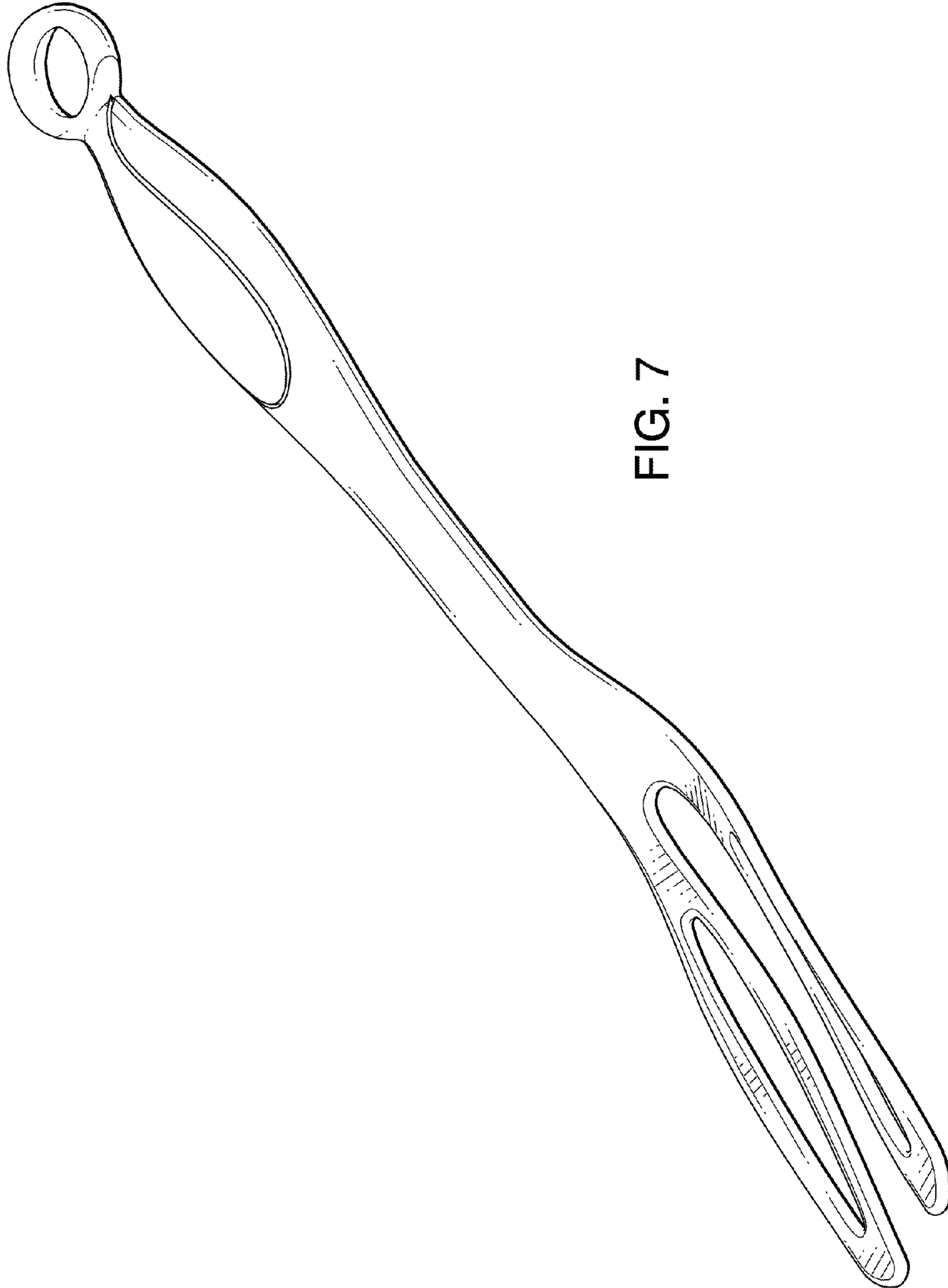

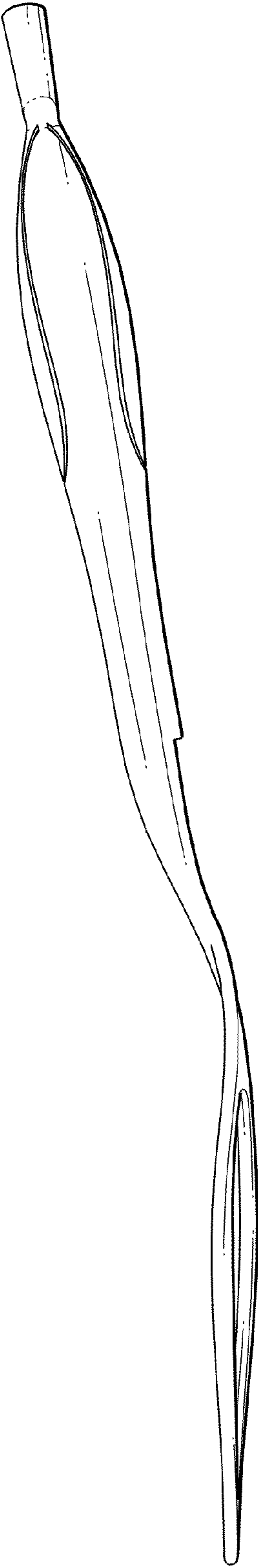

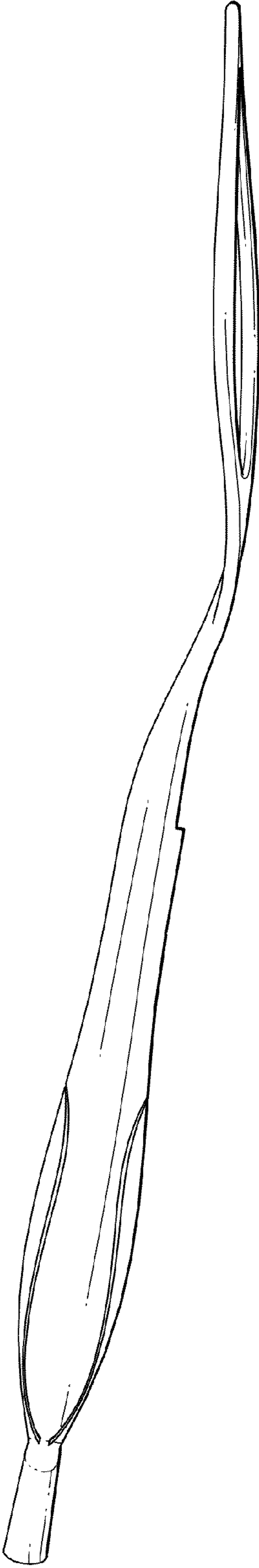

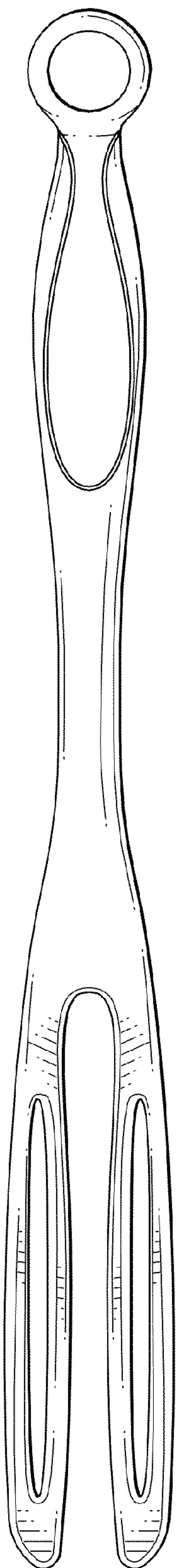

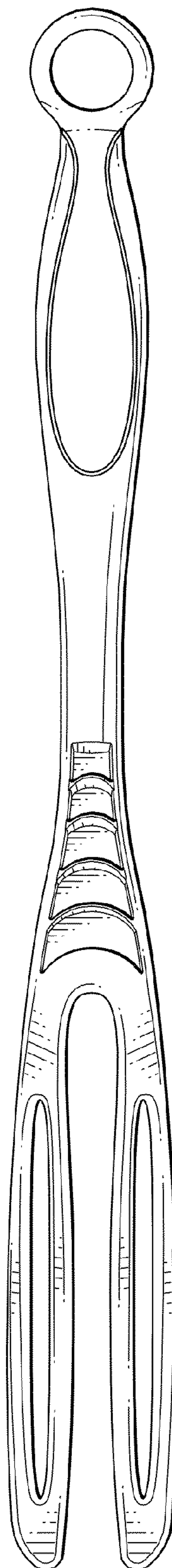

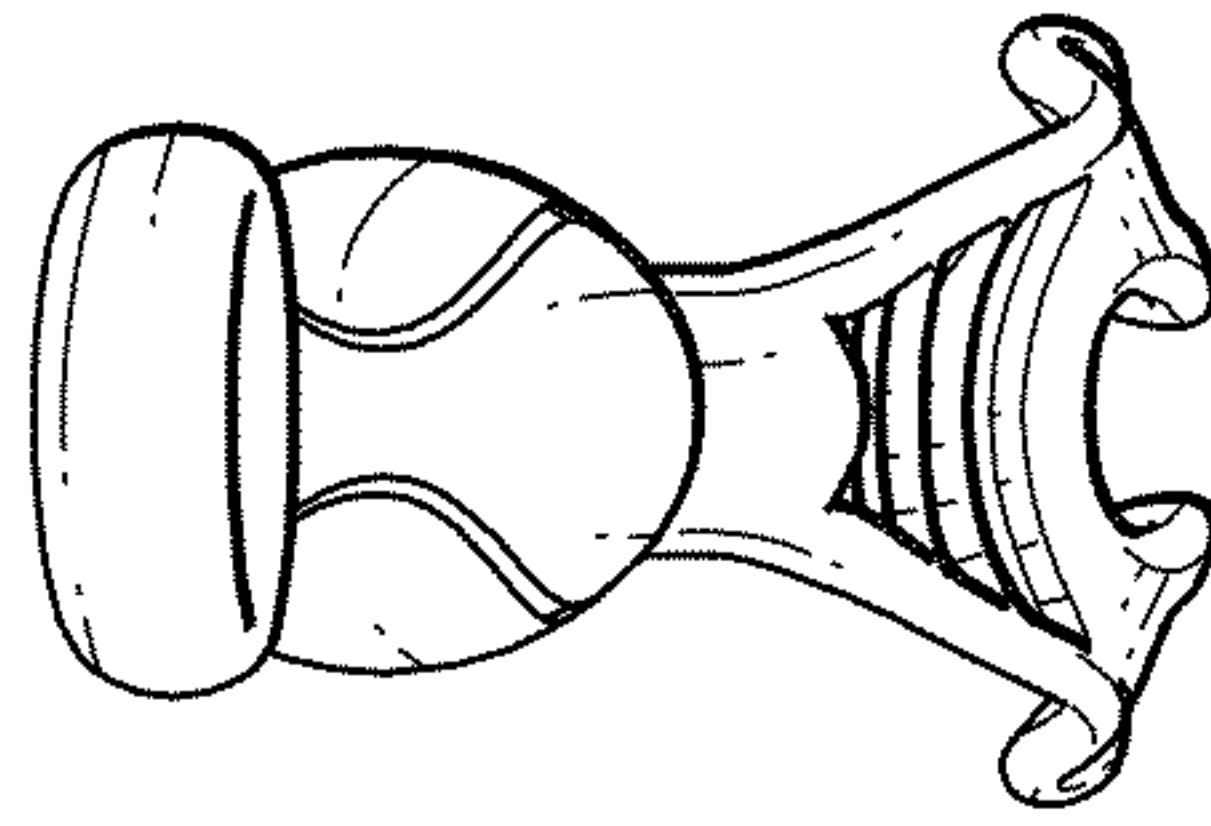

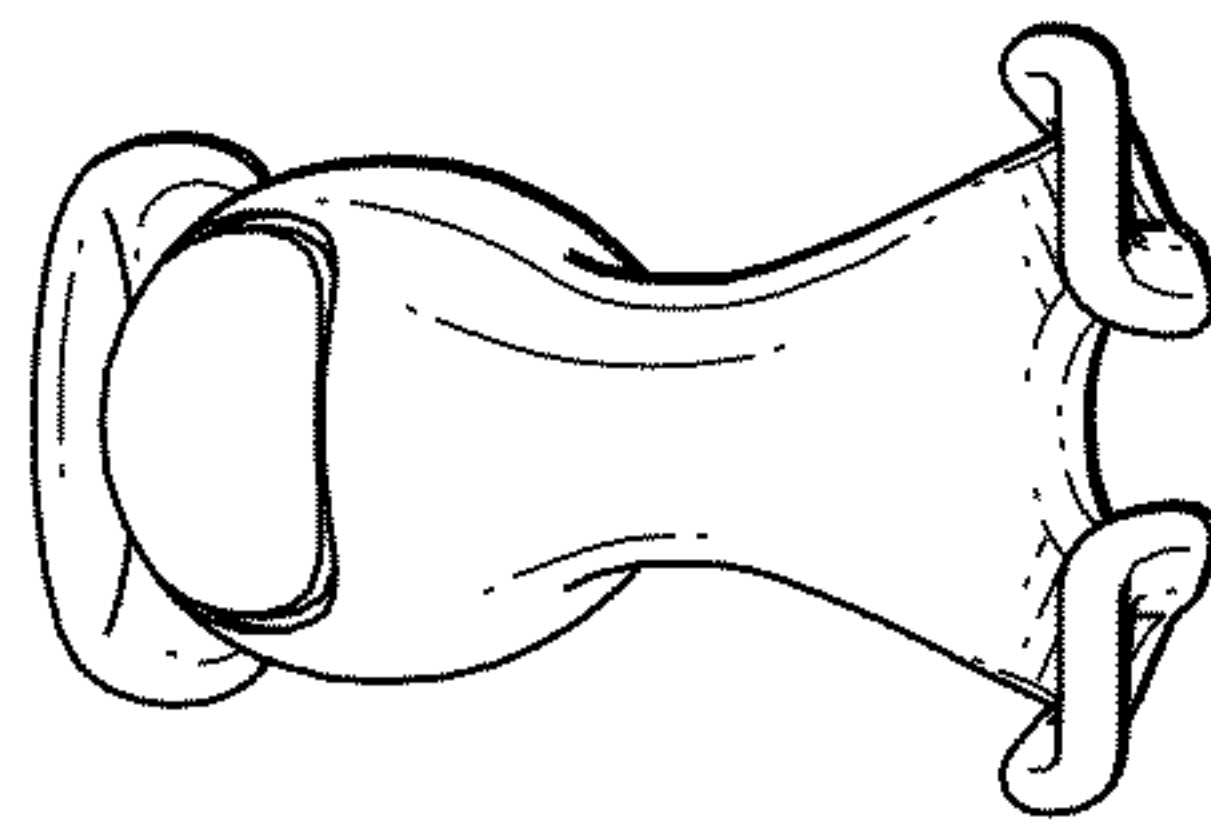
