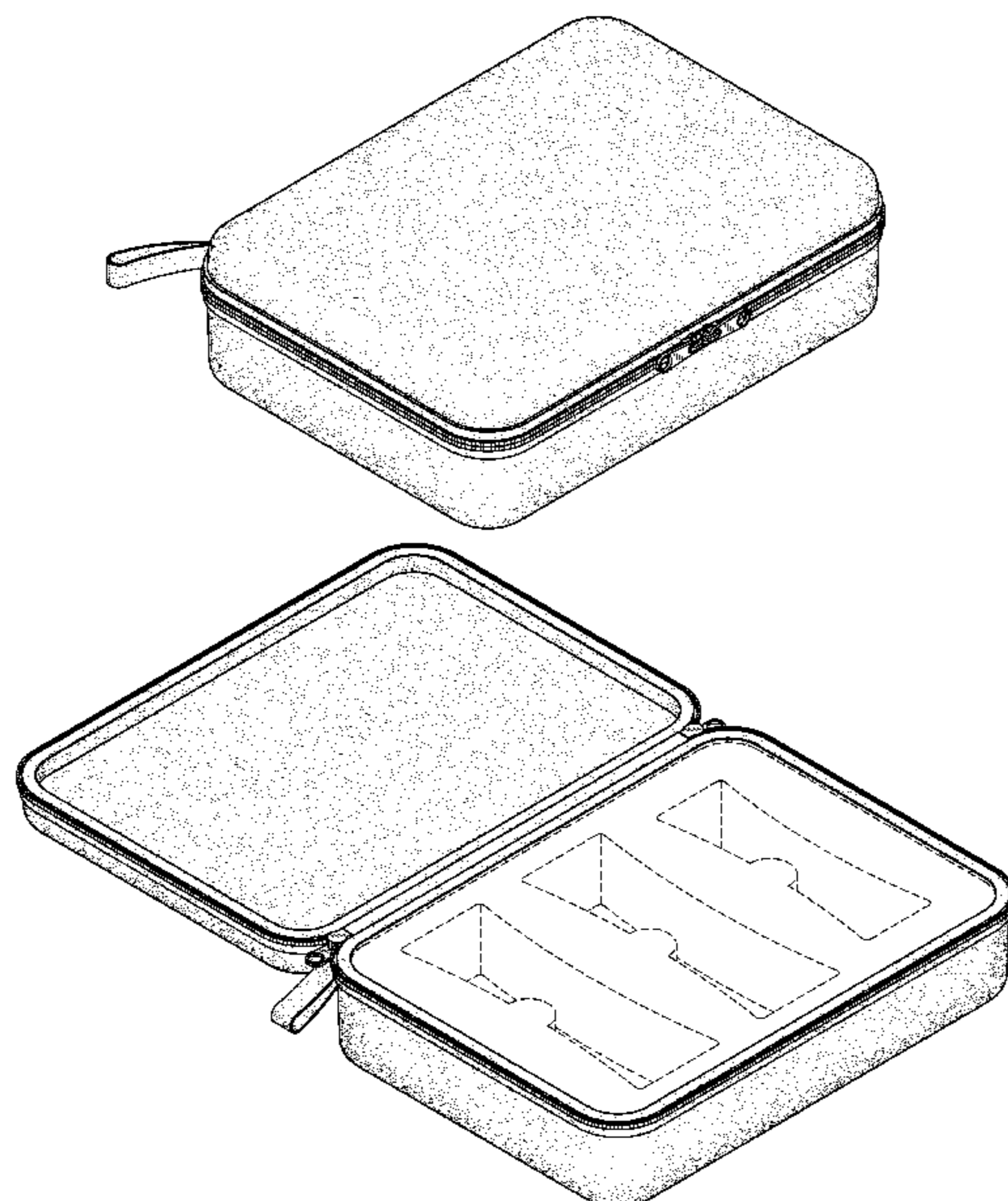
(57) **CLAIM**

The ornamental design for a case for glasses, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of one embodiment of a case for glasses showing my new design;
FIG. 2 is a top plan view of FIG. 1;
FIG. 3 is a bottom plan view of FIG. 1;
FIG. 4 is a front elevation view of FIG. 1;
FIG. 5 is a rear elevation view of FIG. 1;
FIG. 6 is a left end elevation view of FIG. 1;
FIG. 7 is a right end elevation view of FIG. 1;
FIG. 8 is a perspective view of FIG. 1 in the open position;
FIG. 9 is a perspective view of another embodiment of a case for glasses showing my new design;
FIG. 10 is a top plan view of FIG. 9;
FIG. 11 is a bottom plan view of FIG. 9;
FIG. 12 is a front elevation view of FIG. 9;
FIG. 13 is a rear elevation view of FIG. 9;
FIG. 14 is a left end elevation view of FIG. 9;

FIG. 16 is a perspective view of FIG. 9 in the open position.

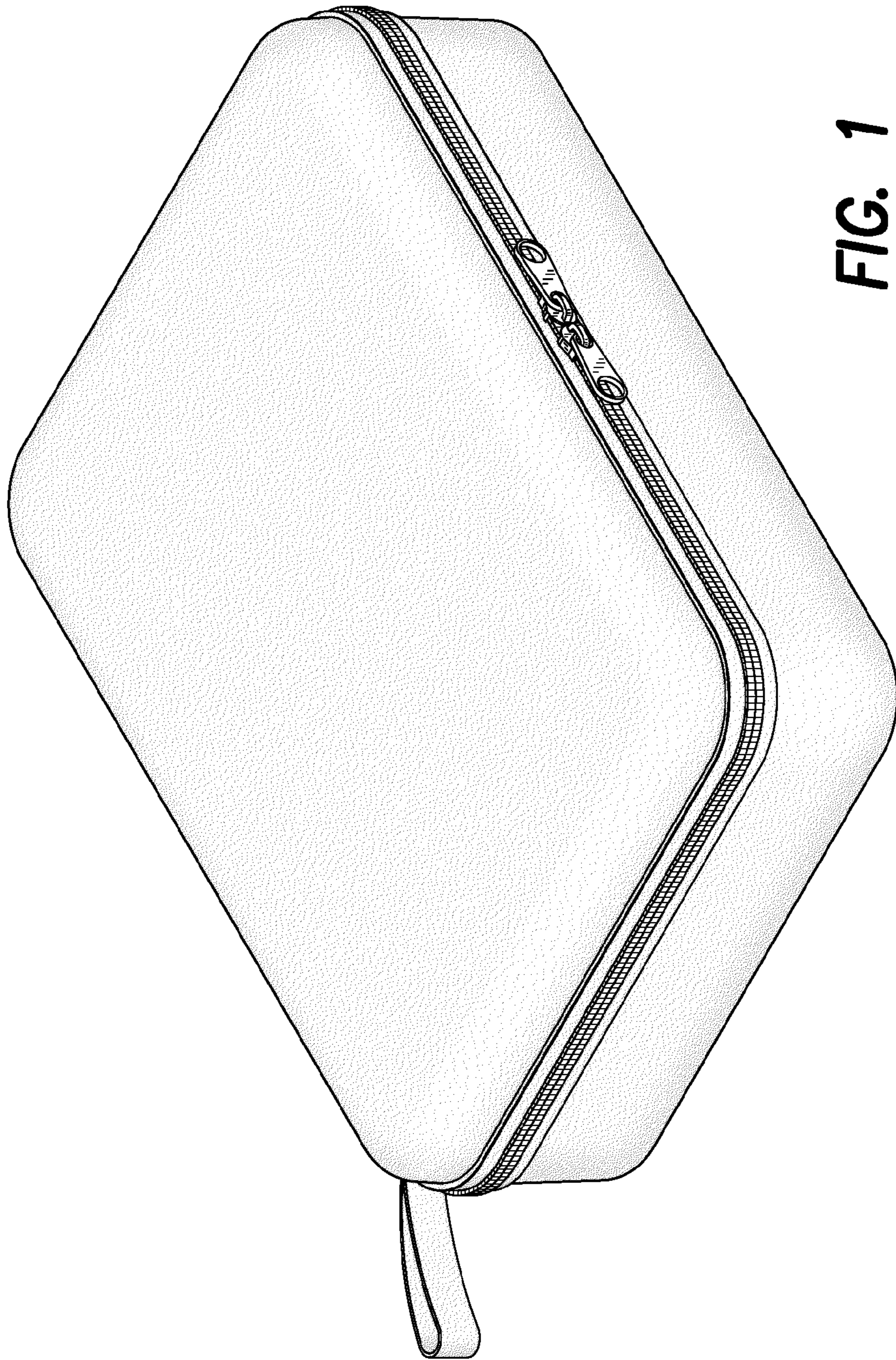

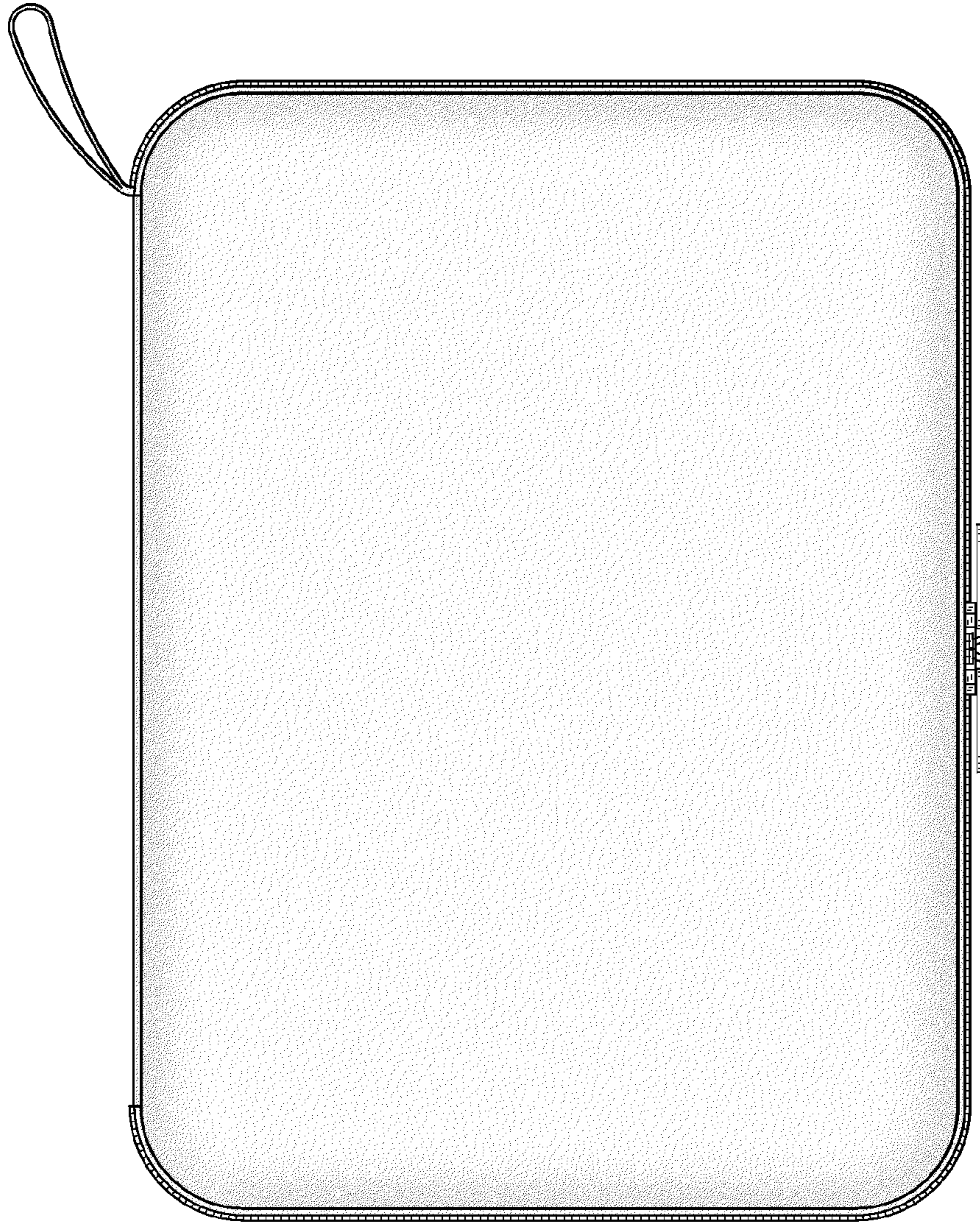

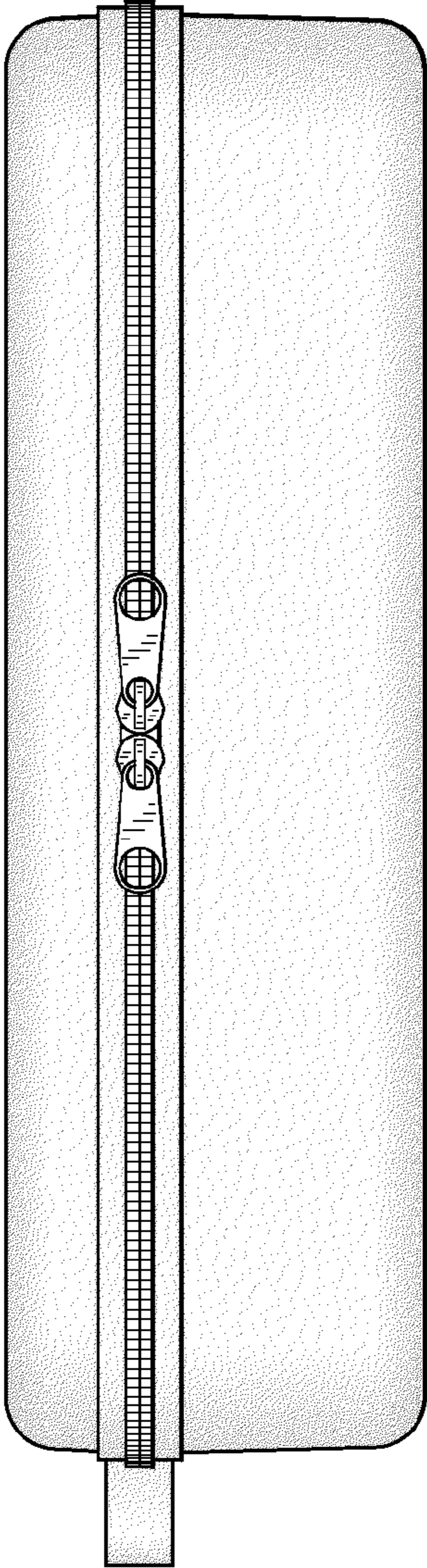

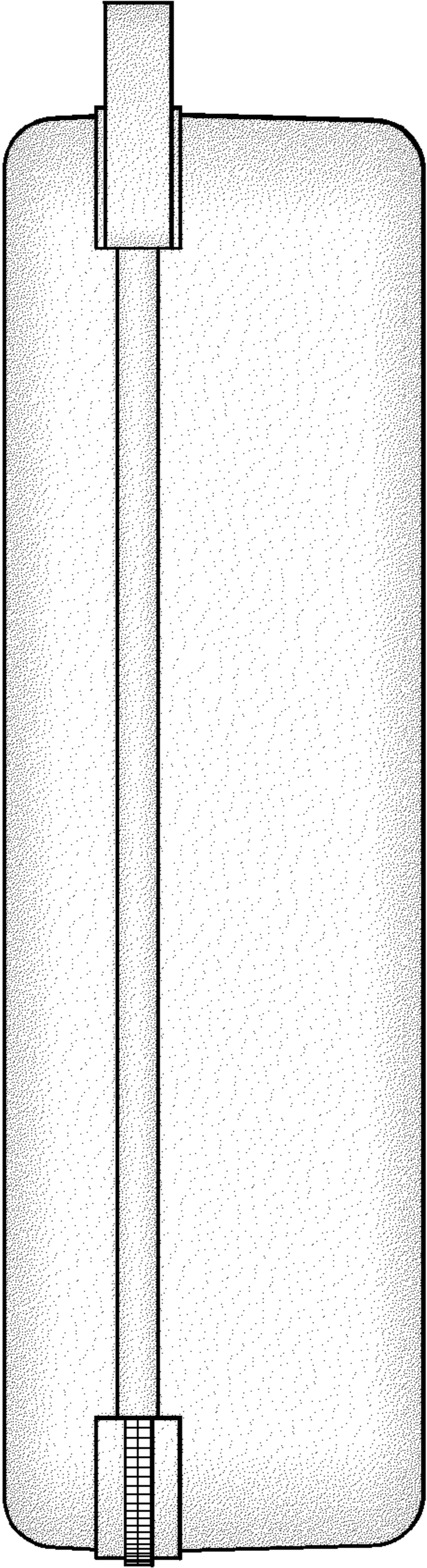

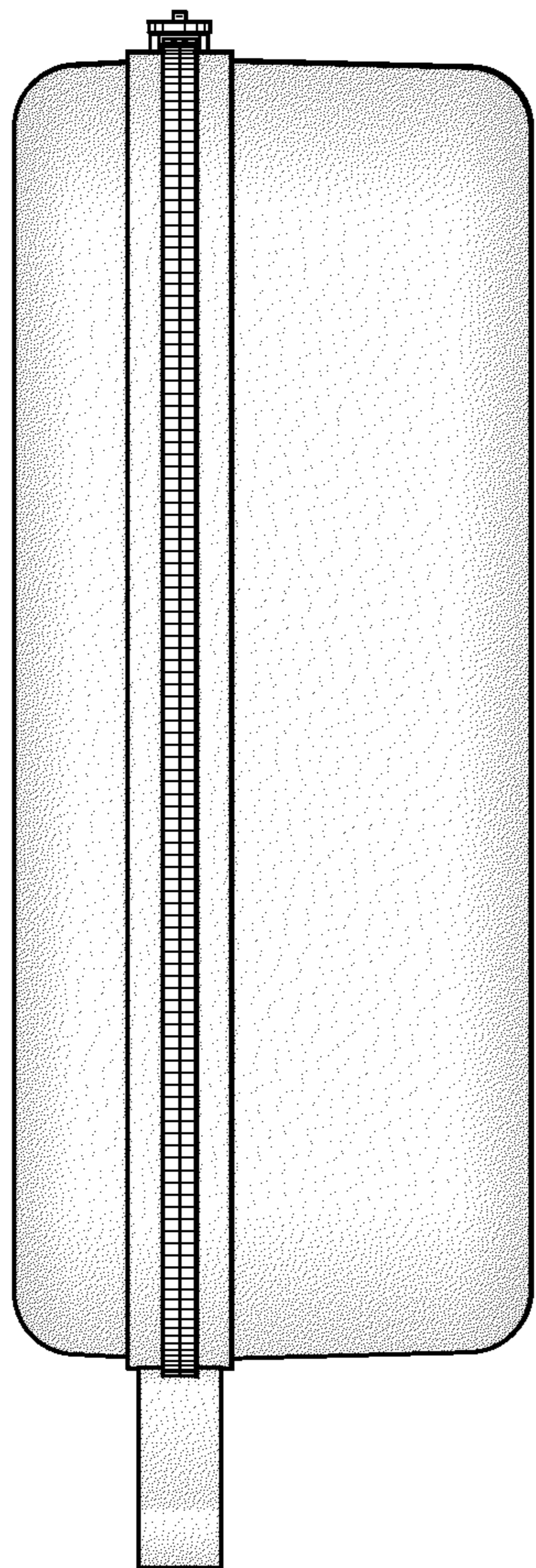

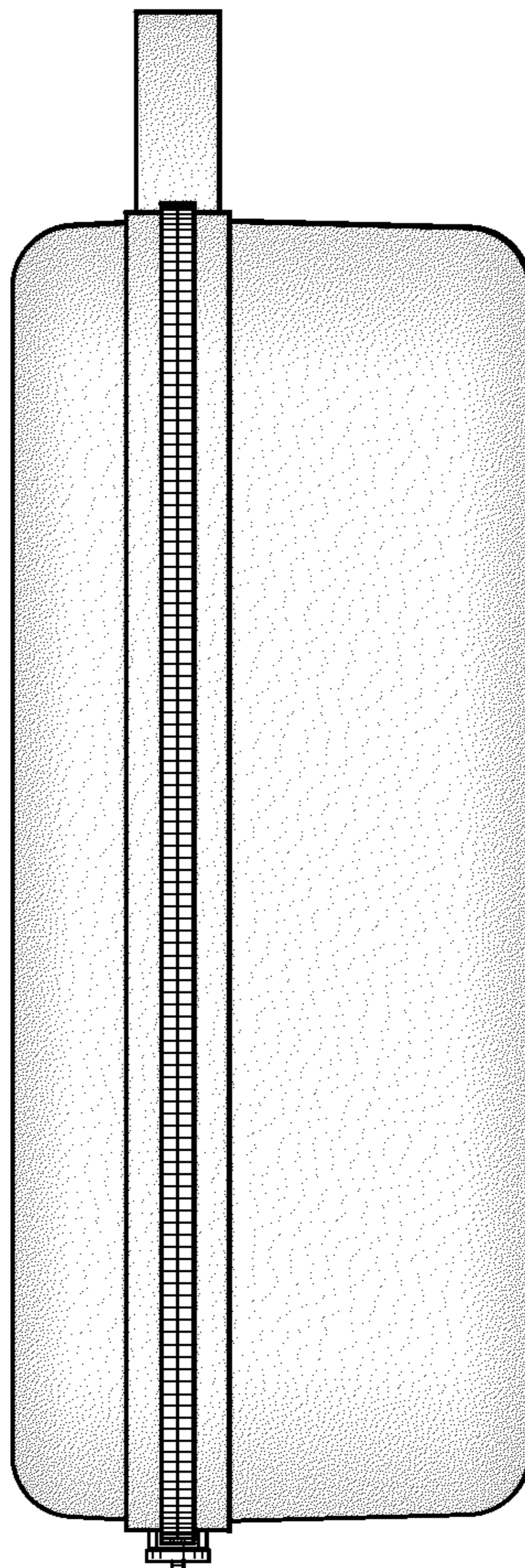

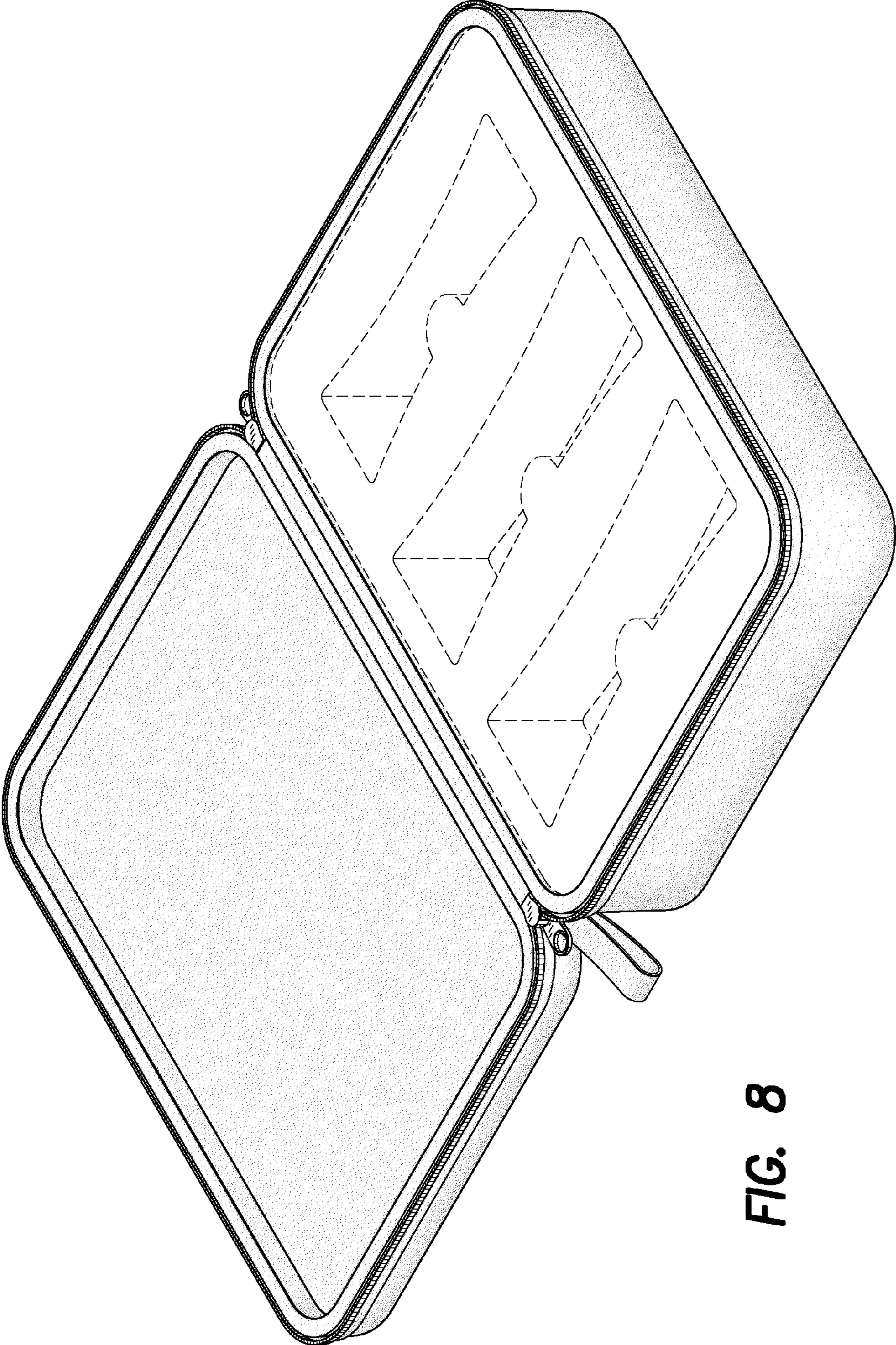

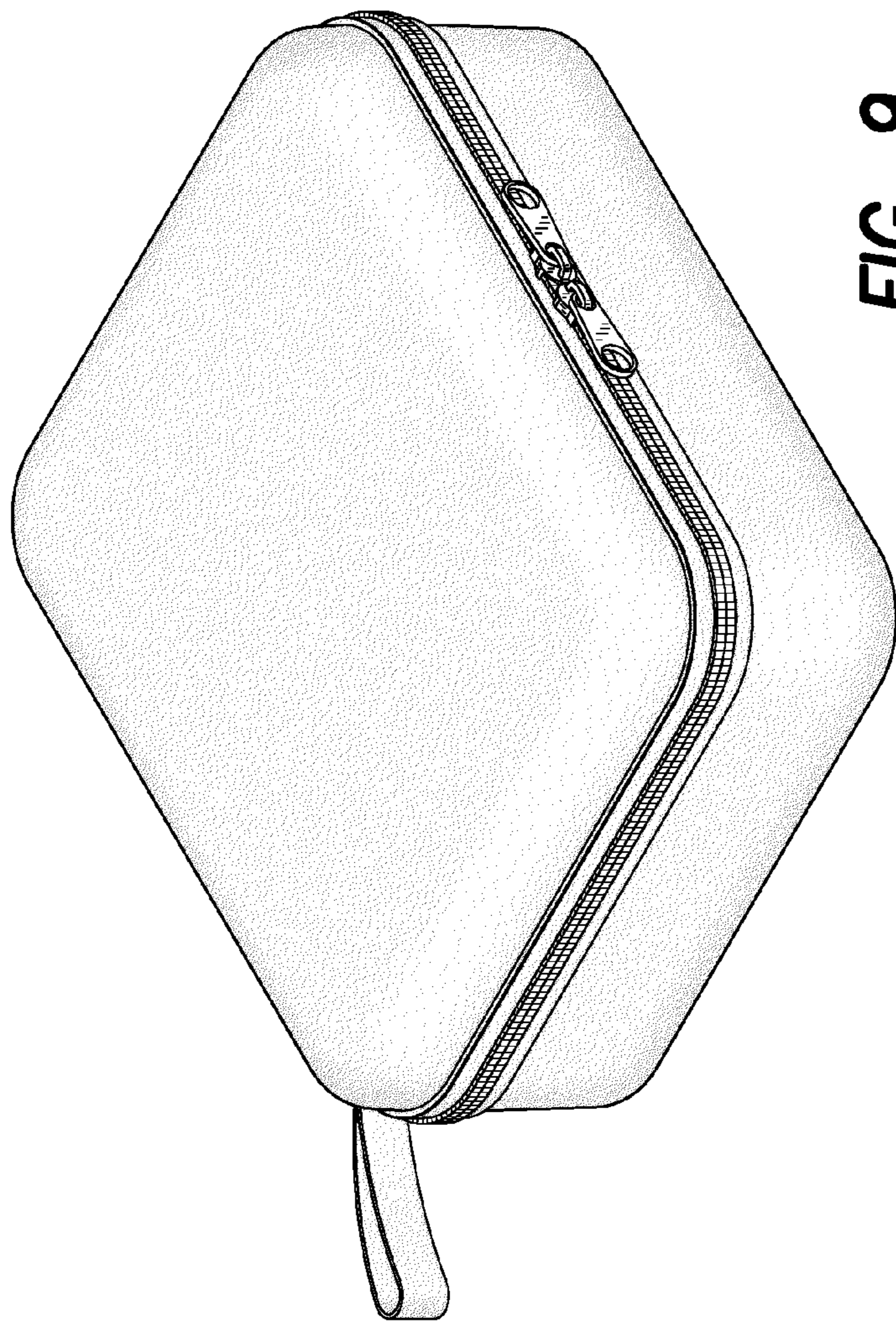

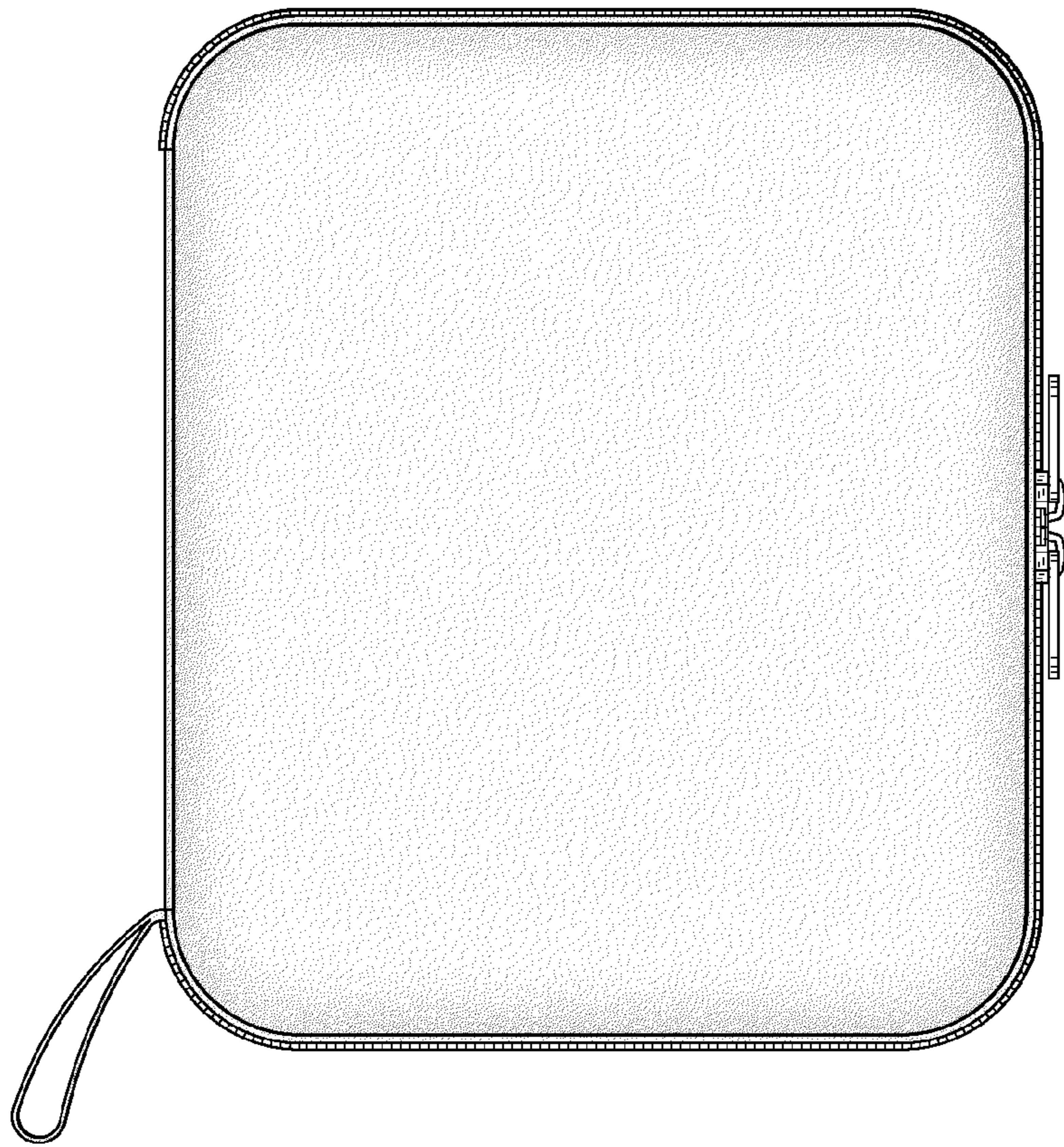

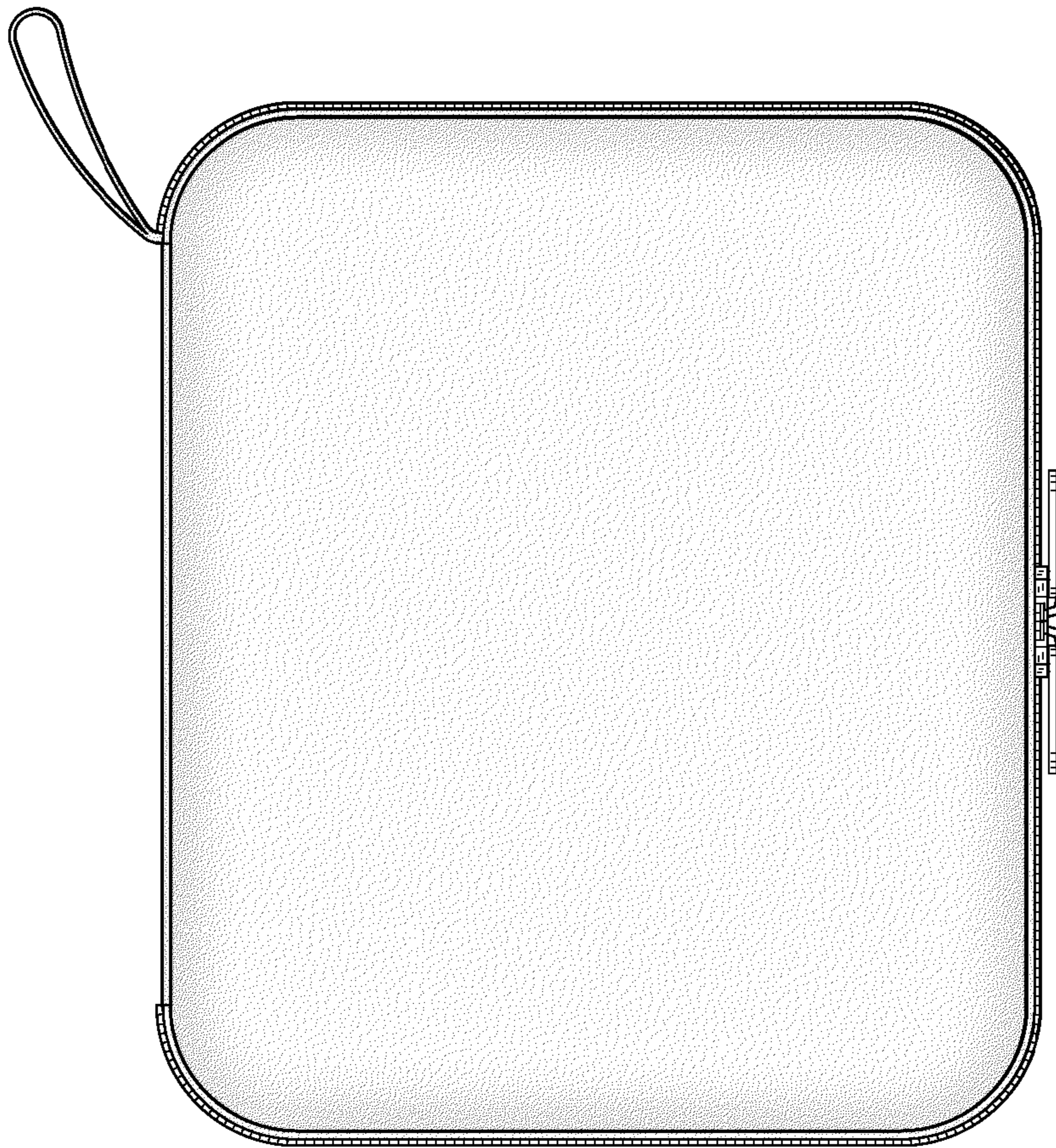

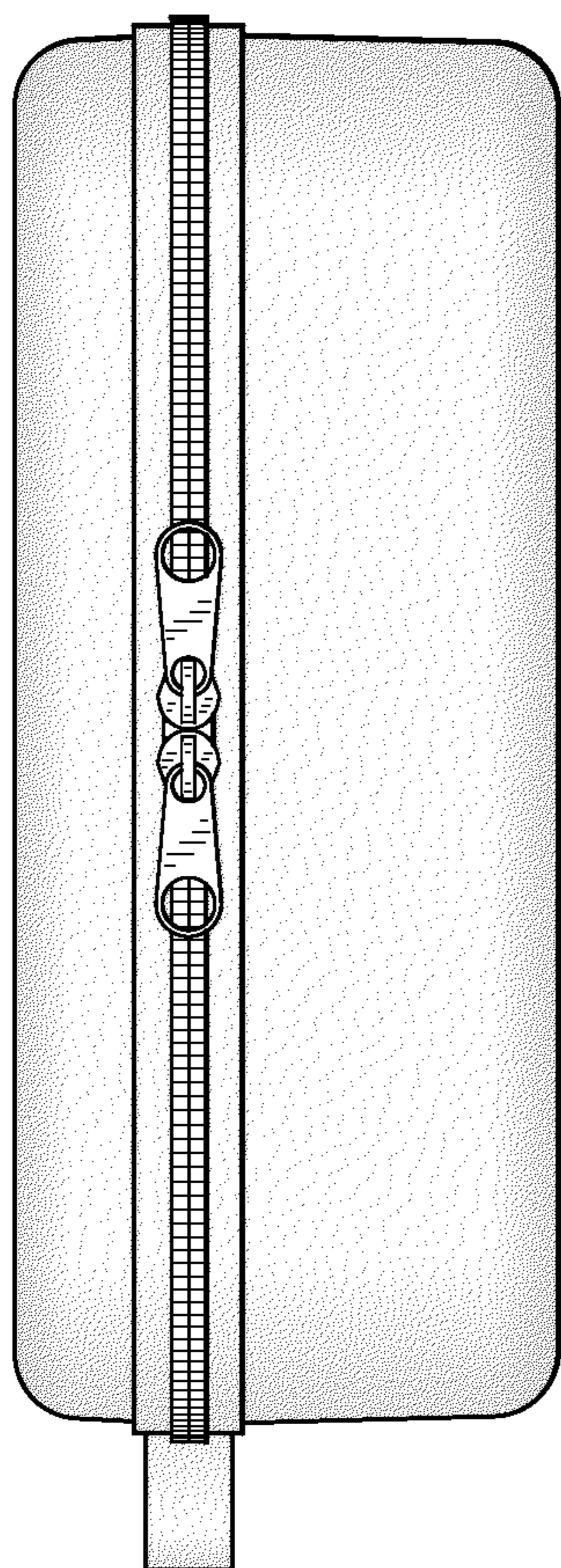

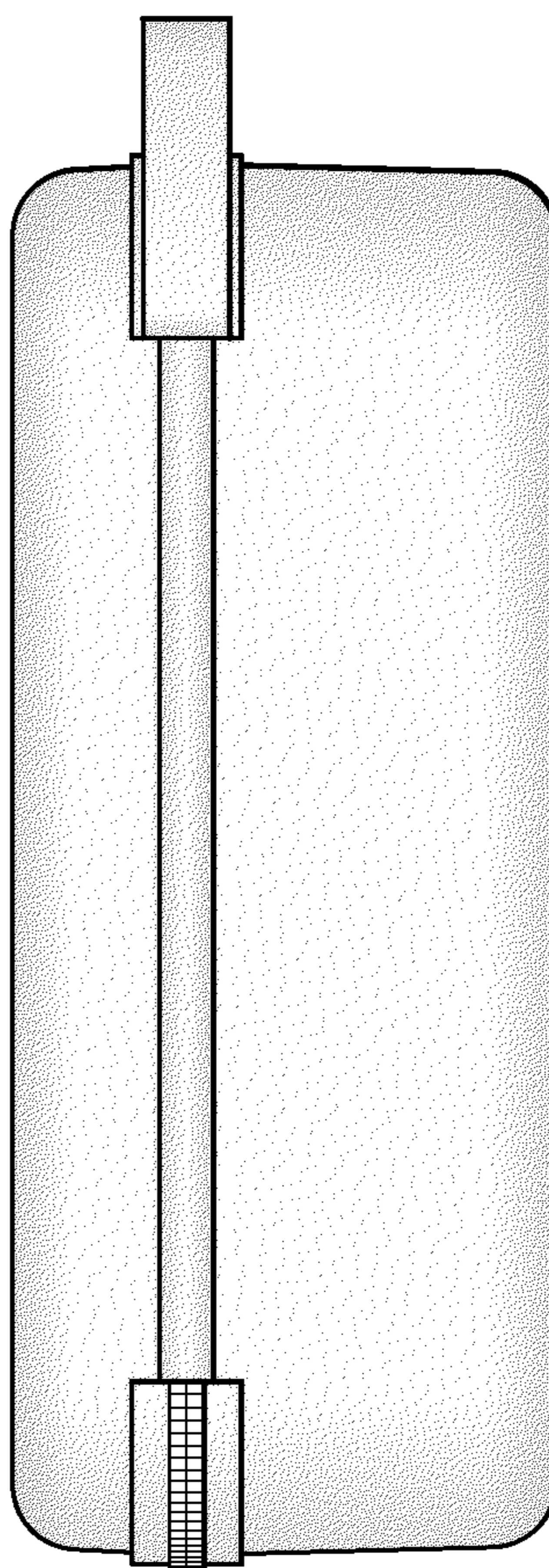

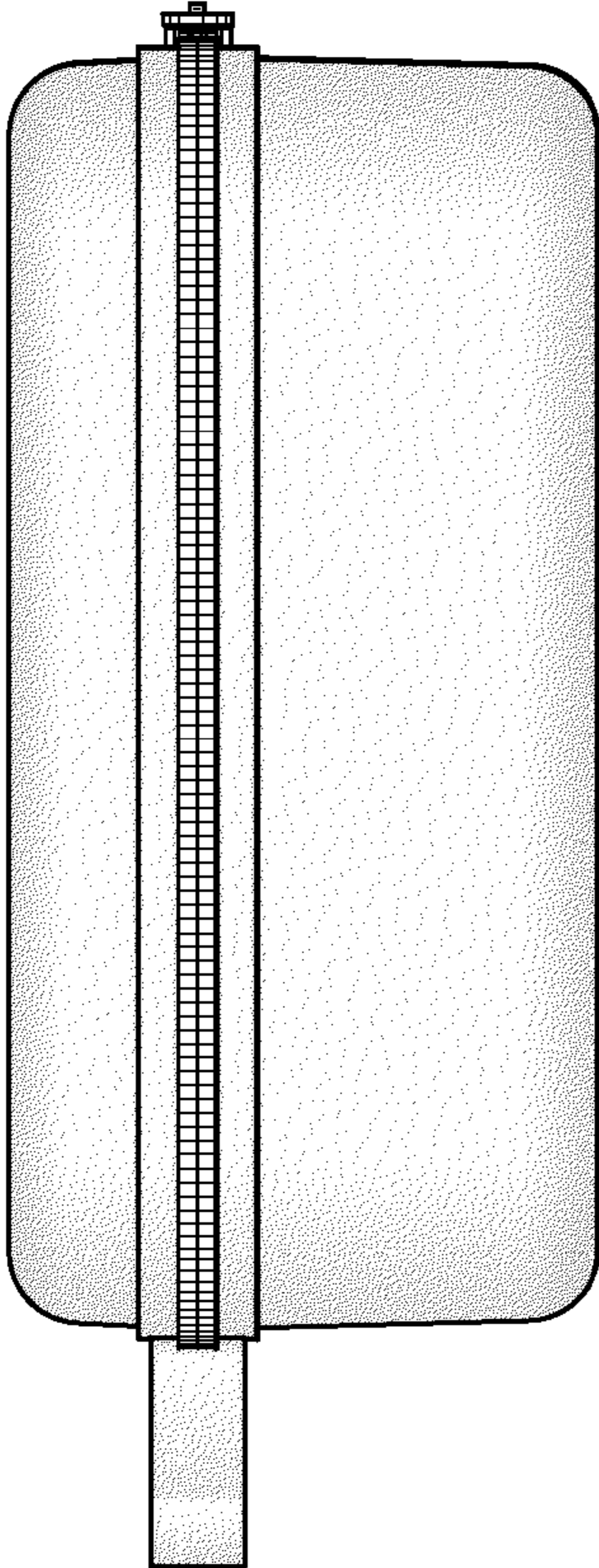

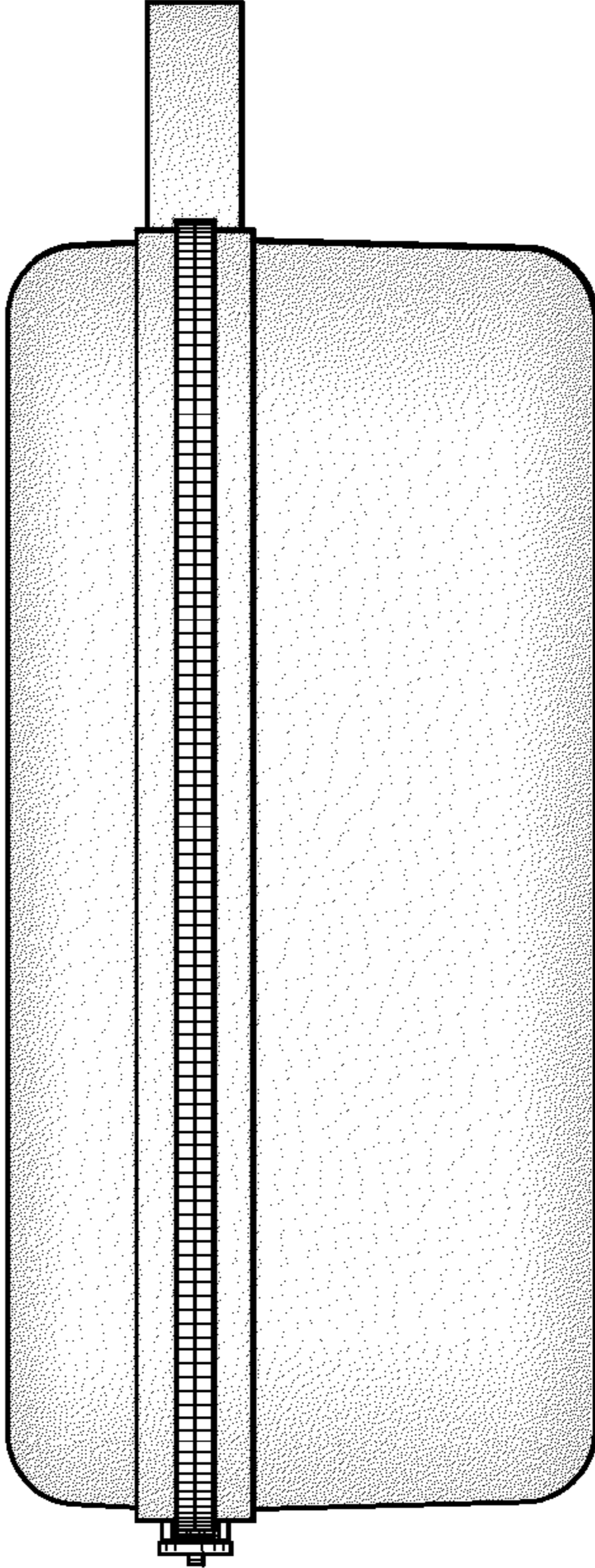

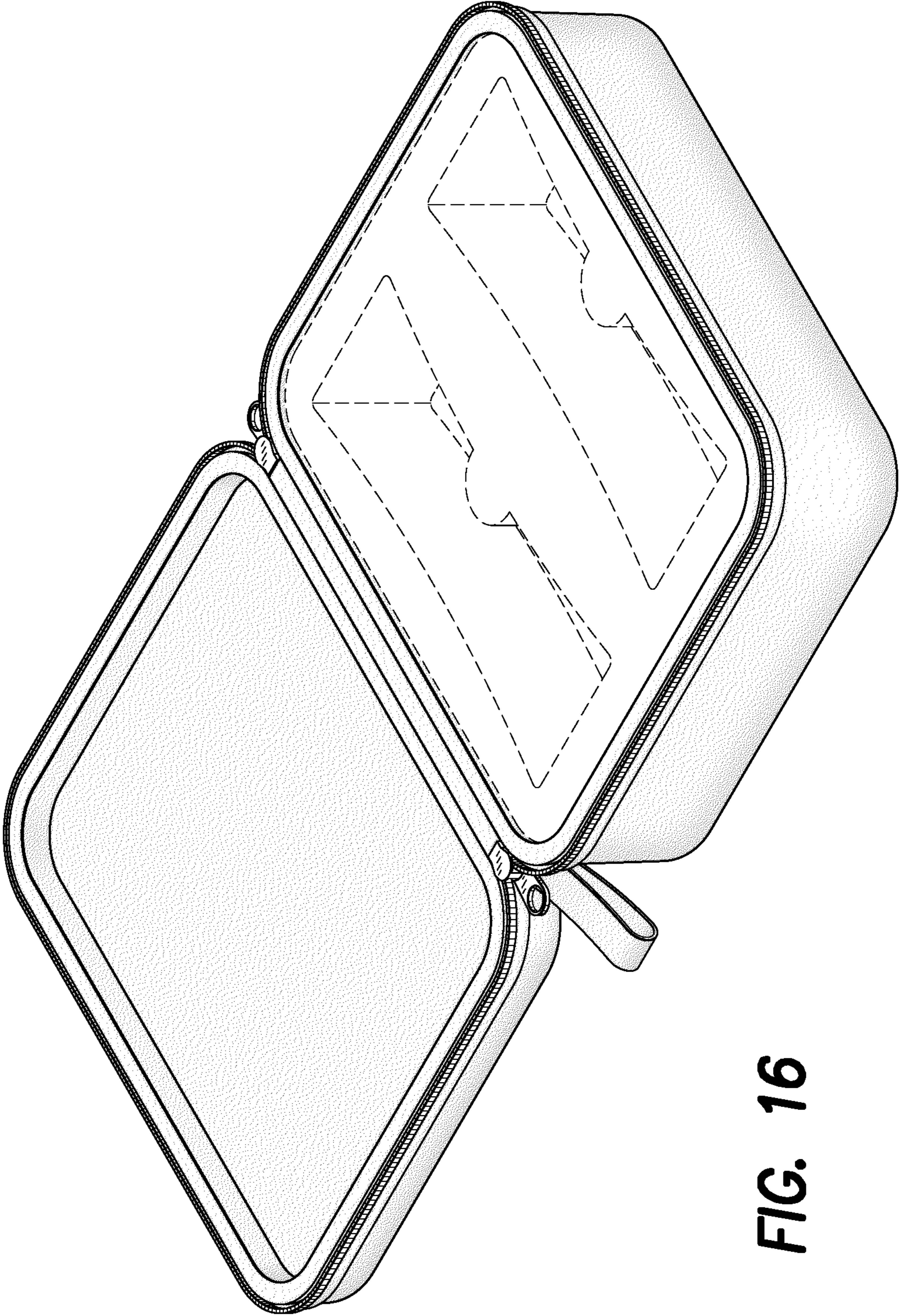
