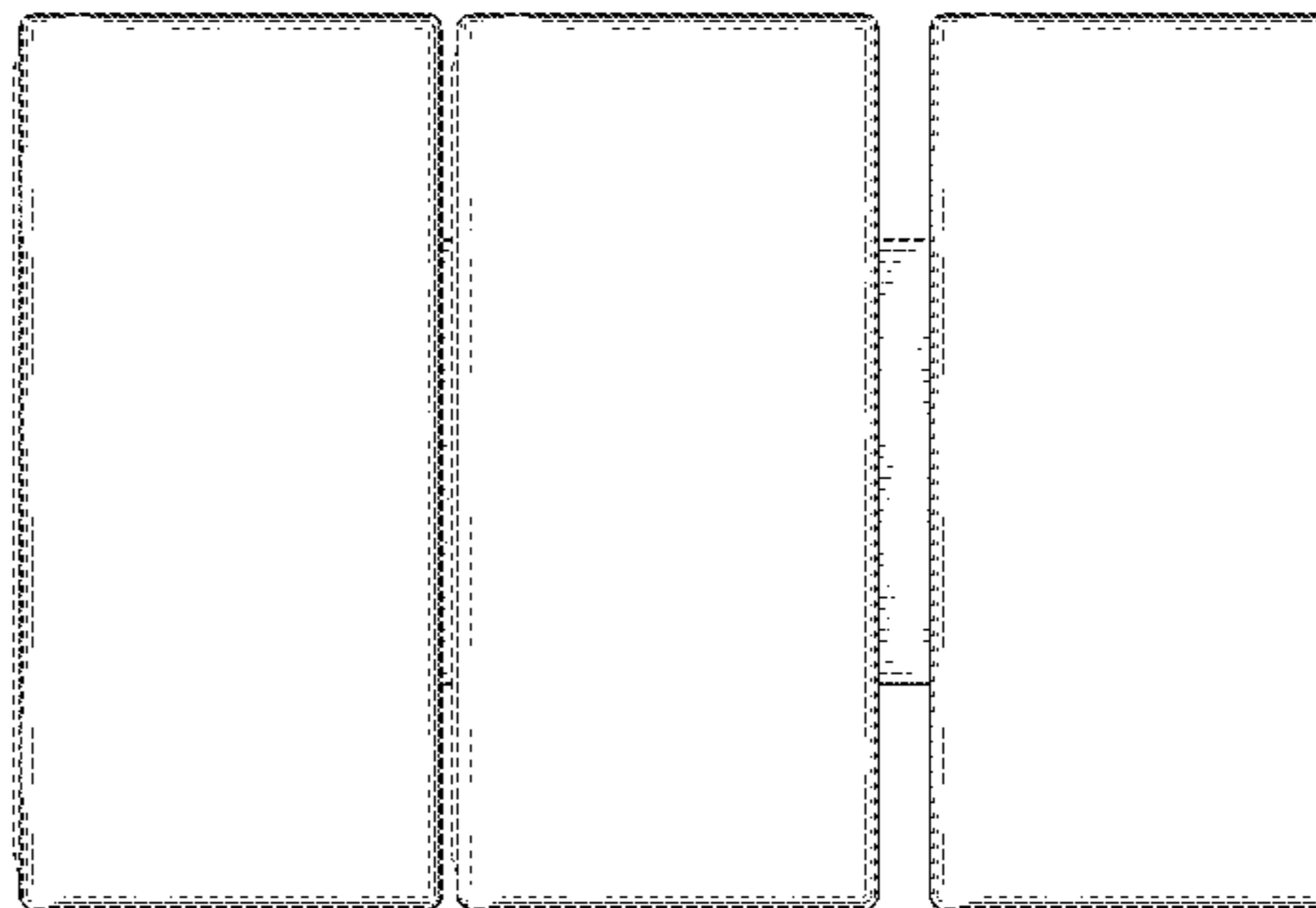
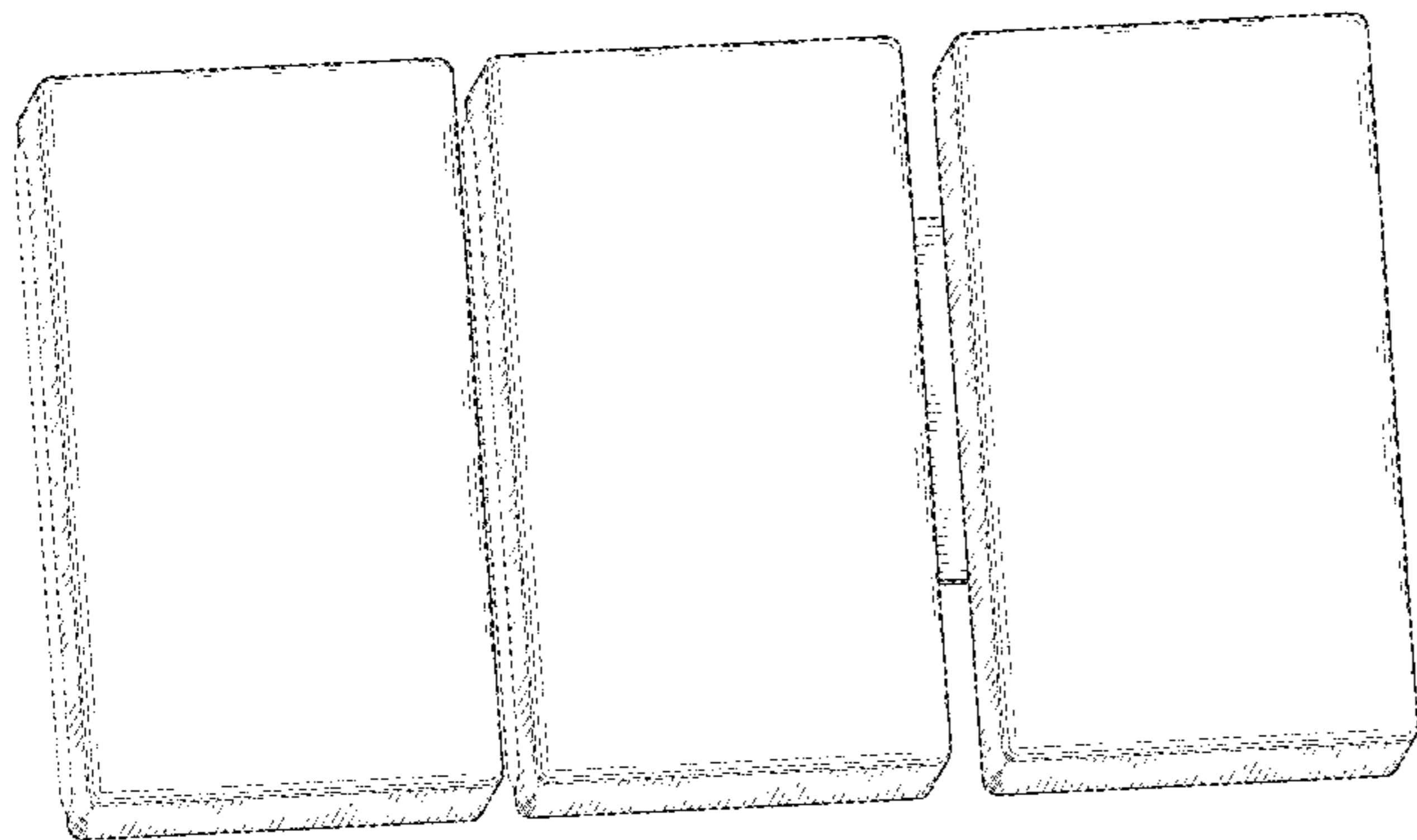
(57) **CLAIM**

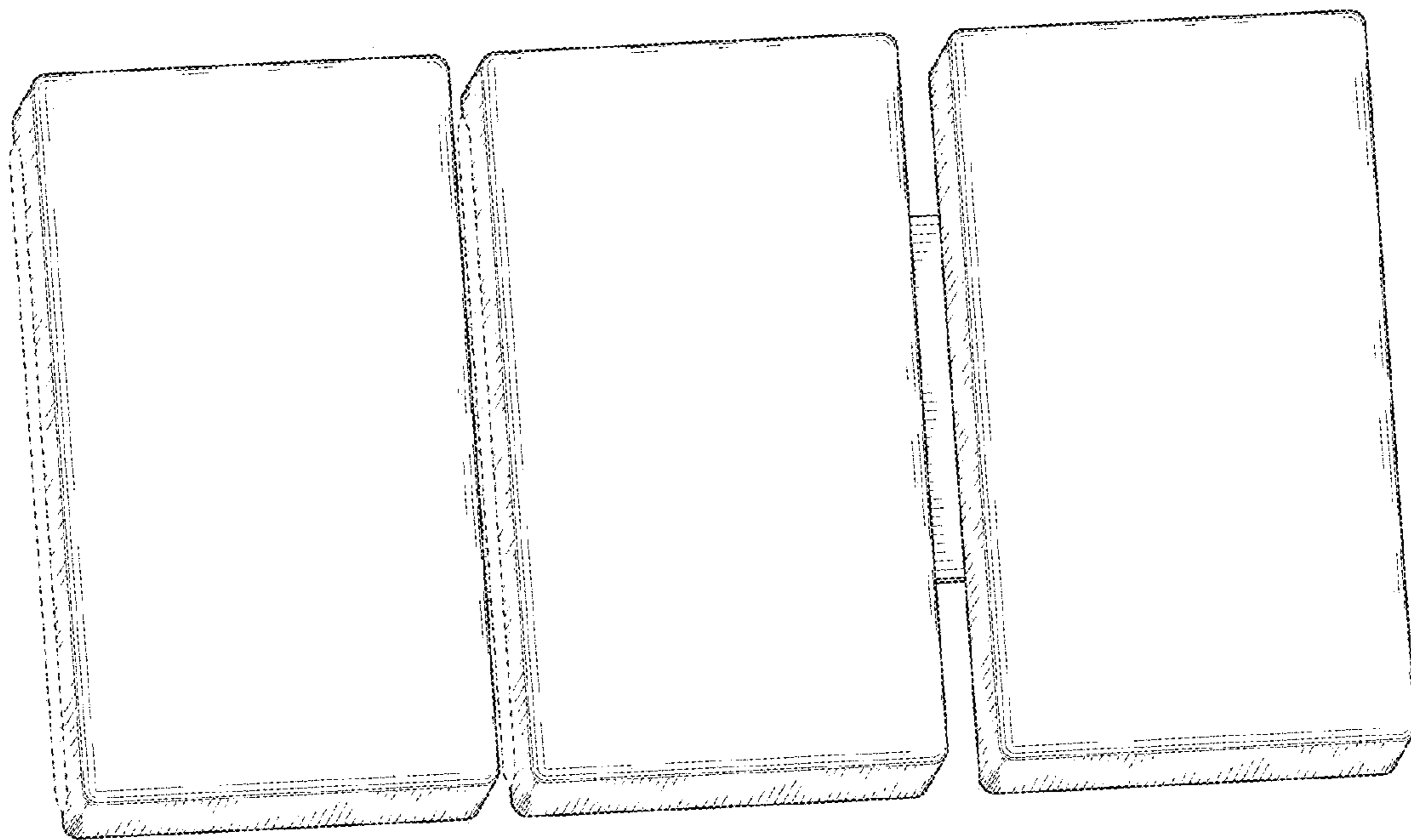
The ornamental design for a mattress topper for a play yard, as shown and described.

**DESCRIPTION**

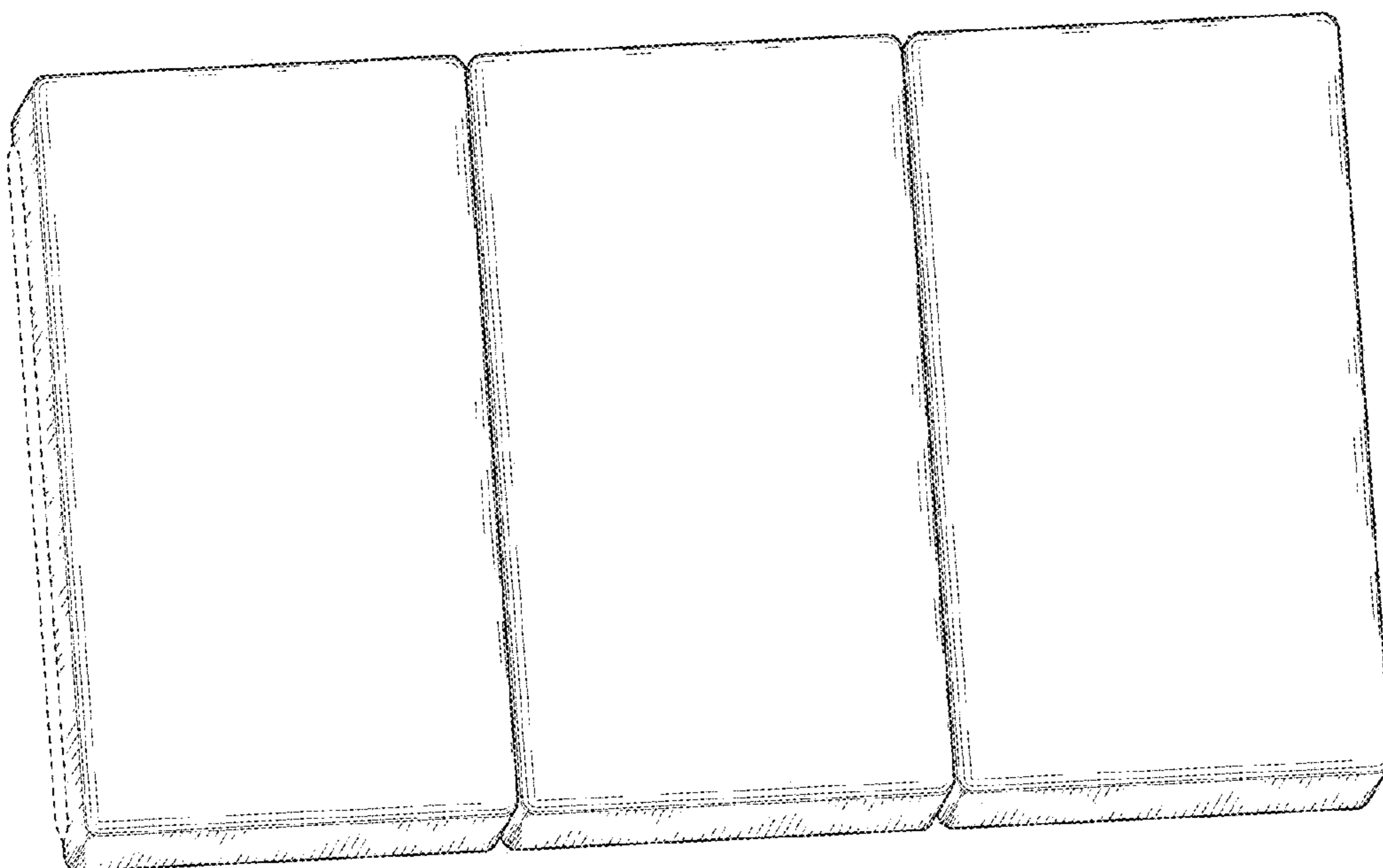
FIG. 1 is a perspective view of a mattress topper for a play yard;

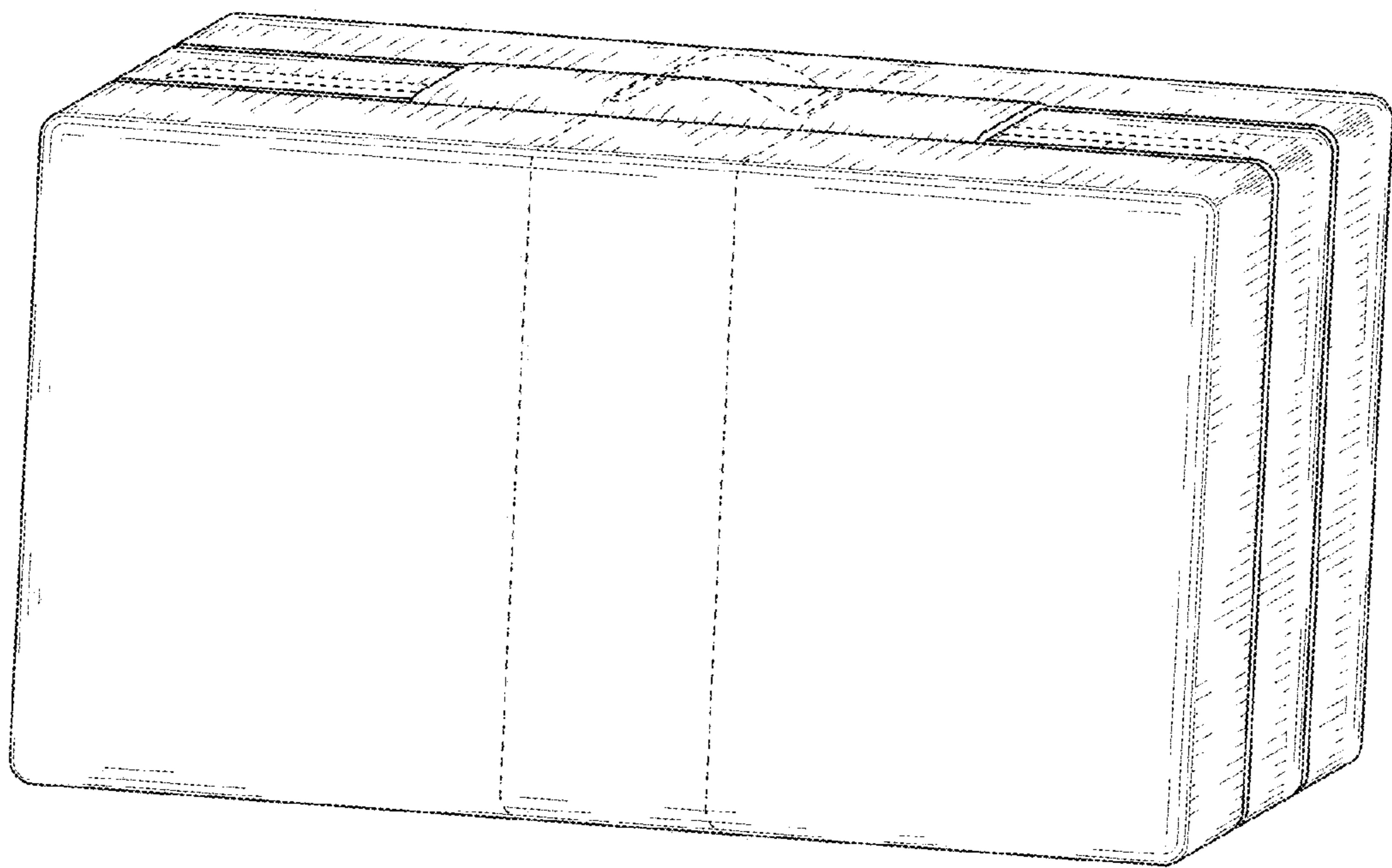




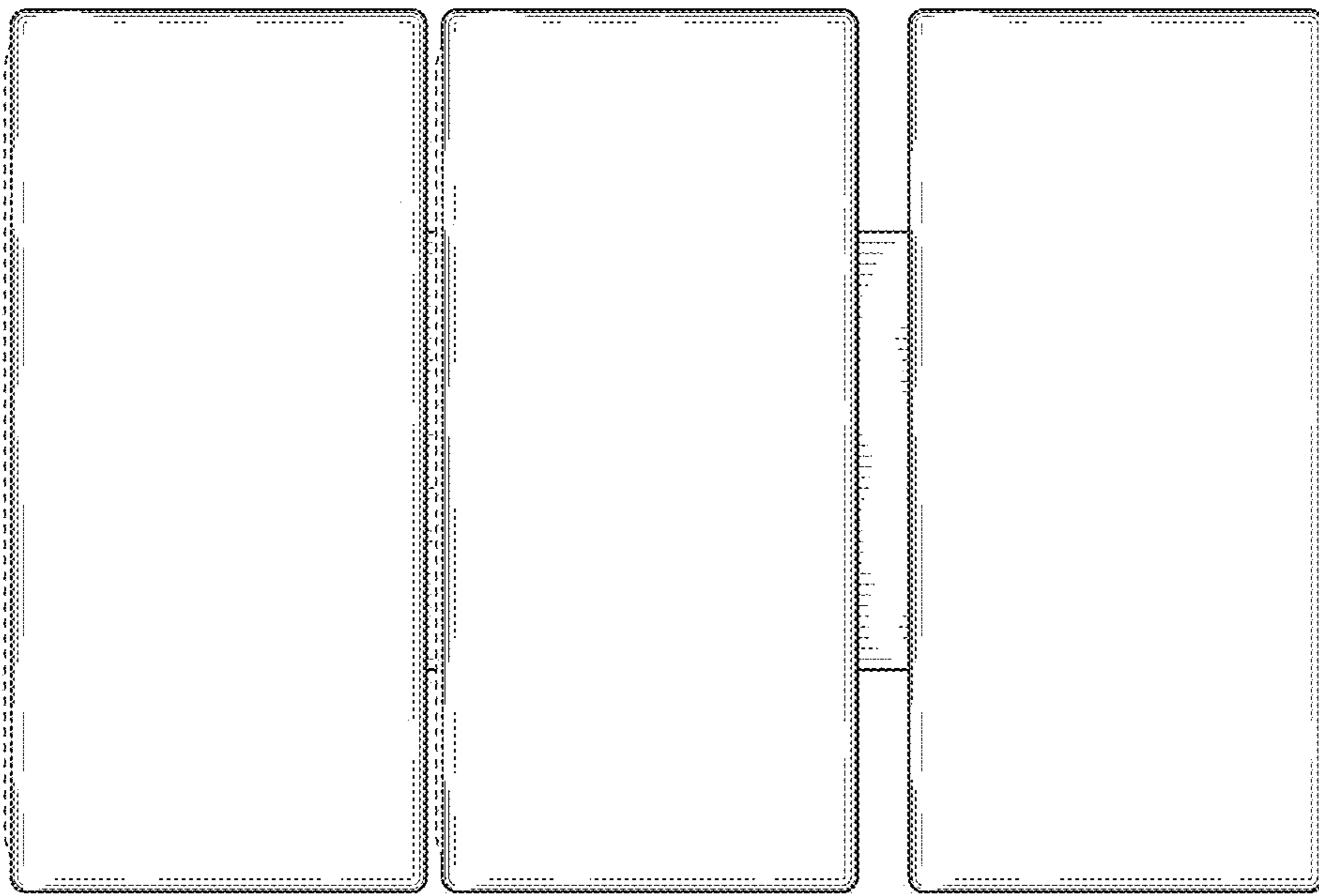

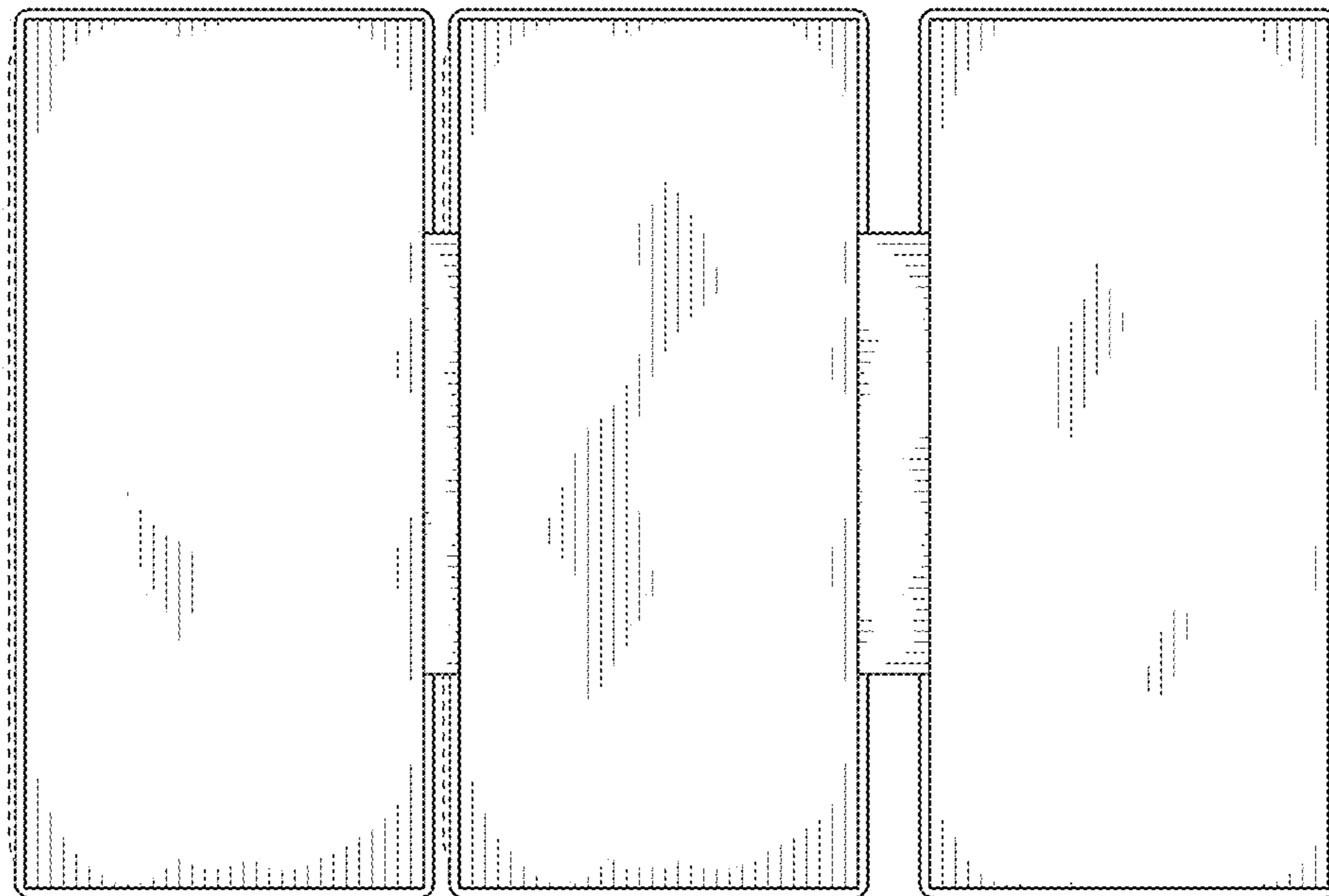

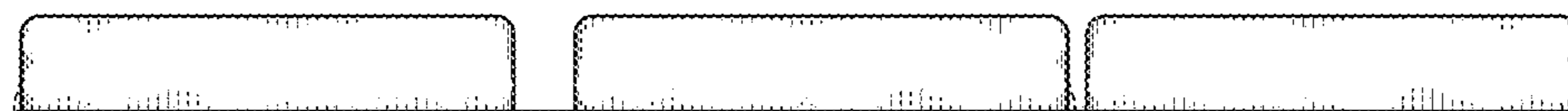

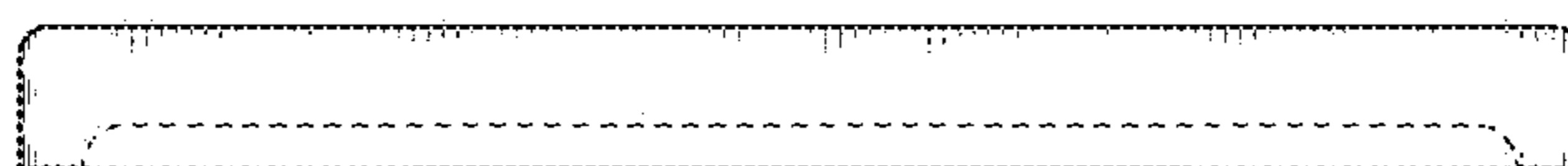

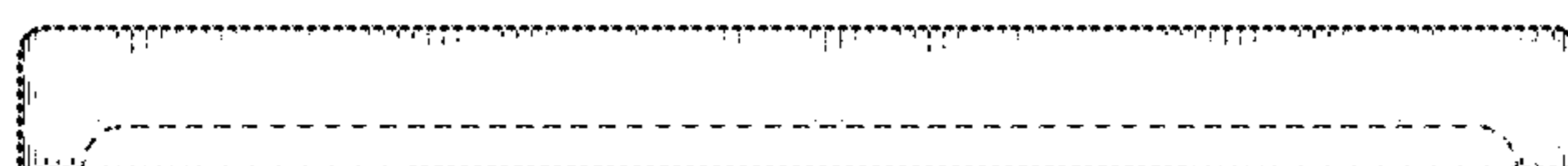
