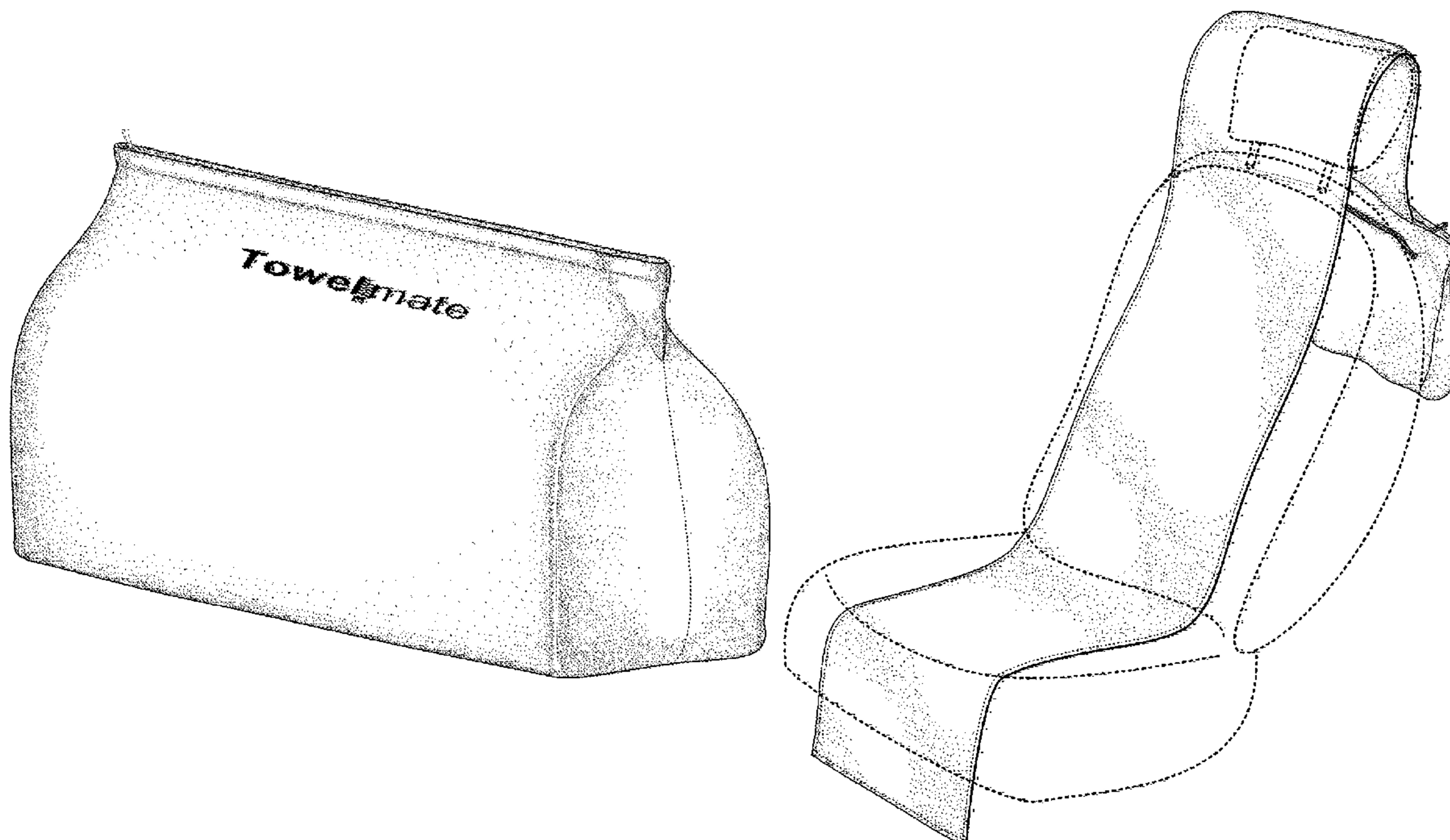
(57) **CLAIM**

The ornamental design for a car seat cover, as shown and described.

DESCRIPTION

FIG. 1 is a front view of the invented car seat cover.
 FIG. 2 is a back view of the embodiment shown in FIG. 1.
 FIG. 3 is a right side view of the embodiment shown in FIG. 1.
 FIG. 4 is a left side view of the embodiment shown in FIG. 1.
 FIG. 5 is a bottom view of the embodiment shown in FIG. 1.
 FIG. 6 is a top view of the embodiment shown in FIG. 1.
 FIG. 7 is a perspective back view of the embodiment of FIG. 1.
 FIG. 8 is a perspective front view of the embodiment of FIG. 1.
 FIG. 9 is a front view of the embodiment of FIG. 1 showing the enclosed cover unfurled; and,
 FIG. 10 is a view of the embodiment of FIG. 1 as installed on a car seat. The car seat shown in dashed lines is not claimed the dashed lines on the car seat cover itself represent stitching.

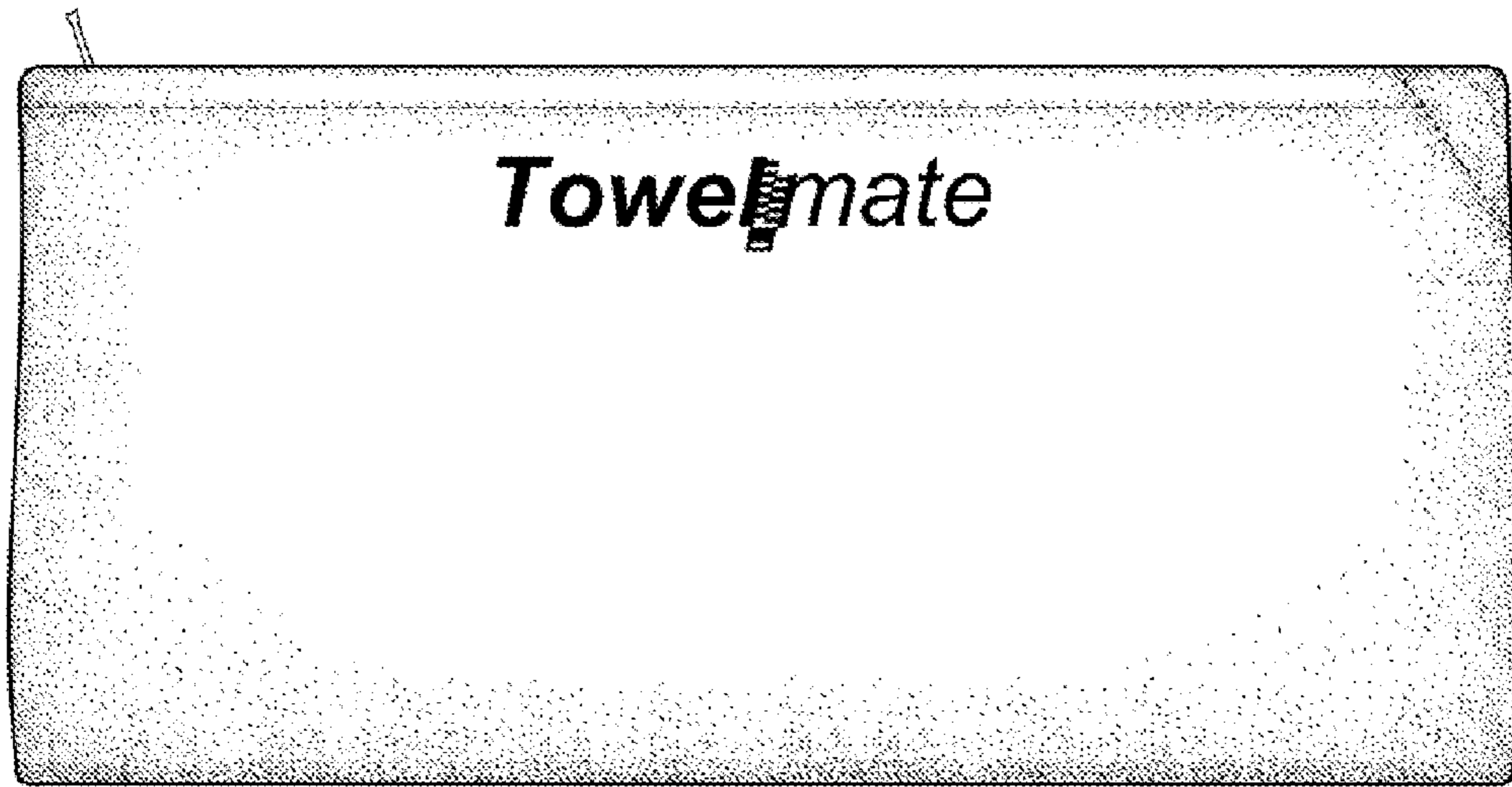

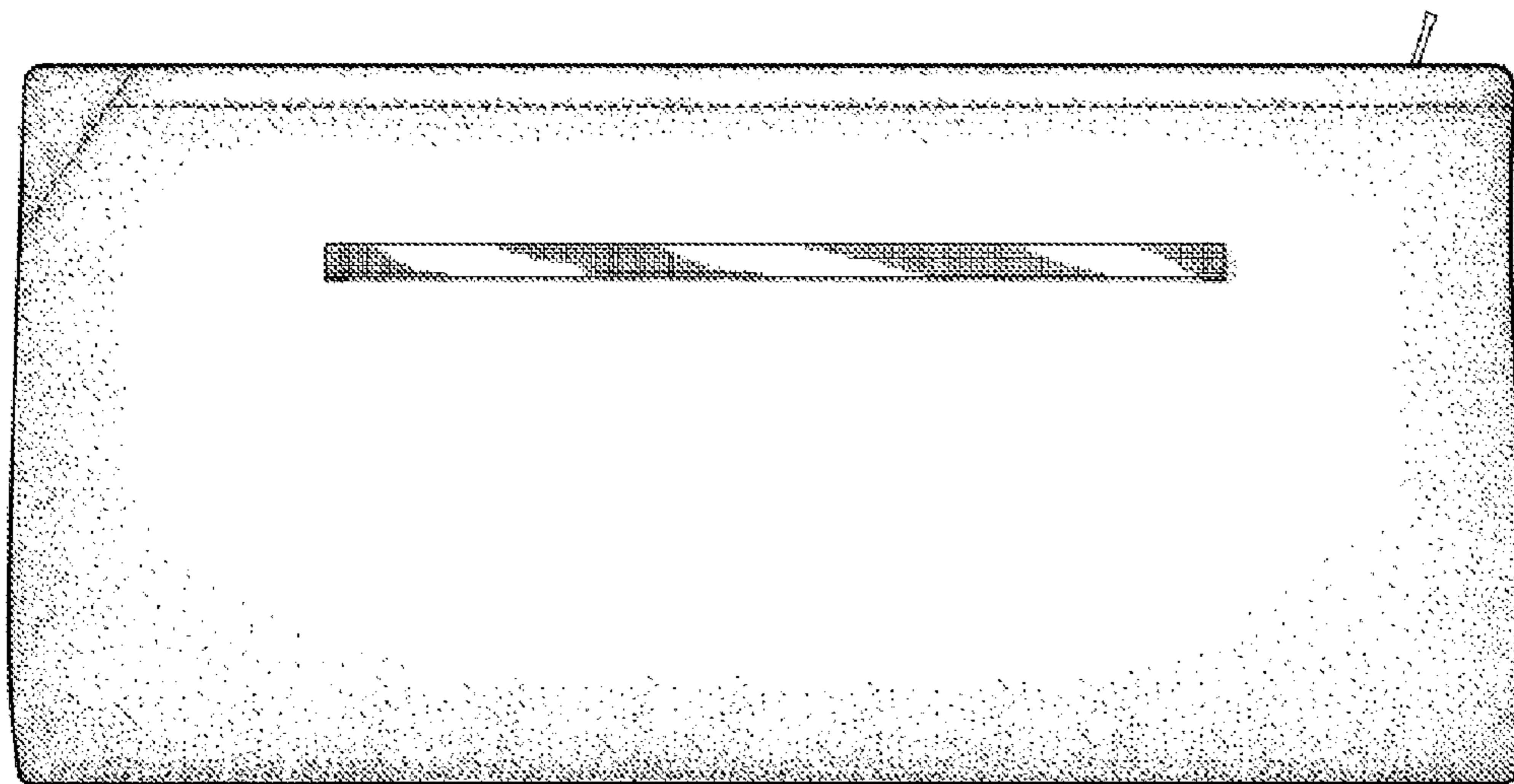

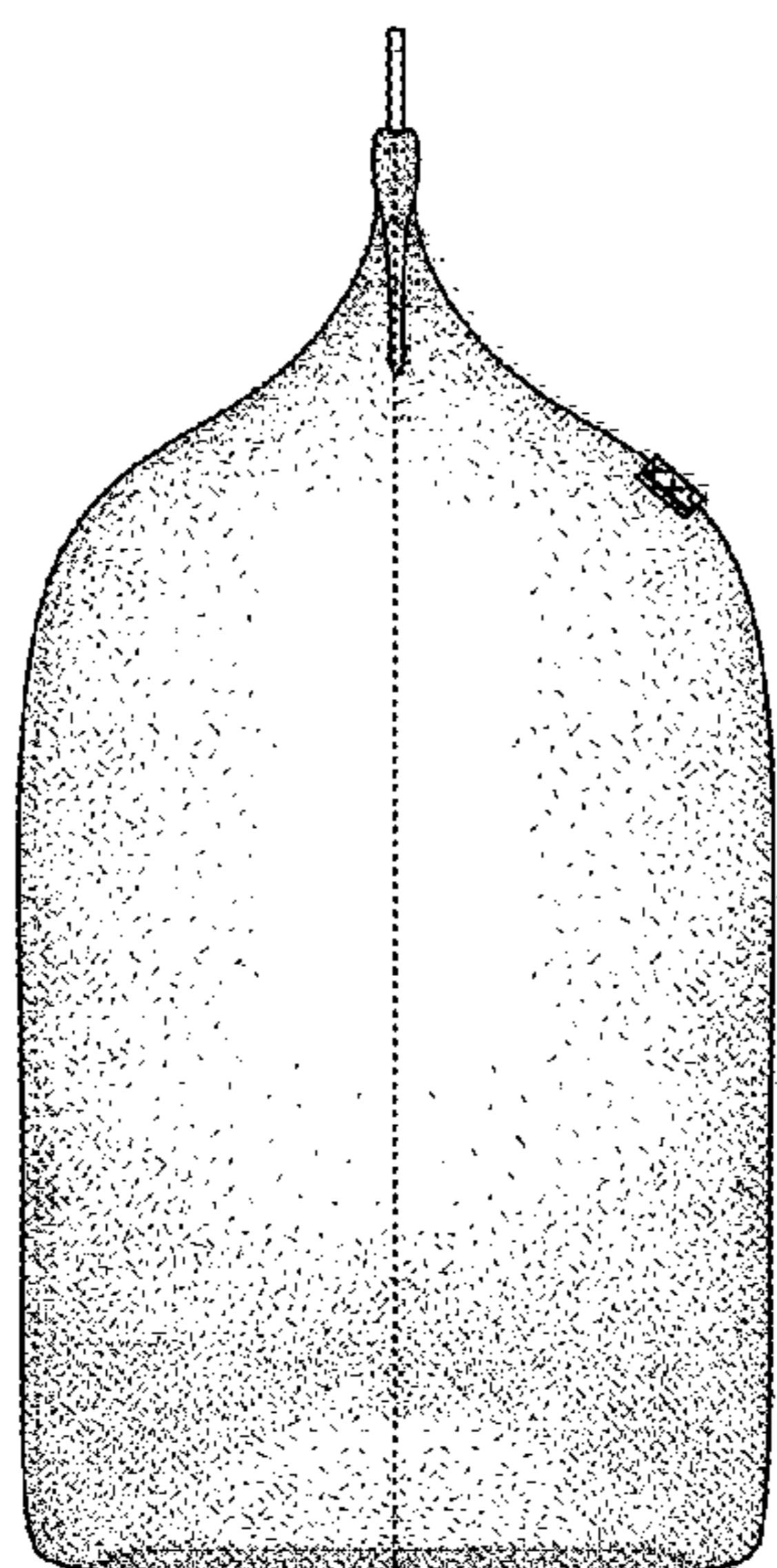

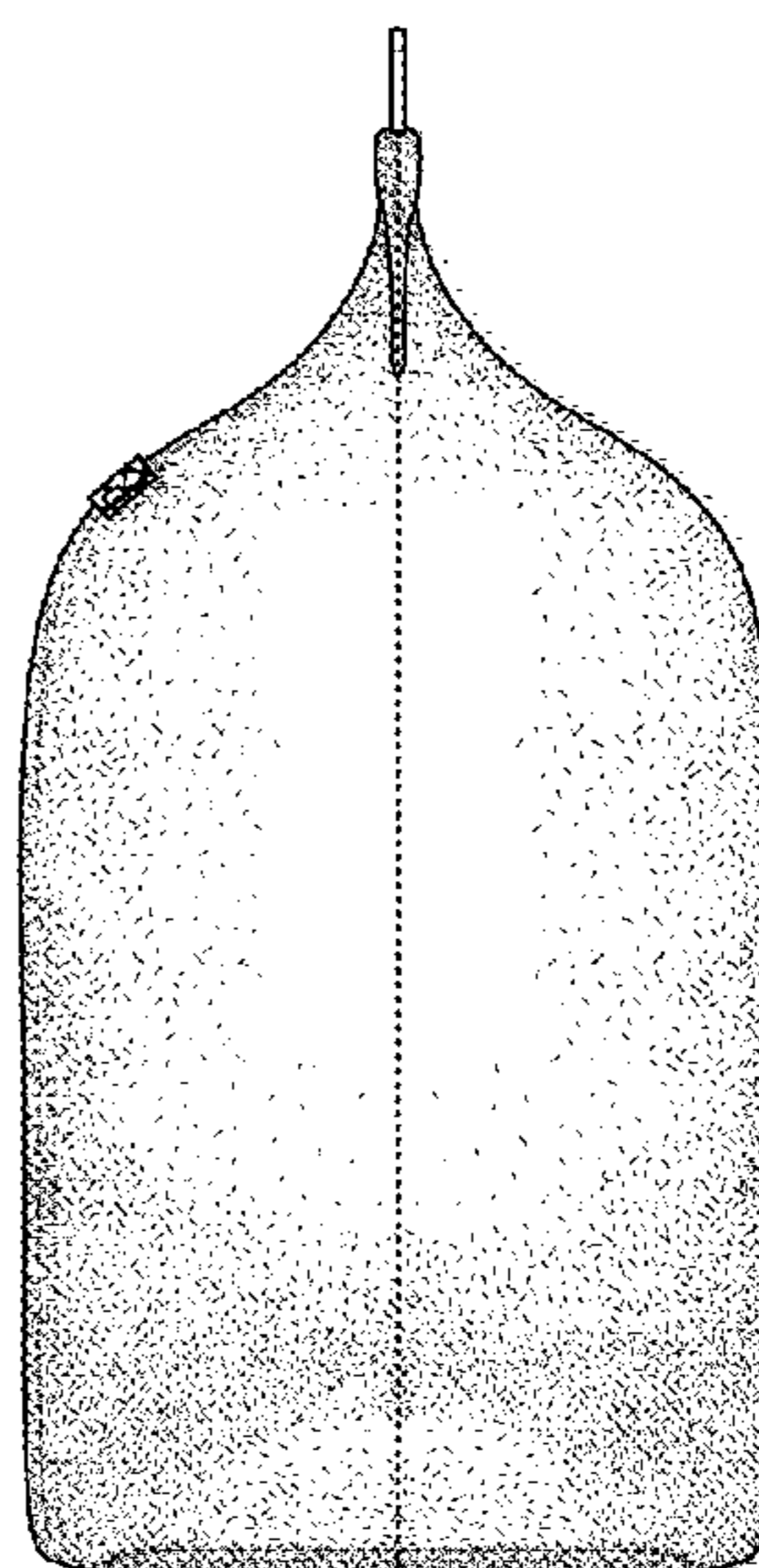

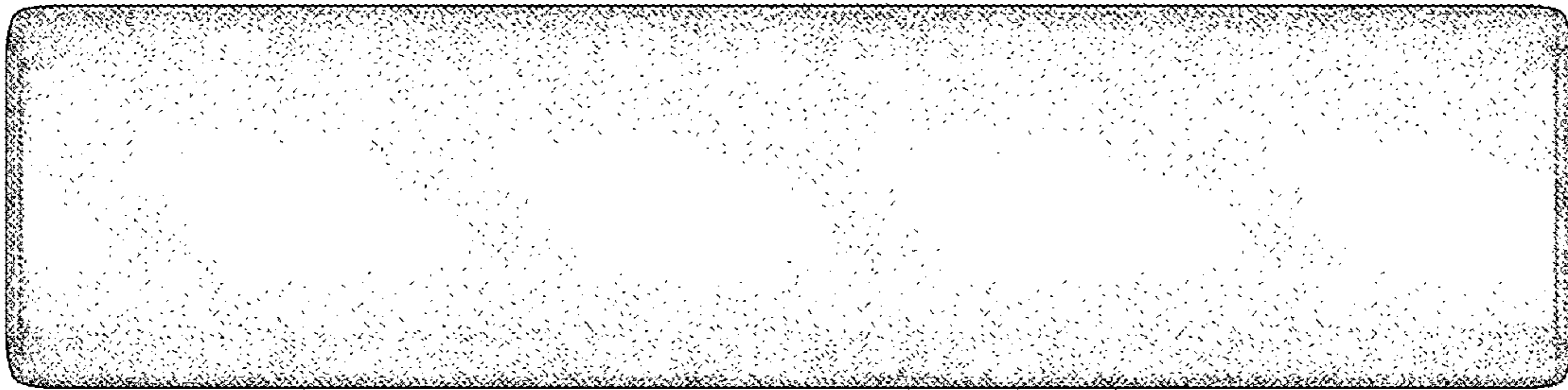

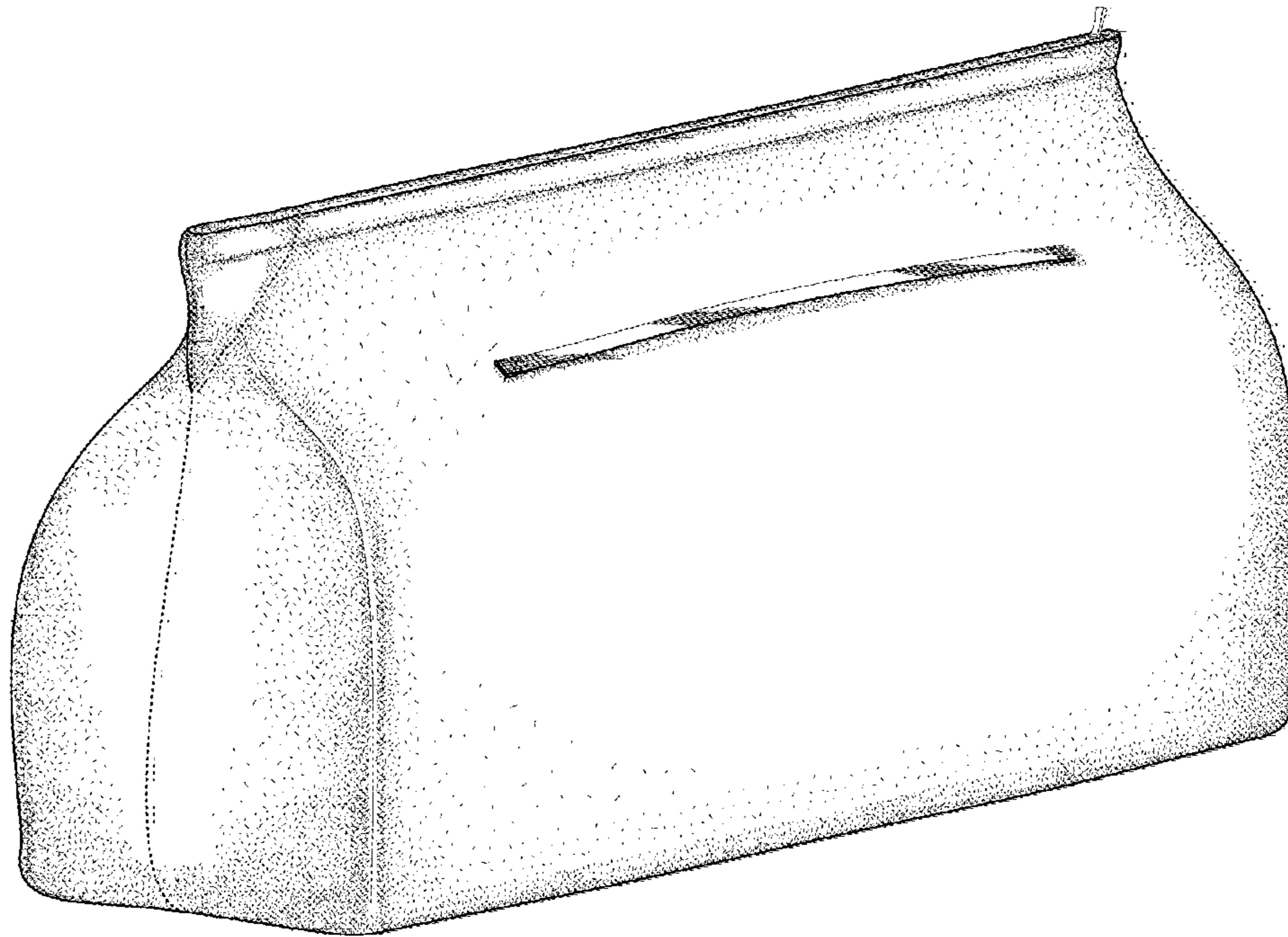

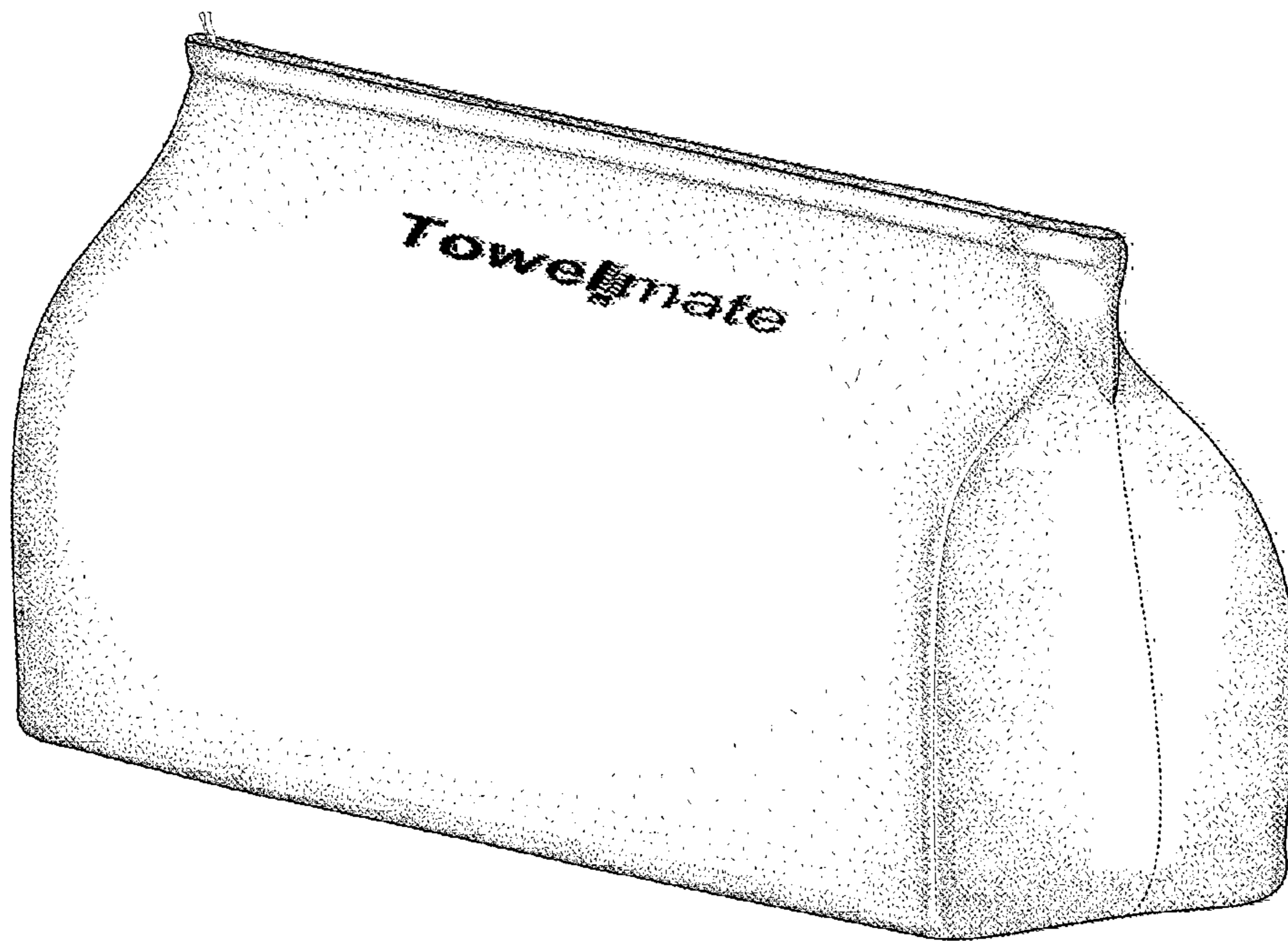

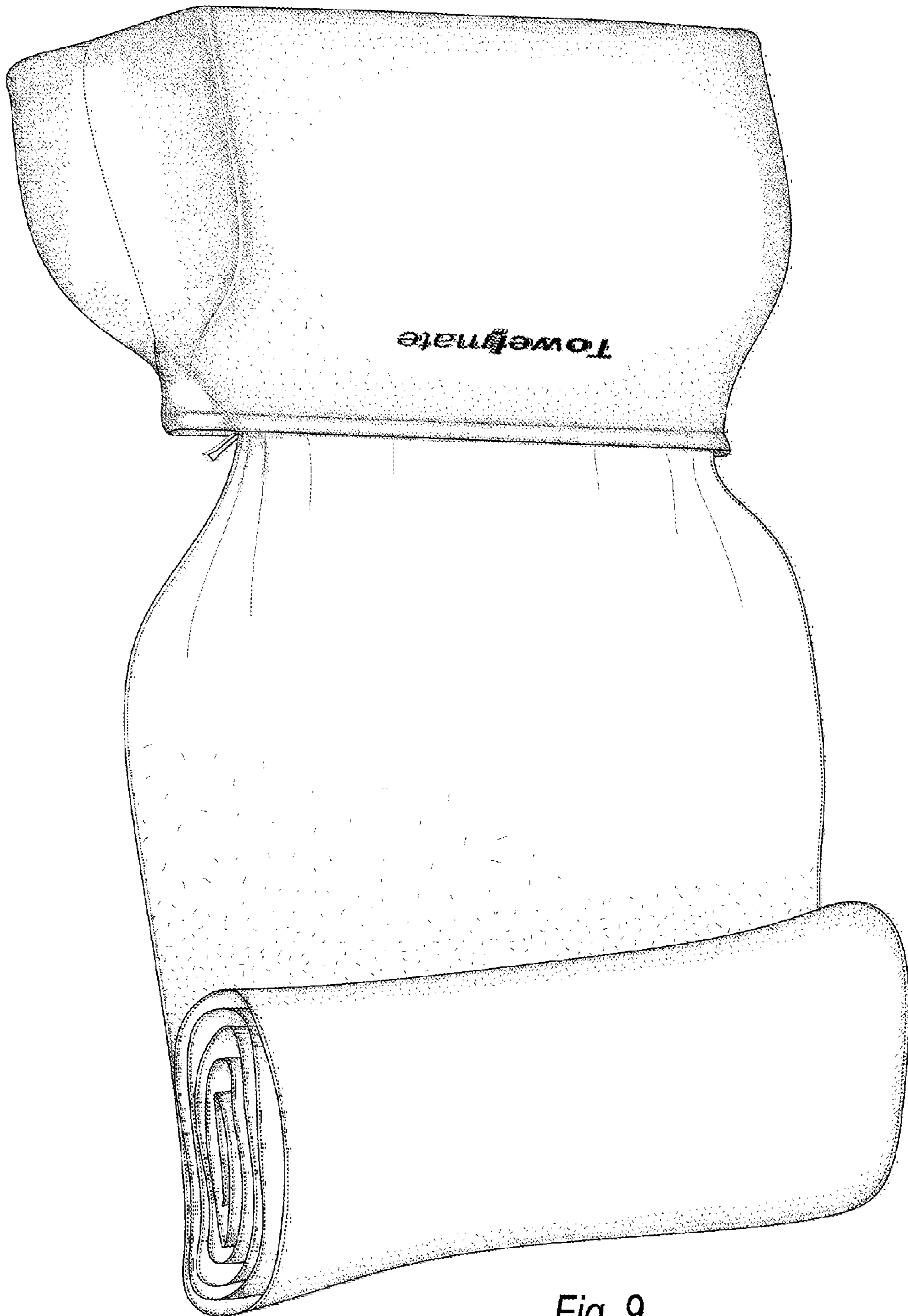

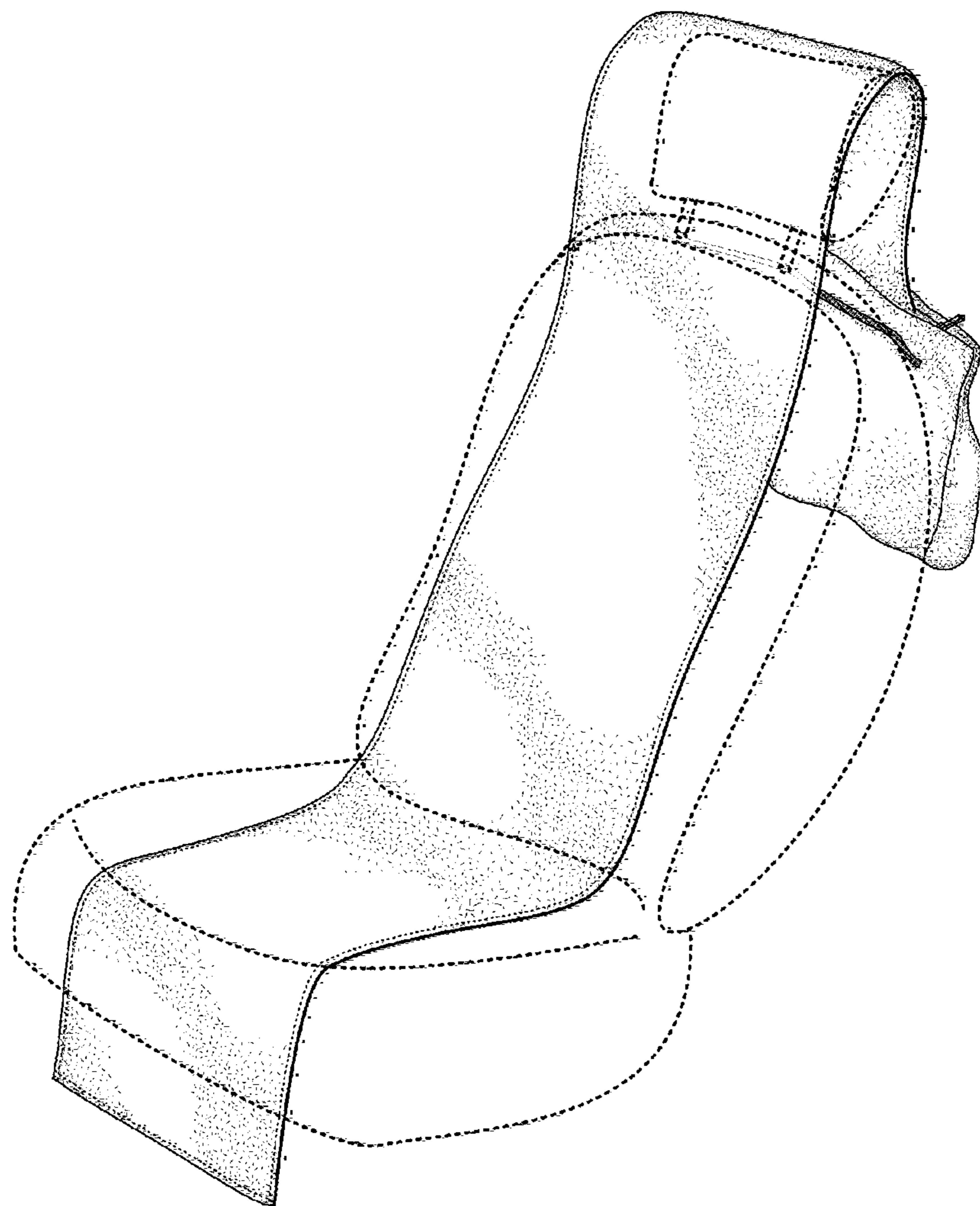
