FIG. 5 is a left side view of the bracelet.

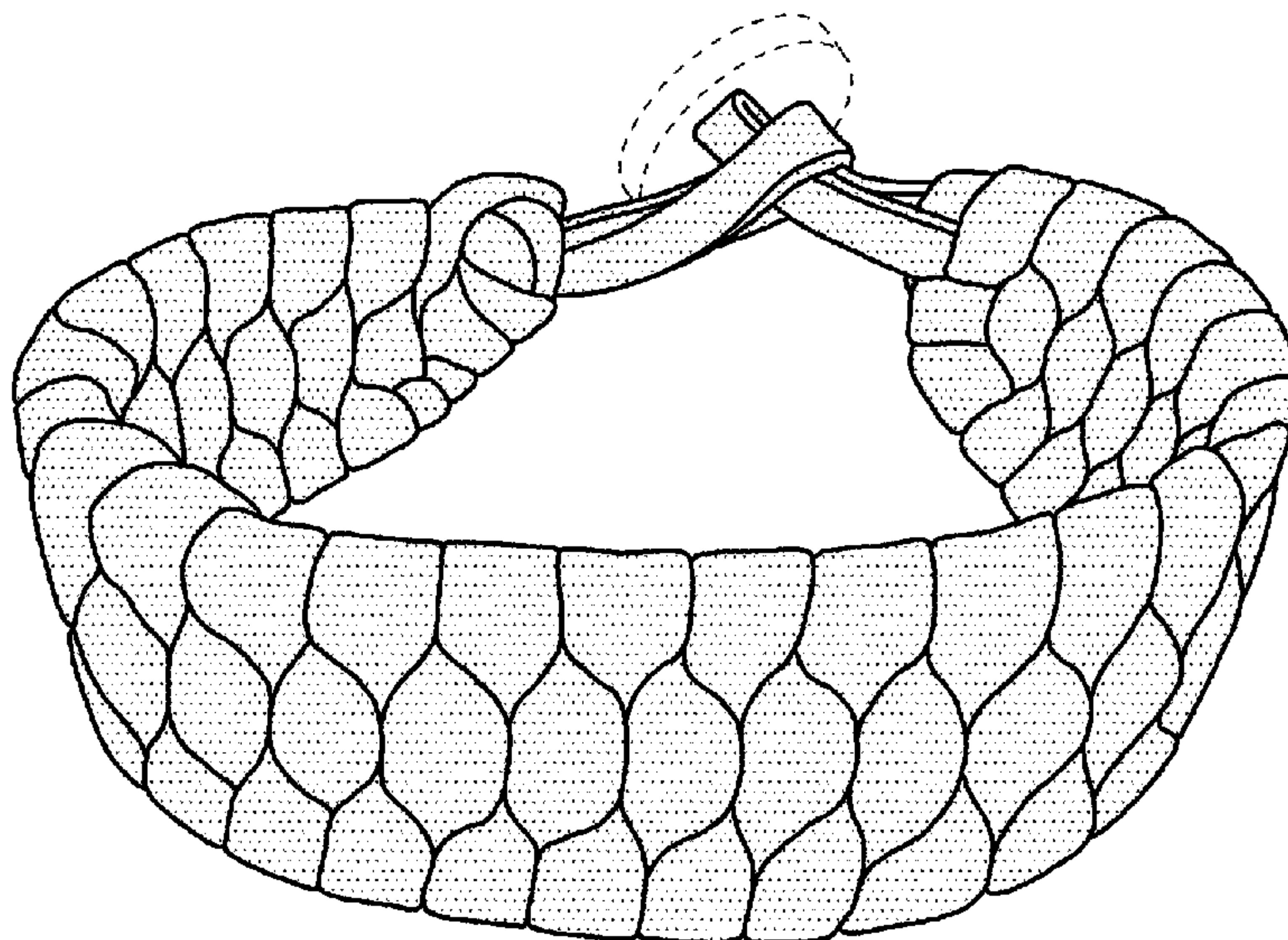
FIG. 6 is a top view of the bracelet.

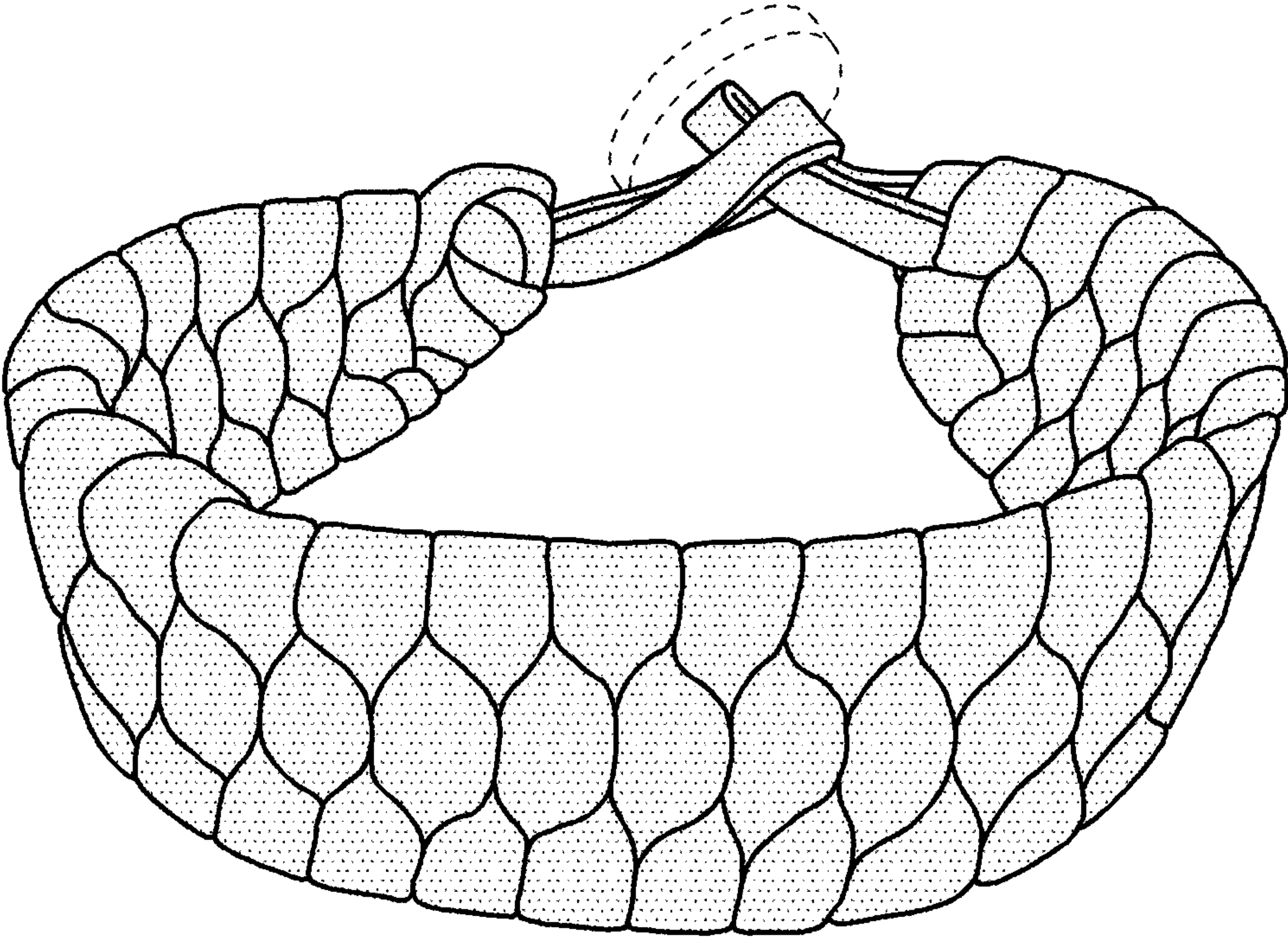

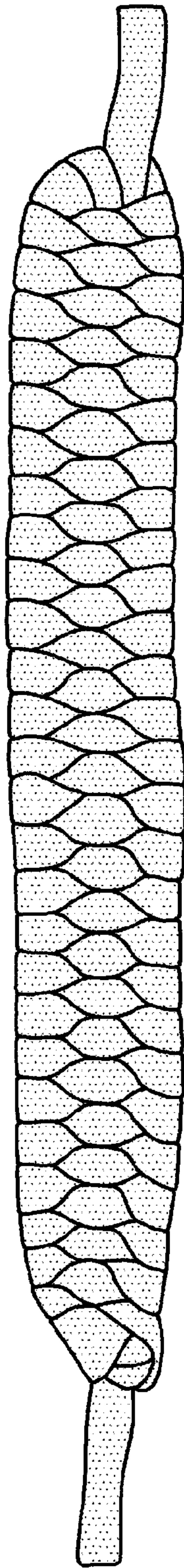

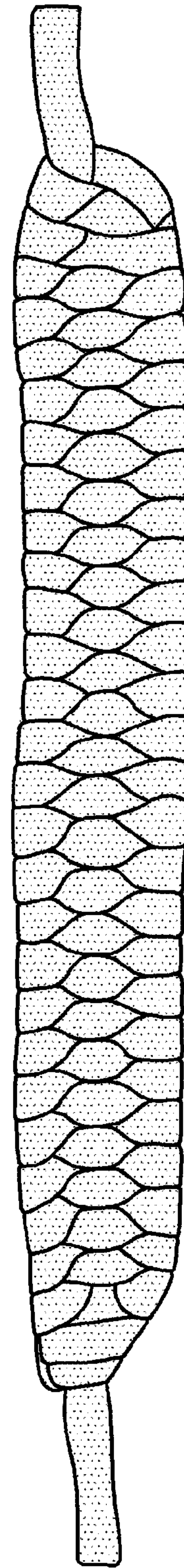

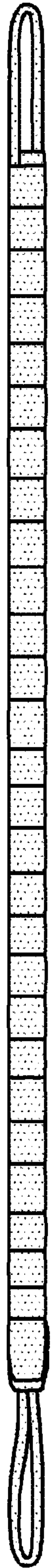

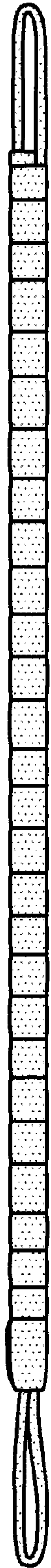

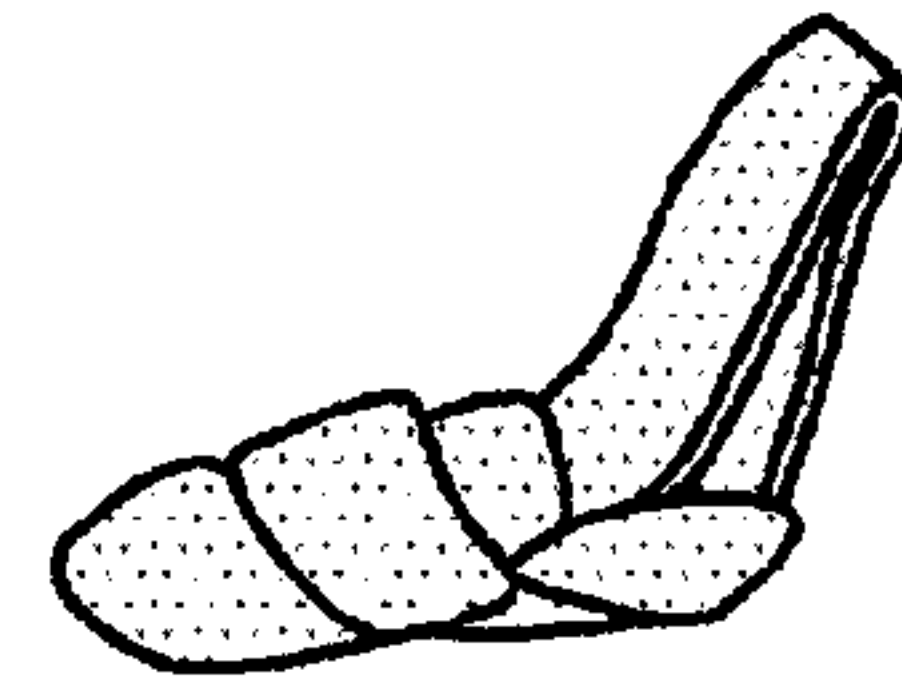

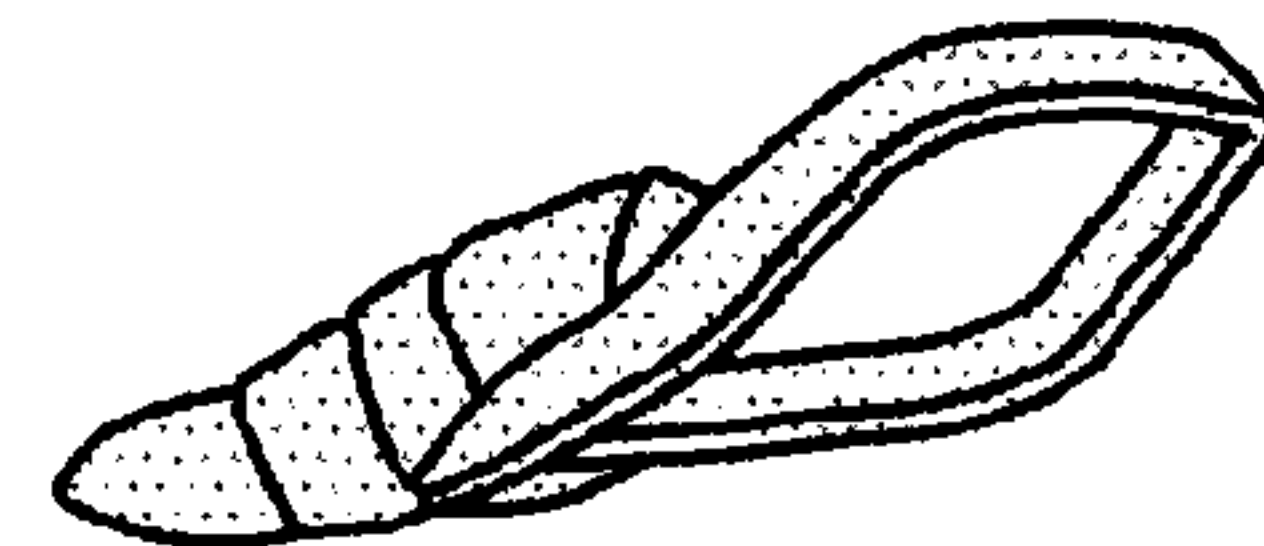
