FIG. 11 is a top view thereof; and,

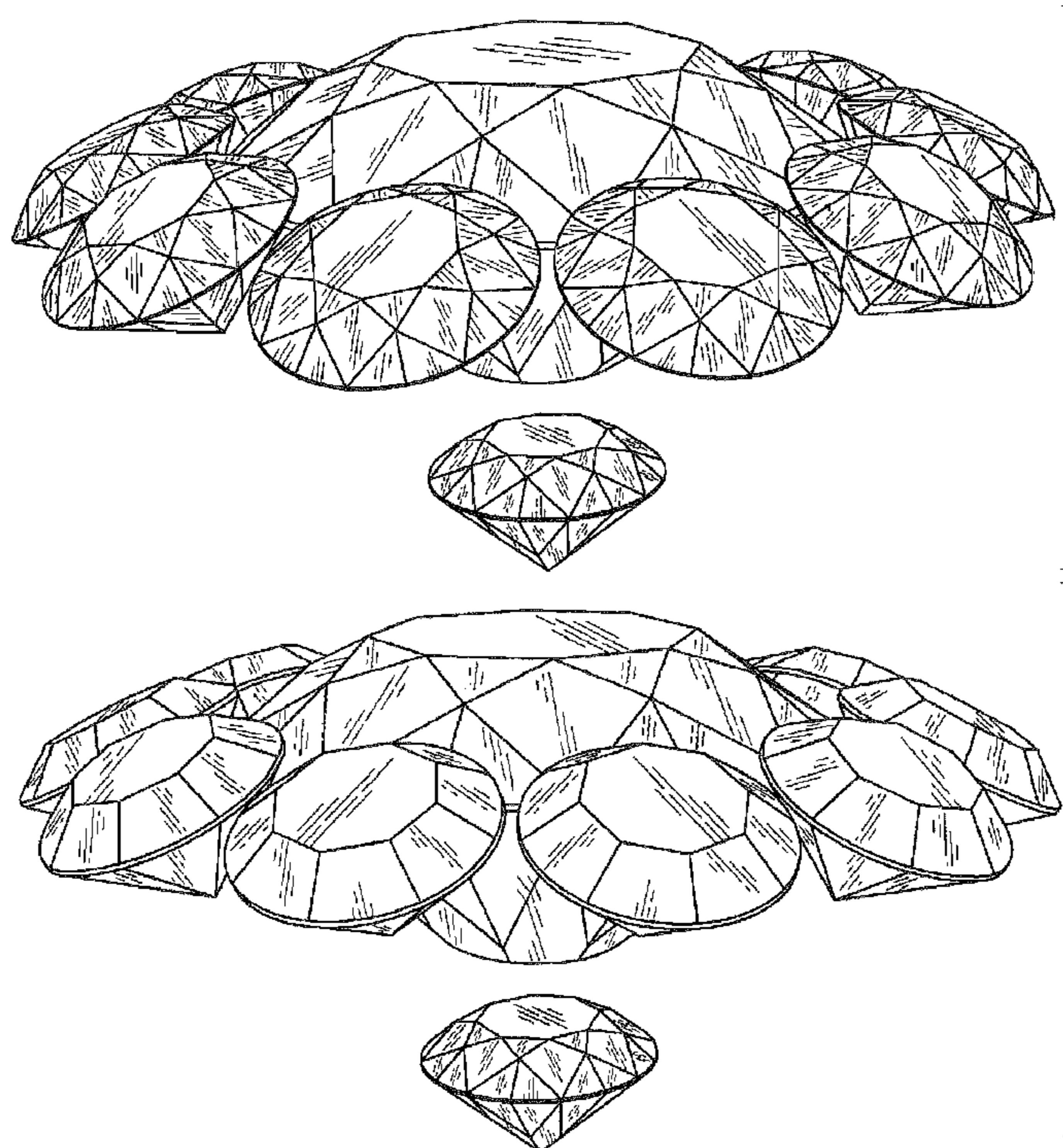
FIG. 12 a bottom view thereof.

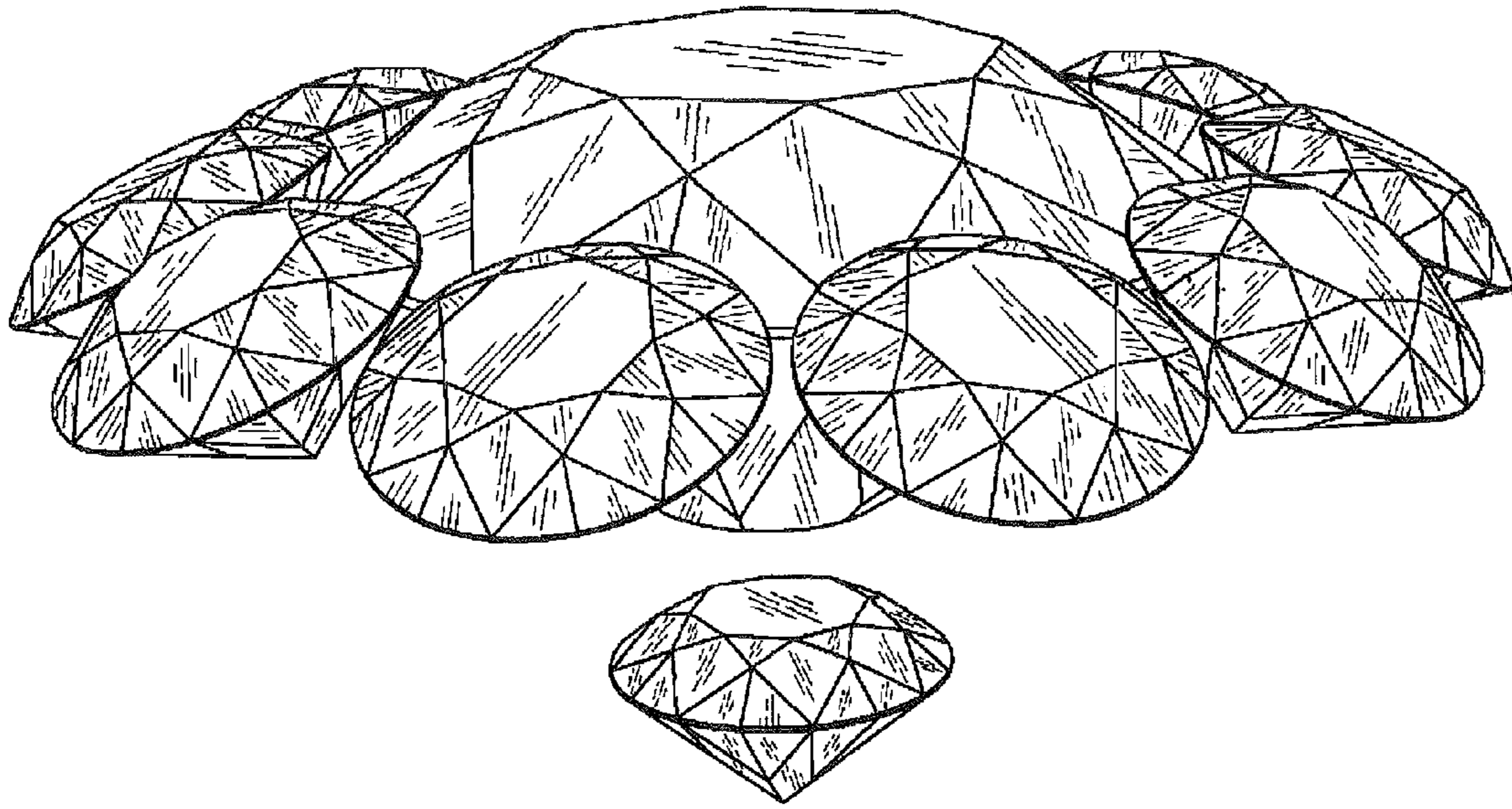

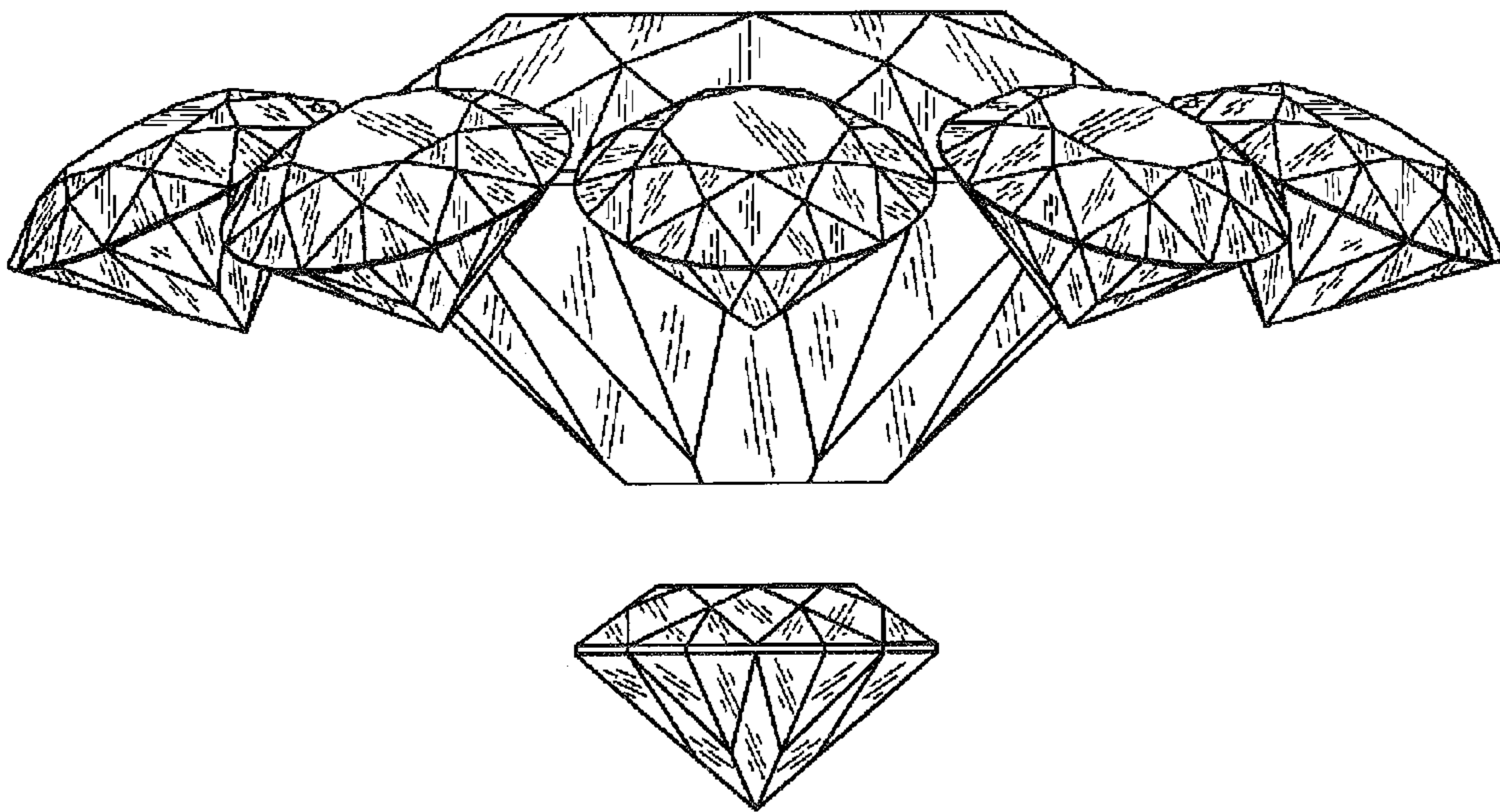

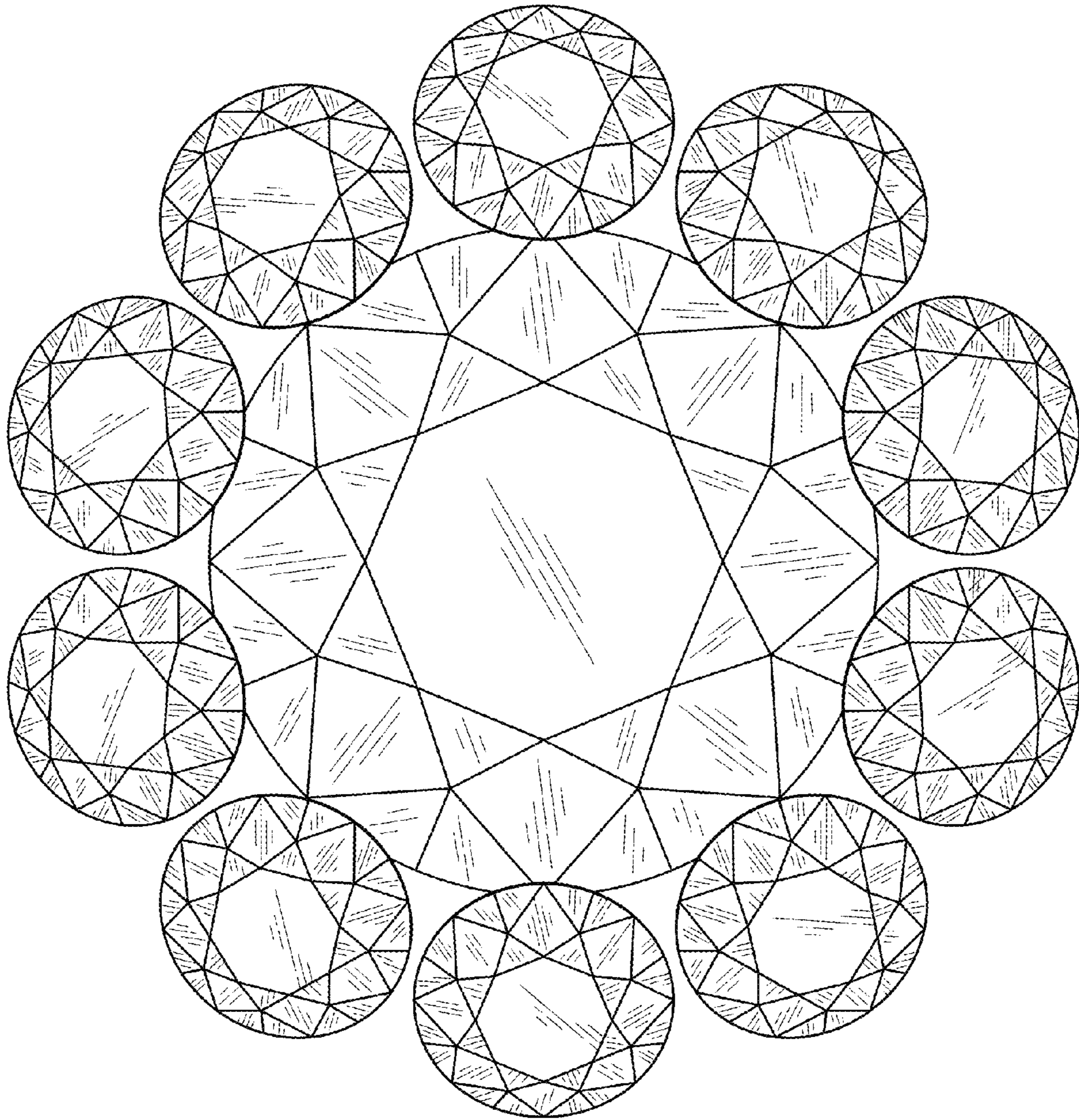

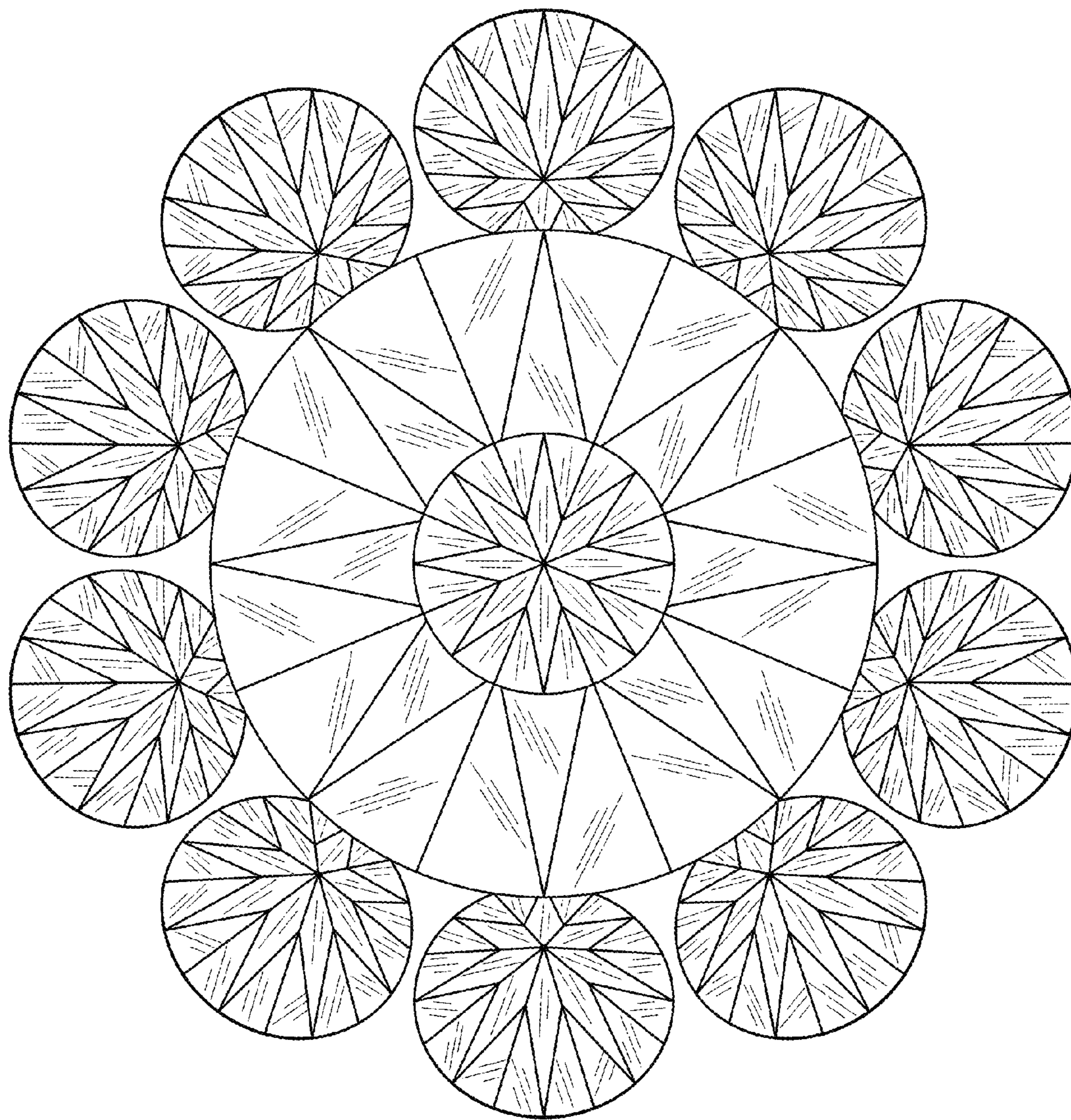

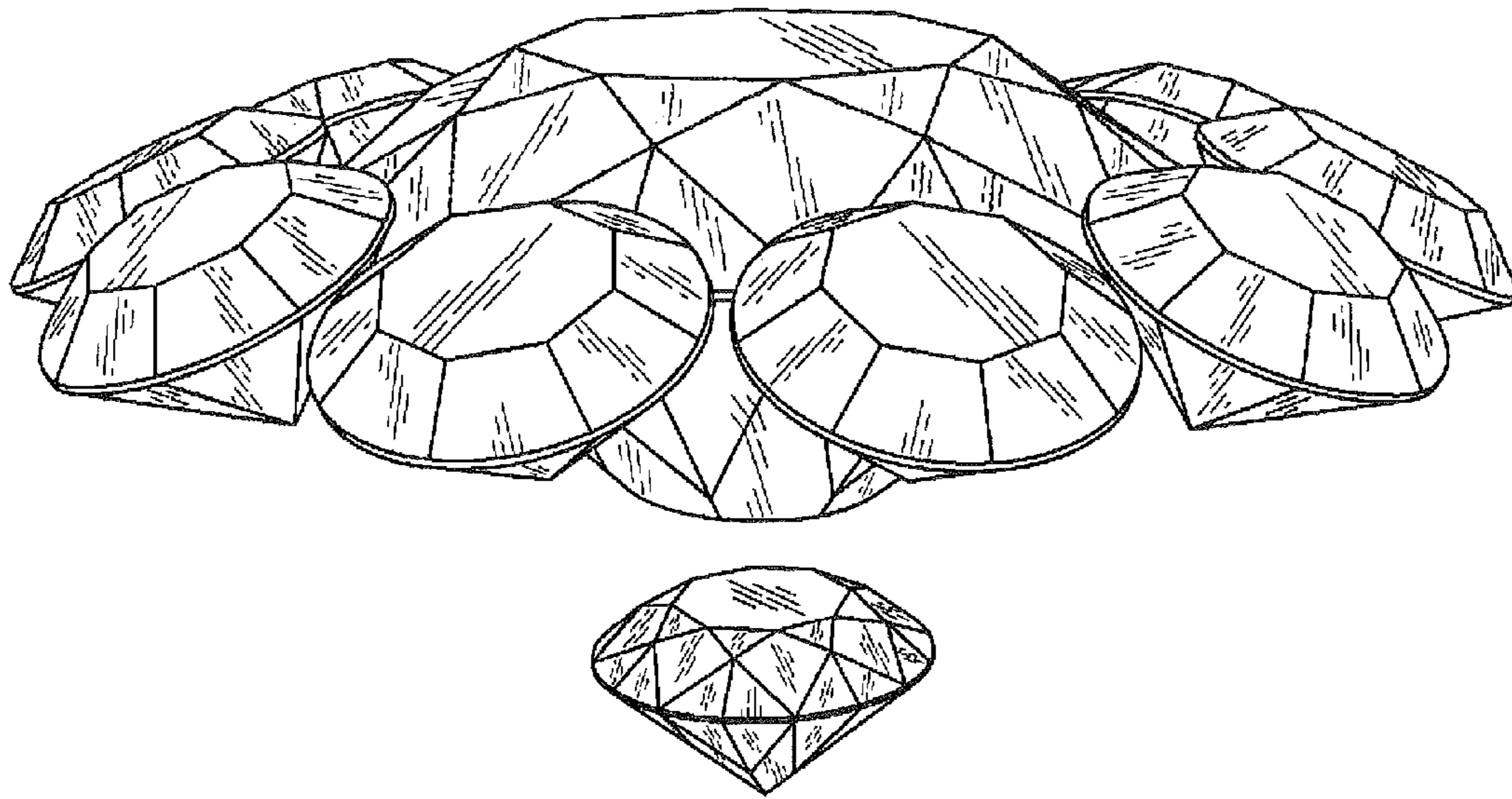

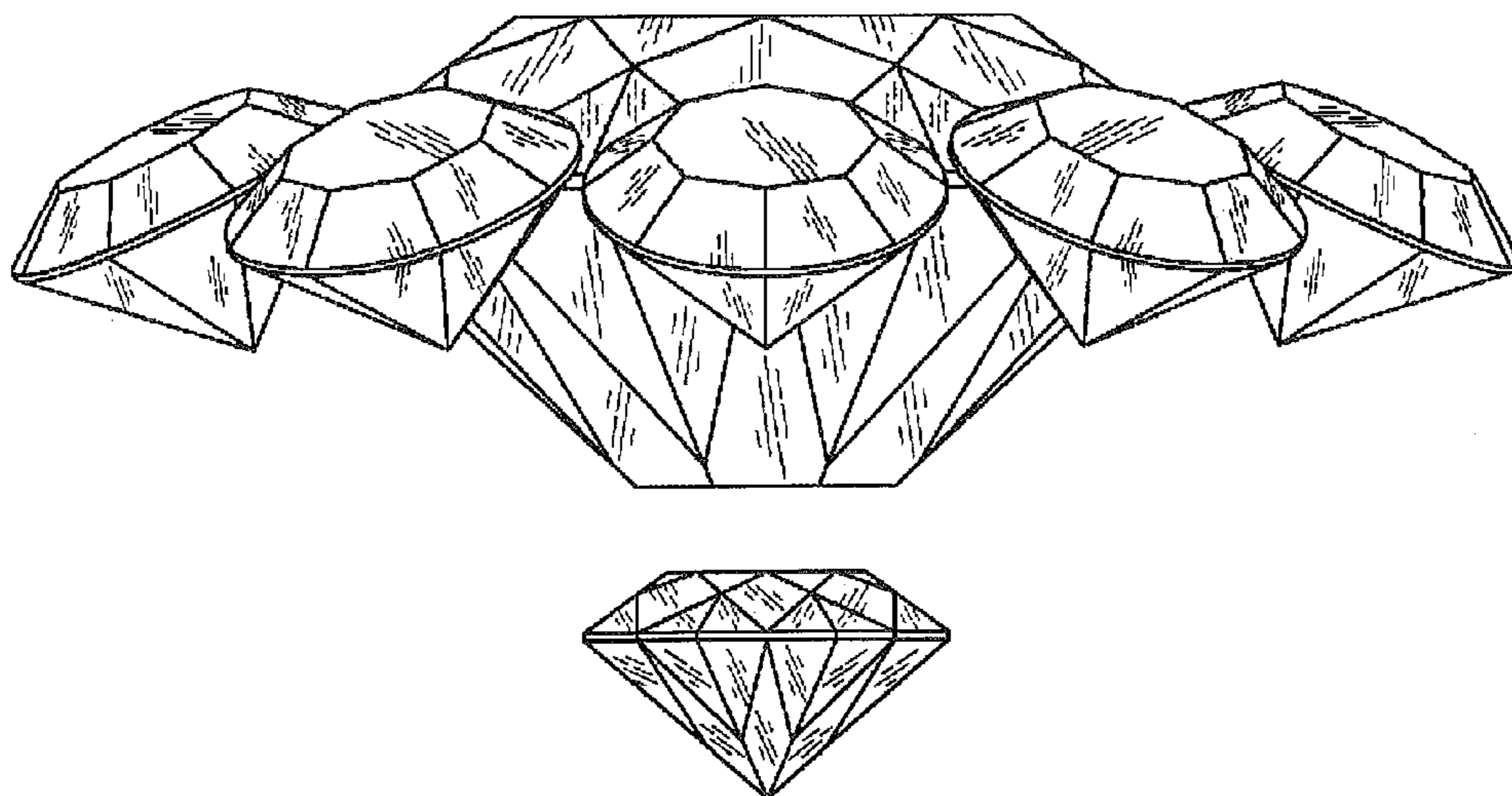

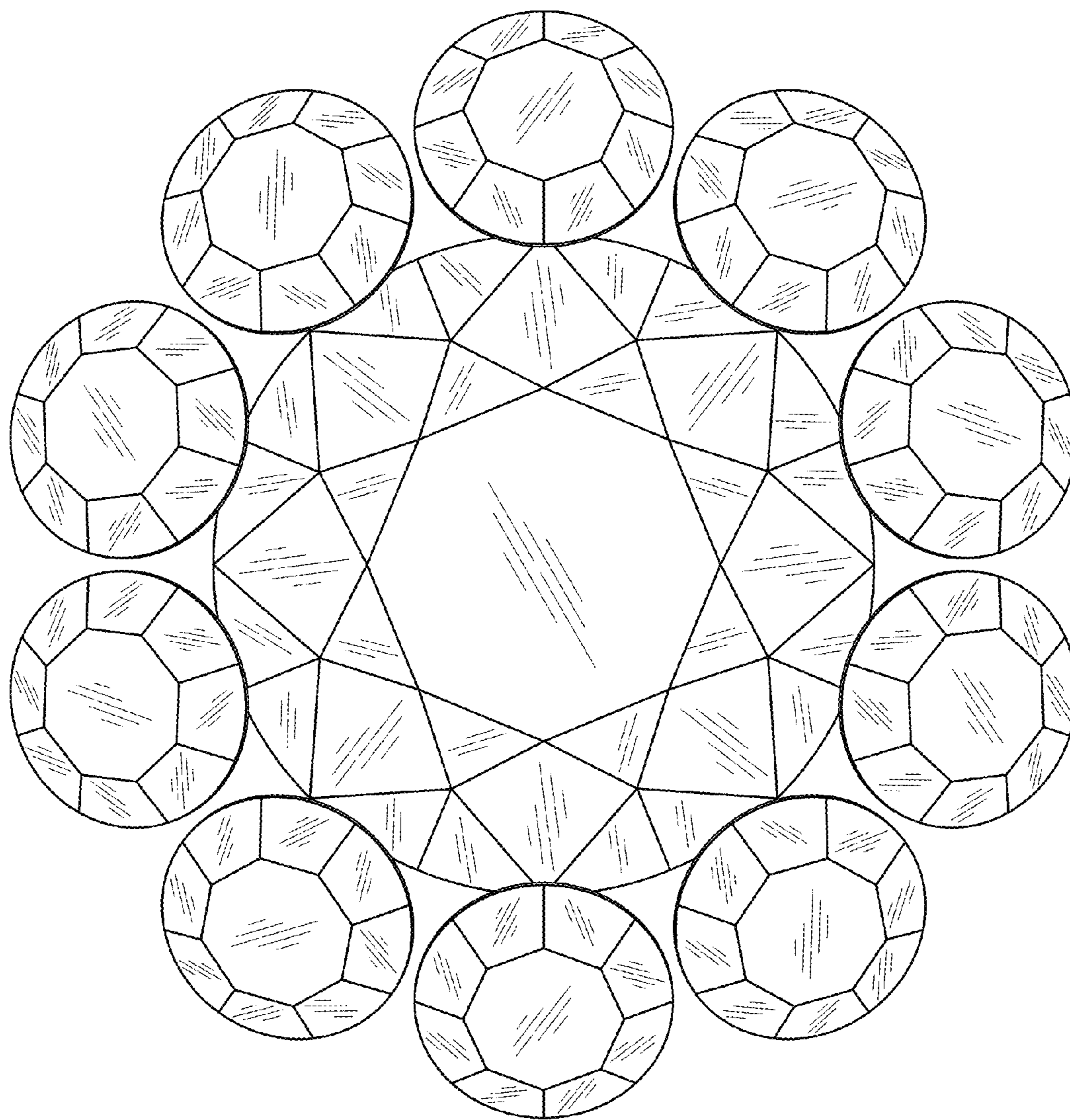

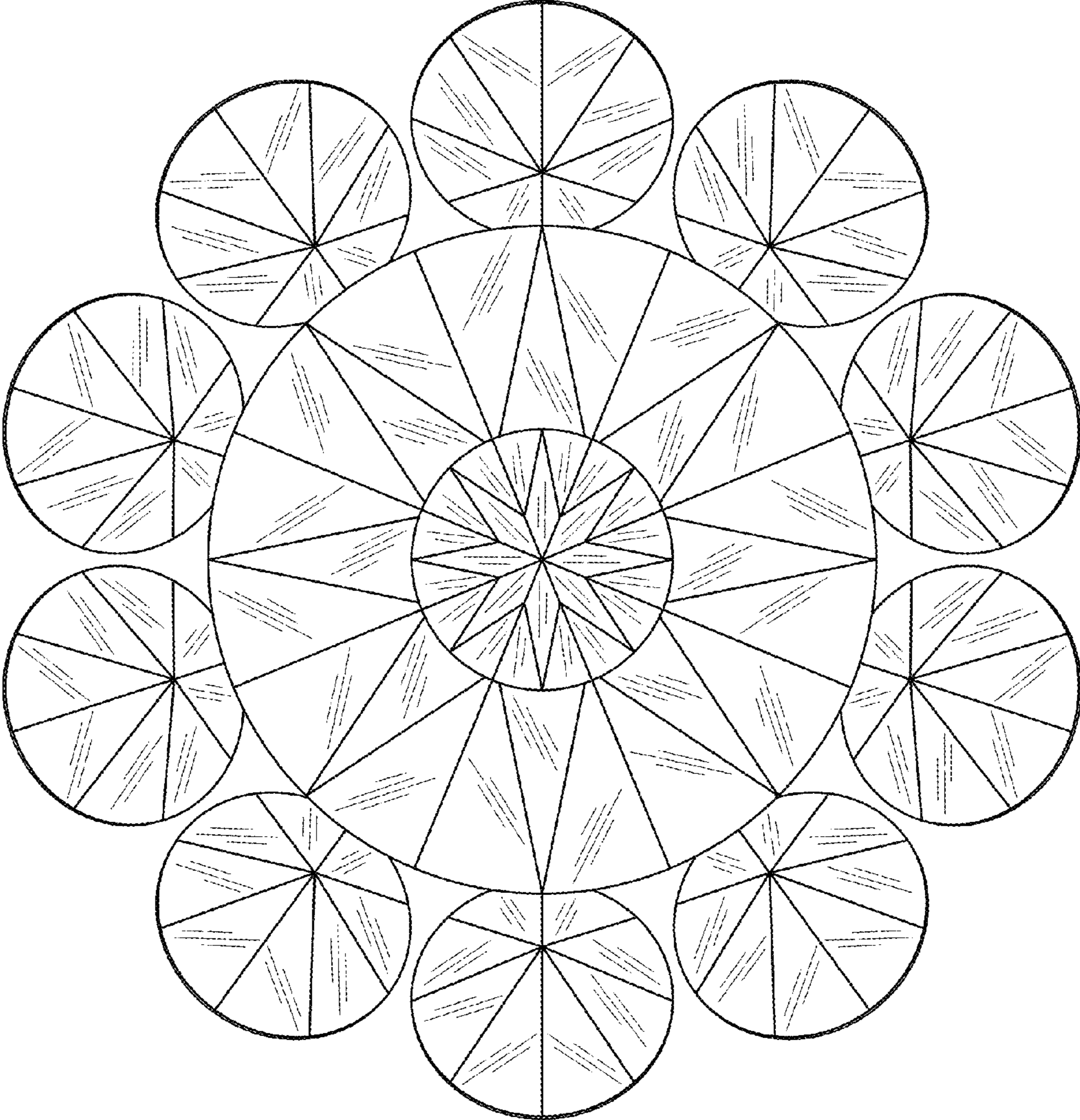

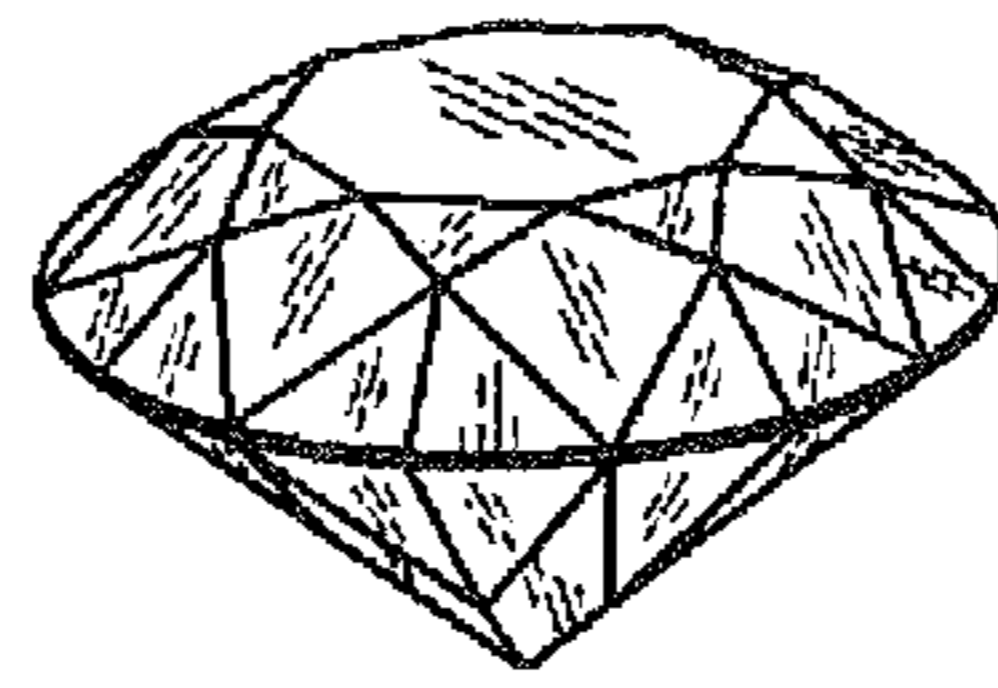
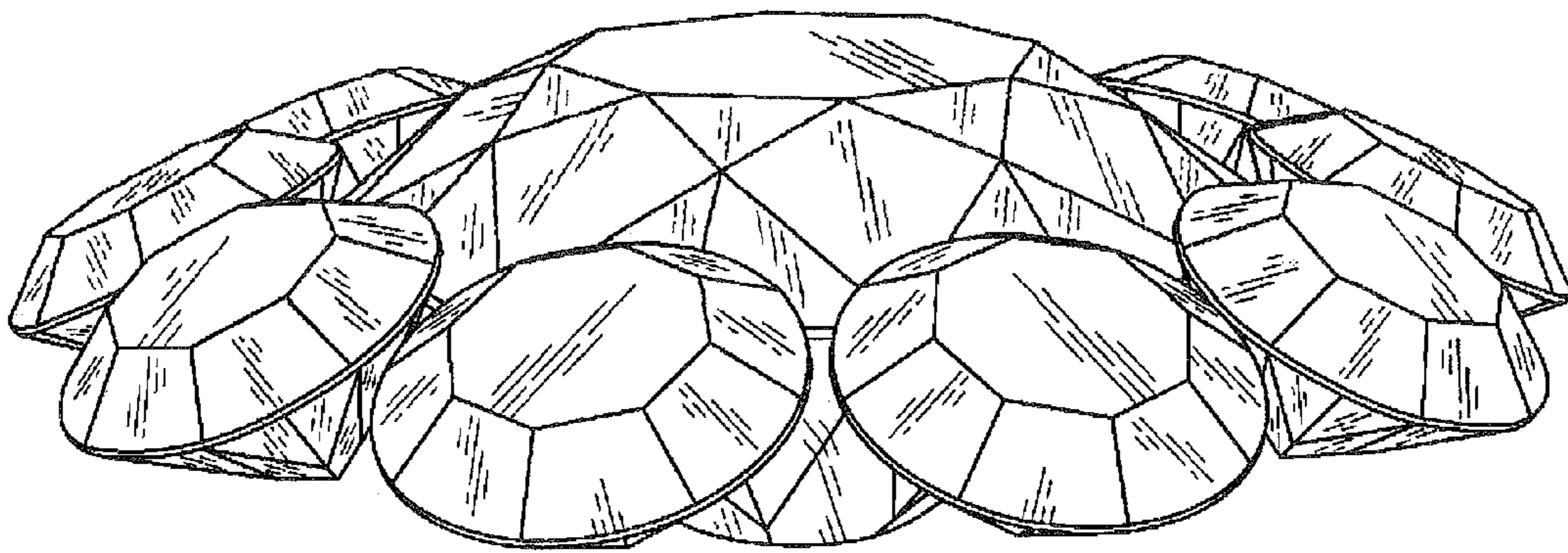

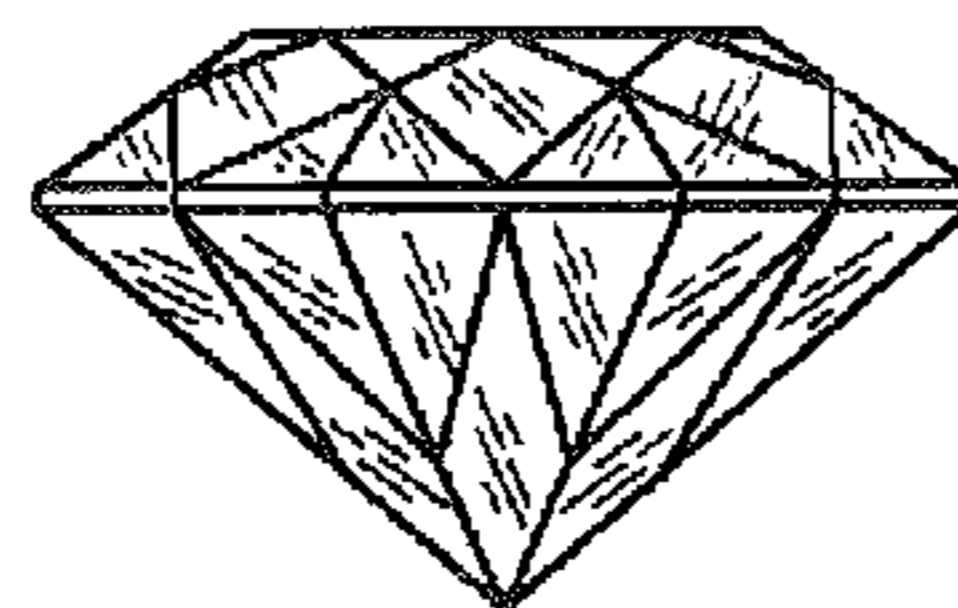
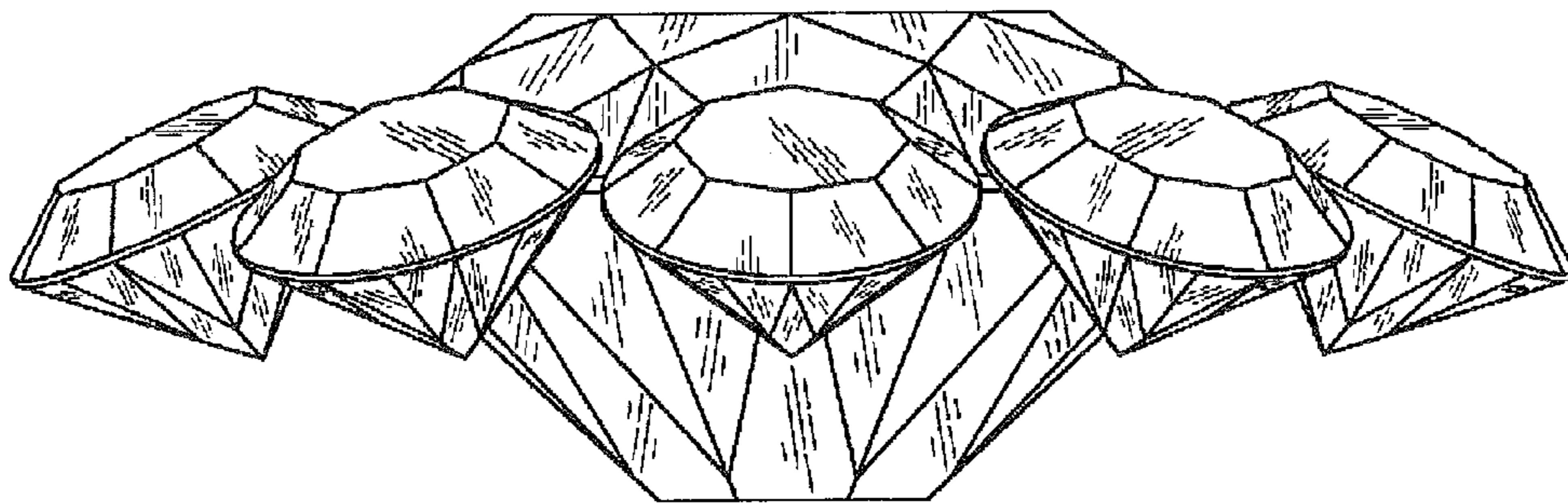

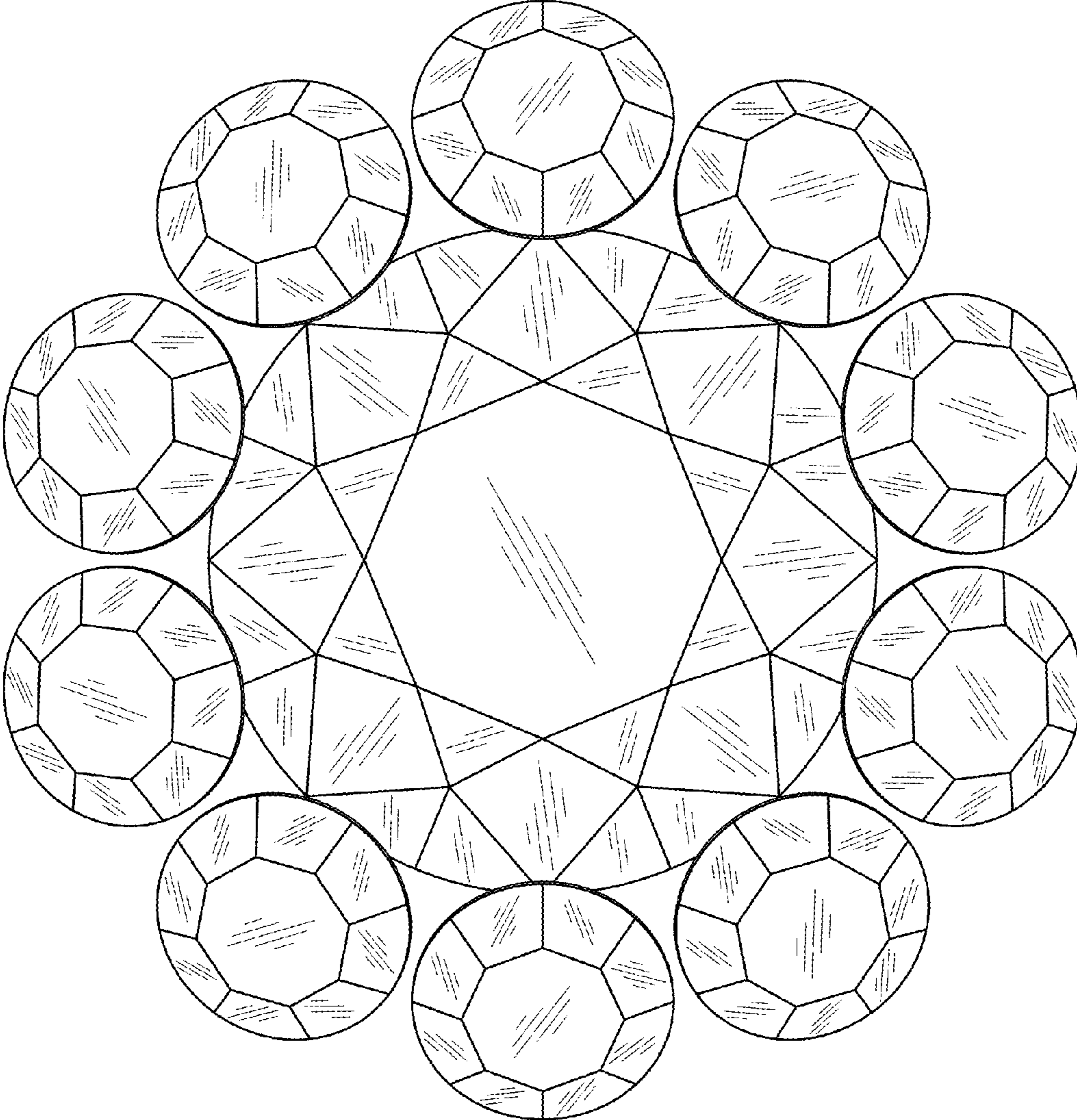

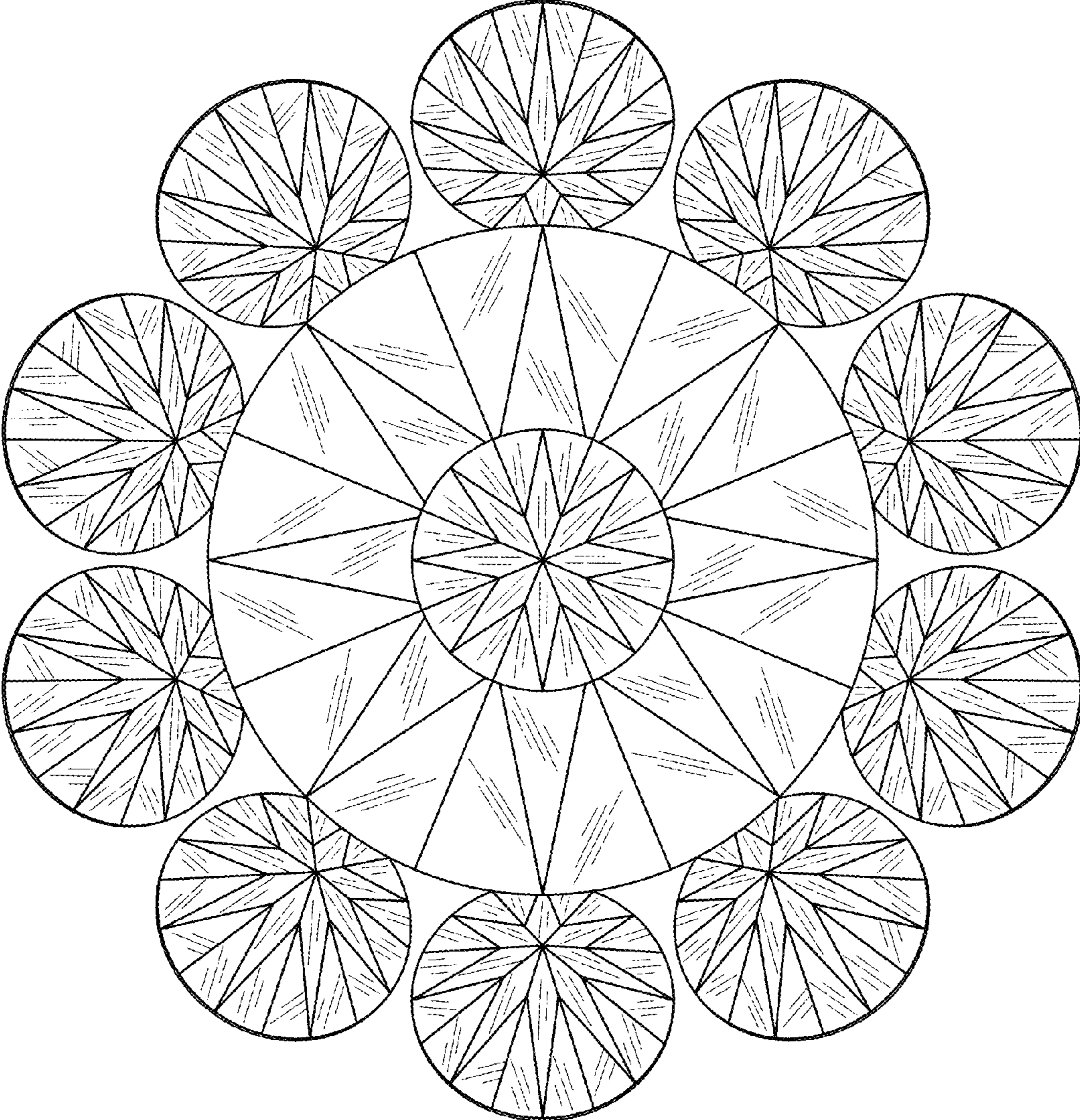
