FIG. 1 is a front elevational view of a hood for an automobile in accordance with our new design;

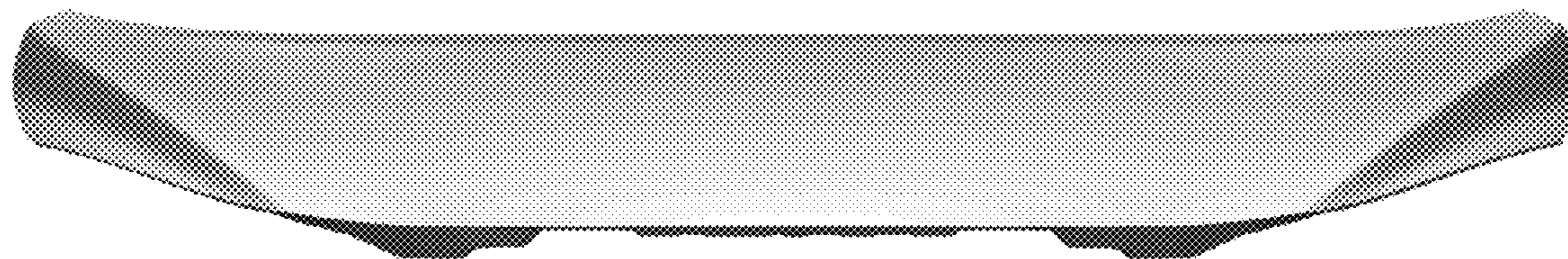
FIG. 2 is a top plan view thereof;

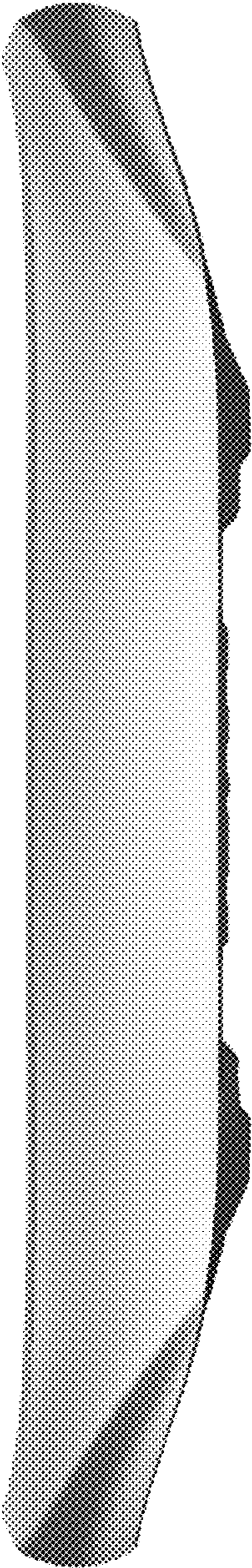

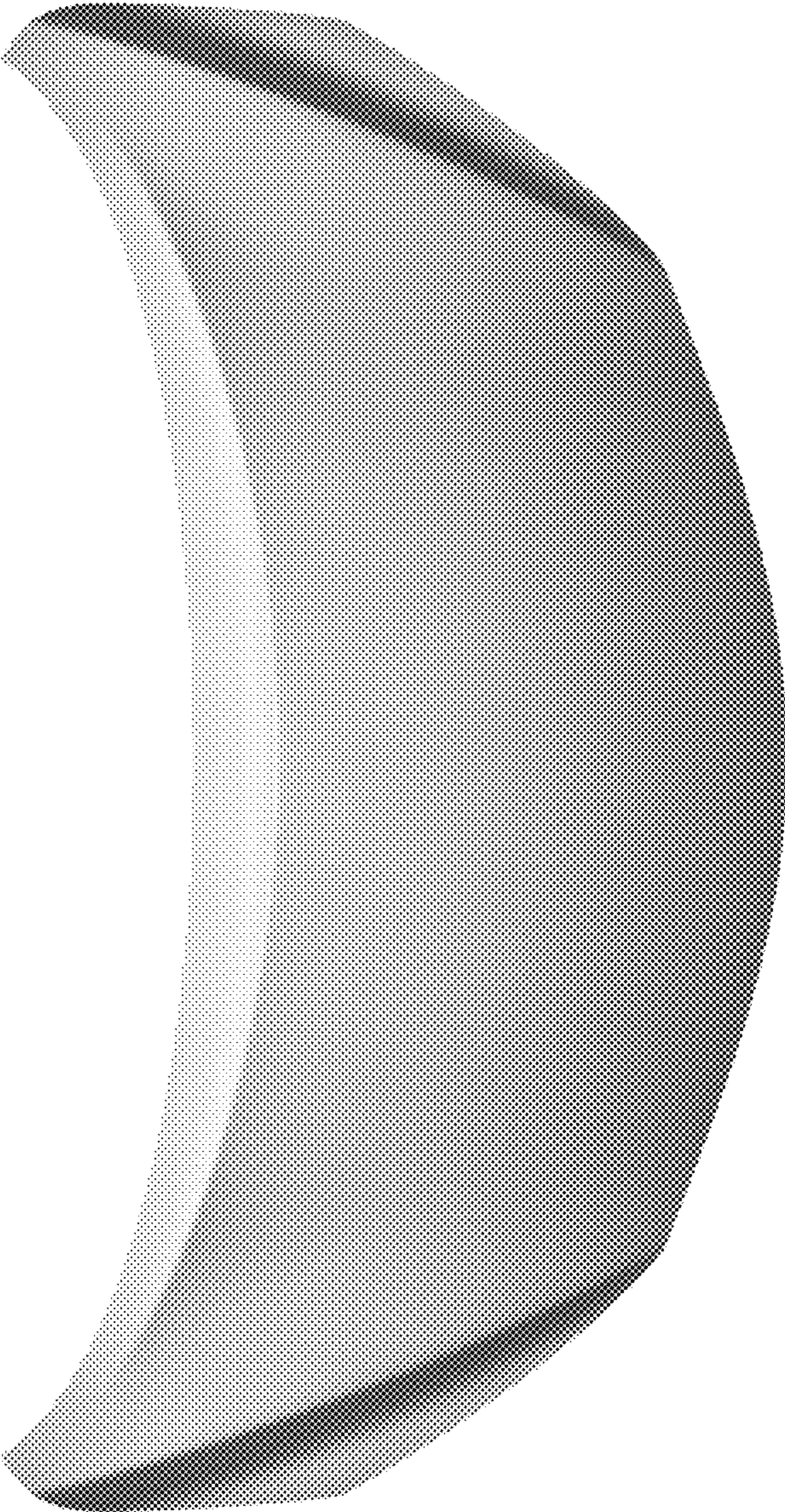

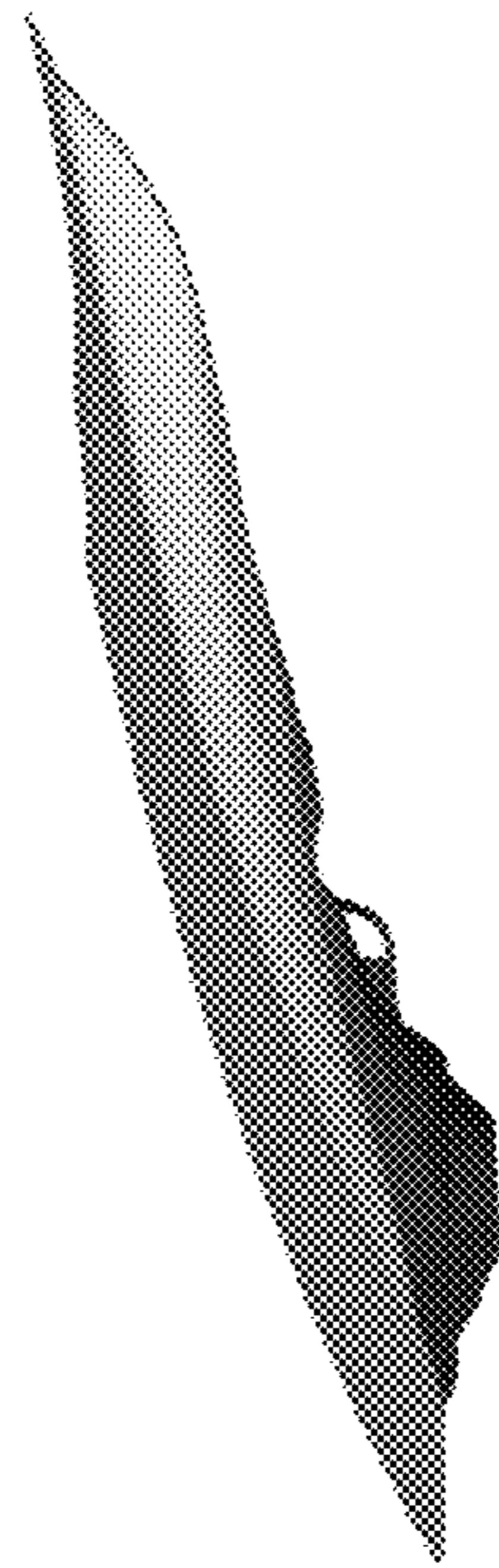

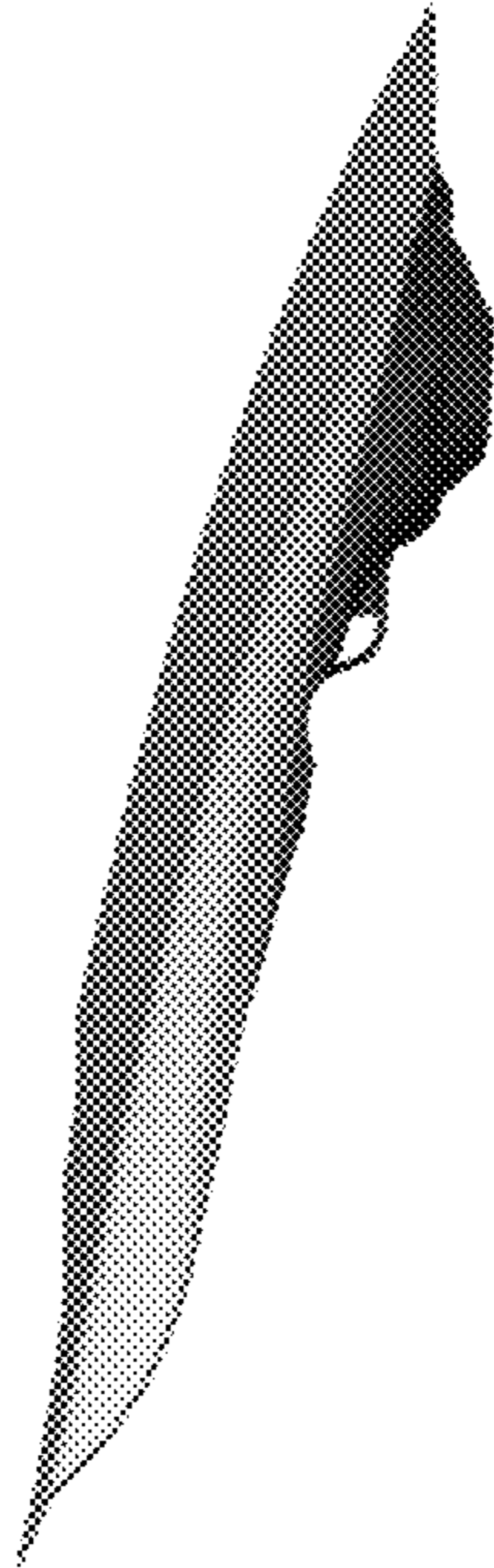

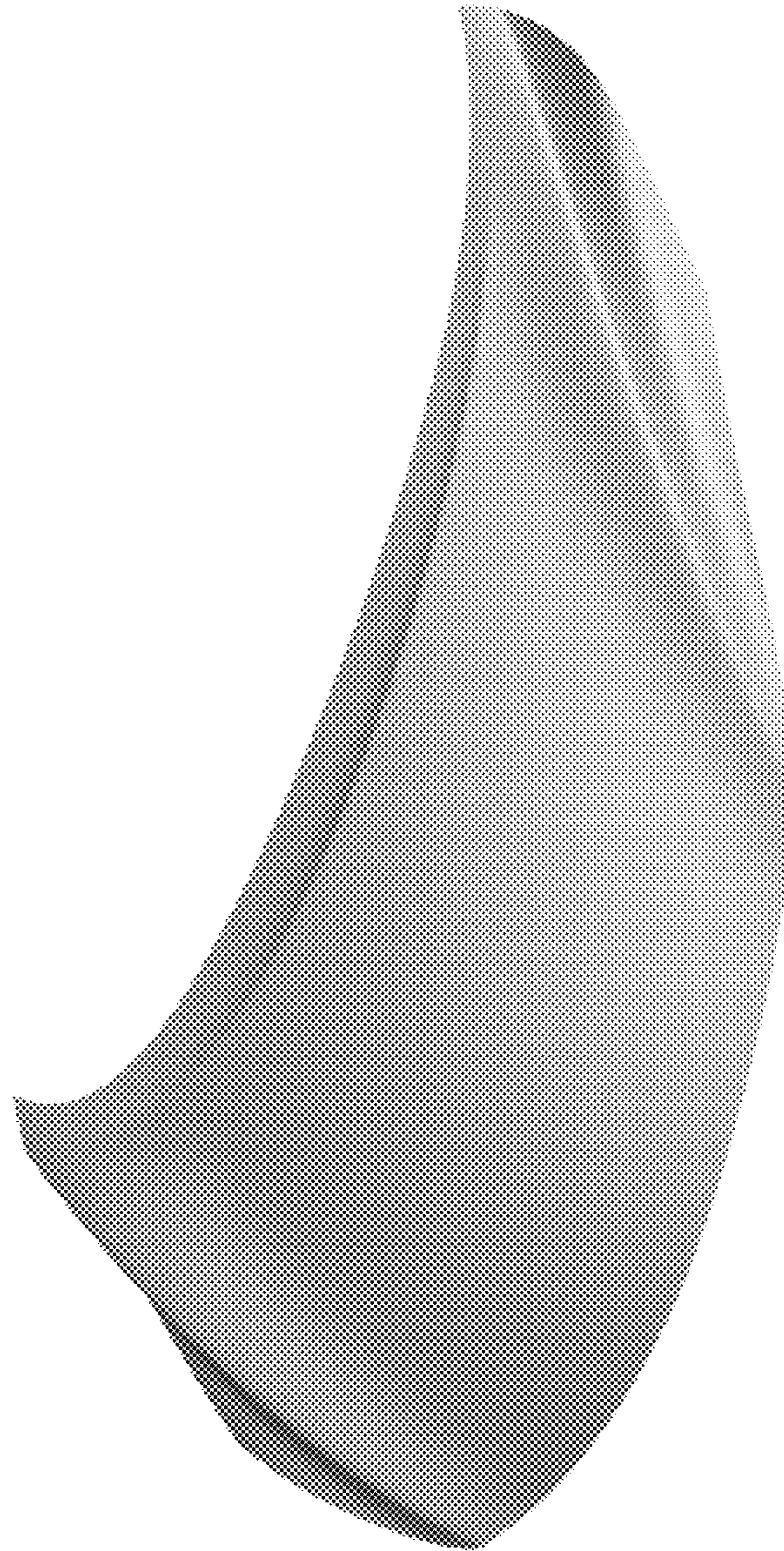
