DESCRIPTION

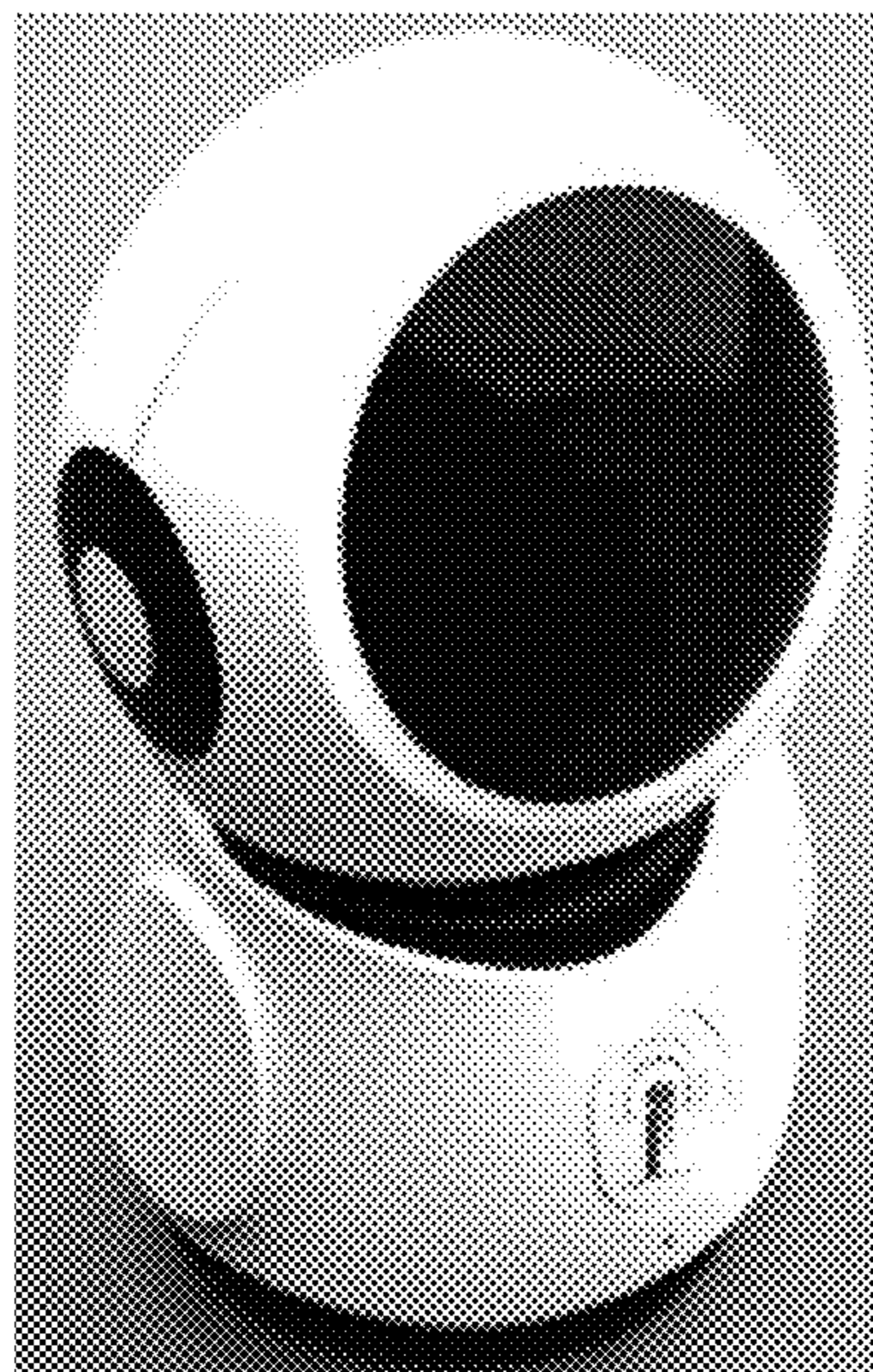
FIG. 1 is a front view of a robot showing our new design;

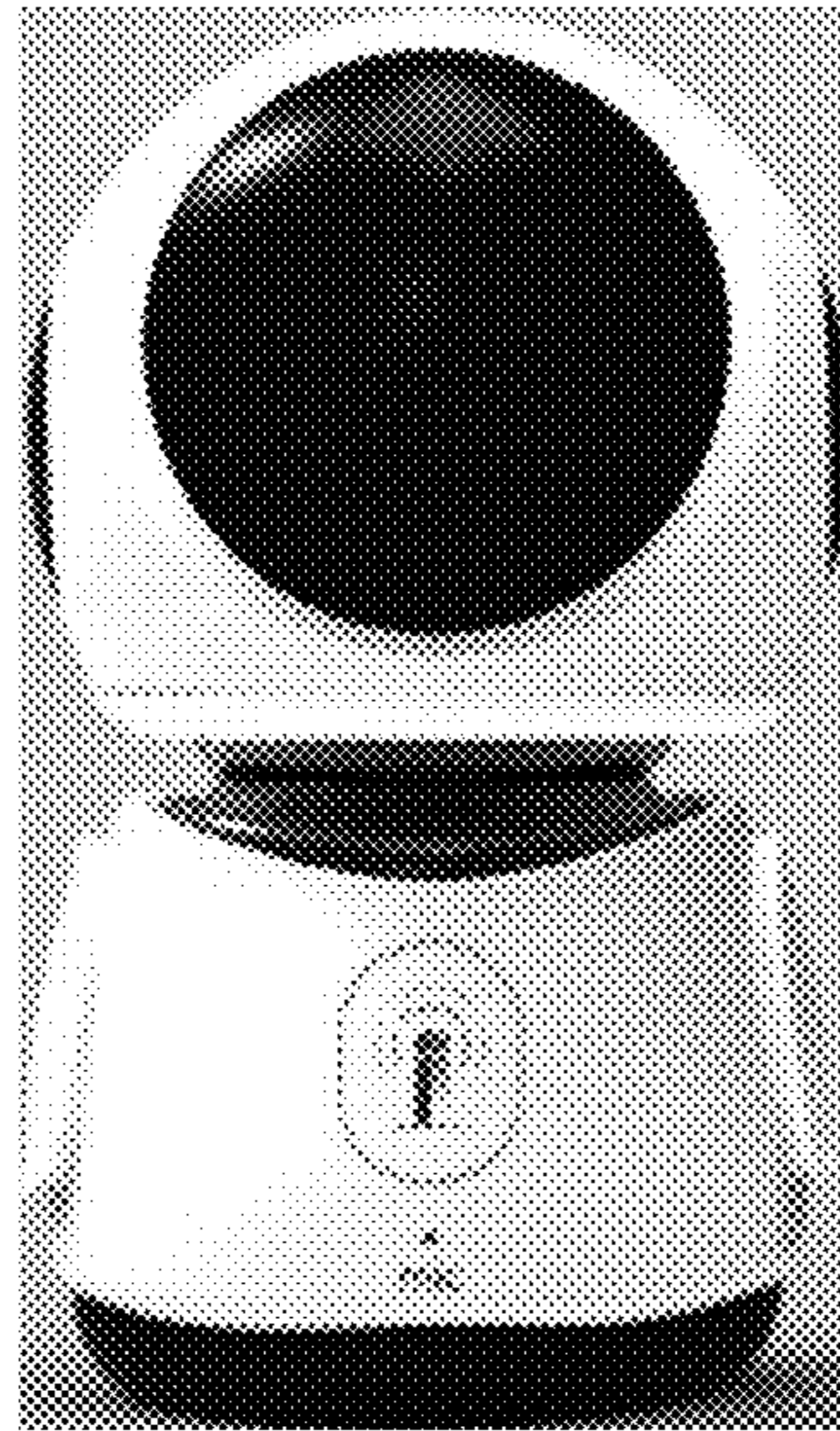

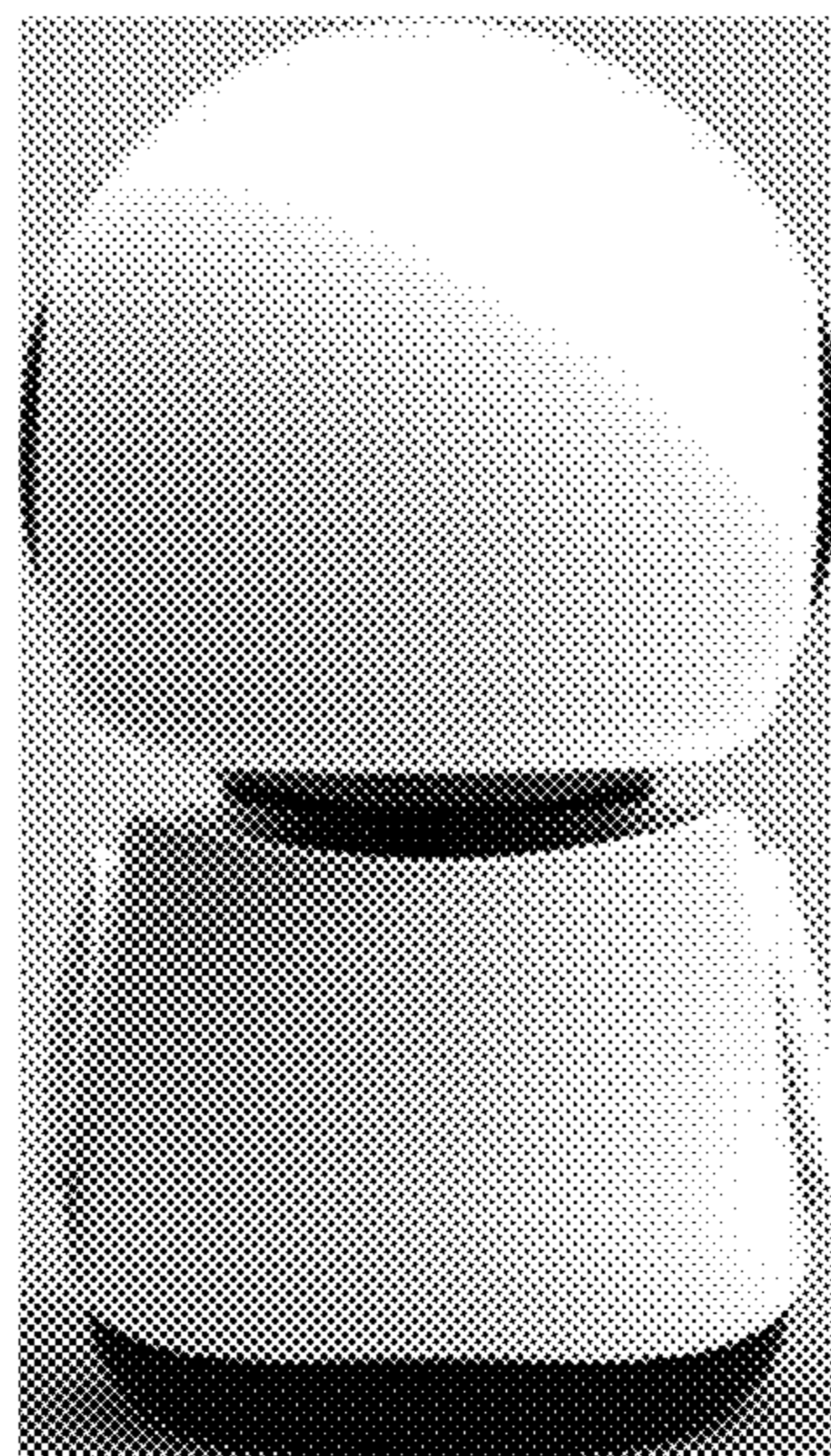

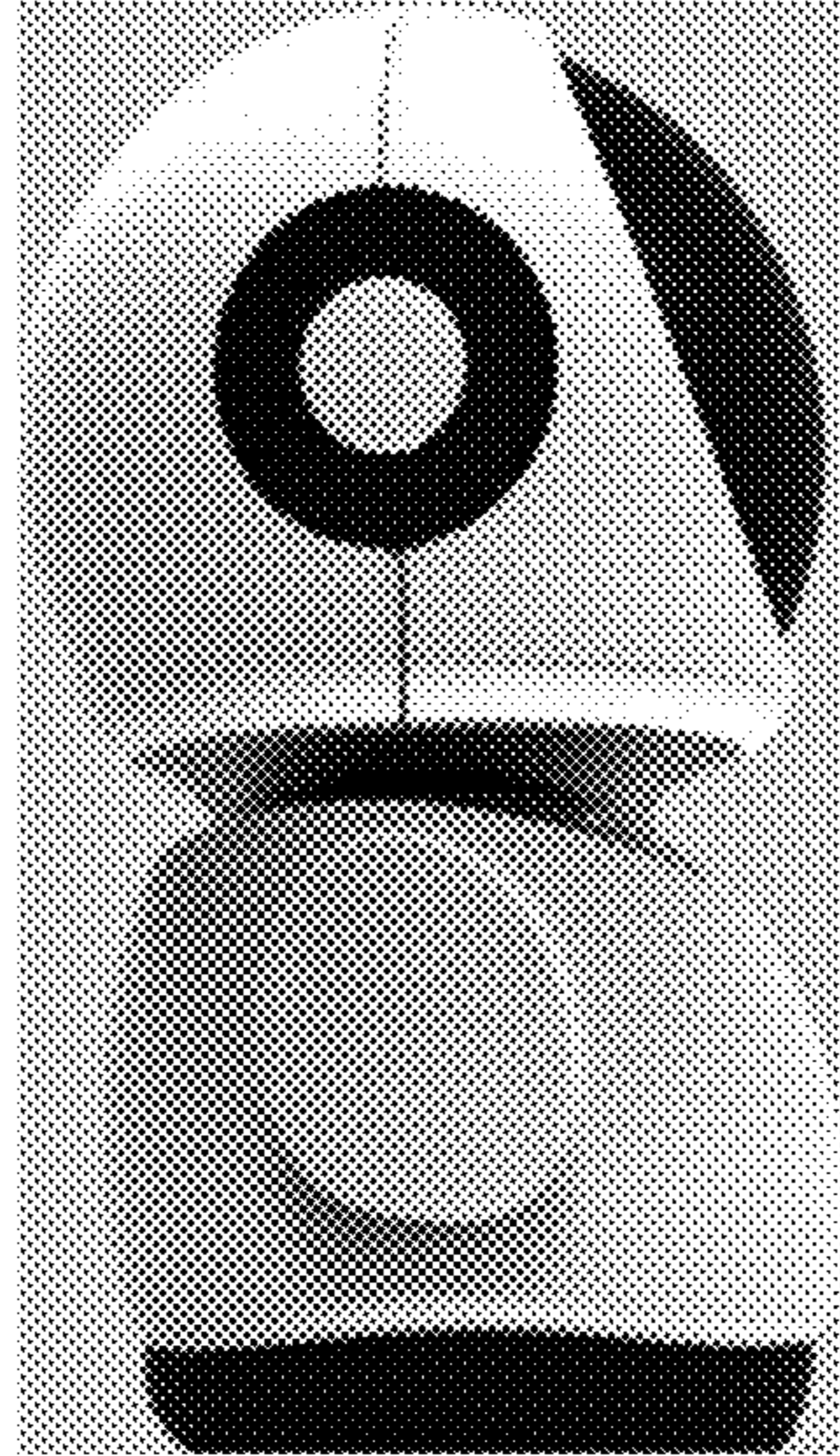

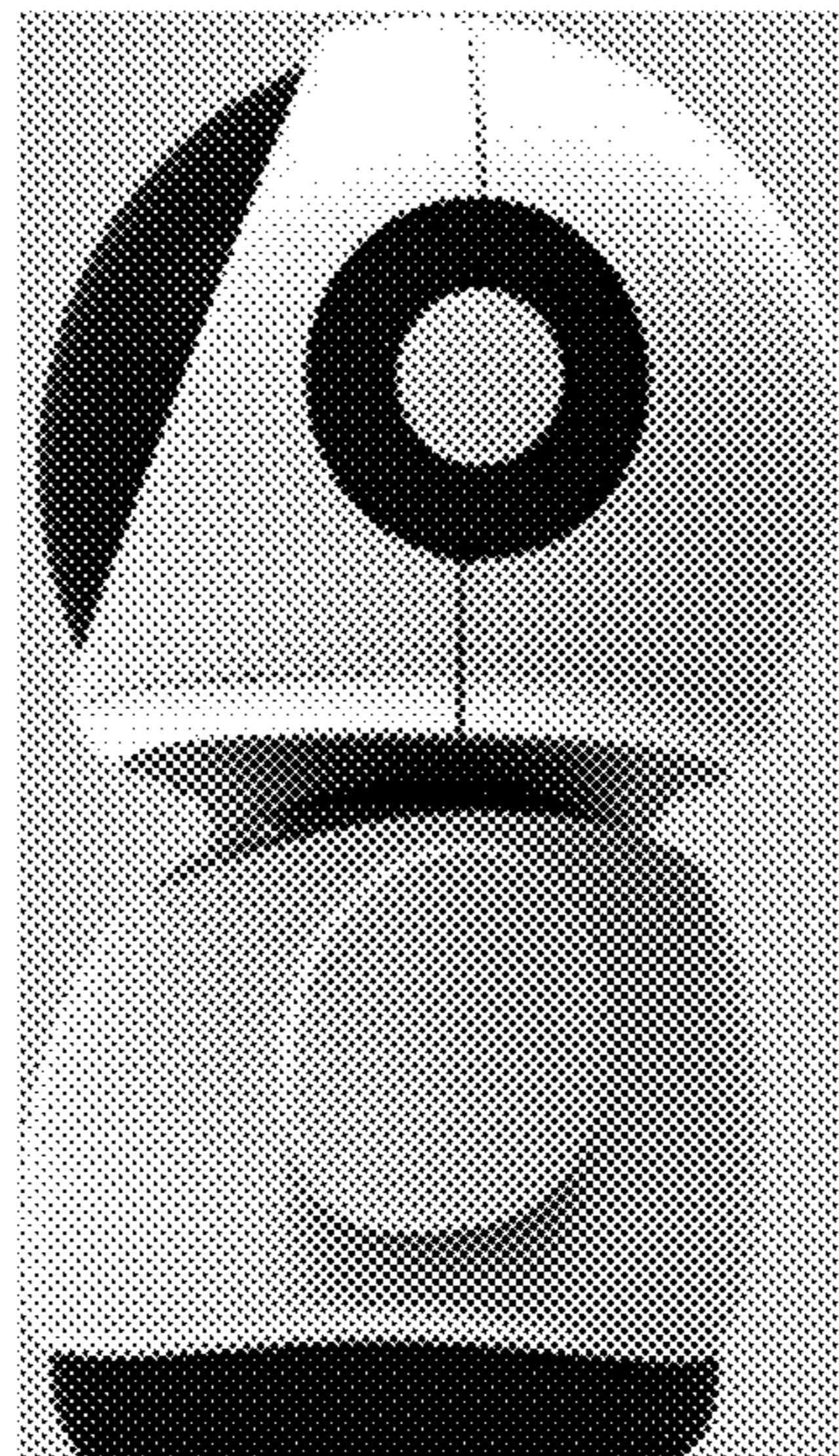

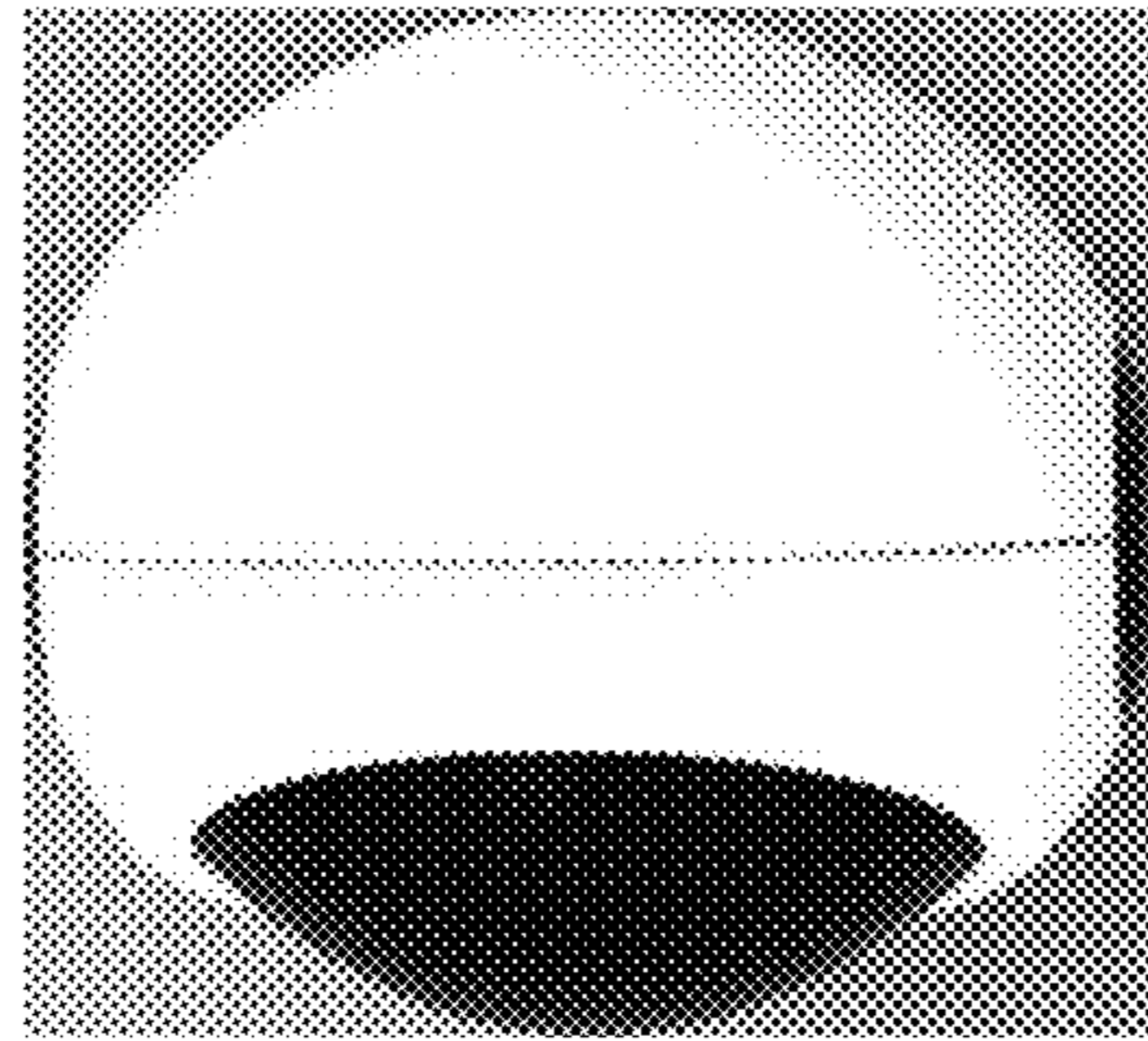

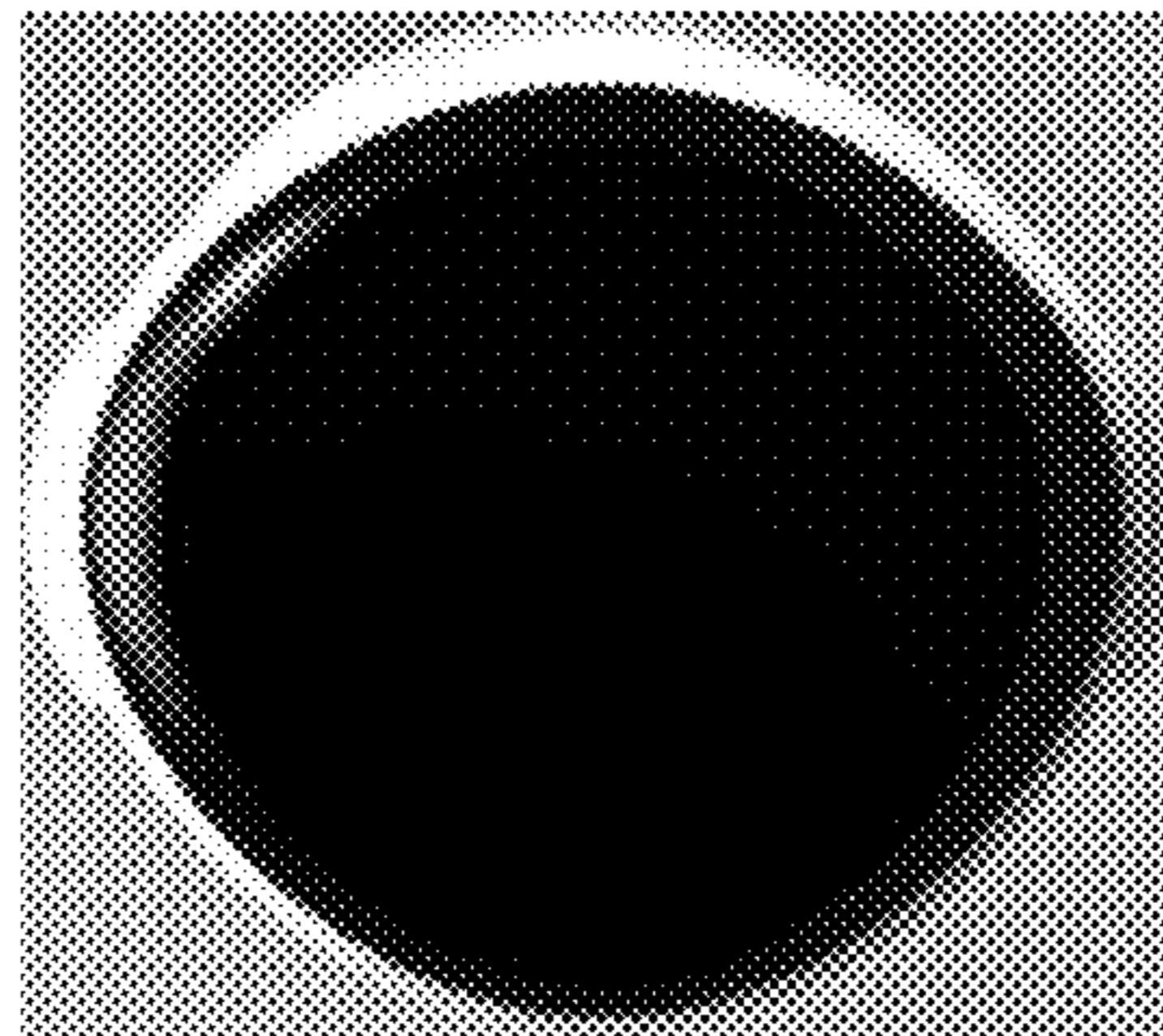

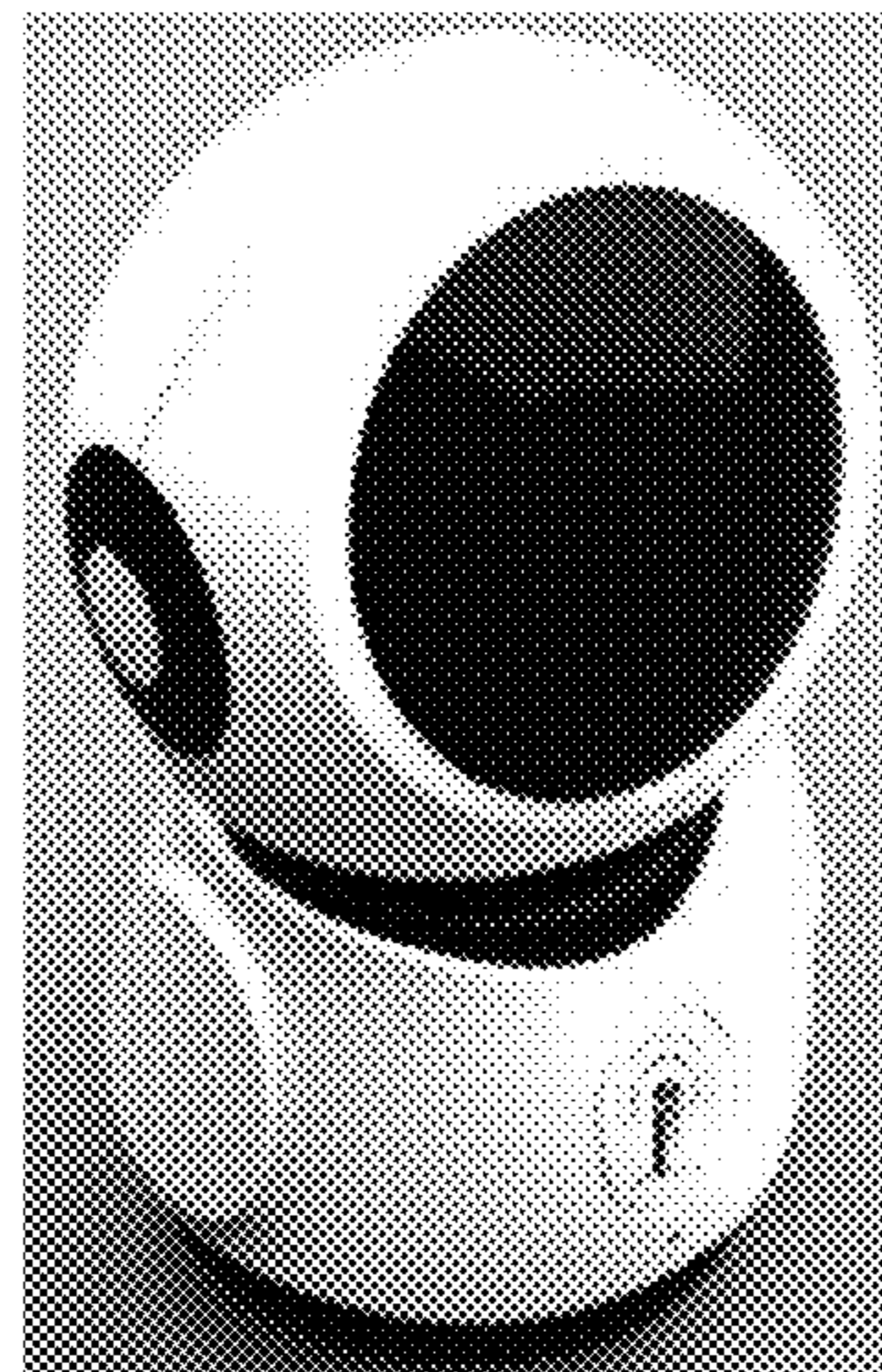
