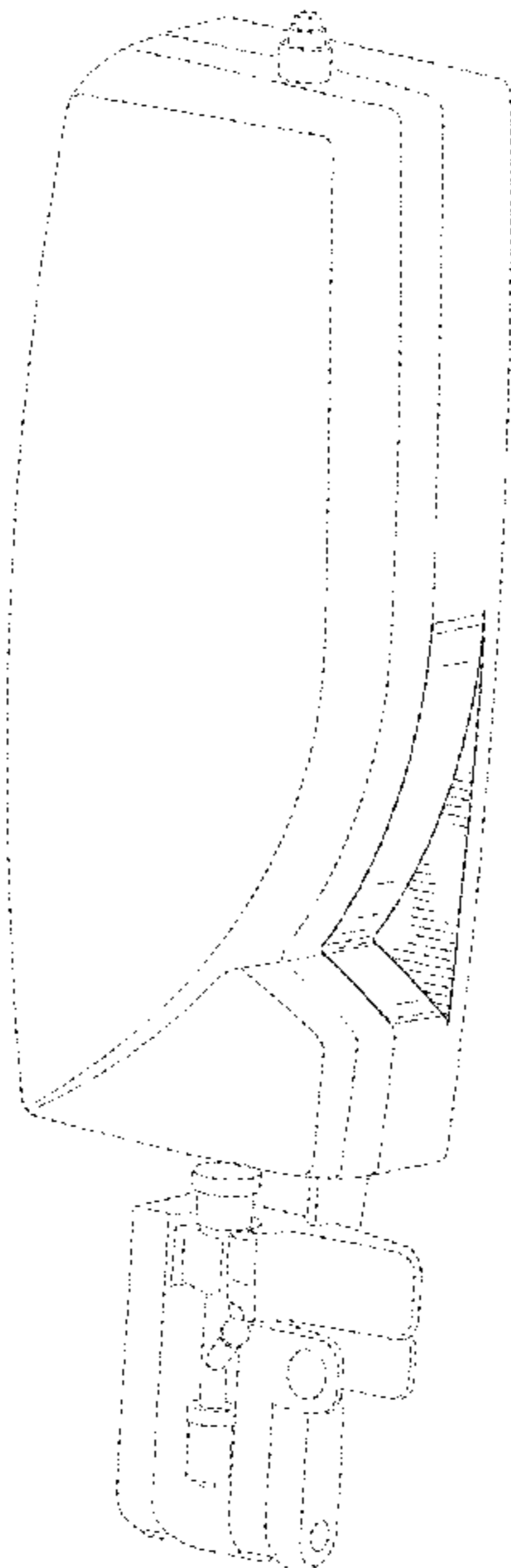
(57) **CLAIM**

We claim the ornamental design for a catheter system cassette, as shown and described.

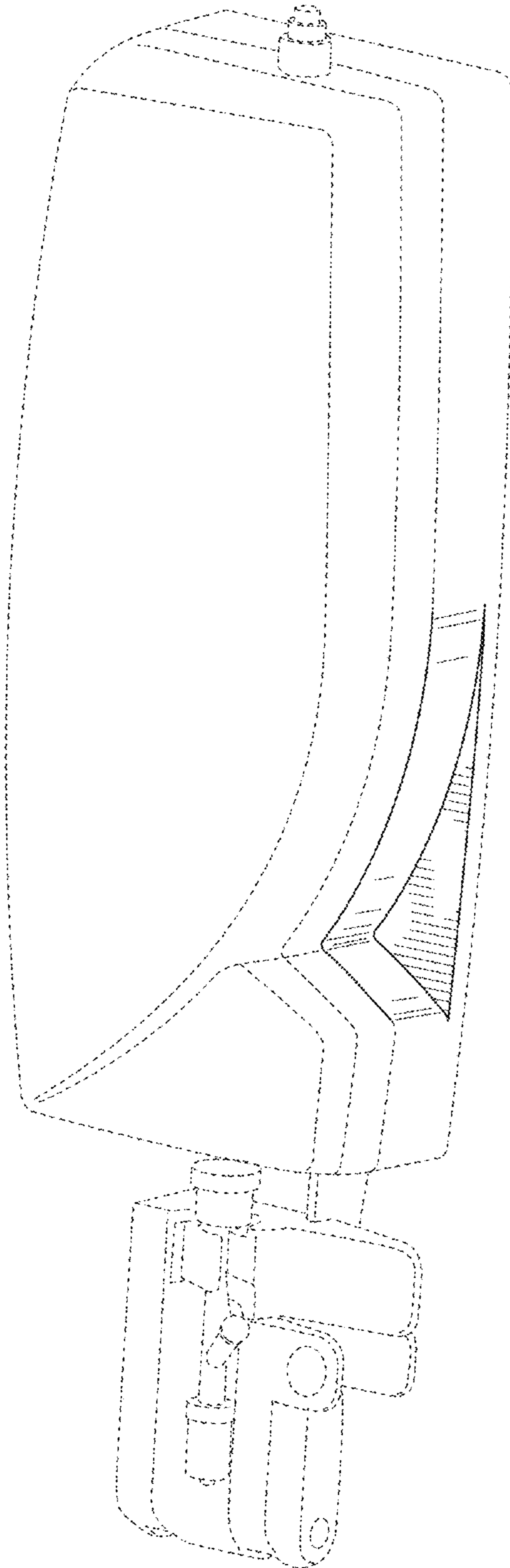

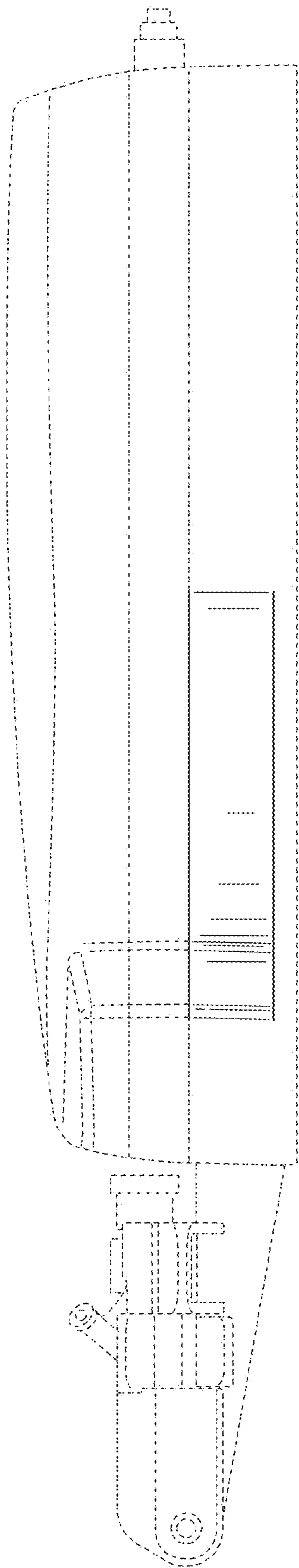

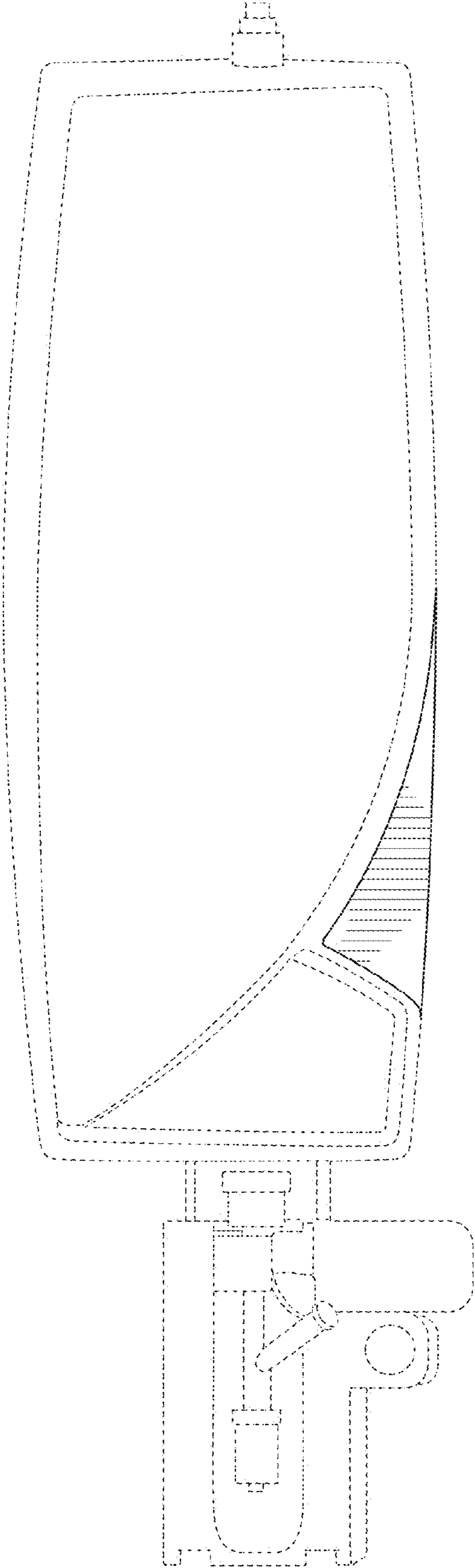
