(57) **CLAIM**

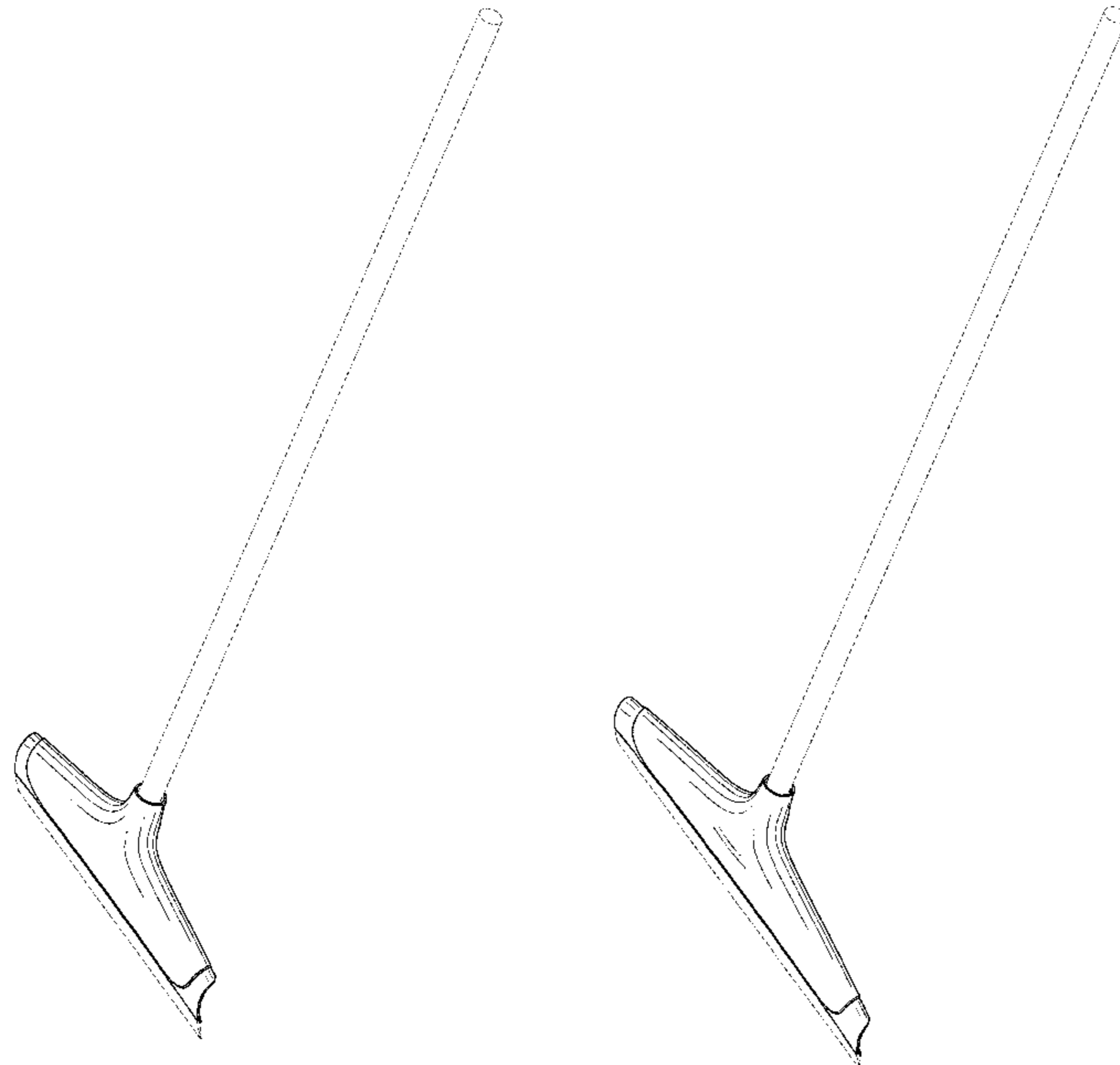
The ornamental design for a cleaning tool, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of a cleaning tool showing the new design;  
 FIG. 2 is a right side view thereof, the left side view being a mirror image thereof;

 FIG. 11 is a bottom view thereof;

 FIG. 13 is a top view thereof; and,  
 FIG. 14 is a perspective view thereof showing the cleaning tool with a long handle.

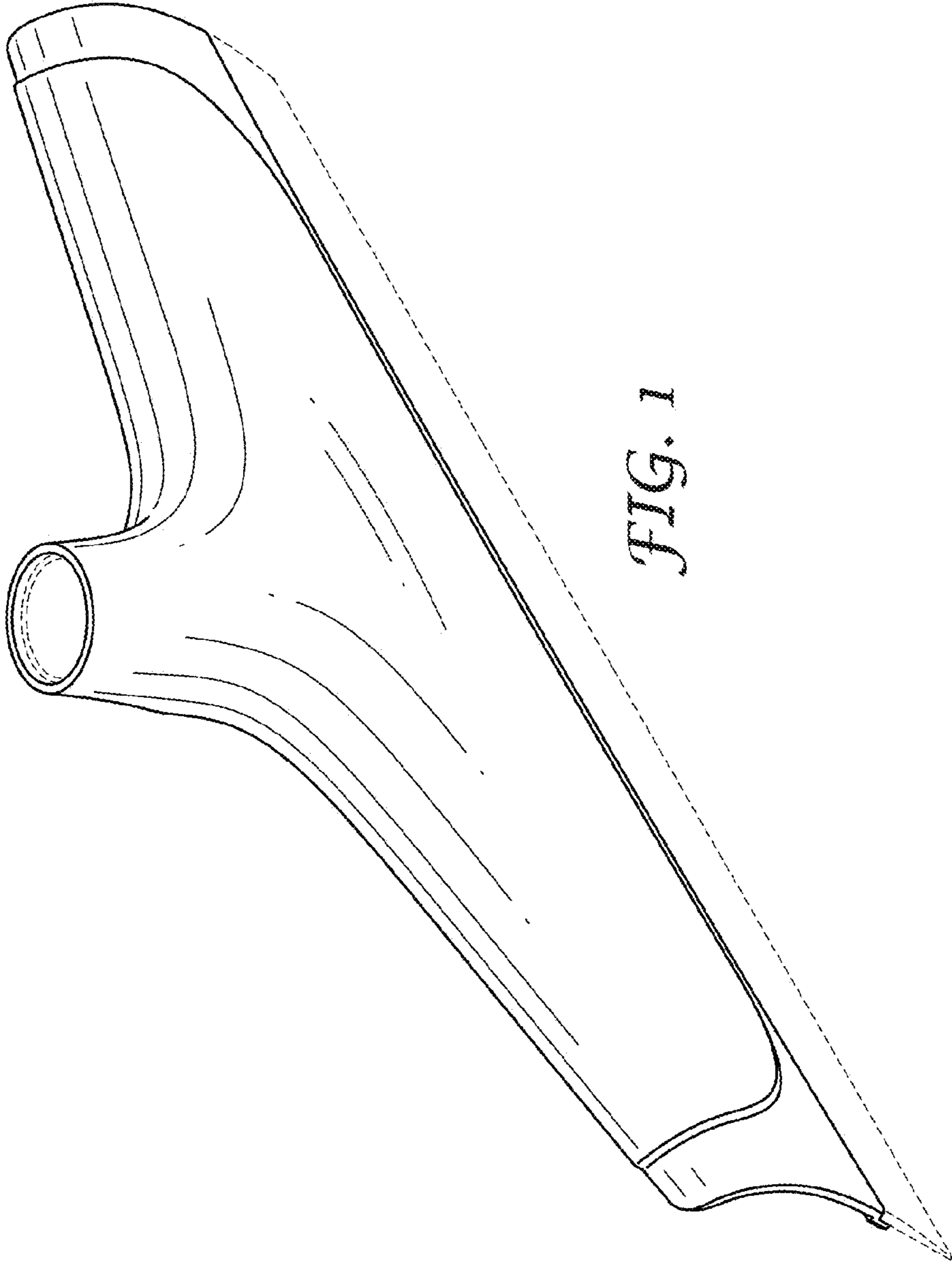

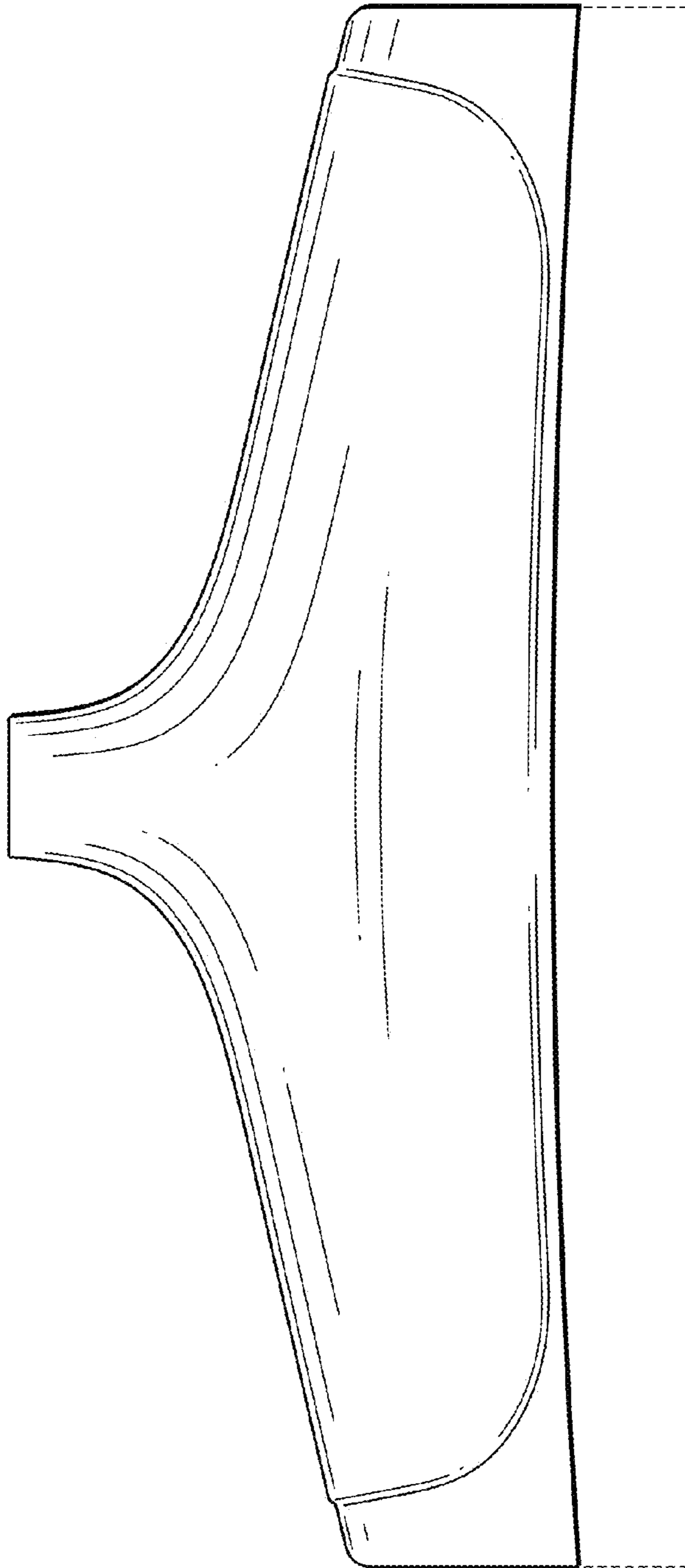

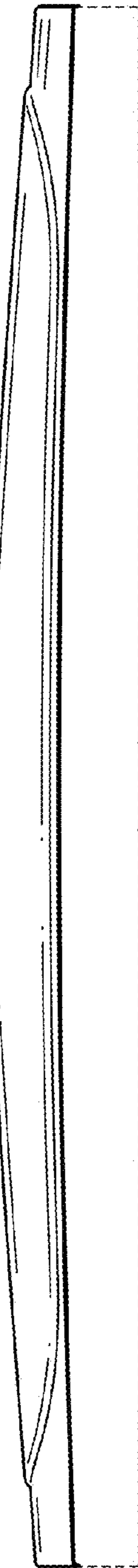

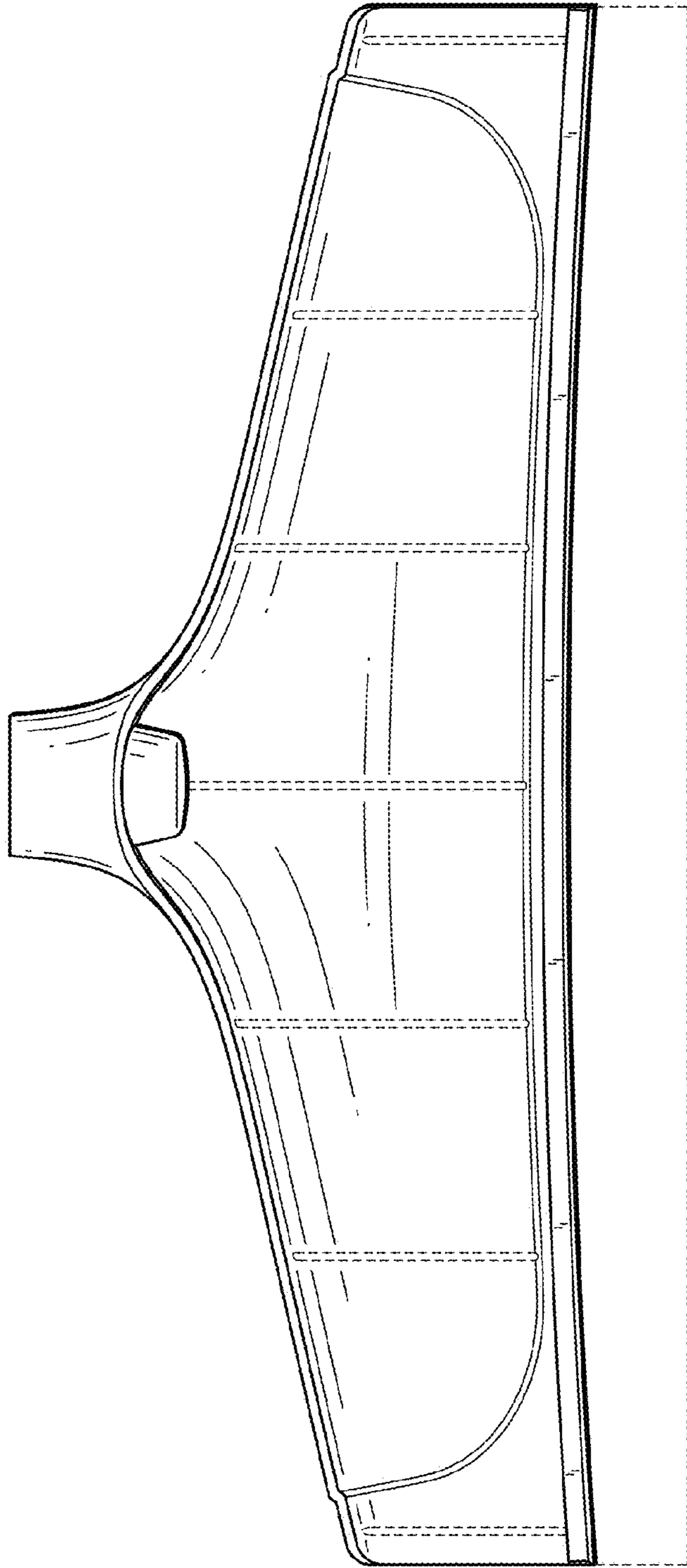

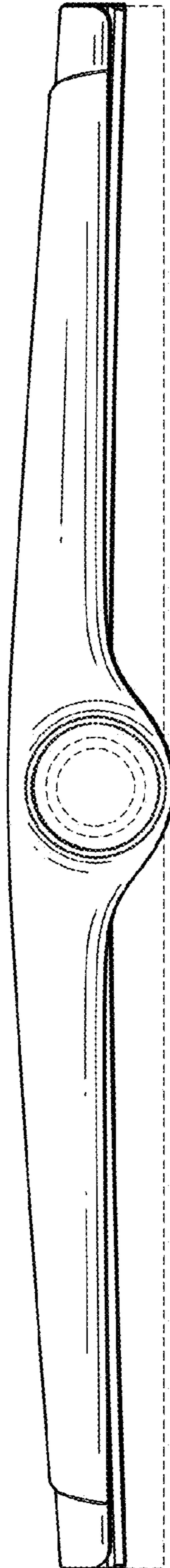

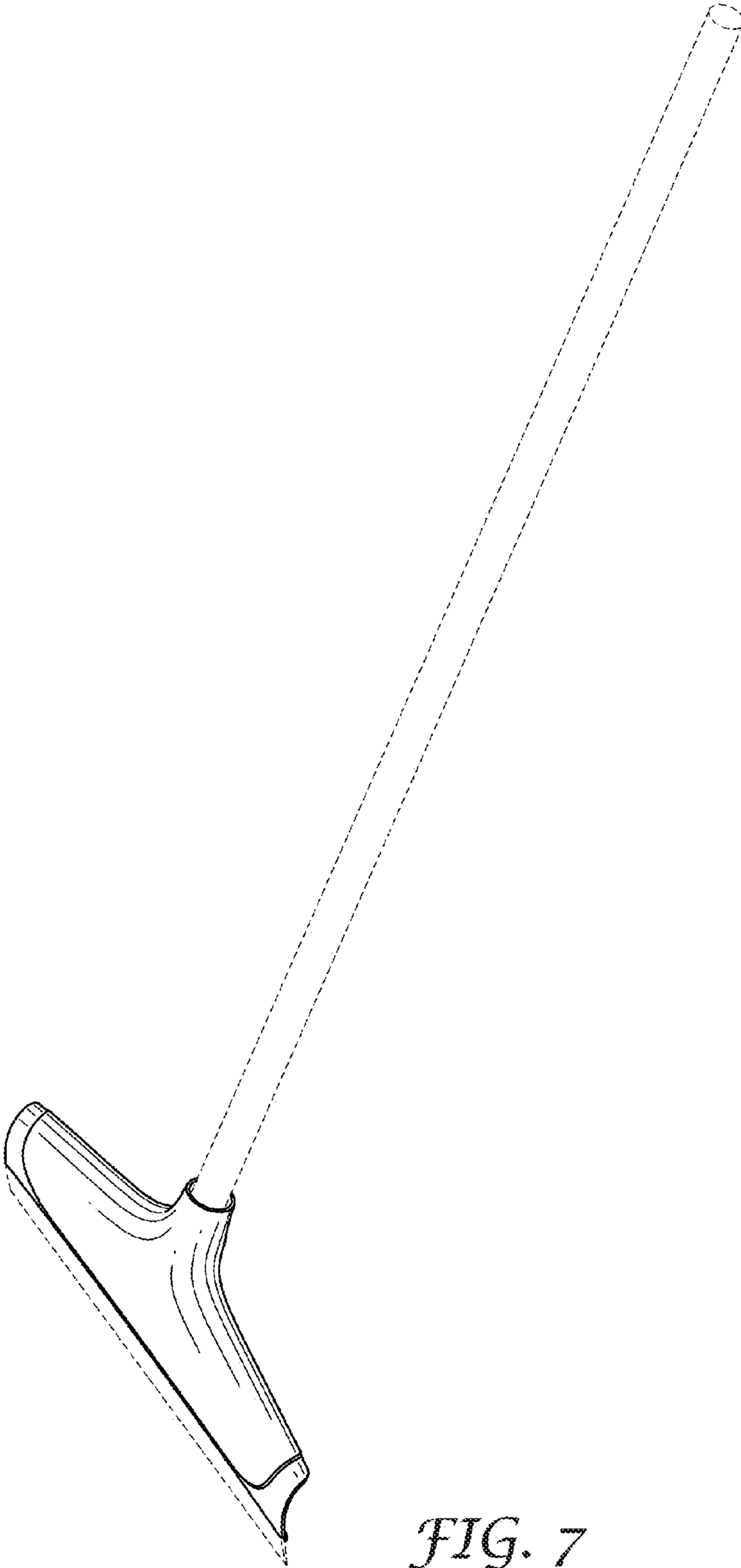

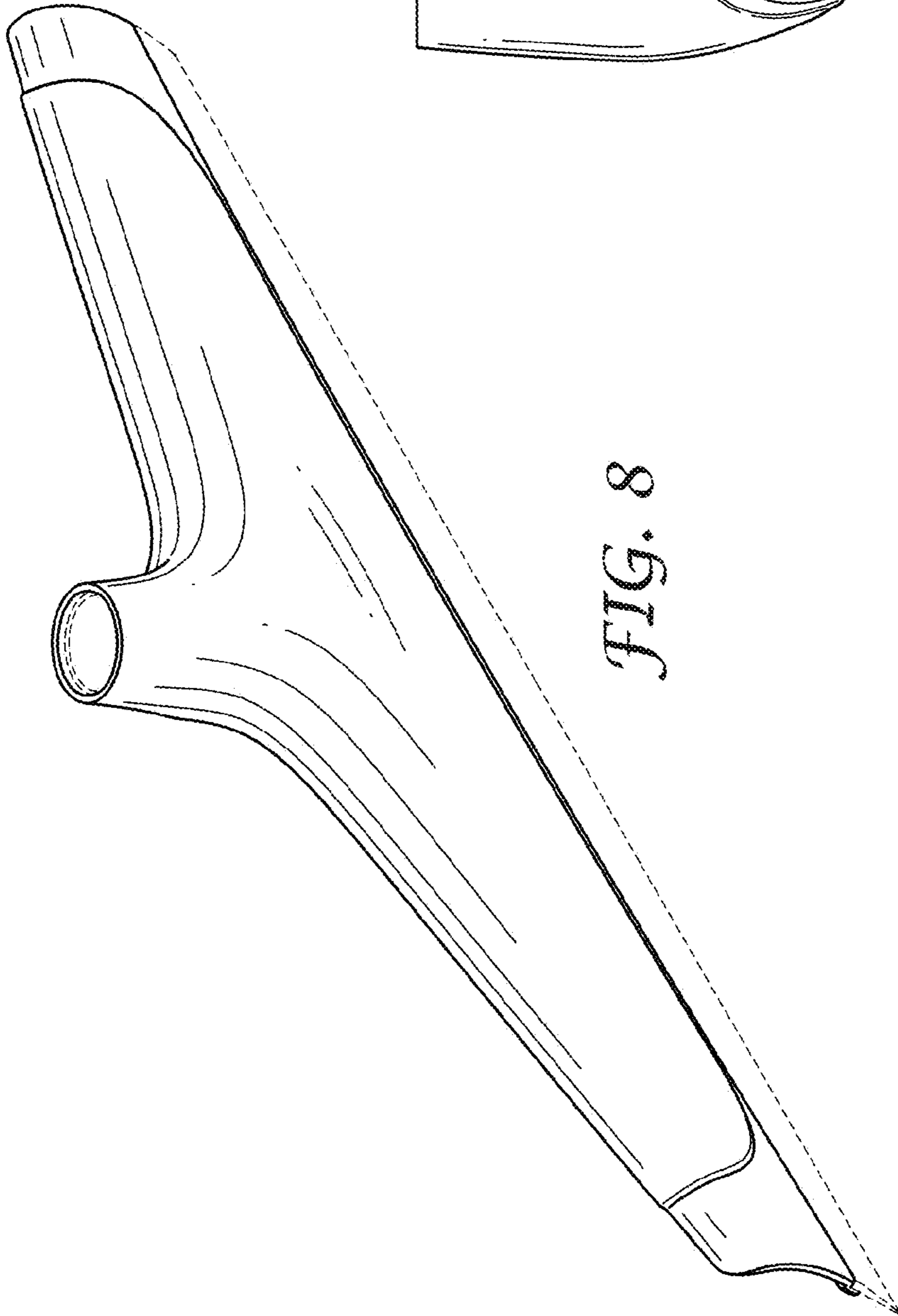

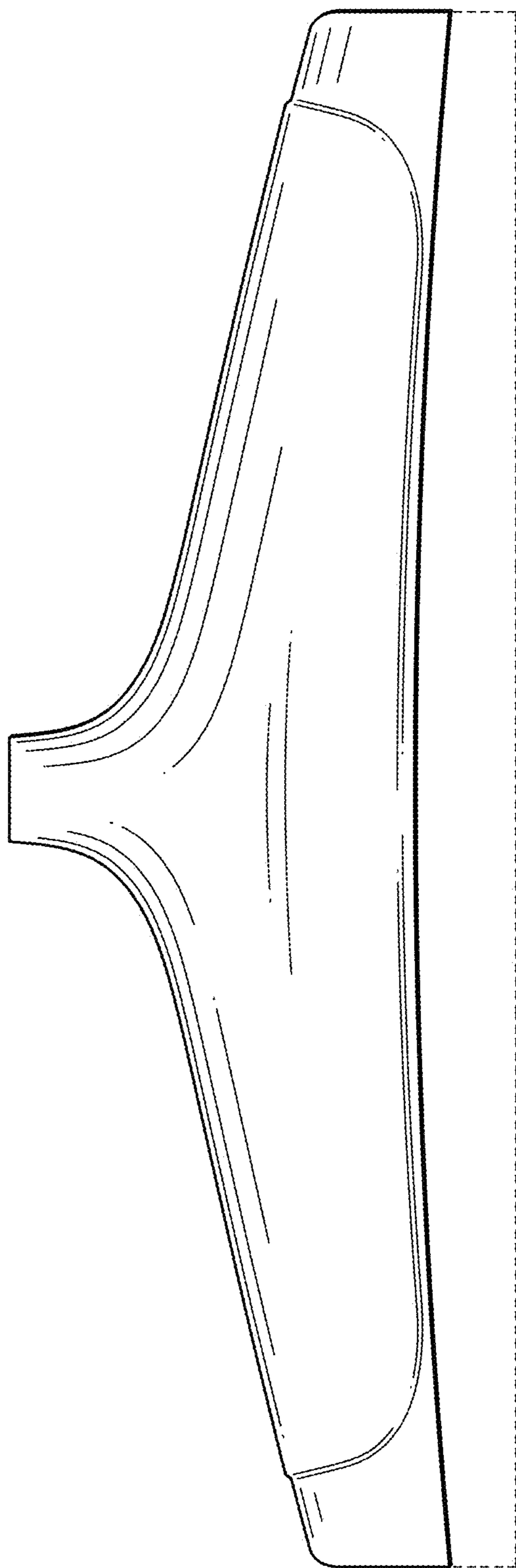

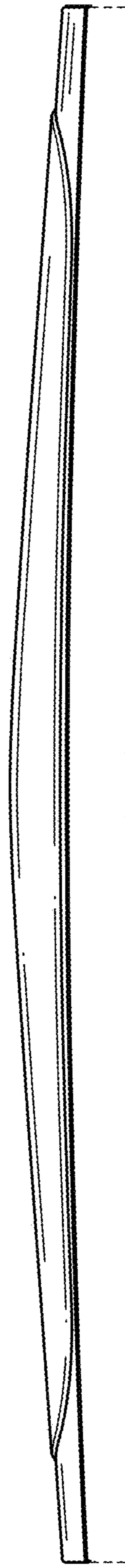

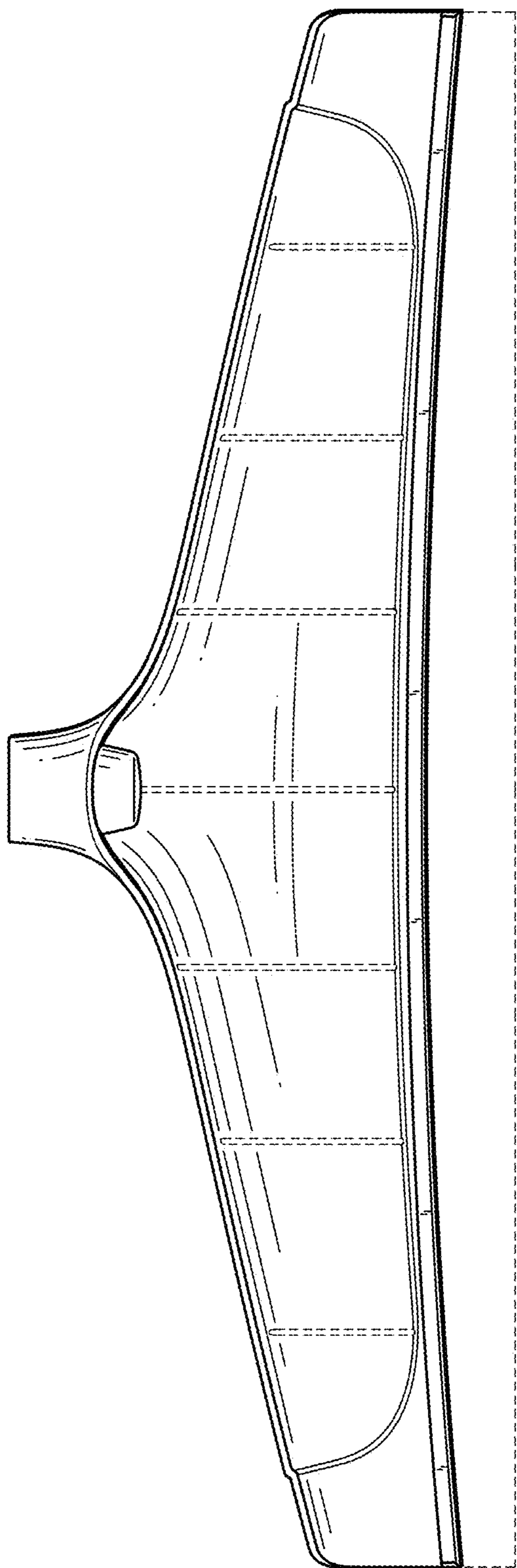

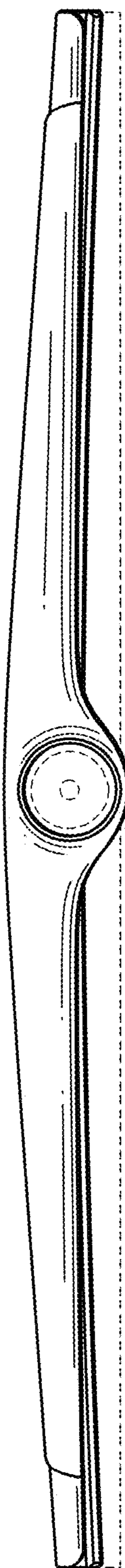

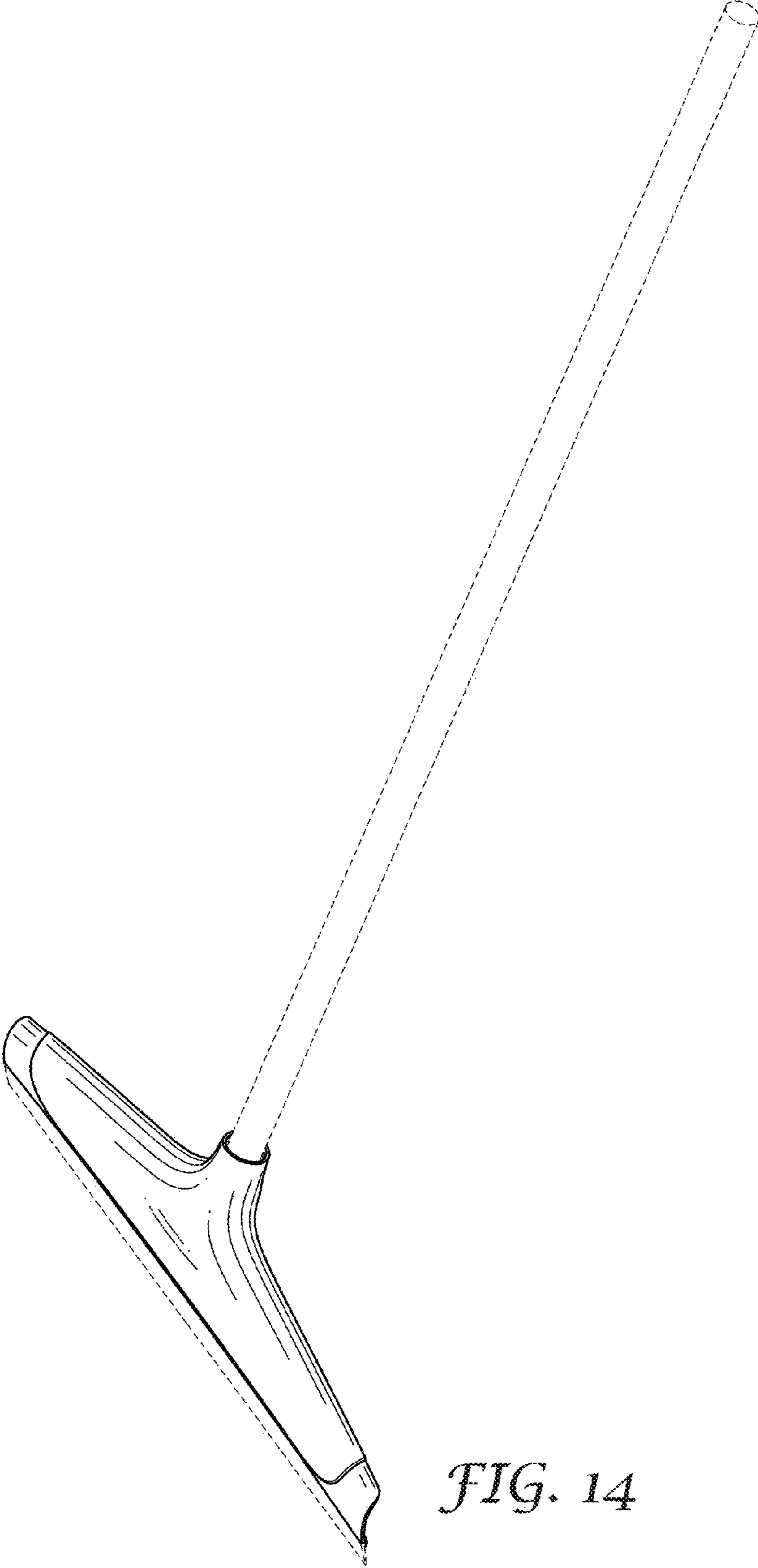
