FIG. 3 is a bottom plan view of the sink mat of the present invention shown on its side.

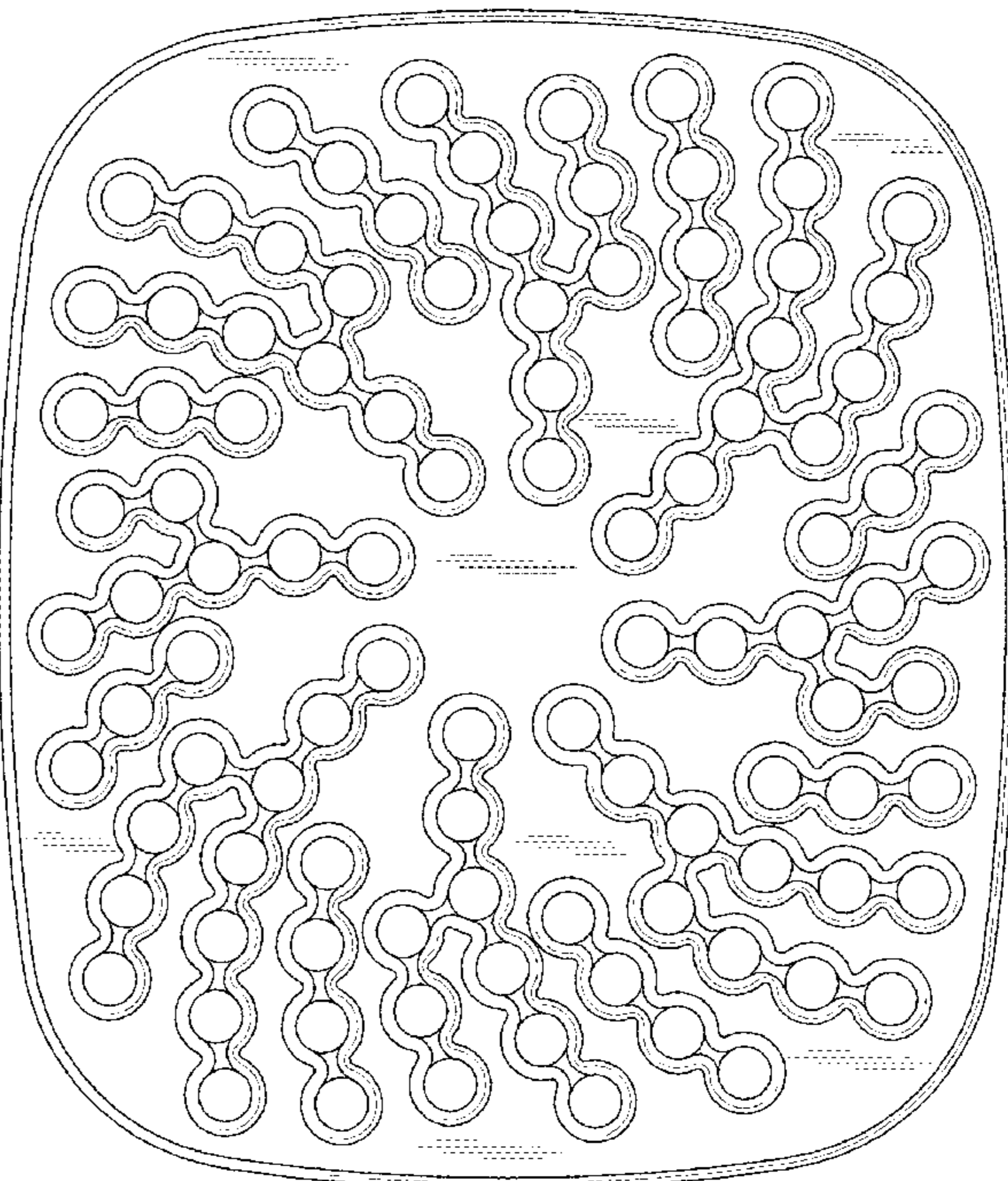
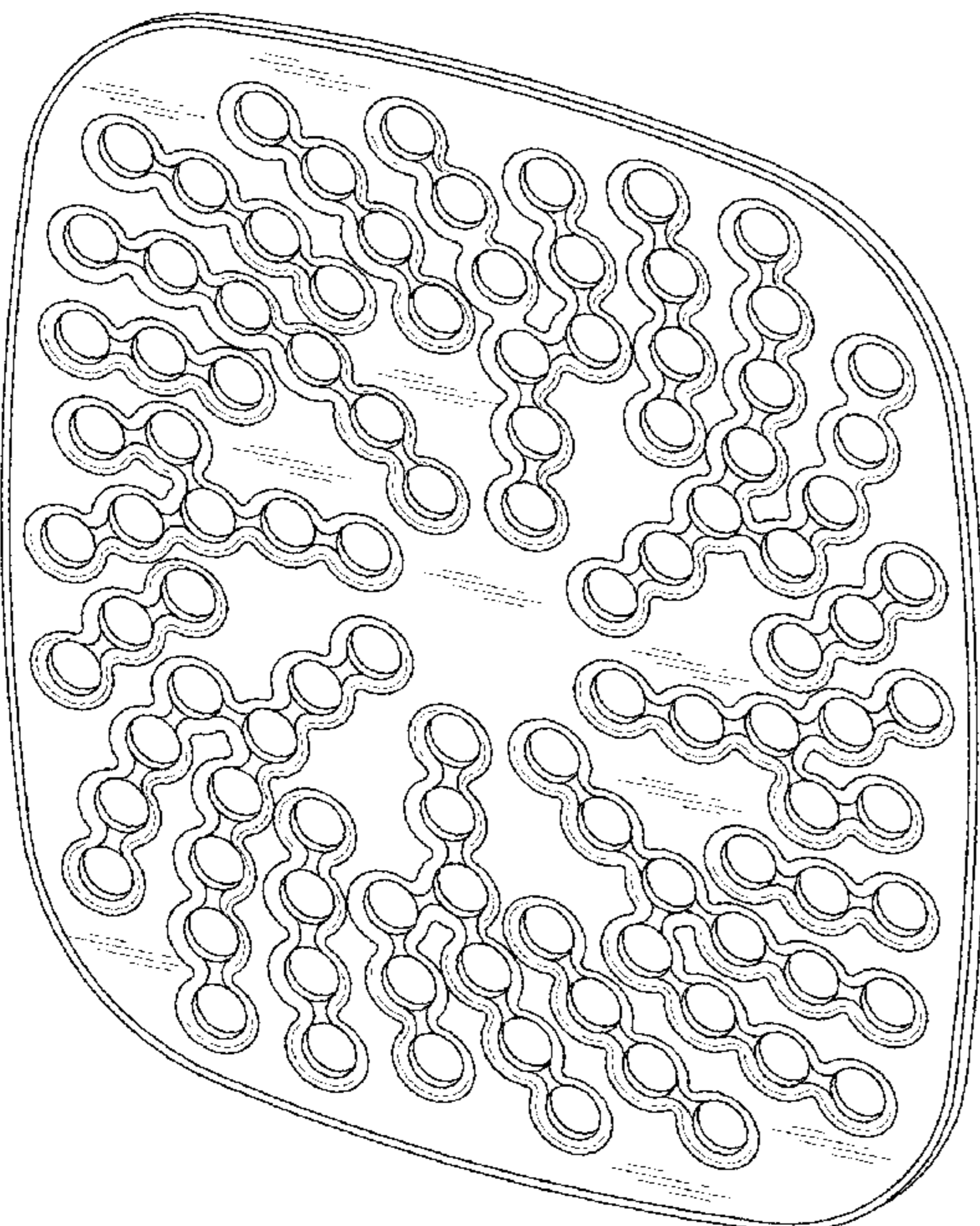
FIG. 4 is a right side elevation of the sink mat of the present invention on its side.

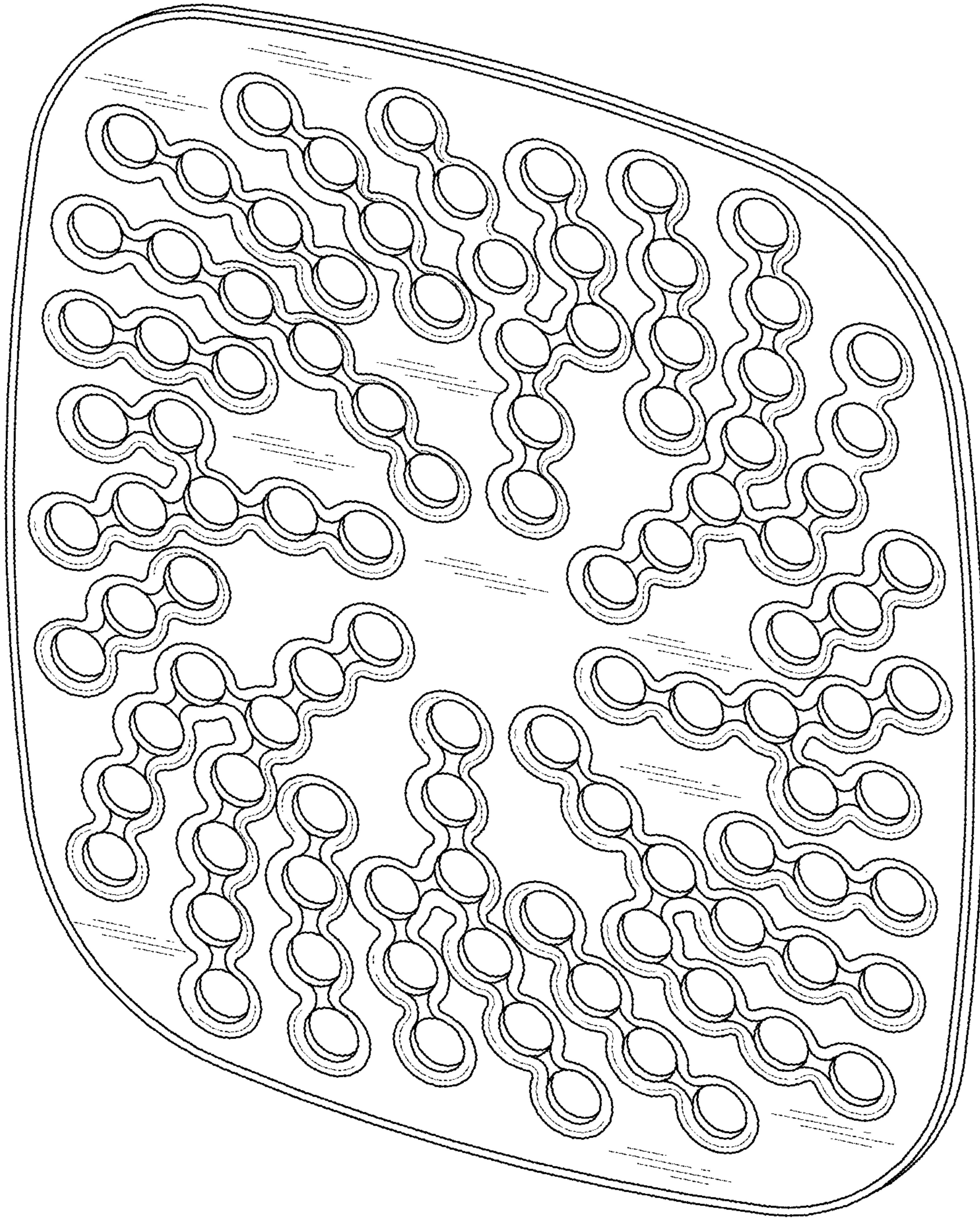
FIG. 5 is a left side elevation view of the sink mat of the present invention on its side.

FIG. 6 is a front elevation view of the sink mat of the present invention; and,

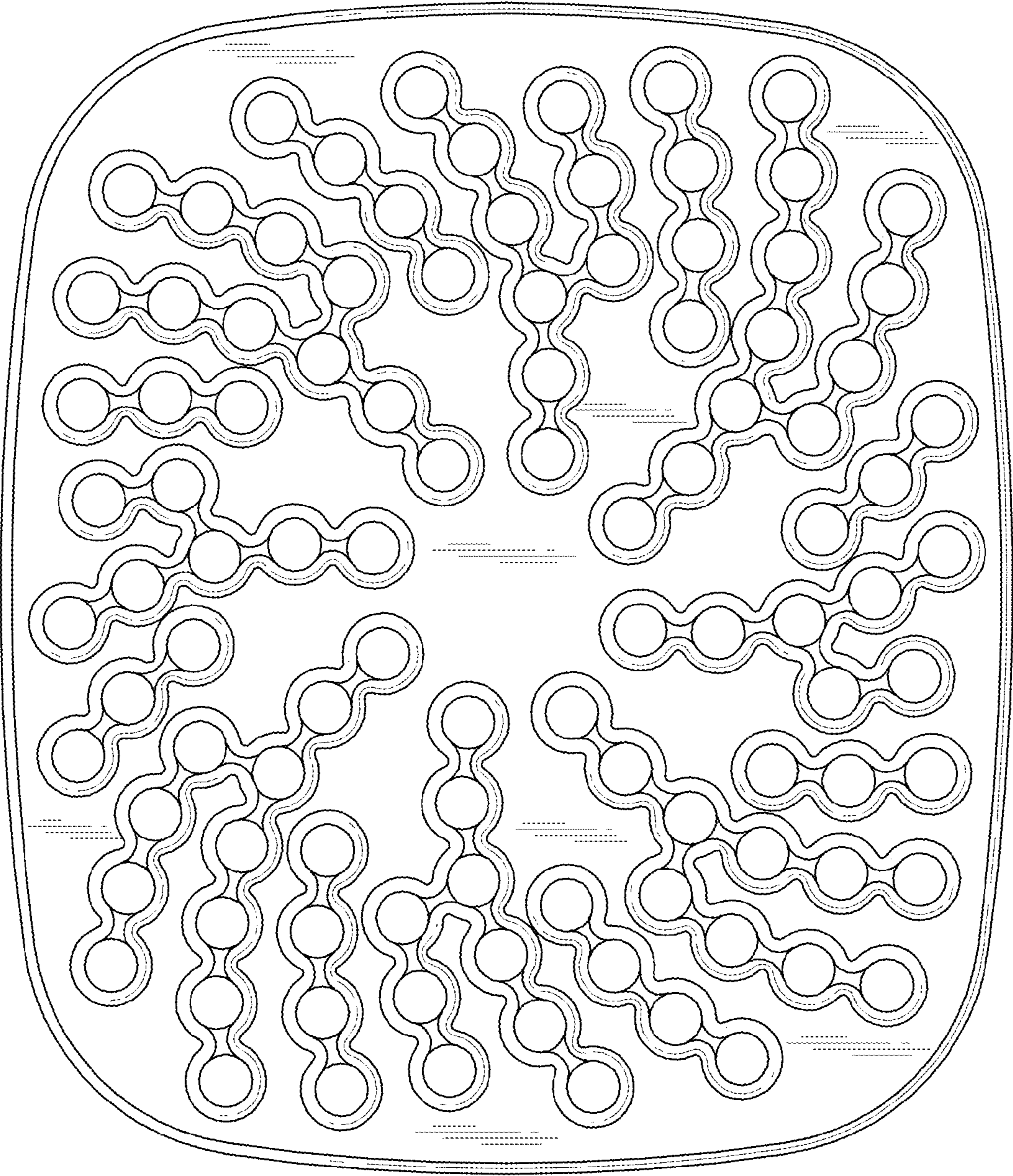
FIG. 7 is a rear elevation view of the sink mat of the present invention.

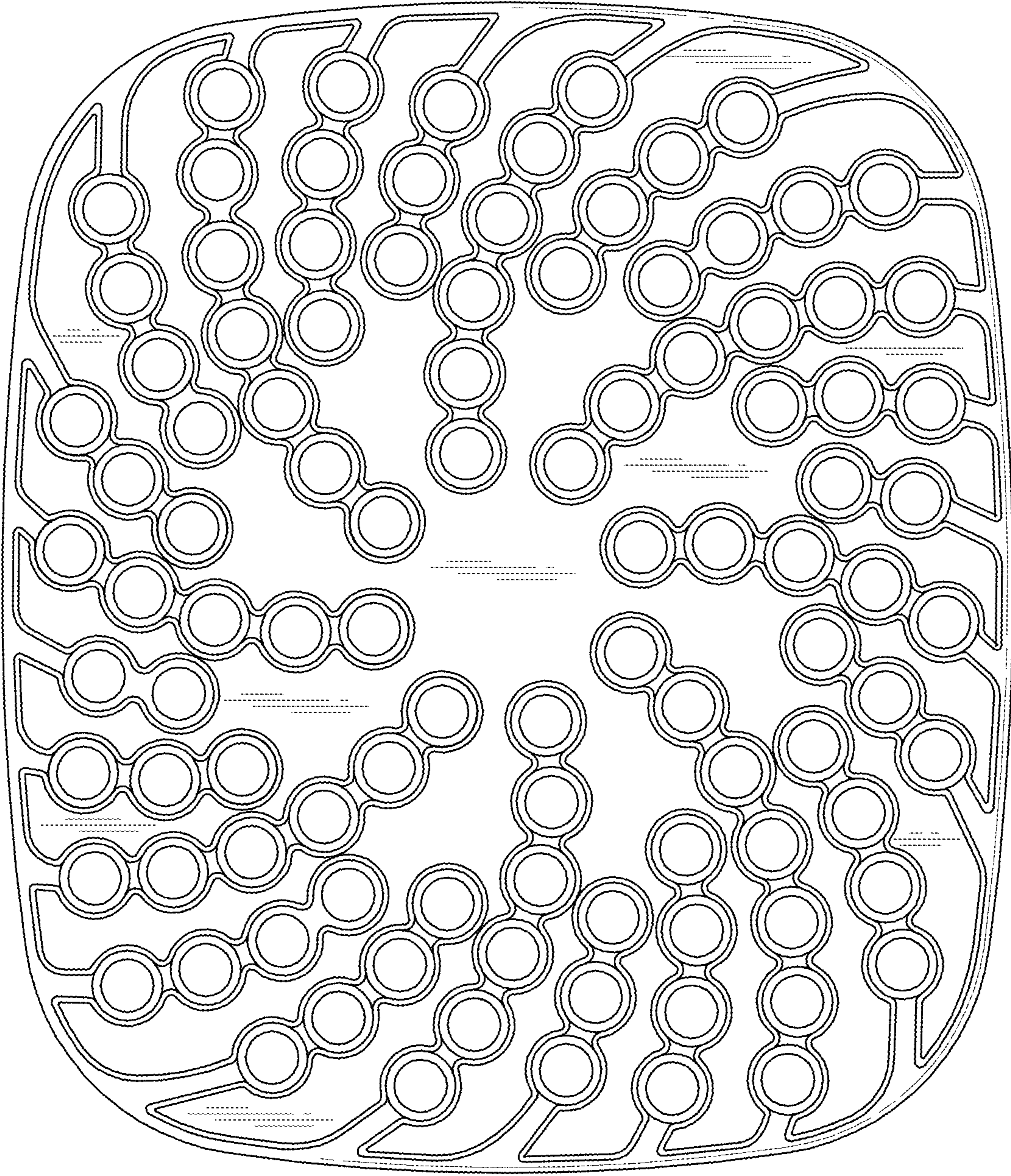




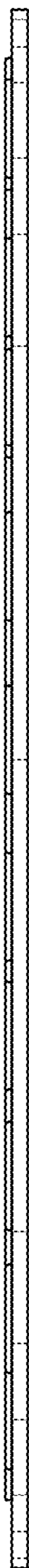

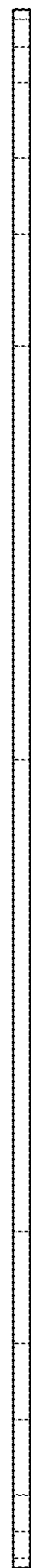

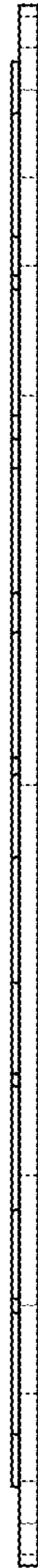
