(57) **CLAIM**
The ornamental design for a “portable chair and backpack with modified frame,” as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portable chair and backpack with modified frame in a collapsed, backpack configuration, showing my new design;
 FIG. 2 is a perspective view thereof, illustrating the portable chair and backpack with modified frame in an open, chair configuration;
 FIG. 3 is a front elevational view thereof;
 FIG. 4 is a rear elevational view thereof;
 FIG. 5 is a right side elevational view thereof;
 FIG. 6 is a left side elevational view thereof;
 FIG. 7 is a top plan view thereof;
 FIG. 8 is a bottom plan view thereof; and,
 FIG. 9 is a rear elevational view thereof, with the shoulder straps broken away to show the rear surface of the backpack.
 The broken lines shown in the drawings are understood to represent stitching.

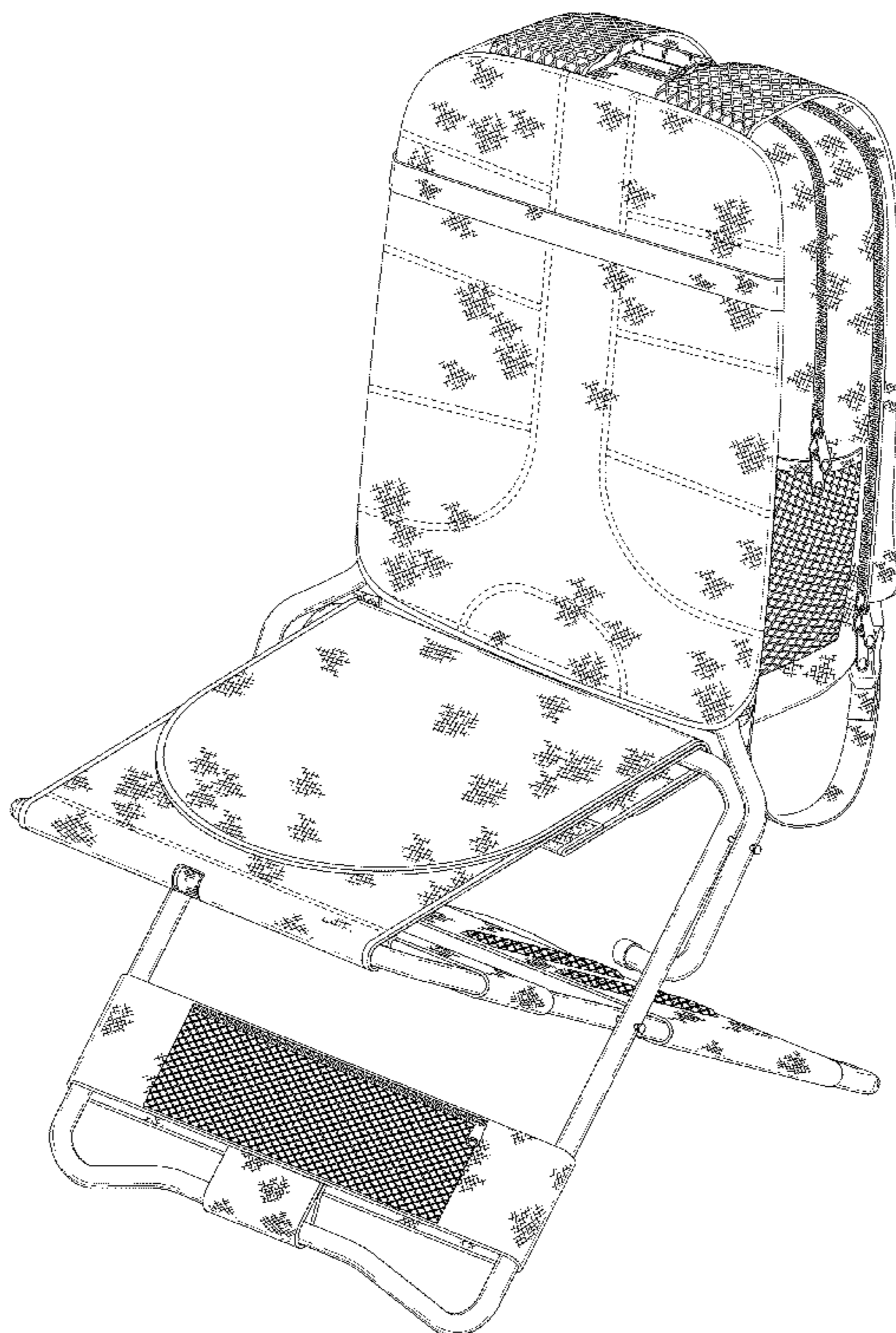

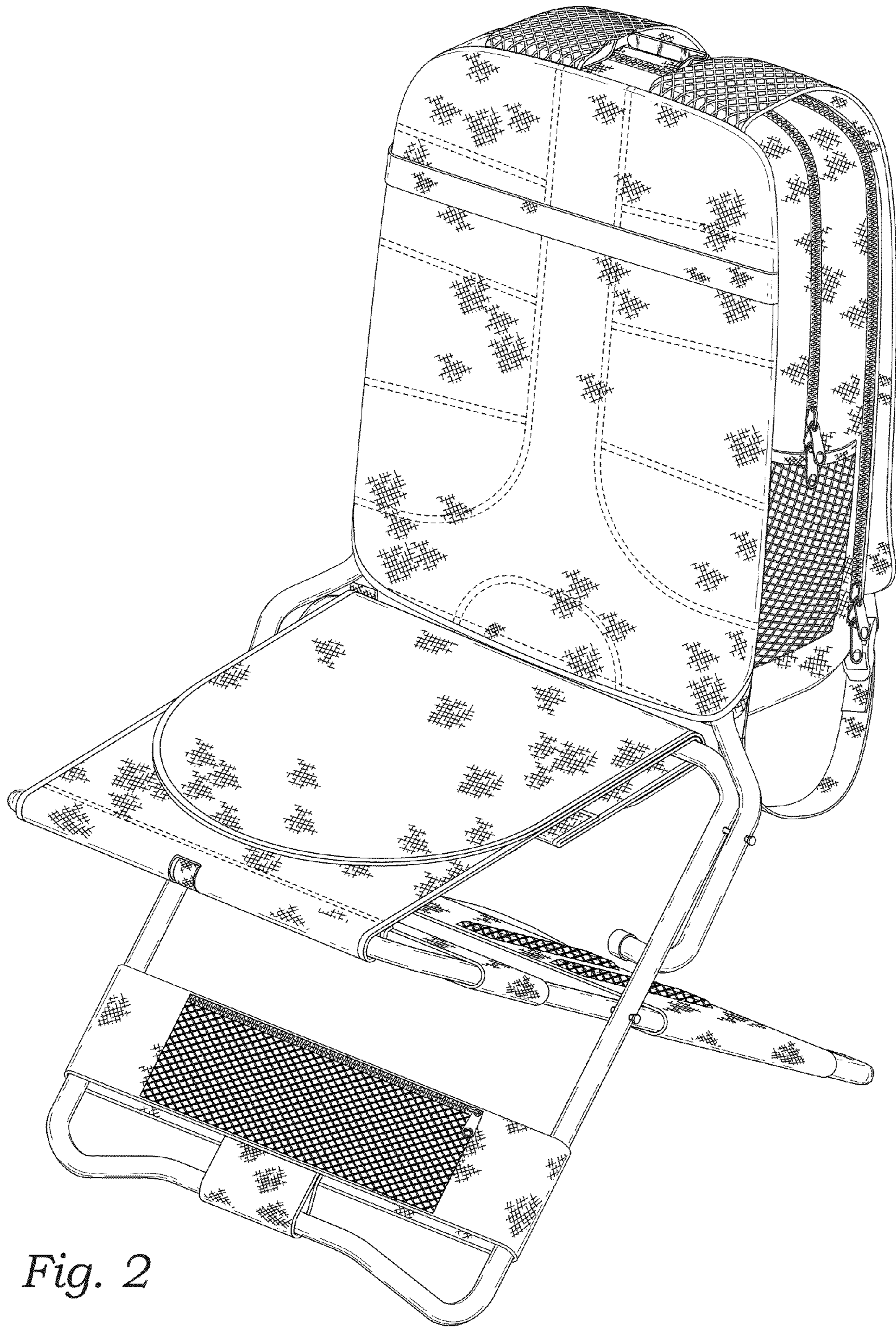

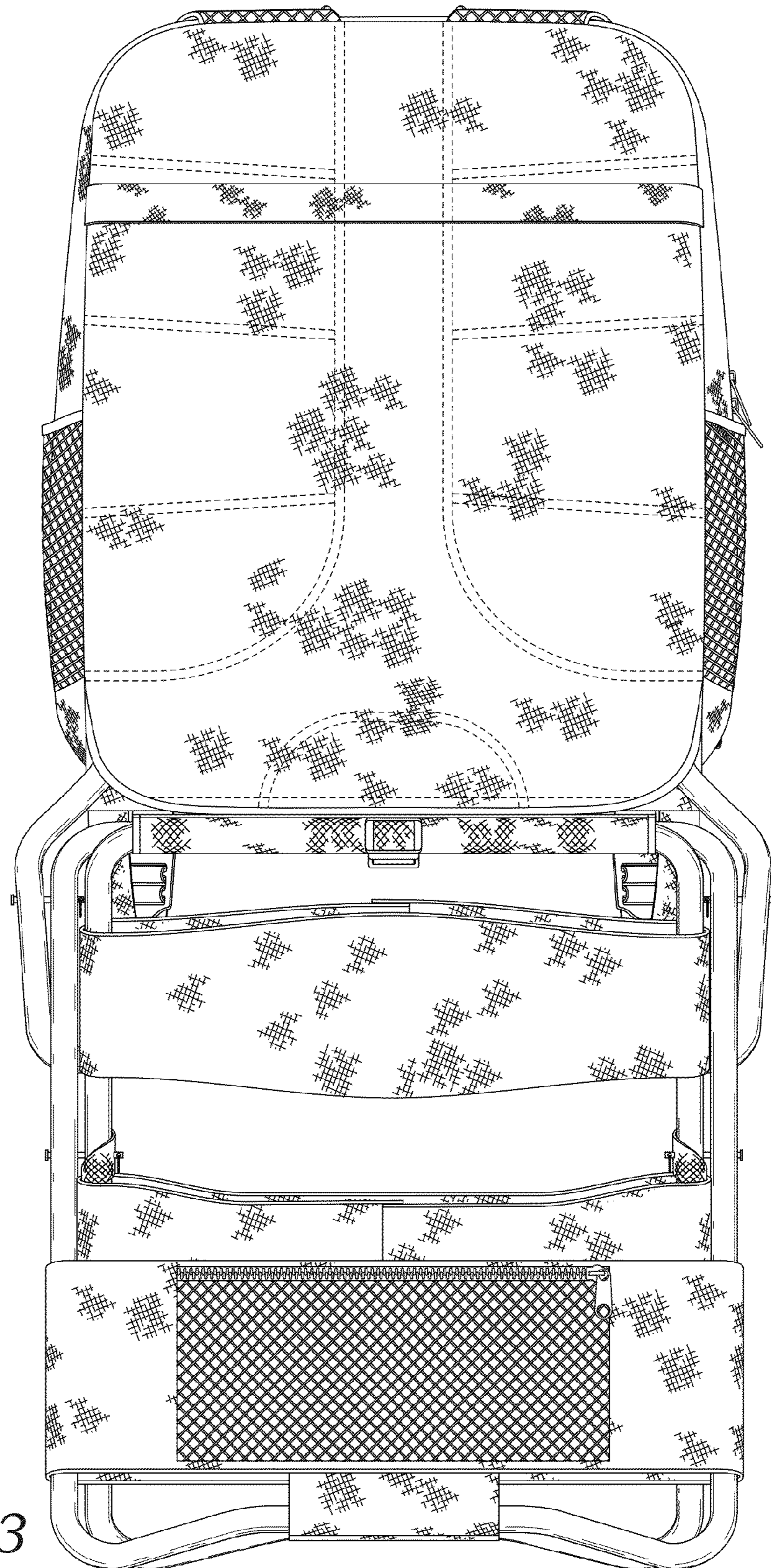

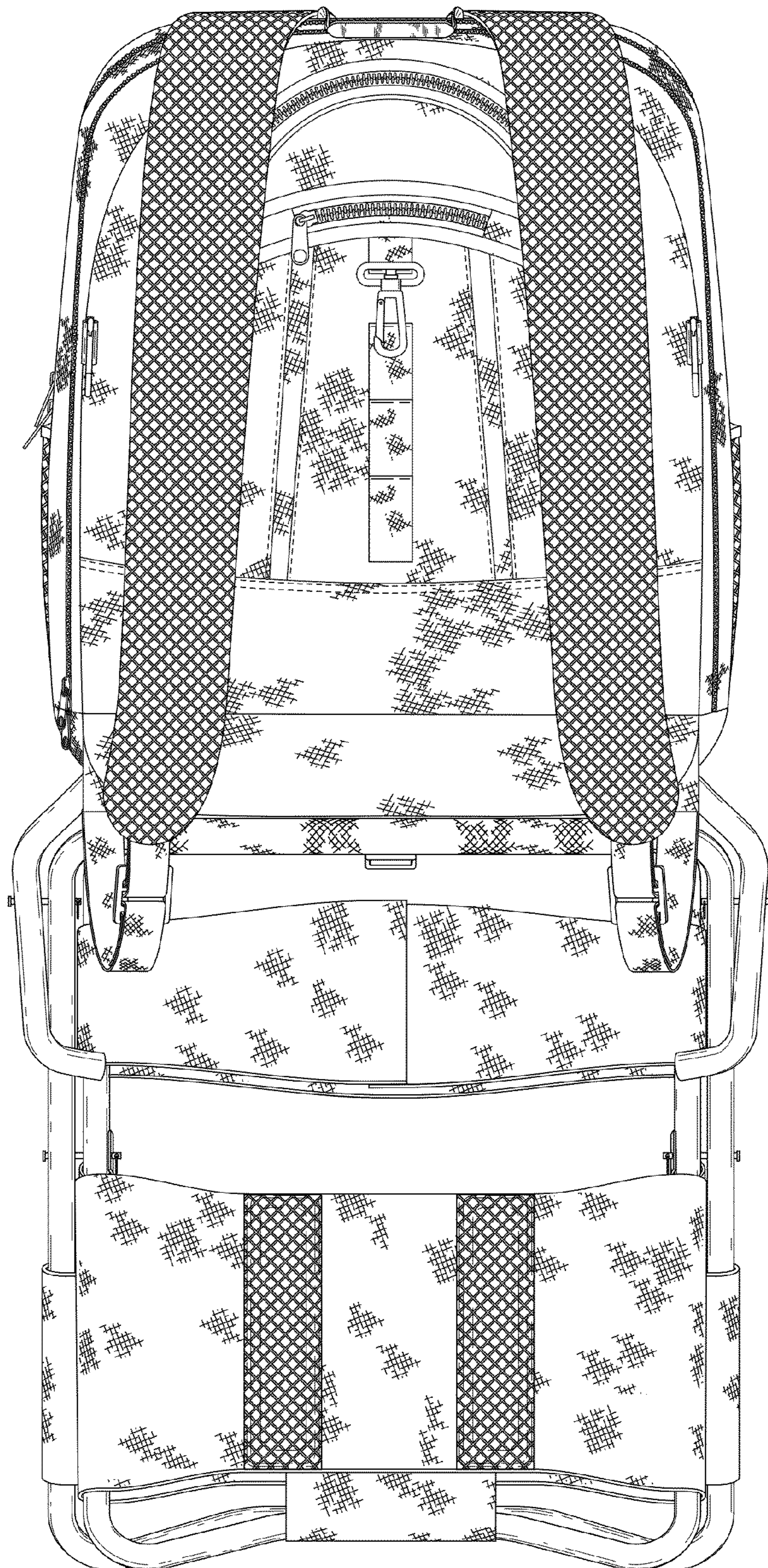

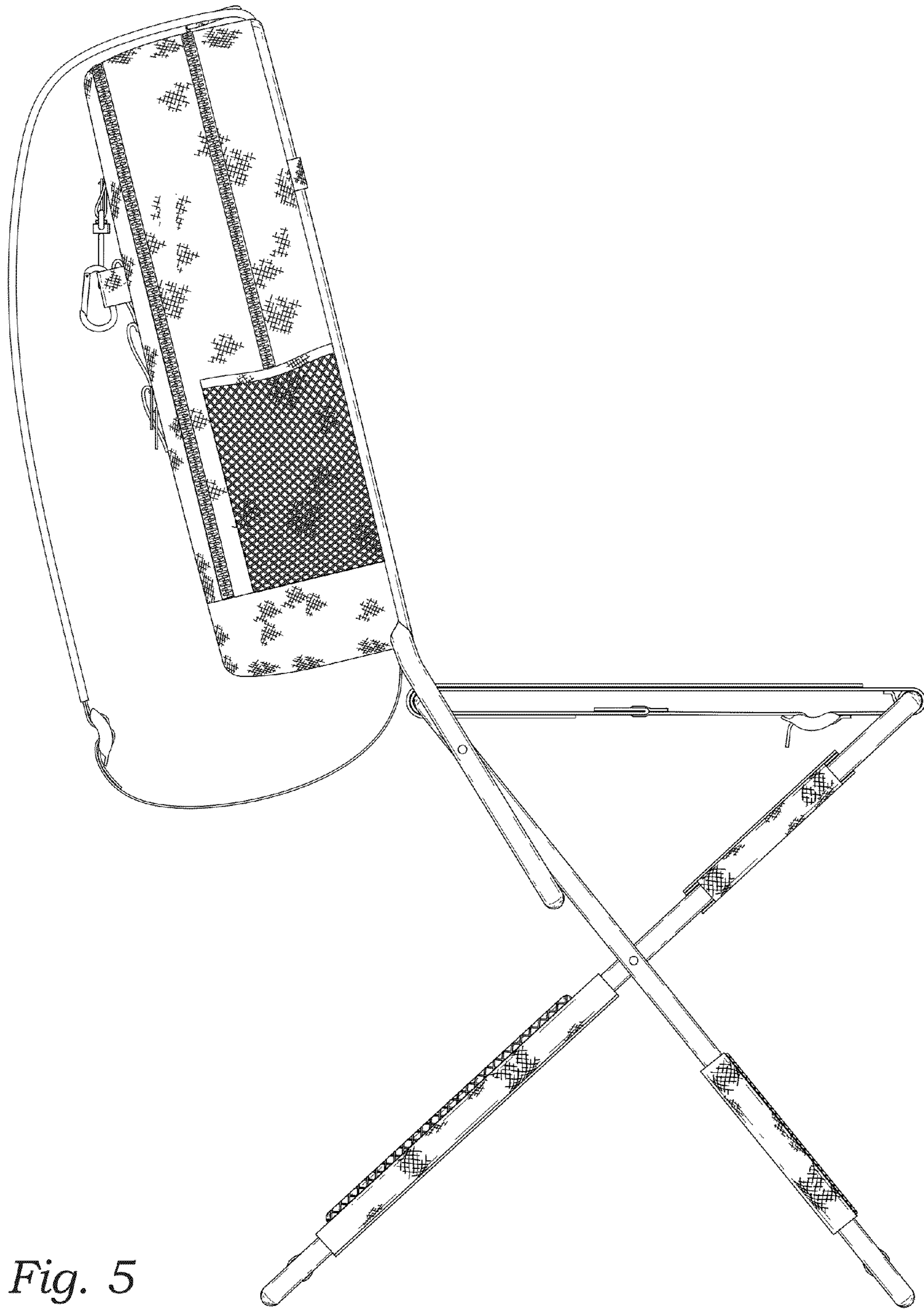

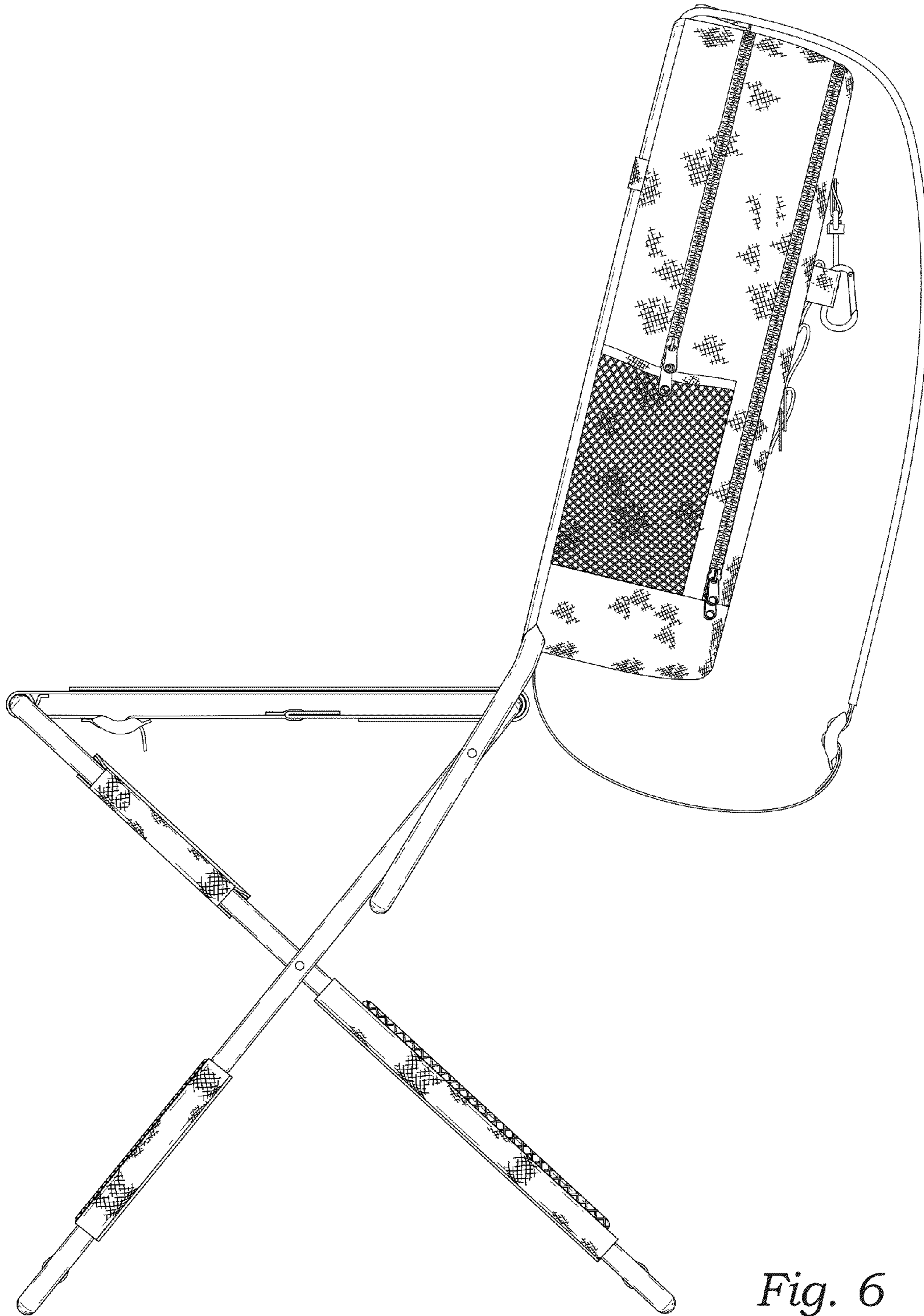

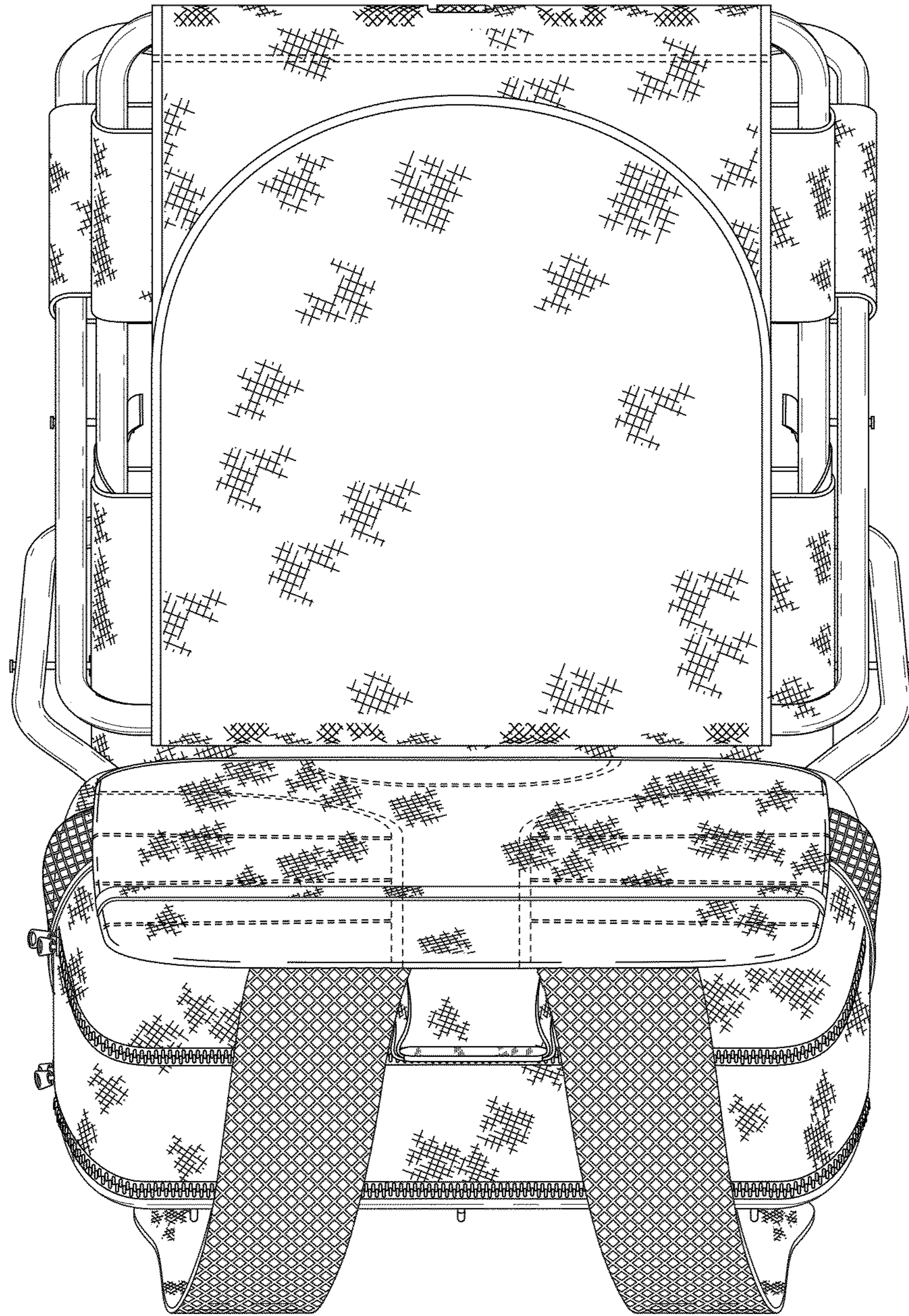

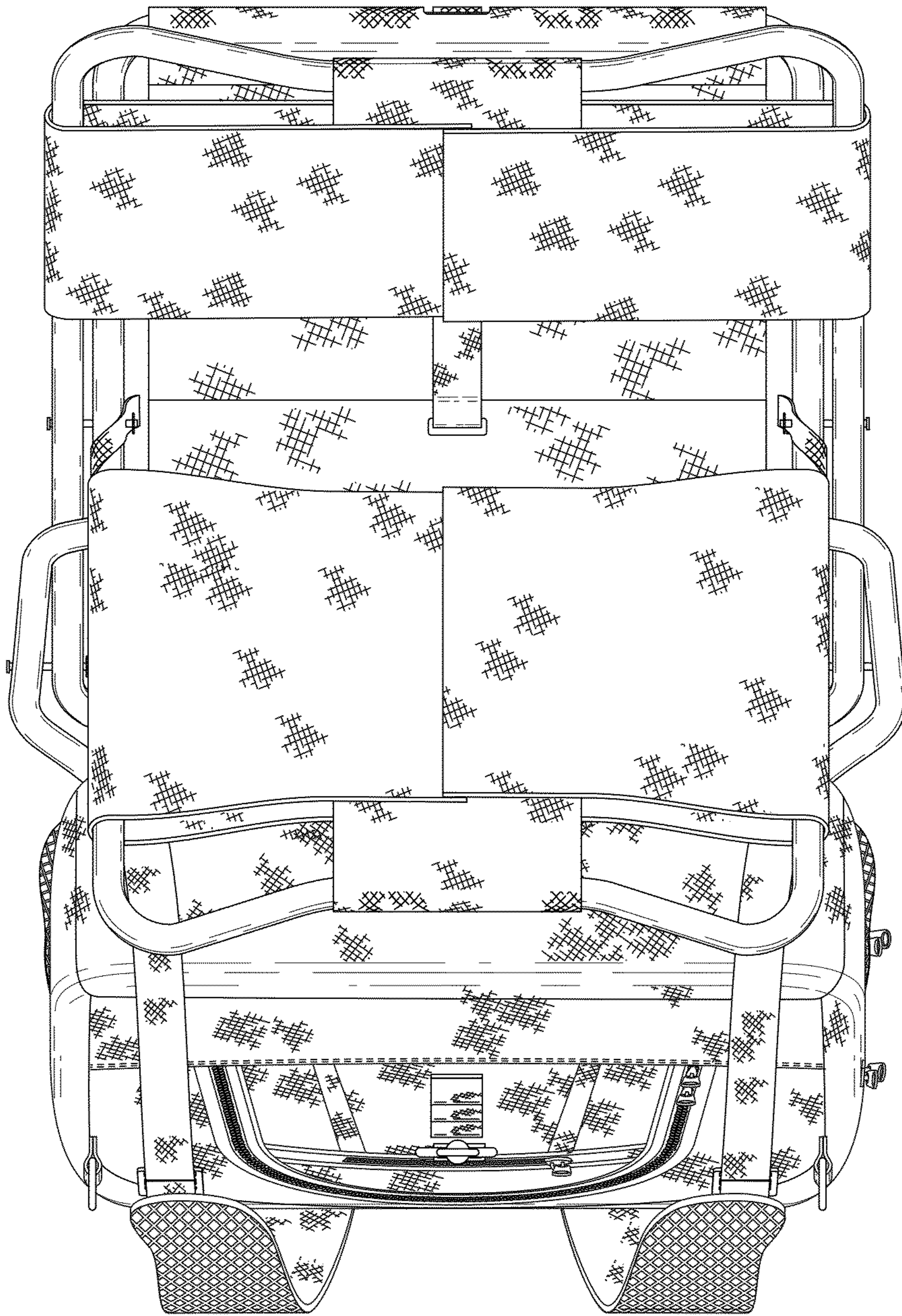

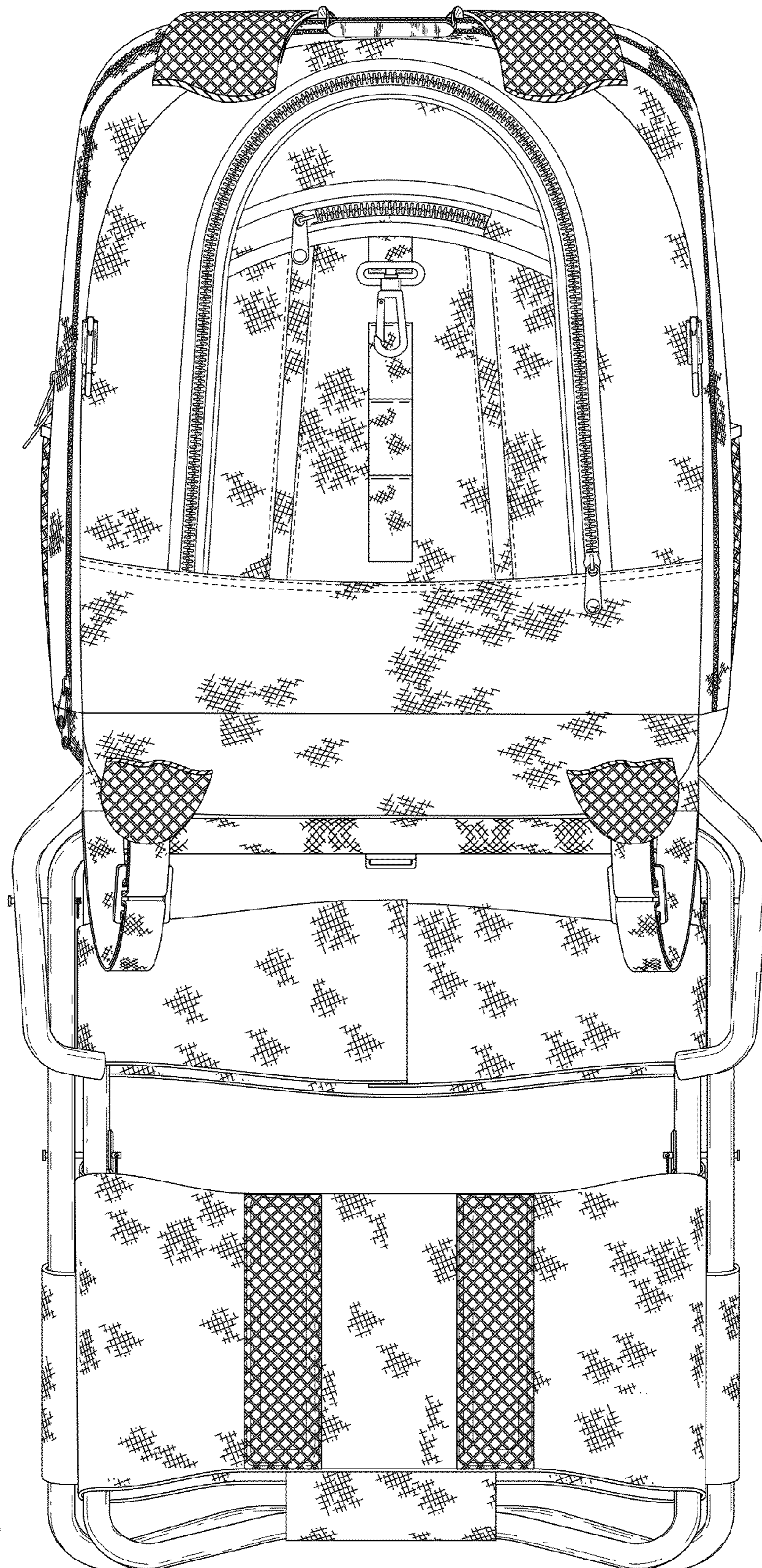
