(57) **CLAIM**

The ornamental design for convertible bar and food station, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a convertible bar and food station showing our new design, wherein the panels are positioned in front of the food station;

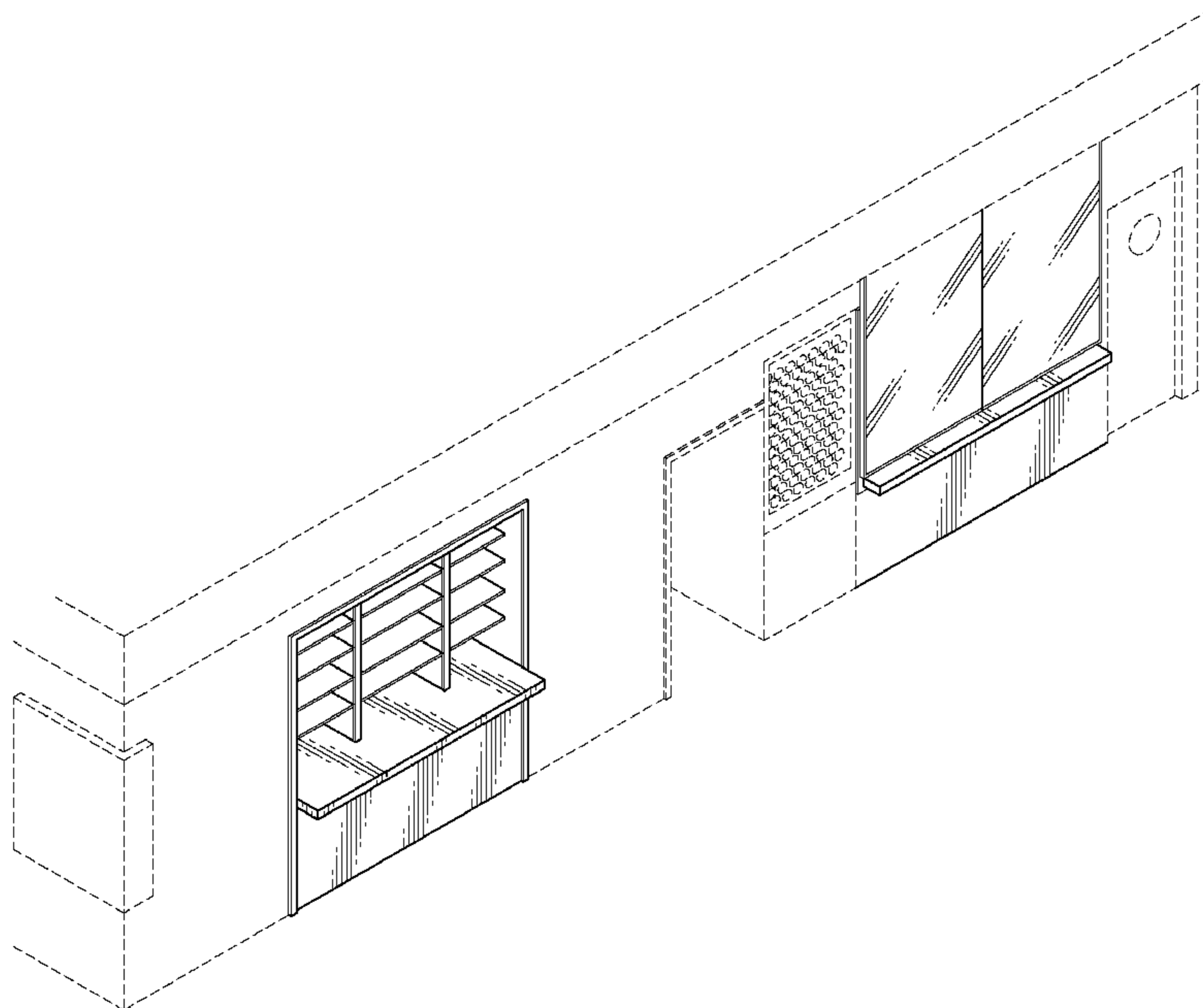
FIG. 2 is a front elevation view of FIG. 1;

FIG. 3 is another perspective view thereof, wherein the panels are positioned in front of the bar area; and,

FIG. 4 is a front elevation view of FIG. 3.

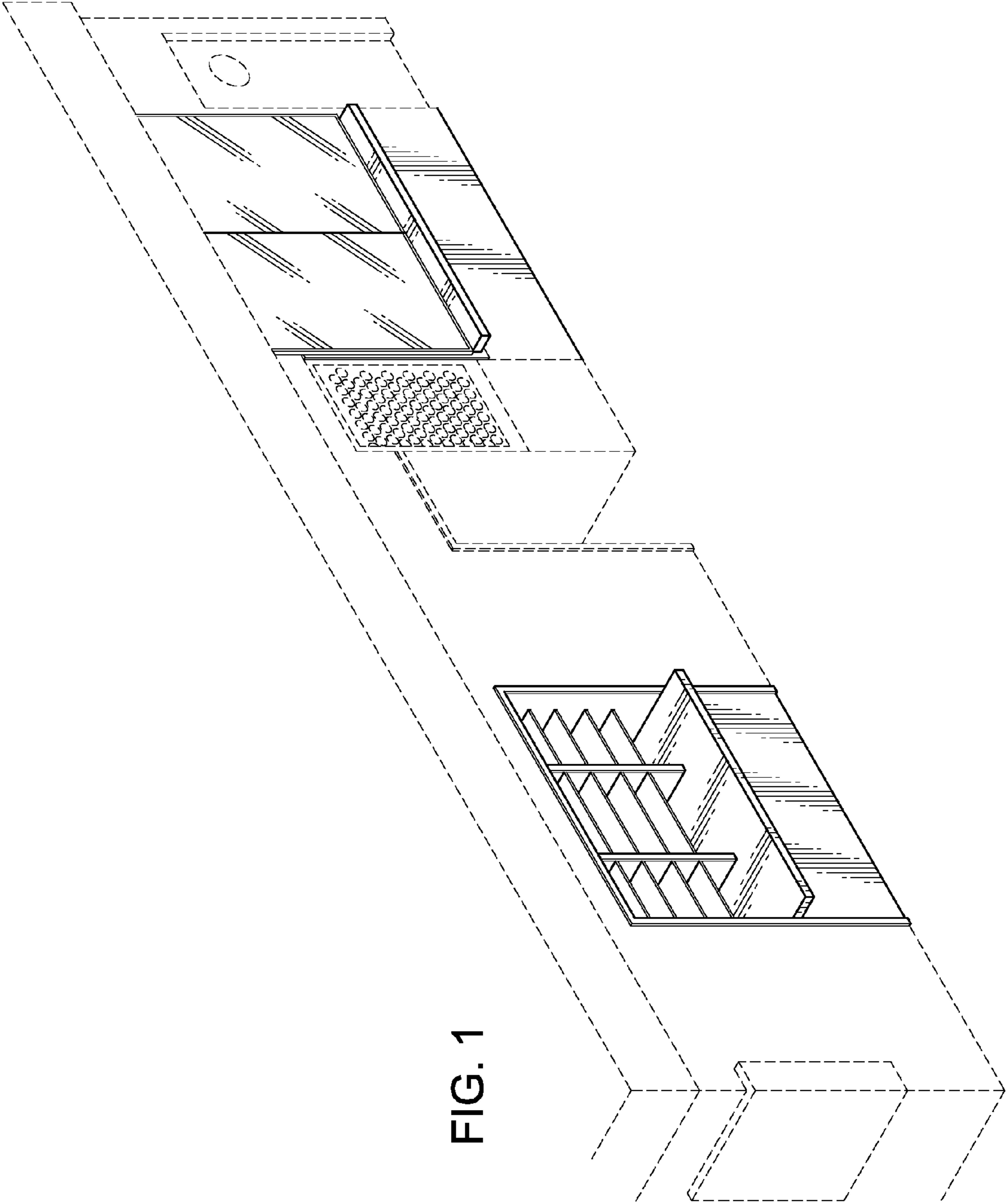
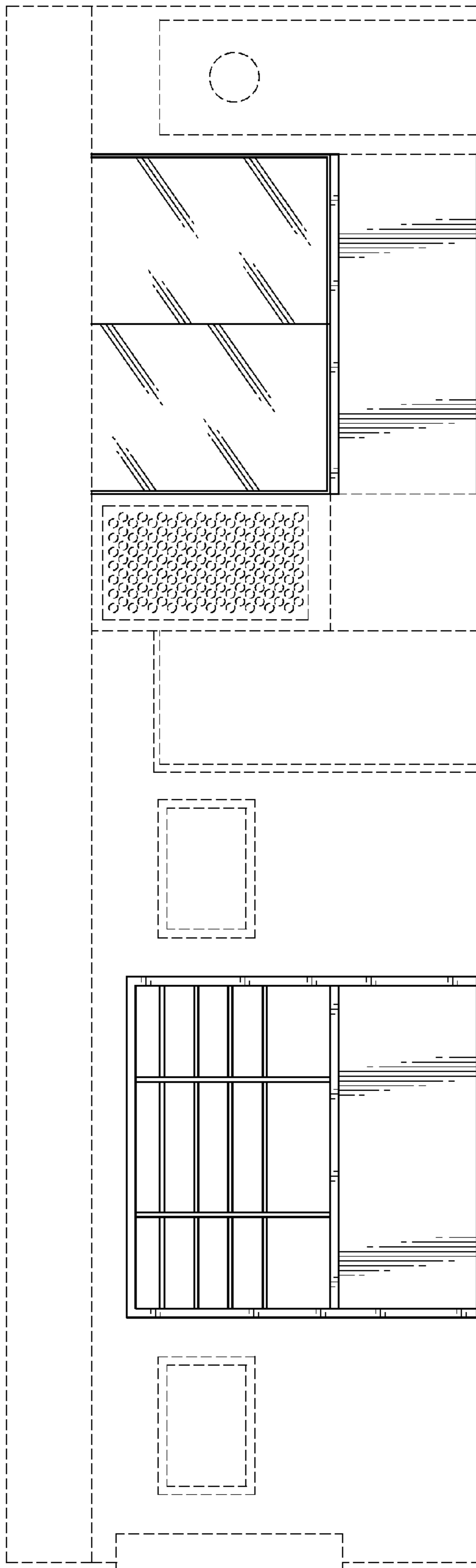

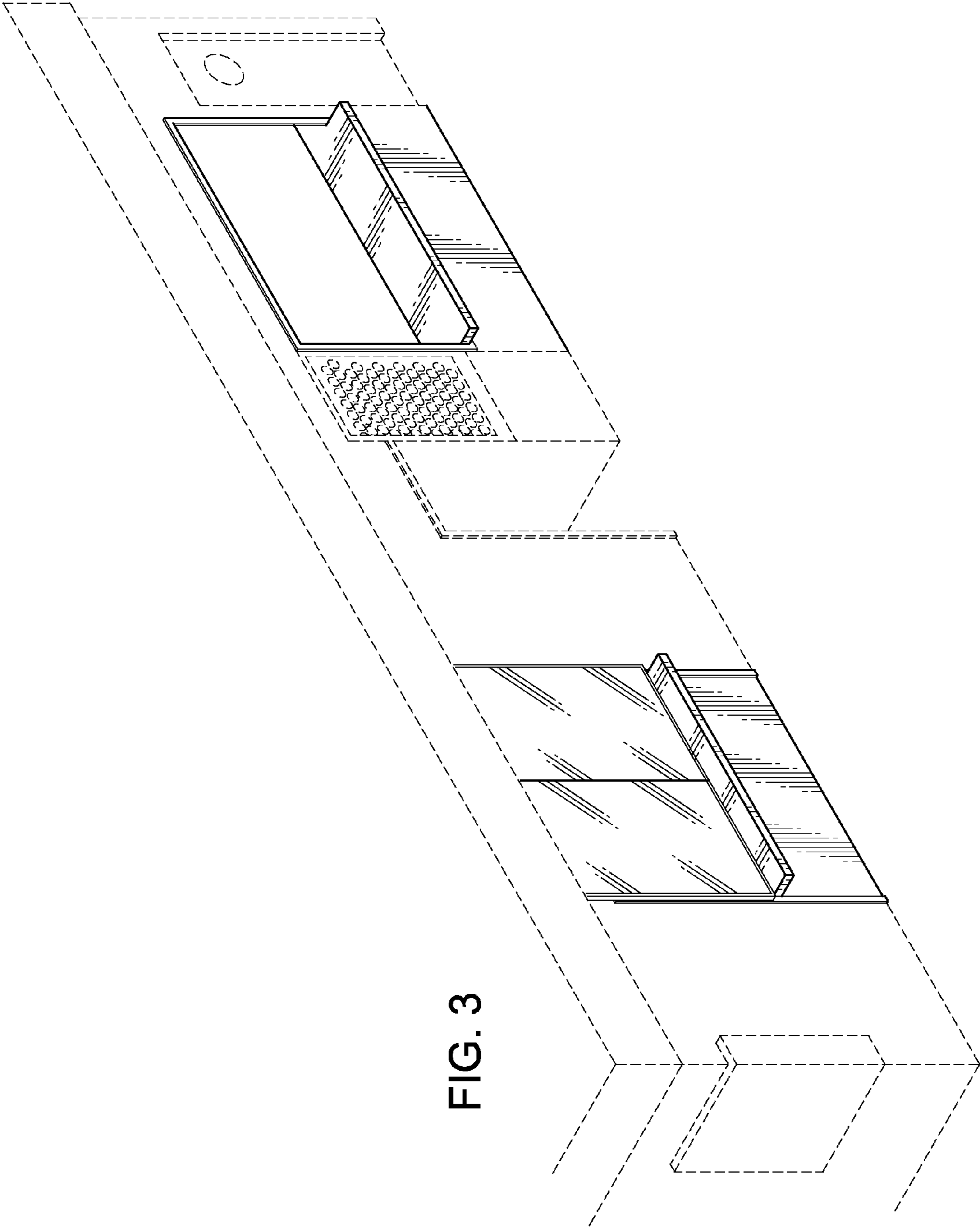
