DESCRIPTION

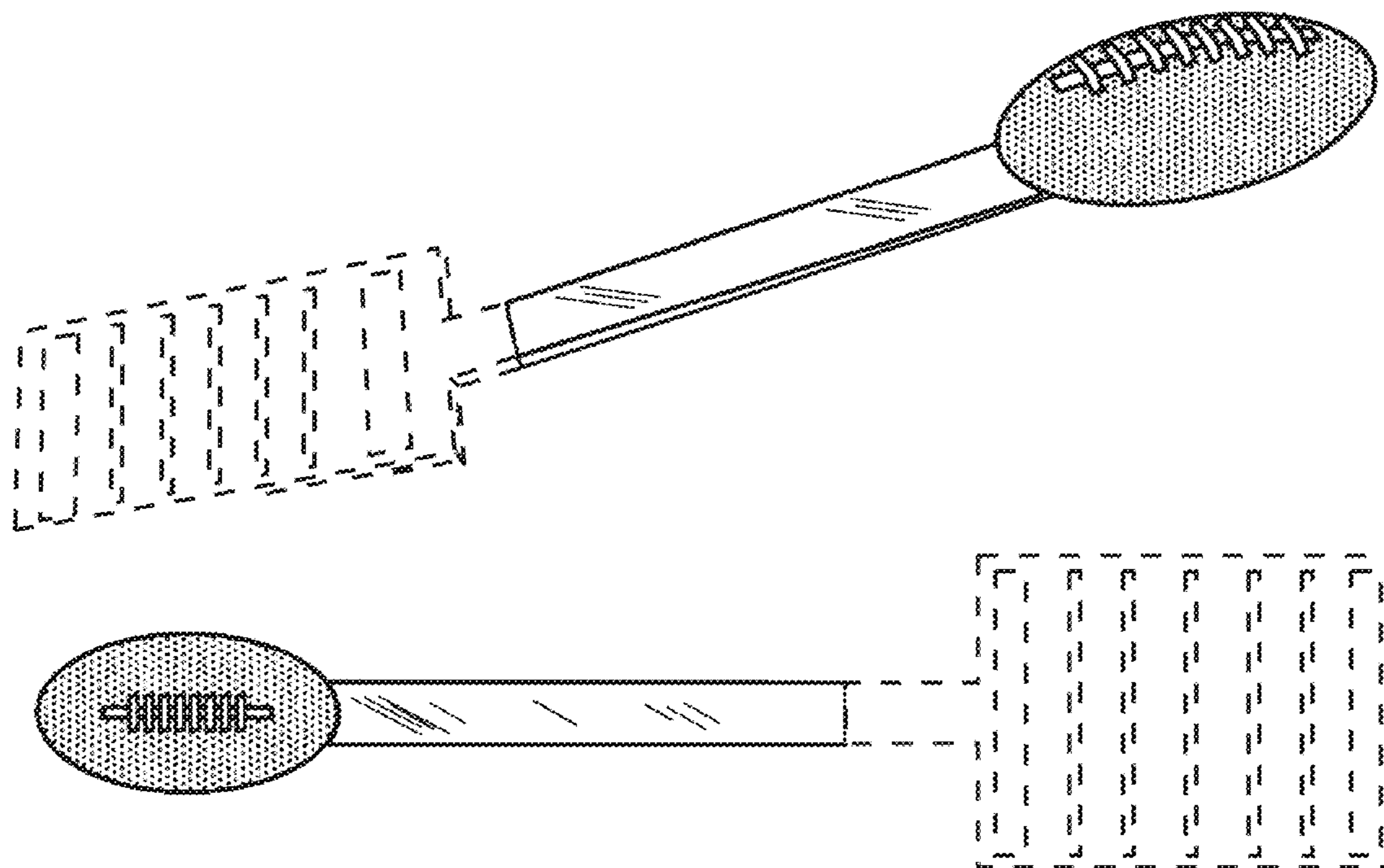
FIG. 1 is a perspective view of a football spatula showing my new design;
FIG. 2 is a top plan view thereof; and,
FIG. 3 is a side elevation view thereof.
The broken lines shown in the drawings represent portions of the football spatula that form no part of the claimed design.
The present invention is in the area of cooking utensils, and more particularly pertains to a spatula to be used with grilling food.

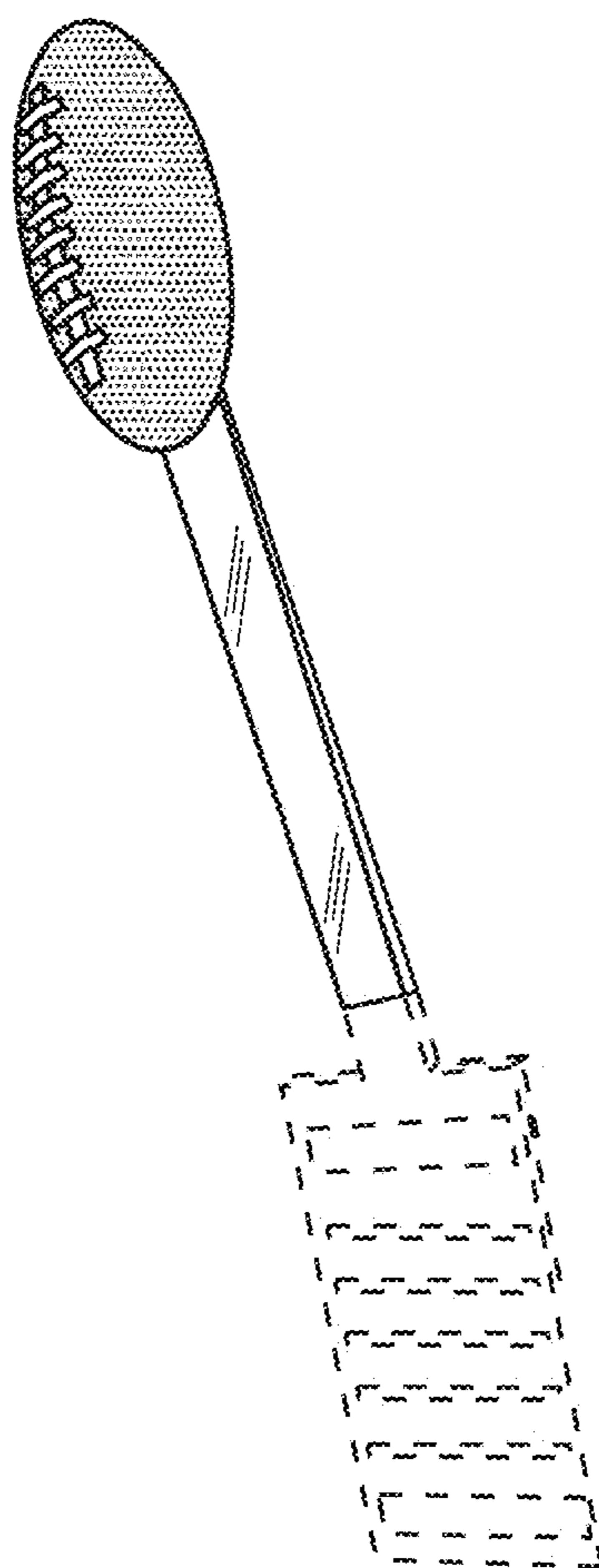

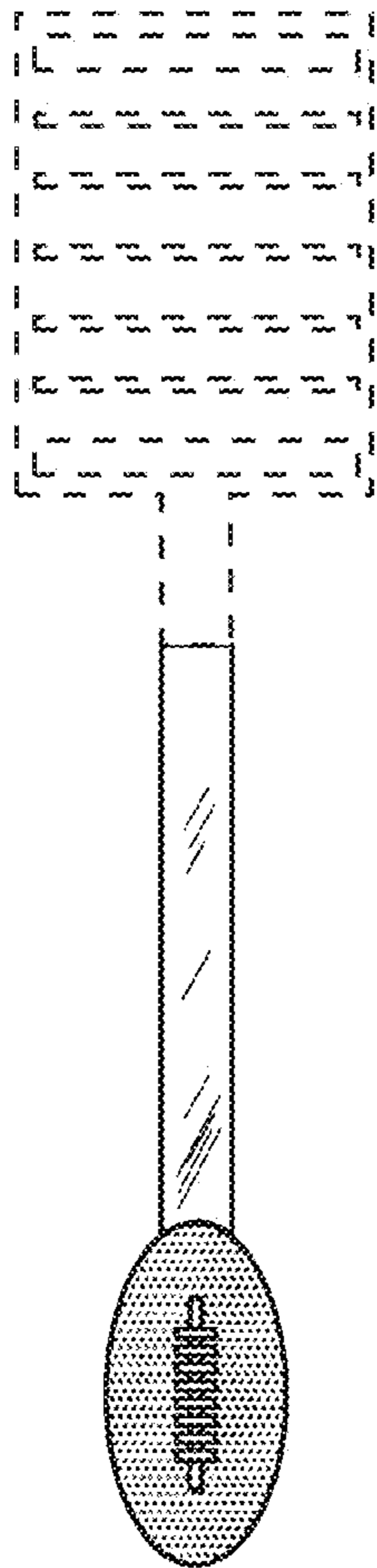

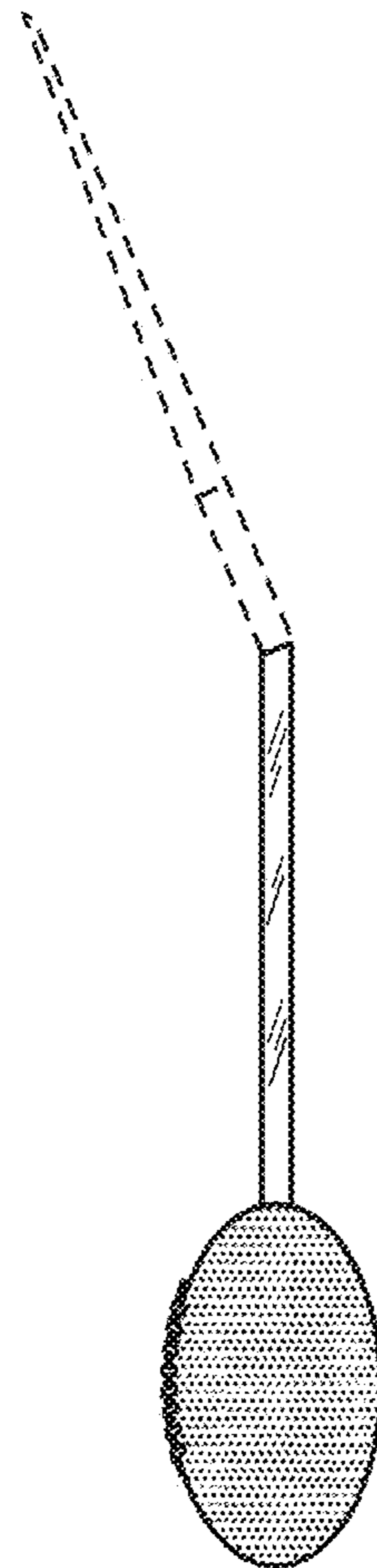
