(57) **CLAIM**

The ornamental design for a container, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a container showing our new design;

FIG. 2 is a left side view thereof;

FIG. 3 is a right side view thereof;

FIG. 4 is a rear view thereof, the front view being a mirror image thereof;

FIG. 5 is a top plan view thereof;

FIG. 6 is a bottom plan view thereof; and,

FIG. 7 is a bottom perspective view thereof.

The broken lines shown are included for the purpose of illustrating the unclaimed portions of the container and form no part of the claim. The shading in the figures is intended to show contour and transparency or translucency and not surface ornamentation.

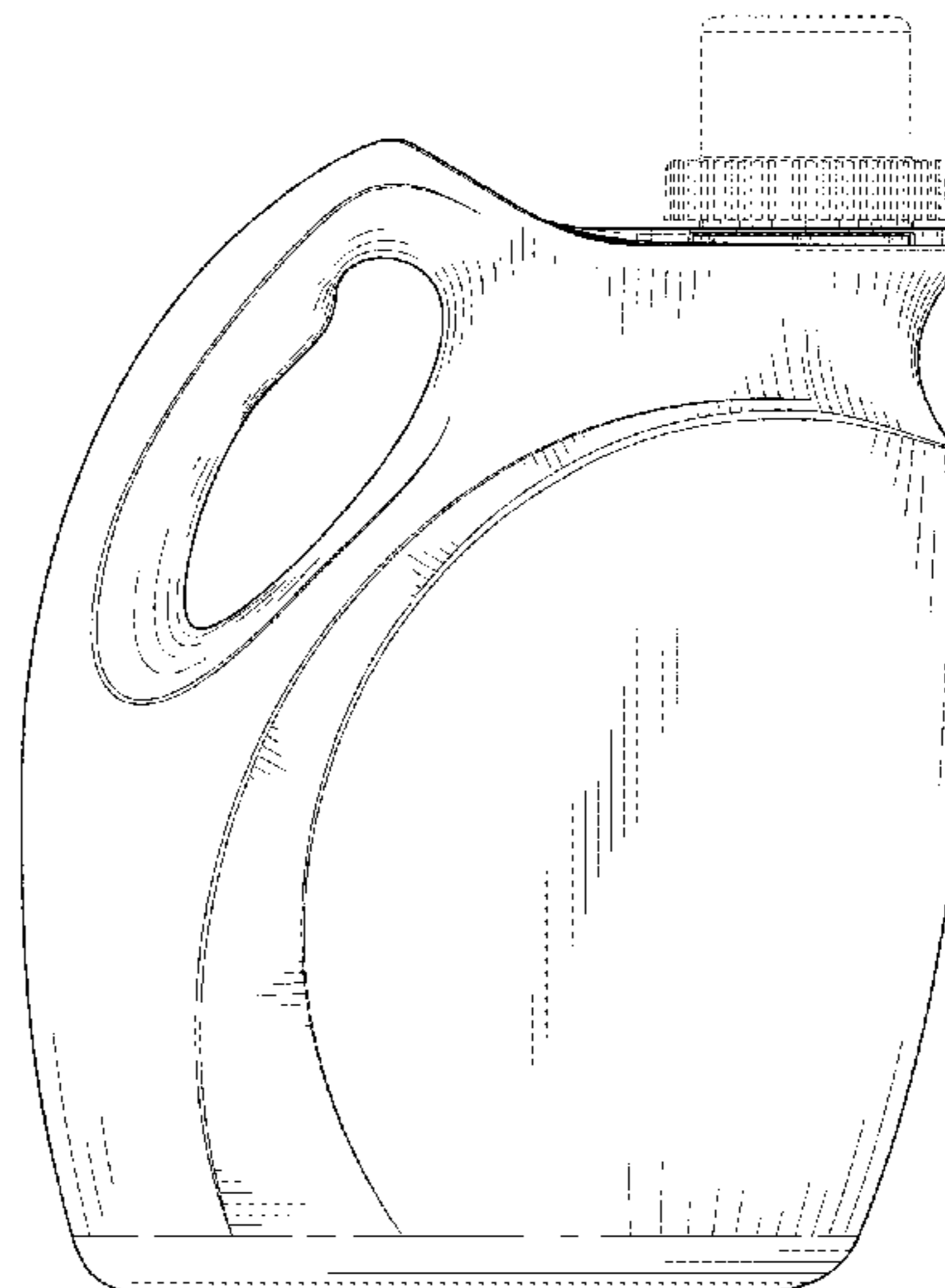
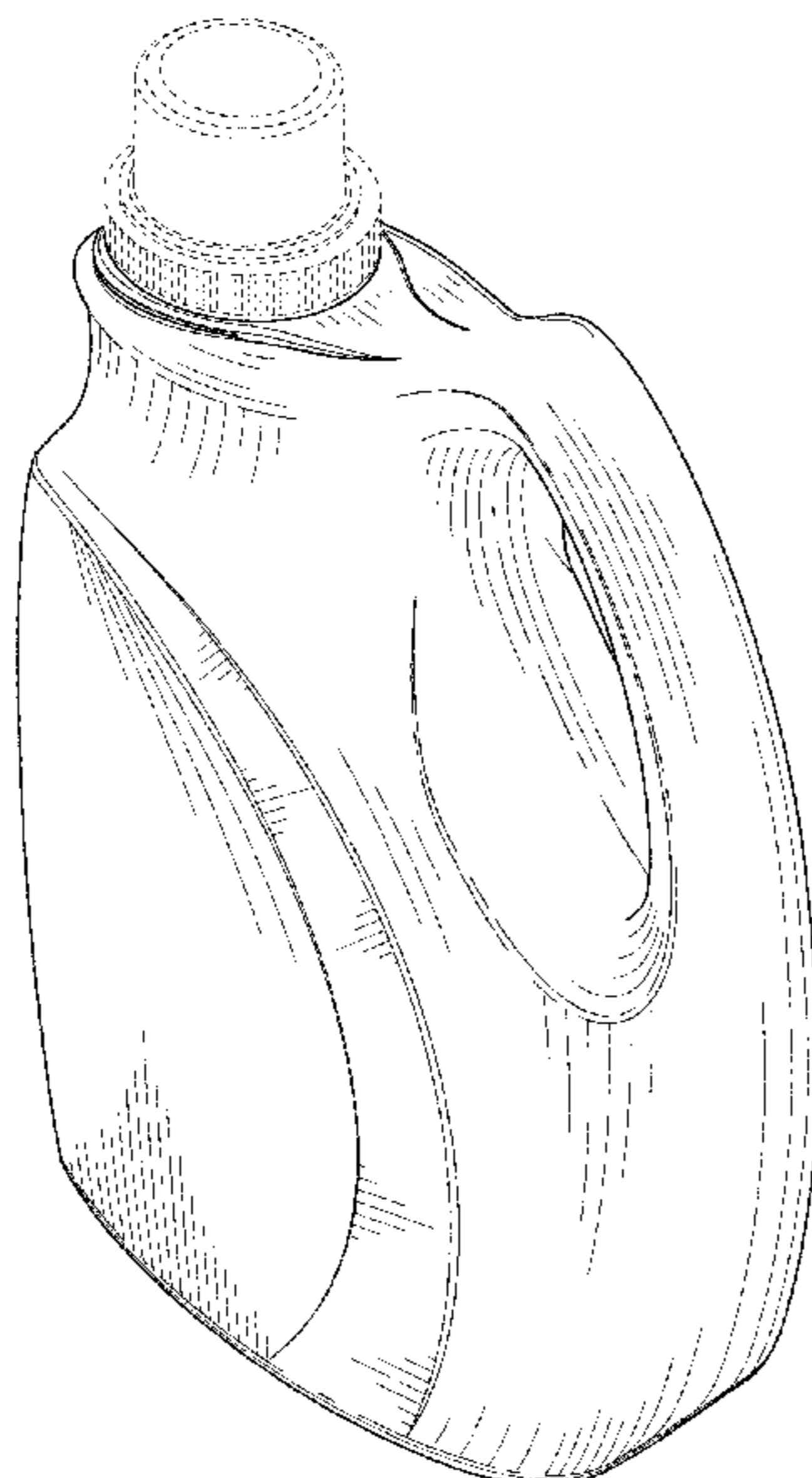

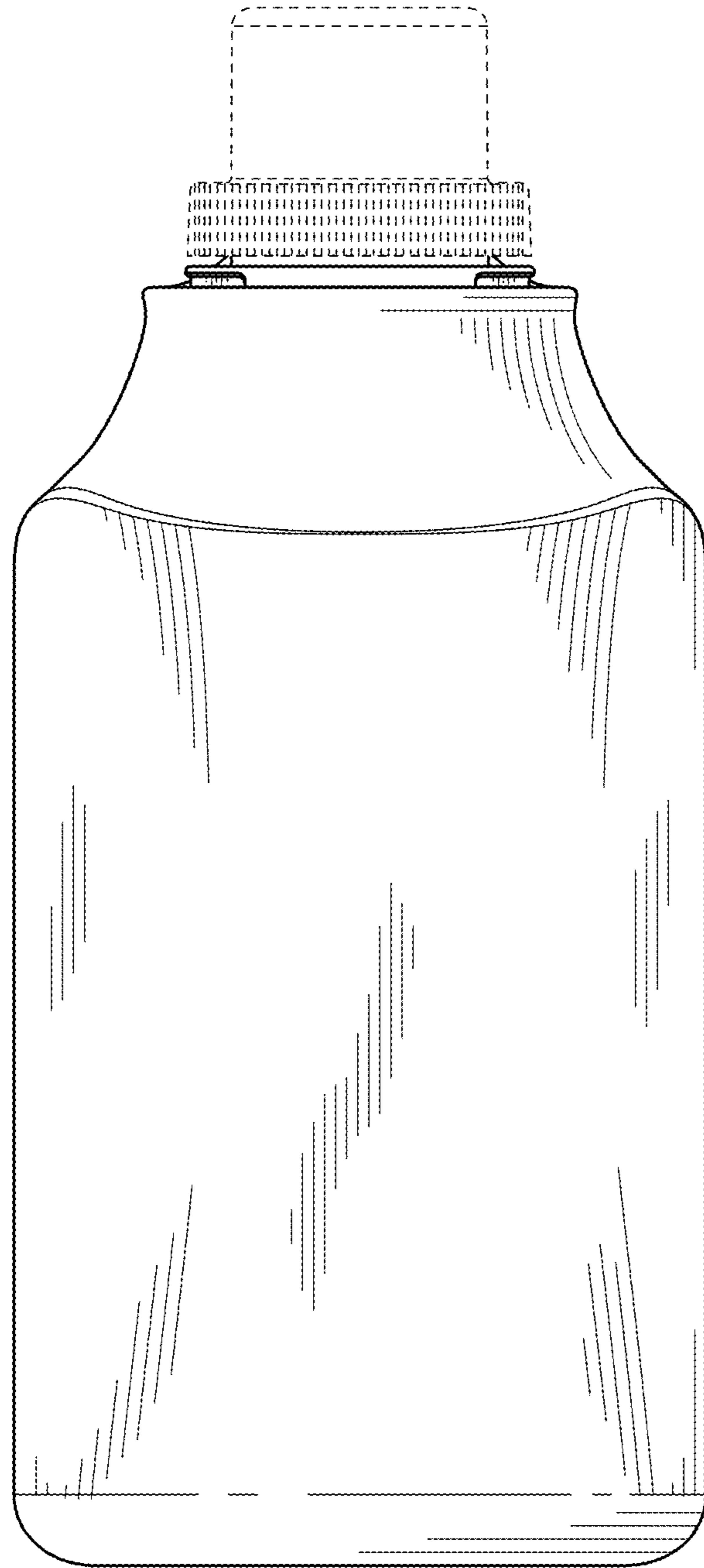

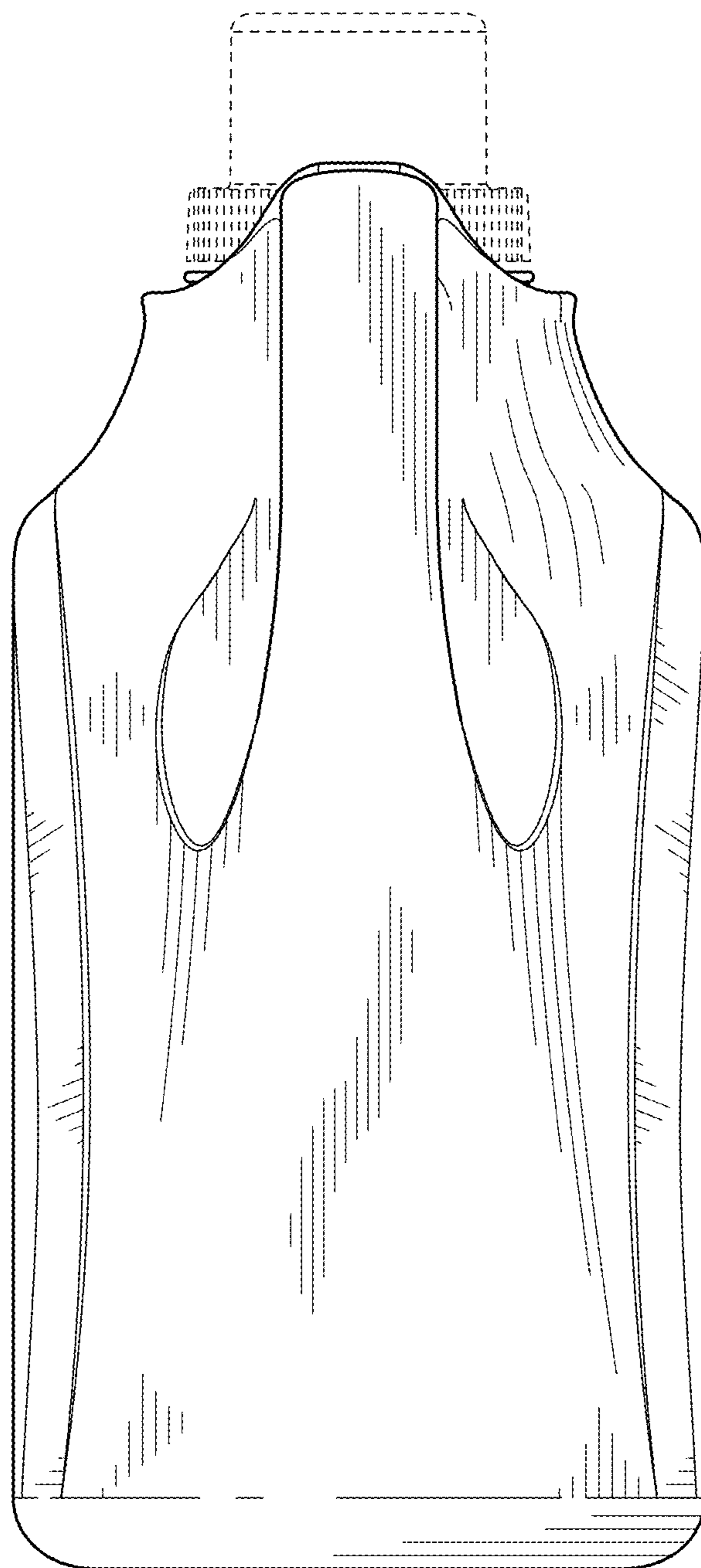

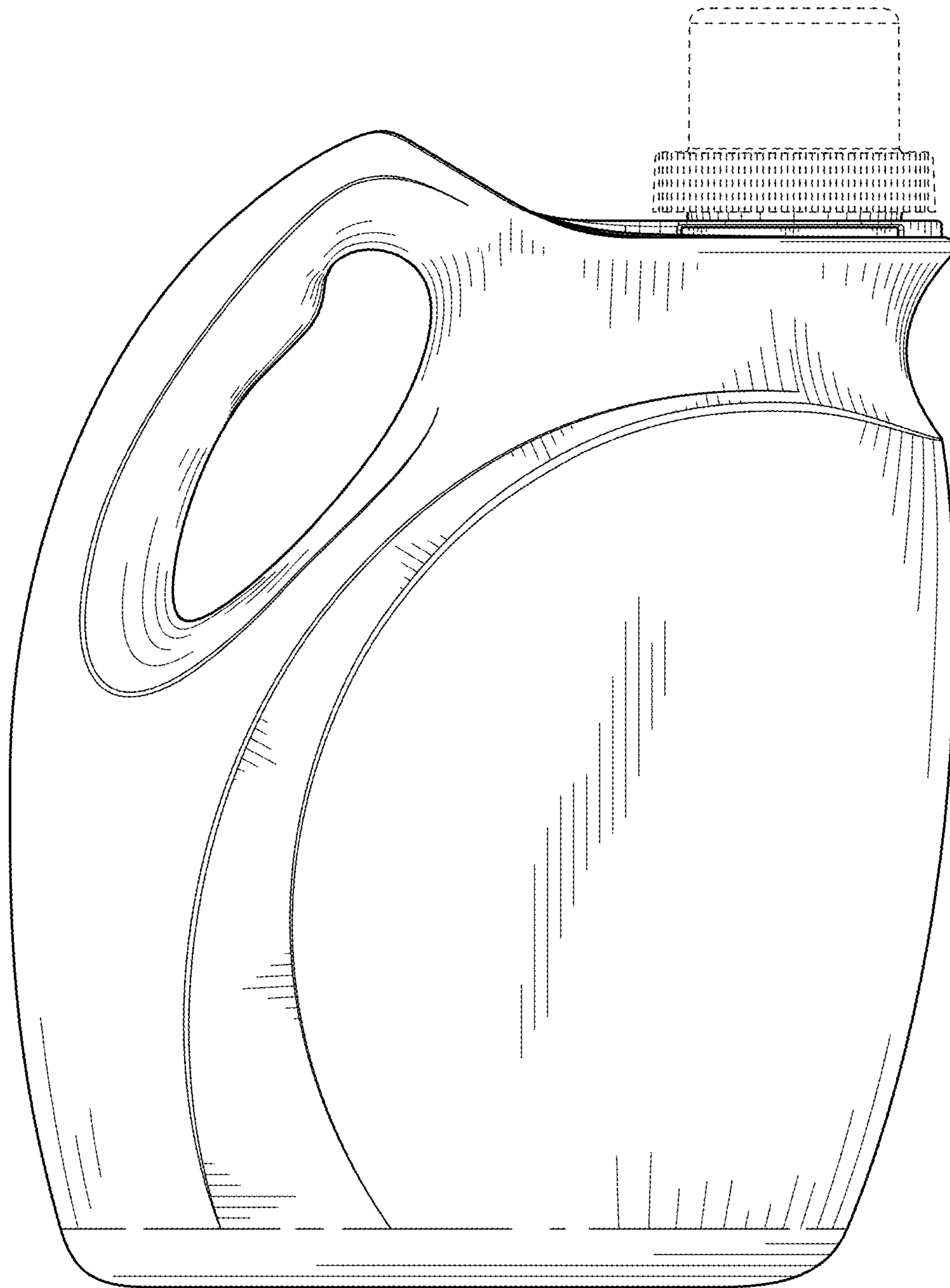

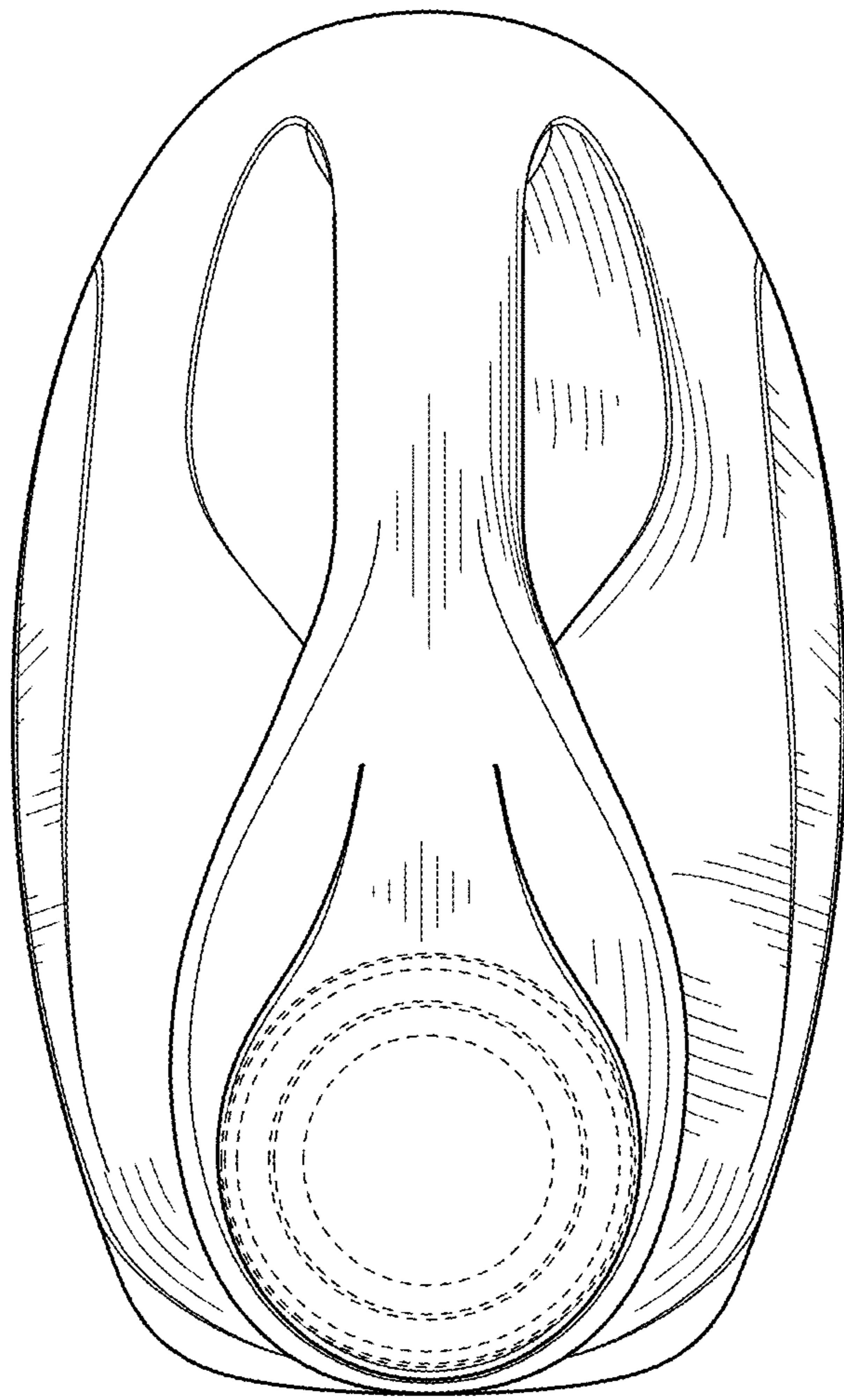

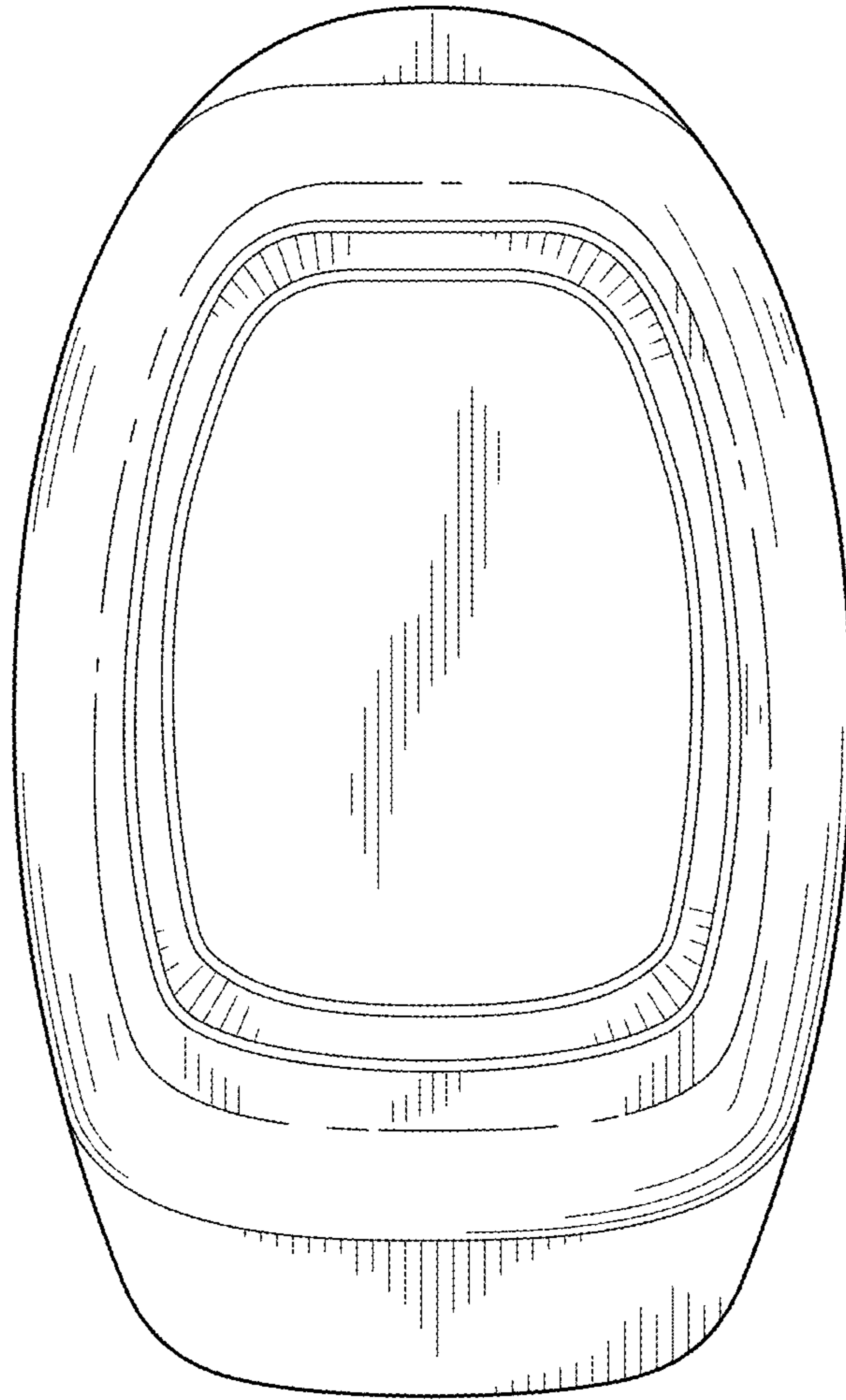

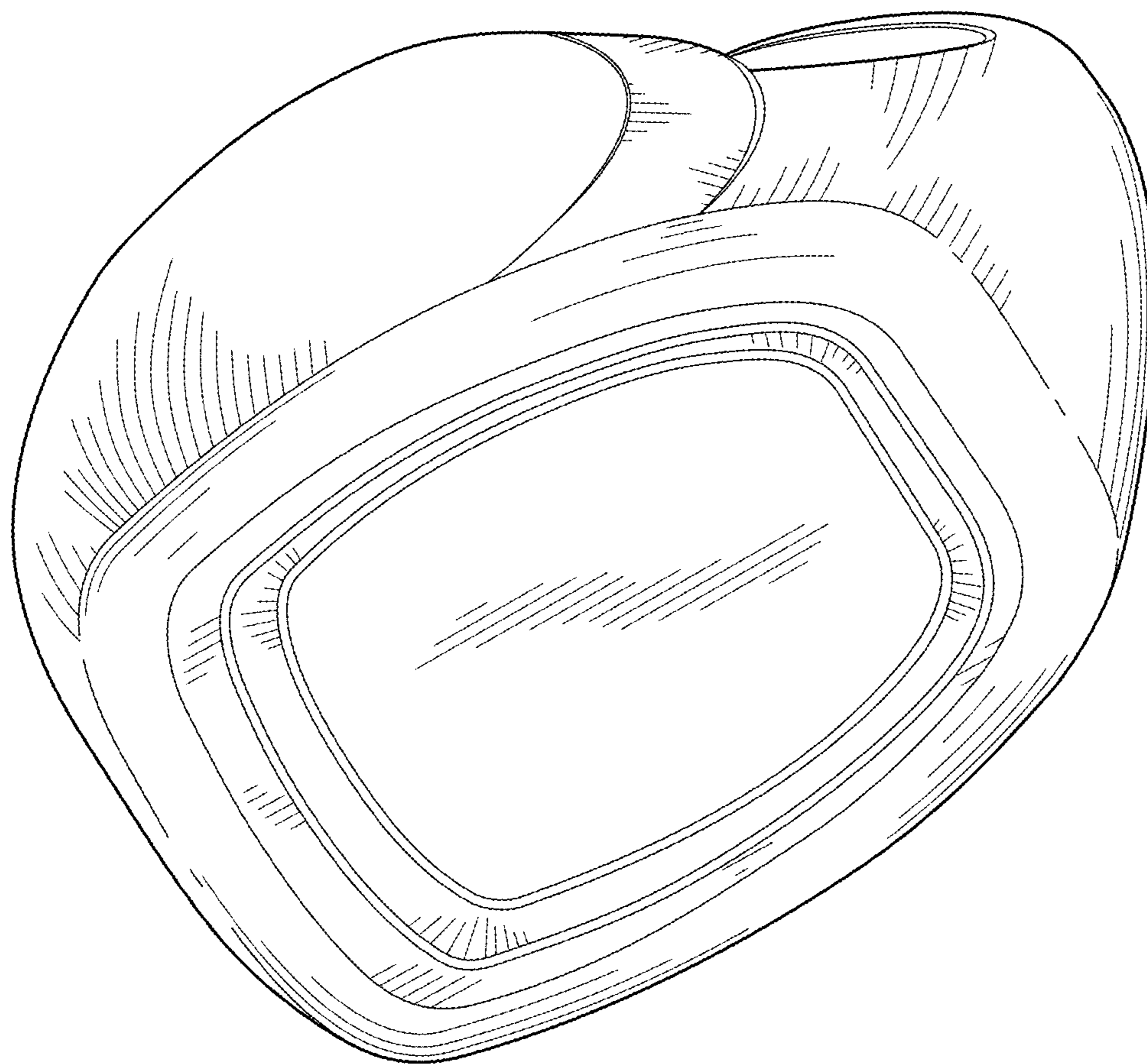
