FIG. 1 is a perspective view of the ladder pack of the present invention.

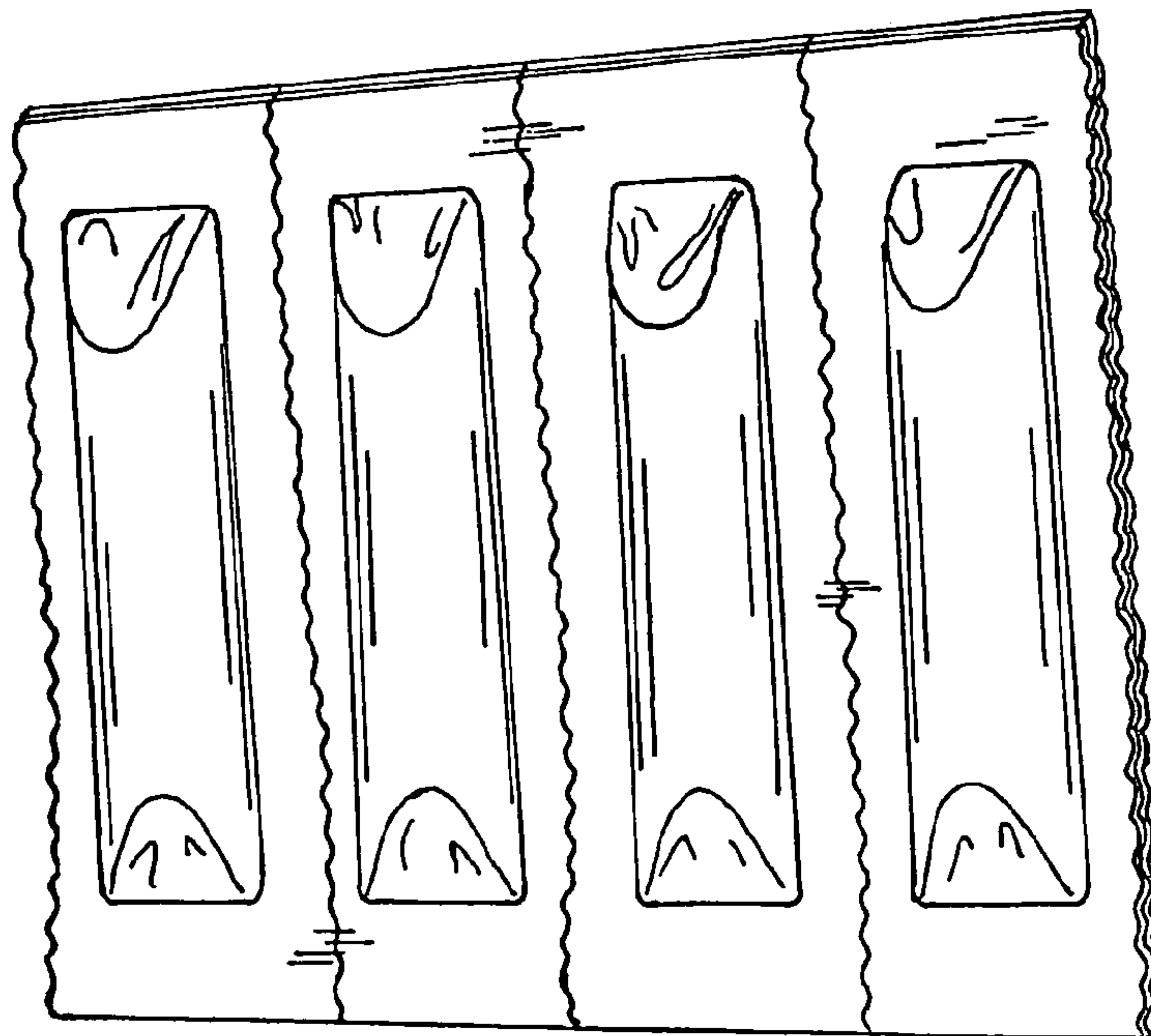
FIG. 2 is a front view of the ladder pack of FIG. 1.

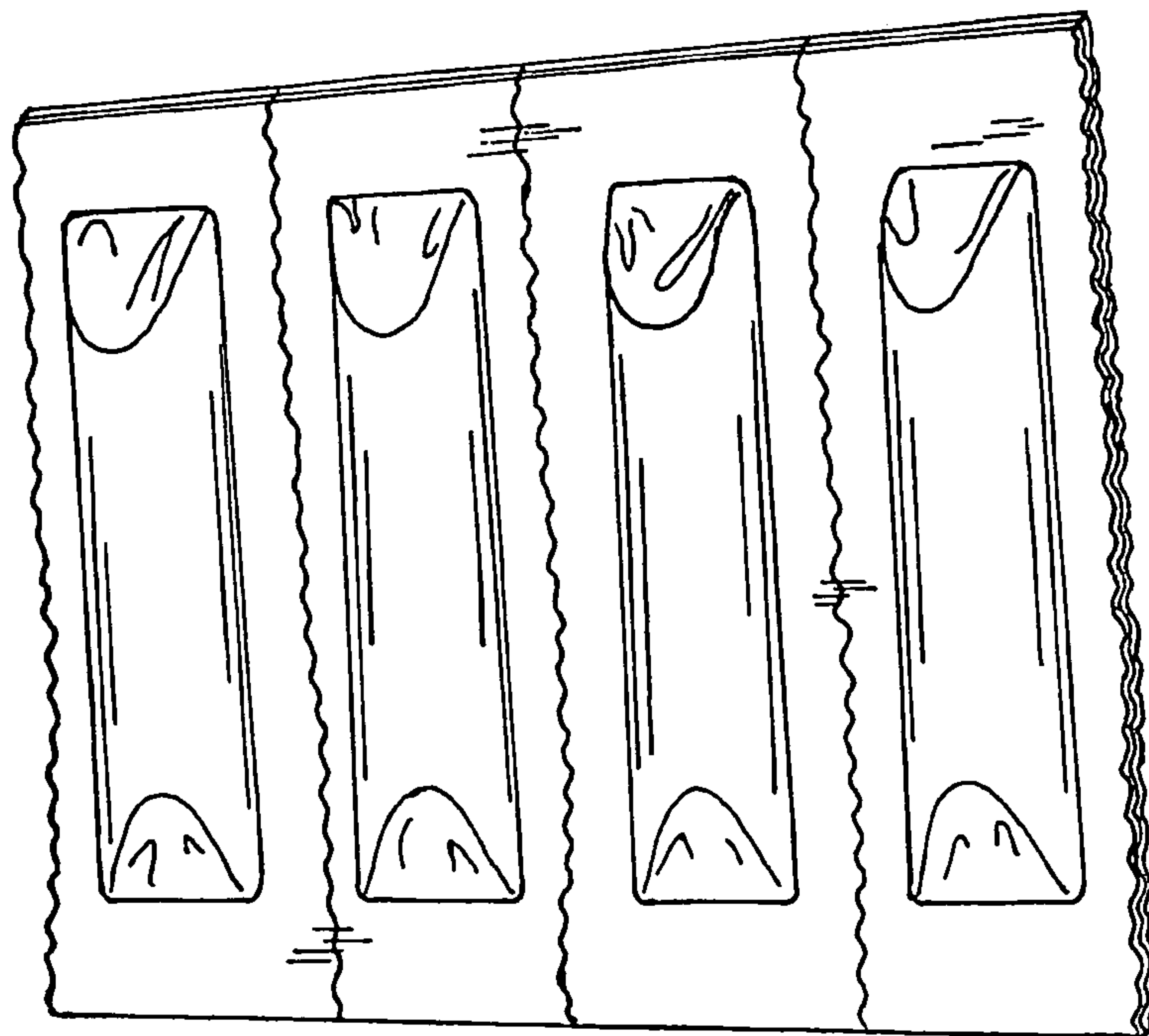

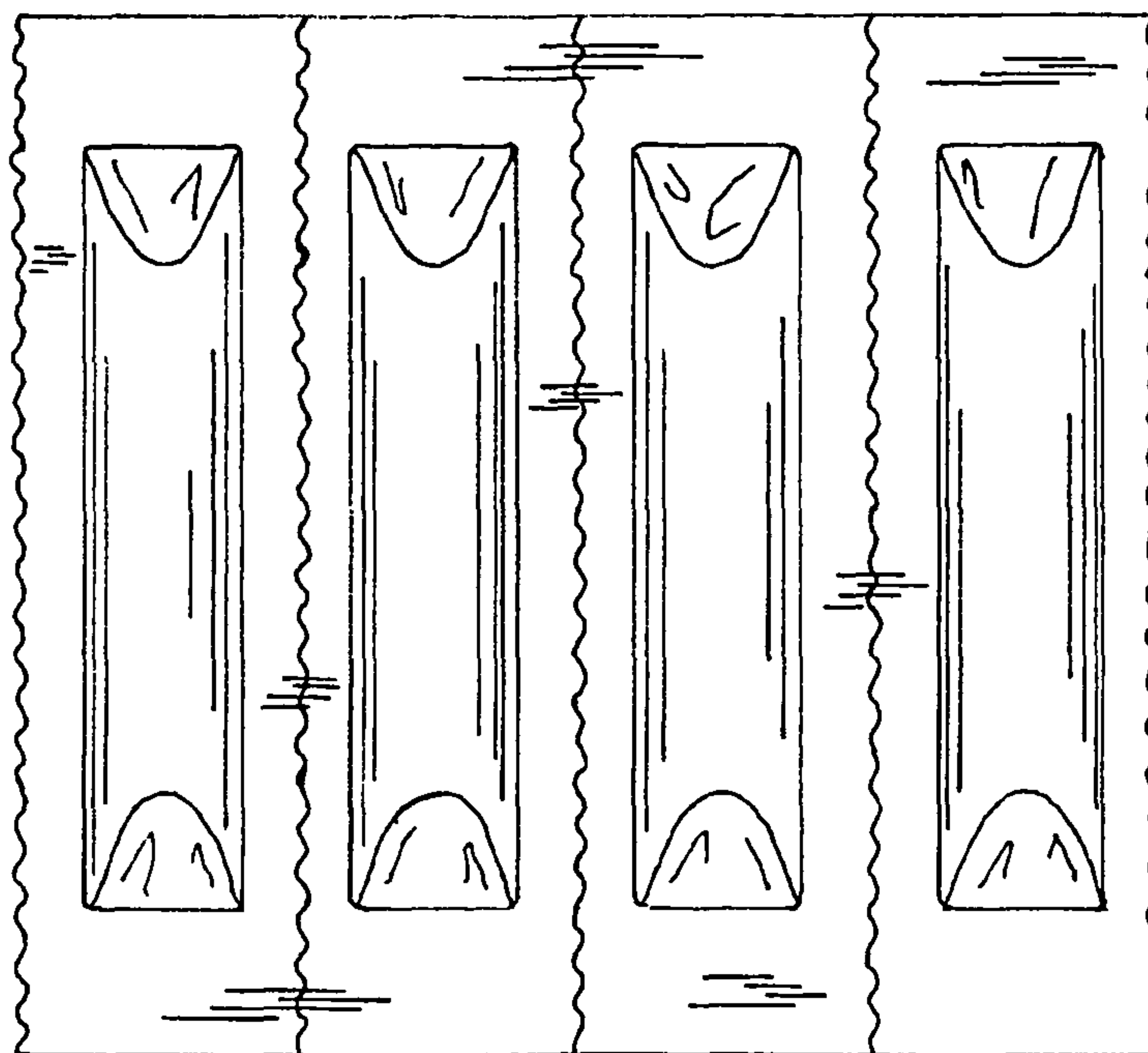

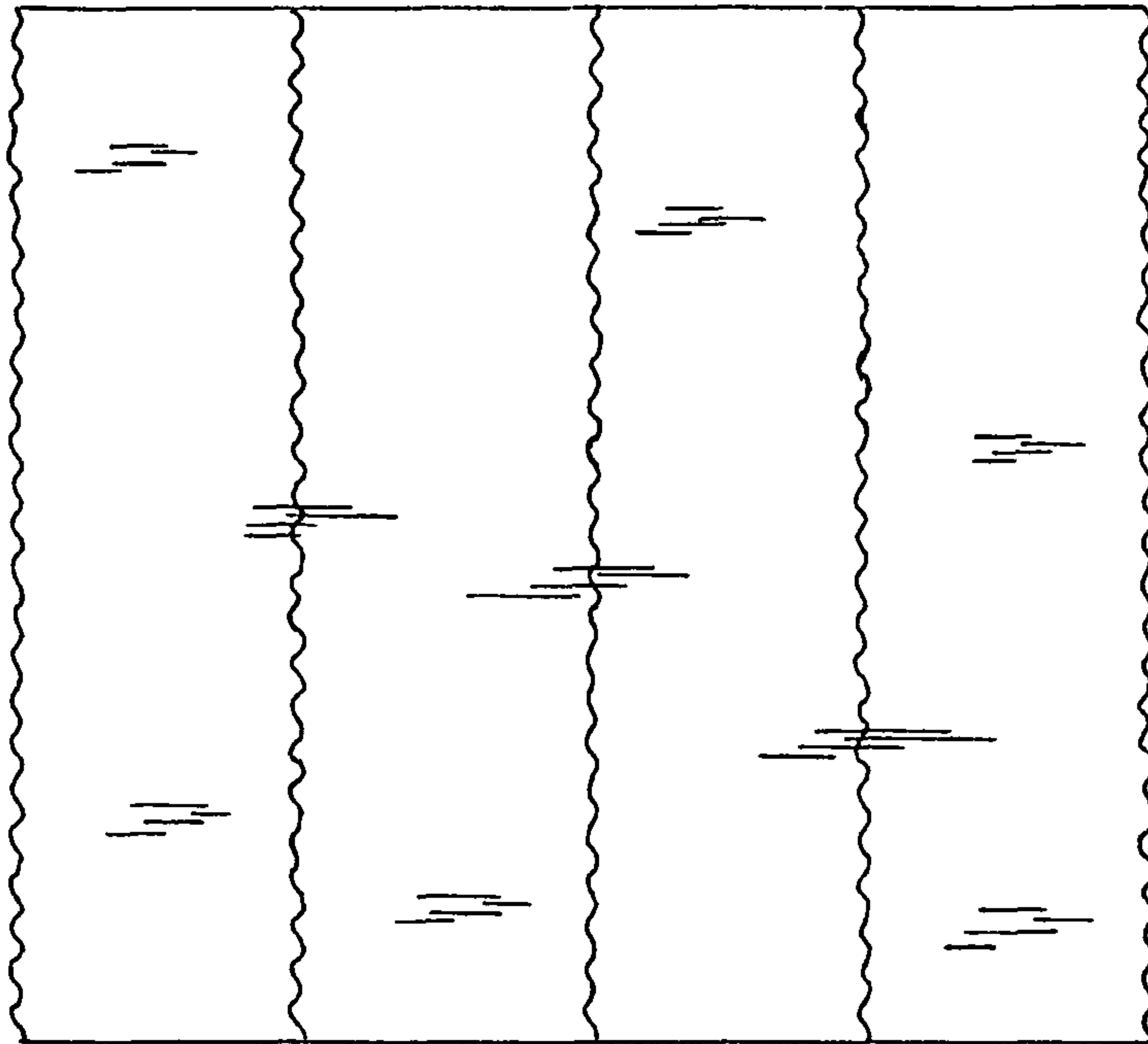

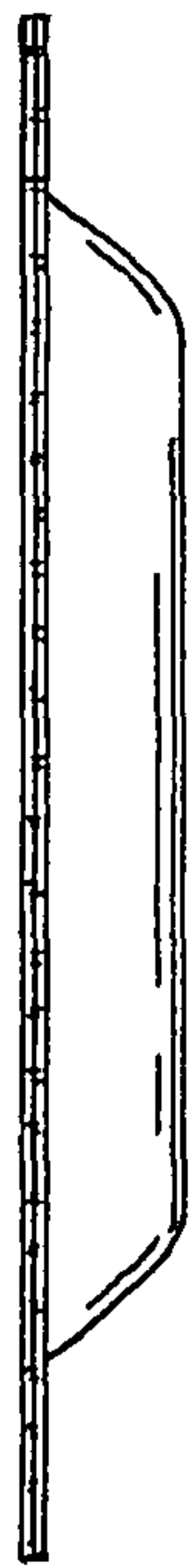
