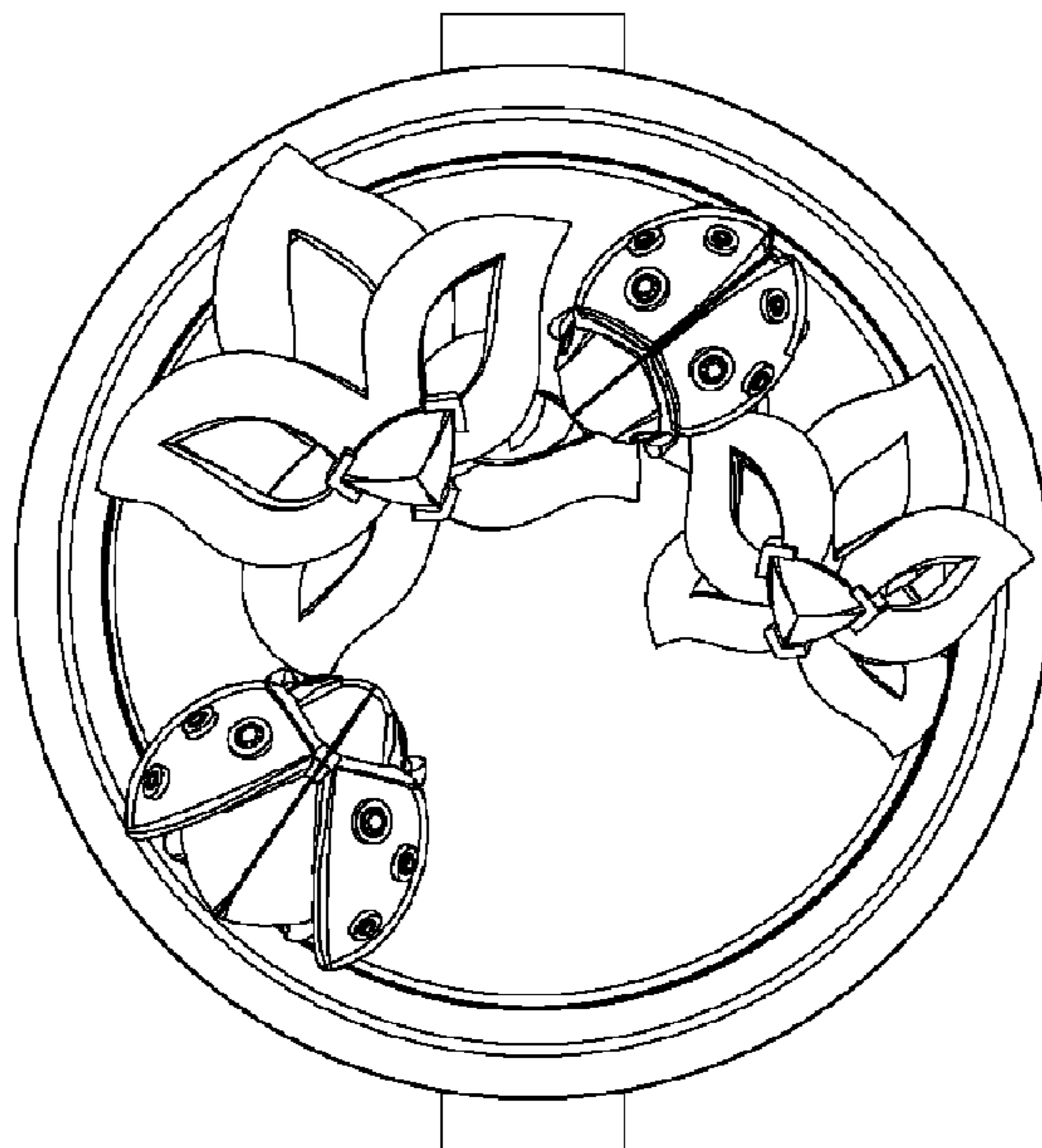
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top view of the watch case of the present invention. FIG. 2 is a bottom view of the watch case of FIG. 1. FIG. 3 is a front view of the watch case of FIG. 1. FIG. 4 is a back view of the watch case of FIG. 1. FIG. 5 is a right side view of the watch case of FIG. 1. FIG. 6 is a left side view of the watch case of FIG. 1; and, FIG. 7 is a top right side perspective view of the watch case of FIG. 1.

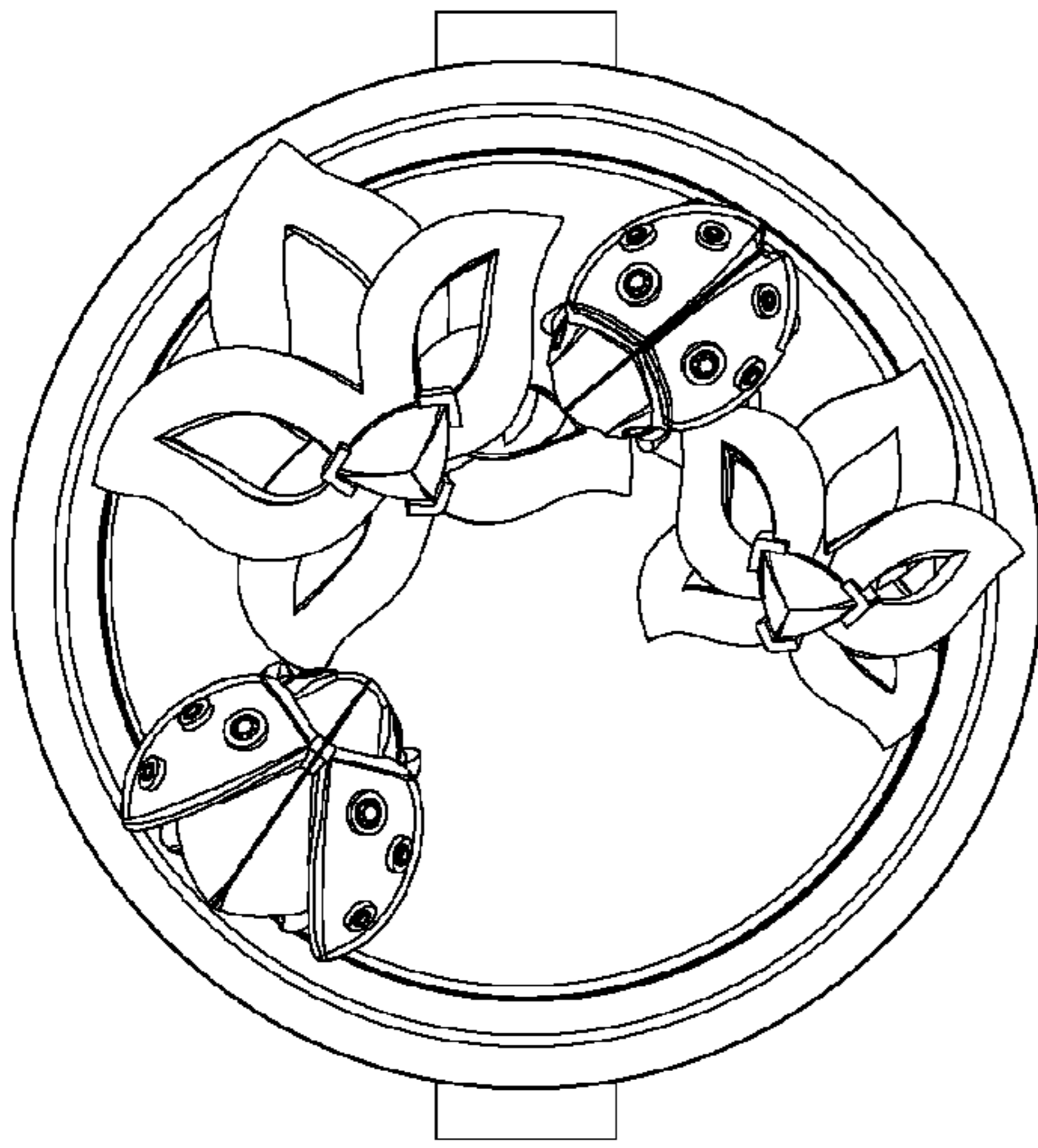

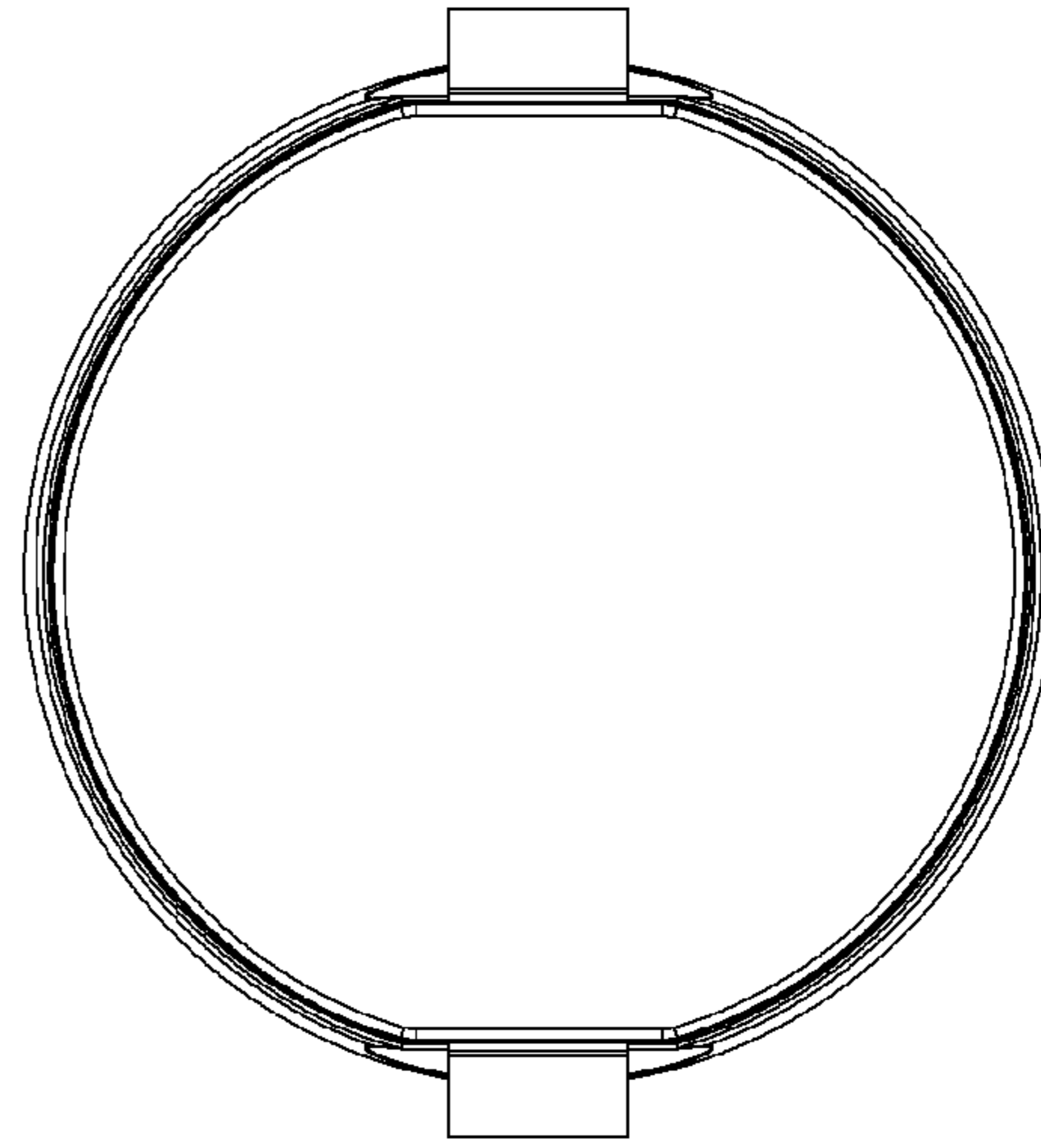

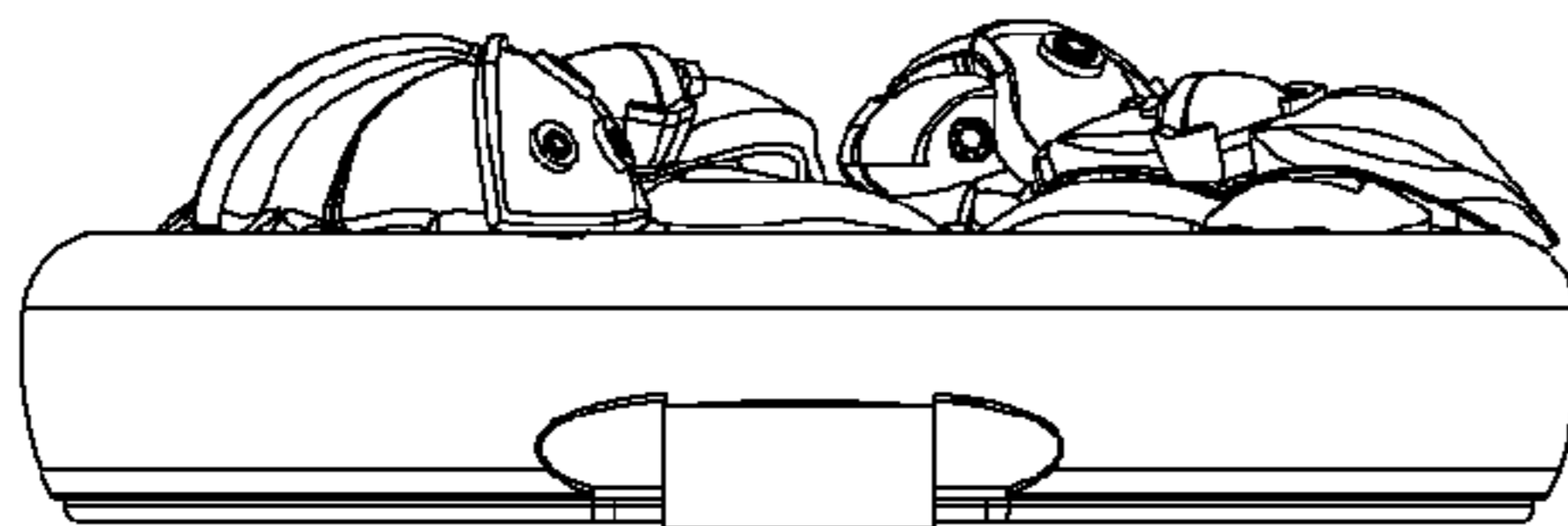

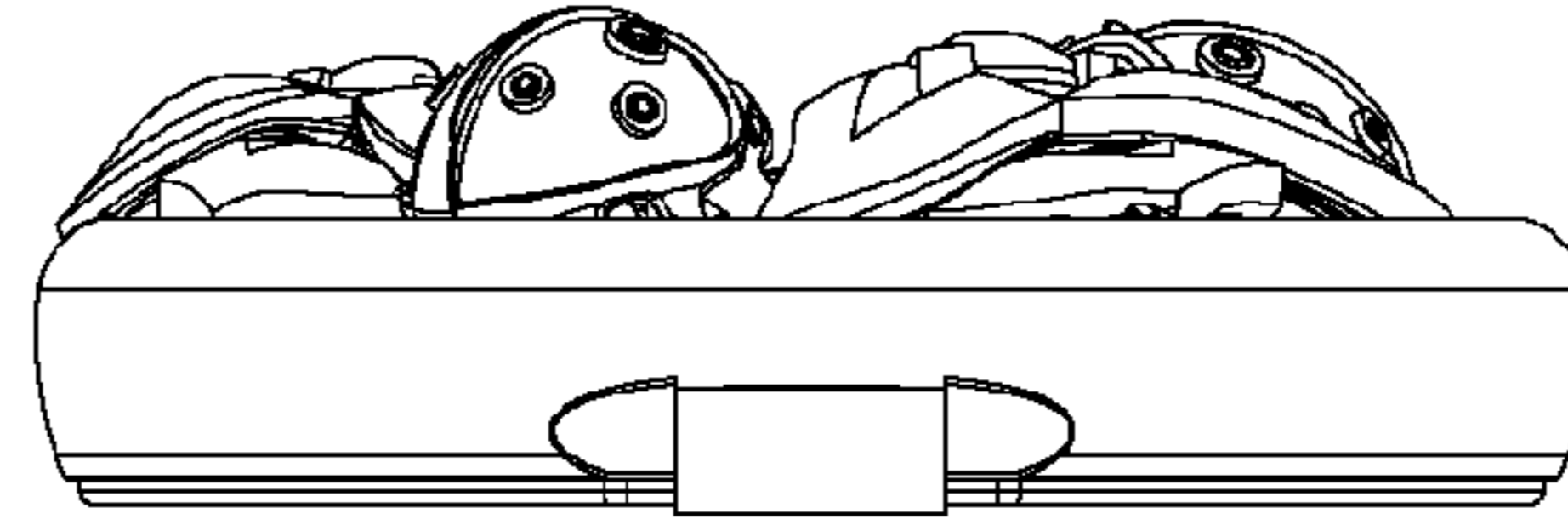

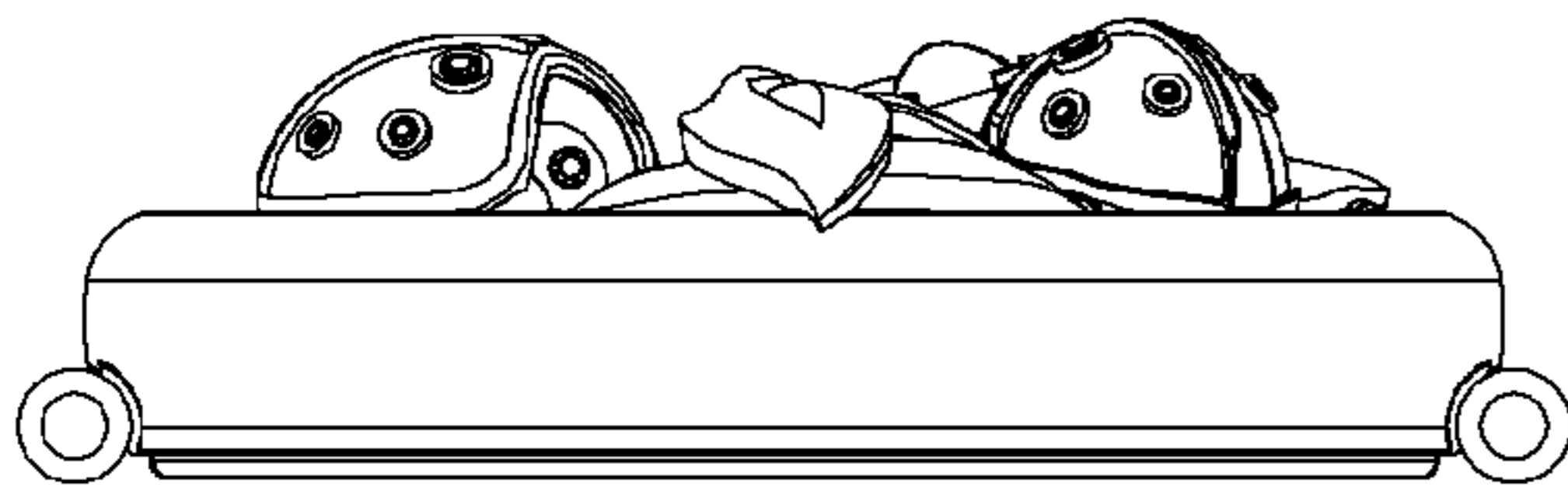

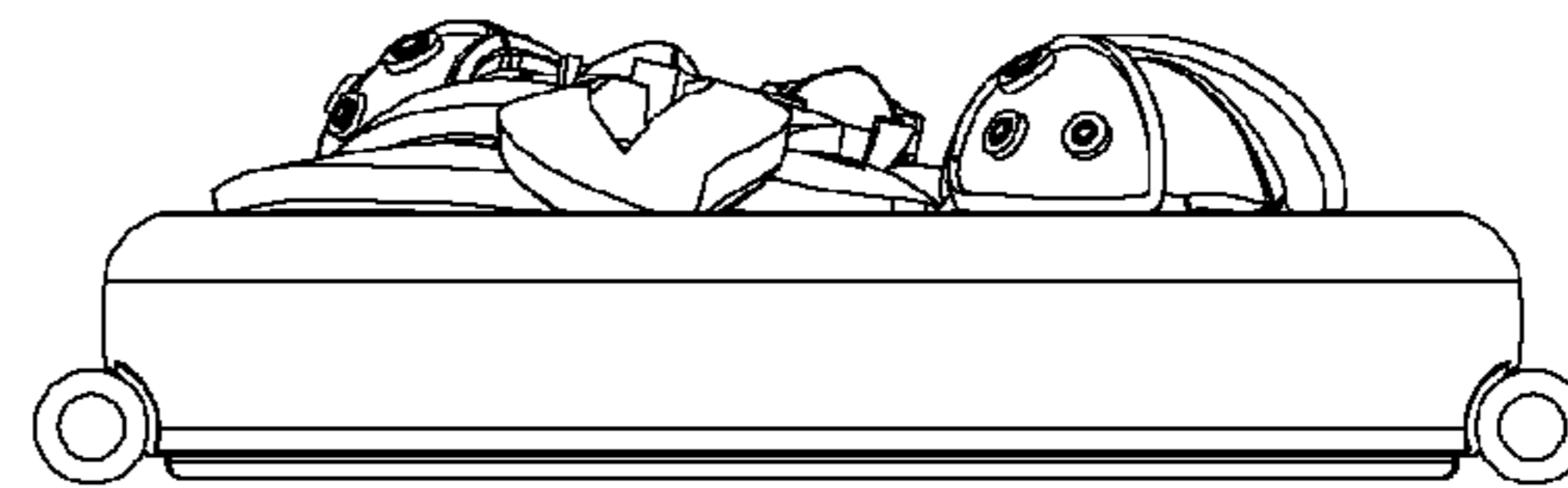

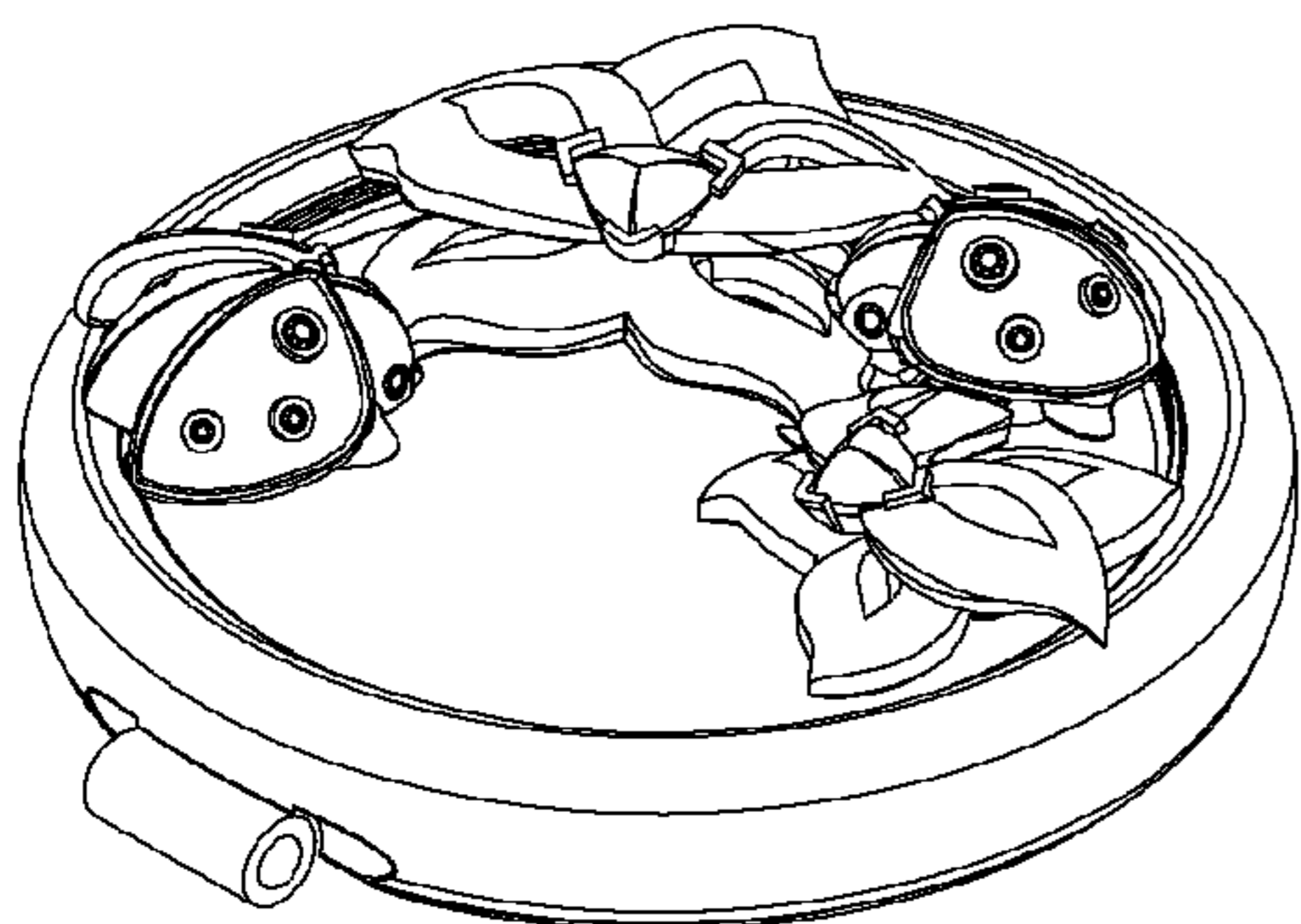
