DESCRIPTION

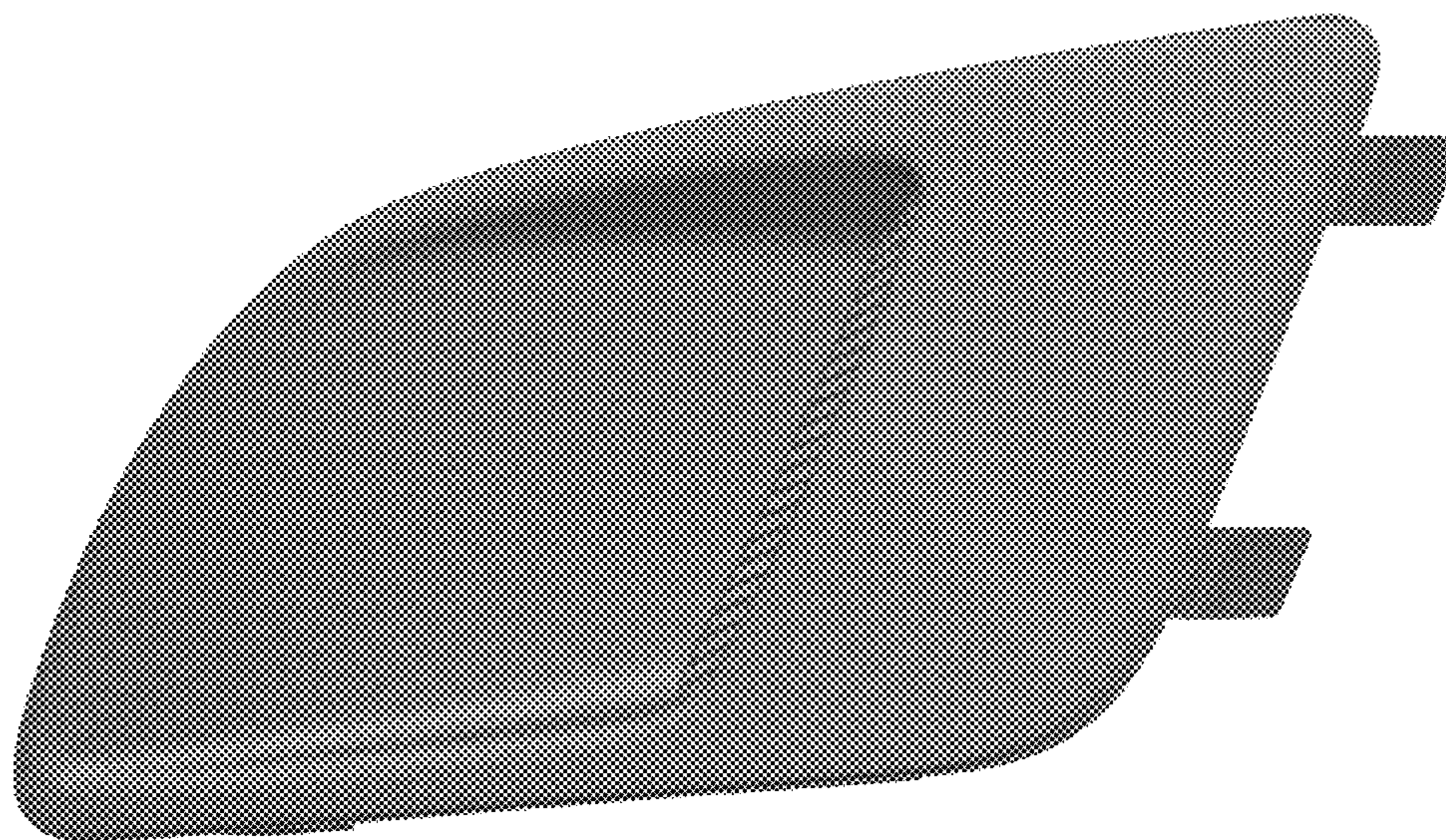
FIG. 1 is a left side elevational view of a left vehicle front side grille (the right vehicle front side grille being a mirror image and is not shown);
FIG. 2 is a right side elevational view of the vehicle front side grille;
FIG. 3 is a front elevational view of the vehicle front side grille;

FIG. 5 is a bottom plan view of the vehicle front side grille;

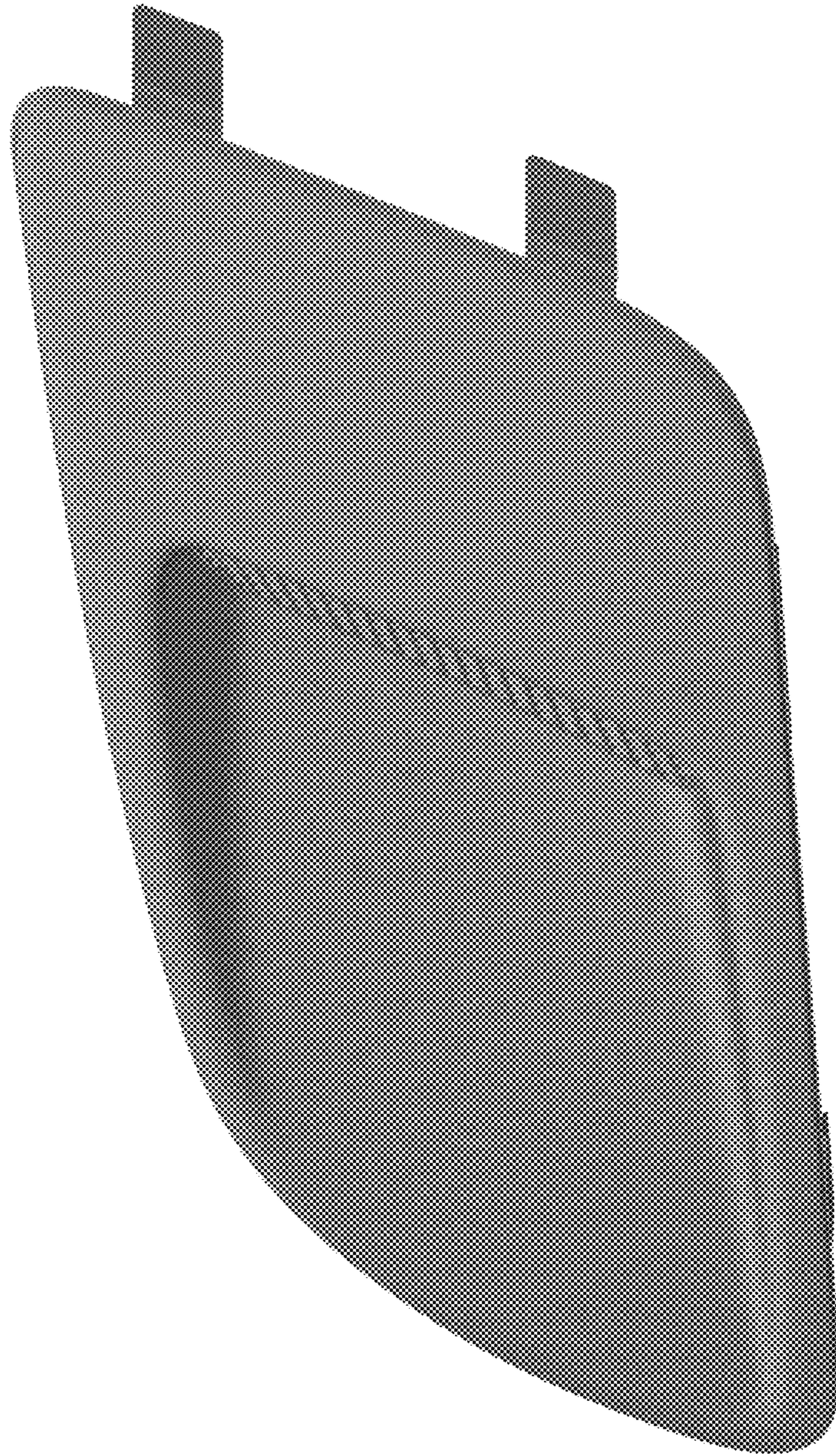

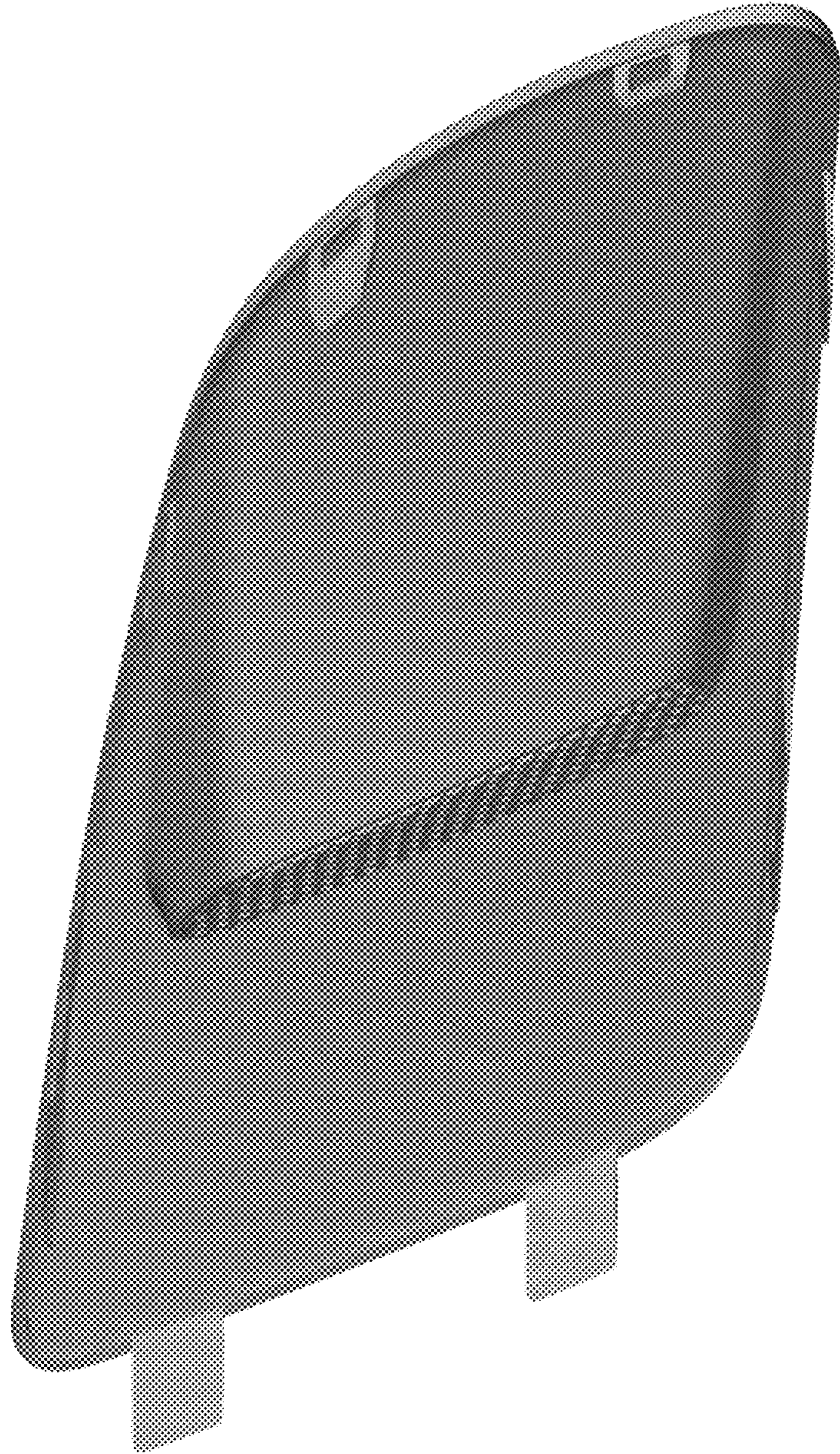

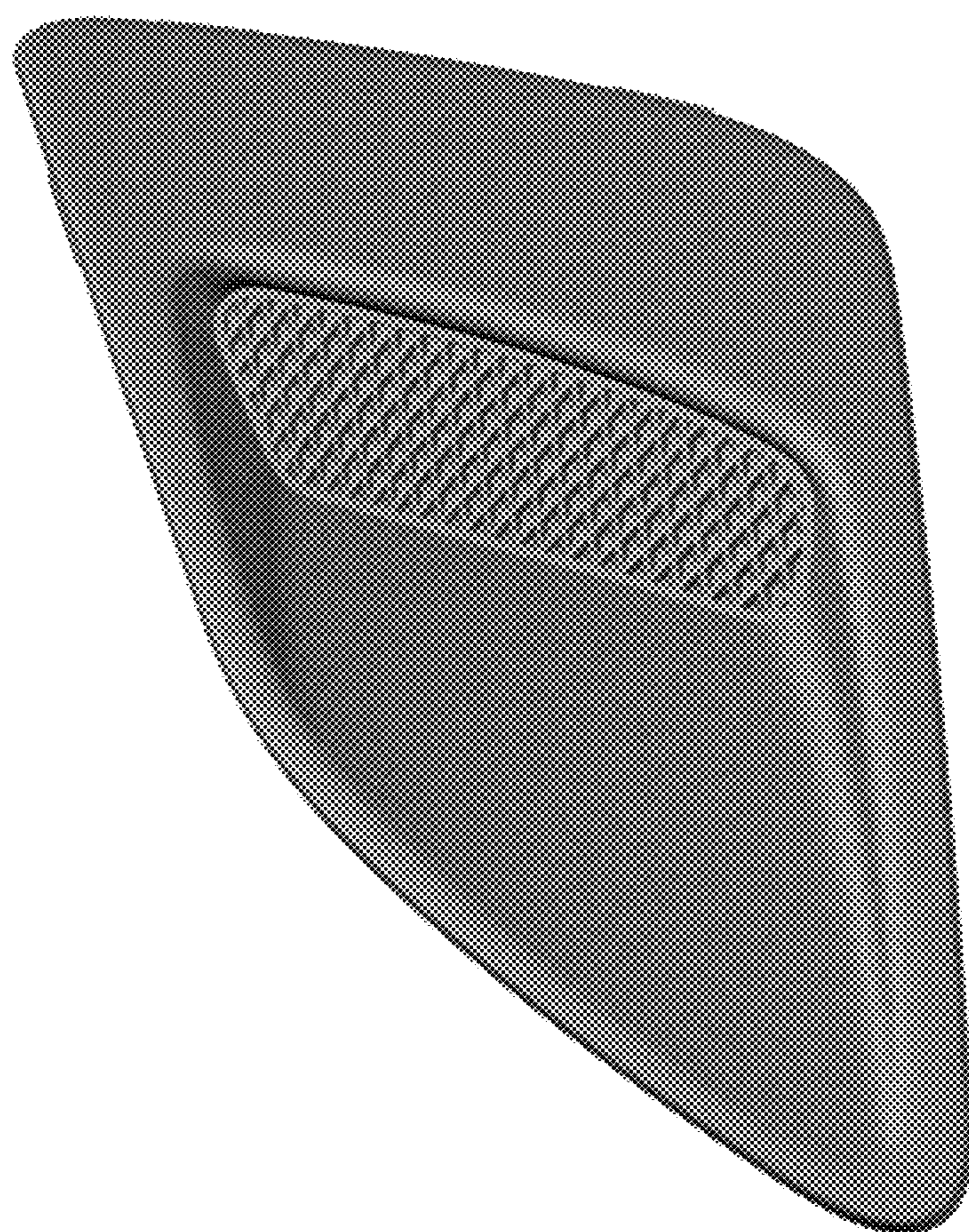

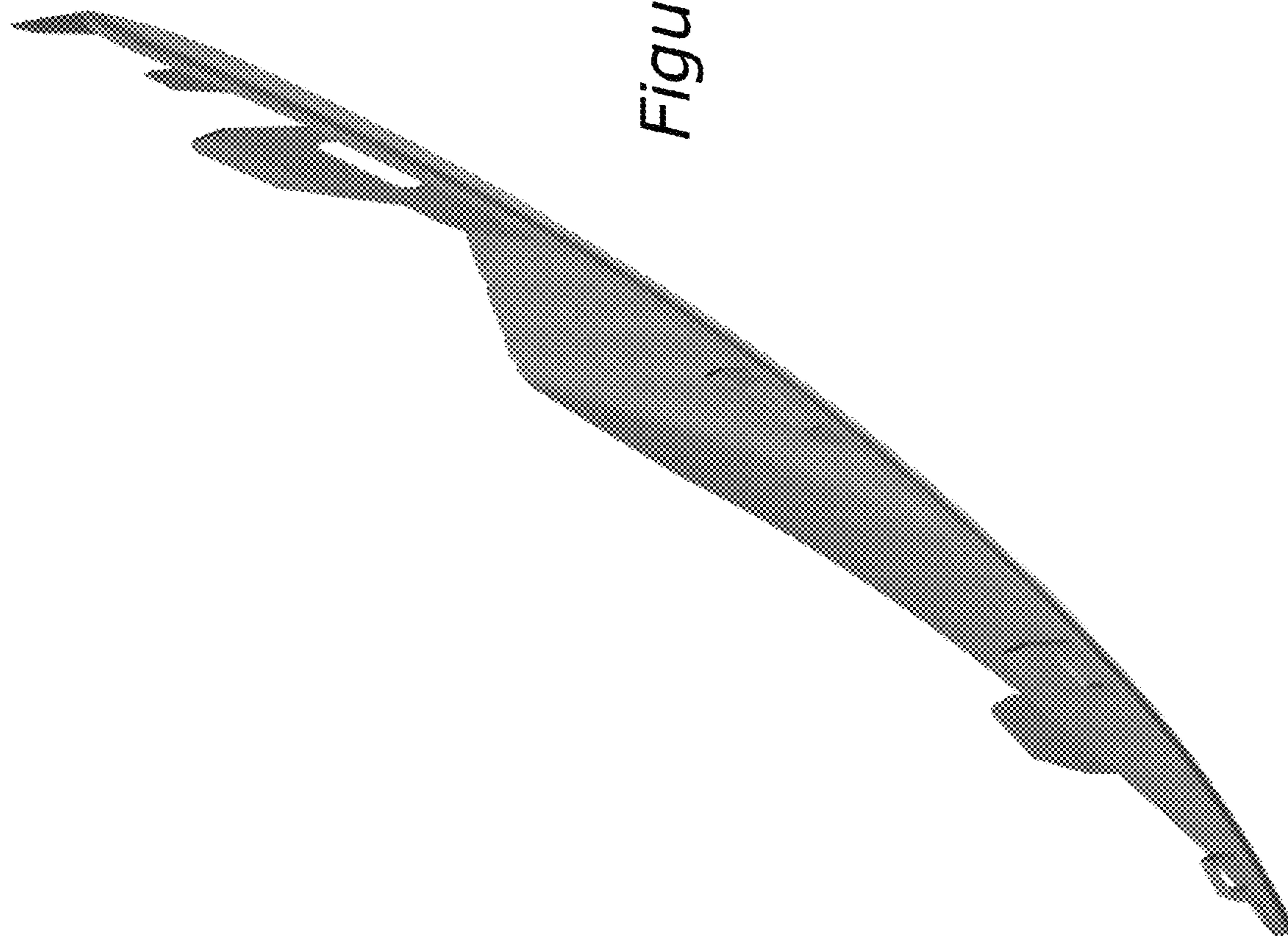
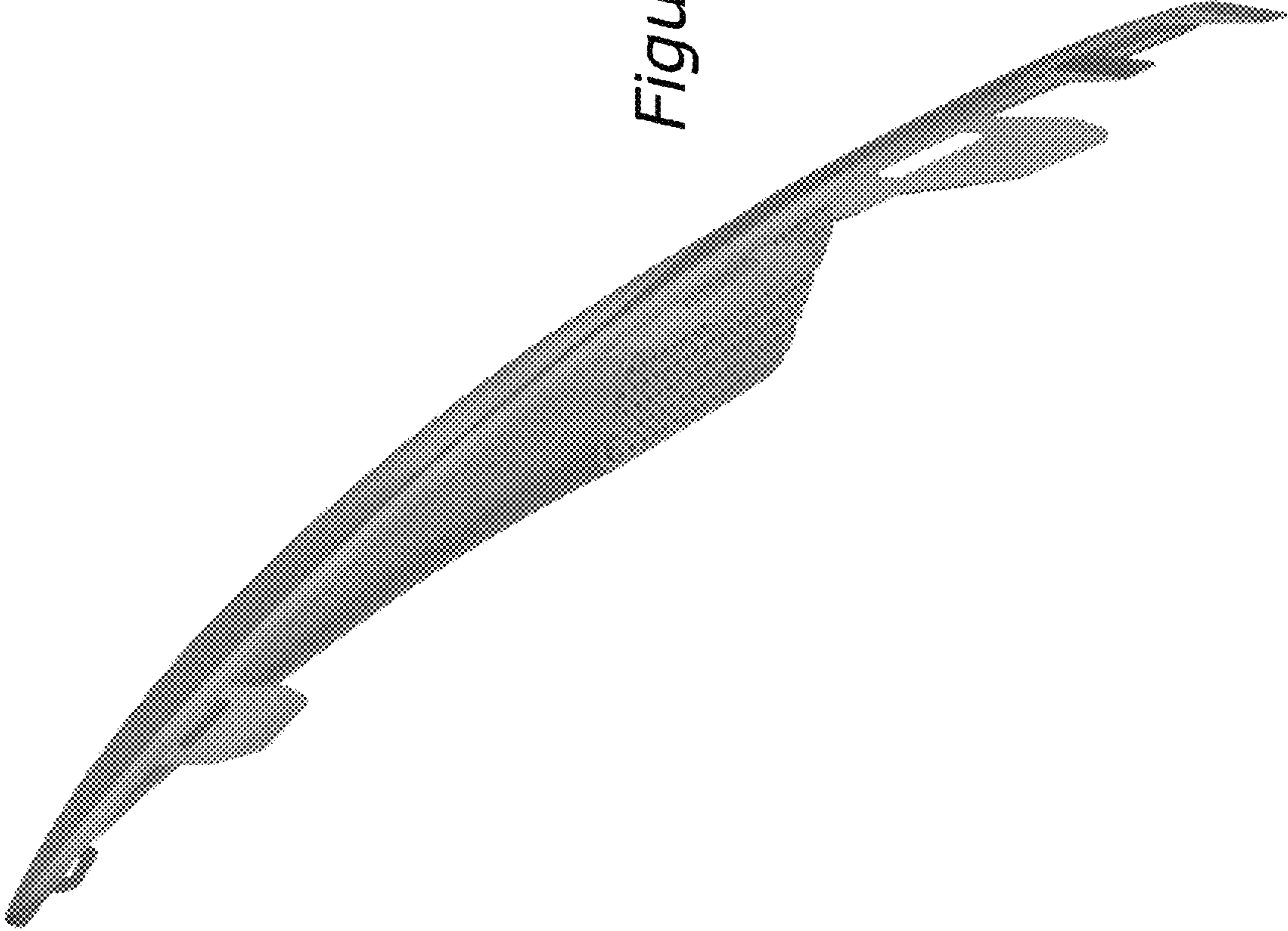

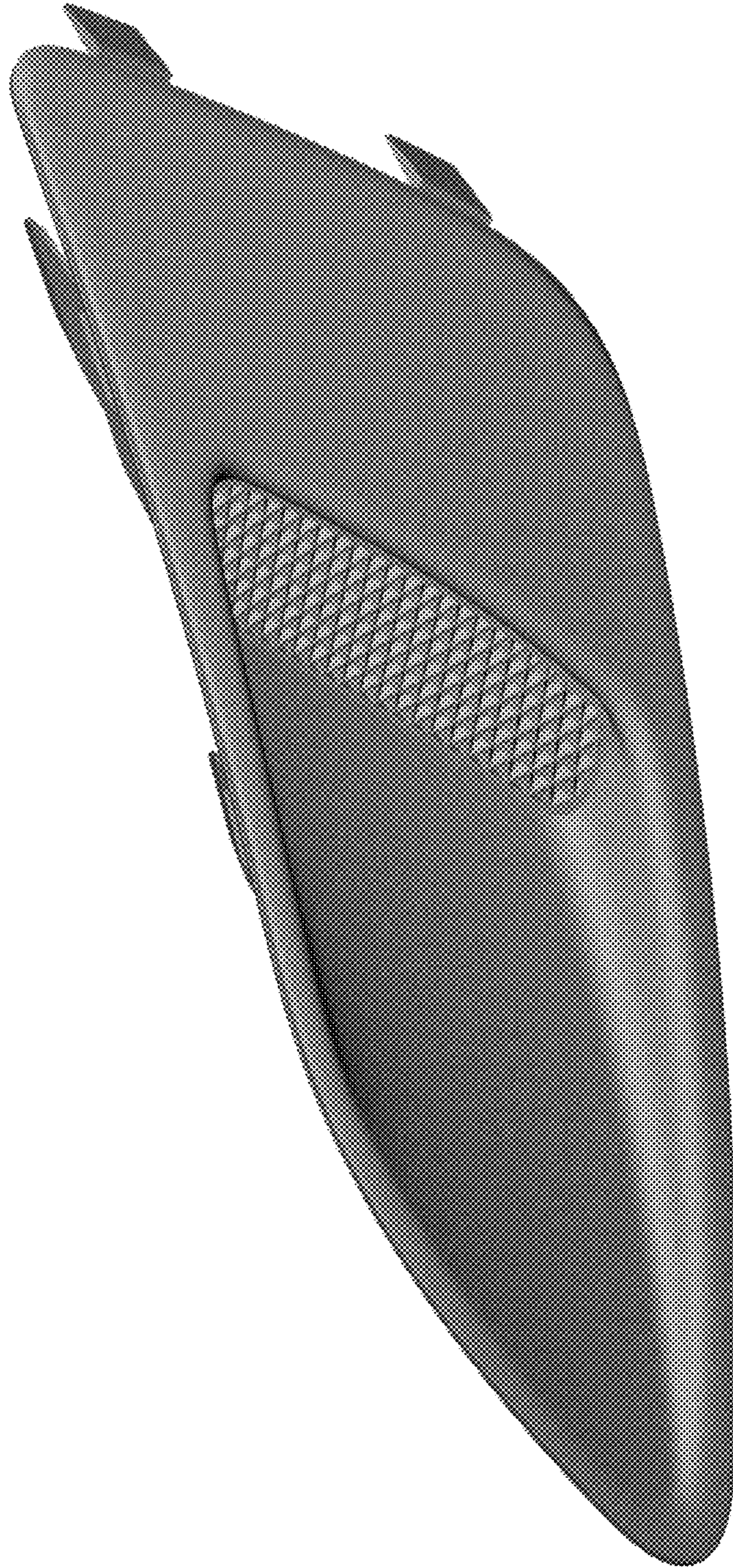

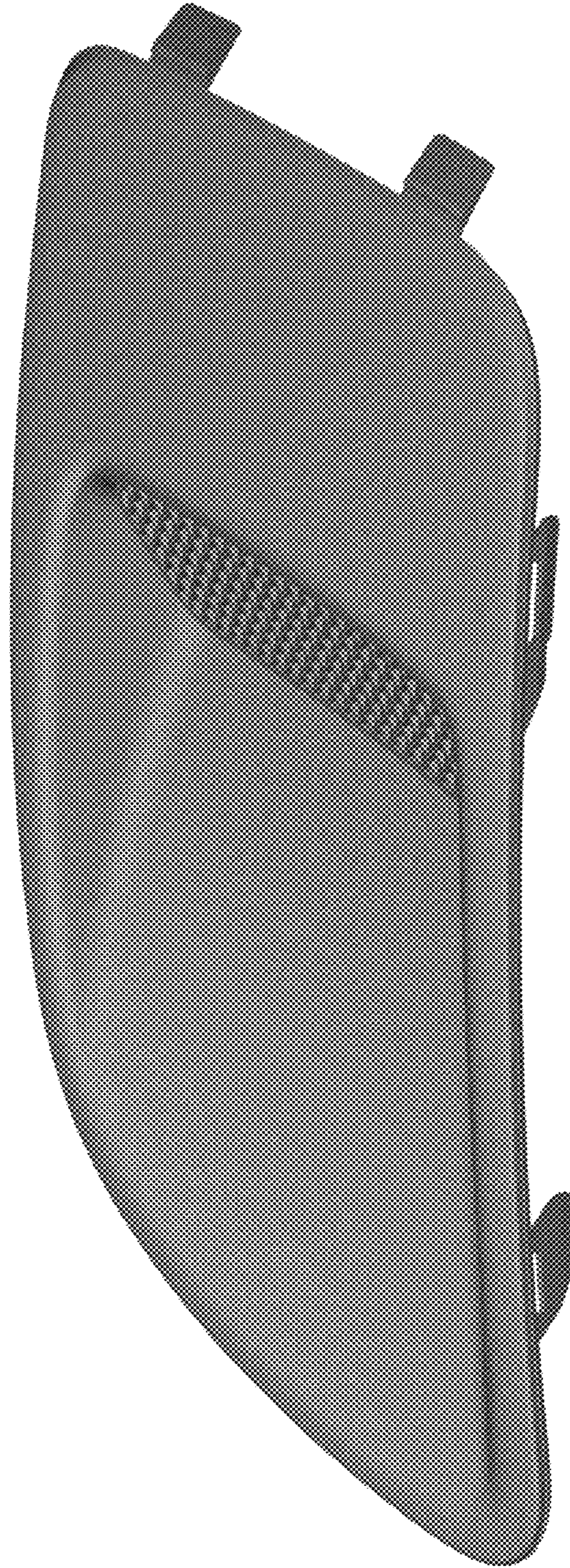
