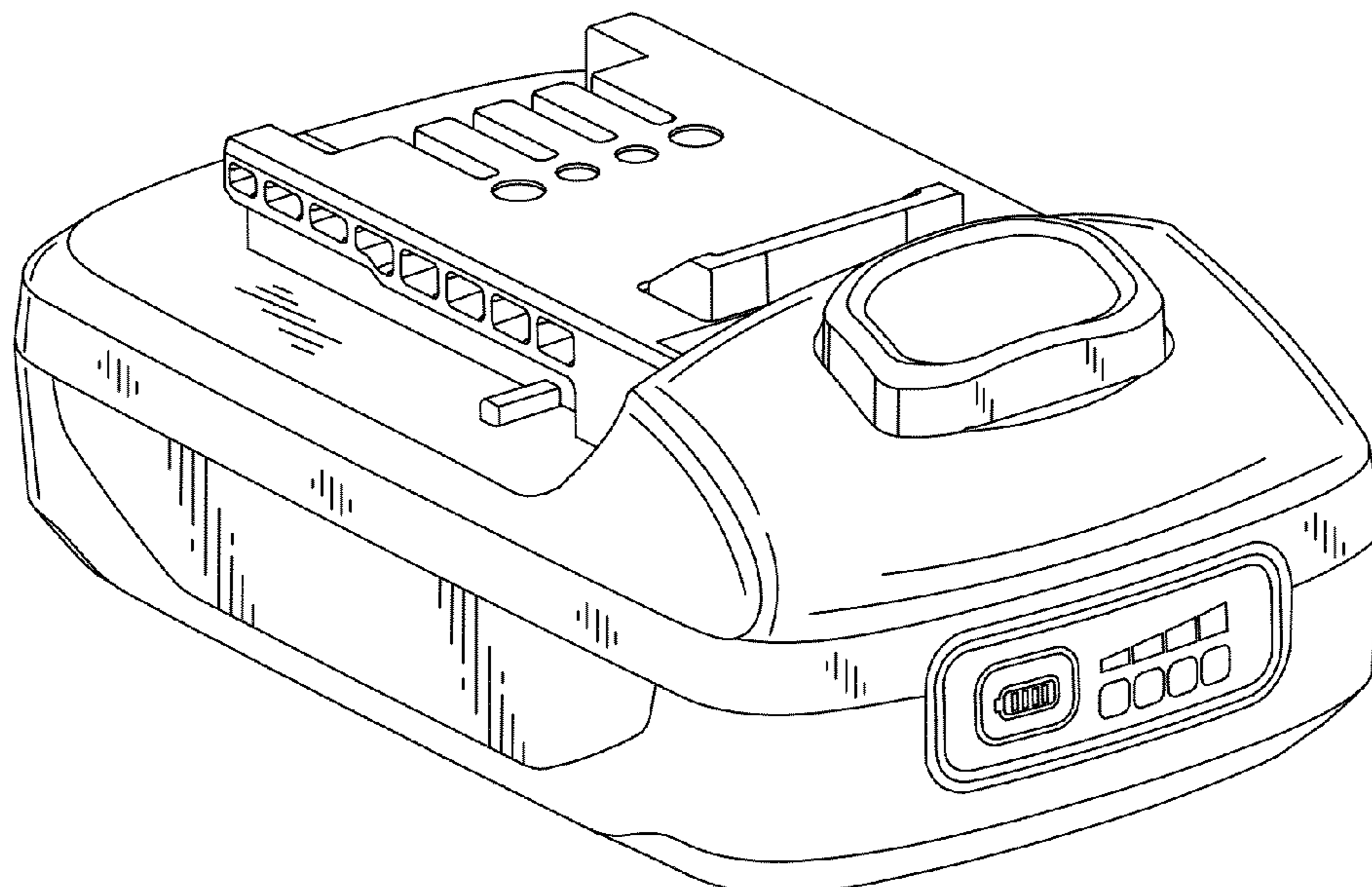

(57) **CLAIM**
What is claimed is the ornamental design for a battery pack,
as shown and described.

DESCRIPTION

FIG. 1 is a front, left side perspective view of a battery pack.
FIG. 2 is a left side elevational view thereof.
FIG. 3 is a right side elevational view thereof.
FIG. 4 is a rear side elevational view thereof.
FIG. 5 is a front side elevational view thereof.
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.

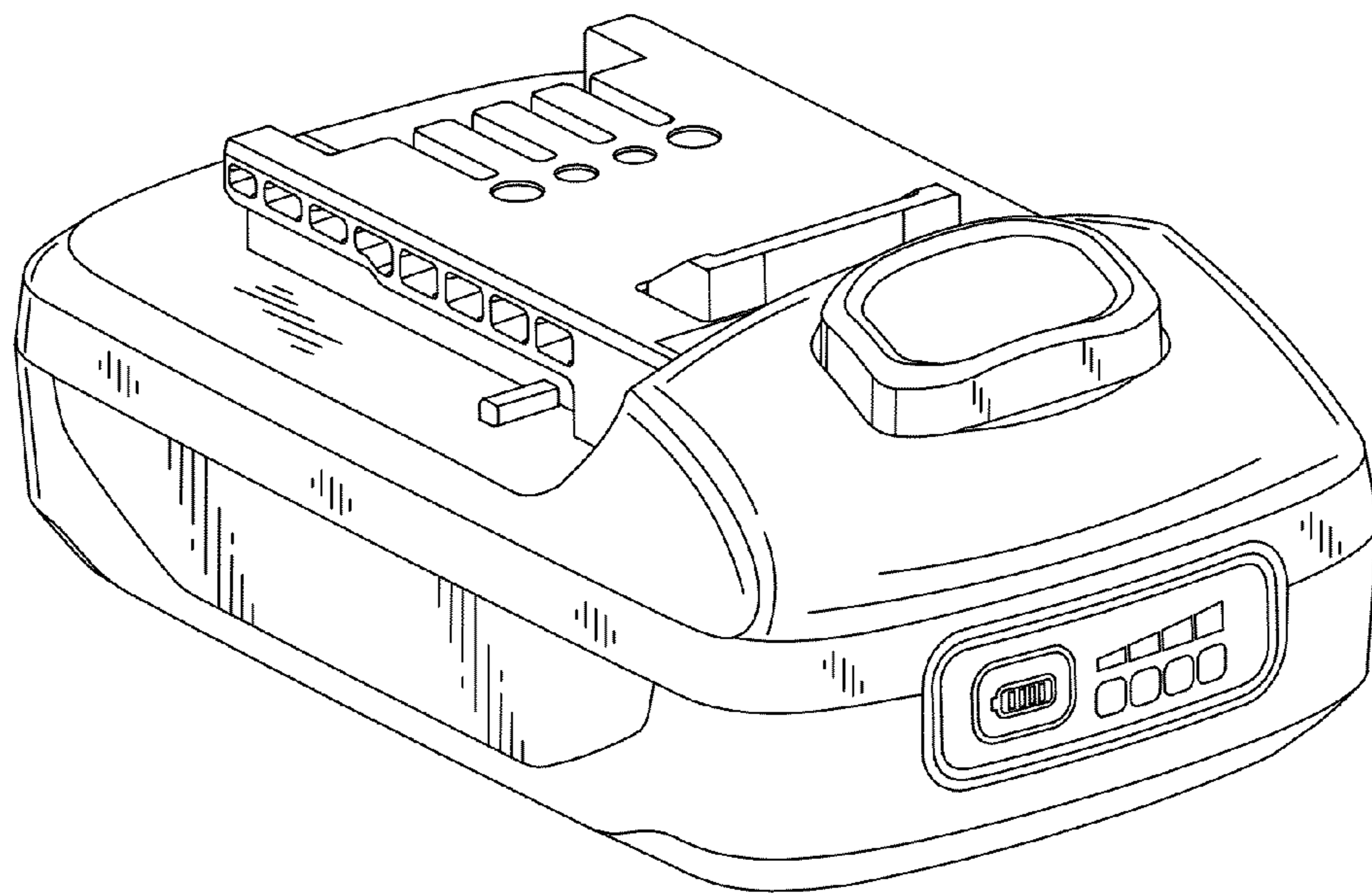

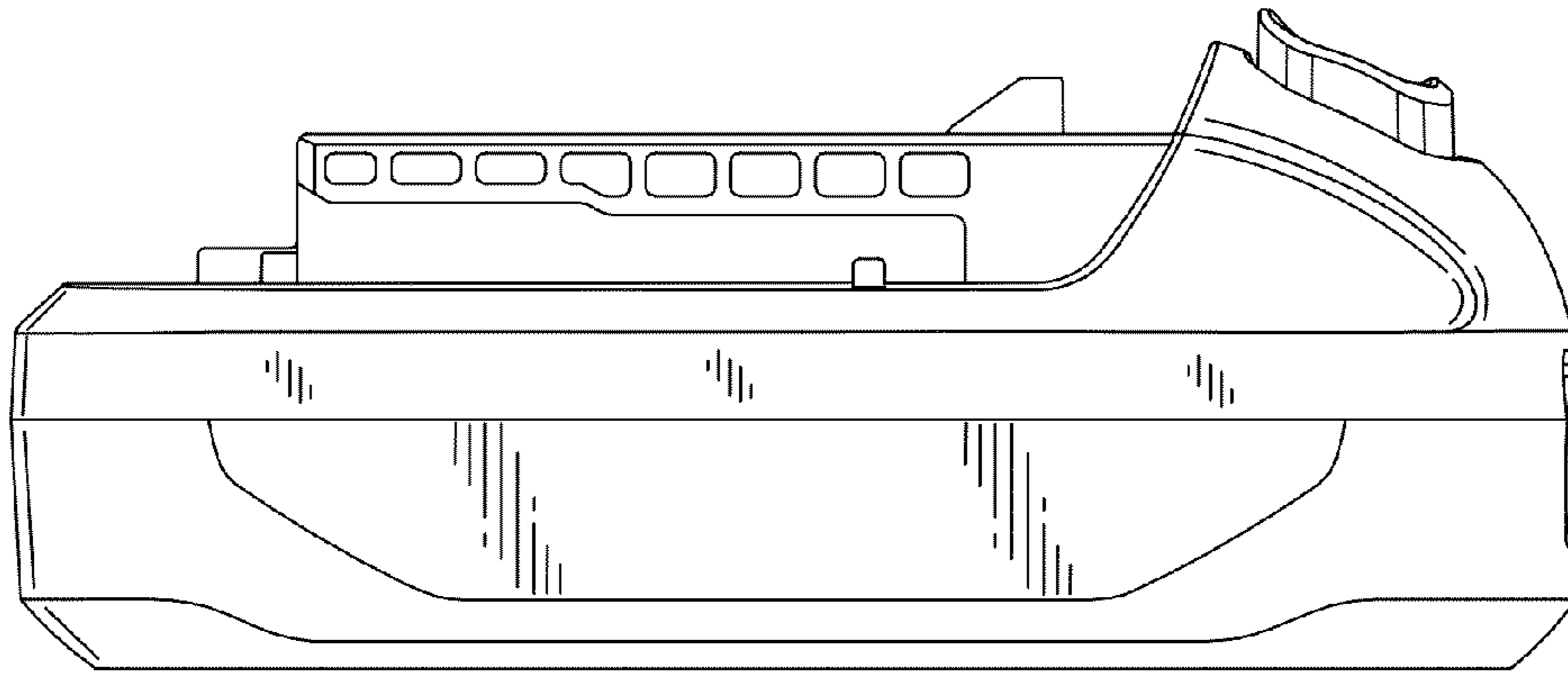

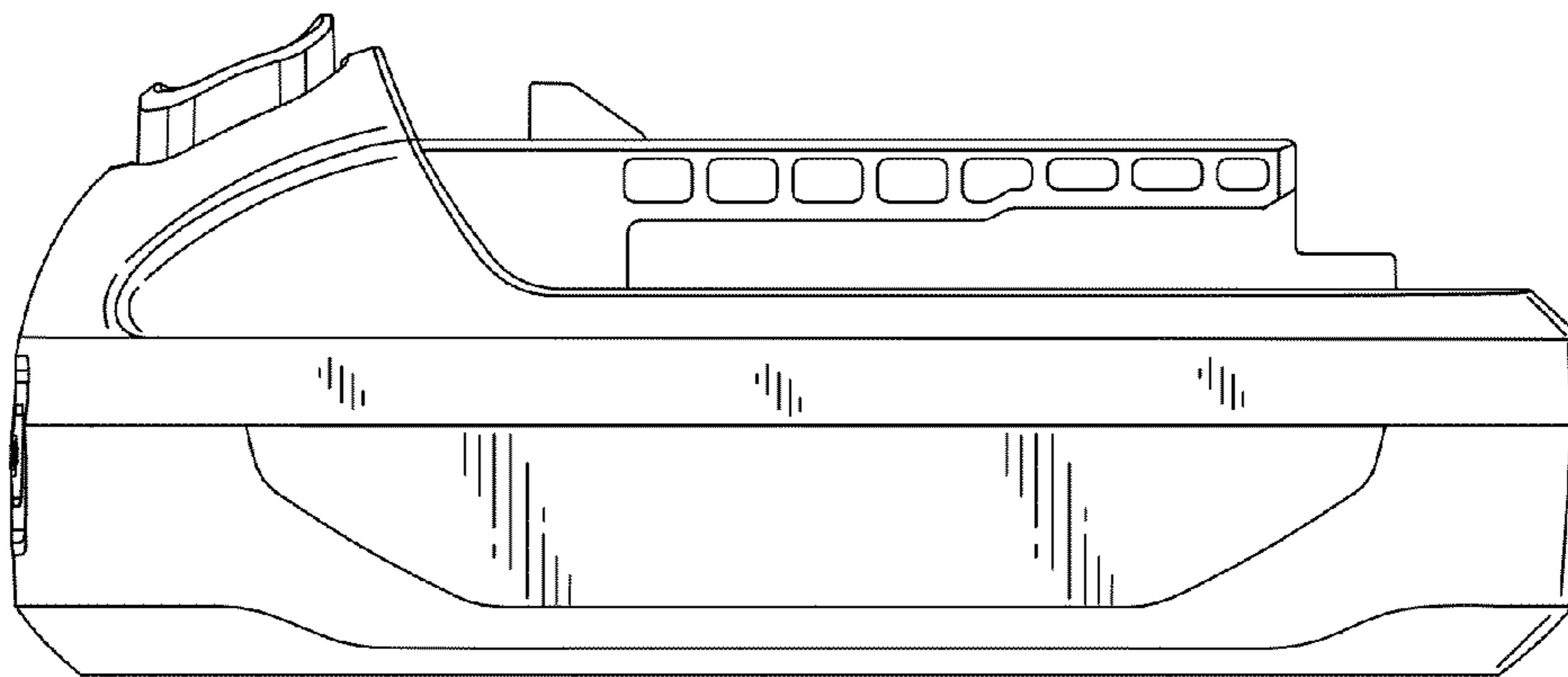

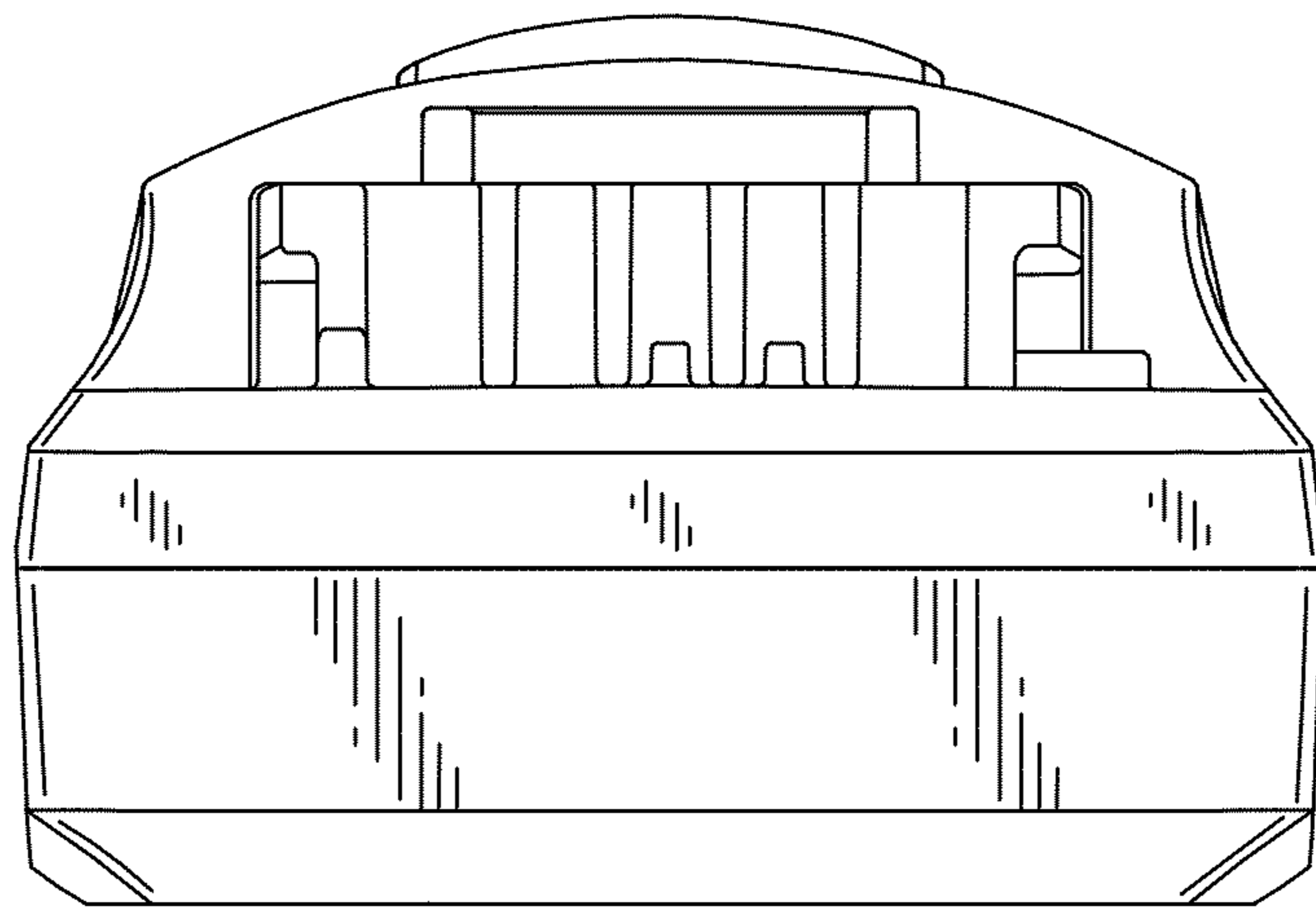

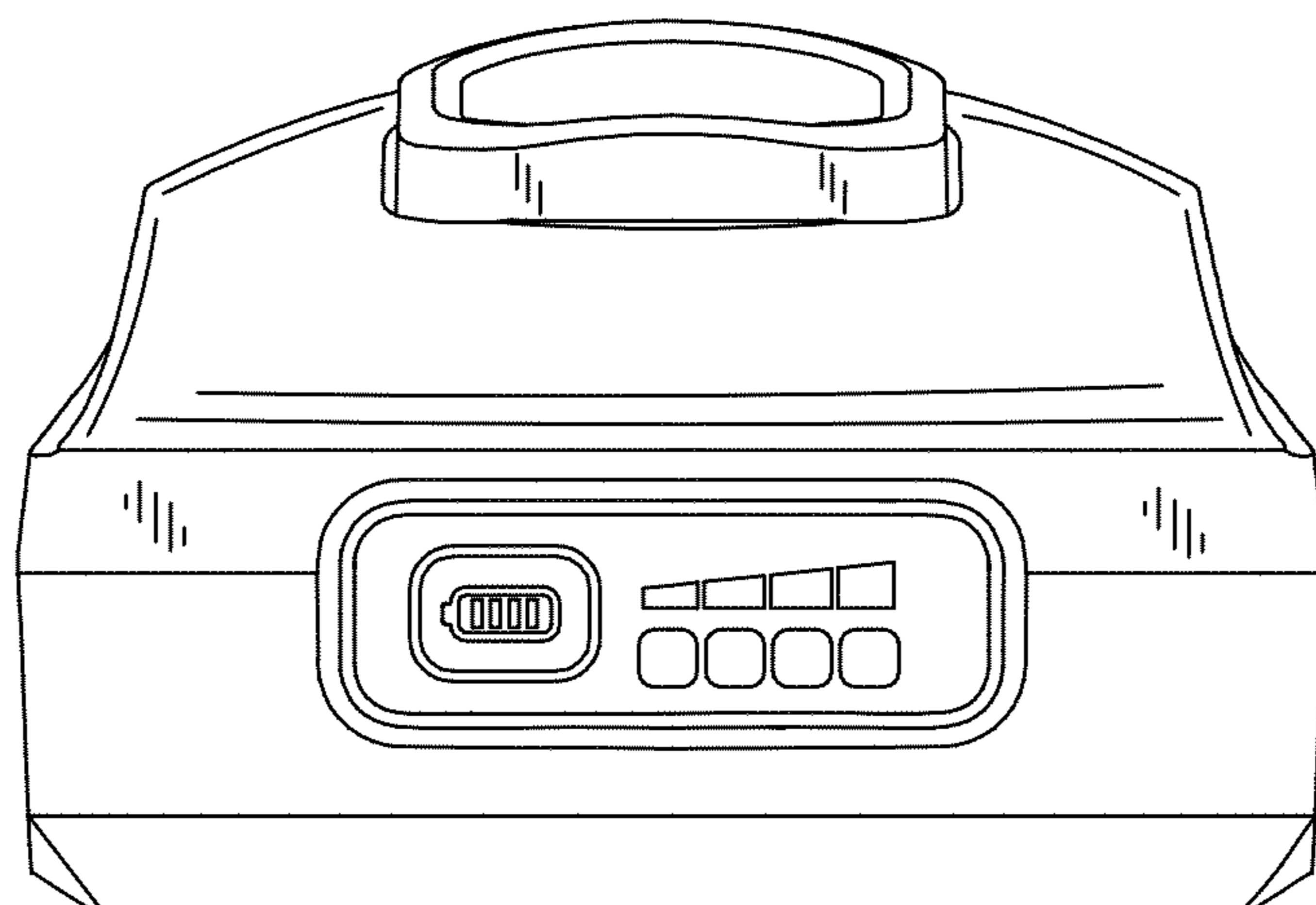

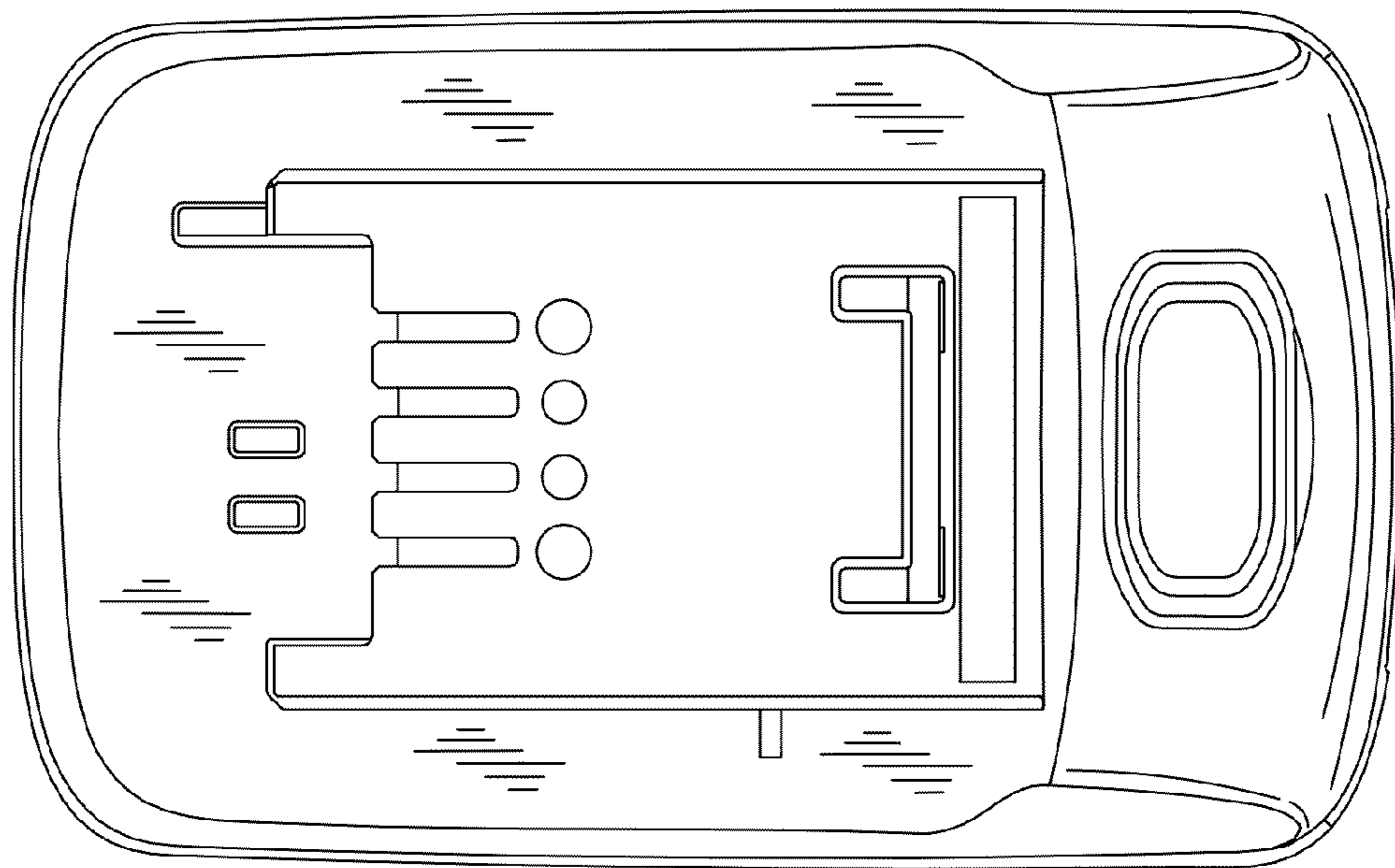

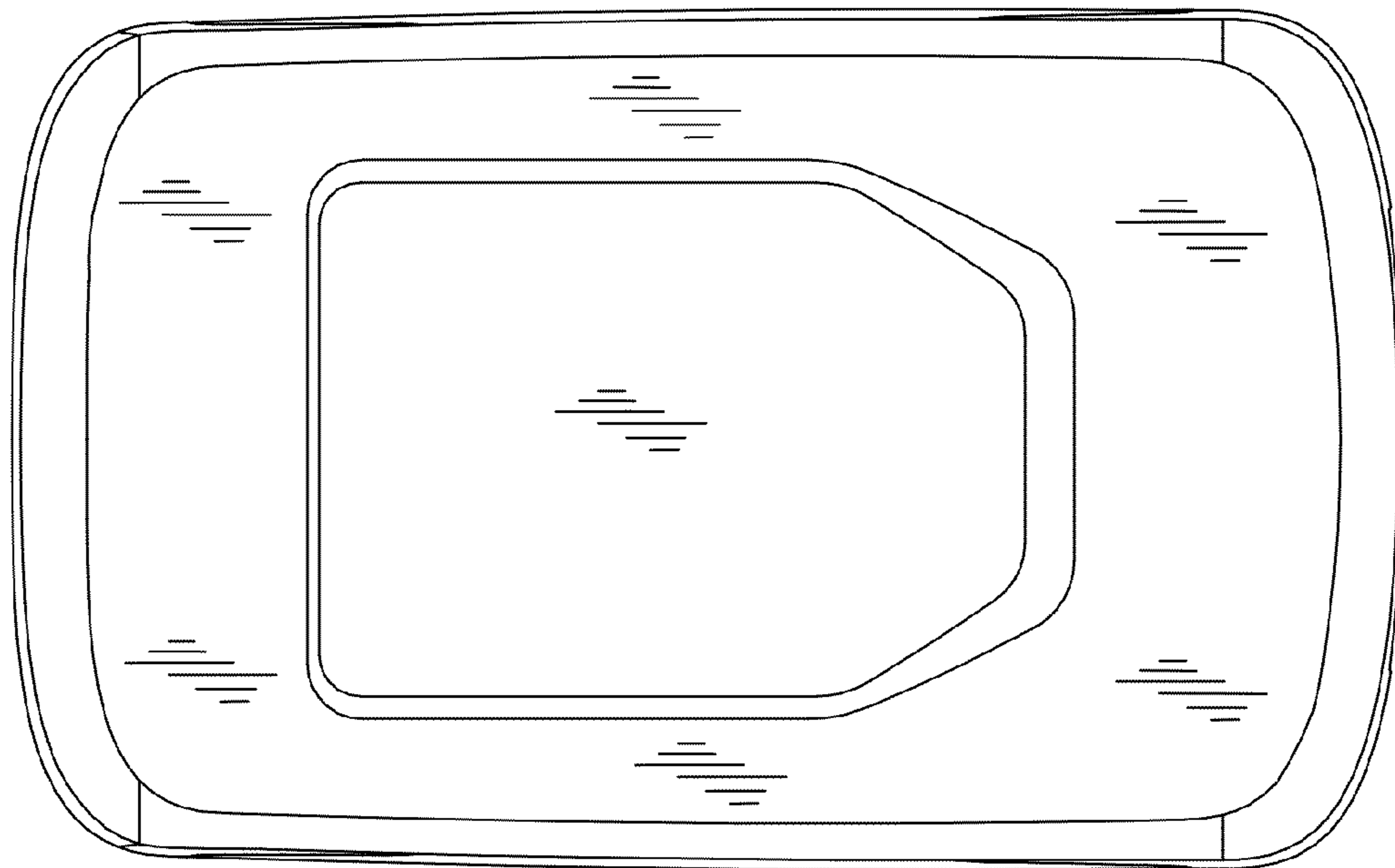
