(57) **CLAIM**

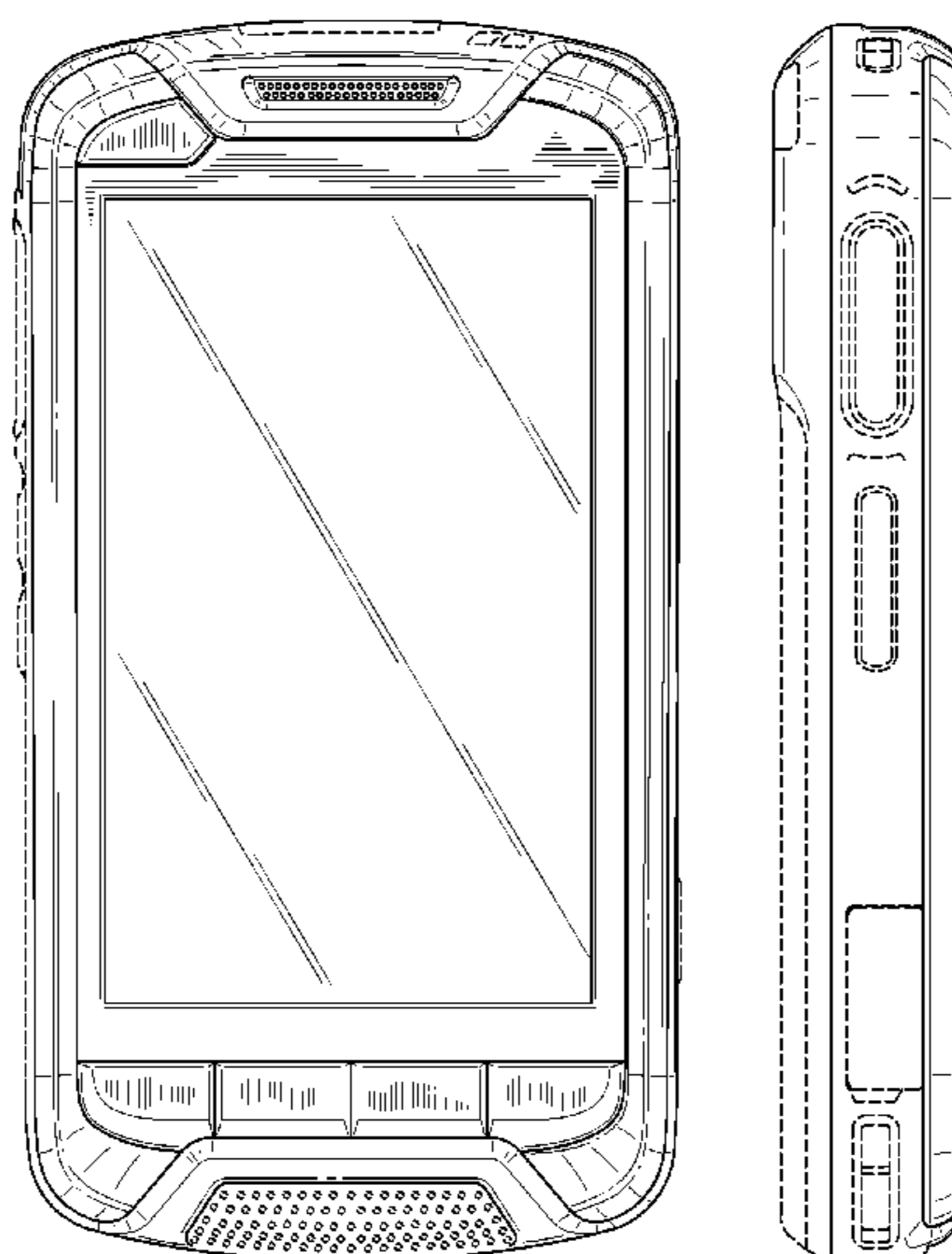
The ornamental design for a portable communication device, as shown and described.

**DESCRIPTION**

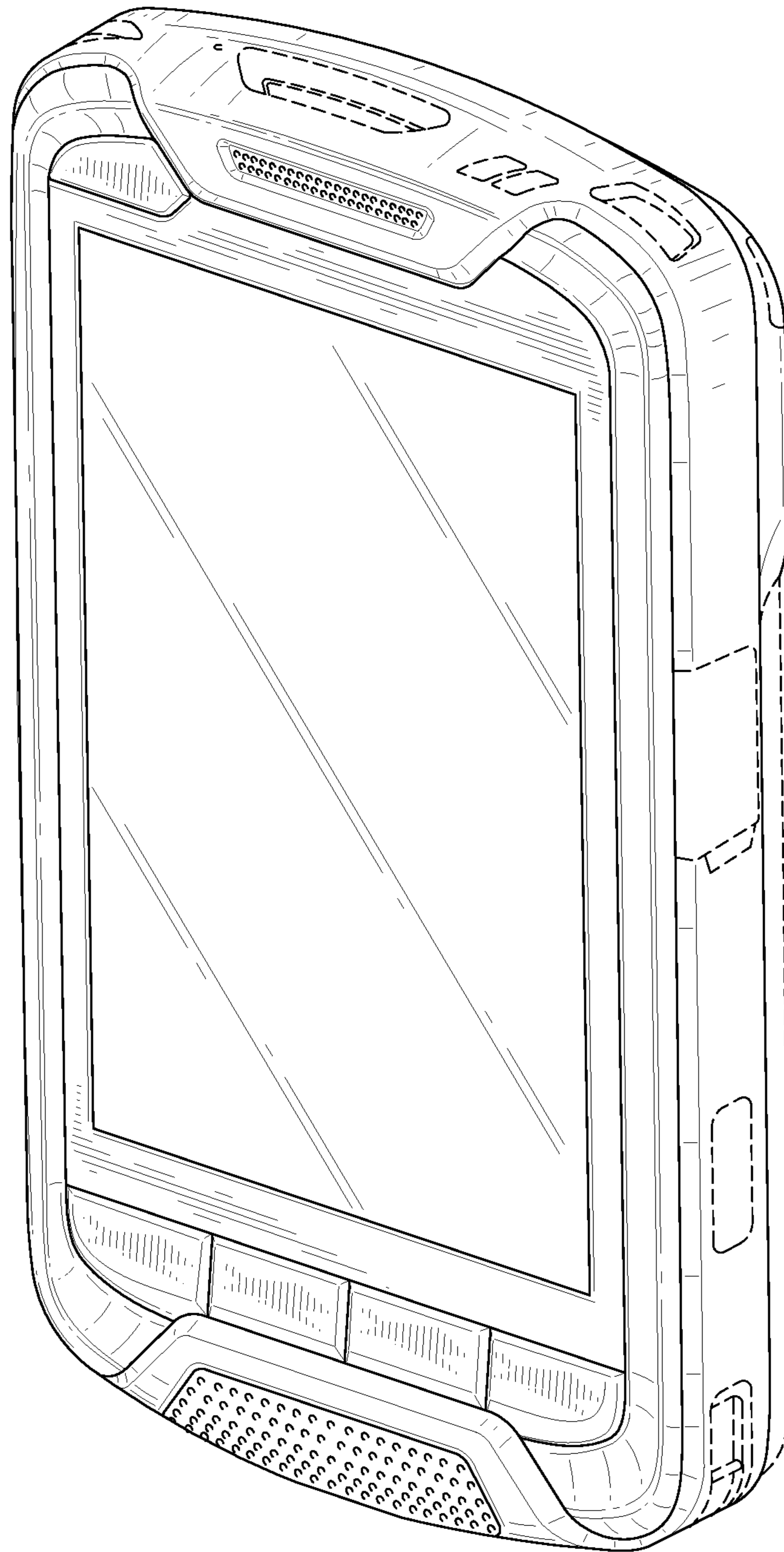

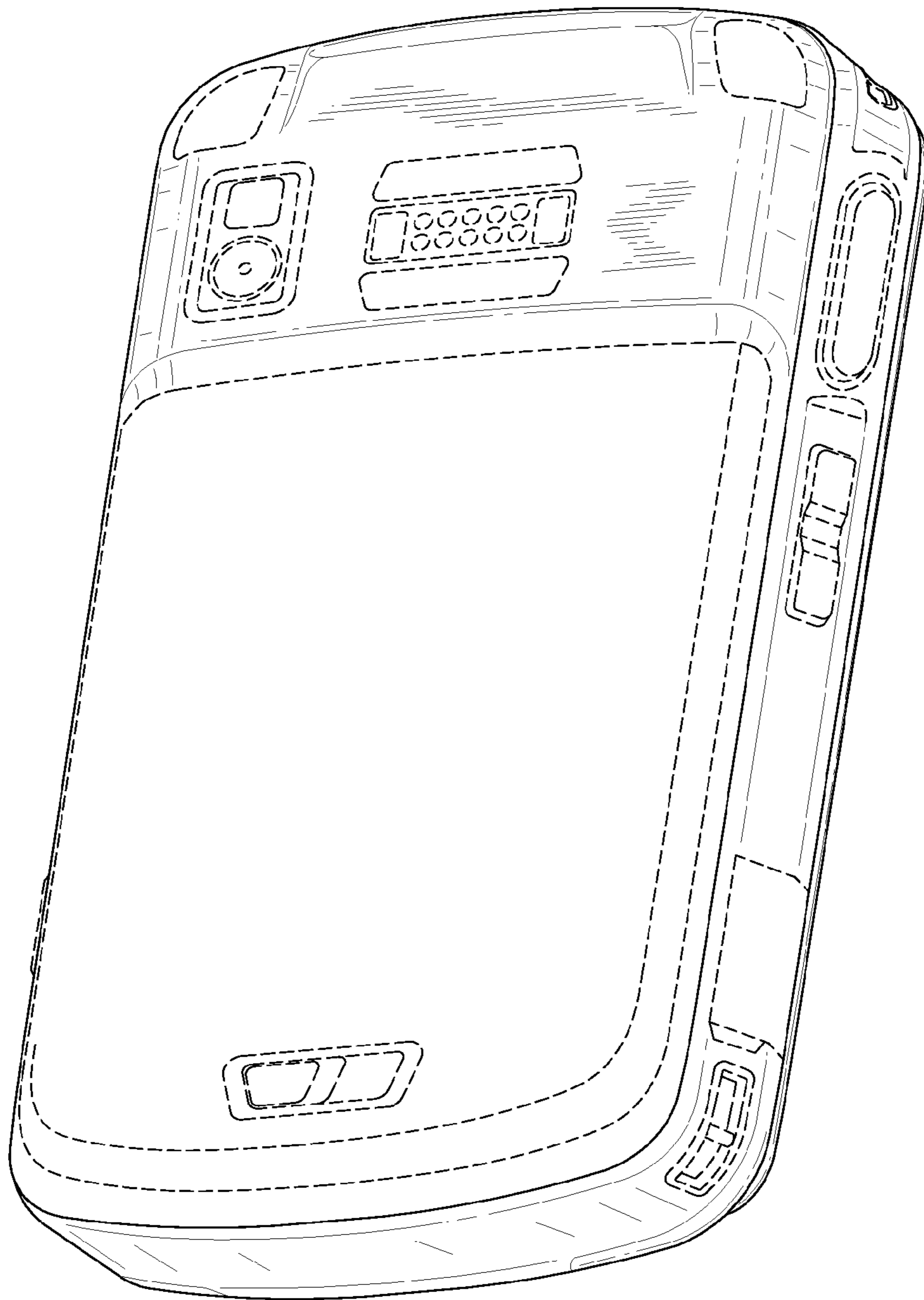

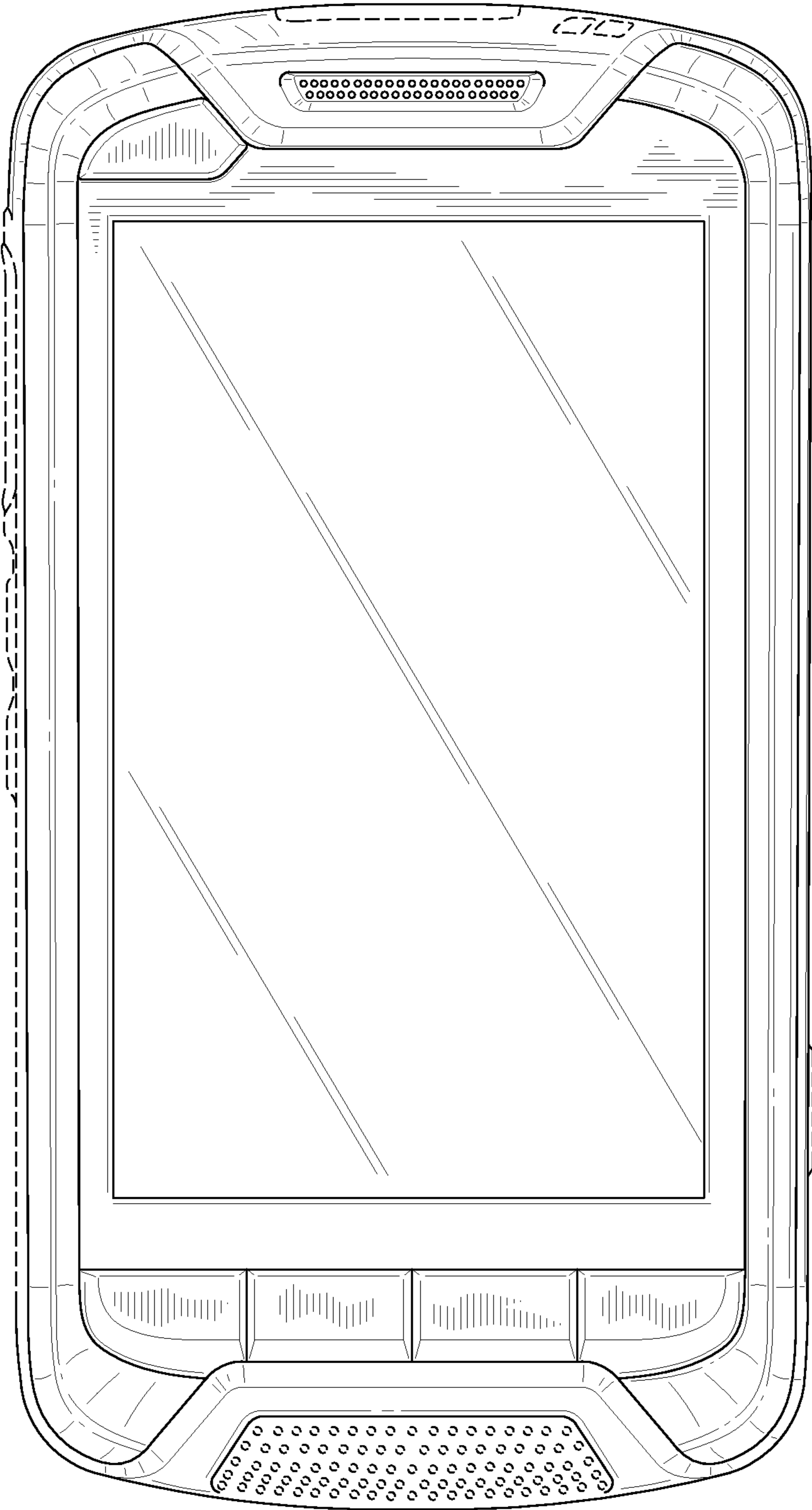

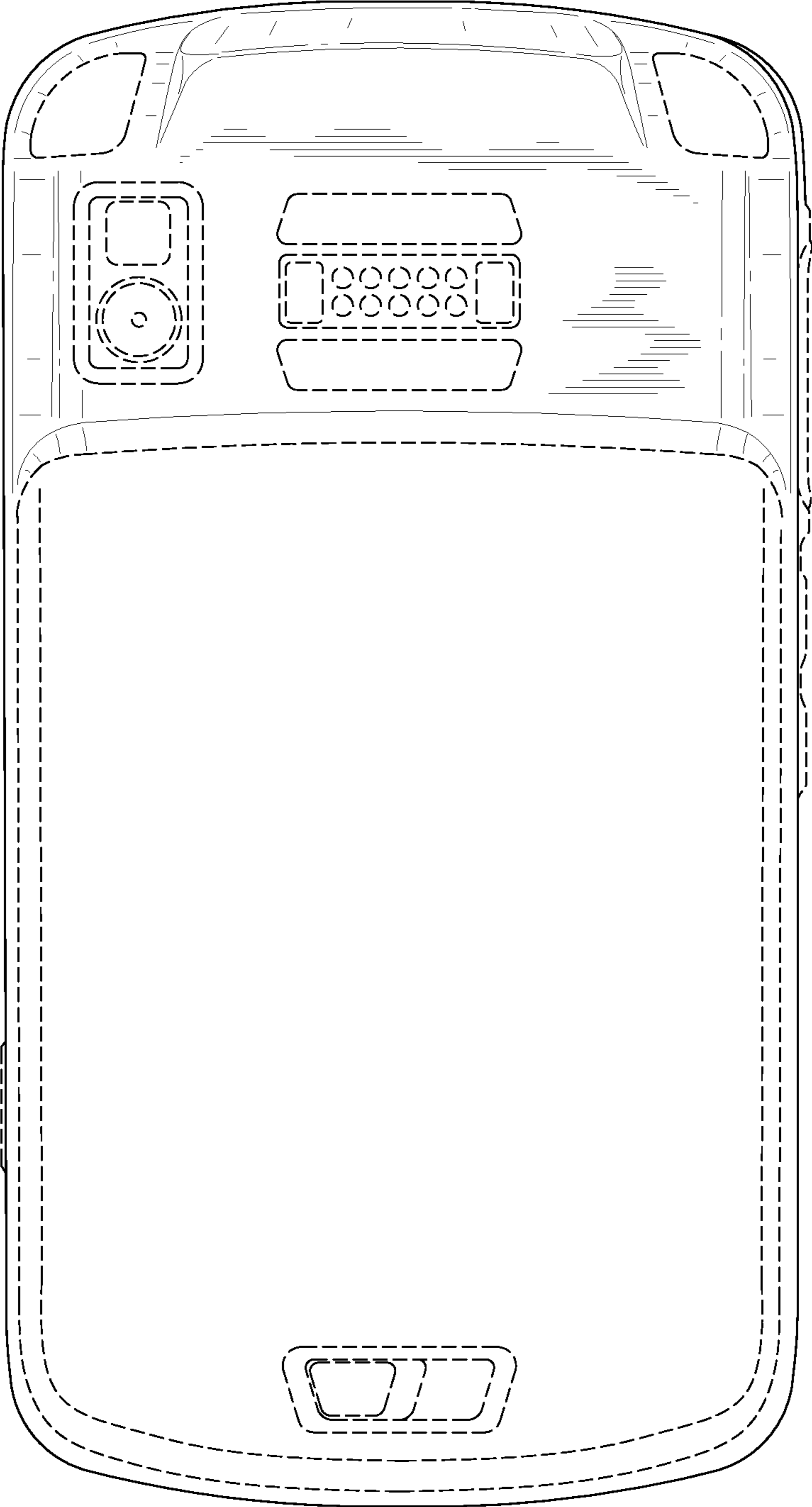

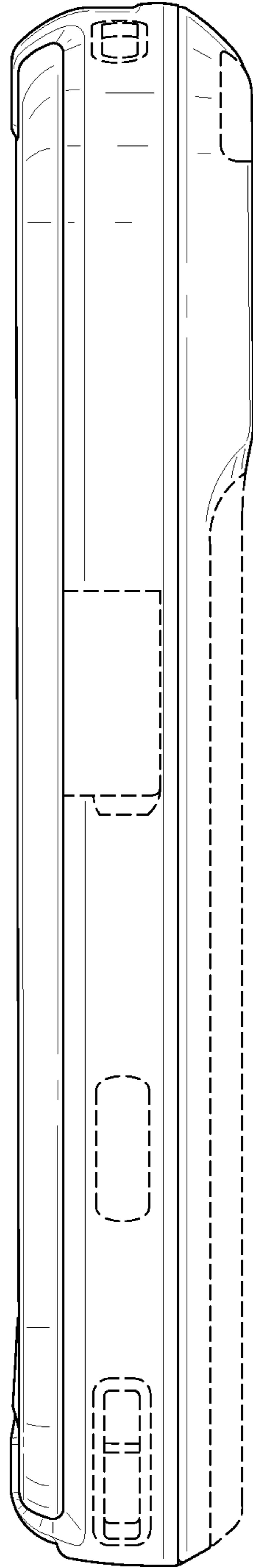

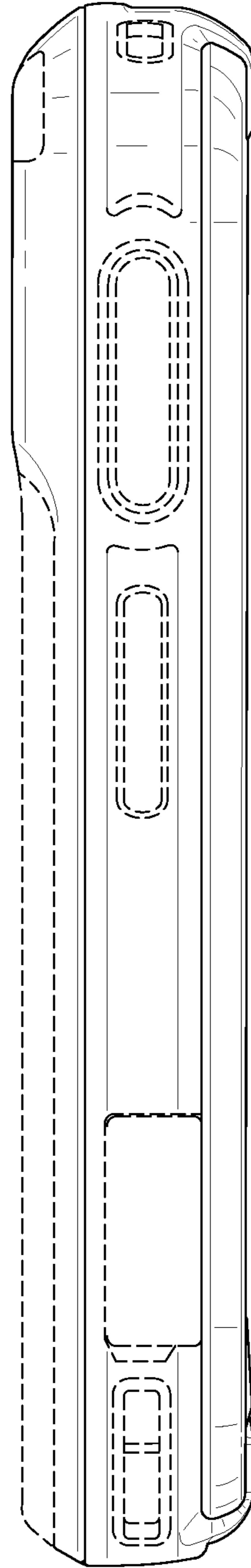

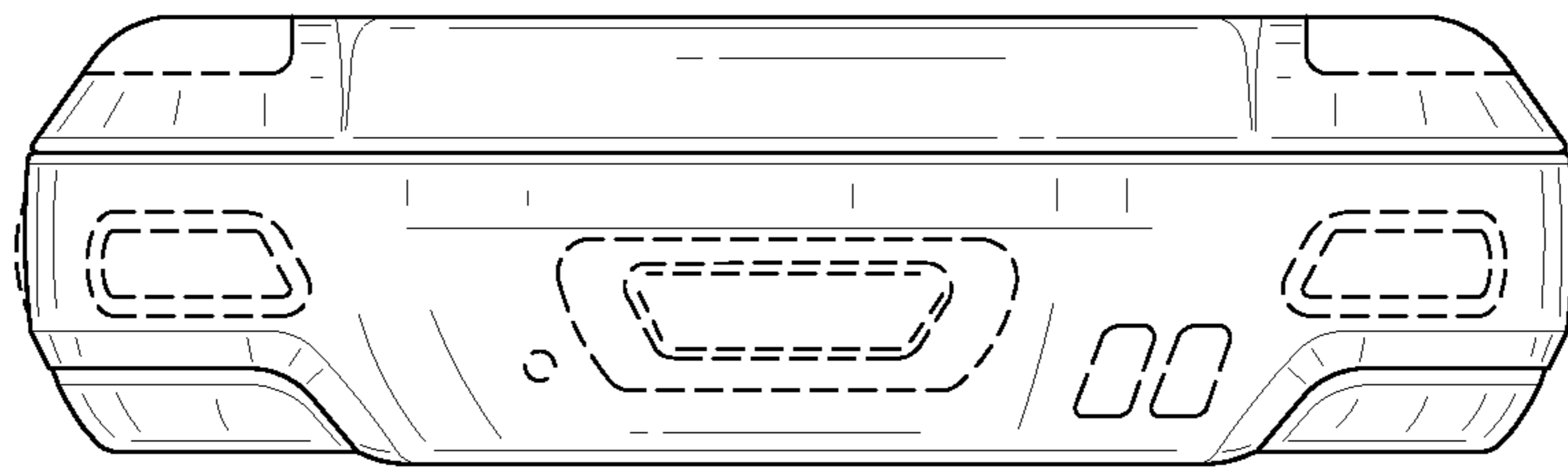

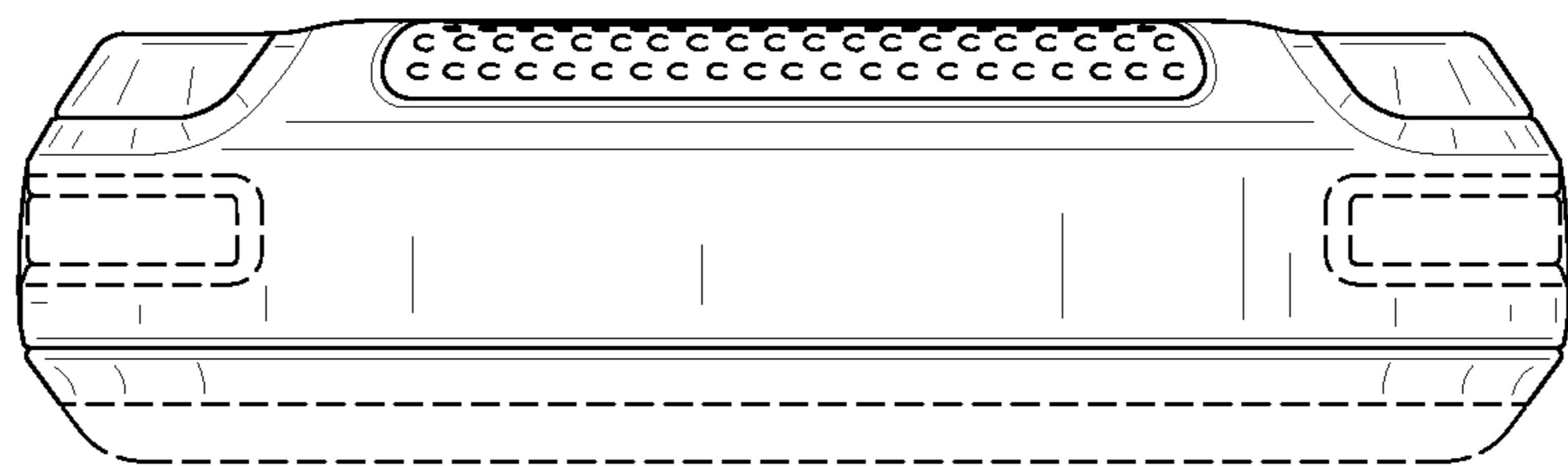
