The ornamental design for a lighted electronic device cover, as shown and described.

**DESCRIPTION**

FIG. 4 is a left-side elevation view of the lighted electronic device cover of FIG. 1;

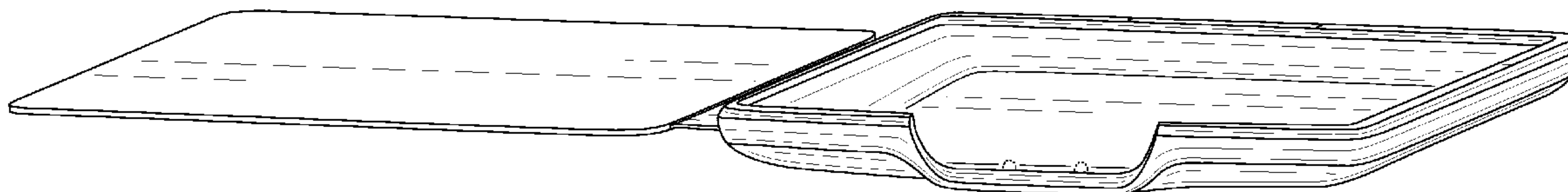
FIG. 5 is a right-side elevation view of the lighted electronic device cover of FIG. 1;

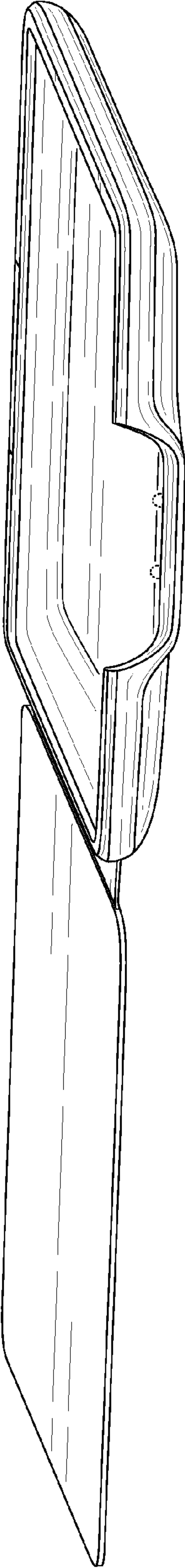

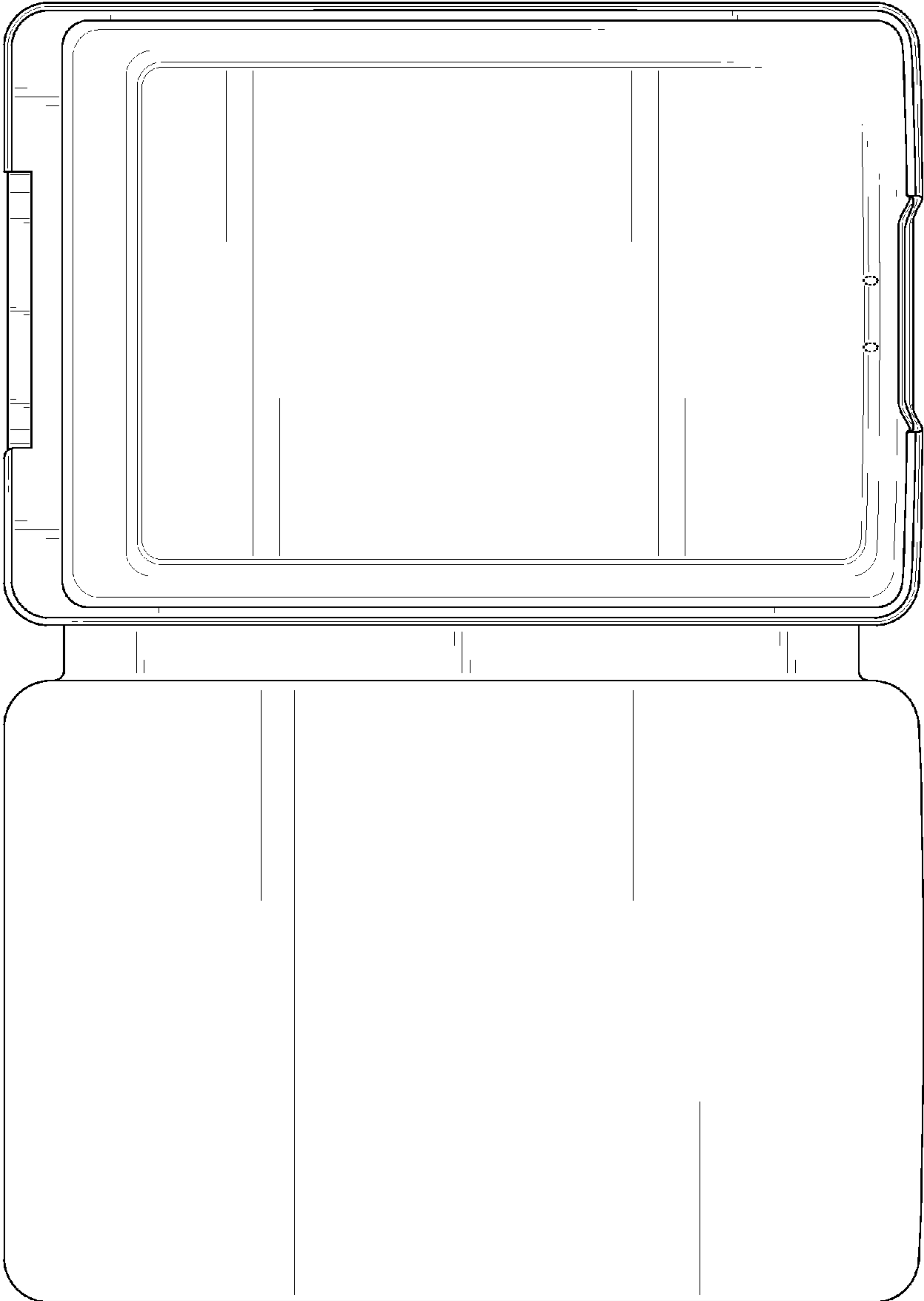

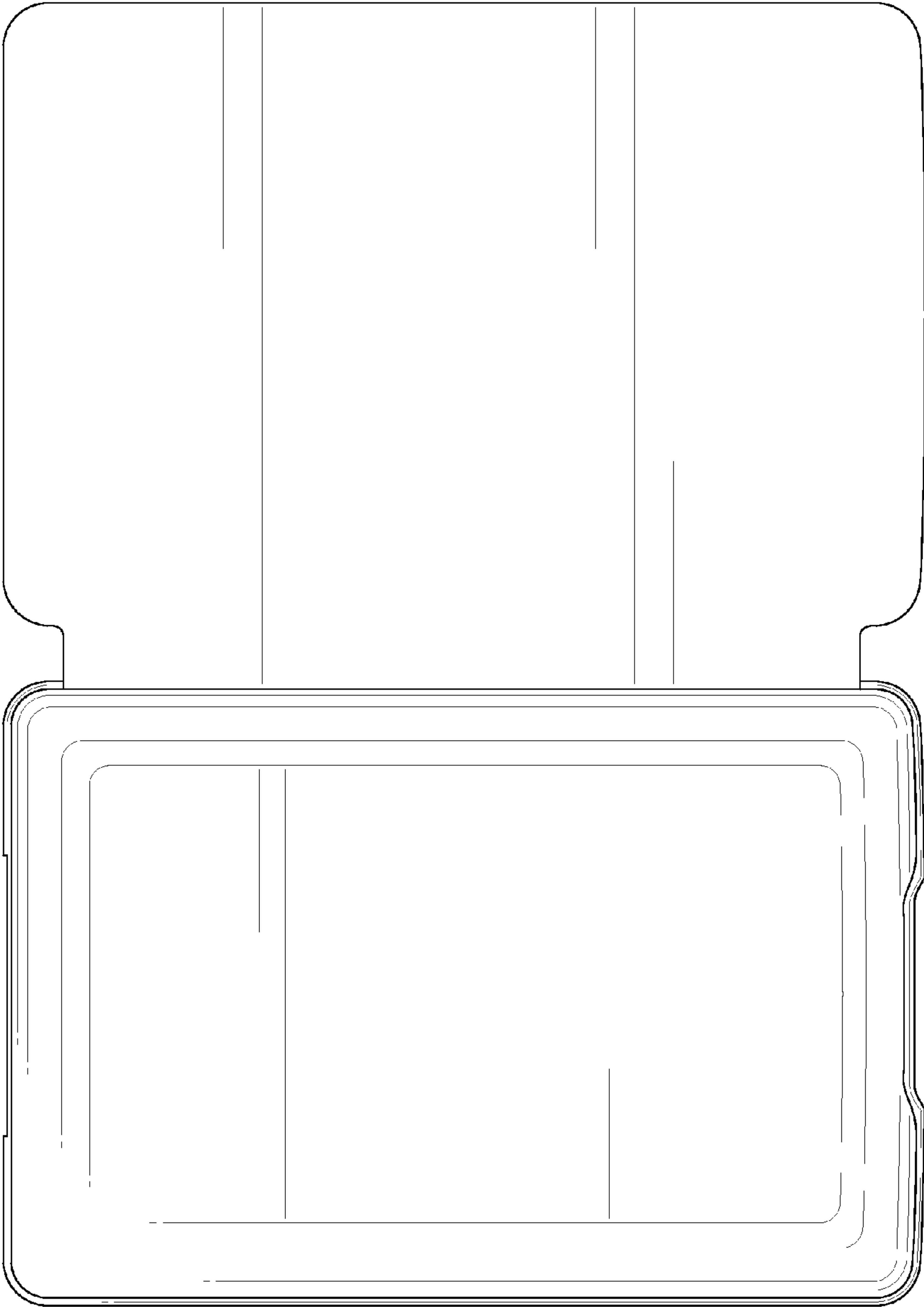

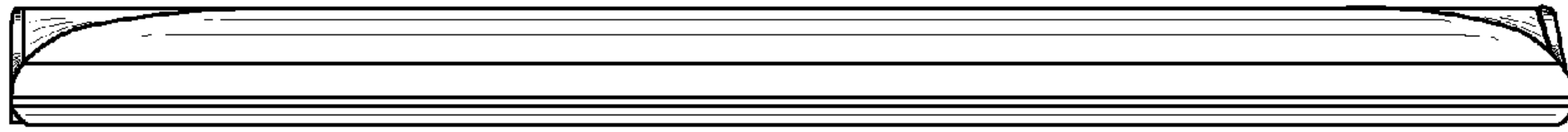

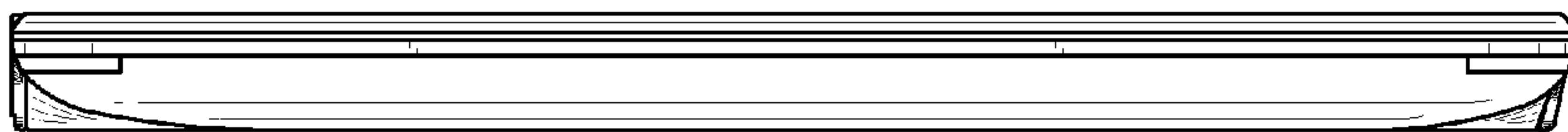

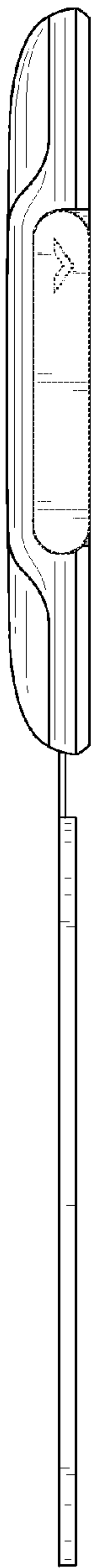

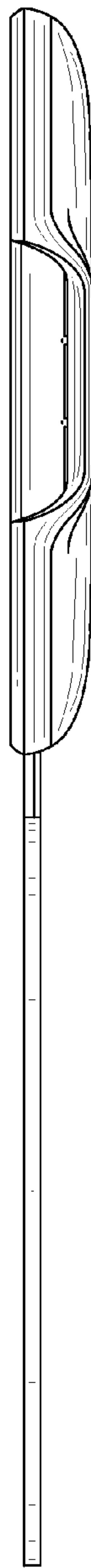
