FIG. 4 is a front view of the sizing template.

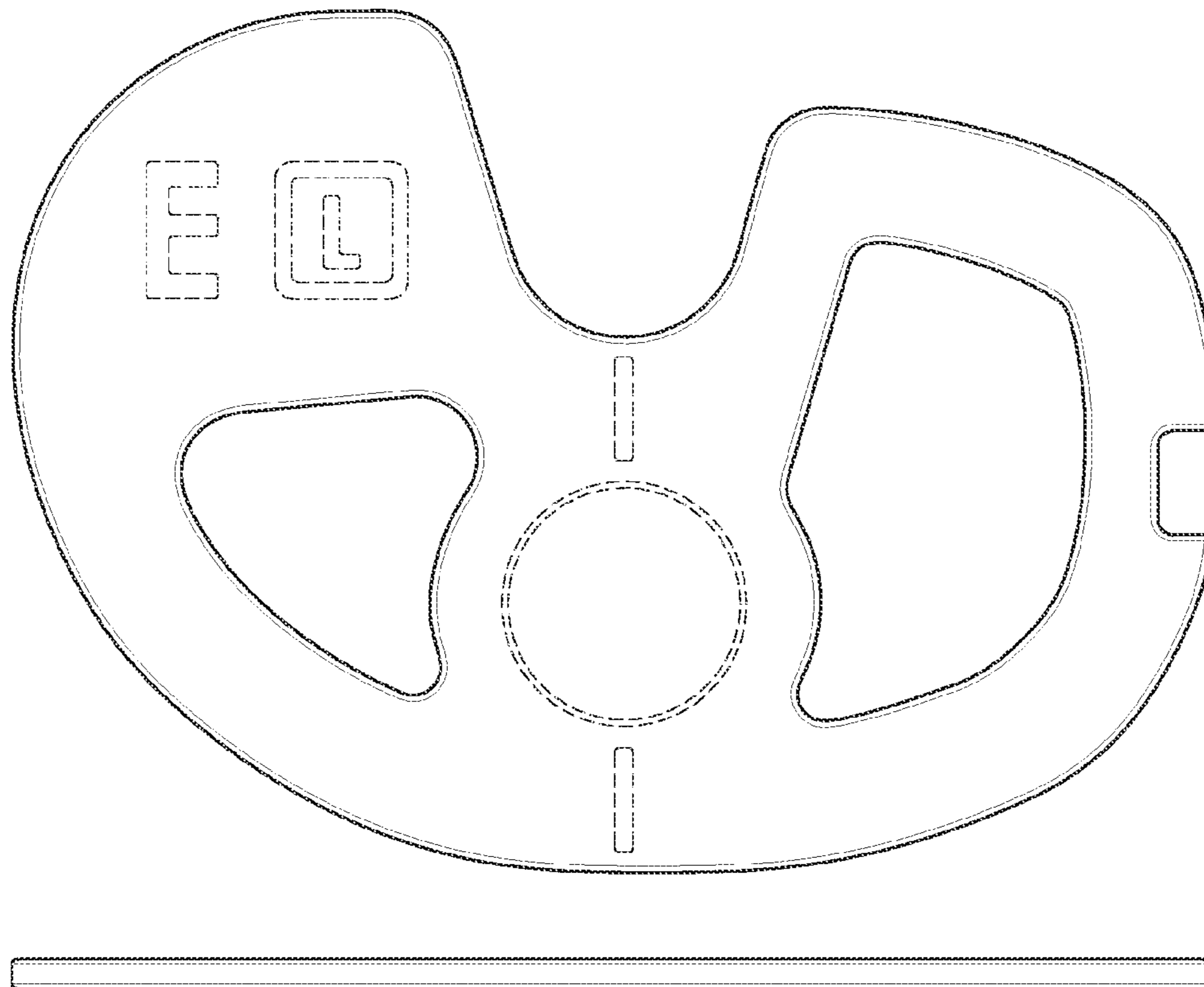
FIG. 5 is a back view of the sizing template.

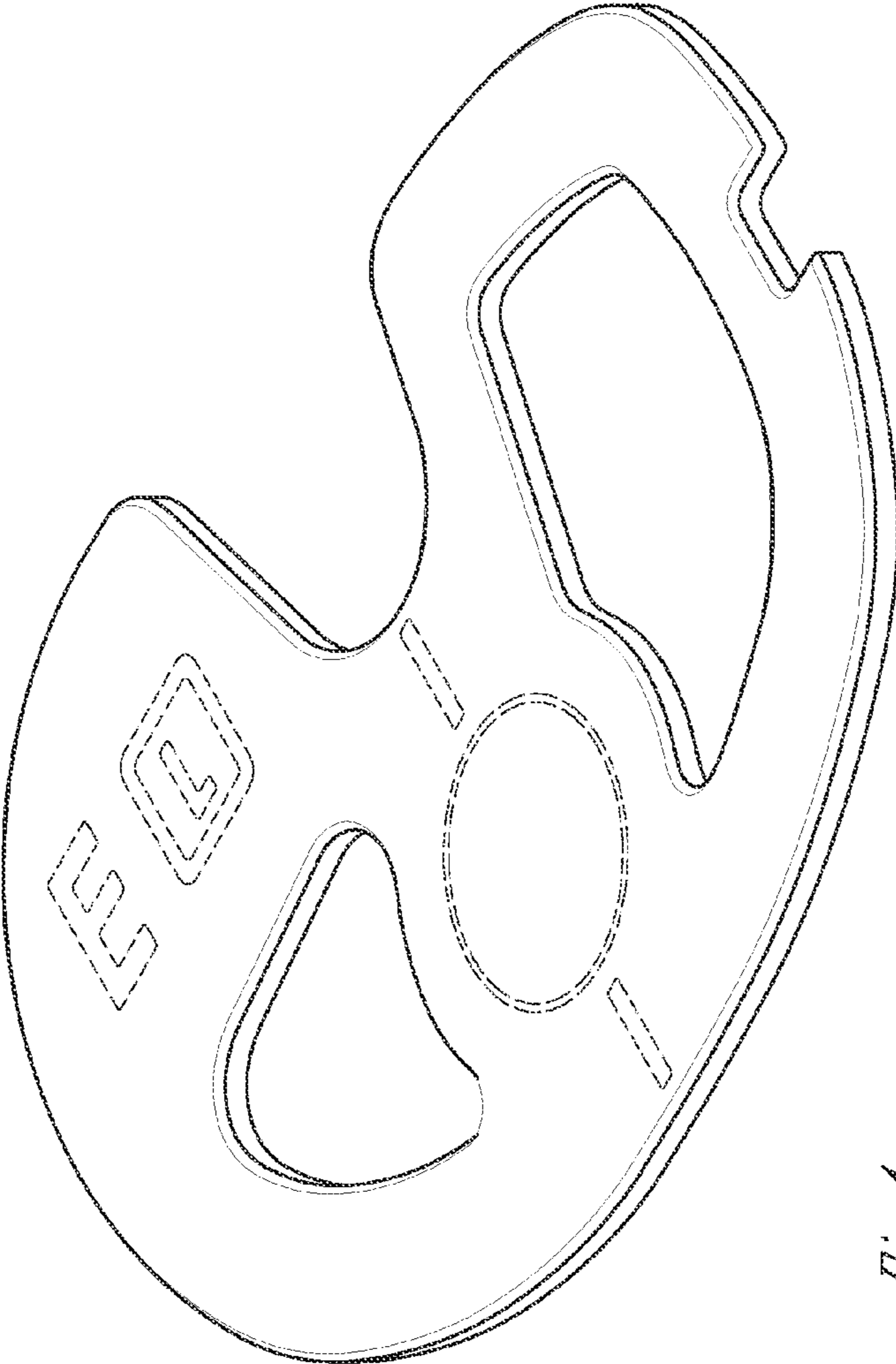

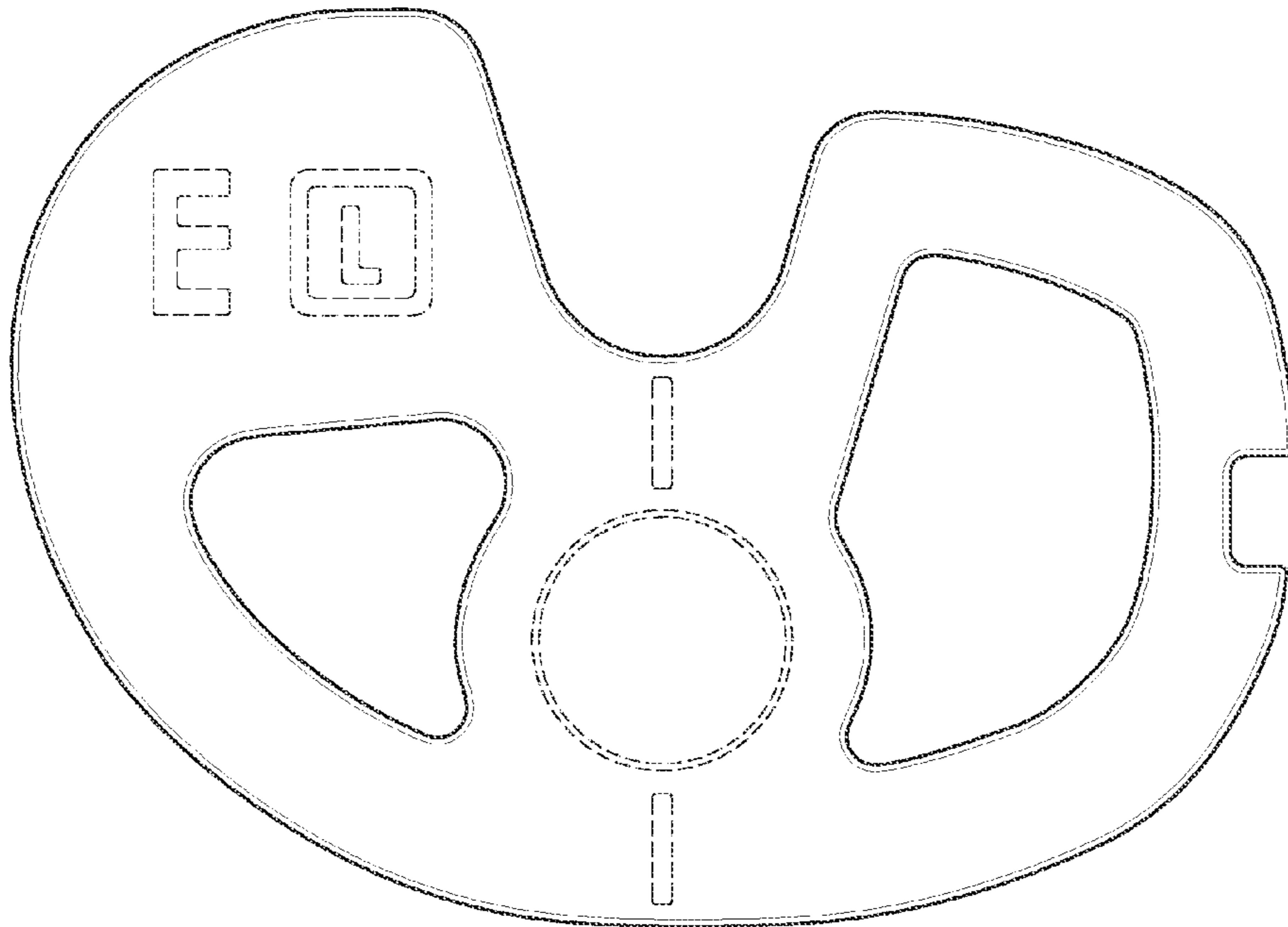

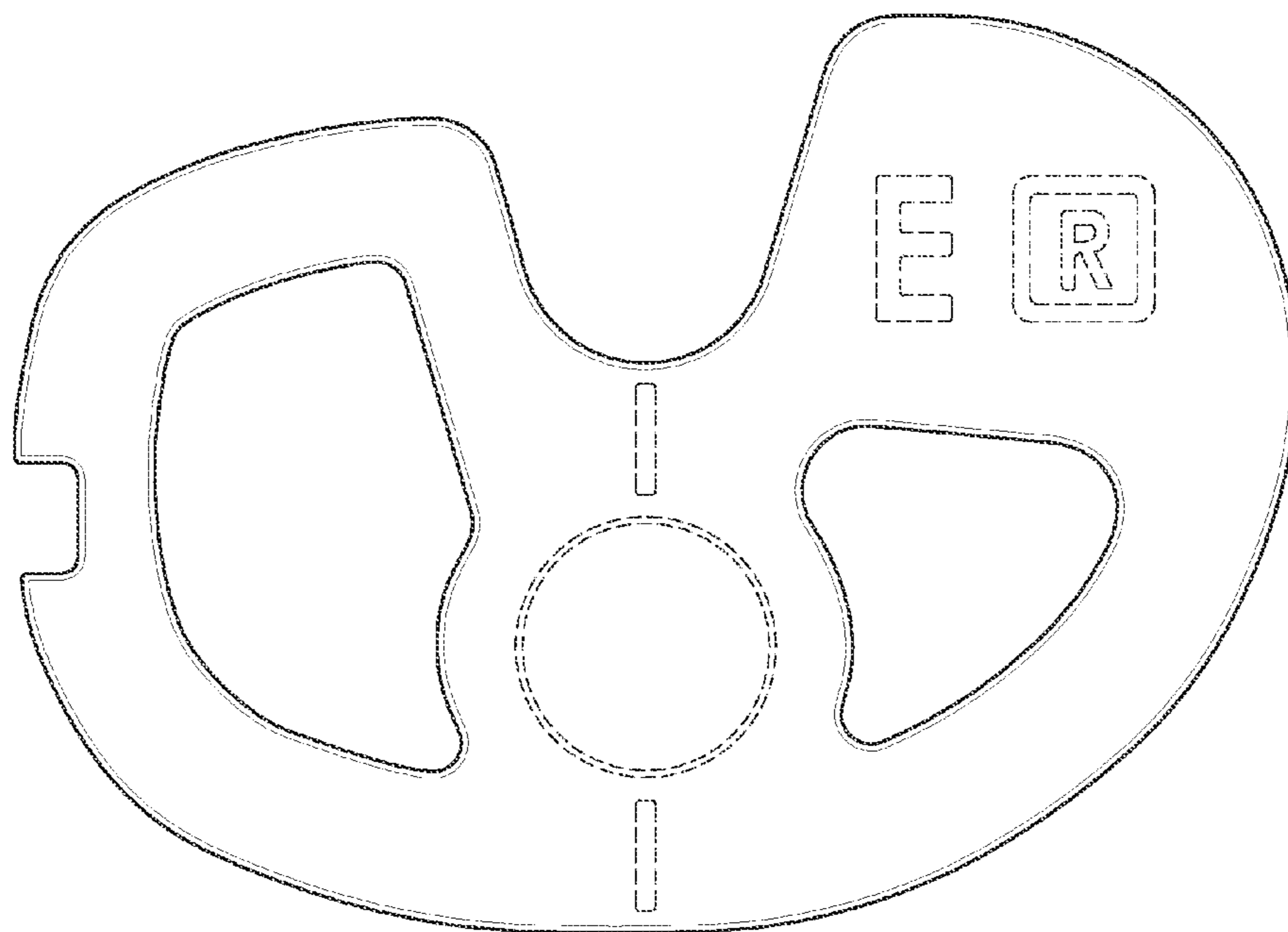

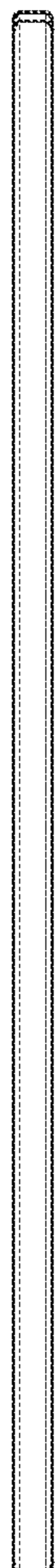

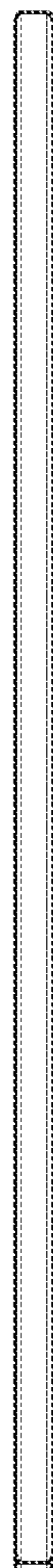

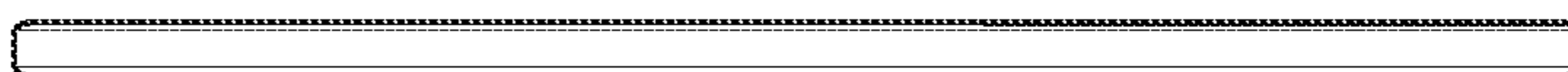
