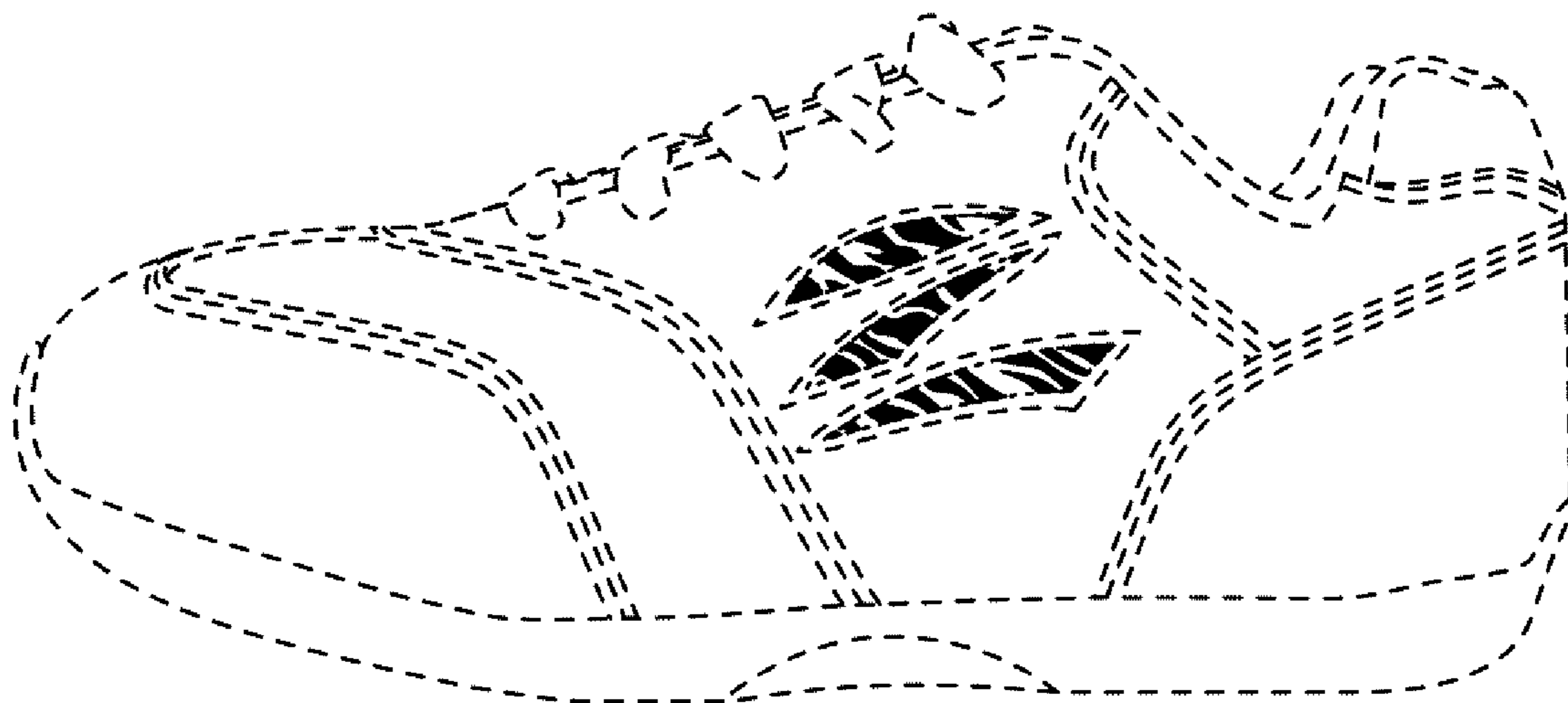
(57) **CLAIM**

The ornamental design for zebra patterned inserts for an athletic shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a left view of a zebra patterned inserts for athletic shoe showing my new design;  
FIG. 2 is a right view thereof;  
FIG. 3 is a partially enlarged view of the lower, right end portion of the right side view of FIG. 2; and,  
FIG. 4 is an top view of FIG. 1.

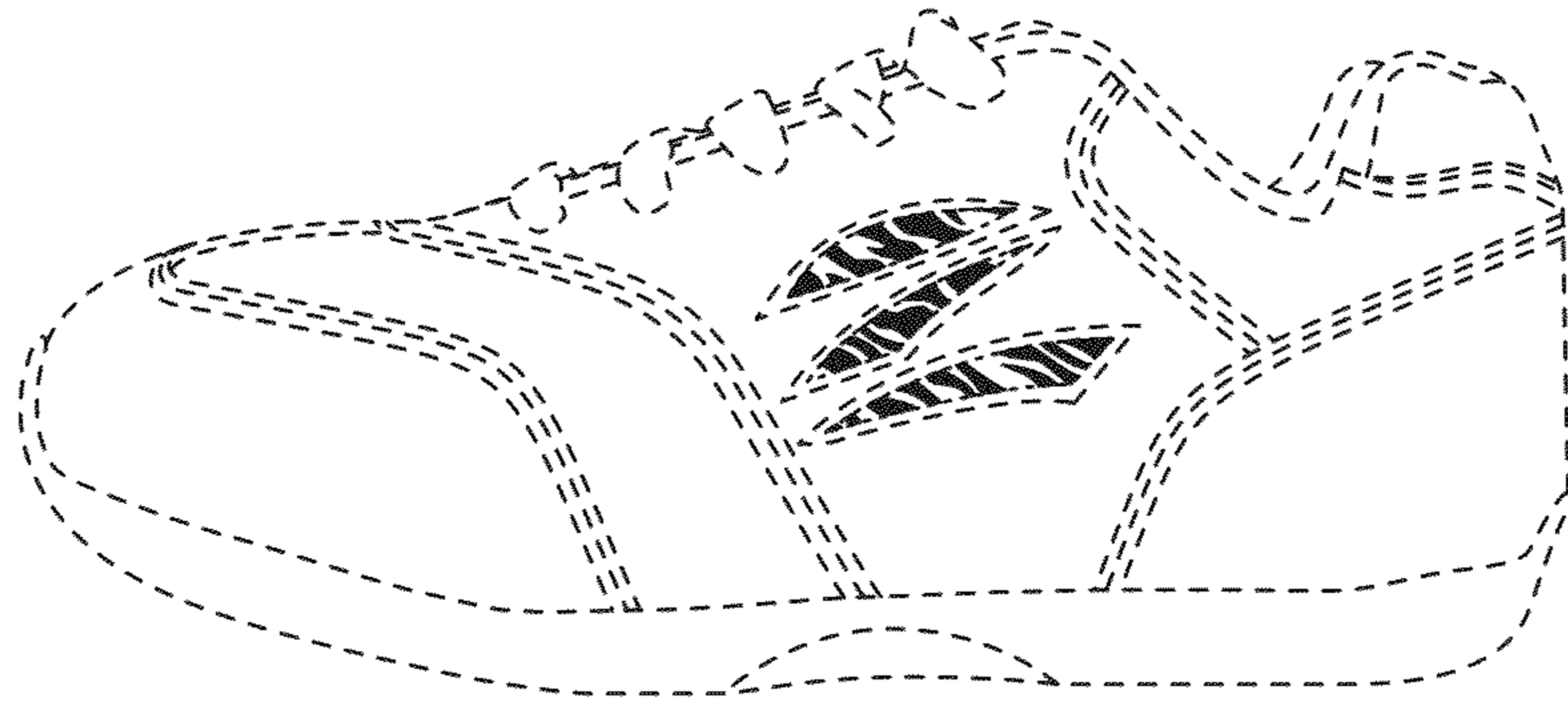

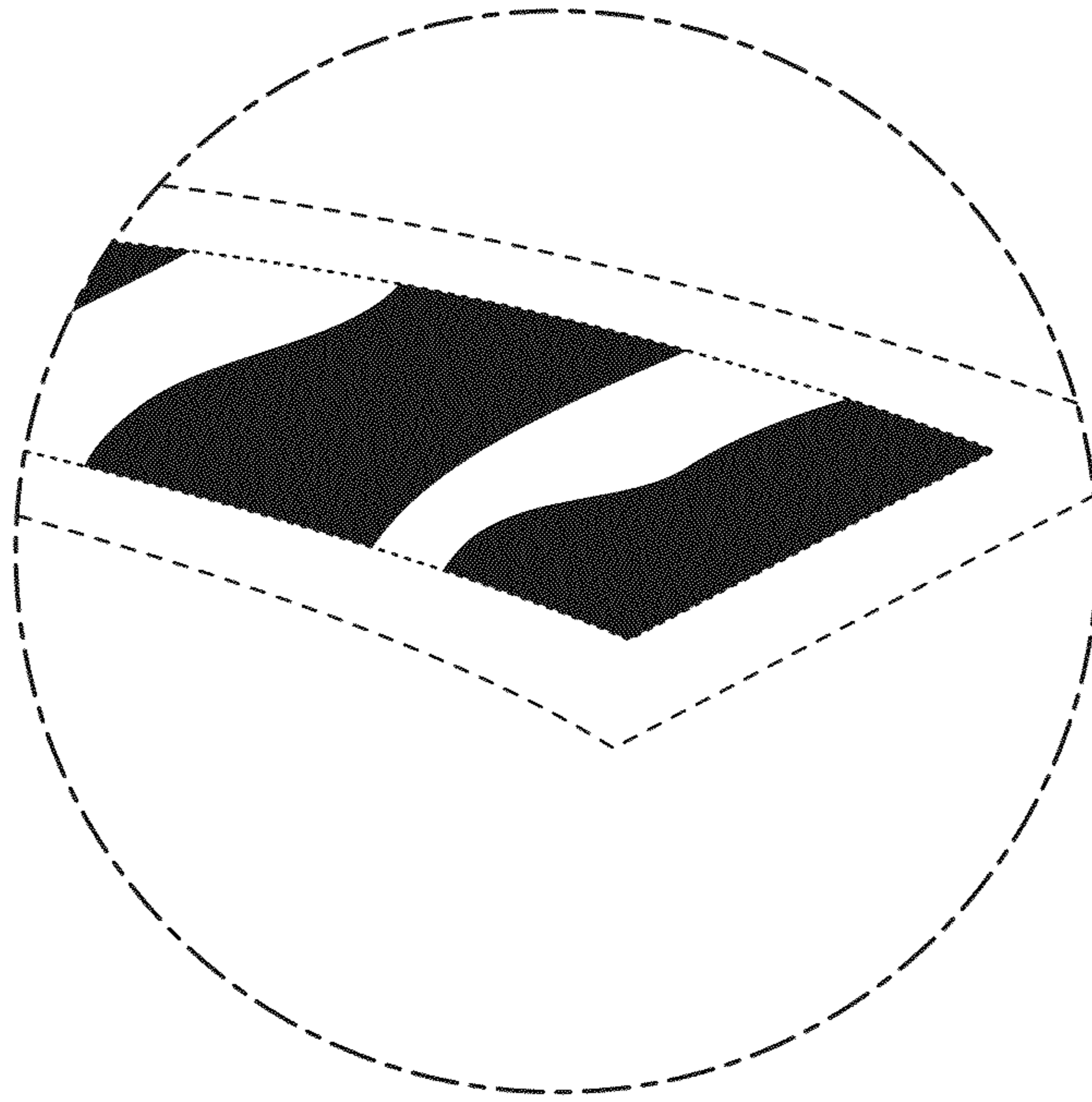

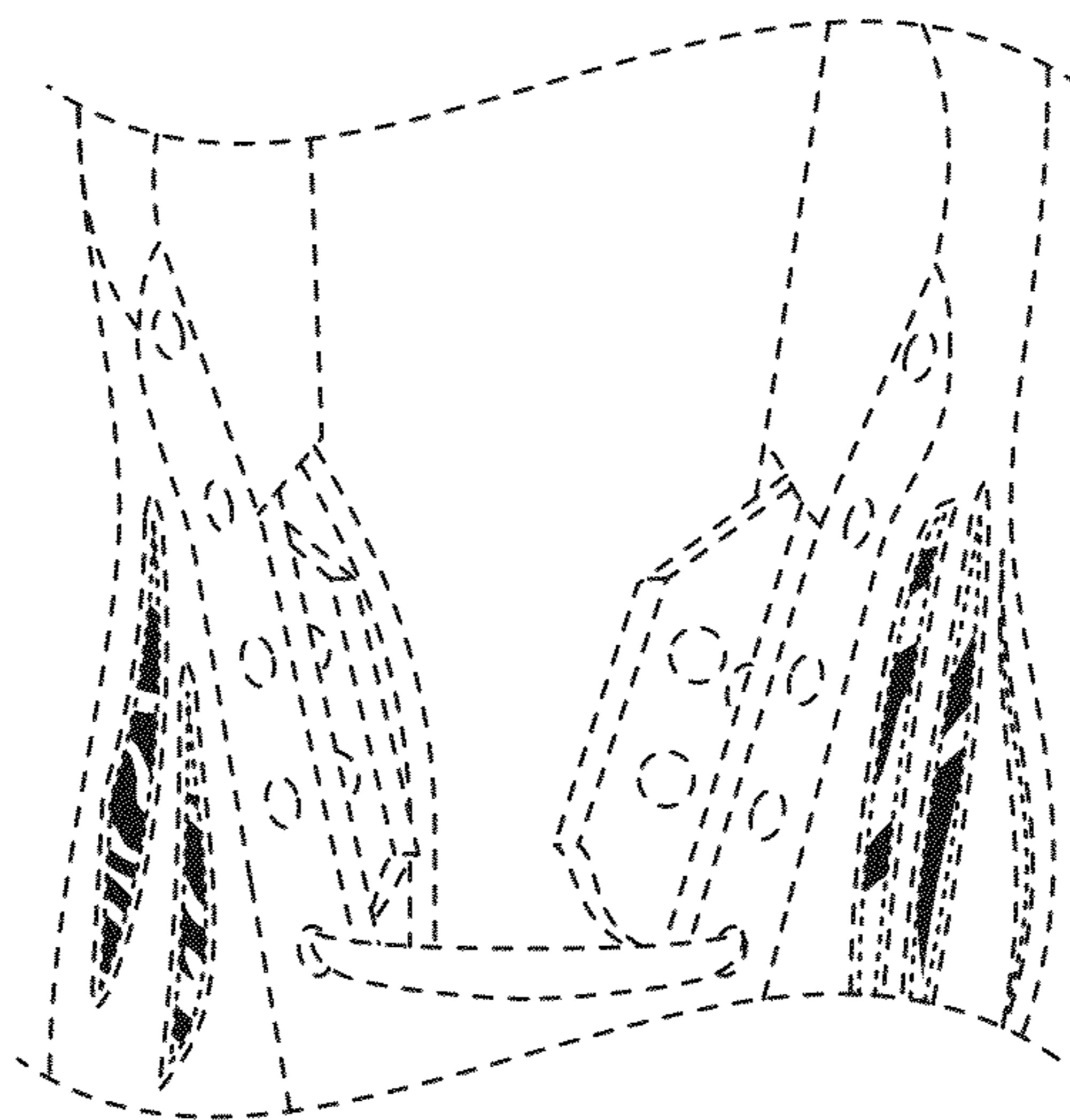
