FIG. 7 is a right-side view of the car seat for children of the new design.

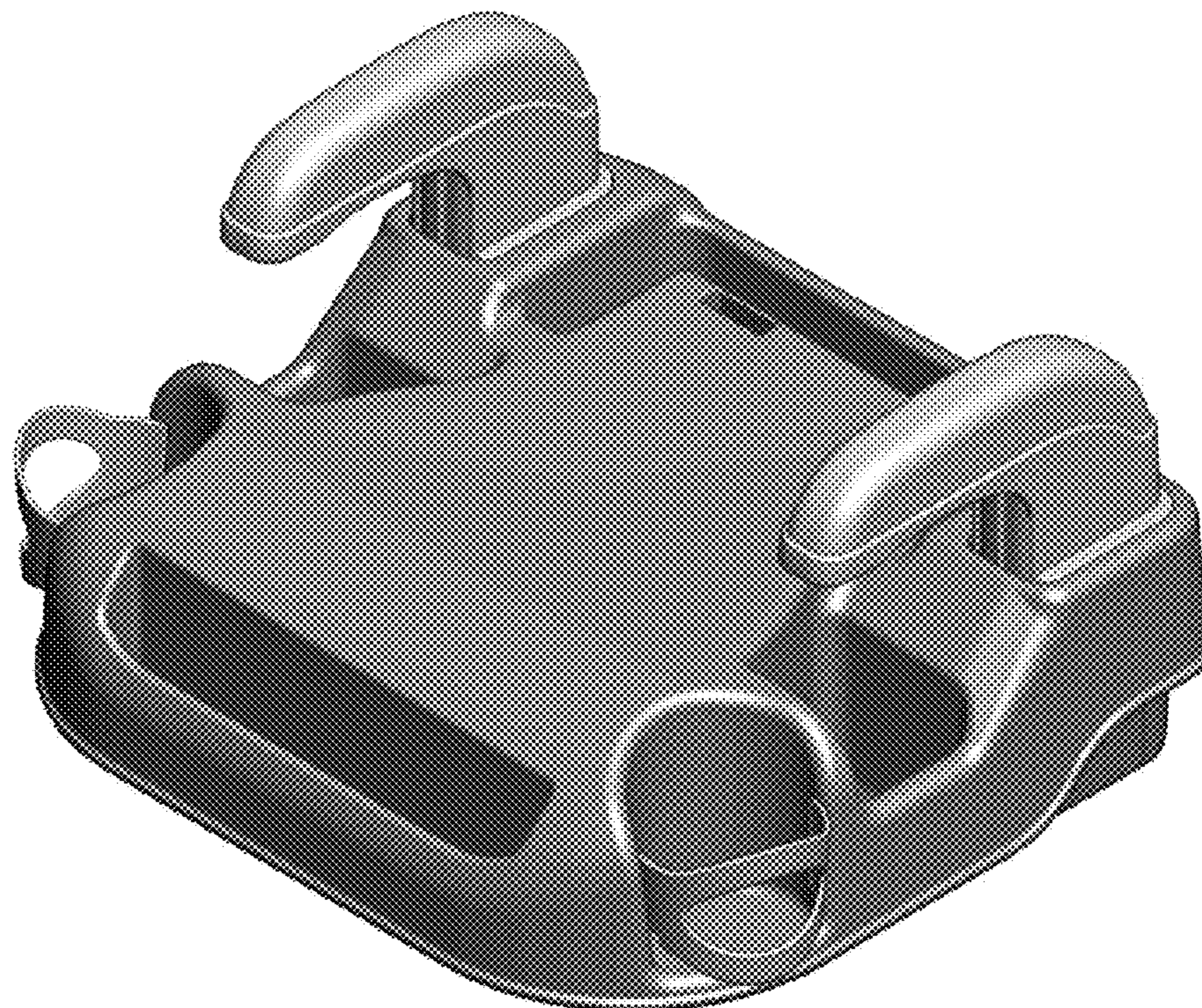

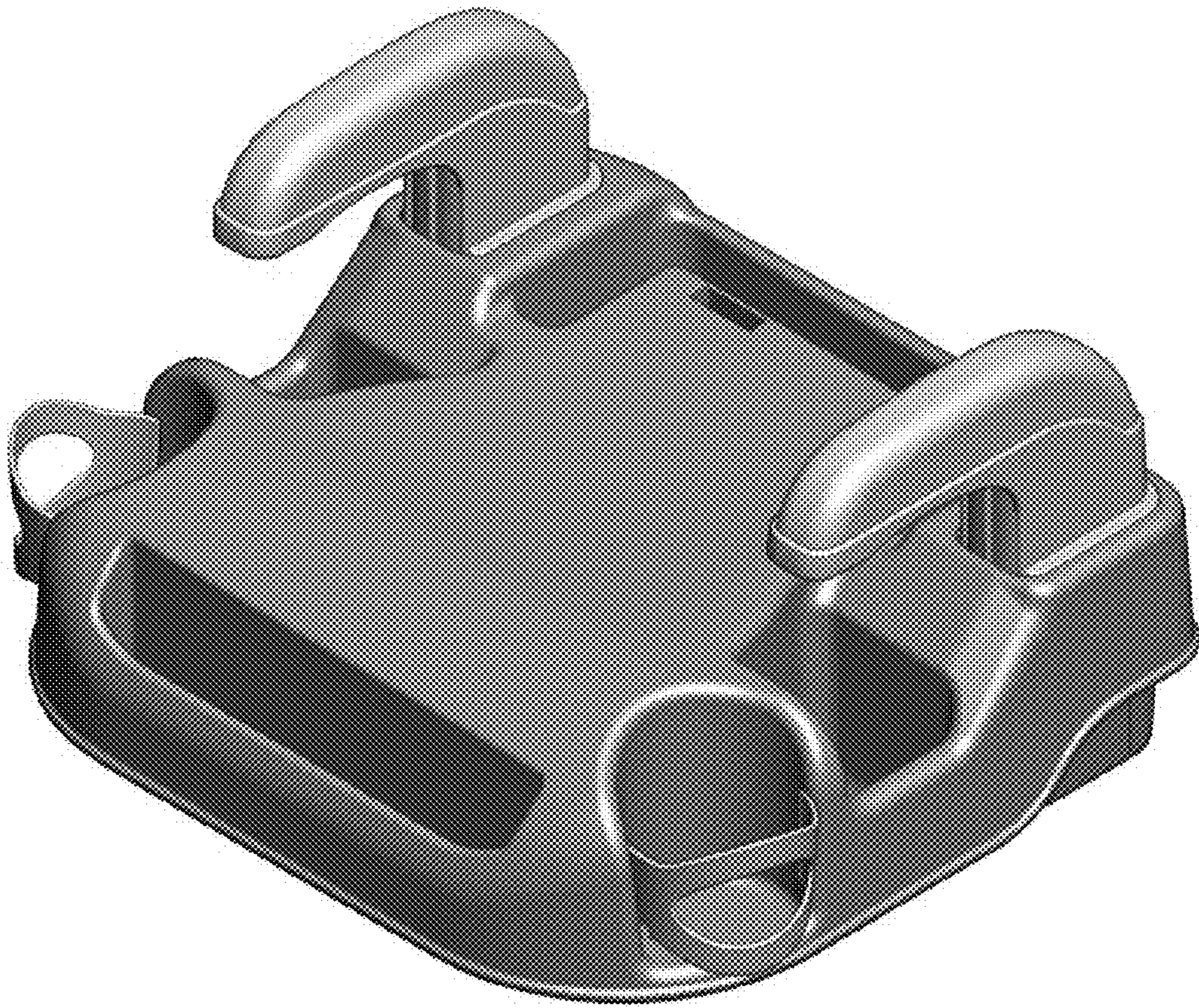

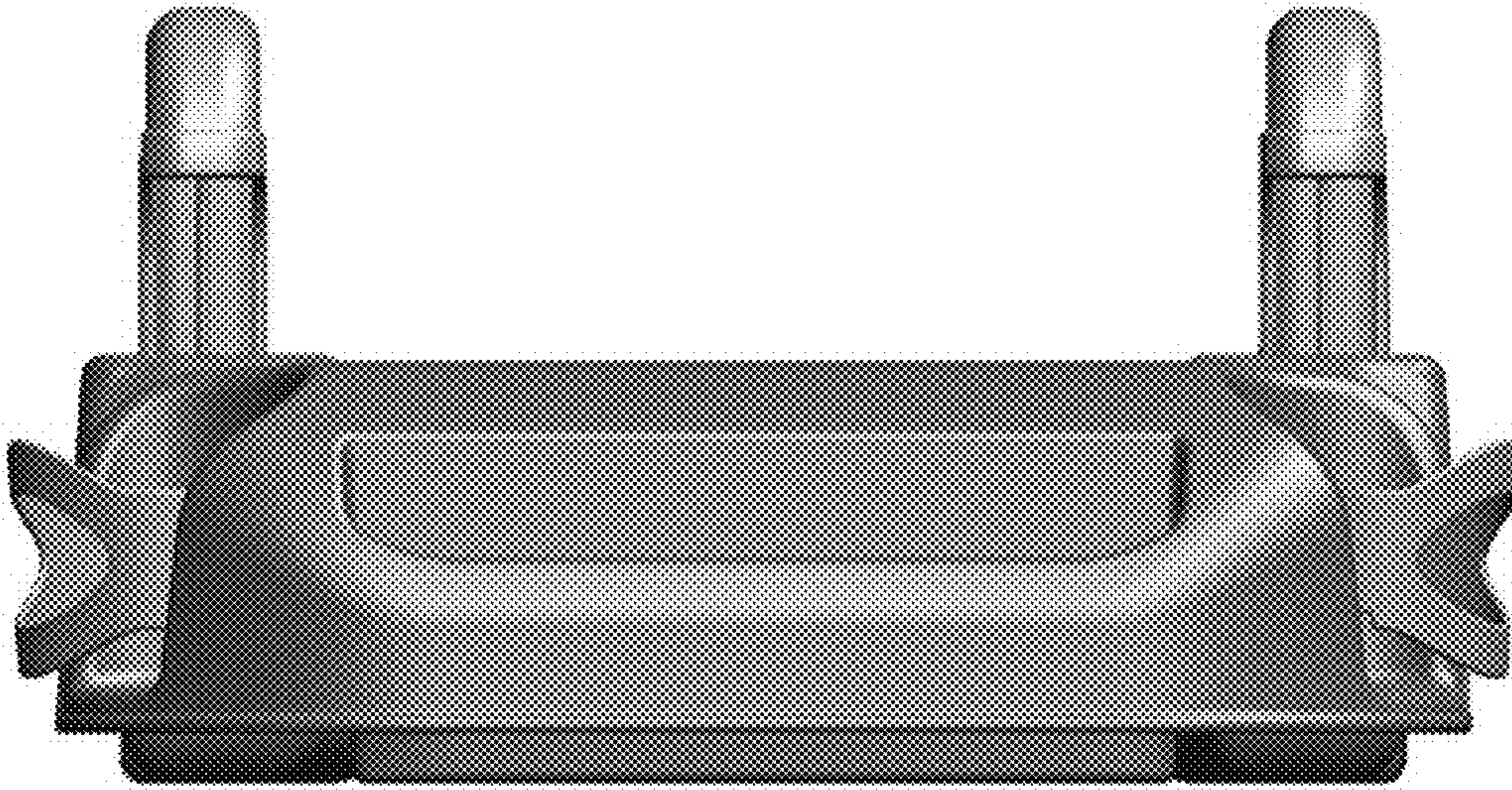

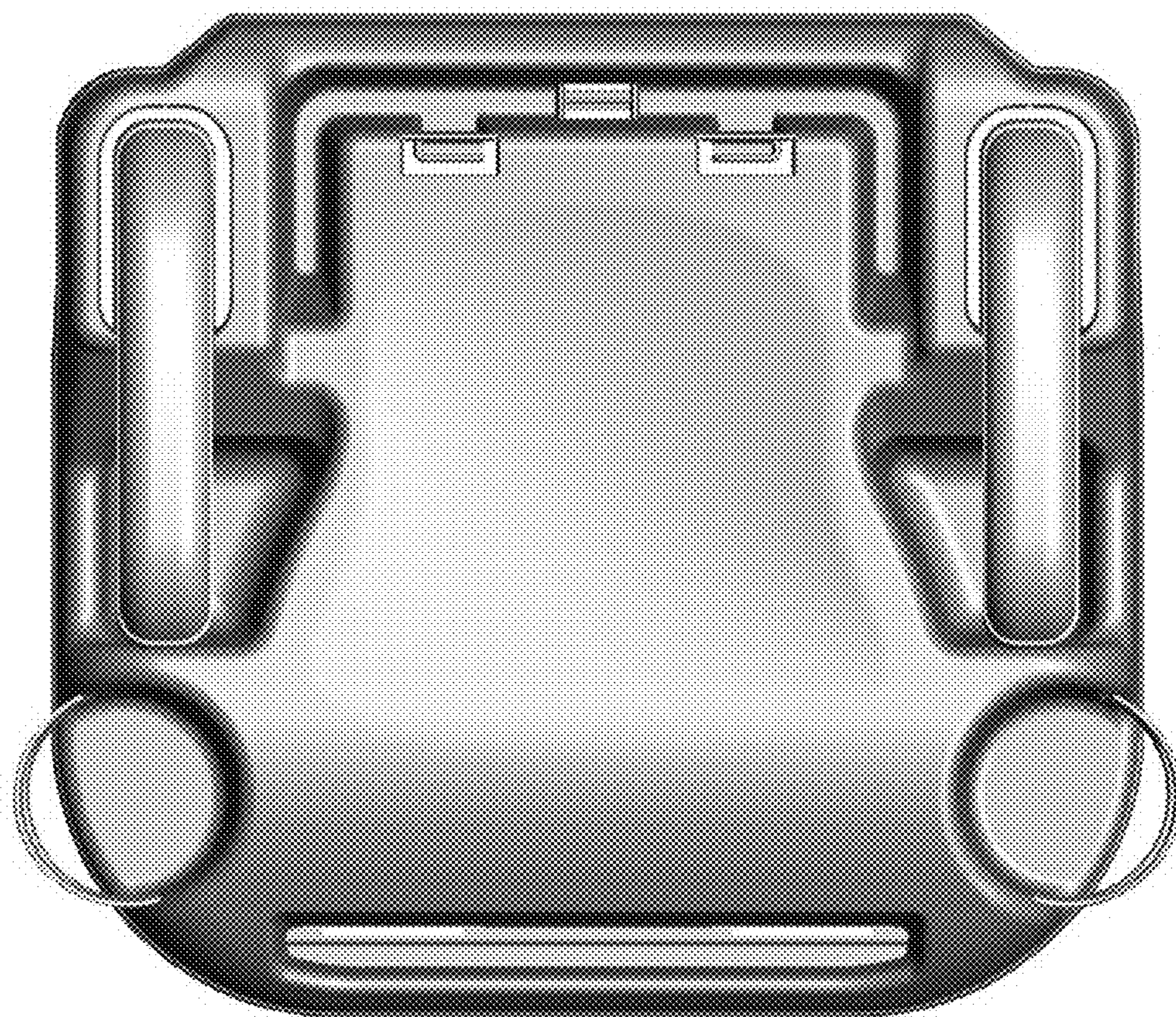

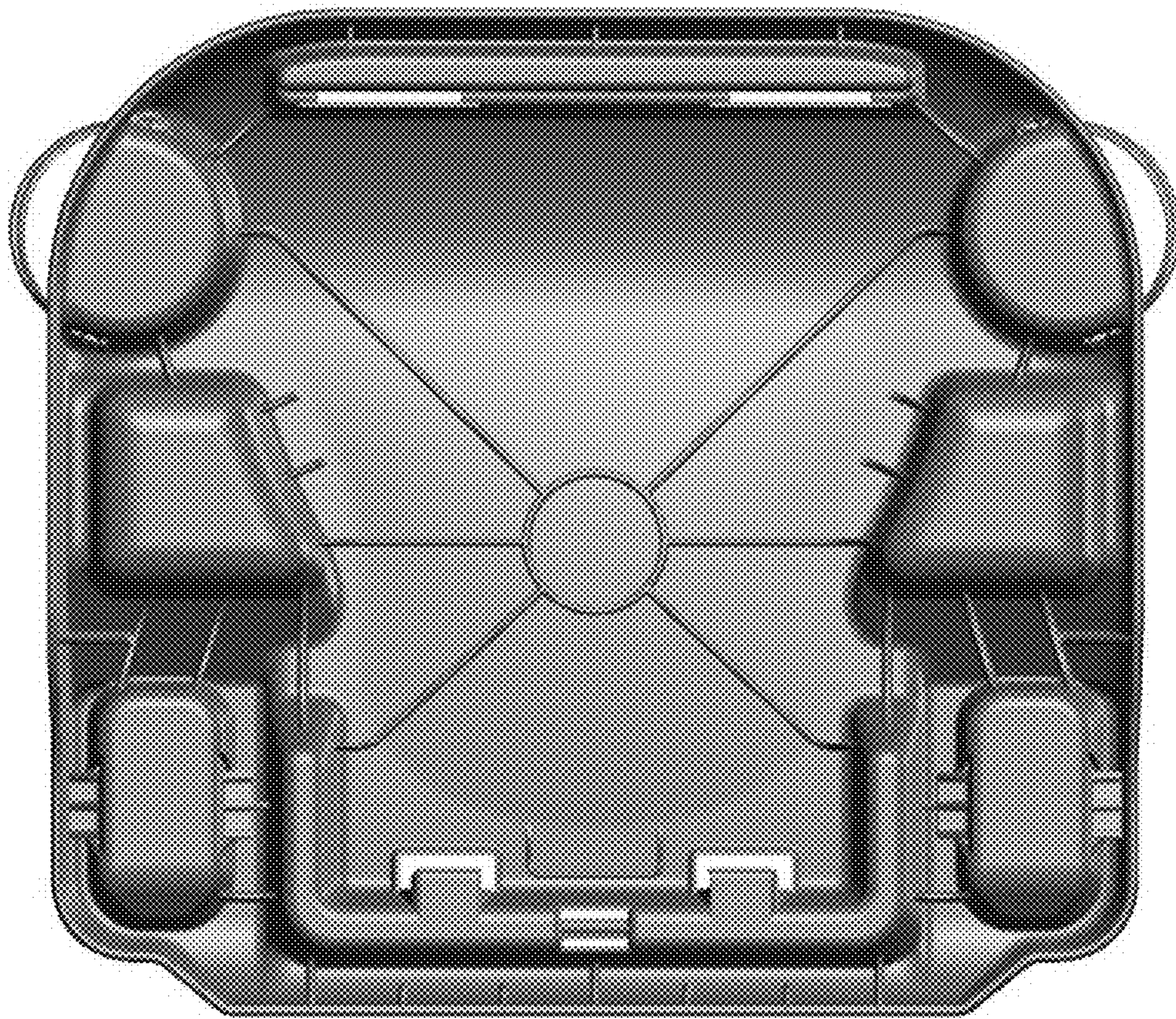

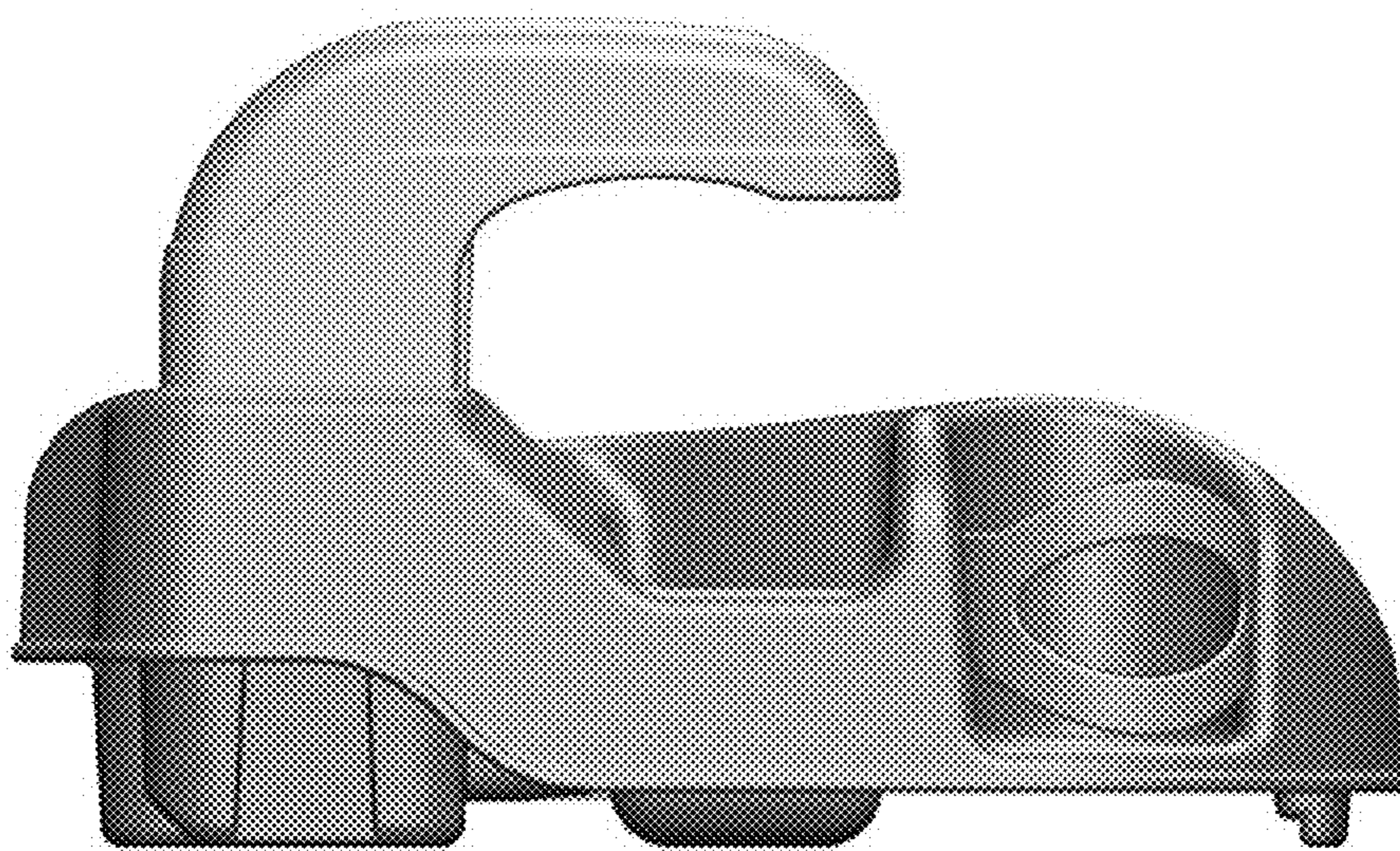

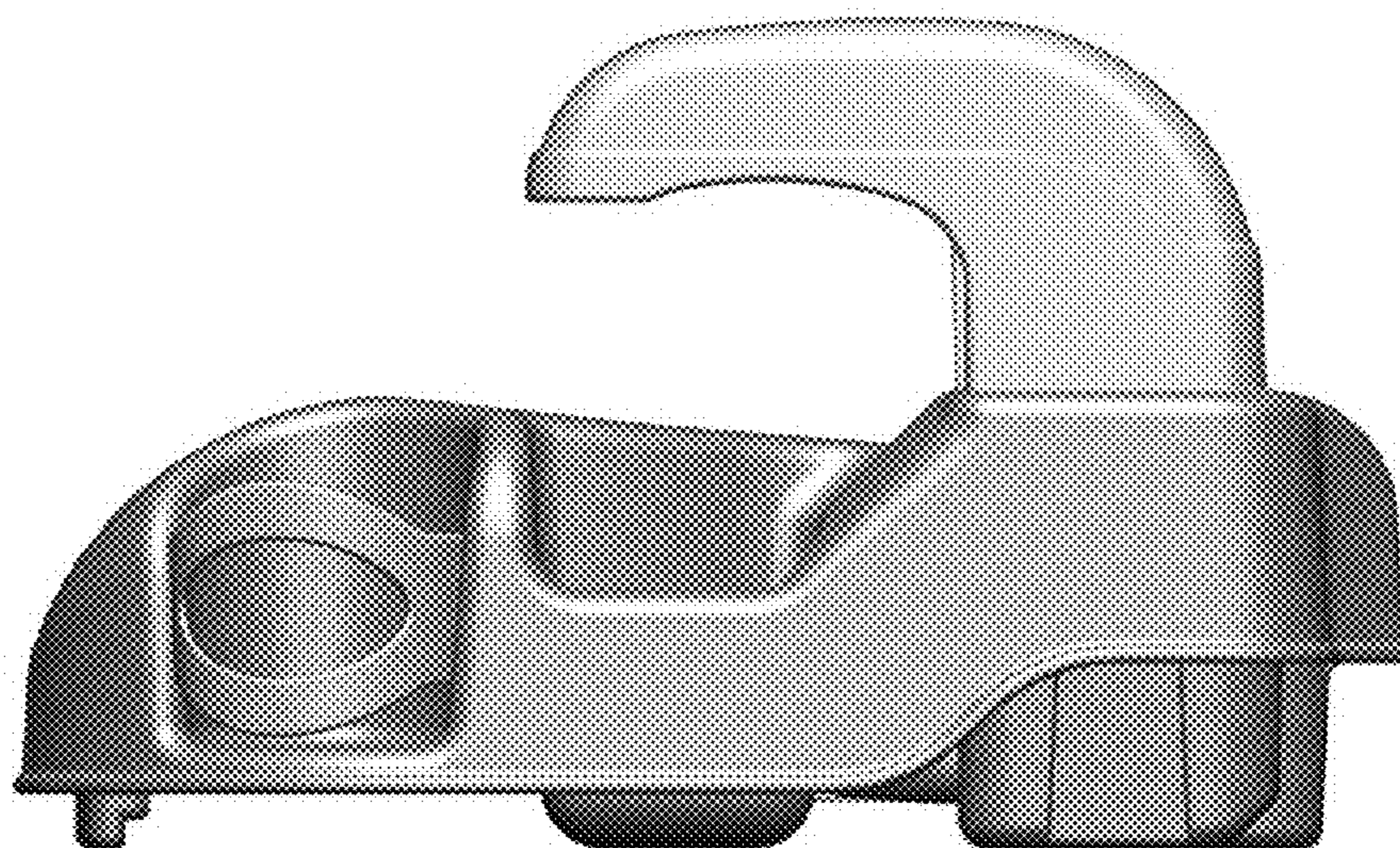
