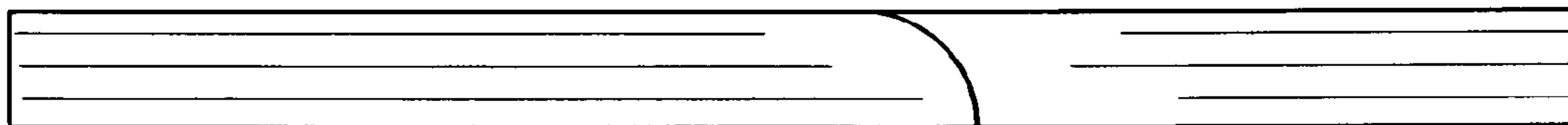
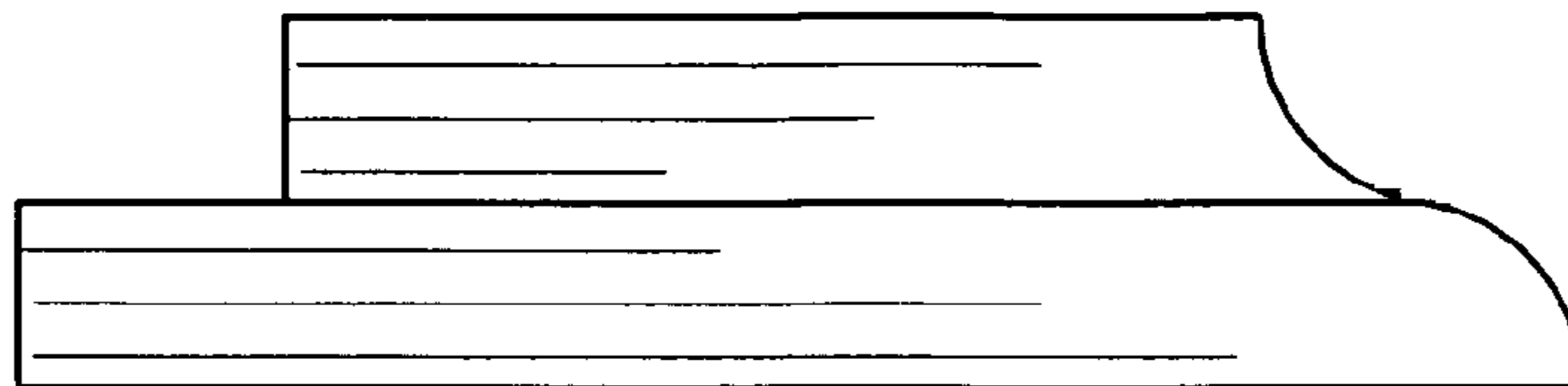
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a left side view of the shelf extender, closed, the right side view being a mirror image thereof.
FIG. 2 is a left side view of the shelf extender, open, the right side view being a mirror image thereof.
FIG. 3 is a rear view of the shelf extender, closed.
FIG. 4 is a bottom view of the shelf extender, closed.

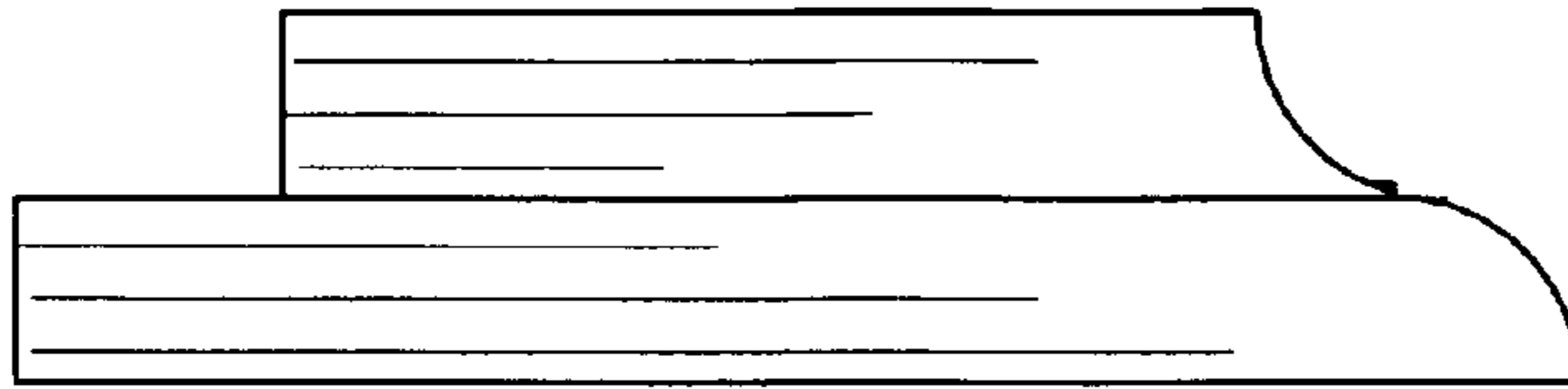

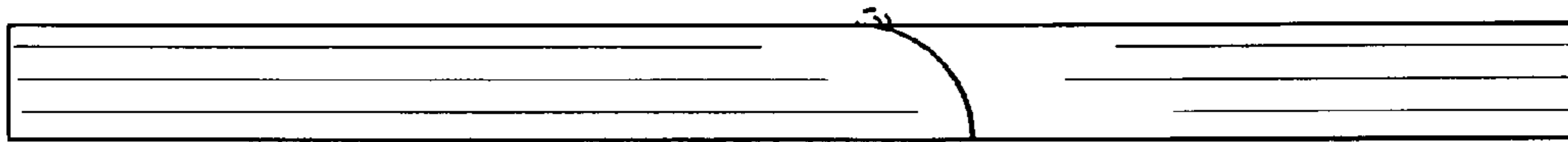

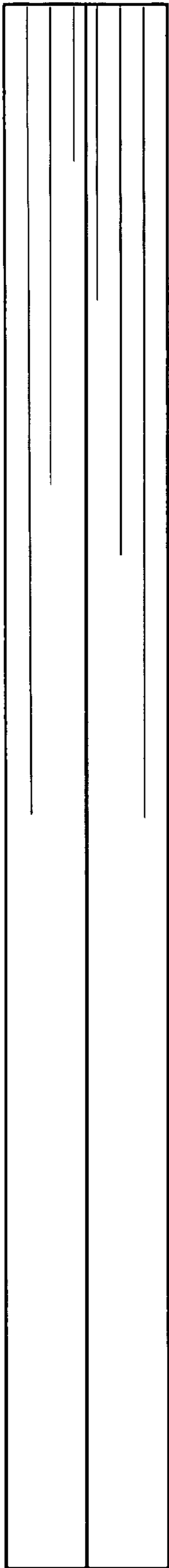

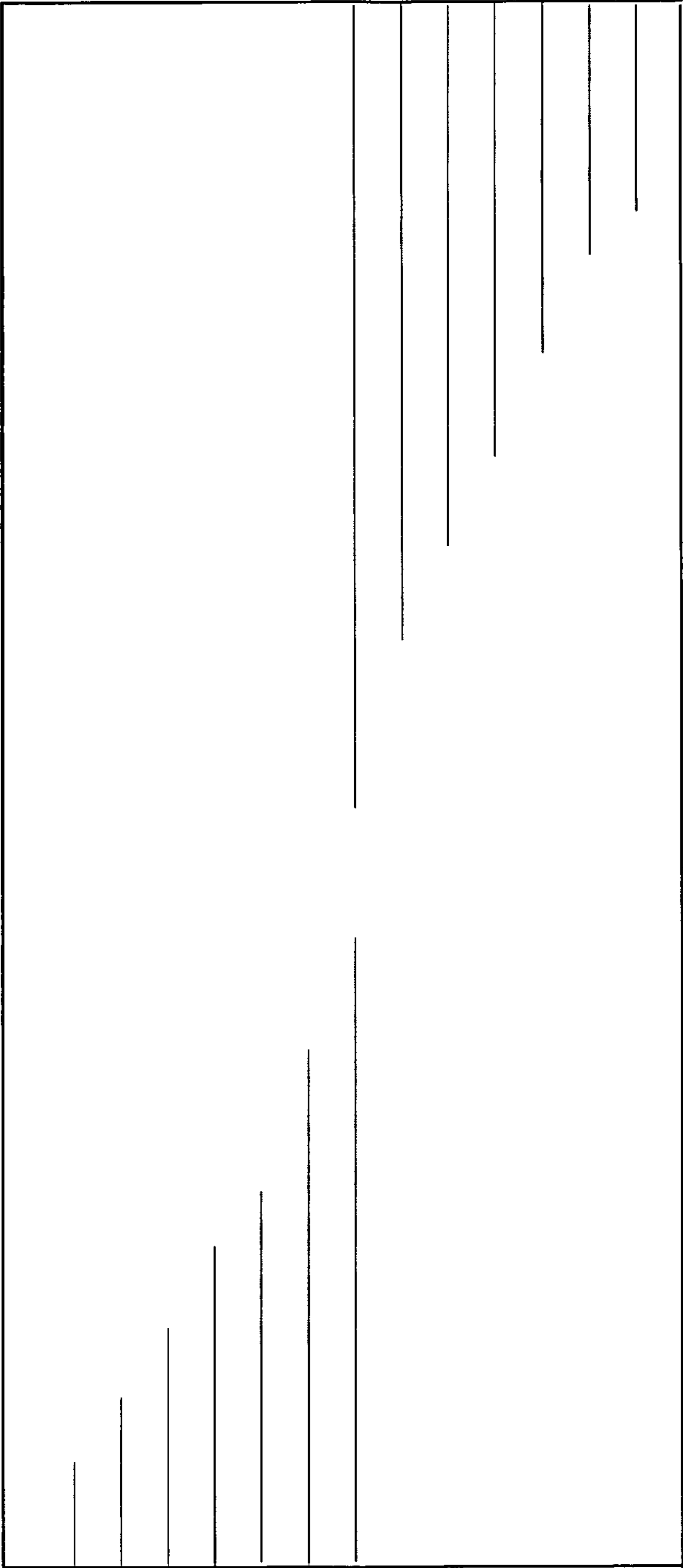

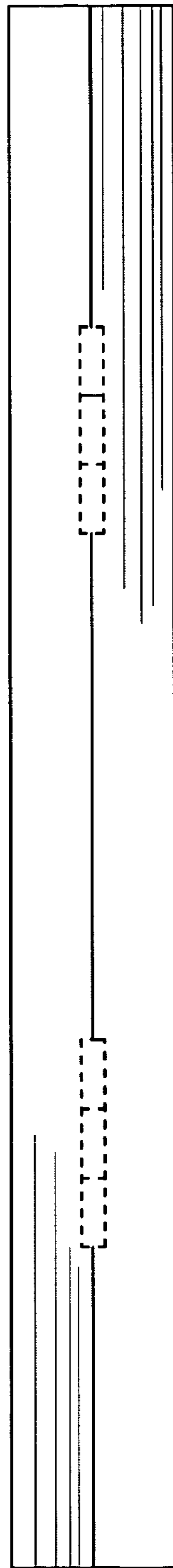

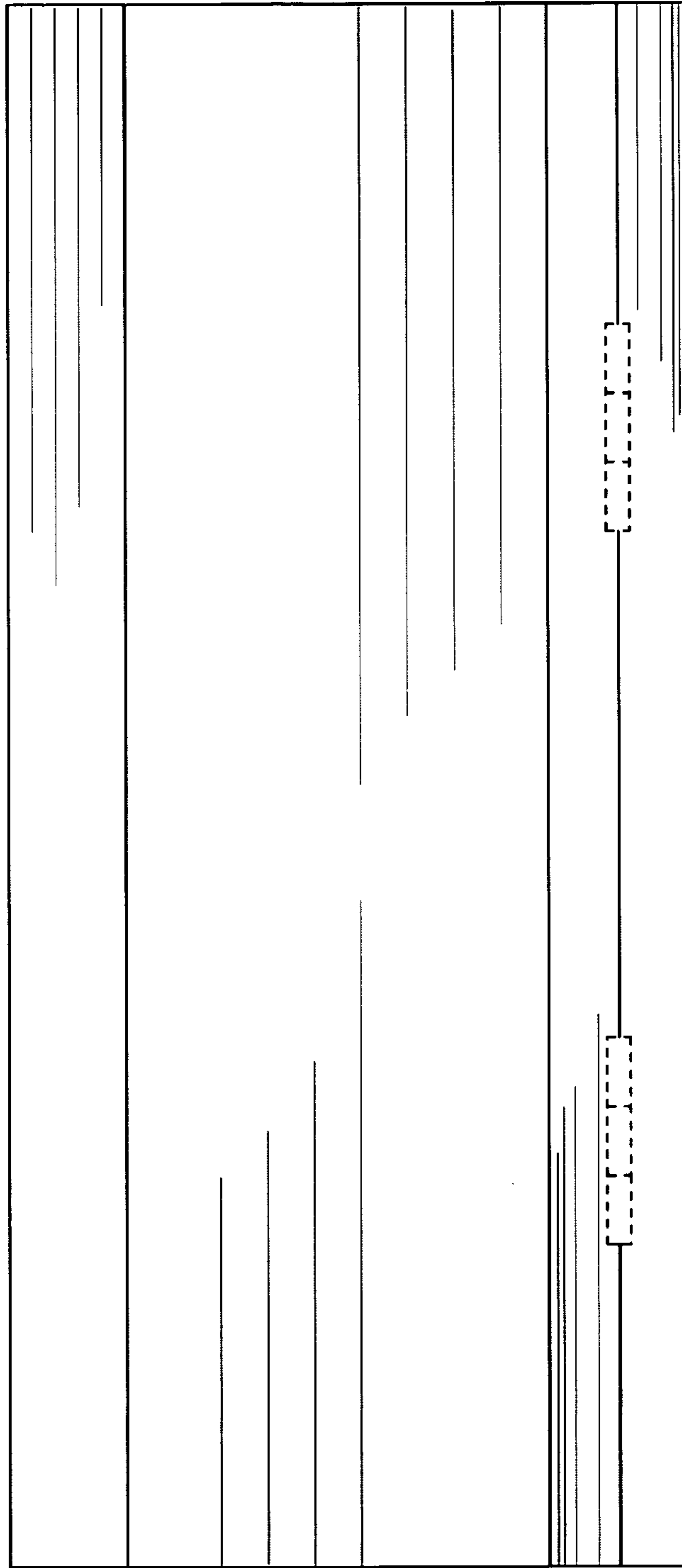

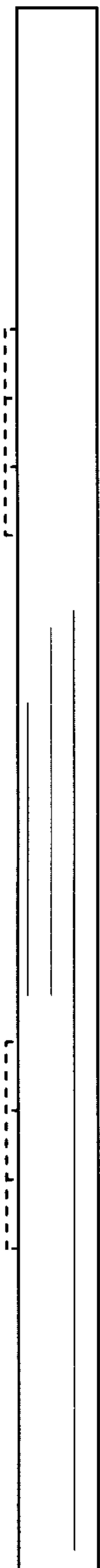

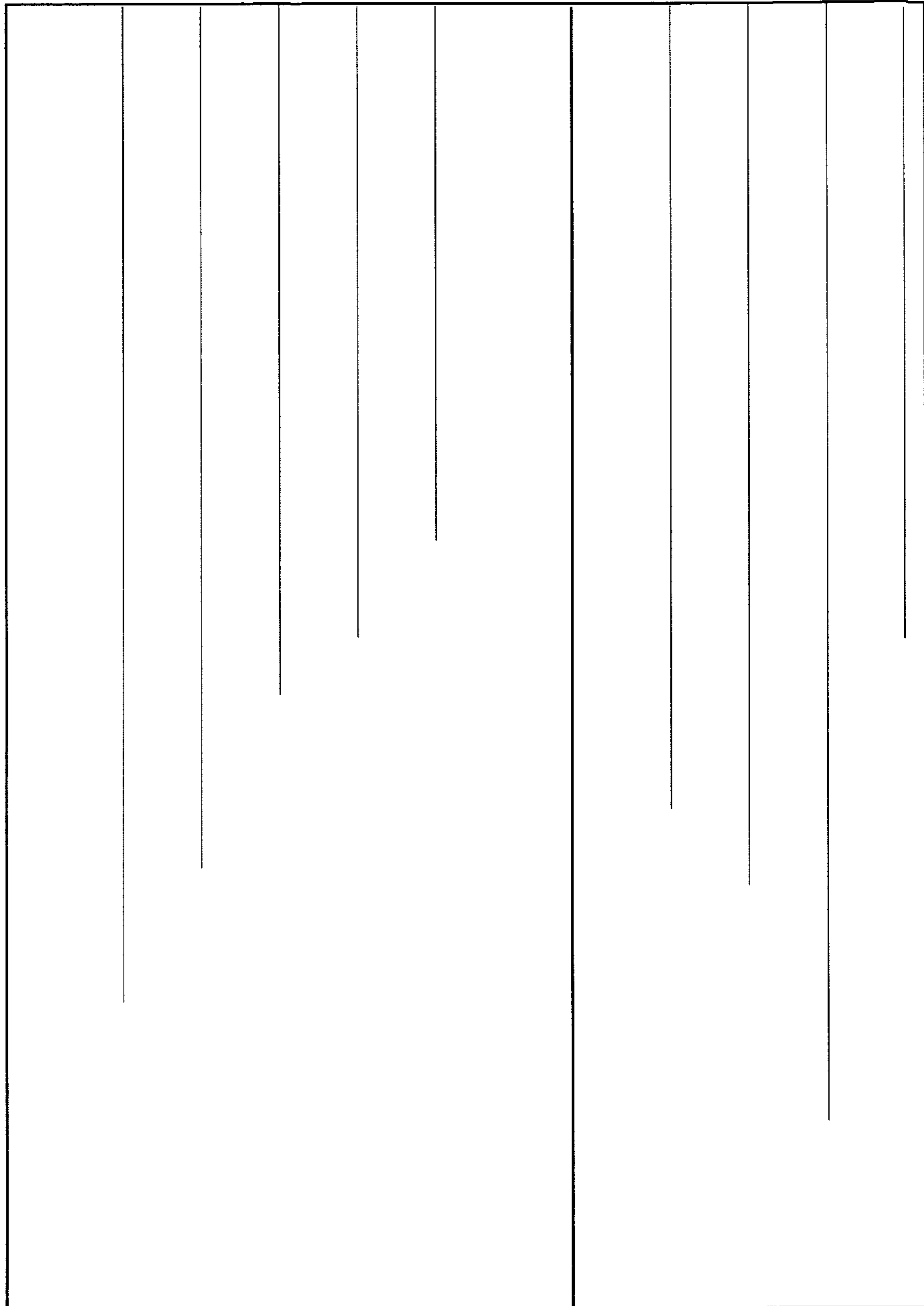

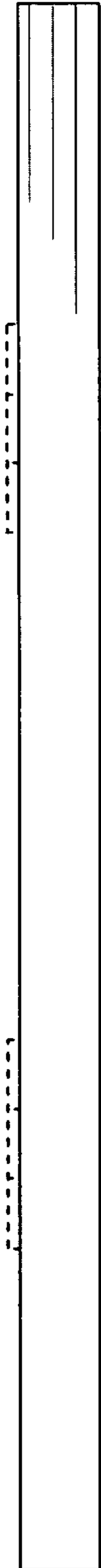

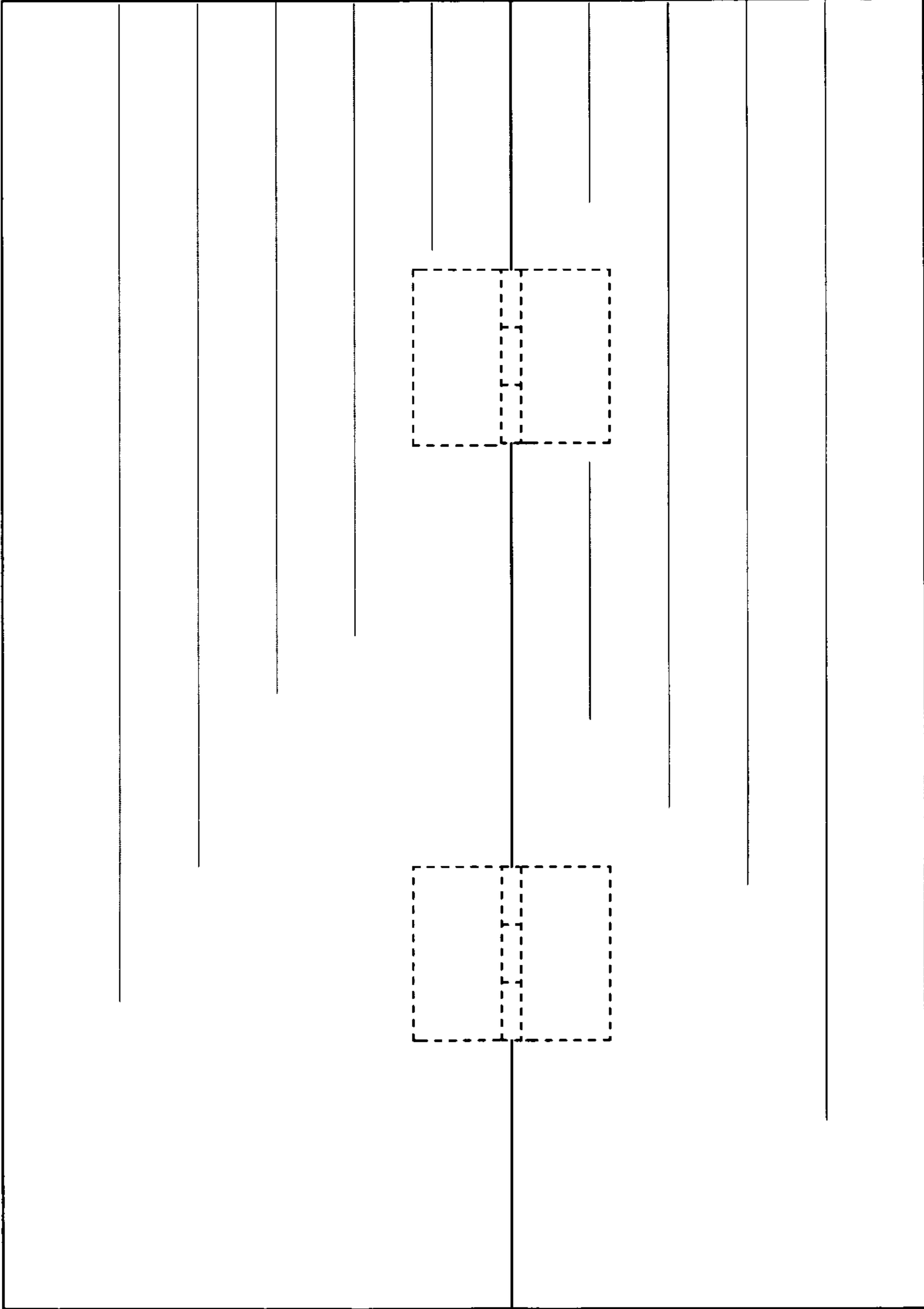
